■ New poll shows huge majority would vote no in Scottish referendum

A survey of Scottish people living in the US has revealed that 74% of them are against the country breaking away from the rest of the UK.

According to a Friends of Scotland survey, cited by Huffington Post and Scotland Now, of the 26% that would vote for Scotland to become independent, 66% said they would like to retain their British passports.

Friends of Scotland was forged in 2001 and one of its most famous supporters is legendary actor Sir Sean Connery.

"It is interesting to note that Scots living in the United States share the views of President Obama that in the case of the United Kingdom 'if it ain't broke don't fix it,'" said a Better Together Campaign spokesperson.

"Ex-pat Scots employed in a variety of professions across the US are clearly saying 'No Thanks' to separation."

Scots will vote in an

independence referendum on 18 September this year and will be asked the straight "yes/no" question: "Should Scotland be an independent country?"

The referendum period started on 30 May.

The poll also revealed that 84% did not believe that there was sufficient enough thought given to an independent Scotland's international representation through embassies and consulates.

Meanwhile, a whopping 94% of the respondents believe that "there is commercial value in Scotland remaining part of the UK, given the USA is the biggest international market for Scottish tourism."

While an

overwhelming majority of the survey's respondents are against Scottish independence, limited to those currently living in the country. "Importantly the respondents to this

Vladimir Putin is a thug and liar, says top British envoy

■ British ambassador to the United States Sir Peter Westmacott says West's increasingly firm response to Russia over Ukraine and the downing of Flight MH17 is beginning to have an impact on the Kremlin

Vladimir Putin, Russia's president, is a "thug" and a "liar", one of Britain's most senior ambassadors has said, as the EU prepares to approve tough new sanctions against Moscow.

Sir Peter Westmacott said the West's increasingly firm response to Russia was

survey highlight that 62% believe that Scotland's strong relationship with the US will endure after a 'yes' vote and that Scotland will come together after the referendum," said a spokesperson for Yes Scotland, in response to the survey.

"Large numbers of the respondents also want more powers for the Scottish Parliament.

"But as the referendum debate has developed, more and more people in Scotland have come to realise that the only way to achieve a meaningful package of powers to grow the economy and build a fairer society is to vote 'yes' in September."

The British ambassador to the United States said Moscow's aggression in Ukraine was starting to look like "the wrong call".

He spoke as the Ministry of Defence announced that a battle group of 1,350 troops and armoured vehicles, including Challenger tanks, would join Nato exercises in Poland.

Russian aggression

The Government said Exercise Black Eagle in south-west Poland would see Britain's biggest deployment to Eastern Europe since 2008.

The exercises were designed to reassure Nato's eastern members that the alliance would shield them from Russian aggression.

Sir Peter said Mr Putin's behaviour in Ukraine had been "thuggish, dishonest and reckless" and he "thought he'd done pretty well after he stole Crimea".

"It doesn't look so good now," he said on

the cable channel MSNBC. "It's starting to look like this was the wrong call. This is a defining moment for what is going on in Ukraine.

"We've had some very bad behaviour from the Russian side for a long time now, and now we've had this terrible atrocity - the shooting down of the aircraft. We have to change the cost/benefit analysis for Putin, for the Russian people, for the government that they have elected there."

Nato has stepped up manoeuvres in Eastern Europe since the annexation of Crimea with generals believing the alliance needs to reset its stance towards a more aggressive Kremlin.

'substantial support'

Exercise Black Eagle is the latest Nato war game to be bolstered at short notice in the area.

Military sources said the exercise at Poland's Zagan training area had been long planned, but significantly beefed up in recent weeks.

Polish forces and other

Nato nations are expected to join the exercise. The bulk of the British forces are expected to come from the King's Royal Hussars, though Army sources said a final decision had not yet been made.

Michael Fallon, the Defence Secretary, said the exercise showed Britain's "sustained and substantial support to Nato's eastern border". Britain was not ruling out "further enhancements", he said.

The confrontation over Ukraine is also likely to dominate a Nato summit in Wales in September. Mr Fallon

said: "We have a strong opportunity at the Nato summit to discuss how we will continue our response to Russia's illegal annexation of Crimea and its destabilisation of eastern Ukraine."

air patrols

The sending of an armoured battle group is by far Britain's largest show of military backing to Eastern Europe since the crisis in Ukraine began.

Four RAF Typhoon fighter jets were sent to Lithuania earlier in the year to reinforce Nato air patrols over the Baltic nations and

British troops have also joined smaller military manoeuvres.

Nato generals are calling for the alliance to pour military resources into Eastern Europe and build up a deterrent against Russia after years in which alliance members have cut spending and focused on conflicts elsewhere.

Western leaders are concerned that the Kremlin has chosen to escalate the conflict in Ukraine, even after the downing of MH17, by carrying out cross border artillery strikes and by sending more equipment to separatists.

Woman 'threw prosthetic leg' at cabin crew

A plane had to be diverted to Gatwick Airport this week after a woman threw her prosthetic leg at cabin crew and shouted abuse at them.

Sussex Police said the trouble began on Wednesday night when the 48-year-old woman started "swearing blue murder" and throwing food at crew on Thomson Airlines flight 297.

The flight, which was heading from Enfidha in Tunisia to Edinburgh, was diverted to Gatwick after the captain became alarmed.

The woman, who is unemployed and from Edinburgh, was arrested by police at the North Terminal at 10.22pm on Wednesday.

She was questioned by officers on suspicion of using threatening behaviour at Crawley police station.

Sussex Police said: "At 10.22pm on Wednesday a 48-year-old unemployed woman from Edinburgh was arrested at the North Terminal, Gatwick Airport, on suspicion of using threatening behaviour while aboard Thompson flight 297 from Tunisia to Edinburgh.

"The flight was diverted into Gatwick after it was alleged the woman had been abusive and had thrown a prosthetic leg and food at cabin crew."

A spokesman added: "She was swearing blue murder, saying she was going to do this and that and the other, so the flight was diverted to Gatwick."

The spokesman did not comment on reports the woman was drunk when the alleged attack took place.

Fighting back against the booze: Boris launches UK's first stay-sober ankle tag

AN ALCOHOL monitoring system based on a successful American model was introduced for the first time in Britain this week. The so called 'stay-sober' ankle tag is designed to enforce abstinence by measuring a person's perspiration every 30 minutes and testing to see if it contains alcohol.

The tags will be fitted to offenders as part of a scheme designed to cut down on violent drink-fuelled crime.

If any trace of alcohol is found, an alert will be sent to the offender's probation officer and they can then be recalled to court, where they could face sanctions such as a fine or be re-sentenced.

The 12-month scheme is being trialled in four London boroughs - Croydon, Lambeth, Southwark and Sutton. It was launched by London Mayor Boris Johnson on Thursday and is based on a successful programme in the US.

The tags are made by Alcohol Monitoring Systems, an American company which has been

producing them for use in the US for more than a decade. Among offenders in the States to have been fitted with one was Lindsay Lohan, the actress, who was ordered to wear one in 2007, after she failed to show up for a probation hearing relating to a drink-driving case.

Mr Johnson said: "Alcohol-fuelled criminal behaviour is a real scourge on our high streets, deterring law-abiding citizens from enjoying our great city, especially at night, placing massive strain on frontline services, whilst costing businesses and the taxpayer billions of pounds.

"I pledged to tackle this booze culture by making the case to Government for new powers to allow mandatory alcohol testing as an additional enforcement option for the courts.

"This is an approach that has seen impressive results in the US, steering binge-drinkers away from repeated criminal behaviour, and I am pleased we can now launch a pilot scheme in London."

Alcohol-related crime is estimated to cost the UK between £8 billion and £13 billion every year, while 40% of all accident and emergency attendances are related to alcohol misuse.

The first person to be fitted with one of the tags yesterday was Augustine "Nana" Apraku, a 24 year-old father-of-two from Sutton, London.

He was ordered to wear it for 80 days after he pleaded guilty using abusive language and provoking unlawful violence during a night out in Croydon earlier

this year. He had been drinking Grey Goose vodka in the Revolution bar in the town when he got involved in a "minor dispute" on the high street, he said.

He said he thought they tags were a good idea but was concerned by the fact that he was not allowed to have a bath while wearing it, only a shower.

"I like to have nice soak, that is the only inconvenience. I don't think it works in the bath, you can't use loads of aftershave either because that has got loads of

alcohol in it," he said.

"I'm a guinea pig aren't I? I'm not a binge drinker at all. It is not my first offence but I haven't been in trouble for a long time.

"I am happy not to drink for 80 days, it is a test. Drink does make you do things you would not normally do, liquid confidence - that is what they call it and that is why I am in this predicament. I think it is probably down to the drink a little bit. I don't want to have to go through this again so I think it is a good idea."

Beach babe ripped for pier blaze pic

- Blaze ripped through Eastbourne's iconic pier on Wednesday, reducing it to ashes
- Local MP says fire on 144-year-old structure was 'a dreadful event' for town

A laughing woman has been criticised online for posing up for a photo while a huge fire ripped through Eastbourne's historic pier.

The unidentified woman was pictured smiling with a bottle of cider in her hand while, behind her, locals watched in horror as their town's famous landmark went up in smoke.

The blaze started Wednesday afternoon in the iconic structure's arcade hall and fire crews were still dousing hotspots Thursday morning after the building was reduced to a smouldering wreck.

But while most bystanders watched

open-mouthed as flames ripped through the 144-year-old building, one woman, at least, saw the tragic blaze as a photo opportunity.

She was pictured posing on a wooden breakwater in a leopard-print swimsuit and matching sunglasses, with fire and thick black smoke clearly visible in the background.

The picture drew angry complaints today after it was posted on photo-sharing website Imgur.com.

investigators

One Eastbourne resident wrote: 'Really wish people would stop taking pictures of my town's historic landmark burning. So many memories on that pier.'

Another added: 'If it were in America or any patriotic country she would be confronted, no one has respect in my town.'

Reacting to the bikini photo, one web-user wrote: 'So fashionable to enjoy destruction and human suffering...'

While another posted: 'I swear to God, one day the apocalypse will come and everyone will be posting selfies.'

But, remarkably, while many expressed outrage, other website users posted comments encouraging the woman.

Among the more than 300 comments posted beneath her picture, one person joked: 'She's smokin'.' Others wrote 'looks like an album cover' and 'that girl is on fire'.

By late Thursday investigators were picking through the remains of the pier's domed amusement arcade trying to assess whether the building can be repaired or will have to be pulled down.

Local MP Stephen Lloyd has spoken of his fears that the town's economy will be severely hit by the potential loss of one of its main tourist attractions.

Mr Lloyd said: 'This is a dreadful event to happen to our lovely pier. I hope and pray that our wonderful pier is not lost for ever.'

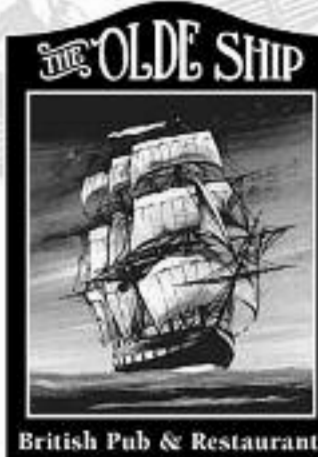

British icons? Mr. Bean leaves (almost) all of them in the dust...

It is the country which produced Chaucer, Milton, Robert Burns, Dylan Thomas and Seamus Heaney to name just a few.

But when thousands of people around the world were asked to name the figure they most readily associate with UK culture, none of those listed above came close to the status of – Mr Bean.

Rowan Atkinson's comic creation also proved a greater global cultural draw than Sir Winston Churchill, Charlie Chaplin, Diana Princess of Wales, John Lennon, Sir Paul McCartney, and even the Duchess of Cambridge.

Among only a handful of British figures past and present with more global recognition than Mr Bean, William Shakespeare is dominant, with the Queen ranked second and third place reserved for David Beckham.

Others edging ahead of Mr Bean in global appeal are JK Rowling and Adele, the singer.

More than 5,000 people

from the US, China, India, Brazil and Germany were asked to give one example of a person they associate with British culture, without being offered a list of options.

The survey was part of a research project carried out by Ipsos MORI for the British Council to identify Britain's greatest international assets – as well the things people abroad find most off-putting.

Sense of humor

Britain's population emerged with a decidedly mixed reputation around the world. They are regarded as polite and well educated but also hard drinking, xenophobic and with appalling eating habits.

When participants were asked to list the best and worst characteristics, British manners were by far the most common answer, cited by 46 per cent of those polled.

A quarter also cited the British sense of humour and as many as 37 per

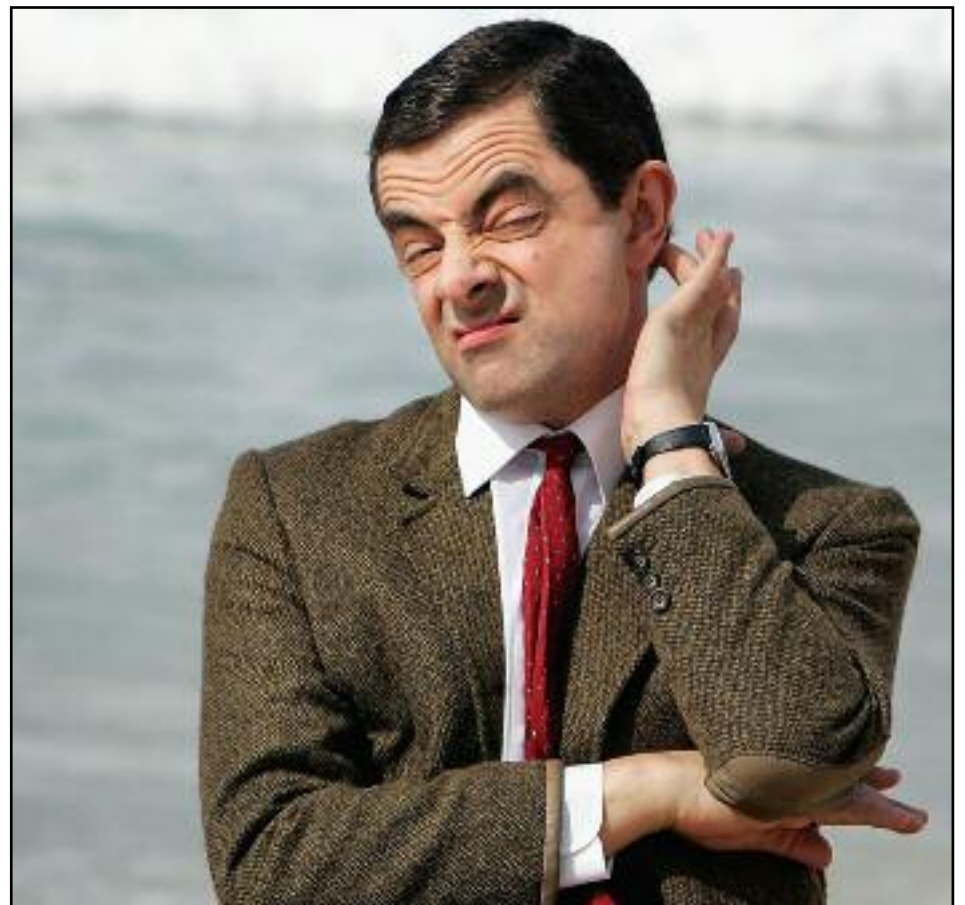
cent thought Britons are well educated.

But among the less positive characteristics, 27 per cent said they thought the British drink too much, 23 per cent listed "bad eating habits" just ahead of ignorance of other cultures and intolerance towards people from other countries.

John Worne, director of strategy at the British Council, said: "While there's a lot to be proud of, some stereotypes still colour the way that we're viewed overseas: boozy, bad eaters and ignorant of other cultures all figure in our worst characteristics.

"At our best we are rated 'polite', 'educated' and 'friendly', and the English language, our cities, universities, arts and culture definitely make people want to visit, study and do business here.

"So there's plenty we can do to ensure that the nation's smile matches its many attractions in the eyes of the world – and that's a job for us all."

Gatwick chaos: misery for thousands as they go on holiday...and their bags don't

THOUSANDS of Britons were facing their summer holidays without their luggage this week, as the antics of a low-priced baggage handling outfit left Gatwick airport in chaos.

As the situation worsened several MPs got involved in the fiasco, with one claiming the company at the center of the problem, Swissport, have "failed to deliver" and should hire more staff, while more airlines consider terminating their contracts with the firm following delays at London's second busiest

airport during its peak summer season.

Monarch Airlines have terminated their contract with Swissport at Gatwick and Manchester airports after a series of disastrous delays saw hundreds of customers sent home from Gatwick without their luggage, because the firm was short-staffed.

Other airlines are understood to be on the verge of following suit, and on Thursday MPs applied more pressure on the multi-national, with Labour saying the company had "clearly failed to deliver" and should recruit more staff.

In some cases holidaymakers missed connecting flights in Europe because of delays loading luggage on to departing planes, while Britons have been waiting for nearly a week in far-flung locations for their bags to arrive.

Gatwick and Swissport said they are to hire extra staff as they bid to avoid delays this weekend, one of the busiest of the year. Gatwick said it was recruiting 45 workers "to help get baggage delivered on time" and Swissport said it was adding 40 baggage handlers at the airport.

Commonwealth Games Scottie dogs 'disrespectful to Muslims'

■ Use of Scottish terrier dogs during Commonwealth Games opening ceremony was 'shameful' and 'offensive', Malaysian politicians claim

Malaysian politicians and religious leaders have attacked the use of Scottie dogs during the Commonwealth Games opening ceremony, claiming it was disrespectful to Muslims.

Around 40 Scottie dogs were used in the opening ceremony in Glasgow last Wednesday to lead teams around Celtic Park.

The dogs, which all wore tartan dog coats with the name of each team on them, were widely praised on social media, with many people stating they thought they had "stolen the show". Hamish, who led out the Scotland team, received one of the biggest cheers of the night.

However, not everyone was as impressed.

Political and religious leaders in Malaysia have claimed the use of dogs connected to Muslim countries was "disrespectful".

Many Muslims refuse to have direct contact with dogs, which are considered by some to be "unclean" in Islamic culture. Some overseas Muslim groups have reportedly previously called for a jihad on dogs.

'aware and sensitive'

Possibly making matters worse was the fact that Jock, who was supposed to lead out the Malaysian team, sat down and refused to move as soon as his coat was put on, meaning he had to be carried by the team representative.

Mohamad Sabu, the deputy president of the opposition

Pan-Malaysian Islamic Party said: "Malaysia and all Islamic countries deserve and apology from the organiser.

"This is just so disrespectful to Malaysia and Muslims – especially as it happened during Ramadan. Muslims are not allowed to touch dogs, so the organiser should have been more aware and sensitive on this issue.

"It is hoped this incident can teach other Western countries to be more respectful in the future."

Dato Ibrahim Bin Ali, a far-Right politician, former MP and founder and president of Malay supremacist group Perkasa also called for an apology.

"I think it is unbecoming. The hosts have not been sensitive

enough – especially in a so-called knowledgeable and civilised society like Britain," he said. "It is shameful and has offended not only

Malaysia as a Muslim country, but Muslims around the world."

A Glasgow 2014 spokesman said: "Glasgow 2014 have

received no complaints from the Commonwealth Games Associations of the competing nations and territories following the Opening Ceremony."

Prince Harry photobombs New Zealand officials at Commonwealth Games

■ Clown prince is at it again, giving the thumbs-up to a Kiwi snap...but he still HATES Twitter...

Prince Harry has followed his grandmother's example by photobombing three New Zealand officials at the Commonwealth Games.

The open-mouthed royal was snapped giving a double thumbs up in the background of a photograph with New Zealand rugby sevens coach Gordon Tietjens.

Former Olympic boxer Trevor Shailer and sports psychologist Gary Hermansson also posed for the photograph at the Glasgow swimming venue.

Shailer, the New

Zealand Commonwealth Games team's deputy chef de mission, posted the photograph on his Facebook page Monday night.

"Photo of the day," he wrote. "A royal photo bomb by Prince Harry with Titch (Tietjens) and Gary Hermansson."

The 29-year-old Prince's photobomb comes just days after the Queen was captured smiling in the background as two Australian hockey players took a selfie.

Hockeyroos" Jayde Taylor and Brooke Peris managed to get another

picture with the royal on Monday.

Taylor explained: "We asked him if he would do a selfie with us so we could add it to our collection, but he said 'I hate selfies but I will definitely do a photo with you'."

But although Harry seems to enjoy the funny side of social media, he's no fan of Twitter. He recently told an audience 'I really quite hate Twitter' when asked if he would be tweeting during the Games. Harry said: 'I would love to get involved and go on social media...but the

issue for myself and my family, put quite simply, is that it's very hard for me to tweet about something that means a lot to me, whereas I at the same time really quite hate Twitter by the invasion of privacy. I think you all understand what I'm talking about.'

Although Buckingham Palace and Clarence House both use social

media to promote the work of the Royal Family, Harry, who is fourth in line to the throne, has often spoken of his anger at the way details or pictures of his whereabouts outside of official engagements are made public on the internet.

But it seems that not all social media is off limits, as he admitted that he

once had a Facebook account – for which he used the pseudonym Spike Wells.

Harry was not the only royal in attendance at the Games. Prince William and his wife, the Duchess of Cambridge, were also in attendance at Glasgow 2014, as they watched gymnastics, boxing, hockey and swimming.

Blogger arrested in 2am raid on his home after claiming Lee Rigby's murder was an anti-Islam HOAX

- Christopher Spivey, 51, was arrested at his home in Rochford, Essex
- Claimed in internet articles that Lee Rigby's brutal murder was faked

A **BLOGGER** was arrested on Thursday after claiming that the brutal murder of Lee Rigby was faked to discredit Muslims.

It is unclear whether the arrest of Christopher Spivey, 51, was made in relation to these articles or another separate case, or cases, of alleged harassment.

In a rambling post uploaded to his blog on Tuesday, Mr Spivey claims that there are eight seconds of footage 'missing' from the CCTV footage that captured the death of Drummer Rigby, who was run down and then hacked to death in Woolwich, London, in May last year.

brutal murder

He goes on to discuss his theory in extensive detail, sharing 'calculations' that he has made of the speed that the car was travelling at when it hit Lee Rigby.

This logic, among other suggestions, shows that the brutal murder was in fact a 'hoax', he claims.

Police involved in the investigation would neither confirm nor deny whether the alleged harassment was connected to Lee Rigby's mother Lyn Rigby and stepfather Ian Rigby, who live in Middleton, Manchester.

Among Mr Spivey's online supporters are

David Icke, the former footballer and BBC Grandstand presenter who has become known for his conspiracy theories.

Mr Spivey was being held in custody Wednesday night in Southend, Essex after his arrest, which came about when officers from Essex Police acted on a referral from Greater Manchester Police.

He has since been released on police bail pending further inquiries until September 5.

An Essex Police spokeswoman said: 'A 51-year-old man from Rochford was arrested by Essex Police on suspicion of harassment in the early hours of Wednesday, July 30.

He is at Southend Police Station helping officers with their enquiries.

'The arrest relates to an allegation of

harassment via social media which has been referred to Essex Police by Greater Manchester Police.'

Mr Spivey was also recently critical of Lib Dem deputy prime minister Nick Clegg, portraying him as Hitler on his Facebook page.

Killers Michael Adebowale, 23, and Michael Adebolajo, 29 were both sentenced to life in February for the brutal murder of Lee Rigby.

Adebolajo received a while life term while Adebowale will serve a minimum of 45 years.

The pair ran 25-year-old Fusilier Rigby down in a car before attacking him with a meat cleaver and knives in a frenzied attack.

Both pleaded not guilty and claimed to be 'soldiers of Allah' and motivated by the plight of Muslims.

Legends sees Bean play a gruff FBI agent able to adopt a new identity each episode. A source at the channel refused to reveal any information surrounding Bean's fate on the show, saying that it "will depend on the ratings. He's safe for a bit."

Landing gear: inspiration from above

■ Exclusive interview with author Kate Pulling and a review of her new novel about an aircraft stowaway

Rating: ★★★



"There's a myth in some parts of the world that you can stowaway on an airplane by climbing up through the landing gear," says *Landing Gear* author Kate Pulling. "But it isn't true. People who stowaway like this almost always die. A body had landed in a supermarket car park not far from where I live. And over the course of ten years a series of bodies had fallen in or near this

London supermarket because it is the place on one of the flight paths into Heathrow where planes lower their landing gear. Using what the journalists discovered about the most recent body, I began to wonder about what would happen if, in fact, the stowaway survived and landed on the car of a London woman."

In the spring of 2010 the Icelandic volcano

Eyjafjallajökull erupts disrupting flights all over Europe. Harriet's husband Michael can't get home from New York. Harriet works at a London radio station while her co-workers are stuck abroad. Yacub, a Pakistani migrant worker, is stranded in a Dubai labor camp. Two years later he stows away in the landing gear of a plane. He falls out and lands on Harriet's car at a supermarket in London. Emily, who works for a TV station, accidentally captures it all on film. The arrival of Yacub changes the lives of Harriet and Emily.

A stowaway falling from a plane and surviving; that's high concept, literally. But it isn't the page-turner thriller or laugh-out-loud romantic comedy you might

expect. It's Yacub's story. Yet it's written as women's fiction, a down-the-rabbit-hole Alice in Wonderland story of Harriet and Emily. The head hops and flashbacks may bewilder readers. It jumps around a lot. The best part of the story is Yacub and how he got to the UK. The story covers four years.

"I've had the idea for *Landing Gear* since I first read a newspaper article in the Guardian newspaper here in the UK," says Pulling.

"The early response to the book has been very, very heartening and compelling," says Pulling, who built a fan base for her book by telling the story in an online multimedia project called *Flight Paths: A Networked Novel*

(www.flightpaths.net). Pulling did most of her research during that phase, about airplane stowaways and the Icelandic airspace shutdown of 2010.

The *Mistress of Nothing*, Pulling's last novel, won the Canadian Governor General's Award for Fiction in 2009. The *Mistress of Nothing* is in its second draft as a screenplay being developed by a film production company in Toronto.

Pulling is a Professor of Creative Writing and Digital Media at Bath Spa University. She works at two of its campuses. One is in a stately home just outside Bath in Somerset, and the other in a stately home in Wiltshire. "It's amazing working on two such beautiful campuses," says Pulling.

I'm off to the homeland this week which got me thinking about how many questions we get asked regarding passport renewal. So, with the help of our consulate friends, we put together some handy tips, which can be viewed online at: www.britsin.la/passport

Britons used to have to send their passport to Washington D.C., however overseas residents must now apply for their passports ONLINE via the gov.uk website as part of a worldwide change to the passport process. The British Consulate also recommends you DO

NOT leave it until the last minute to apply for your passport. You can apply up to nine months in advance and any unexpired time will be added to your new passport. (www.gov.uk/overseas-passports) You can also book a same-day appointment in the UK for a renewal passport but if you have lost your passport and go home on an emergency document, it can take a week for an expedited renewal. You will need to visit your nearest

Passport Customer Service Centre in the UK and your appointment may be up to two weeks from the day you book it. The UK Passport Advice line is 0300 222 0000, open Monday to Friday, 8am to 8pm Saturday, Sunday and public holidays, 9am to 5:30pm.

Nationality inquiries

The Home Office is the lead government department on nationality matters. If you have an enquiry about eligibility for British citizenship or nationality - for instance, if your American spouse is eligible, information can

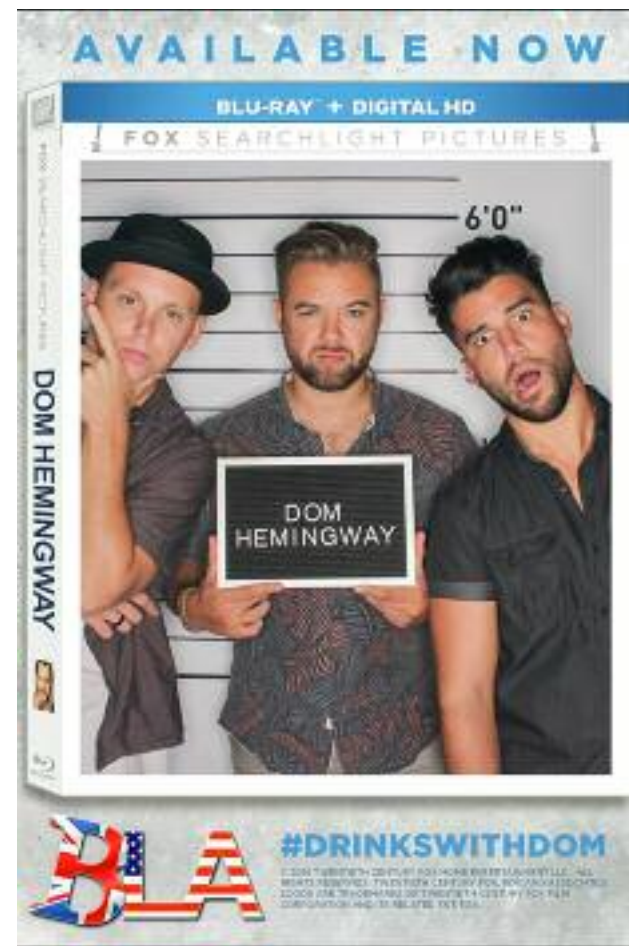
be found at: www.gov.uk/british-passport-eligibility.

Urgent Travel: if you need to travel urgently and your normal passport is not available you should contact your nearest consular office. They may be able to provide you with emergency travel documentation. Please note they will not be able to answer general passport questions or give information on passport applications in progress (as they are no longer involved in this process). You should only contact them if you have a need to travel urgently and you will be asked to supply evidence of your need.

For mailed applications you'll need to send your old passport to the following address:

Durham Passport Office, Milburngate House, Durham, DH97 1PA. We advise getting a tracking number when you mail; you can send through the USPS for about \$16.

Please note that UK passport photos are a different size to the USA so get a photographer who knows the difference.

tourists 445 to win, England took the six wickets required on the final day to bowl the tourists out for 178 and end a 10-match winless run.

Moeen Ali claimed his first Test-match five-wicket haul to finish with 6-47, while James Anderson picked up 2-24.

The result levels the five-match series at 1-1 going into the fourth Test at Old Trafford, which begins next Thursday.

The win also represents a personal triumph for home captain Alastair Cook, who had faced calls to quit after the second Test defeat at Lord's amid his own and his team's poor run of form.

Cook responded with

95 in the first innings and an unbeaten 70 in the second, while there were also strong showings from a trio of underperforming senior players - a century from Ian Bell and a combined 10 wickets for Anderson and Stuart Broad in the match.

Along with Joe Root, they are the only men who survive from England's previous win, which came in the fourth Test against Australia at Chester-le-Street in August 2013.

While that victory sealed a third consecutive Ashes triumph for an experienced outfit accustomed to winning, this is a welcome success for a transitional team containing six members who had never been on the right end of a Test result.

Mourinho desperate to sell Torres

■ Stamford Bridge club may be forced to sell goalkeeper Petr Cech if they cannot find buyer for cut-price Spanish flop

JOSE Mourinho has admitted that he will have to get rid of one of his foreign players as Chelsea desperately try to find a buyer for Fernando Torres.

The return of Didier Drogba means Chelsea's anticipated first-team squad has one too many foreign players under Premier League and Champions League rules relating to the home-grown quota.

Clubs can only name 17 foreign players over the age of 21 in their official 25-man squads and Chelsea have 18 overseas stars who are realistically vying for those places.

Mourinho, the Chelsea manager, wants to offload £50 million flop Torres, but clubs are being put off by the £20 million asking price and the Spaniard's £175,000-a-week wages.

Chelsea hope that Atlético Madrid may take Torres back, while Monaco are understood to have looked at his situation in case Radamel

Falcao leaves.

Should Chelsea fail to sell Torres or midfielder John Obi Mikel, who has not generated much interest, Mourinho may be forced to consider a Paris St-Germain offer for the goalkeeper Petr Cech.

The area of Mourinho's squad is clearly overloaded in the goalkeeping department, where he has three senior foreign players - the Czech Republic international Cech, the Belgian Thibaut Courtois and Mark Schwarzer, of Australia.

Schwarzer signed a new one-year contract this summer, which, despite Mourinho's claim that he would like both men to stay, points to the possibility of either Cech

or Courtois leaving.

Courtois returns on Tuesday to Chelsea pre-season training in Holland, with PSG watching Cech's situation carefully and ready to make a £10 million bid for the 32-year-old.

Selling Cech would allow Mourinho to use the Englishmen Jamal Blackman or Mitchell Beoney as his third-choice goalkeeper, behind Courtois and Schwarzer, and bring Chelsea's foreign quota down to the permitted level.

"From the group you are expecting us to have as a squad, I have to send one away because we have one extra foreign player," Mourinho said.

"So from all these

players, if you think all of them have to stay, you are wrong. One of them has to go."

New signing Cesc Fàbregas counts as a home-grown player because of his eight years at Arsenal. But with Ryan Bertrand and Victor Moses set to leave Stamford Bridge, Mourinho will not be able to fill his quota in the Premier League or Champions League and will have to top up his squad from the club's under-21 list.

Romelu Lukaku still counts as an under-21 player under Premier League rules and would fulfil home-grown status, which means a move to Everton would not solve Mourinho's problem.

Big Sam 'shocked' over Twitter bombshell

Sam Allardyce is poised to sign the Arsenal defender Carl Jenkinson but his future as West Ham United manager appears increasingly bleak.

Allardyce has agreed a deal to take Jenkinson on loan for the season after holding talks on Monday with the England international, following West Ham's return from their tour of New Zealand.

Jenkinson, 22, has been made available following Arsenal's £16 million

signing of Southampton's Calum Chambers and West Ham are on the brink of beating competition from Hull City, Swansea City and Queens Park Rangers to take the right-back for the forthcoming campaign.

However, Allardyce is said to be "surprised and shocked" by David Gold, the co-chairman, taking the remarkable step of 'favouriting' a derogatory message about the manager on Twitter.

Gold was sent a message by a Hammers

fan reading "Is today the day we get rid of BFS ?? fingers crossed", a reference to Allardyce's nickname Big Fat Sam, and favourited it, which was seen by his 92,000 followers.

Allardyce has been made aware of it and a source close to the West Ham manager admitted that it had left him stunned. It only serves to increase the pressure further on Allardyce, 59, with the uncertainty building over the weekend after David

Sullivan admitted that he opposed his stance on Ravel Morrison.

Sullivan wants to offer Morrison, a peripheral figure under Allardyce, a new contract while he also insisted that the record signing of Andy Carroll has been a huge mistake.

Carroll will miss at least the next three months with an ankle injury and Sullivan revealed that he regretted "putting all his eggs in one basket" to sign the England international from Liverpool.

Champions League humiliation for Celtic

Ronny Deila suffered a nightmare first loss as Celtic boss with a heavy 4-1 defeat by Legia Warsaw in the Champions League third qualifying round first leg on Wednesday.

Lukaku seals Everton move

Everton have signed Chelsea striker Romelu Lukaku for a club record £28m.

The 21-year-old Belgian World Cup forward, who scored 16 goals on loan at Everton last season, has signed a five-year contract at Goodison Park.

Everton boss Roberto Martinez said: "This signing is not just important for this season. It is a significant day in the history of this football club."

Lukaku joined Chelsea from Anderlecht for £18m in August 2011 but played only 15 games for the club.

After signing his contract at Goodison, Lukaku said: "I'm 21, I need to be playing in a good team. I needed to be in a place that felt right."

"I decided very quickly I wanted to come back. This is the place I belong."

Lukaku's transfer breaks the previous record of £15m for Marouane Fellaini when he joined Everton from Standard Liege in 2008.

It was originally thought Everton would

pay £23.7m for Lukaku before the club revealed the £28m fee. Chelsea believe the transfer puts them in a strong position to comply with Uefa's Financial Fair Play rules.

Chelsea boss Jose Mourinho said: "He wanted to play for Chelsea but wanted to be the first-choice striker. That's very difficult to

promise.

"Everton made an important offer and financial fair play is something that is always behind the thoughts of the

board. This leaves Chelsea in a great position."

Martinez said: "We know that Romelu is still a young man and the potential that he has is

quite unique, and we are desperate to see him enjoying his football and to watch him grow as a footballer in the years to come."

Chambers in £16m Gunners move

HIGHLY-RATED England prospect Calum Chambers has completed a transfer from Southampton to Arsenal in a deal that could end up costing £16m.

Chambers will initially provide cover for another signing, the £10m Mathieu Debuchy, at right-back and will also be utilised at centre-half but Arsène Wenger is convinced the 19-year-old will eventually graduate more permanently into a central midfield berth at the Emirates. While Chambers would expect to feature for Arsenal in

domestic cup competitions, he has been told he will play at least 20 senior matches this season, with Arsenal also set to compete in the Champions League.

"We are very pleased that Calum has agreed to join us," said Wenger after adding his fourth recruit of the summer. "The way he adapted to the Premier League last season with Southampton at a young age shows that he has tremendous quality. He has a lot of the attributes that we look for in a young player and I am sure that he will do well with us."
