LAKE DISTRICT NAMED WORLD HERITAGE SITE

■ Historic region has long provided inspiration to artists and writers

The Lake District been named as a World Heritage Site, Unesco has announced.

The region, famed for its stunning scenery, joins the likes of the Taj Mahal, the Great Wall of China and the Grand Canyon on the illustrious list and is the UK's first national park to be given the status.

Lord Clark of Windermere, who chaired the Lake District's bid, said the decision to recognise its culture, art and literature, as well as its landscape, was "momentous".

He said: "It is this exceptional blend which makes our Lake District so spectacularly unique and we are delighted Unesco has agreed."

The Lakes, which is visited by 18 million people every year, was one of 33 sites around the world to be considered by the Unesco committee in Krakow, Poland, and was praised for its beauty, farming and the inspiration it has provided to artists and writers.

The committee suggested the impact of

tourism be monitored and requested improvements in conservation efforts.

It was the 885 sq-mile region's third attempt to be awarded the status and was 30 years in the making.

successful bid

The first nomination was as a "mixed" site of natural and cultural merits in 1986, and the second, in the cultural category, was made in the 1989.

The cultural landscape category, which it won, was created in 1993 in direct response to the region's previous nominations.

The successful bid, managed by the Lake District National Park Partnership, was launched in 2001 as an opportunity to provide a boost in the wake of the foot and mouth outbreak.

It was formally entered by the Department for Digital, Culture, Media and Sport and Historic England.

John Glen, minister

for arts, heritage and tourism, said: "The Lake District is one of the UK's most stunning and ancient landscapes and I am thrilled it has been granted World Heritage Site status.

"It is a unique part of the world that combines a vibrant farming community with thousands of archaeological sites and structures that give us an amazing glimpse into our past.

"This decision will undoubtedly elevate the position of the Lake District internationally, boosting tourism and benefiting local communities and businesses."

The Lake District has provided inspiration for some of the country's best-loved writers including Beatrix Potter, William Wordsworth and Samuel Coleridge.

It boasts sites of historical importance such as King Arthur's Round Table and is home to England's largest

natural lake-Windermere - and highest mountain - Scafell Pike.

It is the 31st place in the UK to make the list, following in the footsteps

of Stonehenge, the city of Bath and Canterbury Cathedral.

GO-GO-GO: The red-hot British housing market shows no sign of cooling down

Ripple Effect: more million pound homes now sold OUTSIDE the capital

BRITAIN'S seemingly-unstoppable house price boom has seen sales of £1million-plus homes almost triple in the past five years.

And this year, for the first time, more than half are set to be sold outside Greater London, official figures show.

Property transactions worth £1million-plus rose 195 per cent between 2011 and 2016, compared with a 54 per cent rise in total activity over the same period.

London has seen the highest growth since 2011 but the capital's property market was outpaced by Hertfordshire, Surrey, Essex, Hampshire, Kent and Greater Manchester between 2015 and 2016, according to Land Registry data.

If current trends continue, at least 51 per cent of high-end sales this year will take place outside Greater London – up from just 37 per cent in 2011.

The latest UK House Price Index shows values are now rising faster year-on-year in the East of England, the South-west, West Midlands, South-east, East Midlands and Yorkshire and the Humber than in London.

In Derbyshire in 2011 just six homes sold for more than £1million but by 2016 the number was 64.

In Lancashire in 2011, 16 homes were sold with seven figure price tags.

Last year that had leapt to 85. By far the biggest number of homes worth over £1million bought

and sold between 2011 and 2016 were in London with 7,333 transactions, followed by Surrey on 818.

Hertfordshire was third with 676. But the study by mortgage broker Private Finance also showed a sizeable five-year increase in top-end transactions outside the capital.

Growth of 4,800 per cent was recorded in South Yorkshire and 2,600 per cent in Co Durham and Swindon.

The biggest increase in 2015-2016 alone was seen in Carmarthenshire, West Wales, at 1,200 per cent.

Shaun Church, of Private Finance, said of the trend: "Even for many highly-paid professionals, a large family home in the capital

is now out of reach.

"With buyers looking further afield as a result, this has contributed to significant growth in the number of £1million-plus transactions in areas like Kent, Essex and the Home Counties, which are all within easy commuting distance of London.

Buying a million pound-plus property is a significant financial commitment, and with increasing numbers of buyers falling into this category borrowers may need to look to private banks and brokers. These tend to offer a more bespoke, flexible service. For example, buyers might leverage unconventional assets like jewellery, fine art or sports cars as a means of obtaining their property.

"The lender will take into account how liquid the assets are and make a judgment as to whether the borrower could sell an item to repay the loan."

The country-wide trend comes despite cooling activity at the very top of the housing market after reforms to stamp duty in December 2014 and April 2016.

However, sales of £1million-plus properties still rose 10 per cent from 2015 to 2016.

The data also shows wealthy buyers taking advantage of falling interest rates while the average loan to value rose to 56 per cent last year, suggesting high-end buyers are leveraging their assets as six-figure deposits.

It's splitsville for Jamie and Louise as 'Strictly Curse' claims latest marriage

■ Performing on hit BBC One show made Louise realize "I just love being on the stage"

Jamie and Louise Redknapp have reportedly ended their 19 year marriage, making theirs the thirteenth relationship rumored to fall victim to the 'Strictly Curse'.

Louise, who has moved out of the home she shared with husband Jamie and their sons Charley, 12, and Beau, 8, was last year's runner-up on Strictly Come Dancing, the wildly-successful BBC One television dance contest, which features contestants, celebrities and other people from all walks of life, with professional dance partners competing in a Ballroom and Latin dance competition.

While there's no suggestion that their partnership was anything other than professional, Louise has admitted that dancing with Kevin Clifton on the BBC show reignited her passion for performing.

Louise described her decision to take part in the show as "the first time I'd been selfish in 12 years".

Speaking to Women's Health earlier this year, she admitted, "it is hard when you're married to someone with a very successful career, and you have children, to have everything.

"Something has to give somewhere, and I think it was me that gave. Going back and doing Strictly made me realise my desire is still the same. I just love being on the stage."

Romantic entanglements and time apart have caused many a relationship to crumble under the Strictly spotlight. Neither the

celebrities who take part nor their professional partners are immune.

New Zealand's famous ballroom dancer Brendan Cole saw his relationship with fellow dancer Camilla Dallerup begin to unravel when his rumored affair with series one winner Natasha Kaplinsky hit the headlines, ending her own marriage.

A few years later, Italian professional dancer Flavia Cacace's long-term relationship with dance partner Vincent Simone ended when her partnership with EastEnders' Matt DiAngelo became more than strictly professional. But then Matt was supplanted in Flavia's affections by Jimi Mistry a few series down the line.

TV insiders claim that the 'Strictly Curse' is deterring potential contestants from signing on the dotted line.

Last year, Michael Buble admitted that he would be "too afraid that I would fall in love with the professional that I would be dancing with," and risk jeopardising his relationship with wife Luisana Lopilato by appearing on the show.

"I honestly do not know how everyone is not having sex with everyone else in that show," he told the Daily Star.

A BBC spokeswoman refused to comment on this year's would-be contestants' curse-related jitters. Ruth Langford, who has a 15-year-old son with husband Eamonn Holmes, Casualty star Jason Durr, who is married with three children, and The

Couple renew vows - after one of them undergoes sex change

Once married as man and wife, Denise and Kristiana Taylor of Kent are planning to renew their vows next month, but this time as a same-sex couple.

In 2012, Kristiana began to transition from male to female, following a lifetime of knowing something wasn't quite right.

She left school at 16 and spent most of her life in the Royal Navy, serving in the Gulf War, but left in the mid-90s and soon met her future wife.

The pair, who live in Sittingbourne with their 14-year-old son, Stephen, first met in Newcastle and were married within a year of becoming an item, in 1996.

They renewed their vows in 2012, but just days later Kristiana told Denise she was transgender. Now

they plan to do it all again.

Kristiana, a radiographer at Tunbridge Wells hospital in Pembury, said: "We're renewing our vows on August 17 and we both get to wear the dress this time."

"It's a blessing and a celebration of the 60-odd people that are invited, saying thank you for the support as we're so thankful."

"Something which could have torn us apart, actually brought us together."

In 2012, three days after they renewed their vows as a man and woman, a bedroom conversation over the wedding dress Denise had worn led Kristiana, 49, to break down in tears and come out, with the pair spending hours talking.

Denise said the

revelation was a relief: "I had my suspicions for quite some time, and every time I'd try to approach the subject we'd have a full-blown argument and she'd storm out."

"For me I thought, her as a man was having an affair or was gay and I kept finding things round the house and didn't know how to approach it and I was anxious of thinking what was going on."

"It was a relief more than anything."

"It made me better to know I hadn't physically been sharing her with someone else but actually someone that was trapped inside and was trying to get out."

"The way I saw it was that the inside's not changing, and that's what I married - so the outside didn't make much

difference."

However, Kristiana does still suffer some discrimination - something they say is borne from stupidity and ignorance.

Denise, a midwife at Medway hospital, added: "We just come and go like

anyone else. We're living our own lives."

"We're just a normal family, and normal is as normal as you make it."

The ceremony will take place at Judd's Folly Hotel in Ospringe.

Kristiana knew she was different when she was

eight years old, but didn't know why.

"All I knew was that I felt comfortable wearing feminine clothing, there was a sense of attachment," she said.

"But as a boy I felt the opposite of what I felt as a woman."

Vile toff facing jail after offering £5k reward to 'run over' leading Remainer

A WEALTHY British aristocrat is facing a prison term after he was found guilty of making menacing threats relating to anti-Brexit campaigner Gina Miller.

Rhodri Philipps, the 4th Viscount St Davids, posted a series of messages on Facebook in November last year, in which he offered money for the campaigner to be run over.

The 50-year-old wrote a post related to an article headlined 'Gina Miller clashes with Nigel Farage on TV over Brexit law challenge' where he offered cash for the campaigner to be run over.

'bloody troublesome'

He said in November: "£5,000 for the first person to 'accidentally' run over this bloody troublesome first generation immigrant."

"This f***ing boat jumper come to this country, then believes she knows better than the people of our country, what is best for us."

"If this what we should expect from immigrants, send them back to their stinking jungles."

Mr Philipps defended his remarks by claiming they were simply "political comment" and "satire" after he was arrested on January 25.

However, Chief magistrate Emma Arbuthnot said she had "no doubt it was menacing".

Ms Miller told the court on Monday that she had been angered by the comments.

The business owner said: "This challenge has not been popular with supporters of the EU exit. I have

have received a series of threats. These threats have also been extended to family members and staff who work for me.

'upset and angry'

"Threats have been made over numerous social media accounts. The content of the threats vary widely."

"The most serious state I should be shot in the head, and left in a bin. There have been numerous racial slurs made against me."

She added: "All of this abuse and the threats have made me feel very scared about my personal safety and that of my family."

"The words contained in this post generally shocked me, and made me feel violated, upset and angry."

'a form of satire'

"This is one of the main reasons I take my own personal security so seriously, and why I employ a professional company to protect me."

Mr Philipps, of Knightsbridge in central London, denied three counts of sending by public communication network

a menacing message.

He told the court: "My family motto is 'Love of Country is my motivation'."

Mr Philipps said his comments were "meant to be a form of satire, a literary technique, iterated in my personal style, which may not be to everyone's taste, but is understood and accepted by everyone who knows me".

But Ms Arbuthnot, in a series of exchanges with the aristocrat, asked Mr Philipps: "Boat jumper, how can I see that as anything other than a racial, ethnic aggravation?"

Mr Philipps also posted comments about an article involving a man called Arnold Sube headlined "Immigrant who turned down 'small' five-bed house may have more kids".

He offered £2,000 for the "first person to carve" the "piece of s*** into pieces", the court heard.

The aristocrat was today found guilty of two counts of malicious communications at Westminster Magistrates Court and cleared of a third charge.

Queen chooses first black equerry

The Queen has chosen a Ghanaian-born Household Cavalry officer to be her next aide.

It is understood Major Nana Kofi Twumasi-Ankrah will be the royal household's first black equerry, a role which requires him to support the monarch at official engagements such as regional visits and audiences at Buckingham Palace.

The Sunday Times said Maj Twumasi-Ankrah, a

38-year-old Afghanistan veteran known as TA to his friends, moved to the UK from Ghana with his parents in 1982 and studied at Queen Mary University of London and the Royal Military Academy at Sandhurst.

He will start the role later this year, the paper said.

The Queen's Equerry is an officer from one of the armed services, who takes on the role for three years.

Twumasi-Ankrah, 38, told the Sunday Times that as a young child he used to watch the Trooping the Colour with fascination.

He said: "I would have never imagined that one day I'd command the regiment which I'd fallen in love with."

"From what I've seen in the UK, our cultures really do mix and if I'm not a good example of that I really don't know what is."

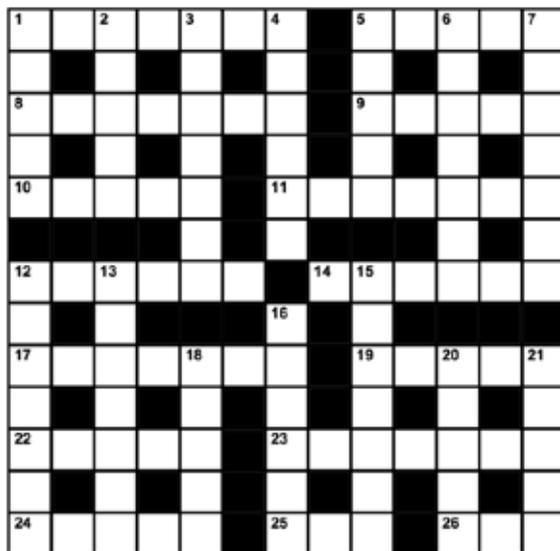

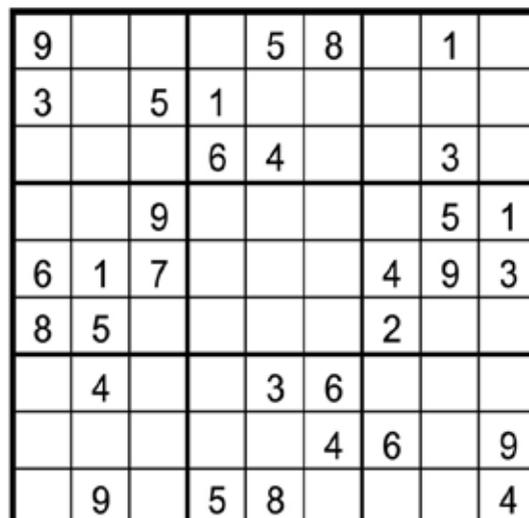

The move completely changed the course of my life. This City has been very good to me. I really do love LA, and I have a new appreciation each time I return from a trip.

What do you miss most from home?

I would have to say Los Angeles is my home now. I do miss Scottish humor and the cheeky banter. I have not been back to Scotland since 1996. Watching Trainspotting 2 recently made me very nostalgic. Plus, I did not need subtitles. I may have lost my accent, but not my cheeky Glasgow

I know, I know, every summer ice-cream is a thing. But this year, there are more and more parlours opening up in and around LA with flavors that you could never have imagined... until now.

So I thought it only fair (and in the name of research, of course) that I go and visit a few of them for you.

1. Salt & Straw. This place looks to be LA's hottest ice cream destination right now, if Instagram is anything to go by. Located at 829 E 3rd St in Los Angeles with a sister location at 1357 Abbot Kinney Blvd in Venice. They have an array of unusual flavors from "Black Olive Brittle" to "Toasted Strawberry"; however my favorite here was just the plain ol' vanilla. Definitely worth checking out!

2. Carmela Ice Cream, 7920 W 3rd St, Los Angeles. These great purveyors of icy deliciousness are kind enough to sell their wares at the Hollywood Farmers' Market on Sundays, so I'm able to stock up without traveling too far. My favorites here are the Salted Caramel, the Blood Orange Sorbet and the Mint Cacao ice cream.

3. Sweet Rose Creamery, 225 26th St (at San Vicente Blvd), Santa Monica. I went to visit these guys recently with my fiancé and a few friends. On this day they happened to be working with a mixologist. He was experimenting with flavors, such as sushi

ice-cream, caviar and balsamic vinegar! To be honest I wasn't a huge fan of the savory ice-cream. But to cleanse my palate I went for the Rose Geranium flavor with the chocolate fudge sauce. Reminded me of a Turkish delight. YUM.

4. Little Damage, 700 South Spring St, Los Angeles. Before stumbling upon this place in Downtown we attempted to check out the Museum Of Ice Cream. But unfortunately we weren't aware that you can't just stroll up. You must have tickets and an appointment time. We were also informed that they are sold out until mid October! And to go visit the website and sign up for their newsletter to get info on when tickets will be come available. Urgh! However I've seen a lot of members have been going and blowing up my Facebook feed with images of them diving into a pool full of sprinkles. So, yes I'm having major FOMO (fear of missing out) about that one. ;) However, I was even more determined than usual because my 11-year-old niece Rainna was on a mission to find the exclusive, rare black ice-cream. She had heard about the wondrous soft-serve place on the grapevine inside the school gates. So I got my personal assistant on the case:

"Siri, were can I find black ice Cream in LA?"

"Hello Craig, I have found one location near you. Little Damage.

Eureka! By jove we found it. We parked up in the lot next door (\$10 FYI)

and joined the massive queue around the block in that dreadful heat last week. Everyone in the line had their cameras and phones at the ready. About 30 minutes later we arrived at the front and found out about all the different flavors... of which there are only four. The coveted black one is called Dark Cinns which boasts a cinnamon flavour. And in case you are wondering, it's charcoal that makes the ice cream black. I also got to try the Unicorn Tears (cake batter flavour) and the Salted Cafveve. (A play on Potus 45's recent Twitter mishap) this was my favourite – it comes in purple-lilac coloring and is not as sweet as some of the others.

So was it worth the wait? Well I am partial to the soft-serve ice-cream over the scoops, as it takes me back to Sunday afternoons after lunch and hearing the odd echoing-sound of the ice-cream man's blaring nursery rhyme music coming down the street. "Mum! Can I please have an ice-cream?" Some days we couldn't have it, but boy, was it good on those days we did!

Oo-er!

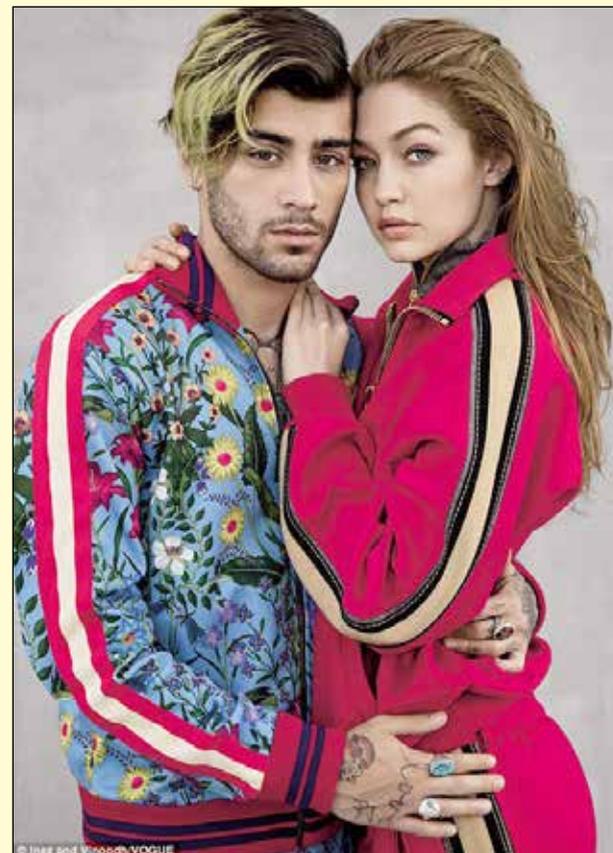
The fashionable pair have collaborated and posed together in the past, but their latest shoot for the upcoming edition of the fashion glossy is next level.

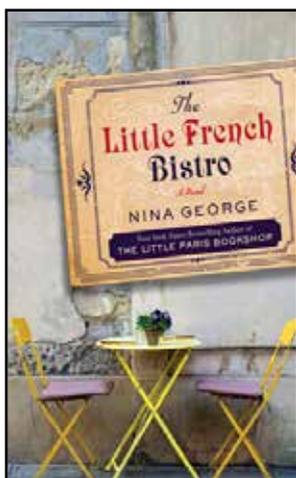

The Little French Bistro: a tasty little tale

■ Exclusive interview with author Nina George about her latest novel, featuring a woman in crisis who leaves Paris for Brittany



"I was sitting near a bar tabac, a mélange of a coffeehouse, bar, and tabac-shop," says *The Little French Bistro* author Nina George.

"Often these places are the heart and centre of a village's market. I was watching some older ladies and gents, coming together out of the bar, a little tipsy. Their friendship was obvious, and I was shot in the heart by how they were

interacting with each other. The story came up like a slap in the face: What if a German woman in the autumn of her life would meet this group of Bretons?"

In this charming new work, Marianne leaves Paris and moves to Brittany. After over forty years of marriage, she needs something more. In Brittany, the locals teach her to take pleasure in life's small moments. It frees her to figure out what she really wants in the time she has left.

"I developed the story of 60-year-old Marianne, who is going on a road trip through France and Brittany, to at least find, at the end of the world, her beginning of the world," says George. "To start in Paris is logic for me, the illusion of Paris: city of romance, free living, culture and so on, has to be broken up by the

truth."

"In literature Paris is often used to set up a very romantic background," says George. "But I had been living there for a short while, and this city is great on one hand, but also depressing, poor, a city where inhabitants fight, with a lot of traffic, with tiny, expensive rooms to live in, with the fear of terror. To have a look under the sweet frosty-topping made it interesting for me. In *The Little Paris Bookshop* as well as in *The Little French Bistro*, Paris is just the beginning of the stories. They are a kind of road movies and inner quests, too."

For her research, George repeatedly traveled through the historic Brittany. "In these periods of research I had been strolling the country, reading Breton legends and myths, learning to

cook the Breton way, and again and again I would sit and watch, talk to people, try to figure out the special mentality, the food, the religions, the secrets of the region. The westernmost of Brittany's four departments still bears the name Finistère, (the end of the world) although some Bretons prefer to call it 'The beginning of the world.' Indeed, according to Celtic legends, this is where the first land rose up from the water and spread around the globe from Brittany to the rest of the world. Regions and landscapes leave marks on the souls of their inhabitants."

George became a journalist and novelist in 1992 at age 18. She has 27 or more published books, fiction and non-fiction, under five pen names. She received a DELIA award in Germany in 2011 for *The Little French Bistro*.

She won the Gläuser Prize for best mystery short story in Germany in 2012. This year she was elected Woman of The Year by the Association BücherFrauen (Women in Publishing).

George combines a daily routine of writing and political activities. She is author rights adviser for the German Writers Association VS and the German PEN-Centre.

"In every country and book market, are some similar and some totally different rules," says George. "The most challenging part is always the cover and the title. I don't believe that you can make a novel for a specific group of readers, who are divided up by age, gender or a sort of emotion. I believe that everyone is a potential reader for any book."

George's next novel in English is *The Book Of*

Manchester United record goalscorer Wayne Rooney has rejoined Everton for an undisclosed fee, 13 years after leaving the Merseyside club.

Rooney, 31, (above) played 559 times for United, scoring 253 goals.

He won five Premier League titles and each of the Champions League,

Europa League and FA Cup once after joining from Everton for £27m in 2004.

Rooney, who has signed a two-year deal, said he was "ecstatic" and his "first game back will be an emotional day".

"It's a great feeling to be back. I cannot wait to meet the lads, get on the training pitch and then get

on the pitch to play," he added.

Rooney's return comes as United look set to sign Everton striker Romelu Lukaku, with a £75m deal for the Belgium international agreed between the two clubs.

Everton confirmed Rooney will wear the number 10 shirt previously worn by Lukaku.

Gatland to honor Welsh contract

Wales head coach Warren Gatland says he will honour his current contract after returning from his second stint in charge of the British and Irish Lions.

The 53-year-old's stock has never been higher after leading the Lions to a thrilling drawn Test series in New Zealand.

Gatland extended his Wales contract in 2013, keeping him in charge until the end of the 2019 World Cup.

"My focus is now on Wales, preparing for the World Cup in Japan," he said.

"I am a firm believer of what will be will be so I won't be looking too far ahead. I am looking forward to the next few years with Wales and then see what other opportunities are out there."

Gatland took the reins with Wales in December, 2007, and led them to 2008 and 2012 Six Nations Grand Slams as well as a World Cup semi-final in 2011.

Welsh Rugby Union (WRU) chief executive Martyn Phillips has said he would be prepared to release Gatland from his contract if the New Zealander wanted to leave, but does not expect him to make such

a request.

Gatland has been tipped as a future All Blacks head coach and has reiterated his intention to see out his current WRU deal.

"My focus is on Wales, for the autumn internationals and then looking towards the 2019 World Cup," he added.

"I'm definitely finishing up there, unless they decide to get rid of me sooner!"

Solanke (above) scored four goals as England won the under-20 World Cup in South Korea this summer.

"It feels amazing and everyone has made me feel welcome already,"

Solanke said.

"Even just pulling on the training top, I was over the moon. Hopefully I can put on the shirt in the near future and make some history here."

Solanke spent the 2015-16 season on loan at Vitesse Arnhem, scoring seven goals in 25 games.

Celtic were also understood to be interested in Solanke, whose only Chelsea game came as a substitute in a Champions League victory against NK Maribor in October 2014.

Walker close to City move

Manchester City are close to completing the signing of Tottenham and England right-back Kyle Walker.

The 27-year-old is expected to have a medical and complete the transfer on Friday after the clubs agreed a deal on Wednesday worth £50m plus add-ons.

Walker, who joined Tottenham from Sheffield United in 2009, will not join up with Spurs for the start of their pre-season training on Friday.

Instead, he will travel with City on Monday to start their tour of the USA.

City boss Pep Guardiola released three full-backs at the end of last season, including both right-sided players - Pablo Zabaleta and Bacary Sagna.

And Guardiola missed out on his preferred target, Brazilian star Dani Alves, who signed for PSG this week.

The defender, selected in the 2016-17 Premier League team of the year, will become City's third signing of the summer,

after the arrivals of midfielder Bernardo Silva and goalkeeper Ederson Moraes.

Swansea City have rejected a £40m Everton bid for midfielder Gylfi Sigurdsson.

Leicester City also had a £40m bid for the player rejected with the club having set a £50m asking price for him.

The player will not go to the United States for Swans' pre-season tour, heightening speculation he is to leave.

"Gylfi did not feel in the right frame of mind to travel due to the current uncertainty over his future," said the Swans on Twitter.

West Ham forward Enner Valencia has joined Mexican side Tigres for an undisclosed fee.

The 27-year-old Ecuadorian signed for the London outfit for £12m in 2014 after impressing at the World Cup, and scored 10 goals in 66 appearances and has failed to hold down a first team place after a promising debut.

England unchanged for second Test Match

England have named an unchanged team for the second Test against South Africa at Trent Bridge on Friday.

The hosts took a 1-0 lead in the series with a 211-run win at Lord's, spinner Moeen Ali taking 10 wickets.

Middlesex bowler Toby Roland-Jones misses out again - seam trio James Anderson, Stuart Broad and Mark Wood bowled just 10 overs between them in the second innings in London.

The teams will play two further Tests at The Oval and Old Trafford.

"It is nice to have options," said captain Joe Root. "This is a side that can potentially play on any surface. It gives me confidence knowing the options are there."

"If it does seem or swing around, we have options and when it spins we have players who can turn it either side."

South Africa welcome back captain Faf du Plessis, who missed the first Test following the birth of his child.

Suspended fast bowler Kagiso Rabada is set to be replaced by Duanne Olivier, while Du Plessis has confirmed that batsman JP Duminy will be left out.

Root says he expects a reaction from South Africa when the second Test begins. The Proteas have only suffered consecutive defeats once since 2009.

"They are a side that pride themselves on coming back from defeats like last week," said Root.

Success at Trent Bridge would give them an unassailable 2-0 lead in the four-match series over a South Africa side they have not beaten in a home series since 1998.

'Back to work' as Murray's repeat dreams are dashed

THERE WAS misery for Andy Murray at Wimbledon on Wednesday, as the injury-racked defending champion tumbled out of the tournament in the quarter finals, losing in four sets to America's Sam Querrey.

The Scot's hopes of repeating as men's singles champion were snuffed out despite his brave battle to overcome a hip problem that has bedeviled him since he was 22.

In the wake of his 6-3, 4-6, 7-6, 6-1, 6-1 defeat, Murray said he would have no rest day and it would be "back to work" immediately, adding that there was "no time to waste" in getting immediate rehabilitation for the hip issue which so sorely affected his performance this week.

The problem clearly flared up during the latter stages of the Querrey match, curtailing his chances of going any further.

Question marks have

been raised about the Scot's ability to return to full fitness for the US Open in six weeks' time, as well as the American hard-court season leading up the final Grand Slam of the season.

However, Murray's camp are confident the issue can be addressed by rest and rehabilitation, while the player himself said he would seek "the best possible medical advice" in a bid to get back to full form and fitness.

Speaking straight after the defence of his Wimbledon crown ended, Murray said: "Tomorrow it's back to work. I'll sit down with my team and discuss the best plan moving forward. There's no time to waste."

Murray's season has been plagued by illness and injury since he moved into the world No1 spot, which he would have conceded to Novak Djokovic had the Serbian won the tournament. Djokovic, too, faces a spell out of the game after

he was forced to retire during the second set of his quarter-final against Tomas Berdych with an elbow problem.

Murray's ranking is also under threat from Roger Federer - the last of the 'Big Four' still standing and now the favourite to win Wimbledon - and Rafael Nadal, despite the Mallorcan's shock fourth-round defeat to Luxembourg Gilles Muller.

After his year to date, Murray admitted he no longer felt he deserved to hold the top spot.

"I haven't played well enough this year to deserve to stay there for much longer," he said. "If it doesn't happen by the end of this tournament [which it now cannot mathematically], it will happen by the end of the US Open.

"It [losing his No1 status] was going to happen at some stage. I don't think anyone has ever stayed at No. 1 their whole career. It always comes to an end."

Venus cuts short Konta's fairy-tale

Briton Johanna Konta's hopes of a first Wimbledon final ended with a straight-set semi-final defeat by five-time champion Venus Williams on Thursday.

The 37-year-old American 10th seed played superbly to win 6-4 6-2 on Centre Court and set up a final against Spain's Garbine Muguruza.

Sixth seed Konta, 26, had hoped to become the first British woman in a Wimbledon singles final since 1977.

"It was very difficult for me to get a good foothold

in the match," she said.

"The few opportunities that I did get, she did incredibly well to take them away from me.

"I don't think I did too much wrong out there. I think it was all credit to her."

Virginia Wade, the last British woman to win the title 40 years ago, said of Konta's loss: "Maybe 41 years will be her number.

"It was sad she couldn't come through in an anniversary year, and it's so long since we had a winner, but I think next year she could make it, or make it to the final

and progress that little bit more."

Williams is the oldest Grand Slam singles finalist since Martina Navratilova finished runner-up at Wimbledon in 1994.

The American, through to her ninth final, won her first Wimbledon title in 2000 and the most recent of her seven major victories came on Centre Court in 2008.

In a tight contest between two of the best servers in the game, Williams worked her way to victory with smarter serving and more effective returns.
