MAY ATTACKS RUSSIA ON PROPAGANDA WAR

■ Moscow using fake news to undermine democracy, says prime minister

Theresa May this week made her most outspoken attack on Russia for using fake news to “sow discord” in Britain and other western nations.

The prime minister accused President Putin of trying to “weaponise information” in the age of social media to undermine democracies. “I have a very simple message for Russia,” Mrs May said. “We know what you are doing.”

In a lengthy charge-sheet of actions that she said risked provoking “dangerous and unpredictable” conflicts, Mrs May accused Russia directly of meddling in elections. The comments risk raising tensions with President Trump, who drew criticism last

week for saying that he believed Mr Putin’s denial that Russia had interfered in the US presidential race.

Downing Street sources said that Mrs May had chosen to go on the offensive after becoming increasingly concerned at intelligence pointing to Russian complicity in online misinformation. Damian Collins, the Conservative MP who is leading a parliamentary inquiry into fake news, has requested data from Twitter and Facebook on Russian accounts that

posted about the EU referendum. The small number of accounts positively identified as Russian could be the tip of the iceberg, he has said.

‘illegal annexation’

The US government, meanwhile, is investigating whether Russian media outlets

such as RT and Sputnik are breaking laws on foreign propaganda.

Addressing the Lord Mayor’s Banquet at Guildhall, in the City of London, Mrs May accused Moscow-backed outlets of spreading lies. “[Russia] is seeking to weaponise information [by] deploying its state-run media organisations

to plant fake stories and photoshopped images in an attempt to sow discord in the West and undermine our institutions,” she said.

The prime minister touched on the Brexit negotiations only briefly as she said that she was determined to maintain close security ties with European countries

and pledged increased defences against Russian aggression.

She said: “Russia’s illegal annexation of Crimea was the first time since the Second World War that one sovereign nation has forcibly taken territory from another in Europe. Since then, Russia has fomented

May facing Tory revolt over firm Brexit date

A cabinet minister has given the strongest signal yet that the government is set to ditch its controversial plan to enshrine in law the date that Britain will leave the European Union.

David Lidington,

the justice secretary, on Wednesday indicated that the recently unveiled amendment to the EU Withdrawal Bill, which is at committee stage in the Commons, could be pulled as the threat of a government defeat looms.

About 20 Tory MPs - enough to overturn the slim majority Theresa May holds with the aid of the Democratic Unionist Party - are thought to be willing to vote against the amendment. It would write on the statute book a time for the withdrawal from the bloc of 11pm on March 29, 2019. The would-be rebels believe locking the date in stone is unnecessary and could tie the hands of UK negotiators.

Mr Lidington, a former Commons leader, suggested the government was listening in the face of vocal opposition from the backbenches over the amendment.

Speaking to reporters in Westminster, he was asked whether the amendment would be withdrawn and said: "[It's] hypothetical but, as the PM said, there are various constructive suggestions that have been made during the committee debates about how the bill might be improved and obviously we'll listen to ideas coming from colleagues across the house during the bill's progress in both the Commons and Lords.

"All that clause was designed to do was to clarify and put beyond doubt what was already inherent in Article 50.

Now Article 50 says that after two years from the date of notification, unless there is a withdrawal agreement that comes into effect earlier, that after the two-year point the treaties cease to apply to the country that is leaving. So that is written into European law."

Mrs May unveiled

the proposal last week, saying in an article for The Daily Telegraph: "Let no-one doubt our determination or question our resolve, Brexit is happening. It will be there in black and white on the front page of this historic piece of legislation."

David Davis, the Brexit

secretary, added: "Our amendment makes it crystal clear that the UK is leaving the EU at 11pm on March 29, 2019.

"We've listened to members of the public and Parliament and have made this change to remove any confusion or concern about what 'exit day' means."

conflict in the Donbas, repeatedly violated the national airspace of several European countries, and mounted a sustained campaign of cyberespionage and disruption. This has included meddling in elections and hacking the Danish Ministry of Defence and the Bundestag, among many others."

Mrs May added that Britain was trying to ensure "the profits of corruption cannot flow from Russia into the UK" as well as raising cyberdefence spending.

Her intervention comes as it emerged that a Twitter account identified as a Russian bot in evidence to Congress tweeted an image of a hijab-wearing Muslim woman crossing Westminster Bridge apparently ignoring a prone victim of the terror attack on March

22.

The @SouthLoneStar account, which supposedly belonged to a Stetson-wearing "proud TEXAN and AMERICAN patriot", shared the image, which went viral, saying: "Muslim woman pays no mind to the terror attack, casually walks by a dying man while checking phone #PrayForLondon #Westminster #BanIslam."

The tweet was quoted in news reports, when the unnamed woman said she was dismayed by the misrepresentation. The account, which had 16,800 followers, also posted about Brexit.

Yin Yin Lu, of the Oxford Internet Institute, told The Times that at least 54 accounts on the list of 2,752 linked by Twitter to the Internet Research Agency in evidence to Congress tweeted about Brexit. The agency is a Russian state-backed "troll factory" in St Petersburg.

Economy keeps booming...

BRITAIN'S economy hit a six-month high last month thanks to rising demand and low unemployment, a survey showed this week.

Wales led the way, with the quickest growth rate for the second month in a row as output rose to a nine-month peak. It was closely followed by the North-west and the East of England, which both recorded sharp expansion, while growth in North-east England reached a 10-month high.

The latest Lloyds Bank Regional Purchasing Managers' Index is seen as an important "health check" indicator of business confidence and activity. Factors that it takes into account include employment, prices and

manufacturing costs. Only the South-east of England, the East Midlands and Northern Ireland showed a slower rate of growth than previously, but they were nevertheless still growing. The latest figures show that the UK hit a six-month high of 55.8 in October - just under the of 56.2 recorded in April. A reading greater than 50 represents growth.

Scott Barton, managing director of Mid Markets at Lloyds Banking Group, said: "The fourth quarter of 2017 started positively, with business activity growth accelerating across England, Scotland and Wales. There was also an increase in employment as firms responded to higher demand for goods

and services, though the pace of job creation slowed for the second month running."

All parts of the country recorded an increase in employment in October, most strongly in Yorkshire and the Humber and in eastern England, although the overall pace of job creation in the UK dipped to a four-month low. The survey also showed the steepest rise for six months in average prices charged for goods and services, as businesses seek to offset the impact of higher costs. The survey, compiled by IHS Markit for Lloyds Bank Commercial Banking, was based on questionnaires sent to purchasing executives in more than 1,200 private manufacturing and service companies.

Leading baker facing boycott over sausage roll in the crib

CUSTOMERS were urged to boycott leading British baker Greggs this week after it replaced Jesus in his crib with a sausage roll for a nativity scene to advertise its advent calendar.

The £24 calendar is available in selected shops and behind each door is a voucher for one of its treats. The firm's decision to use a publicity image of the Three Wise Men around the crib containing a sausage roll has sparked outrage.

Reverend Mark Edwards, of St Matthews and St Cuthberts churches in Newcastle upon Tyne, felt so strongly about the "shocking, offensive" picture he wrote a letter of complaint to Greggs. He is also calling for customers to boycott the bakery chain. He said: "I think this advert is appalling, disgusting and I know Greggs wouldn't dare treat

another religion in this way.

"This is an affront to millions of Christians.

"I would challenge Greggs to do the same thing to any other religion. They simply would not do it. I would challenge them to release a similar stunt during Ramadan and face the backlash. It would be huge."

Greggs released its annual festive advent calendar on Monday and almost immediately faced a torrent of criticism over the image which appears to show the three wise men bearing gold, frankincense and myrrh, kneeling down beside the sausage roll.

On Tuesday a Greggs spokesman said: "We are really sorry to have caused any offence, this was never our intention." The Rev Edwards added: "I will be encouraging my flock to boycott Greggs and I will never go there again."

I beat my wife, admits Kate's uncle

■ Gary Goldsmith knocked wife unconscious during argument over cocaine

The Duchess of Cambridge's uncle attacked his wife after a row during which she accused him of taking cocaine, it was revealed this week after he pleaded guilty to assault.

Gary Goldsmith, the younger brother of the duchess's mother, Carole Middleton, hit his wife, Julie-Ann, with a powerful "left hook", Westminster magistrates' court was told.

Mrs Goldsmith, 47, was left unconscious on the pavement outside their home after the couple had returned by taxi from a charity auction at Home House, a private members' club in Marylebone, central London, last month. The prosecution is seeking a restraining order to ban Goldsmith from contacting his wife.

'quite rude stuff'

The taxi driver who witnessed the attack has described how the couple were rowing during the journey to their home, also in Marylebone. Daniel Shepherd told *The Times*: "All the way they were arguing, saying quite rude stuff. She was accusing him of sniffing loads of cocaine. She was saying, 'I haven't seen my husband for a week and you go and leave me at the party'."

Prosecutor Kate Shilton said when the couple got out of the vehicle at their home near Oxford Street in central London, Mrs Goldsmith slapped her husband. He retaliated with a "left hook" and she fell down. A witness said Mrs Goldsmith appeared unconscious and had her eyes closed for about 15 seconds before getting up and staggering to her feet. Ms Shilton said: "She then becomes upset, starts crying and uses some railings to assist her."

After the fight at around

1.20am on October 13, Goldsmith was described as "panicked and walking in and out of the house, trying to get her to go back in." The court was told that when Mr Shepherd challenged Goldsmith he again became aggressive and Mrs Goldsmith asked the taxi driver to call the police. At a police station, Goldsmith told officers he had pushed his wife hard with his left hand but denied using a hook punch. Magistrates heard that he was apologetic for his actions.

Goldsmith, who attended court in a blue suit, red tie, and heavy blackrimmed glasses, will be sentenced at the same court on November 21. The maximum sentence for the charge is six months in jail, but

chief magistrate Emma Arbuthnot ruled that out, telling the court: "I am excluding custody and looking at a community order. "But I am really looking at how to protect this lady from this man."

'captain ambitious'

A self-made millionaire, Goldsmith made his fortune from sports management and IT recruitment and was at one stage estimated to be worth £30million. Julie-Ann is his fourth wife. He married sales executive Miranda Foote in 1991, then a second wife Luan, with whom he had a daughter, Tallulah, in 1997. After he and Luan divorced, he married Julia Leake following a whirlwind romance. She left him and he later met

and married Julie-Ann in 2012.

In 2005, he sold his shares in firm Computer Futures for £17million and bought a villa in Ibiza. He called it "La Maison de Bang Bang" and in 2006 Kate and Prince William holidayed there as his guests while they were still single. Goldsmith once described the differences between himself and his sister by saying: "I'm the City yuppie and she's the country girl.

"While I was driving a Lotus Esprit in my Gucci shoes, she had an Alfa and wore Hunter wellies. "I used to call her the 'original Sloane Ranger' while she called me a 'tearaway' or 'scamp'. I'm a Thatcher child. I'm Captain Ambitious."

The changing of the guard

Charles takes over Remembrance duty as teary queen looks on

SHEDDING a tear in the bitter cold, the Queen watched a Remembrance Day service as Prince Charles led the nation in honouring Britain's war dead on Sunday.

In a historic transfer of royal duties, the 91-year-old monarch stood beside Prince Philip on a Foreign Office balcony as Charles – in the uniform of Marshal of the RAF – laid the first wreath on behalf of his mother. She and her consort, with whom she will celebrate 70 years of marriage on November 20, watched the service at the Cenotaph, central London, alongside the Duchess of Cornwall.

On a neighbouring balcony the Duchess of Cambridge joined Sophie,

Countess of Wessex, and the Queen's cousin Princess Alexandra to watch a ceremony that marked the changing of the royal guard. In the corner of the balcony, Philip, at 96 one of the last survivors of the Second World War to be present at the service, looked frail and uncomfortable. Wearing the uniform of Admiral of the Fleet, he appeared to struggle to stand at times. An equerry laid Philip's wreath before Charles, who turned 69 on Tuesday, returned to lay his tribute of red poppies at the foot of Sir Edwin Lutyens's monument to the fallen in Whitehall.

The Duke of Cambridge, wearing an RAF squadron leader's uniform, and

Prince Harry, in the uniform of a captain in the Household Cavalry's Blues and Royals, also laid wreaths.

On a chilly autumn morning, 10,000 veterans, their medals proudly pinned to their chests, and serving military personnel paraded in Whitehall. Prime Minister Theresa May and Labour leader Jeremy Corbyn both bowed at length after laying their wreaths. Former Prime Ministers David Cameron, Gordon Brown, Tony Blair and Sir John Major also attended the ceremony.

parade took place there on Sunday. The march was diverted and wreathlaying at the County Tyrone town's cenotaph was postponed after the area was sealed off. In 1998, a bomb planted by the Real IRA killed 29 in the busy market town. Northern Ireland Chief Constable George Hamilton described the pipe bomb as "sickening and appalling".

Latest report confirms heavy Russian influence on Brexit vote

A NEW REPORT from Swansea University this week has revealed the astonishing extent of Russian interference in the Brexit referendum and is expected to increase calls for an official inquiry.

Tracking 156,000 Twitter accounts in Russia, the research found that their mentions of #Brexit spiked on the day of the vote and the day after, before dropping off almost entirely. The accounts include genuine commentators but many appeared to be either fully automated bots or semi-automated "cyborgs" — bots with some human involvement.

Researchers at the college pinpointed the Russian town of Gelendzhik, on the banks of the Black Sea, which has a population of 55,000, as a hotbed

of propaganda for the Leave campaign. According to Twitter, one of its inhabitants is Svetlana Lukyanchenko, a voracious user of the social platform who signed up in May 2016 — less than a month before Britain voted to leave the European Union.

Sveta1972, as she called herself online, did not fit the profile of someone interested in British politics. Yet in the four days before the vote on June 23 she posted or retweeted at least 97 messages mentioning "#Brexit".

Her messages were mainly pro-Brexit and often repeated conspiracy theories. On June 21 she retweeted a story by the website Zero Hedge that said Britons were "appalled and disgusted" by a Brexit postal ballot "fraud".

Later that day she tweeted that the EU was an "unelected assembly of corporatist agents" imposing debt and austerity "on all member states".

After the vote she lost interest, confining her 12,000-plus tweets to subjects such as lighting design websites or free e-books on web traffic. Despite her Russian origins, most of her tweets were in English, Spanish or Italian.

Another prominent Tweeter was Stormbringer15, a virulently pro-Kremlin Twitter power-user with 241,000 posts mainly asserting Russia's rights over Ukraine. On the day after the referendum he tweeted a fake picture of President Putin giving a medal to Nigel Farage.

The findings will fuel concerns that the Russian

state has weaponised social media.

Damian Collins, chairman of a parliamentary committee investigating fake news, said that he had written to Facebook and Twitter to ask for "urgent clarification and information regarding Russian-linked accounts".

Separate research from the Oxford Internet Institute and City University has revealed the scale of bot activity around Brexit. Oxford researchers found that 30 "highly automated" accounts posted 135,597 tweets from June 20-24. These were viewed about 11 billion times. While there is no direct connection between the bots and the Russian state, intelligence officials in Britain and the US are confident that many have

been backed by Moscow.

The most active account over Brexit was the apparently London-based Israel Bombs Babies, which had tweeted 1.55 million times since joining in September 2011. On the day of the vote, it tweeted 492 times about Brexit.

Ben Nimmo, from the Atlantic Council's digital forensic research lab, said that such content was typical of a Russian troll factory. "Pro-Russian, pro-Assad, pro-Ukraine rebels, anti-Clinton, anti-Nato, anti-White Helmets, anti-EU," he said. "The question is whether it's pro-Kremlin or actually Kremlin-run; that's something which only Twitter can answer definitively."

Twitter has divulged to US investigators 2,752 accounts believed to be linked to Russia's Internet

Research Agency, a "trolling" organisation in St Petersburg. Employees there were told to amplify "negative attitudes" towards the EU, leaked documents show.

Russian-linked bots also left messages supporting Remain. "They just stirred up dissent and discord in order to weaken this country and make themselves stronger," Keir Giles, senior consulting fellow at Chatham House, said.

"It is possible to determine with a reasonable degree of confidence whether an account is being run by Russia by observing their behaviours. But we cannot be clear on the national security challenge until we have full access to the data available."



'Sexual' robin redbreast Christmas cards banned by Facebook

■ Jackie Charley has said she 'could not stop laughing' after harmless festive images were blocked by Facebook because of 'adult' nature

Facebook has blocked the sale of a pack of Christmas cards featuring a robin redbreast because of its "sexual" and "adult" nature.

The artist, Jackie Charley, from Kelso in the Scottish Borders, said she "could not stop laughing" when she discovered the reason the social media company would not approve the product last month.

The bird, with its distinctive red and orange breast, was one of three designs painted by Charley of animals in the snow for the set. The others were a stag and a squirrel.

But Facebook blocked what it perceived as an "adult item" after the artist attempted to upload the image to her Bothycrafts page.

In a post on her Facebook page, Charley said she was sent the message: "It looks like we didn't approve your item because we don't allow the sale of adult items or services (e.g. sexual enhancement items or adult videos)."

The 52-year-old wrote: "Hilariously, Facebook has blocked my Christmas cards from becoming a product in my shop due to their shameful, sexual nature! Please judge for yourself! (Can't stop laughing!) And if

you'd like a pack of six at £5.99 plus postage and packaging let me know."

Charley said the move had left her mystified, as she could not understand why the paintings were considered inappropriate.

She said: "There's obviously nothing in the images themselves which is inappropriate. Similarly, there were no 'trigger' words used in the cards' descriptions that I'm aware of. For instance, the robin card was simply called 'Robin', not 'Robin Redbreast' as some people have wondered.

The artist said she had not had any direct response from Facebook, but the interest generated from the gaffe had led to a lifting of the initial ban.

The odd decision is one in a string of recent judgment-related blunders committed by the social networking site recently.

Recently a photo showing a statue of Roman sea god Neptune was also not approved after being deemed "explicitly sexual". Elisa Barberi, a local writer, attempted to post them on her page earlier this year.

And until 2012, Effin, a small village in Limerick, was deemed "offensive" by the site and users were prevented from listing it as their registered "homeplace".

British surfer escapes shark by punching him Down Under

A BRITISH doctor surfing in Australia fought off a shark with a punch on the nose after learning the escape technique from an online video clip.

Charlie Fry, 25, was at Avoca beach north of Sydney when the shark leapt out of the water and bit his arm. He heard a "massive thud" and initially thought it was a friend playing around. Dr Fry, who was based in Southampton before moving to Australia two months ago, said: "I turned to the right and I saw a shark's head come out of the water with its teeth and I just punched it in the face. I got back on my board, shouted at my friends who were there and managed to catch a wave in, so it was a bit of a close call."

He added: "I didn't feel the teeth going in, it felt like

I was smacked, it felt like a hand, a hand grabbing me, shaking me. "I didn't really notice it at the time, because when you're surfing, all I was thinking was 'I'm about to die', and I was just thinking about getting in [to shore] as fast as possible."

The novice surfer had remembered a YouTube clip of Australian surfer Mick Fanning, who famously punched a

shark to survive an attack during a competition in South Africa in 2015.

He said: "Me and my friends have just started surfing and we saw the YouTube clip of Mick Fanning saying he punched a shark in the nose. So when it happened I was like, 'Just do what Mick did.'" He added: "If you are watching or listening, Mick, I owe you a beer. Thank you very

much."

Dr Fry was treated for minor scratches and bite wounds by colleagues at Gosford Hospital, New South Wales on Monday. The beach at Avoca was closed after a 10ft bronze whaler shark was spotted near the site of the attack. Dr Fry, who is originally from Bury St Edmunds, Suffolk, said he plans to return to surfing as soon as his wounds heal.

11th hour deal ends court case for Mel B

MEL B settled lawsuits against her estranged husband and their former nanny this week, averting a damaging trial at the last minute.

The former Spice Girl, 42, had claimed that Stephen Belafonte subjected her to years of physical and mental abuse and their former nanny, Lorraine Gilles, conspired with him to threaten to release explicit videos of her.

But Mr Belafonte, 42, and Ms Gilles denied the allegations, while Mr Belafonte claimed his estranged wife's "habitual and consistent addiction" to cocaine and alcohol was a major issue in their marriage.

The Leeds-born judge on *America's Got Talent*, real name Melanie Brown, applied for restraining orders against the pair after she filed for divorce in Los Angeles' Superior Court. A trial was due to hear further damaging

claims and view intimate videos involving the singer on Monday morning, but the parties reach a settlement late Sunday evening.

Judge Mark Juhas told the court the case had been resolved and the temporary restraining orders dissolved.

A source close to Mr Belafonte said the agreement included "substantial custodial time" with his six-year old daughter with Brown.

Brown married Belafonte, a film producer, in Las Vegas in June 2007.

She filed for divorce in March, citing irreconcilable differences and detailing allegations of domestic abuse.

Ms. Brown's lawyer told the court his client had been drugged by Mr. Belafonte throughout much of their relationship.

Belafonte denied the allegations and claimed Brown suffered from cocaine and alcohol

addiction, describing it as a "major issue" in their marriage.

It has also been claimed that Brown led an "extravagant" lifestyle and had "wiped out" a \$50m (£39m) Spice Girls fortune.

Leeds-born Brown shot to fame in the 1990s as Scary Spice, and was the subject of her own reality show called *It's A Scary World*, which documented her life with Belafonte.

Lastly, how can we find out more about you? Are you working on anything at the moment?



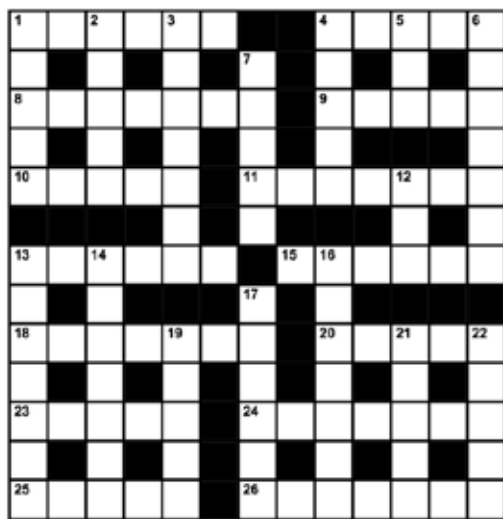
KARINA DIGLYTE: regular at The Comedy Store

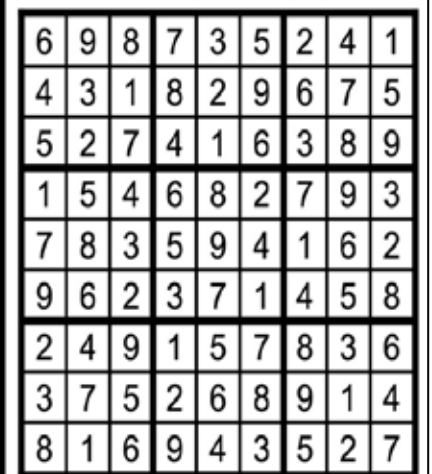

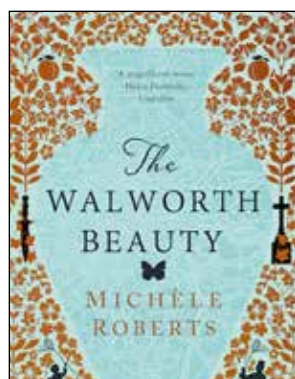

The Walworth Beauty: two stories intertwined

■ Exclusive interview with author Michèle Roberts discussing her new novel about a Victorian house of ill-repute



"I had a waking reverie," says *The Walworth Beauty* author Michèle Roberts.

"An image of a man walking upstairs in a dark house, previously unknown to him, following a young woman bearing a lit taper, up towards a closed doorway. It was the 19th century, I knew. I just had to follow him and find out what happened when he opened that door and entered that room...I had

to write the novel."

It's 1851 in Victorian England. Joseph Benson has been employed by Henry Mayhew to help research his articles. Joseph had lost his previous job due to illness, so this opportunity is a godsend. But his job is not exactly easy. He's interviewing prostitutes about their lives. In Apricot Place he meets Mrs. Dulcimer, who runs a boarding house. She's a wealth of information. Meanwhile, in 2011, Madeleine has lost her job and decides to move from London into the Walworth cul-de-sac of Apricot Place. She comes across the work of Henry Mayhew, who wrote about the area she now lives in. As she learns more, their two stories intertwine.

"I'm fascinated by

how lost memories suddenly re-erupt into the present," says Roberts. "In literary terms, I'm fascinated by how past and present in a narrative can haunt each other and result in ghost stories. Ghost stories always work retrospectively: a troubling image is made sense of by becoming surrounded with a story. For me, the unconscious is always part of writing stories...what we want to say, what we forget, what we feel scared of telling. This can include questions around sex, desire, exploitation, power...all the ambiguities attending those."

"A second inspiration was moving flats, to southeast London, to an 1830s building," says Roberts. "Imagining the women who had worked

in the basement that formed my flat, that had been the kitchen area."

In her research into the unrecorded lives of working-class women in 19th century London, Roberts re-read Mayhew's contemporaneous work on working-class people in London, *London Labour and the London Poor*.

"In particular I re-read his *Volume Four: Those That Will Not Work*, which included his reports on the testimonies of young women selling sex in order to survive," says Roberts. "I read a great many secondary historical sources on 19th century life in London. I relied on 19th century novels. I looked at maps, for example, in the John Harvard Library in Borough, southeast London."

Roberts has written

over 20 books. Her work includes novels, short stories, poetry, memoirs, artist's books, pamphlets, essays. She writes about literary journalism regularly. She's written for TV. She won the W.H. Smith Literary Award 1993 for *Daughters of the House*, which was also shortlisted for the Booker Prize 1993. Her first novel, *A Piece of the Night*, won the Gay News Book Award in 1978. Her short story collection, *Mud: Stories of Sex and Love* was shortlisted for the Edgehill Award. Her novel *Ignorance* was selected for the IMPAC Award and the Orange Prize.

Roberts memoir *Parer Houses* was a BBC Radio Book of the Week. Her novel *Flesh and Blood* was adapted for radio. *The Walworth Beauty* has yet to be optioned for film or

Change at the top likely for Ireland after Denmark debacle

Republic of Ireland manager Martin O'Neill will speak to the country's football association about his future after failing to reach the World Cup.

The Republic were trounced 5-1 by Denmark in the play-offs this week. In October, O'Neill and assistant Roy Keane agreed contract extensions to remain until the Euro 2020 campaign. "I thought there was an agreement. I'll speak to [FAI chief] John Delaney - I've not spoken to him since we spoke about the new contract," said O'Neill.

O'Neill and Keane were appointed in November 2013 after the departure of previous boss Giovanni Trapattoni. They guided the Republic to Euro 2016, losing to France in the last 16.

Defender Shane Duffy gave the Republic - who last played at a World Cup in 2002 - an early lead, but Denmark hit back through Cyrus Christie's own goal, Christian Eriksen's superb hat-trick and Nicklas Bendtner's late penalty.

"I am really disappointed," said O'Neill. "We were well beaten in the end after a good start.

"We could have made it 2-0 but the two goals we conceded in the space of a couple of minutes knocked us for six. They were very poor goals and turned the tide.

"We were chasing the game and needed goals to get back into the game but as we were trying to press, Denmark took advantage. They deserved to go

through after beating us convincingly."

Former Leicester and Celtic manager O'Neill's style of play has often been criticised, and his side scored three or more goals in a single game just once in their 12 qualifying and play-off matches.

O'Neill - a two-time European Cup winner as a player who has won nine major trophies in management - took exception to being asked

if his luck had run out because of his cautious approach.

"That is simply not true," he said, adding he had not won the "trophies that I have won both as a player and manager" because of luck.

"I don't agree with our luck running out, it was a commendable effort by the team. They are technically better than us and had a world-class player [Eriksen] in their team."

suitable for the job," former Scotland boss Craig Brown said this week. "He's got a very good international CV, particularly good with European football, and it's exactly what Scotland need.

"He's picking players from the lower echelons of both England and Scotland with minimal resources. I think the Scotland [resources] should be better, so I would think he would do equally well or better with Scotland."

Asked how O'Neill might handle the media scrutiny in Scotland, Brown added: "He lives in Scotland so he will have seen what Gordon Strachan has been subjected to. He will have to make his

name in Scotland, and that depends on a few positive results."

O'Neill won only one of his first 18 matches in charge of Northern Ireland, but has won 17 and drawn eight of his 35 matches since September 2014.

O'Neill's Northern Ireland assistants are also based in Scotland. Austin MacPhee is assistant manager at Hearts, while Jimmy Nicholl is assistant boss at Falkirk.

SFA performance director Malky Mackay took charge of Scotland for a friendly defeat by Holland last week, but chief executive Stewart Regan had already ruled him out of the running to succeed Strachan on a long-term basis.

Scotland have not been to a major tournament since the 1998 World Cup.

Under Strachan, Scotland were unbeaten in their final six

qualifying matches but finished third behind group winners England and Slovakia.

Southgate: We're winning them over

■ English public getting behind national team again, insists coach after draws with Germany and Brazil

England's displays against Germany and Brazil have helped "change the wind of public feeling", says boss Gareth Southgate.

Southgate handed out six debuts as a youthful Three Lions recorded back-to-back goalless draws against the world's top two sides at Wembley in the past week.

Last month, England's poor display in a home win over Slovenia drew mockery from some sections of the crowd.

"I hope the English public will see they gave everything," said Southgate.

"I would hope there's a little more of a connection, it feels like a little connection between supporters and the team."

With a host of regulars absent through injury and several more overlooked, Everton goalkeeper Jordan Pickford, 23, midfielder Ruben Loftus-Cheek, 21, who is on loan at Crystal Palace from Chelsea, and Liverpool defender Joe Gomez, 20, seized their chance to prove themselves.

"I think they've succeeded in changing the wind of public feeling," said Southgate.

"That's a huge credit

for the way they've taken responsibility.

"They've shown belief, they've worked for each other and they've dug in.

"I know they're basic qualities but they're qualities we've been accused on not having in the past. They've shown them in abundance."

England's next friendlies are against Netherlands in Amsterdam on 23 March 2018, before they host Italy at Wembley four days later.

"We're showing people what youth development in our country can produce," added Southgate.

"We've given these

Scots hope to lure away O'Neill

The Scottish Football Association has made an official approach to its Northern Ireland counterparts for permission to speak to Michael O'Neill.

O'Neill, 48, is the SFA's preferred candidate to succeed Gordon Strachan as Scotland manager. Strachan left in October following Scotland's failure to reach the World Cup play-offs.

In an attempt to retain O'Neill as manager, the Irish Football Association has offered him an

improved contract.

O'Neill has been in charge of Northern Ireland for six years but just missed out on World Cup qualification.

The former Brechin City and Shamrock Rovers boss is under contract until 2020, on a deal believed to be worth £500,000 a year.

O'Neill is also reportedly in the frame for the vacant manager's position at Sunderland.

O'Neill, who lives in Edinburgh, guided Northern Ireland to Euro

2016 - their first major finals since the 1986 World Cup.

He steered them to second place behind Germany in a World Cup qualifying group that included the Czech Republic and Norway, only to lose out on a place at Russia 2018 after a 1-0 aggregate loss to Switzerland in a play-off.

Northern Ireland are currently 23rd in the Fifa rankings, six places above Scotland.
