# BRITAIN IN GRIP OF KILLER FLU

## Outbreak could be worst for 50 years, say experts

Britain is on the brink of the worst flu epidemic for half a century as a deadly new strain spreads across the country.

The virulent disease could prove as deadly as Hong Kong flu in 1968, which killed a million people worldwide, experts warned on Monday. The elderly are feared to be most at risk because vaccines are not providing enough protection. At press time just five areas of the country were free from all strains of the disease – including the feared H3N2 Aussie strain. The number of people being treated in hospital for flu tripled over the Christmas week. Now it is feared NHS chiefs may be forced to cancel more operations and appointments to cope with a surge of patients in the coming weeks. Hospital bosses have so far been forced to delay around 55,000 procedures.

Professor Robert Dingwall, from Nottingham Trent University, said: "The problem with the Aussie

flu is that the vaccine is not as good as it is for the other strains because it is a new strain.

"By the time the new Aussie strain had been identified, this year's vaccine had already been manufactured.

"We are looking at a flu season that is likely to be worse than last year.

"It is too early to say it could be the worst flu season in a generation. But it could be if the Aussie strain really takes hold.

"It might mean the system remains at this intensity for another four to five weeks instead of returning to normal as we would expect. That could mean elective surgery has to be cancelled well into February."

Public Health England data shows flu-related hospital admissions tripled from 2.33 per 100,000 people to 6.82 between Christmas Eve and New Year's Eve. This

suggests the number of flu patients in hospital soared from 1,280 to 3,750 in just one week, with 17 said to be in intensive care. Fears of fatalities have been growing after the lethal virus claimed its first victims in Ireland. In France at least 30 people have died and 11,500 treated in hospital.

Areas worst hit in the UK include Portsmouth, Plymouth, Dundee, Doncaster, Chelmsford, Northampton and Canterbury. But Dorset, Ilford, the City of London and two smaller areas have reported zero cases. Professor Helen Stokes-Lampard, chairwoman of the Royal College of GPs, said: "Whilst this is currently within seasonally expected levels, we are also hearing anecdotal reports of increased demand at surgeries.

"We want to reassure patients that the influenza

vaccine remains the best protection. It is not too late for patients to receive their vaccination."

Professor Paul Cosford, Medical Director, Public Health England, said: "As we would expect at this time of year, flu levels have increased.

"The vaccine is the best defence we have against the spread of flu and it isn't too late to get vaccinated."

Aussie flu symptoms include a sore throat and cough, headache, fever, muscle ache, fatigue and sneezing, but some patients have told how they vomited and had hallucinations.

This week Theresa May was forced to defend the Government's record on the NHS, insisting it had "put the money in that was asked for". But she told the BBC's Andrew Marr Show: "Of course nothing's perfect and there is more for us to do."

# Fewer jobs for the boys as May shuffles her Cabinet

More women and ethnicities at the table as embattled MP unveils 'new generation' of ministers

Theresa May has sought to shake up her tottering government with a significant reshuffle which, she says, looks "more like the country it serves" with a "new generation" of ministers brought in.

The PM has appointed several new faces to her ministerial team in addition to several cabinet-level changes on Monday.

These triggered the resignation of education secretary Justine Greening and were branded a "lacklustre PR exercise" by Labour.

Of Tuesday's appointments, six men and eight women were new additions to government, including five from ethnic minorities and 11 who were elected in 2015.

## 'talent pipeline'

Six of the women - all elected in 2015 - have been appointed as junior whips, who will be involved with enforcing party discipline.

Downing Street said that following the reshuffle there were more women attending cabinet, more female ministers and more members of the government from ethnic

minorities.

The number of women who are full cabinet members has remained the same as before at six.

But the number of other senior female ministers also attending cabinet has risen from two to four, taking the total number of women around the table to 10.

The talk in Downing Street is of a new "talent pipeline", the jargon for bringing on a new generation to be ready whenever big jobs available next time round.

But there is a lot of muttering among MPs about the overall logic of the reshuffle. Some individual decisions seem puzzling - moving Rory Stewart from International Development, in which he is regarded as a proper expert - to the prisons brief for instance.

Two of the more head-shaking decisions were making the up-and-coming Brexiteer lawyer, Dominic Raab, the new Housing Minister as was promoting Esther McVey to secretary of state in a department she already controversially served in, DWP, where she was near the top of the Labour hit list.

The changes also

include Jo Johnson being moved from his universities role to transport, and Suella Fernandes becoming a minister in the Department for Exiting the EU.

## 'pointless and lacklustre'

The most high-profile cabinet ministers all kept their jobs in the reshuffle, in which Health Secretary Jeremy Hunt is believed to have persuaded the PM to keep him in post with a beefed-up role rather than move him to another department.

But within Westminster this week's changes were seen as little more than window-dressing and unlikely to be able to arrest the government's slide the polls. The shuffle had done little to change the prevailing media narrative - namely that the Conservatives will lose their razor-thin majority sometime next year, prompting a general election which Jeremy Corbyn is likely to win.

But Conservative deputy chairman James Cleverly was more sanguine about his party's future, telling the BBC on Thursday he was not worried about the hostile newspaper headlines generated by the reshuffle.

"Today and yesterday were about reshuffles and that always causes lots of froth and drama in the media," he said.

"Today's headlines are what they are - tomorrow and onwards we will be getting the really important stuff which is about what we are doing, what we are delivering in government."

Alan Milburn, the former Labour minister who was until recently the government's social mobility tsar, said Ms Greening's departure was "a loss as far as social mobility is concerned", saying she had been "actually getting on and doing something".

Scottish Conservative leader Ruth Davidson also said she was sorry to see Ms Greening leave. In her resignation statement on Monday evening, Ms Greening said: "Social mobility matters to me and our country more

than a ministerial career."

Labour leader Corbyn added: "The government's big plan for the new year is to dodge the real issues and reshuffle the pack in a

pointless and lacklustre PR exercise.

"It's simply not good enough. You can't make up for nearly eight years of failure by changing the name of a department."

## IT WASN'T ALL BAD...

The first polar bear to be born in Britain for 25 years is being cared for by its mother in Scotland. The cub's mother Victoria gave birth at the Highland Wildlife Park, near Kingussie, last month. Little is known about the newborn because polar bear cubs are particularly vulnerable in the first three months of life, so keepers are only getting close enough to check that the drinking water outside the den hasn't frozen. Weighing little more than a guinea pig, newborns open their eyes only after their first month; this cub is expected to remain in its den until late February at

the earliest.

The Government has backed a plan to plant 50 million trees in a 120-mile corridor between Liverpool and Hull. The Northern Forest will be a mix of native broadleaf trees and conifers, and is intended both to create a habitat for bats, birds and red squirrels, and to be within reach of human visitors from Leeds and Manchester. Ministers have pledged £5.7m to the project, which is expected to cost £500m; the Woodland Trust has committed £10m. Planting is to begin in March.

## Trump calls off London visit

Donald Trump has backed off the idea of visiting Britain next month to open the new US embassy in London amid fears of mass protests.

Government sources suggested that Washington had signalled that secretary of state Rex Tillerson would instead open the multimillion-pound embassy.

Theresa May invited Trump for a state visit when she became the first world leader to visit the president in the White House a year ago.

With activists pledging to stage mass protests and MPs determined not to give the president the opportunity to address parliament, no date for a state visit has been set.

Instead, it had been expected that Trump would make a brief, less formal "working visit" next month, to cut the ribbon on the \$1bn (£750m) embassy in Nine Elms, south-west London, and hold meetings with May.

Officials had been examining plans for the president to meet the Queen, without the pomp of a full-blown state banquet, with the attendant risk of disruptive protests.

However, even that more modest plan now appears to have been abandoned for the time being.

Trump confirmed on Twitter late on Thursday night that the trip was off, blaming the "off" location of the new London embassy.

Relations with the controversial president hit a low late last year when May criticised his decision to retweet material posted by the far right extremist group, Britain First.

# STORM IN A D CUP: bra-fitters stripped of royal warrant as former CEO spills the beans on dressing the Queen

THE Queen's official lingerie supplier Rigby & Peller has been stripped of its royal warrant after 57 years.

The upmarket underwear firm lost the coveted honour after the woman who turned the company into one of the leading bra and knicker retailers in the world wrote a tell-all book about her professional life, giving details of her royal fittings.

June Kenton, 82, remained on the board of Rigby & Peller and continued to fit bras for the Queen at Buckingham Palace, even after her majority stake in the company was sold to the Belgian lingerie company Van de Velde in 2011.

But it has emerged that Mrs Kenton's long working relationship with the 91-year-old monarch ended shortly after she published her autobiography, entitled *Storm In A D Cup*, in March last year.

### 'boobologist'

Mrs Kenton, who with her husband Harold bought Rigby & Peller for £20,000 in 1982, sold a majority stake in it for £8million in 2011. In the book she wrote about fitting bras for a half-dressed Queen, who had first granted the firm a much-prized royal warrant in 1960 under previous owners.

The businesswoman gave intimate details about her working relationship with other members of the Royal Family, including Princess Diana, Princess Margaret and the Queen Mother.

Describing herself as "the UK's leading boobologist" in one account to help promote

the book, she noted that "even the grandest ladies need to be well-supported" and described giving the half-dressed monarch a first bra fitting.

### 'I pretend to listen'

In a series of interviews, she told how the Queen Mother, who granted the firm a separate royal warrant from 1993, once confided that Princess Margaret liked to interfere with her choice of hats when her milliner arrived for fittings, but she still got her own way.


"Shall I tell you what I do?" the Queen Mother said. "I pretend to listen to Margaret and then, once she has gone, I order what I want."

Mrs Kenton detailed how Diana came for bra fittings, ordered Israeli-designed swimsuits and accepted posters of models in lingerie and swimwear for her sons, William and Harry, to put up in their studies at Eton.

Russell Tanguay, director of warrants at the Royal Warrant Holders Association, confirmed that Rigby & Peller, whose flagship store is near Harrods in Knightsbridge, had lost its warrant. "This would have been in the middle of last year," he said.

He explained that firms have a certain amount of time before they have to remove the royal coat of arms, earned when a company has supplied the Queen, the Duke of Edinburgh, or Prince Charles for five out of the past seven years, from their promotional material and shop signs. And he added: "We don't go into details."

Mrs Kenton and the company, whose

other customers have included Joan Collins, and Margaret Thatcher, proved to be unusually reticent when asked about the downgrade. Buckingham Palace said: "In respect of royal warrants, we never comment."

Bras at Rigby & Peller can cost upwards of £100 and briefs nearly as much.

## Trump 'will veto US-UK Brexit deal if he is not invited to Royal Wedding'

DONALD Trump would stop a Brexit trade deal with the US if he is not invited to Prince Harry and Meghan Markle's wedding, the author of an explosive new book has claimed.

Michael Wolff, the author of *Fire And Fury: Inside The Trump White House*, suggested that the UK could jeopardise a Brexit trade deal with the US if Donald Trump is not invited to the Royal Wedding on May 19.

Prince Harry and Meghan reportedly want former president Barack Obama and his wife Michelle to attend their wedding.

Government officials are worried, however, that President Trump will take great offence if he is not invited as well.

Meghan branded the billionaire as "divisive" and "misogynistic" last year.

also believed to be a fan of Hillary Clinton, who Trump defeated in the US Presidential Election.

Mr Wolff said: "If the Brits give him what he wants he will value the Brits."

In an interview with the *Mail on Sunday*, the political writer also said: "He doesn't like being snubbed and wants to be the centre of attention all

the time.

"Trump's foreign policy doctrine is simple: you Brits suck up to him and enlist in whatever geopolitical fantasy he has going, he'll give you what you want - though only if it doesn't hurt him.

"It is not so much vengeance, rather 'you flatter me and I'll flatter you'."

Mr Wolff also revealed

that Trump "had no idea what Brexit was" two weeks before the referendum back in 2016.

He said: "I interviewed Trump two weeks before your 2016 referendum and he had no idea what Brexit was."

The author also claimed that the President would abuse his planned state visit to the UK by "Trumpalising" the

Queen, treating her as though she is on one of his reality TV shows.

He warned that Theresa May's offer of a State visit to the UK, made weeks after Mr Trump was elected, could backfire.

It was seen as a bid to pursue him into giving Britain a lucrative post-Brexit UK-US trade deal.

But Mr Wolff claimed Mr Trump sees it purely as an opportunity to show off and outshine the Queen.

The *Fire and Fury* author added: "He sees the Queen in reality TV show terms. That's the Trump modus operandi. He will try to Trumpalise the Queen and Buckingham Palace."

The English rock hero, 76, died at his home in Surrey on Thursday, January 4.

His record label have since released a statement confirming his death.

In a statement, they said: 'It is with profound sorrow and sadness that

## On white bread with ketchup and a cuppa: Britons weigh in on the perfect bacon buttie

**THE great debate has rumbled on for years – just how do you make the perfect bacon sandwich?**

Every weekend sees arguments rage in households across the country over the best recipe for the British breakfast favourite. But now the people have spoken and the results are in. A survey has declared that the UK's preferred formula is a generous heap of grilled rashers served on white bread with ketchup. The classic recipe, using either smoked or unsmoked bacon – but never toast – was favoured by the majority of 2,000 adults in an effort to finally settle the age-old dispute.

### back, not streaky

They said the perfect bacon butty should be made with back bacon rather than streaky, on buttered bread with an evenly-spread layer of red sauce. It should be ideally enjoyed alongside a cup of English breakfast tea as part of a classic lazy

Saturday morning routine.

One in four confessed that cooked bacon was enough to get him or her out of bed – the same number said that the smell was a memory of home. One in five said the savoury smell reminded him or her of his or her childhood, while three in four said a bacon butty was the best way to prepare for the day ahead.

Two-thirds of British adults favoured a bacon sandwich over other breakfast options. If eggs are on the menu, almost half those surveyed said they had to have bacon with them, with two per cent opting for avocado. More than one in three of those surveyed via OnePoll. com reckoned a bacon sandwich tastes better when made by someone else.

Mike Greenup, from Holiday Inn Express, which commissioned the poll, said: "It is clear to see bacon is a favourite breakfast choice. "There is nothing better than waking up to the smell of bacon cooking away."

## A Wedding at Two Love Lane

■ Exclusive interview with author Kieran Kramer discussing her contemporary novel about love and wedding planning



"When I decided to write a wedding book, I wanted my character to be one of those 'pre-planners', says *A Wedding At Two Love Lane* author Kieran Kramer.

"A few years ago, I read a New York Times article about women who plan their weddings when they don't have a partner in place yet. They open Pinterest files, cut out

magazine photos of anything about wedding preparation that appeals to them. Some focus on the dress. Others might be into the bachelorette party planning. Or the food angle might appeal. I thought it was really interesting, and I never forgot it."

This is book two in the *Two Love Lane* series. Greer Jones, the owner of a matchmaking agency, is great at her job. She's a bit of a geek, not so great in her own love life. She asks a handsome Brit, Ford Smith, a starving artist she just met, to accompany her to a party. Except he's not a starving artist, he's really the Eighth Baron of Wickshire, one of the most eligible bachelors on the planet. He's traveling incognito,

avoiding women who would want to marry him for his money.

Kramer says much of the series is based on her knowledge of Charleston and my own life experience.

"I do borrow heavily from my family's and friends' lives to fill out my characters," says Kramer. "Macy Frost, for example, is a big basketball fan because my sister is."

"My first-generation Irish-American mother knew Kieran is a boy's name, but she didn't care," says Kramer. "I took such flack for it when I lived in Scotland. I attended the University of Strathclyde in Glasgow for a year. It was an amazing experience. I made so many great friends that year. I was a barmaid at

the university pub, too, and it was open to the public. So I'd meet all the old lads who'd come in and tell me their experiences fighting in WWII. I dated a Scottish rugby player the entire time, and we were in Edinburgh often attending matches."

"When I'd get homesick, I'd take a coach or the train down to London and then out to Kent to see my nanny," says Kramer. "I grew up with a zany English nanny. So, I had a lot of exposure to the sort of madcap humor the British are known for."

Kramer worked as a writer in Washington, D.C. and wrote for *The Charlotte Observer* newspaper. Kramer wrote her first book when she was eleven,

*The Adventures of Tom Nooley*, about a talking baseball. Kramer won an award as Best Regency Debut author from *RT Book Reviews* magazine for *When Harry Met Molly*, which finaled in the Romance Writer of America's Rita awards. *Cloudy with a Chance of Marriage* is listed by *Library Journal* as one of the Top 100 Romances of the past ten years. She's had an Amazon Book-of-the-Month and is a Top December Pick from Book Page. *Christmas at Two Love Lane* is being considered for film adaptation.

Kramer is currently working on short stories for her thesis, part of an MFA in Creative Writing at The College of Charleston. She's a teaching assistant in an

## Mentally fragile England fall woefully short Down Under

**TO NOBODY'S great surprise** Australia wrapped up the Fifth Test with a minimum of fuss at the weekend to ensure they clinched a one-sided Ashes series 4-0 and left England facing an inquest both within and without.

As Australia celebrated victory by an innings and 123 runs, and with England captain Joe Root hospitalized for dehydration and dysentery after the final day, it was left to assistant coach Paul Farbrace to face the media, and he quickly admitted his charges have suffered from mental fragility throughout the tour.

"A series like this does expose issues in your team," Farbrace said. "And we have a choice. You either churn out some positive stuff or be honest and say that there are certain areas that are not good enough. That's every single one of us – players, staff, structures, set-up. Everybody needs to look very closely and ask if we have got the right people in the right places."

Farbrace added that lessons from this winter

need to be learned quickly and acted on if they are to avoid another drubbing in four years' time.

"Every series you play when you come away from home exposes issues you have in your team, and we have a choice," he said. "Either we say we've had some positives or we be really honest and we say there are some areas which are not good enough and we do something about it."

### harsh spotlight

"Every single one of us – whether it's players, staff, structure, set-up, the way we prepared for the series – everybody needs to look very closely and say, 'Have we got the right people in the right places and are we doing things the right way?'"

The outcome of the series would suggest plenty went wrong not only in planning but in execution. And while Farbrace calling for a harsh spotlight to be shone on England's preparation might seem like turkeys voting for Christmas, the assistant coach said honesty was key. "You are always looking at how

we can improve and how we can get better but the key is how honest you are with your conversations," he said. "There is no point me sitting here and chatting about niceties. Nice periods of play and brief glimpses do not win you Test matches and certainly not Test series. If England are serious about coming back here in four years' time and winning then the planning for four years' time needs to start in the next couple of days.

"We need to start identifying the personnel we need character-wise and skill-wise that we will need to win. Extracting bounce out of these wickets is key. We are going to need high-quality spin to win on these wickets."

"The honesty and the planning for next time has got to start as soon as possible."

Farbrace's assessment seems at odds with ECB chief executive Tom Harrison, who in Melbourne last week maintained there would be "no knee-jerk reaction" from the series and indicated coach Trevor Bayliss remained secure

in his role.

But the feeling that someone has to be answerable for what has been an abject attempt to retain the Ashes is growing. Failures have been evident throughout the squad with fading senior players left unchallenged by the next generation, significant injuries to at least six of England's fast bowlers, questionable strategy, poor discipline off the field, and a lack of spin options.

In addition, England's batsmen, aside from Dawid Malan, have failed to stand up when they were needed. "If we are very honest the last few days have summed up

where we have been," said Farbrace.

"We haven't been good enough with the bat. We have talked a lot about getting in good positions and we have had glimpses – Overton and Crane have shown bits of positivity – but we have only had sessions or so where we have played good cricket."

"Over the course of an innings we haven't put Australia under pressure."

And while positives may be thin on the ground, it was at least hard to fault Root's side on their effort. They have tried and trained and pushed and took each Test into a fifth day. Ultimately, though, their skill sets have simply not been

as good as Australia in these conditions. England have been in positions of strength in every Test match. They were 246-4 in Brisbane, then had Australia 76-4 in reply. In Adelaide, they had Smith's men 294-6 and bowled them out for 138. In Perth, England were 368-4, in Melbourne 218-2 and here 228-3. Yet on each occasion they have been pegged back, beaten down by a relentless Australian side who performed better individually and collectively in the crunch hours. They have been beaten by a better side. A harder cricket team led by a man in Smith who looks destined to join the very greats of the game.

## Surgery for Andy Murray

**TENNIS ACE Andy Murray has had hip surgery in Melbourne and says he hopes to be playing again in time for this summer's grass-court season.**

The former world number one, 30, has not played a competitive match since he was knocked out of Wimbledon in July.

The ongoing problem forced the Scot to pull out of the Australian Open, which begins on 15 January.

"I'm not finished playing tennis yet. I'm going to be competing at the highest level again," he said.

"I'm very optimistic about the future - the surgeon is very happy about how it

went."

Murray, a three-time Grand Slam champion, believes if he can return to 95% of his best, that will be enough for him to compete again at the top level.

He hopes he will be hitting balls on court again after seven or eight weeks, and has been given 14 weeks as a guide for a return from this kind of surgery.

But Murray, who has fallen to 19th in the world, said he is not "interested in coming back for a specific tournament".

"My plan is to be back playing around the grass-court season - potentially before then - but I'm certainly not going to rush anything,"

said Murray, speaking from his hospital bed in a telephone conference call to a group of British journalists.


"I want to know when I come back that I'm ready."

He was operated on by Dr John O'Donnell at the St Vincent Hospital in Melbourne on Monday.

Murray posted a photo from hospital on Instagram and said: "Feeling really positive and looking forward to starting rehab."

Murray withdrew from the US Open two days before the start of the tournament in August last year, and said he realised he was not ready to compete in Brisbane

# Stoke eye Flores to replace Sparky

Stoke City have made Quique Sanchez Flores their preferred choice for the manager's job - and are waiting for an answer from the Espanyol boss.

The Potters sacked Mark Hughes on Saturday, with the club in the Premier League relegation zone.

A Stoke delegation has met ex-Watford boss Flores, whose side beat Levante 2-0 in the Copa del Rey on Thursday.

"I'm not going to talk about me on such an important day for

Espanyol," he said after his side reached the last eight.

"I don't want to talk about me but to enjoy these moments. I want to continue being happy with my profession.

"I'm very grateful to Espanyol. I've been frustrated sometimes because we haven't advanced as fast as desired, but that's because Espanyol haven't been able to, not because they haven't wanted to.

"Right now we're not

thinking about anything other than today's game and Sunday's match against Athletic [Bilbao]."

The 52-year-old is under contract with the La Liga side until 2019, but has a release clause in his deal.

Republic of Ireland manager Martin O'Neill is still in the running if Flores turns down the chance.

Derby County boss Gary Rowett was originally one of the bookmakers' favourites

to succeed Hughes, but he signed a new three-and-a-half-year deal with the Championship club on Tuesday.

Stoke had hoped to have their new manager in place for the Premier League game against Manchester United on 15 January - but it is thought Flores might not arrive by then.

## Reds legend Tommy Lawrence dead at 77

The former Liverpool goalkeeper Tommy Lawrence, a key member of Bill Shankly's side in the early 1960s, has died aged 77.

Lawrence joined Liverpool as an apprentice and made his debut in 1962 during a 1-0 defeat to West Bromwich Albion. He became affectionately known as "The Flying Pig" due to both his physique and flair for spectacular, acrobatic saves.

He missed only four league matches between 1963 and 1969 and was part of the side that won the 1963-64 league title, the 1965 FA Cup and the 1965-66 league. He set a then record for the fewest goals conceded in a season in 1968-69 when he let in only 24

league goals.

Lawrence made 390 appearance for Liverpool before moving to Tranmere Rovers in 1971, where he made 80 league appearances before joining non-league Chorley.

In February 2015, the Scot made the news when BBC reporter Stuart Finders was conducting vox pops on the street in Liverpool, asking for memories of the Reds' 1967 Merseyside

derby against Everton at Goodison Park. After unwittingly approaching Lawrence and asking if he could remember the match, the goalkeeper replied that he had: "I played in it - I was goalkeeper for Liverpool. It was a great game."

A Liverpool club statement read: "The thoughts of everybody at the club are with Tommy's family and friends at this sad time."

Tottenham Hotspur's new 61,000-seat stadium will host an NFL game for the first time when the Seattle Seahawks play the Oakland Raiders on 14 October.

It will be played on the stadium's artificial surface, which sits beneath the retractable grass pitch. Premier League side Spurs are due in their new home for the 2018-19 season.

Tottenham chairman Daniel Levy said at the International Series launch: "We hope there

is a franchise in London and we want this stadium to be its base."

The club have a 10-year deal with the NFL to stage two games a season.

Wembley Stadium will host the Philadelphia Eagles against the Jacksonville Jaguars and the Tennessee Titans versus the LA Chargers later in October.

One of those fixtures will be played on 21 October and the other on 28 October, with the decision on that still to be taken.

last week when he tested his hip against other top-50 players.

"I want to come back when I'm fit and ready to play, not to get into a situation like in Brisbane or New York, where I'm unsure when I turn up at a tournament how fit I am," he said.

Murray has not played a competitive match since his Wimbledon quarter-final defeat by Sam Querrey on 12 July.

He said he first felt pain in his right hip during June's French Open semi-final against Stan Wawrinka, though he has had issues with it throughout his career.

"The surgeon felt that my hip will be feeling better than it did a year ago," Murray said. "Obviously, I was still doing fine a year ago - I was ranked number one

in the world.

"I'm certainly not going to be putting in the same amount of tournaments and effort to try to get to number one in the world. I'll be playing a reduced schedule, and then focusing more on trying to win major events and big tournaments rather than trying to achieve certain ranking goals.

"I've been fairly competitive with top-50 players in the world in Brisbane when I'm struggling to move, and I made the quarter-finals at Wimbledon when I literally couldn't walk and was in so much pain. "So if I can get myself to 95% of my best, I believe that's enough to compete at the highest level. No question.

"The rest of my body feels fantastic. I feel really, really good physically apart from this one issue. The surgery allows me to extend my hip well, and I'll be able to sprint."

## Conte and Mourinho spat shows now sign of cooling

ONE OF THE more bizarre football stories of the past ten days has been the bizarre spat between Jose Mourinho and Antonio Conte, which looks likely become one of the dominant subplots of this year's title race.

Verbal hostilities broke out between the two over the weekend after the Portuguese obliquely referred to the Chelsea boss with talk of 'clowns' on the touchline, which prompted the Italian to claim Mourinho was suffering from 'senile dementia'...although he later walked that claim back, saying he meant to say amnesia.

Then, when former Chelsea manager Mourinho referred to a match-fixing scandal in Italy of which Conte was cleared, the Italian responded by calling the United boss "a little man" and "fake".

Things showed no sign of improving as the weekend went on. On Wednesday, ahead of the Blues' dismal goalless

draw with Arsenal in the Carabao Cup, Conte was in no mood to back down. When asked if he regretted his words, he pointed to his stern face and said: "I have this look, of a person that regrets? I don't think so. I think we both said things, and we'll see what happens in the future."

Asked if the row could damage the reputations of the two clubs, Conte was dismissive, saying: "This is not a problem for the club, it's a problem between me and him. I stop."

The League Managers Association and FA have refused to get involved in the row and Conte made it clear there was no point, saying: "It's not important, [involving] the association.

He used serious words. I won't forget this."

Conte had also insisted at the weekend that he was "ready" for any confrontation with Mourinho.

The next time the two managers are due to come

face to face will be the Premier League clash at Old Trafford on February 25. However, that will have to be rescheduled if Chelsea reach the Carabao Cup final, which is on the same day.

The Italian recently also had a dig at under-pressure Arsenal manager Arsene Wenger, back after his rival had accused Eden Hazard of diving to win a penalty in the 2-2 league draw between the clubs last week – calling the Frenchman "old".

As he prepared for the second of three confrontations with the Gunners this month, Conte insisted he had no problem with the Frenchman and that he did not hate anyone.

"I made a comment about Arsene because he mentioned my player.

"Otherwise, I have respect for what every coach thinks. Every coach has their own opinion and we must respect it if you don't offend anyone. It is not true that we both hate the same person."

## Cahill hails 'bargain' Barkely

CHELSEA have not had the best of weeks after two goalless draws with Norwich and Arsenal, but they did get one fillip with the arrival of Ross Barkely for a bargain £15m in the transfer window.

The Everton midfielder was set to join the Blues in August for £35 million but a ruptured hamstring scuppered the move. However, a new deal has been struck – for £20m less – with the midfielder nearing full fitness.

"He's a phenomenal signing and it's a bargain," said England defender Gary Cahill, who hopes Barkley can join him in Gareth Southgate's World Cup plans.

"I know what he's capable of. He ticks all the boxes. Now he is ready for a platform where he can

express himself."

Meanwhile Norwich striker Josh Murphy, 22, who impressed at Carrow Road in the weekend FA Cup clash, still believes there is a chance of the Championship club pulling off an upset in the replay at Stamford Bridge.

"We have the quality to break down even the top teams," he said.

Chelsea were not the only Premier League team to find the third round a tricky hurdle. Steve Cook's header in added time rescued Bournemouth as they drew 2-2 at home to League One leaders Wigan. Swansea defender Kyle Bartley compared Championship pacesetters Wolves to Barcelona after a goalless clash at Molineux. "They are Barca in disguise – they were very good,"

said Bartley. "They've got a good plan, they show a lot of rotation of the ball and their manager has got them very well drilled."

Fleetwood goalkeeper Chris Neal is after some garlic bread and potato wedges to go with his free pizza if he shuts out Leicester again next week. Neal, 32, was promised one pizza a week for the next 12 months by a club sponsor if he kept a clean sheet on Saturday. He did it comfortably as their Premier League opponents, without Fleetwood old boy Jamie Vardy, failed to muster a single shot on target.

"I should ask for garlic bread and some sides as well," said Neal. "Can we keep a clean sheet against Jamie? Definitely. We've shown here what we can do as a defence."

visitors were quickly into their stride. When De Bruyne swivelled near halfway he ran straight into Joe Bryan. Suddenly the home side were back-peddalling, the left winger racing to the penalty area's edge before drawing a save from Claudio Bravo, the keeper flinging himself to his right.

Johnson's side, fourth in the Championship, were hardly overawed. Jamie Paterson, the No10, swept a pass to Josh Brownhill on a left-right diagonal. Oleksandr Zinchenko stamped on his toes and Anthony Taylor gave a free-kick. If this was a warning for City, they continued to pose their own threats on Fielding's goal.

De Bruyne hit a first-time pass into Sané and the German raced on and slid the ball along the line but it was scrambled clear. Sané and Bernardo Silva were Guardiola's brightest performers, the Portuguese's touch and force illustrating his club's strength in depth as the former Monaco man is not yet a first choice for his manager.

Still, the home side could easily have fallen behind from a cleverly worked free-kick which had Bryan zipping in behind and finding Paterson, who should have finished. Shortly

afterwards, though, calamitous home defending proved costly. Eliaquim Mangala was pick-pocketed by Brownhill, then Stones scythed down Bobby Reid in the penalty area. Taylor pointed to the spot, Guardiola wheeled away in disgust and up stepped Reid to give Bristol City the lead.

City responded with fire and furty and City were soon riding their luck at the other end. Aden Flint sent one clearance straight into the feet of Kevin De Bruyne, whose resulting shot was expertly tipped over by Frank Fielding. Flint would make amends on the cusp of half-time when Sterling was put through and chipped Fielding only for the Bristol centre-half to head clear on the goalline and then go careering into his own net.

Sterling was full of running, though.

Deployed as a false nine with Sergio Aguero starting on the bench, his pace and movement asked questions and he was in the thick of things for City's equaliser. De Bruyne bombed forward with the ball, and with the Bristol defence backing off, the Belgian played the ball into Sterling in the penalty area who swiftly returned it, allowing the midfielder to thrash a shot past Fielding.

There were 20 minutes left when Aguero entered the fray. Bristol had been excellent up to that point and good value for the 1-1 scoreline but tired legs can lead to tired minds and their concentration lapsed at the crucial moments. John Stones pushed the ball out to Bernardo Silva and from there the Portugal playmaker whipped a cross over the head of the despairing Aden Flint for Aguero to head home.

**Brighton boss Chris Hughton says the Football Association's decision to interview at least one applicant from a black, Asian and minority ethnic background for future roles in the England set-up is "very promising".**

English football's governing body said on Tuesday that it is to adopt its own version of the 'Rooney Rule' implemented in the NFL in 2003.

Research conducted in November showed only 22 of 482 coaching roles across England's top four leagues were filled by people from BAME backgrounds.

"I would applaud what they have done and certainly I would see it as a positive," said Hughton, the Premier League's only black manager.

"For the FA to make the decision that they have made, it's something that's very worthwhile."

# Sanchez eyes exit door

City favorites to secure Chilean star's services...  
but United also put in surprise £25m bid

Forward Alexis Sanchez will leave Arsenal this month if a suitable offer arrives and a replacement is secured.

It is understood the Gunners hierarchy have privately accepted for some weeks that Sanchez is likely to depart after three and a half years at the club.

However, Arsenal are reluctant to sell without replacing the Chilean and their first choice is Bordeaux's 20-year-old Brazilian forward Malcom.

Manchester City is 29-year-old Sanchez's most probable destination.

Conversations have been held between the clubs but there is as yet no agreement on a fee.

Arsenal are thought to have asked for up to £35m, with Premier League leaders City initially suggesting they would pay around £20m. Sources anticipate a compromise of between £25m and £30m.

It is also widely reported that Manchester United will rival City's interest and have already made a bid.

If a deal cannot be agreed, Sanchez will be able to leave when his contract expires in the summer - a situation Arsenal are keen to avoid as they would receive nothing.

The Chile international almost joined City for about £60m on the final day of the summer transfer window, only for the switch to collapse when Arsenal failed to sign Monaco and France midfielder Thomas Lemar.

Former Manchester United defender Phil Neville said Sanchez would be an "absolutely unbelievable signing" for the Old Trafford club.

Responding to reports that said a £25m bid had already been made, he told Sky Sports: "If you look back at Manchester United's big signings over the decades, Eric Cantona

came out of the hat, [Robin] van Persie was a surprise - and they both helped United win titles.

"I think this could have a similar impact. He's got the character to play at Old Trafford," the ex-England international added.

"It would be a coup, particularly for United fans, to have a player like Sanchez come to them over City. It would be a strong statement.

"It's pretty obvious he's not going to stay at Arsenal. I think if United were going to buy him, £25m would be an absolute snip."

But the player would also 'add something' to Manchester City, says midfielder Kevin de Bruyne.

"If he comes, he will add something to the team," said the Belgium playmaker.

"He is a very good player," added the 26-year-old. "Obviously we will see what happens."



## Plucky Robins give City a scare

Sergio Agüero broke the hearts of plucky Bristol City with a last-gasp goal in Tuesday's Carabao Cup semi final first leg, given the talent at Pep Guardiola's disposal, Robins' manager Lee Johnson and his players can feel rightly proud at losing by only the odd goal at the Etihad.

Manchester City had to fight throughout this semi-final first leg as they will surely have to do in the return game in ten days' time and for Bristol City still to have a chance of reaching Wembley shows how fine a display this was.

As Aden Flint, the Bristol City centre-back, said: "We are

disappointed to concede late on but we can hold our heads high. We've taken probably the best team in the world almost all the way."


Guardiola selected a strong side. Agüero and Fernandinho dropped to the bench while Nicolás Otamendi and David Silva were not in the 18. Yet Kevin De Bruyne, John Stones, Ilkay Gündogan, Leroy Sané and the club's joint-top scorer Raheem Sterling, who has 18 goals this season, were included.

Johnson made one change from Bristol City's last league game, Frank Fielding replacing Luke Steele as goalkeeper. This was their sixth tie in the

competition, against their fifth Premier League opponents, the Robins having already dispatched Watford, Stoke City, Crystal Palace and Manchester United.

There were 7,680 travelling fans - a record at the venue - and they watched the home side come at their end almost instantly from kick-off. In Agüero's absence Guardiola asked Sterling to operate at centre-forward. The 23-year-old's pace was evident when De Bruyne turned a ball round the corner into his path from behind halfway.

It was an end-to-end contest almost from the off, and the
