

# Flooding's over...now here comes the snow

THERE was no respite for weather-weary Britain this week as the New Year gales and floods were replaced with Arctic winds, snow, frost, ice and fog.

Wind and rain have blighted the country for weeks as thousands of homes have flooded and wet and windy conditions and brought chaos to roads and transport systems.

There is finally an end to the downpour in sight, but the change will bring the wintry conditions which have been held off by the storms, forecasters predict.

#### wintry conditions

Until then the country is at risk of further flooding as "slow responding rivers" are hit by further the heavy rain, although the worst is over.

On Wednesday a pensioner became the eighth person killed by the bad weather when he fell from his bicycle trying to pedal though four feet of flood water. And by Monday

wintry conditions are expected throughout the country, with cold air coming in from the US, which has been gripped by a polar vortex.

The Met Office predicts an increasing risk of snow, mainly over hills, and ice.

#### 'very mild start'

Spokesperson Laura Young said: "Into the weekend and next week we are going to see temperatures return to normal levels for this time of year which will make it feel a lot colder and bring a risk of frost, fog, and wintry showers."

December 1st is officially the beginning of winter, but the last six weeks have proved unseasonable, with temperatures in double figures and last month the eight warmest December on record.

"We have had a very mild start to our winter and I think that people might get a bit of a shock next week," Miss Young Snow, frost and ice forecast as British winter goes from bad to worse

### New official protection for genuine Scotch whisky



A new scheme has been launched to protect the Scotch whisky industry from fake or sub-standard products.

The Spirit Drinks Verification Scheme has been set up by the UK government to help consumers identify genuine UK-made products.

Producers will have to sign up for the scheme if they want to sell within the European Union. Scotch Whisky is the first drink to be covered.

The industry said the measure would be "warmly welcomed".

Protection under the new rules will in future be extended to other drinks with a geographical origin, such as Somerset Cider Brandy and whiskey from Northern Ireland.

Producers, blenders, bottlers, labellers and bulk importers will need to apply to HM Revenue and Customs (HMRC) if they want to be verified. HMRC will carry out checks on all businesses involved in the production of the spirits to make sure they meet strict EU requirements.

Scotch Whisky Association chief executive David Frost said: "This is a step change in the protection of Scotch whisky and should be warmly welcomed.

"We fully support the introduction of the verification scheme by the UK government. It will give even more protection to consumers of Scotch whisky.

"It will greatly improve the industry's ability to stop the sale of adulterated Scotch whiskies bottled abroad."

Launching the scheme, Chief Secretary to the Treasury Danny Alexander said: "The verification scheme will make sure people who buy Scotch get what they pay for - the finest spirit in the world."

#### 'very good year'

Windrush also paid out £12.1 million in expenses, to cover the cost of office rents, travel and hotel bills for Blair and his entourage. Blair's staff are estimated to earn an average of £86,000, with the company's highest paid director getting £273,000.

One City accountant told the *Sunday Telegraph*: "These numbers are a big improvement on last year. Mr Blair has had a very good year. This is a bumper year – his best year yet."

### **England cricketers save** bridge suicide man

England cricketers Matt Prior and Stuart Broad (above) finally got some positive press this week after helping rescue a man preparing to jump off a bridge in Sydney, Australia.

The pair found the man on the edge of a bridge in Darling Harbour and Prior helped to pull him down.

The 31-year-old wicketkeeper told The Daily Telegraph: "We just did what anyone would do in that situation.

"It all happened very quickly and we acted on impulse"

"We were trying to help а bloke who was struggling and in a bad way. I look back and I'm just glad we left the bar when we did and we were there for him "

Broad and Prior, who both featured in England's 5-0 Ashes defeat by Australia, were returning to their team hotel from a Barmy Army fundraising event when they found the man, who said he was from Cheltenham.

After speaking to him for over an hour, Prior pulled the man down from the bridge before New South Wales police arrived.

"Matt Prior is a best friend of mine and I'm very proud of him. It was a tough situation but so glad he was there," tweeted Broad, 27.

Terry Minish, the team's security officer, was with the England duo and claimed the man had indicated he wanted to drown.

"Walking back to the hotel we spotted a young man on the edge of the bridge about to jump," Minish said.

"He was saying he just wanted to drown. Matt helped to pull him down off the edge of the bridge and sat with him until the police arrived."

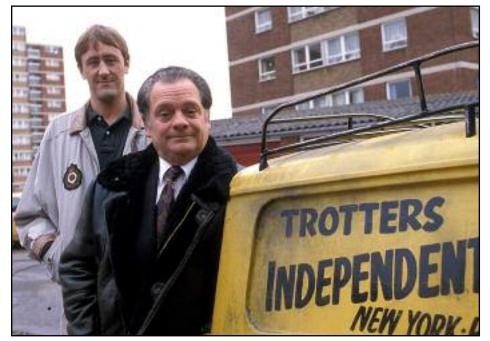

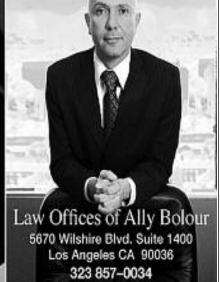

# Four dead as 'safest ever' US chopper comes down in Norfolk

An investigation is underway after four crew members were killed when a US military helicopter on a training mission crashed near the north Norfolk coast this week.

The HH-60 Pave Hawk, a derivative of the Sikorsky Black Hawk aircraft, plunged into marshland at Cley-next-the-Sea at about 6pm on Tuesday.

Emergency services worked throughout the night with the help of military personnel and volunteers to secure the crash site, with some debris threatened by tidal waters.

The US Air Force said the helicopter went down between a beach car park at Cley and Eastbank, near Salthouse - an area which remains flooded following the recent tidal surge.

An investigation has now been launched into how the aircraft, described as having "the best safety record of any helicopter that the US has ever owned", could have crashed during a routine low-level training exercise.

The Pave Hawk was

stationed with the 48th Air Wing at the US Air Force base at RAF Lakenheath, Suffolk, which issued a statement saying: "US military officials are coordinating the recovery efforts with the UK police and the Ministry of Defence.

"The authorities have secured the crash site and established a cordon.

"The aircraft, assigned to the 48th Fighter Wing, was performing a low-level training mission along the coast when the crash occurred."

helicopter at the time were killed in the crash, and that wreckage including live munitions had been scattered across an area the size of a football pitch.

Speaking near the scene, Chief Superintendent Bob Scully of Norfolk Police said it was too early to say what caused the crash.

#### birdwatching

He said the aircraft had contained ammunition, and that a 400 metre-wide area had been closed off because the scattering of bullets made the site "hazardous to members of the public".

A second helicopter from RAF Lakenheath was also in the area at the time of the crash and set down on the marshes to try to assist.

Richard Kelham, the chairman of Cley Parish Council, told ITV News that the helicopter was thought to have landed in a bird reserve. North Norfolk is famous as a birdwatching area and is popular with walkers and tourists.

But speaking to BBC News, retired colonel and former Pave Hawk pilot Rick Davis said it was highly unlikely that a so-called bird-strike would have caused any problems for the aircraft. He said one possible explanation, based on the presence of live ammunition on board the helicopter, could be that the crew got into difficulties while going through strenuous " b a t t l e - r e a d y " preparations.

He added that the crash was particularly unusual given the fact that "the Pave Hawk may have the best safety record of any helicopter that the United States military has ever owned".

Peter and Sue McKnespiey, who run Cookies crab shop in Salthouse, live near the crash site and said they heard the helicopter come over "very fast and very low".

Mrs McKnespiey said: "I don't know about engines but I am used to the sound of helicopters and this sounded very heavy and very unusual. My gut instinct was there was something wrong."



# Lapdancers take revenge after being stiffed over £42k debt

Nightclub boss 'kidnapped by three lapdancers' after he failed to pay them hefty sum for entertaining punters during upscale horse racing meet

■ Victim refused to pay the women 'because they broke the rules'; He claims they ignored strict instructions not to remove bikinis and nipple tassels'

Three lapdancers and their manager kidnapped a club boss after he failed to pay them more than £42,000, a court has been told.

The women had been hired to work at a pop-up nightclub to provide entertainment for customers during the Cheltenham Festival in March 2012.

Curtis Woodman, who had set up the club was driven to a remote field and beaten up, it was claimed.

Three lapdancers and their agent Charlotte Devaney, 34, are alleged to have enlisted the help of two male friends to strongarm him.

A court heard that Mr Woodman, 34, hired the girls around the time of the festival but fell out with them when he accused them of breaching the Embassy Club's strict licence conditions by stripping off.

#### contracts

Bristol Crown Court heard the club failed to secure a lapdancing licence and the girls signed contracts agreeing they would wear 'bikinis and nipple tassels at all times'.

But when the club opened some of the women, who were paid £150 per night to work there, 'insisted on taking their clothes off' and it was shut down by officials.

The women claimed they were promised 50 per cent of any card takings which included £42,000 spent by one excited punter. In a taped police interview played to the jury, Mr Woodman said that he struggled to get the women to keep their clothes on.

'A lot of the girls earned a lot of money from working that Monday, Tuesday and Wednesday.'

Mr Woodman said the problem between him and the girls arose on the Tuesday night, when a customer began spending money on his debit card.

'He was obviously a big spender, he was spending a lot of money, I mean in the region of £40,000.

'Throughout all of the week, we had just one night which was a full nude lapdancing night, the rest of the nights were running as a hostess business fully clothed.

'If you have ever asked a stripper to keep her clothes on when she is working, it doesn't happen.

'I was constantly bombarding them 'put your clothes back on we are going to get shut down'.

'You try and keep 60 girls in check. On the Wednesday we had a team meeting before we started, we told the girls to go into town and buy clothes.

Devaney spent months chasing Mr Woodman for the 'debt' before visiting a police station in Cheltenham on September 3, where she was advised to take civil action.

#### Stanley knife

Later that day, Devaney, along with dancers Mandy Cool, 29, Stephanie Pye, 31, and Rachel Goodchild, 24, met with brothers Alexander, 23, and Robert Morris, 27. The group headed to Mr Woodman's work in Tewkesbury, Gloucestershire, in two cars where thev 'kidnapped him', the jury of seven men and five women was told.

Prosecuting, Martin Steen said: 'Miss Devaney made clear she thought that there would need to be a discussion with Mr Woodman.

'He was helped into Miss Devaney's car by the Morrises, who sat either side of him in the back of the vehicle

'They had in their possession a Stanley knife. He was under threat. He had no choice but to hand over that watch, worth £4,800, and he did so.'

Mr Steen said that when Alexander Morris was later arrested, the watch was found to be in his possession.

During the drive, Mr Woodman was sat in Devaney's BMW One Series with her, the Morris brothers and Stephanie Pye. Cool, in her BMW Three Series, with Goodchild, followed.

#### released with threats

Mr Woodman was allegedly struck twice in the face by Robert Morris as the car drove onto the M5 and left at junction 10. His phone was confiscated and attempts were made to transfer

money using a banking app, which were unsuccessful, Mr Steen said.

'He was then persuaded to ring the bank and arrange for a transfer using the details of Charlotte Devaney's bank card,' he told the jury.

'£4,800 was transferred into Charlotte Devaney's account.'

Mr Woodman was then taken 100 metres down an agricultural track, where he was taken out of the vehicle by the Morris brothers, it was alleged.

'They told him they were going to have some fun,' Mr Steen said. 'That

involved hitting him to the face and kicking him to the face, causing him to bleed.

'It was suggested that they should pay a visit to his parents, perhaps dealing with his parents might encourage satisfaction of the debt that was owed.'

Mr Woodman directed the vehicles to an empty property he claimed was his home - stating he had left the keys in his office before the cars set off again.

He was then driven to a fish and chip shop and left him in the car, Mr Steen said.

'Mr Woodman was later released with threats that if he didn't pay the rest of the money, they would be back,' Mr Steen said.

Police had already been tipped off because Mr Woodman rung a business partner during the drive and they were able to trace the two BMWs.

The Morris brothers, Cool and Goodchild were arrested when Cool's BMW was stopped on the A34 in Hampshire at 8.30pm that evening.

Devaney was arrested at an address the following day, while Pye handed herself into a police station later.

Mr Steen said Devaney and the girls hatched a plan to kidnap Mr Woodman after months of chasing him for payment.

'As far as the girls were concerned, they were hoping to have their share of the credit card payment of £42,000,' Mr Steen said.

'Mr Woodman felt that the girls had broken their contracts and were not entitled to keep the money.'

Earlier, Alexander Morris, from Southampton, admitted carrying a bladed article, namely a Stanley knife, on September 3, 2012, the day of the alleged kidnap.

Morris and his brother Robert, also from Southampton deny robbery of Mr Woodman's Brietling watch.

Devaney, from London; Pye, from Sutton Coldfield; Cool, of Southampton; and Goodchild, of Southampton, each deny a charge of kidnap on September 3 2012.

The trial, in front of judge Geoffrey Mercer, continues.

The veteran singer's daughter Ruby, 26, posted a photograph of her father sporting a bright red hooter on her online Instagram picture-sharing account.

She claimed Stewart had asked her to send the picture "around the world", but warned him that she had fewer than 2,000 followers who would see it.

Ruby, whose mother is model Kelly Emberg, captioned the picture: "My dad asked me to capture this moment and to 'send it around the world' for his 69th birthday...Hope he is not disappointed with a mere 1,823 people..." ## Thief who evaded police for almost a year arrested after posting LOCATION on Facebook

A THIEF who went on the run for almost a year after stealing £8,000 from his workplace was arrested ....after posting his location on Facebook.

Officers said they almost fell off their chair after Craig Munnerley led them right to him after bragging about his job on the social networking site.

The 33-year-old stole thousands from the safe at a travel agents in Warrington before running off to Scotland for 10 months.

He was arrested after posting his location on Facebook and was jailed for a year at Chester Crown Court.

#### catering position

PC Graham Davies from Cheshire Police said: "I nearly fell off the chair when I saw that he had decided to not only leave his Facebook profile unprotected but also list his new employer. It was very rewarding to get this offender."

The court heard Munnerley changed his name to Hilton to evade capture but after creating a new Facebook

page failed to make his account private.

Munnerley, who stole from a Co-op Travel on 7 January 2013, had started work in a catering position at First Scot Rail in Glasgow.

Officers searching for his name found the profile and a status update which said he had started working at First Scot Rail in Glasgow. Police arrested Munnerley when he started an induction week and arrested him as he arrived at the head office.

PC Davies and PC Kate Hall, made the arrest following the lengthy investigation.

PC Davies added: "Theft from an employer is a fundamental breach of trust and Munnerley had clearly thought himself beyond the reach of the law.

"With his new name and new job it must have been pushed to the back of his mind."

#### abusive relationship

The court, who sentenced him on December 23 2013, heard Munnerley had been working at the store for three months when he stole the cash.

The defendant did not show up for work having already left Widnes without telling anyone and his then partner reported him missing to police.

The court was told the defendant stole the money to escape an abusive relationship.

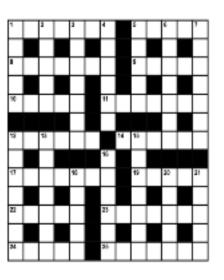

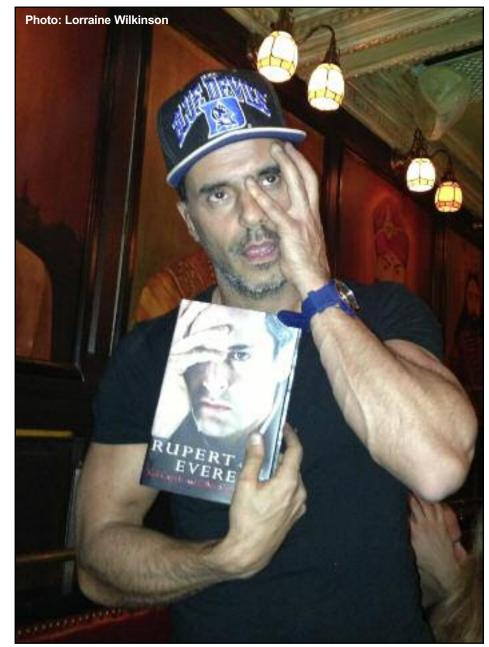

# Flower vows new start as England left in Ashes

England plan for life without KP after shocking 5-0 reverse Down Under

A BATTERED and shell-shocked England team can expect drastic changes this year following their humiliating whiteash in the Ashes series.

And the most high-profile casualty is expected to be volatile batsman Kevin Pietersen, who is widely seen within the camp as a disruptive presence – despite his obvious talent with the bat.

Team manager Andy Flower boarded a flight home on Wednesday 'determined to rebuild the team around captain Alastair Cook', according to sources close to the England camp.

Flower was furious on Wednesday at claims he had given the English Cricket Board (ECB) an ultimatum over Pietersen, especially because such a move would go against his insistence that a period of reflection is needed before any major decisions are taken.

He also knows that a similar tactic cost Pietersen his job as captain when he

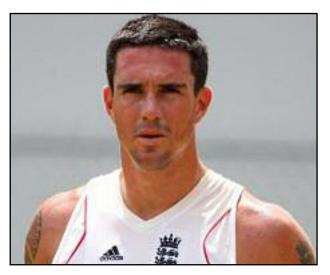


**BLUE SKY THINKING?** Andy Flower, the England team director, is expected to plan for the future without Kevin Pietersen (below)

demanded the removal of then-coach Peter Moores in 2008.

But it is understood Flower recognises the need to reinforce team discipline, particularly with an emerging younger element to the England side, and he believes it will be tough to do that with Pietersen in the dressing room.

Pietersen remains professional in training and his work ethic has never been questioned but the management have become exasperated by what they perceive to be a lackadaisical approach to warm-up matches, the manner of his dismissals in the first three Tests when they needed him to bat responsibly, and the influence he is having



over younger members of the side.

When the England team contained senior figures such as Andrew Strauss, Paul Collingwood and Graeme Swann it was able to absorb the less positive aspects of Pietersen's character, but with Cook struggling as a captain and young cricketers such as Joe Root and Ben Stokes becoming important members of the side it has become harder to manage the team's most mercurial player.

According to at least one report Pietersen knows if the ECB back Flower his time will be up and he is not willing to go quietly. To add to the problem Pietersen is a skilfull user of social media to advance his own PR agenda and relies on the advice of Piers Morgan, his friend and former editor of the Daily Mirror, who has more than 5 million followers on Twitter.

Morgan tweeted his support for Pietersen moments after the player himself wrote he was "shocked and saddened" by reports about his England future and repeated his "strong desire to continue playing for my country, and to help us regain the Ashes in 2015."

Pietersen's tweets emerged around an hour after the ECB put out a statement on behalf of Flower, who on Wednesday flew home leaving the England team under the control of Ashley Giles, the one-day coach.

Flower said: "It would be sensible and responsible to review the tour in a calm and logical manner before assessing our options for the future and planning ahead. I repeat that neither I nor the wider ECB leadership group have made any decisions as to the future involvement of any individuals in the playing group or in the support staff. The reports that I have issued an ultimatum of some description to the ECB are totally inaccurate."

Australia wrapped up the Fifth Test in Sydney by 281 runs on Sunday. Alistair Cook won his first toss of the series but it had no bearing on the result. Australia made 326 and 276, while England suffered two batting collapses to finish with 155 and 166.

"If it was a boxing match it would have been stopped," admitted Cook during the post-match ceremonies and he was hardly exaggerating.

This is only the third time England have suffered a whitewash in 100 years of Ashes tours the other two were in 1920-21 and 2006-07, but statistically this tour will go down as the worst in Ashes history. Three times the margin of defeat was more than 200 runs, while the manner in which they succumbed inside three days at the SCG was enough to persuade coach Andy Flower that it was the "end of an era".

# Martinez blasts Qatar winter world cup scheme

Everton boss Roberto Martinez claims players would find it difficult to cope with a winter World Cup in the middle of their domestic club season.

His words were in response to Fifa's secretary general Jerome Valcke, who this week hinted the 2022 event Qatar will be played between November and January due to the desert heat.

"I find it very difficult to find a way that would work," said Martinez.

Martinez revealed his concerns for a winter World Cup after experiencing issues with players leaving for the African Nations Cup in the middle of the season.

He added: "We had many problems with that because you're going in to a different climate, you come back from a different coach. It was difficult to find continuity in players' performances.

"I can't see how a player's mentality would be fine for going into a season, then starting the World Cup and then coming back and picking up where they left it. I find it very difficult to find a way that would work."

# Defoe 'on brink' of MLS move

Jermain Defoe is on the brink of joining Toronto FC in Major League Soccer, with the Canadian club hoping to formally unveil the England striker as early as Monday.

Roy Hodgson, the England manager, is understood to have discussed the move with Defoe and, although it is unlikely to help his l o n g e r - t e r m international prospects, more regular football in the build-up to the World Cup could be valuable.

Defoe has become peripheral at Tottenham, with new head coach Tim Sherwood generally starting with both Emmanuel Adebayor and Roberto Soldado in attack.

It is expected that Defoe will agree a deal worth around £90,000 a week and that Tottenham will be paid around £6million for a 31-year-old player who has only 18 months remaining on his contract.

It is also likely that Tottenham and Toronto will agree a loan-back option that will mean Defoe remains at Spurs until the middle of March before travelling to Canada ahead of the start of the MLS season.

Toronto are managed by Ryan Nelsen, the former Tottenham defender, who has described Defoe as "one of the most natural goalscorers" he has ever seen.

His arrival would also underline the ambition of Tim Leiweke's Maple Leafs Sports and Entertainment, the company which owns Toronto FC. Leiweke also helped bring David Beckham to Los Angeles Galaxy.

The likely loss of Defoe will only harden T o t t e n h a m

determination to keep club record signing Erik Lamela, despite his apparent desire to move back to Italy this month.

Lamela's father was quoted on ESPN saying that his son is "not happy" at Spurs and would like to return to Serie A. Tottenham, though, remain adamant that Lamela will not be leaving this month either permanently or on loan. Lamela was signed from Roma – the former club of technical director Franco Baldini – for £30 million last summer but there was always an expectation that he would need time to settle in the Premier League.

Sherwood is not pushing for new signings, although the club will explore replacements for Defoe with Juventus forward Mirko Vucinic and Rubin Kazan's Jose Salomon Rondon regarded as options. "I don't think we need

players here," said Sherwood. "We need to get them fit, the ones we have got, and then if anyone springs up who could really make us better, our 11, then possibly we will go in."
