

Jagger takes refuge with kids after 'devastating' suicide of girlfriend L'Wren Scott

GIMME SHELTER!

MICK JAGGER sought refuge in the comfort of his children in Los Angeles this week following the sudden death of his longtime girlfriend L'Wren Scott.

The Rolling Stones singer reportedly headed to the home of his daughter Karis so he could mourn among his family, with daughters Elizabeth, Georgia May and Jade expected to join him imminently.

Jagger arrived in California on Thursday en route from Australia, where he had been touring with the Stones when Scott's death was announced. The fashion stylist was found hanged on Monday in her New York apartment.

suicide

A Jagger rep told reporters of his relationship with his daughters: "They adore him..... "He will stay in L.A. while the funeral arrangements are being made in New York."

While Jagger headed for the U.S., the rest of the Stones were believed to have taken off from Perth International Airport for Abu Dhabi in the band's private plane adorned with the famous lips and tongue.

Meanwhile, Scott's

body was taken to a Manhattan funeral home on Wednesday after the medical examiner confirmed that her death was a suicide.

There was no suicide note with Scott's body, but a motive for her taking her own life quickly emerged when it was revealed her company was nearly \$6 million in the red - despite boasting an impressive client list including Amy Adams, Nicole Kidman and First Lady Michelle Obama.

independence

Jagger met Scott back in 2001 at a photo shoot after she had established herself as an in-demand stylist, working for the likes of Madonna, Tom Hanks and Julia Roberts. Six years later, they moved in together in a house in London, though their respective schedules often kept them apart.

Jagger and Scott were together longer than he was married to either of his ex-wives, and friends say what particularly captivated the singer

was Scott's sarcastic wit, and her determination to keep her independence from him, rather than let his larger-than-life existence as the frontman of the world's greatest rock n' roll band consume her personality and work.

'many wonderful years'

"I will never forget her," Jagger wrote on his website. "I am struggling to understand how my lover and best friend could end her life in this tragic way. We spent many wonderful years together and had made a great life for ourselves. She had great presence and her talent was much admired, not least by me. I have been touched by the tributes that people have paid to her, and also the personal messages of support that I have received."

Jagger's bandmates rallied around their heartbroken front man.

"No one saw this coming," Keith Richards told reporters on Thursday.

Coming in 2017: new pound coin designed to combat counterfeiting

A new £1 coin, billed by the Royal Mint as the "most secure coin in the world", is to be introduced in 2017, the Chancellor announced this week.

The move comes amid concerns about the 30-year old coin's vulnerability to counterfeiting, with an estimated 45 million forgeries in circulation.

The new coin is based on the design of the old threepenny bit, a 12-sided coin in circulation between 1937 and 1971.

A competition will be held to decide what image to put on the "tails" side of the coin.

'More resilient'

In his Budget statement to the Commons, Chancellor George Osborne said: "The prerequisite of sound money is a sound currency."

He said the £1 coin was one of the oldest coins in circulation and had become "increasingly vulnerable to forgery".

"One in 30 pound coins is counterfeit, and that costs businesses and

the taxpayer millions each year," Mr Osborne continued.

"So I can announce that we will move to a new, highly secure, £1 coin. It will take three years.

"Our new pound coin will blend the security features of the future with inspiration from our past.

"In honour of our Queen, the coin will take the shape of one of the first coins she appeared on - the threepenny bit.

"A more resilient pound for a more resilient economy."

'authentication'

The government said it would hold a detailed consultation on the impact of the change on businesses, which may face costs from having to change vending machines, supermarket trolleys and lockers at gyms and leisure centres.

Some commentators have raised fears the new piece will not work smoothly in vending machines but the Royal Mint said the coin "will be expressly designed to fit existing mechanisms".

It said the move would increase public confidence in the UK's currency and reduce costs for banks and other businesses.

Earlier, the chancellor tweeted this picture of the £1 coin next to the Budget box, captioned: "Today I will deliver a Budget for a resilient economy - starting with a resilient pound coin."

The current £1 coin was introduced in 1983 as part of the phasing-out of the Bank of England £1 note, which was withdrawn five years later.

Of the 1.5 billion estimated to be in circulation, as many as two million counterfeit ones are removed every year.

competition

The proposed new coin will be roughly the same size as the current one and will be based on the threepenny piece that disappeared after decimalisation in the early 1970s.

The new coin will be made in two colours and will incorporate state-of-the-art technology to ensure it

can be "authenticated via high-speed automated detection at all points within the cash cycle", the government added.

While the Queen's head will be on the obverse side of the coin, as it is on all legal tender in the UK, the Treasury has said there will be a public competition to decide the image on the other side.

'fitting tribute'

A silver threepence is still manufactured in very small numbers by the Royal Mint for inclusion in sets of Maundy Money.

A Treasury spokesman said the time was right to "retire" the existing £1 coin and using the threepenny bit as inspiration for its replacement was a "fitting tribute" to such an iconic design.

"With advances in technology making high-value coins like the £1 ever more vulnerable to counterfeiters, it's vital that we keep several paces ahead of the criminals to maintain the integrity of our currency," he added.

Adam Lawrence, chief executive of the Royal Mint, which is based in Llantrisant, south

Wales, said the process could change the way coins were made in the future.

"It is our aim to identify and produce a pioneering new coin which helps to reduce the opportunities for counterfeiting, helping to boost public confidence in the UK's currency in the process."

The Bank of England, which earlier this year announced banknotes would be made out of plastic rather than cotton from 2016, said the move would "enhance the security and integrity of the currency".

Tributes flow as veteran Leftie Tony Benn dies at 88

Former cabinet minister and veteran left-wing campaigner Tony Benn has died at home, his family said on Friday.

The 88-year-old former Labour MP had been seriously ill.

Mr Benn became an MP in November 1950 and served in the cabinet under Harold Wilson and James Callaghan.

A major figure on the left of the party, he narrowly missed out on the deputy leadership in 1981 and was a popular public speaker, anti-war campaigner and political diarist.

In a statement, his children Stephen, Hilary, Melissa and Joshua said Mr Benn died peacefully early Friday this morning at his home in west London surrounded by his family.

'inspiring life'

"We will miss above all his love which has sustained us throughout our lives," the family said.

"But we are comforted by the memory of his long, full and inspiring life and so proud of his devotion to helping others as he sought to change the world for the better."

Born Anthony Neil Wedgwood Benn and entering Parliament aged just 25, Mr Benn subsequently renounced his peerage, which he inherited on his father's death, to remain in the House of Commons.

He served as an MP for more than 50 years, becoming secretary of state for industry in 1974 under Harold Wilson and going on to become secretary of state for

energy, keeping his post when James Callaghan became PM in 1976.

But after the Labour government was ousted in 1979, he staged a bitterly divisive battle as the champion of the left with Denis Healey for the deputy leadership of the party.

He retired from Parliament in 2001, famously saying he wanted to "spend more time on politics".

Labour leader Ed Miliband led the tributes to an "iconic figure of our age".

"He will be remembered as a champion of the powerless, a great parliamentarian and a conviction politician," he said.

"Tony Benn spoke his mind and spoke up for his values. Whether you agreed with him or disagreed with him,

everyone knew where he stood and what he stood for."

Mr Miliband revealed he paid a visit to Mr Benn in hospital recently, describing him as being "as sharp as ever in mind".

He said: "As I left he said to me 'Well, old son. Let's have a proper talk when you have more time'."

He added: "He believed in movements and mobilised people behind him for the causes he cared about, often unfashionable ones. In a world of politics that is often too small, he thought big about our country and our world.

"Above all, as I had cause to know, he was an incredibly kind man. I did

work experience with him at the age of 16. I may have been just a teenager but he treated me as an equal.

"It was the nature of the man and the principle of his politics."

Prime Minister David Cameron said Mr Benn was "a magnificent writer, speaker, diarist and campaigner, with a strong record of public and political service".

"There was never a dull moment listening to him, even when you disagreed with everything he said."

Former Labour Prime Minister Tony Blair said: "Tony Benn was one of those rare things: a genuine radical for all his life. He was a fearless campaigner and a legendary figure for the

Labour movement.

"Even when I disagreed with him, I always had enormous respect for his brilliance, his passion and his commitment to the people of Britain and of the world."

'Nuttiness'

But Joe Haines, who was chief press secretary to Harold Wilson in the 1970s, gave a more critical assessment of Mr Benn's political legacy.

"He did one great thing in his life: he changed the constitution of the House of Lords.

"Apart from that he symbolised the sort of left-wing nuttiness that nearly destroyed the Labour party in the late 1970s and early 1980s."

“Spring rush” propels home prices to new record high

BRITISH property prices rose to a new record high of nearly £256,000 in March amid a “spring seller rush”.

The average asking price across England and Wales lifted by 1.6pc month-on-month to £255,962, surpassing a peak set last July by £2,304, according to leading UK property website Rightmove.

A new record was also set in London, where average asking prices have reached £552,530, which is £8,298 above the capital’s previous high, reached last October.

Across England and Wales, sellers’ asking prices are now 6.8pc or £16,251 higher than a year ago and in London they have seen annual growth of 11.3pc, according to the website, whose records go back to 2002. But Rightmove said that the South West and the South East, both affected by the recent severe flooding, “lag behind the spring seller rush”.

The North was the only region where asking prices were down year-on-year, with a 0.3pc annual fall taking them to £145,861 on average, while sellers in Wales were asking 4.6pc more for their properties than a year ago, at around £171,359.

The couple’s new employee will be joining them and their young son on their forthcoming tour of Australia and New Zealand - and she will have been specially trained in self defence as well as defensive and avoidance driving techniques.

A Kensington Palace spokesman said: ‘Maria is a full-time nanny, who started work with us recently, and will be accompanying the Duke and Duchess and Prince

George to New Zealand and Australia.

He added: ‘We will not be giving further details on Maria or her employment, except to say that the Duke and Duchess are of course delighted she has chosen to join them.’

Ms Borrallo trained at the prestigious Norland College which has been producing childminders for the rich and famous since 1892.

The institution’s students are known for their distinctive uniforms and are schooled in all aspects of looking after youngsters during their three-year degree course.

The training costs £36,000 in total and the college in Bath recently added martial arts training and stunt driving to its curriculum to cater for modern

Before news was announced of Ms Borrallo’s hiring, a friend of the, then unnamed nanny, told Hello! magazine: ‘She has worked with other prominent high-society families in the past. ‘It was from there that the Cambridges heard of her and hired her.

‘She is not married and doesn’t have a boyfriend as her life is totally dedicated to the

‘She is known for being totally professional - married to the job.’

William and Kate have made clear they intend to be hands-on parents.

They have often enlisted the help of Kate’s mother Carole Middleton, as well as occasionally employing William’s former nanny Jessie Webb.

However, with their upcoming tour of Australia and New Zealand signalling the start of more frequent public engagements, sources claimed the royal couple were eager to secure a full time aide.

Clarrisa Dickson Wright, TV's 'other' fat lady, dies at 66

Clarissa Dickson Wright, one half of TV cooking duo *Two Fat Ladies* with the late Jennifer Paterson, has died in Edinburgh aged 66.

The former barrister filmed four series of the globally-popular BBC Two programme before Paterson's death in 1999.

"Her fun and laughter, extraordinary learning and intelligence, will be missed always, by so many of us," said a statement from her agent.

Dickson Wright died on Saturday at Edinburgh's Royal Infirmary.

"Loved dearly by her friends and many fans all over the world, Clarissa was utterly non-PC and fought for what she believed in, always, with no thought to her own personal cost," said agent Heather Holden-Brown.

She and Paterson were brought together for *Two Fat Ladies* by TV director Patricia Llewellyn in 1996, during which they were often seen travelling the UK together in their motorbike and sidecar in search of good British grub.

battle with alcohol

Speaking on *Desert Island Discs* in 1999, following the death of her cooking partner Paterson from cancer, she said:

"She died magnificently, she was an example to all of us, if I can die that well I should be very happy."

During the same interview Dickson Wright also explained her "pathological" hatred of the humble carrot.

"My father used to pull them out of the ground and dust them off and feed them to me with the slugs on them so I think I

got put off them. Now of course I would quite readily eat the slug but I still have this thing against the carrot," she said.

Dickson Wright's former career as a young barrister at Gray's Inn was brought to "an abrupt end" by her well-documented battle with alcohol, which she wrote about in her autobiography *Spilling the Beans*.

Her forthcoming birthday on 24 June would have marked her 27th anniversary of abstinence, a birthday her agent said "meant much more to her than another year on the clock".

During an interview with *The Guardian* in 2009, she said of her AA meetings: "You'd go there and you'd know they would be pleased to see you without wanting anything from you."

'very good cellar'

"And that you could talk about the stresses in your life. To me it's very important to go to AA. It helps with the serenity levels."

She added: "I don't mind people drinking. I keep a very good cellar for my friends in my house - it's only me who doesn't drink."

After leaving law, she worked as a cook at St James's club in the capital and in private houses before managing the *Books for Cooks* shop in London's Notting Hill, then the *Cooks Book Shop* in Edinburgh.

During her cooking career, Clarissa ran her own catering business, worked on a yacht in the Caribbean and served 60 meals a day at her London

luncheon club.

She also became one of only two women in England to become a guild butcher.

She recently said: "I've had a fantastic life and I've done everything I could have wanted to do and more".

campaigner

Dickson Wright was also an outspoken campaigner for rural life and a keen supporter of the *Countryside Alliance* and after Paterson's death, she made the controversial series *Clarissa and the Countryman*, which ran until 2003.

During an interview with *The Telegraph* in 2012, to promote her book *Clarissa's England*, she accused the BBC of dropping her and the show because she went too far in praise of hunting, angering then-Prime Minister Tony Blair.

"Those were glorious years," she said of the time. "There we were, fighting the war against them on the same BBC that the leader considered his own personal mouthpiece."

When asked during an interview if she wished the show that propelled her to fame had been called something other than *Two Fat Ladies*, she replied "no".

"If you're fat you're fat. I hate this modern-day political correctness, that you don't call things by their proper name," she told *The Guardian*.

'Privileged upbringing'

She was christened Clarissa Theresa Philomena Aileen Mary Josephine Agnes Elsie

In her autobiography, she talked of "a well-to-do, privileged upbringing", that was overshadowed by her surgeon father's drinking.

"It was like having a wild animal in the house, never knowing when it is going to roar. The only time we felt safe was

when my father was abroad or, in my case, when I was at boarding school," she wrote.

She never married but while working at St James Club met Clive, "the man I was to love more than any other in my life".

"Like me, Clive was a dedicated alcoholic," she wrote. He died in 1982 after his kidneys failed.

She has been declared

bankrupt several times, having spent her £2.8 million inheritance on "drinking and debauchery".

"[It was] my own stupid fault. I've always been bad with finance," she told *The Telegraph*.

"It's from not having to worry about it. If you grow up with money, you never really learn that it doesn't grow on trees."

I'll be rich tomorrow, £108m lottery winner had told family

A LONDON car mechanic revealed on Tuesday he had predicted he would be a multi-millionaire "this time tomorrow" just hours before he won a £107.9 million lottery jackpot.

Neil Trotter, 41, (pictured, right) from Coulsdon in south London, said he had told staff at his father's office on the day of the Euromillions draw Friday that he was feeling lucky.

At around 10:30 pm that night, he went "white as a sheet" when he learned he was the single ticket holder to scoop the massive jackpot worth 128.8 million euros or \$179.2 million.

'good feeling'

After becoming the fourth-biggest lottery winners in British history, Trotter and his partner Nicky Ottaway, 33, celebrated modestly with two bottles of beer.

Trotter now plans to give up work and indulge his passion for touring car racing. Ottaway resigned from her job on Tuesday.

At a press conference with her, Trotter said: "I've always thought I'd win big and I'd had a good feeling all week.

"On Friday evening we were sitting at home when I checked the time and thought the draw must have taken place by now.

"I took out my ticket to check the winning numbers and amazingly one by one they matched. I told Nicky, 'I've done it, I've won the lottery'.

"But she told me to

shut up and to stop being an idiot.

"Apparently I turned white as a sheet and couldn't sit still, I kept walking round the house - I didn't know what to do with myself.

"I got her to check the numbers with me and she started screaming!"

He said his father initially accused him of being drunk when he told him.

uncomfortable

Trotter said the couple intended to start splashing their cash on a new house and cars.

They have been to look at new cars since the win, but their first foray into the world of the super-rich left them feeling uncomfortable.

"People give you the look as if you haven't got the money to buy them," he said.

His girlfriend said she had a similar experience when she enquired about a handbag.

"I just asked the sales guy how much it was. He said '£1,100' but he'd already turned his back and was walking away from us."

Asked if she thought the salesman regretted his actions now, Ottaway said: "I hope so, yeah!"

The mechanic, a keen amateur racing driver, said he now had the financial means to indulge in his hobby.

"I'm taking time off and going to really enjoy following the British Touring Car Championships," he said.

"It's my passion and I wouldn't mind a guest driver slot if I can find the right car," he said.




Everything I ever needed to know...Pythons' legacy continues

■ Exclusive interview with authors Brian Cogan and Jeff Massey, a review of their new book about the broad social impact of the Pythons

Rating: ★★★

"As I recall, I was walking past a fruit stand and had just come off a binge watching Python and was thinking, hmmm, I'm getting a lot more of the jokes than I did when I was 13," says Everything I Ever Needed to Know About co-author Brian Cogan, Ph.D.

"I actually discovered some new Python, including the German episodes, which I somehow had never actually seen...although I somehow knew many of the sketches," says



co-author Jeff Massey, Ph.D. "I also found out that my wife, Kristin, had never seen much Python...and yet she seems to understand me. No idea how that works, really."

Monty Python's Flying Circus ran on the BBC from 1969 to 1974, producing just forty-five episodes. The Pythons often linked different sketches together, juxtaposing them like thoughts in someone's brain. They would take on

history, sports and other subjects and by taking them too seriously make them into something that would make people laugh. Forty-five years later the popularity of their humor is in no danger of abating, is multi-generational and worldwide. The hit play Spamalot is based on a Monty Python sketch.

Authors Brian Cogan and Jeff Massey wanted to explore the impact of Monty Python in the areas of art, history, literature politic and religion that made up almost every sketch. They challenged what people thought, yet made them laugh at the same time. Cogan and Massey share lessons they learned and pose a theory of the Pythons. There were many inside jokes to the show. This book is a treat for fans and an introduction for those new to Monty Python.

Cogan says they did

much of their writing and research took place at Massey's home under the eye of his pregnant wife Kristen. "I never knew how tolerant Kristen was until we spent a whole day watching Python, taking notes, drinking beer and eating pizza," says Cogan. "Kristen came home to find us sitting on the floor - in the TV room, mind you - she was great with child at that point, and asked us, 'Have you two spent all day watching Python, eating pizza and drinking beer?' We looked at each other, nodded the affirmative in our stupor, and she said, 'Well, okay then, carry on.'"

Massey is a professor of English at Molloy College. He's the vice president of Mearstapa (the society for the scholarly study of Medieval monsters), the co-editor of Heads Will Roll!: Decapitation in the Medieval and Early

Modern Imagination, and the author of many academic articles about Thomas Hardy, Chaucer and Beowulf. He has a book chapter on Star Trek and Neo-medievalism to be published later this year. He's currently scripting for Zenescope Entertainment a few comic books, what he describes as weird takes on L. Frank Baum's Land of Oz.

Cogan is an associate professor and chair of the Department of Communication at Molloy College. He's the author of The Encyclopedia of Punk (Sterling 2008) and has written numerous articles on punk rock, comic books, and the intersection of politics and popular culture. He's written, co-written or edited eight books including his first novel Our Beloved Revolutionary Sweetheart



Leading 3-1 from the first leg at White Hart Lane, Benfica star Ezequiel Garay headed in to put the hosts 4-1 up on aggregate and they looked to be cruising until Nacer Chadli scored twice in a minute late on.

Spurs almost grabbed another as Gylfi Sigurdsson's injury-time header was saved, but Benfica made it 2-2 on the night and 5-3 overall when Lima scored from the penalty spot.

Having been outclassed in the first leg of the last-16 tie and looking weary in Lisbon, Tottenham's late surge

almost inflicted Benfica's first defeat in 23 games in all competitions.

■ Olympiakos win can be turning point, says Moyes after pulsating European night at Old Trafford

Manchester United boss David Moyes hopes his side's dramatic Champions League win over Olympiakos can be a turning point in their disappointing season.

Robin van Persie's hat-trick Wednesday night overturned a 2-0 deficit from the first leg to send United into the quarter-finals.

"I don't want to come out and say: 'This is the moment'," said Moyes. "But I hope it is."

Defender Patrice Evra added: "Everyone thought we were out, but we showed Manchester United are still alive."

Moyes, who has been under growing pressure following Sunday's 3-0 home defeat by Liverpool, said he still needed time to make his mark on the club.

"This is a work in progress and it will take time to get it as we really want it," said the Scot, whose team lie seventh in the Premier League table.

"It is a big job. I have got a lot of things I want to do, but the players gave the crowd something after we lost to Liverpool and we are delighted to see Manchester United in the last eight of the Champions League."

Moyes also insisted he was not feeling any pressure from inside the club, claiming it was all coming from the media.

"There are stories of this player falling out, or that one falling out, but it is rubbish," he said.

"People are looking for reasons why we are not doing well and it is only because we have not been playing well."

Although Van Persie scored the goals before going off on a stretcher with a knee injury, Moyes praised the contribution of recalled 40-year-old Ryan Giggs, who had a hand in the first two goals.

"Ryan's passing was fantastic," said Moyes. "His overall play was really good and he defies his age."

"He has not played much recently, but I felt, tactically, I needed him to play a certain role. He carried it out perfectly." Moyes does not think

Van Persie's injury is serious and he is delighted with the striker's contribution.

"To score a hat-trick in the Champions League is a big thing," he said. "There are only certain

Mourinho: Blues are back where we belong



Chelsea boss Jose Mourinho said his team returned to their rightful place in Europe after reaching the Champions League quarter-finals.

The Blues beat Galatasaray 2-0 at Stamford Bridge on Tuesday night to win the tie 3-1.

But they became the first side to crash out at the group stage last season, having won the title the previous term.

"We are a Champions League club and now we are among the best eight, the best clubs in the

world," said Mourinho. "The players deserve to be there."

After dropping out of last season's Champions League, Chelsea went on to win the Europa League and are now on course to win their third consecutive European trophy after first-half goals from Samuel Eto'o and Gary Cahill helped them cruise past a lacklustre Galatasaray side.

Mourinho added: "To come from the Europa League to the quarter-finals of the Champions League is

important for the club, important for the players."

Prior to the last-16 draw, Mourinho expressed a desire to play Galatasaray so he could come up against former Blues striker Didier Drogba, but he has no preferences for Friday's quarter-final draw.

Chelsea could face Barcelona, Real Madrid, Pep Guardiola's Bayern Munich and Atletico Madrid, while Mourinho has not yet ruled Manchester United out of contention.
