Paying tribute in a sea of poppies...

■ The Queen and Prince Philip remember Britain's war heroes

THE Queen and Prince Philip paid their respects to war heroes from Britain and the Commonwealth as they were surrounded by a sea of poppies on Thursday.

Her Majesty and the Duke of Edinburgh visited the Tower of London's war memorial which is dedicated to soldiers who died for their country in the First World War.

The Royal couple were surrounded by ceramic poppies at the castle's former moat and the Queen laid her own floral tribute to British war heroes.

ceramic poppies

The display, titled 'Blood Swept Lands and Seas of Red' was created by ceramic artist Paul Cummins and by Armistice Day on November 11 there will be 888,246 ceramic poppies planted, one for each British and Colonial death during the conflict which began 100 years ago. Mr Cummins, who met the Queen and the

Duke of Edinburgh during their visit to the Tower said: "I was inspired to create this installation after reading a living will by an unknown soldier who we think may have been from Derby.

'poignant and reflective'

"I approached the Tower as the ideal setting as its strong military links seemed to resonate.

"The installation is transient, I found this poignant and reflective of human life, like those who lost their lives during the First World War. I wanted to find a fitting way to remember them."

Stage designer Tom Piper helped Mr Cummins make his vision a reality along with a team of 8,000 volunteers who installed

the flowers.

When the Queen and Duke first arrived at the imposing Tower of London they were met by its Constable, General the Lord Dannatt, the former head of the British Army, and

Colonel Richard Harrold, Governor of the medieval fortress.

In an ancient ceremony they surrendered their ceremonial keys of office to the Queen and she symbolically touched the

objects.

The Queen and Duke walked through a path in the poppies to a small mound where Yeoman Warder Jim Duncan was holding the royal wreath.

The Queen touched it

and it was carefully placed on a small mound by the Yeoman Warder.

Hundreds of spectators lined the perimeter of the moat watching the solemn event and kept a respectful silence.

News From Britain

Former England footballer Sol Campbell has put his house on the market for a whopping £25 MILLION - just a week after slamming the proposed mansion tax.

If Labour is elected in May, the flagship plan would impose the tax on properties worth £2m or more in the UK.

But the ex-Arsenal and Tottenham star blasted the levy a "cheap and easy way to extract money from individuals who have done well".

And Campbell, 40, is acting fast by selling his "magnificent" London home on Cheyne Walk, with stunning views across the Thames and Albert Bridge.

The property has six bedrooms, five bathrooms, a drawing room, library, dining room and a separate mews home at the rear.

It underwent a renovation in 2008 with Campbell's wife, Fiona Barrett-Campbell, designing the interior.

'so much to offer'

The listed home has 7,224 sq/ft of space and also features a lift, 45-foot garden and an underground tunnel which links the main home and the mews property at the rear.

Campbell has now put it up for sale with the John D. Wood estate agency for £25 million.

A spokesperson for the agency declined to discuss the property, which is also available to rent through Knight Frank for £15,000 a week.

It comes onto the market just over a week after Campbell's stinging criticism of the proposed mansion tax, which would see him pay around £250,000 per year on that property.

Campbell described Labour as "the grim reaper of business entrepreneurs or anyone that has done well!"

He added: "An Englishman's home is his castle, there will be uproar with this tax!"

Campbell, who retired in 2011 having won 73 caps for England, revealed last week he is considering joining the Conservative Party and possibly even stand as a candidate.

He said: "[Let's have] a conversation just to see where they want to go with things. I have got so much to offer."

'entirely fair'

Labour is set to clarify its plans for a mansion tax amid a growing backlash from supporters.

Ed Balls announced at the party conference he hoped to raise £1.2 billion from taxing homes worth £2 million or more.

But the policy has been criticised by some Labour MPs who fear it will drive away middle class voters.

Labour will seek to reassure MPs the average charge will be closer to £3,000, rather than £15,000 as suggested.

"It is entirely fair if your home has doubled in value in the last ten years and have made a £1 million profit you should pay your bit," said an insider.

The Shadow Chancellor said the proceeds from the mansion tax would be used to pay for thousands of NHS nurses, doctors, midwives and other health workers.

Under the plans there will be a series of bands with those in the most expensive houses, worth

over £10 million, paying proportionately more.

Mr Balls has insisted Labour will be "sensitive" to the fact that some people might have an expensive house but a low income. He said they will be exempt from the annual charge.

The decision to clarify the plans follows criticism

from Labour MPs, including former minister Margaret Hodge who said the tax was "too crude to work".

Former Cabinet Minister Dame Tessa Jowell has also voiced concerns it could hit "typically older families who are asset rich and income poor".

Ebola: new screening at Heathrow branded 'a joke'

- Travellers arriving at Heathrow from West Africa walked through unchecked
- Government said the screening is needed 'to make our country safe'
- Health Secretary: 'It's a global health emergency possibly on scale of Aids'

Britain's Ebola screening plans descended into chaos on its first day this week after people flying to the UK from high risk countries revealed the checks are not compulsory.

Health Secretary Jeremy Hunt said airline passengers from West Africa must be checked for symptoms 'to make our country safe' and warned the epidemic could be as deadly as Aids.

He also warned Britain should expect up to ten cases by Christmas as screening of passengers from Sierra Leone, Liberia and Guinea, where 4,000 have died from Ebola, started at Heathrow.

But travellers at Terminal One Wednesday morning said the system is a 'complete joke' because they were either not checked at all, told it was optional or had to seek out medical staff themselves.

After the complaints the Department of Health confirmed that screening travellers at major entry points into UK is not mandatory unless they 'show symptoms of the virus'.

'complete joke'

Sorious Samura who flew in from Liberia, said he had decided to volunteer to be screened and was not made to take the questionnaire and temperature check.

The documentary maker had been making a film about the deadly virus in Liberia and arrived at the

London hub this morning from a connecting flight from Brussels.

And he said checks and precautions were more strict in the west African state than those he met at Britain's borders.

He said: 'It was disappointing. I think in a situation like this, given the fear that is being spread, I would expect a mandatory screening.'

'I was told it is up to you if you want to be screened or not.'

'Having seen it first hand I think it was a bit lax here. To be honest it was a complete joke.'

'compulsory'

Clive Patterson, 32, who was working on a documentary on the virus with Mr Samura, also volunteered to be screened.

He said: 'We have been working, interviewing, people who are in the

'If you are going to make the effort and take this measure, you might as well make it compulsory.'

'I could have Ebola and I could have walked

straight through.'

Gina Jere, 50, said she was surprised not to have been screened at Heathrow the same day.

The journalist - who flew in from The Gambia via Brussels - said she saw no one being screened this morning and she was not

It came as Jeremy Hunt said the Ebola epidemic could be as deadly as Aids, which has claimed 30million lives.

And it emerged the death rate has now reached 70 per cent, with the World Health Organisation warning there could be 10,000 new cases per week within two months.

More than 4,000 people have died from a total of 8,914 cases across West Africa and also Spain and the United States.

In America every high risk passenger arriving at five airports including JFK in New York from Liberia, Sierra Leone or Guinea has their temperature checked and asked if they are unwell.

Exit screening is already in place in West Africa, but the World Health Organisation does not advise on entry screening in other countries.

Mr Hunt told reporters: 'This is a global health emergency we haven't seen for years. Possibly it could get to the scale of the Aids epidemic. The impact it could have could be absolutely huge.

'If we are going to make our country safe we need to make sure the virus is contained. It is a global phenomenon'.

Pensioner told she had dementia and sold her house to pay for care is told 18 months later there is NOTHING wrong with her

An elderly lady diagnosed with dementia sold her house to pay for an 18-month stay in a specialist care home - only to find out there was nothing wrong with her.

Winnie Hill, 88, was left distraught after doctors told her she was suffering from Alzheimer's and needed round the clock care.

The frail pensioner didn't think she was ill but agreed to sell her home in Plymouth, Devon, so she could move into a specialist medical facility.

Her weight plummeted and she described the experience as like living in a 'prison' - but her confused family could see no signs of the dreaded condition.

They pushed for a second diagnosis and were left stunned when another doctor rubbished the original diagnosis and said Mrs Hill wasn't

suffering from dementia at all.

She has since moved out of the home but her family say she suffered a devastating 18 month ordeal at the hands of the errors made to her care.

'isolated'

Mrs Hill was given the devastating diagnosis of dementia in early 2013 when she showed signs of cognitive impairment.

Her daughter, Katherine Hicks, trusted experts who recommended she move into a care home with a dementia wing.

In order to pay for it, she had to sell her mother's house.

Over the next few months she watched as her mother became withdrawn, unhappy and stopped eating.

Ms Hicks said: 'She was feeling like she was in a prison and isolated. I think she was angry as well and didn't know

how to express herself.

'Everyone was looked after really well but I saw things I didn't want to see - and worried that was what my mum was going to be like - it was really hard.

'She stopped eating and started losing weight. I decided I had to had to find out what was going on.'

'very angry'

Mrs Hill said she was shocked to hear she had Alzheimer's and hated being constantly monitored by medical staff inside the home.

She said: 'I was upset because I didn't realise there was anything wrong

with me. I felt normal I didn't understand why the doctor would say that.

'I didn't like it much. It's as though they were watching over me and I didn't need watching.'

Over a year later, miserable and frustrated, she pushed her daughter to seek a second opinion. 'A doctor came in to see me and said: "I don't know why they've put you in here. You don't need to be here because you don't have Alzheimer's".'

She claims the doctor added there was nothing wrong with her.

Mrs Hill is now furious at the way she was treated. She said: 'I got

very angry. I'm not accepting this, I don't think it's right they should treat me like this.'

Her daughter added: 'It makes you feel like you want to scream and shout and somebody - but I'm not sure who I'm meant to scream and shout at.'

Mrs Hill is now living in a home where she is much happier.

Dementia affects an estimated 670,000 people in England and Wales but experts say 350,000 of those remained undiagnosed and without access to support.

A spokeswoman for NHS England said misdiagnosis rates are not recorded.

Geldof: I blame myself for Peaches' death

Sir Bob Geldof says he blames himself for the death of his daughter, Peaches, because as a parent he was responsible for her "and clearly failed".

The musician said he had known about her heroin addiction and tried to help her through it.

"Of course I knew about it and we did more than talk about it. She was super bright. Too bright. A very errant mind that could focus intensely on a book which she would consume and just absorb it.

"But the rest was a franticness. She knew what life was supposed to be and, God bless her, she tried very hard to get there. And she didn't make it," Sir Bob said in an interview with ITV News.

The Geldof girls were subject to intense media interest following Sir Bob's split with their mother, Paula Yates, and her subsequent death in 2000 from a heroin overdose.

"They got at them to get at me," Sir Bob said of the media. "Because it hurt me so much but it just damaged them and I'm not just blaming the newspapers, of course not... You blame yourself.

'utterly cathartic'

"You're the father who is responsible and clearly failed."

Asked if he really felt responsible, he replied: "Yes, of course you do. For anybody watching who has a dead kid and you're a parent: you go back, you go back, you go back, you go back, you go over, you go over. What

could you have done? You do as much as you can."

Sir Bob said he had not yet come to terms with his daughter's death. She died of a heroin overdose at her home in April. She was 25 and left behind a husband and two young sons.

Performing on stage with his band, The Boomtown Rats, acts as catharsis. "I put on my snakeskin suit and I can be this other thing. It is utterly cathartic. Those two hours and I am drained. In every sense it empties, it drains my mind. On stage I'm lost in this thing and it's a very brief respite," he said.

"When Paula died and Peaches a few months ago... the ability to try and understand, although it is incomprehensible with the immensity of the grief, is there.

"But it takes a long while for it to filter through from the filth to get to the front so you can see it. Peaches yet. It is all too soon, all too sudden. Too unexpected."

Britain battens down the hatches...

■ Hurricane Gonzalo expected to reach UK by Tuesday

AFTER A YEAR when it seemed the weather in Britain could not get any stranger, the country is now preparing itself for high winds and flash flooding from Hurricane Gonzalo.

The category 4 storm was set to hit Bermuda on Friday and experts predict the tail of the tempest will batter Britain by early next week.

Emergency planning procedures are on standby in case they are needed and officials from the Met Office are working closely with the Highways Agency and the Environment Agency.

If it strikes the country there is a risk of flash flooding and strong winds.

Last October, the St Jude's Day storm saw

80mph winds, flights cancelled and 20ft waves battering the coastline.

This weekend forecasters have already predicted a bizarre combination of unseasonably warm weather, strong winds and rain from the fall out from Hurricane Fay, which hit last weekend.


Despite winds forecast of up to 50mph in exposed areas, temperatures are set to increase from the average of 55F (13C) to 70F (21C).

The National Hurricane Center in Atlanta predicts Hurricane Gonzola will hit Bermuda on Friday and make its way across the Atlantic to reach Britain's coastline by next Tuesday in a milder form.

It is expected to remain in Bermuda until Saturday before it begins to move towards Britain, reaching Newfoundland in the early hours of Sunday morning and continuing its path across the Atlantic Ocean on course to hit Ireland in the early hours of Tuesday morning.

When it reaches the British coastline in will be in the less ferocious guise of a post-tropical storm but it could still spell misery and chaos for the country.

A spokesperson for the Met Office said: "By the time it reaches us it will bring wet and windy weather. The forecast for next week is wet and windy weather and if the storm hits us it will just make the wet and windy weather worse."

Happy ending for local expat after beloved parrot goes native...

BRITISH EXPAT Darren Chick was gutted when he lost his beloved grey African parrot, Nigel, four years ago.

After a couple of months of fruitless searching the Torrance-based Brit had given up all hope of ever seeing the bird again – until veterinary tech Teresa Micco turned up last week with Nigel in tow.

Quite where the bird has been for the past four years remains a mystery. But Nigel certainly seems to have gone native – he has lost his British accent and now speaks Spanish, with ‘que paso?’ his favorite utterance.

Mr Chick told a reporter that even

though he has no idea where the bird has been for the last four years, he recognized him immediately.

Nigel was discovered by Julia Sperling of the Happy Tails Dog Spa in Torrance, who found him at the door of her salon one day and took him in.

“He was the happiest bird. He was singing and talking without control. He was barking like the dogs,” she told reporters.

“I’m from Panama and he was saying, ‘What happened?’ in Spanish.”

Julia thought he resembled Benjamin, a missing grey parrot whose picture she had seen posted in the neighborhood, so she

contacted Benjamin’s owner, Teresa Micco and handed him over.

After careful examination Teresa realized Nigel was not Benjamin and attempted to trace his original owner. Fortunately Nigel had been microchipped – amazingly enough by Micco some years earlier – and by searching through old sale records Teresa was able to ensure a reunion between the bird and his human companion.

Both phone numbers Teresa had on record were disconnected, so she drove round to Darren’s house and knocked on his door.

“I introduced myself and said, ‘Have you lost a bird?’ He initially said

no. But he thought I meant recently.

“He looked at me like I was crazy.”

The reunion brought tears – and not just of joy – to Chick’s eyes. Things

Micco said the behavior was not unusual and that Nigel

would settle back in soon enough.

“He’s doing perfect,” Chick said by the end of the week. “It’s really weird, I knew it was him from minute I saw him.”

Former drug addict and ex-convict Jamie Blandford becomes 12th Duke of Marlborough after father dies

■ New Duke has a 30 year record of drugs, burglary, criminal damage, driving offences and assaulting a PC

Jamie Blandford’s father once viewed his son as such a lost cause that he went to court in an attempt permanently to disinherit him.

But on Thursday the convicted burglar, drug addict and serial prisoner became the 12th Duke of Marlborough and custodian of Blenheim Palace following the death of his father at the age of 88.

The Spencer-Churchill family announced “with great sadness” that the 11th Duke, John George Vanderbilt Henry Spencer-Churchill, “passed away peacefully” Wednesday morning. His funeral will be held next Friday.

David Cameron, a friend of the Duke as well as his local MP, said: “I am

greatly saddened to hear of the death of the Duke of Marlborough. To me, he was not only the vice-president of my [Witney Conservative] Association but also a good man and friend.

“His grace will be deeply missed by all those he worked alongside at Blenheim and by the town of Woodstock where he played such a positive and active role in the community he loved.

The responsibility of maintaining one of Britain’s grandest country houses for future generations now passes to 58-year-old Jamie Blandford, as he is commonly known, following a remarkable turnaround in his relationship with his late father, who once described

him as the “black sheep” of his family.

Blandford, or His Grace as he will now be formally addressed, has more than 20 convictions going back 30 years for drug offences, burglary, criminal damage, numerous driving offences and even punching a police officer.

His well-documented battle with heroin and cocaine addiction – he once admitted spending £20,000 on cocaine in four months – strained his relationship with his father to breaking point, and in 1994 the two men faced each other in court to fight out the future of the dukedom and the £100 million Oxfordshire estate.

The 11th Duke became the first aristocrat for more than a century to attempt to use the courts to deny

his direct heir his eventual title, and was ultimately thwarted because the 1706 act of Parliament that gifted Blenheim to the 1st Duke of Marlborough forbade any intervention in the inheritance.

But Blandford’s father managed to persuade the High Court that it had a duty to protect the estate for future generations, and his son was forced to agree to an agreement that ceded all executive power to a

board of trustees that look after the estate.

Two years ago it emerged during a Channel 4 documentary about the family that Blandford had stayed clean of drugs for several years, earning something of a reprieve from his father, who agreed that he should inherit overall charge of the estate, though with trustees retaining a power of veto.

The 11th Duke said at

the time: “I am fully confident that James will be able to keep this place going. But over the top of him – and over the top of me – are trustees. You can’t predict the future.

“Trying to keep Blenheim going is a very important part of the family’s history and life at the present time, and so what we’re trying to do is ensure that Blenheim is kept for future generations.”

BRITISH AMBASSADOR to the U.S.A., Sir Peter Westmacott, KCMG, LVO, will be the guest of honor at the upcoming Distinguished Speaker Series at the Beverly Wilshire Hotel on Friday, October 31st.

The event runs from 7.30-9.15am and is hosted by the British American Business Council.

Sir Peter became British Ambassador to the United States in January 2012. This is his second posting in Washington, having previously served as the British Embassy's Counsellor for Political and Public Affairs in the mid-1990s.

Prior to his service as ambassador to the United States, Peter served as the British Ambassador to France - from 2007 to 2011 - and as Ambassador to Turkey starting in 2002. Peter's forty-year career in the British Diplomatic Service has included postings in Tehran and Brussels, time as the Foreign and Commonwealth Office's Director for the Americas, and a seat on the board of

the Foreign Office as Deputy Under Secretary. In addition, he served as Deputy Private Secretary to His Royal Highness The Prince of Wales from 1990 to 1993.

Peter's personal connection to the United States extends back even further than his diplomatic posting. In 1942, his father was a sailor on the HMS *Illustrious* as it underwent repairs in Norfolk, Virginia to recover from damage inflicted during fighting at Malta.

Peter was born in Somerset and educated at New College Oxford and joined the Diplomatic Service in 1972. He married Susie Nemazee in 2001; together they have four grown children: Oliver, Laura, Rupert and Safieh.

A source close to SuBo told a British tabloid:

"She has found it very difficult not to talk - anyone who knows her will understand how much she likes to chat.

"But more than anything she just feels terrible about letting her fans down. She just wants to get back to her best.



Shakespeare’s Pub: get it down you...

■ Exclusive interview with author Pete Brown and his book about a pub that’s been around since Shakespeare’s time

Rating: ★★★



“Much of the history of pubs and beer is not written down,” says *Shakespeare’s Pub* author Pete Brown. “They were the places of the working classes, and for most of our history these people could not read or write. I spent a year looking for mentions of the pub in old newspapers, public records offices, anywhere I could find them. Then it was just a case of choosing the right pub, and the George Inn quickly emerged ahead of other old pubs I could

have written about.”

This book isn’t about Shakespeare, but about a pub he may have frequented. The focus of the book is a history of Southwark, on London’s South Bank. The George Inn is located near London Bridge and The Globe Theater where Shakespeare spent much of his time. Changing its name over the years, it has been around for about 600 years. The original building burned down and was rebuilt

only to go up in flames in a second fire and be rebuilt again.

There are chapters in the book about the famous writers who came to the inn. The National Trust now owns it. A detailed time line of the George Inn is included. The details are fascinating with footnotes along the way covering gossip and news of the day. The pub benefited from its location on the road out of London where many great and aristocratic people traveled. It’s where the mail coaches changed horses on their way to the provinces.

Brown had to restart writing the book after the theft of his laptop, “I had almost finished the research, which happened in a pub of course,” says Brown. “I was four months away from my deadline and I had nothing backed up.

My external hard drive had stopped working and I hadn’t quite figured out the Cloud by that point. I literally had to start again from scratch. In some ways it’s a better book because of it, but it’s not an experience I’d care to repeat.”

The idea for the book emerged gradually, over about five years. “There had been a couple of books here tracing the history of individual houses or streets through the ages, and I thought, there’s way more going on in pubs than houses, and many pubs have been around much longer than houses,” says Brown. “A similar book about a pub would be amazing to research and write.”

“I wanted to get to the greatest level of granular detail that I could,” says Brown. “This book owes its existence to public

libraries. The British Library in North London allows you access to pretty much any book ever written, and allows you to work search online copies of newspapers up to 400 years old. Then the local library near the George Inn in Southwark, South London, had a folder of press cuttings about the pub that’s four inches thick, going back to the Victorian era. Our libraries are essential resources and they must be preserved.”

Brown writes a blog and articles. His books include *Man Walks into a Pub* (a general history of beer and pubs), *Three Sheets to the Wind* (a global tour in search of the meaning of beer), and *Hops and Glory* (his quest to recreate the voyage of India Pale Ale). His latest book, *World’s Best Cider*, is a global guide.


and it's a bit of an honor actually to be now the new Dracula on the block!"

"The film is about the transition Vlad made on a human level, after being taken captive by the Ottoman court and reared as a child by his father's enemy, the first sultan," Evans says. "He's the man that inspired Bran Stoker 400 years later to write the story of Dracula," Evans continued. "We start with a human story,



about this man who is a father and a leader and a king and a husband - a loving husband - who has a very dark past, who is now fighting for the safety of his family and his people. It's a very human story, which has never been done before."

Beating the top seeds

Ireland keeps Northern Ireland two points clear at the top of Euro 2016 qualifying Group F, ahead of Romania, whom they visit next month.

Jamie Ward's shot deflected off Loukas Vyntra to put the visitors

ahead.

And, after half-time, Kyle Lafferty ran clear and fired home a low shot from the edge of the area to seal victory.

It was a sublime finish from the Norwich City striker, who has now scored in each of the opening three qualifiers against Hungary, the Faroe Islands and Greece to take his tally of international goals to 12.

Northern Ireland began brightly as they attempted to extend their 100% record and Ward's ninth-minute opener was just reward for their endeavour.

Greece, who had garnered only one point from their opening two matches, began to enjoy more possession, but a poor final ball let them down on too many occasions.

The struggling hosts, European Championship winners in 2004, carved out only one notable chance in the second half, but Panagiotis Tachtsidis saw his curling left-foot shot pushed round the post by former Olympiakos keeper Roy Carroll.

O'Neill left purring after Germany draw

Republic of Ireland manager Martin O'Neill praised the resolve of his team after an heroic 1-1 draw with Germany on Tuesday night.

John O'Shea scored a stoppage-time equaliser on his 100th appearance to leave the Republic unbeaten after three games and joint top of Group D.

"It was a terrific game for us. To the very end we kept going and our spirit carried us through," said O'Neill.

"You couldn't have written that script for John. He gets the goal and I'm absolutely delighted for him."

Toni Kroos put the Germans ahead before O'Shea levelled in the dying seconds of injury time.

"We were backs to the wall in the first half," O'Neill said.

"We had formulated a plan that we would try and thwart them as much as we can while at the same time, when we had the ball ourselves, try and manoeuvre it.

"We were unable to do that for periods in the first half, we seemed to be under pressure.

"We got through that time but it was a wee bit of a similar pattern in the second half when they scored.

"That changed the mindset of us to go and search for the equaliser. Even if we concede two, three, four, I don't care, as long as we try and get something from the game."

O'Shea celebrated a "special moment" by stabbing home just the third goal of his international career and put another dent in Germany's campaign following their defeat in Poland on Saturday.

Sunderland defender O'Shea said the goal will stay with him for a long time and he plans to give his shirt on to his parents so they can share in his success.

"That goal just takes over those other two," he said.

"It was a very special moment because the group has a fantastic spirit and we didn't want to come off this pitch with just a 1-0 defeat. But that makes it a bit more special - we got something from the game.

"I think we might have to find a frame for it [my shirt]. I'm not one for hanging stuff or putting stuff up on any mantelpieces but I think this one could be heading for the mantelpiece at my mam and dad's house."

Speed's legacy lives on, says Welsh star

Winger David Cotterill believes the seeds of Wales' good start to their Euro 2016 campaign were sown by former manager, the late Gary Speed.

Substitute Cotterill scored Wales' opening goal in the 2-1 win over Cyprus on Monday which maintained their unbeaten start.

The Birmingham City player said Speed, who died in November 2011 aged 42, had instilled a tight-knit team spirit during his time in charge.

"He started all this off, the togetherness," Cotterill said.

"Every time we've come away the last few camps everyone seems together and it definitely changed when Gary Speed took over.

"Chris Coleman's taken that on board as well and things are improving.

"Everyone here is working extremely hard for each other and we're all together."

Wales failed to reach the 2014 World Cup finals in Coleman's first campaign in charge but have made a good start in the Euro 2016 qualifiers and are top of Group B.

Cotterill had been recalled to the squad for the Euro 2016 double header against Bosnia-Herzegovina and Cyprus in Cardiff.

The Cardiff-born player hopes to add to his 21 caps against Belgium in Brussels on 16 November.

"It's always nice to play for Wales and it's nice to be back in the squad," Cotterill said.

Roy and Rodgers: the feud deepens?

Euro 2016 qualifying: England riding high but two more wins are overshadowed by Sterling row

THE APPARENT rift between Roy Hodgson and Brendan Rodgers deepened this week as the club versus country issue again raised its head over the issue of Raheem Sterling.

The 19-year-old Liverpool star told England boss Roy Hodgson ahead of Sunday's Euro 2016 qualifying match in Estonia that he was 'tired' and needed rest following a busy start to the season, prompting Hodgson to publicly cast doubt on the claim from Sterling's club manager, Rodgers, that some players need a two-day recovery period after matches.

"Raheem might say it is something that is becoming ingrained in him and that he felt the need to talk about being tired more than normal," said Hodgson.

"I don't think there's medical evidence to support the 'two-day recovery'."

Relations between England and Liverpool were already strained after

Daniel Sturridge was injured on international duty in early September, with the striker not playing for club or country since.

Rodgers was angry when Sturridge suffered a thigh injury in training after England's 1-0 victory over Norway on 3 September, with the Reds boss insisting that players with pace need time to recover.

"I think clubs work differently at times to international teams," said Rodgers. "It's more the recovery strategy. When we look at our players here we look at them individually in terms of what their needs are.

"Fast players would have a second day recovery while other players can work on that day."

Sterling played 45 minutes of the 5-0 win against San Marino and came on as 64th-minute substitute in Tallinn on Sunday.

Although Hodgson was diplomatic when addressing reporters after

the game about the issue, he did say he planned to speak to Rodgers about the issue.

"I should speak to Brendan and I'm sure he understands the situation," said former Liverpool boss Hodgson. "I made the decision to play Adam Lallana, but he [Sterling] recovered well enough for the game and is 100% fit.

"Brendan has been talking about the pressures Raheem has been under and the fatigue that has been setting in so I'm sure he will be dealing with Raheem over the next month as he sees fit."

Sterling played the last 26 minutes as a substitute against Estonia, winning the free-kick from which Wayne Rooney scored the goal that gave England their third win from three Euro 2016 qualifiers.

And former Wales assistant coach Raymond Verheijen took to Twitter to label Hodgson a 'dinosaur' on who has 'made himself look stupid'.

Euro qualifying will go down to the wire, predicts Strachan

Manager Gordon Strachan believes Scotland's Euro 2016 qualifying group not be determined until the final whistle of the last game.

Following a pulsating 2-2 draw with Poland – conquerors of Germany - in Warsaw this week, the Scotland boss said Group D was proving a stern test.

"I said it after the Germany game and this confirms it: this is the hardest group, this will go to the last day," he said.

The Scots have four points from a possible

nine and face Republic of Ireland next month.

The Irish will be on a high after securing a shock 1-1 draw with the world champions on Tuesday night.

In Warsaw, Krzysztof Maczynski opened the scoring for Poland before Shaun Maloney drew Scotland level following a superb counter attack.

Steven Naismith steered the Scots in front but Arkadiusz Milik's equaliser set up a barnstorming finish.

The Poles and Republic of Ireland are joint top of the group on seven points, with Scotland and

Germany three further back.

Strachan conceded that he would have been content with a point in Warsaw before the game. However, he added: "As you've seen, our team said, 'we want three points' and they go a goal behind and still keep playing.

"It was good, terrific, and it wasn't an easy surface.

"I see patterns now getting played during the game so I'm really pleased with the performance and really pleased with their improvement."
