Merkel to UK: follow the rules or leave EU

Germany 'would accept UK exit from EU' to protect migration rules

Chancellor Angela Merkel has reportedly warned David Cameron she would rather see the UK leave the EU than compromise over the principle of free movement.

Der Spiegel news magazine quotes German government sources as saying she feared the UK was near a "point of no return".

Chancellor George Osborne dismissed the story as speculation about how Germany may react to a future UK policy shift.

But he insisted ministers would act in the national interest in addressing public concerns about immigration.

He told a leading British morning show that concerns about abuses of the benefit system were causing "great unhappiness" but the UK would approach

future negotiations in a "calm and rational" way.

Mr Cameron wants to renegotiate the terms of the UK's continued membership before holding an in-out referendum.

The prime minister has insisted that freedom of movement of workers would be "at the very heart of my renegotiation strategy for Europe".

But Mrs Merkel is said

by the magazine to have made clear she will withdraw her support for the UK's continued EU membership if he continues to push for migration reform which requires fundamental changes to the principles of the organisation.

'Britain first'
The German chancellor's warning to Mr Cameron is reported to have come

in a meeting on the fringes of the latest EU summit in Brussels last week.

Der Spiegel, quoting sources within the German chancellor's office and German foreign ministry, said this was the first time Mrs Merkel had acknowledged that the UK's exit from the EU was possible.

Foundering Miliband pleads with rebels to get behind him

■ Speculation rife that Labour leader will be replaced before next General Election

Ed Miliband has made a public call for Labour MPs to back him, adding fuel to the crisis surrounding his leadership.

At least four backbenchers have called on Mr Miliband to step down amid growing fears that he is leading his party to a general election defeat.

The Labour leader used an unplanned television interview this week to try to dismiss talk of a plot against him.

It is understood that Mr Miliband decided to confront the leadership issue publicly because he feared allies of Gordon Brown were organising a concerted attempt to remove him. But the high-risk strategy appeared to backfire as MPs said Mr Miliband had only deepened the sense of crisis around his leadership.

"Going on television to talk about it was mad. It makes it look even worse than it is," one

frontbencher said. "I started off thinking this was the usual grumbling, but now it looks more serious than that."

Another MP said the impromptu interview on BBC News was a sign of a "bunker mentality" among Mr Miliband's team. "He thinks we're all out to get him."

slim majorities

One party official said Mr Miliband was starting to show signs of personal strain over his party's poor poll ratings. "He's been lashing out, blaming people, which is out of character."

Mr Miliband made his address after at least four backbenchers called for his resignation.

Two of the MPs who want Mr Miliband to stand down were named in Westminster as Simon Danczuk, the Labour MP for Rochdale, and Ian Austin, the Labour MP for Dudley South. Both were unavailable for comment.

Several MPs have

directly approached David Watts, the chairman of the Parliamentary Labour Party (PLP), to say that they believe it is time for Mr Miliband to go.

They could now be joined by more than a dozen other MPs with slim majorities who fear that Mr Miliband's leadership could cost them their seats in May.

The MPs are furious at their leader's "lacklustre" performance at the party's conference and a poll at the weekend that suggested he is now less popular than Nick Clegg, the Liberal Democrat leader.

'huge issues'

One of the MPs said: "The mood in the party is black. We are down to 29 per cent in the polls and that could go down further."

"He is less popular than Nick Clegg and he will cost us votes at the general election."

"We are hearing it on the doorstep. People are

saying, 'You are doing an all-right job but we don't like your leader'."

In his address, Mr Miliband chose to tackle the rumours head on. He said: "This is nonsense, I don't accept that this matter arises. I believe that what the party wants to focus on is the country. There are huge issues that our country faces. We are determined to be a one-term opposition."

A YouGov poll for

London's leading news radio station, LBC, found that nearly half of voters believe the Labour Party would be more likely to win the general election without Mr Miliband as leader.

Lord Soley, a former chairman of the PLP, admitted that Mr Miliband's predicament was "serious".

He said: "It would be silly to say that every Labour MP is relaxed about the present

situation.

"You know that that's not true and it's no good me saying they are relaxed."

"And at the moment they're just in their constituencies fighting in their constituencies and I think that's what they need to do."

"But I do think at centre we can do it differently... It's not rocket science, actually."

"It's been done before and we can do it again."

"Should Cameron persist (in this plan), Chancellor Angela Merkel would abandon her efforts to keep Britain in the EU," it quoted the sources as saying.

"With that a point of no return would be reached. That would be it then."

According to the Sunday Times, Germany has already rejected a proposal to impose quotas on low-skilled EU migrants by limiting the national insurance numbers issued to them. Der Spiegel reported that Mr Cameron was now looking at a plan to stretch the EU rules "to their limits" in order to ban migrants who do not have a job, and to deport those who are unable to support themselves after three months.

'No iron lady'

Conservative MP David Davis said Mrs Merkel was an "important" figure in Europe but "she is not an iron lady", suggesting she was also likely to come under pressure from within Germany to restrict immigration within Europe from countries with lower average incomes.

On Sunday, Conservative MP and former justice secretary Kenneth Clarke defended EU migration.

"If you're going to have a sensible single market, if we want to compete with the Americans and the Chinese and so on, we need the free movement of labour," he told BBC's Sunday Politics.

A Downing Street spokesman said Mr Cameron would make a speech on immigration before Christmas, and stressed "you can be sure he will always put Britain first."

■ Cops called in after Sussex town abandons plan to burn effigy of Scottish leader

Thursday's Guy Fawkes' night festivities in Britain took a strange twist after a Twitter spat erupted following news that a South Coast town planned to burn an effigy of Alex Salmond.

At press time police in Lewes were investigating a complaint that effigies of Scotland's First Minister were due to have been burnt at bonfire celebrations in the East Sussex town.

The effigies were quickly withdrawn from the celebrations after a storm of protest on social media.

The Waterloo Bonfire Society, which produced one of the models, said it had "no wish or intention to offend".

A Sussex Police statement said: "We are aware of the portrayal of Scottish First Minister Alex Salmond as an effigy at the 2014 Lewes Bonfire event and acknowledge that concerns have been raised.

"Whilst we accept there is a long tradition of creating effigies of

high-profile individuals in politics, sport, the media, etc, a complaint has nevertheless been received and will be investigated."

The row began on Wednesday afternoon when East Sussex County Council tweeted a picture of one of the effigies of Mr Salmond, complete with a "Yes" badge, a sign saying "45%" and the Loch Ness monster looking over his shoulder.

'insults from Tories'

They faced an immediate backlash on Twitter with one user responding: "Can you imagine the uproar amongst Better Together campaigners had Yes supporters burned an effigy of David Cameron?"

Others posted the council's switchboard telephone number, and urged people to complain. The council later clarified: "Please note that the Alex Salmond and Nessie models were created by Waterloo Bonfire Society #LewesBonfire and have

Two dead after cannibal attack

A MAN involved in a suspected act of cannibalism has died after being Tasered by Welsh police.

Matthew Williams was disturbed by police after allegedly killing a woman and then eating her face at the Argoed hostel in Gwent early on Thursday morning.

Officers went to the former Sirhowy Arms Hotel in Argoed, Blackwood, at 01:23 GMT where it was reported Williams was attacking the woman.

The 22-year-old's death is being treated as murder, the force said.

It confirmed officers fired a Taser at Williams, 34, who was then arrested but later died.

The matter has been referred to the police watchdog, the Independent Police Complaints Commission (IPCC), which confirmed it is investigating.

The police force said Williams was local to the area and the woman was from Blackwood.

It added it was not looking for anyone else in connection with the incident.

Mr Salmond responded to the initial tweet by telling BBC Scotland he was "used to insults from Tories in East Sussex".

He questioned the judgement of those behind the effigy.

But Mr Salmond, who will stand down as first minister and Scottish National Party leader next week, said he was more worried about Nessie, who was also to be burned.

'no political affiliations'

In a statement, the Waterloo Bonfire Society said it had a "tradition of creating satirical tableaux in caricature based on topical local, national and international events".

It said: "It is a tradition which has endured for many years and is intended to portray familiar stories and characters in a light hearted way. Clearly the Scottish Referendum has been a big story in the news recently and Alex Salmond is high a profile figure.

"We are a traditional Sussex family bonfire society and have no political affiliations. We can assure that we have no wish or intention to offend and have never found ourselves in a position where we have done so in the past. To clarify we do not burn tableaux. They are incorporated into our firework display.

"In the light of the responses received to our tableau idea this year we

have made the decision to withdraw it from our celebrations."

The Waterloo Bonfire Society is one of six which parade through the town every year. The societies all have their traditions, costumes, fire sites and fireworks. A second effigy of Mr Salmond was paraded through the Sussex town by another bonfire society - the Commercial Square Bonfire Society.

An effigy of David Cameron holding a "puppet Nick Clegg" was burned in Lewes in 2010. Other effigies in previous years have included Osama Bin Laden.

The event is said to be one of the largest bonfire celebrations in the UK, with 45,000 people attending.

Are we going to the zoo? Camilla jokes as she hops on London bus... during four-day trip to Mexico

THE Duchess of Cornwall left her chauffeur-driven car behind and hopped onto a London bus as she wound up a short tour to Mexico on Thursday.

Camilla boarded the red routemaster during a visit to the industrial northern city of Monterrey then joked "are we going to the zoo?"

Seeing a London bus under grey skies after a

downpour, the Duchess probably felt the city was a home from home.

The number 7 bus - emblazoned with the route London to Monterrey - took her a short distance across Fundidora Park, built on the site of industrial works and now home to a museum showcasing the heavy industry of the area.

Travelling with Camilla was Gretta Salinas de

Medina, wife of the governor of the local state of Nuevo Leon, Rodrigo Medina.

They stepped off at a canal in the park and took a pleasure cruise around a series of waterways which featured cultural performances of dances and musicians along its route.

At one point, when they hit choppy waters, Camilla pulled a face as if

a little concerned.

The routemaster was restored to its former glory by plastic surgeon Angel Tobar, 50, who bought it for his artist wife Marissa, 49, to use as a mobile gallery.

makeshift seat

He said: "This is the first time the bus has been used and it was used to take Camilla on a trip - so that's a nice way to begin."

Camilla sat on a makeshift seat in the bus, built in 1948, as all the rest had been removed to make the routemaster into a mobile gallery.

Mr Tobar bought and

restored the London bus for around \$125,000 (£100,000) just over three years ago and spent the last two having it rebuilt.

He said: "My wife found it on the internet, it was in Arizona. It was taken from London in the late 1960s and it was originally owned by the man who bought London Bridge."

'mutual respect'

When Camilla first arrived with Charles at the industrial museum they were greeted by a group of performers, Ballet Folkloric Monterrey, who wore traditional costumes from the state - Stetson hats and tasselled jackets for the men and long flowing skirts for the women.

The Governor of the local state of Nuevo Leon welcomed the Prince and Duchess in a speech and

Charles spoke a few words in Spanish in return: "Thank you for your kind welcome, Governor. My wife and I are delighted to be here in Nuevo Leon for the first time, on the final day of our visit to Mexico."

As Charles and Camilla's four-day tour of Mexico came to a close, Duncan Taylor, Britain's Ambassador to Mexico, said the royal couple had been well received.

He said: "The crowds of people we saw in all the regions we visited prove that there is real affection for their royal highnesses here in Mexico."

"I am confident that this royal visit will give a significant boost to the relationship between our countries. A historical relationship that has been characterised by mutual respect, co-operation and friendship."



Desert Island Discs reaches 3,000 milestone

BBC Radio 4's long-running Desert Island Discs will celebrate its 3,000th edition next week.

Former Royal Navy test pilot Eric "Winkle" Brown will appear on the show on Friday 14 November.

Brown, 95, is the Navy Fleet Air Arm's most decorated pilot and holds the record for the most flight deck landings.

Presenter Kirsty Young, who has presented Desert Island Discs since 2006,

described Brown as "the perfect castaway" to celebrate the 3,000th edition.

First broadcast on 29 January 1942, the programme was conceived and presented by playwright and novelist Roy Plomley, who each week asked a guest to choose eight songs, a book and luxury item for their imaginary stay on the island.

The "castaways" are then invited to discuss their lives and reasons for their choices.

Acker Bilk dead: jazzman with the bowler achieved worldwide fame with "Stranger on the Shore"

Acker Bilk, the nattily-dressed clarinettist who was the face of British trad jazz for decades, died on Sunday at the age of 85.

With his goatee beard, bowler hat and striped waistcoat, Bilk was one of the most recognisable musicians of the post-war British trad jazz boom and became an international star with his haunting rendition of *Stranger on the Shore*, which was in the charts for more than 50 weeks.

He attributed his unique style of playing to the fact he had lost part of a finger while out sledging, as well as losing two front teeth during a school playground fight.

Bernard Stanley Bilk was born in Pensford, Somerset, in January 1929, the son of a Methodist lay preacher. His mother played the organ in the local chapel.

After a spell working at the Wills tobacco factory in Bristol, he went off to do his National Service in Egypt where he learned to play the clarinet and formed a band known as the Original Egyptian Stompers.

On his return home he worked for his uncle as a blacksmith but he had caught the music bug and

formed another band, the Chew Valley Jazzmen, in 1953.

The following year later he tried his luck in London as a clarinet player with Ken Colyer's band, but soon returned to Somerset and formed his first Paramount Jazz Band.

The band's first big break was when they played seven days a week for six months in a bar in Düsseldorf which gave them plenty of opportunity to hone their skills as musicians.

By now he was widely known as Acker, Somerset dialect for mate. A publicity agent suggested he adopt the Edwardian costume, complete with bowler hat, that came to epitomise the trad jazz style.

signature tune

At one time he employed a road manager, Alan Cutler, known as Adge, who would go on to find success with scrumpy and western outfit The Wurzels.

Bilk, who referred to the clarinet as "that thing I stick in my head and blow", performed with all the major figures in British jazz including Chris Barber, Kenny Ball and George Melly.

But he appealed to more

than just jazz lovers with his wistful signature tune, *Stranger on the Shore*, which became the theme for a BBC TV series.

An expanded version of a piece originally called *Jenny* - after his daughter - it stayed in the charts for 55 weeks and won four gold discs.

It also brought Acker Bilk the unique distinction of being the first artist to have a simultaneous chart-topping hit in both the United Kingdom and the United States.

He said that he never tired of the tune he called *Strangler on the Floor*: generations of music lovers agreed.

Over the years Mr. Acker Bilk, as he liked to be called, toured in the Far East, Australia and Europe and made many television and radio appearances.

He sold millions of records and won an Ivor Novello award.

Contracting throat cancer in 2000 curtailed his singing abilities but he continued to play the clarinet, celebrating his 80th birthday in 2009 with a concert in Hampshire.

As he once told the *Bristol Evening Post*. "At my age, either you're dead or you're 80. And given that choice, I'd definitely rather be 80."

Family and friends say final farewell to Jack Bruce

Guests including Eric Clapton and Ginger Baker paid a farewell in song to their former Cream bandmate and "all round legend" Jack Bruce at his funeral on Wednesday.

The composer, singer and multi-instrumentalist passed away on October 25 after battling liver disease having enjoyed a musical career stretching a remarkable 52 years.

They were among mourners who also included Roxy Music guitarist Phil Manzanera and Procol Harum star Gary Brooker who were paying tribute to the Scottish-born bass player and singer who died last month as a result of liver disease.

The dozens who assembled inside Golders Green Crematorium in north London joined together to sing and hear his music, as well as add their voices to a performance of *Strawberry Fields Forever*.

His friend and Cream lyricist Pete Brown

shared reminiscences with guests at today's service, which also included contributions from Bruce's son Malcolm, daughters Natasha and Kyla, a poem written by another son Corin and a tribute from his wife Margrit.

The guests sang *Morning Has Broken*, the Beatles hit *Strawberry Fields Forever* and Bruce's track *Theme For An Imaginary Western* to honour the man who

was described in the order of service as a "beloved husband, father, granddad and all round legend". Also attending were the US guitarist Vernon Reid and the musician and composer Nitin Sawhney. Bruce was most famous for his work with guitarist Eric Clapton and drummer Ginger Baker in Cream, one of the most successful bands of their era.

Tragic death of gardener after trampling deadly plant in millionaire's garden

■ Nathan Greenaway, 33, died of multiple organ failure after touching the deadly purple flowering plant, known as Devil's Helmet and Monkshood on £4m estate

A gardener collapsed and died after apparently handling a highly-poisonous plant on the £4 million estate of a wealthy businessman, a coroner has heard.

Nathan Greenaway fell ill after brushing against the deadly flower

aconitum, also known as Devil's Helmet and Monkshood, which was growing in the grounds of Millcourt House, owned by retired venture capitalist Christopher Ogilvie Thompson and his wife Katherine.

A pre-inquest hearing

was told that Mr Greenaway, 33, died in hospital from multiple organ failure.

The gardener was rushed to hospital but despite frantic analysis of his blood, doctors were unable to work out what was wrong with him and he died five days later.

The coroner heard that it was only after Mr Greenaway's father,

Richard, carried out hours of tireless research in an effort to find out what happened, that the link with the aconitum plant became apparent.

North Hampshire coroner Andrew Bradley heard from histopathologist Asmat Mustajab, who concluded it was "more likely than not" that Mr Greenaway died after coming into contact with the deadly purple flowering plant.

He was employed by South African-born Mr Ogilvie Thompson and his wife to maintain the manicured gardens of their sprawling estate in exclusive Upper Froyle near Alton, Hants.

The inquest was told that the gardener was thought to have handled the highly-toxic plant, which is a member of the buttercup family of ranunculaceae, while working on the estate. He died in hospital on September 7 this year.

Poisoning from the aconitum plant can occur if it is ingested or handled without gloves. In severe cases the poisoning causes vomiting, dizziness and diarrhoea followed by palpitations, paralysis of the heart and airways, and death.

Aconitum is also known as monkshood and devil's helmet due to its resemblance to a drawn hood, and is known by some as wolfsbane, because its poison is so toxic that it was once used to kill wolves.

The attractive plant has also been responsible for several human deaths, including that of Canadian actor Andre Noble, who died on a camping trip in 2004 after accidentally consuming the plant.

In 2009 Brit Lakhvir Singh, dubbed the 'Curry Killer', poisoned her lover Lakhvinder Cheema with a curry dish laced with Indian aconite, from the same plant family.

Jail for prize-winning bodybuilder who claimed thousands in disability benefits

■ 'Disgraceful' Peter Beddoe visited the gym every day while claiming £28,332 in disability benefit and won the Mr Wales over 40 championship, court hears

A benefits cheat fiddled nearly £30,000 claiming he was too weak to walk - but was caught after winning a major bodybuilding championship.

Muscle-bound Peter Beddoe, 49, was jailed for getting £28,332 in disability benefit while winning the Mr Wales Over 40 championship.

And a court heard he visited the gym almost every day and was a respected role model on the British bodybuilding scene.

Bodybuilder Beddoe was being paid the higher rate of disability allowance meant for people who could not walk.

And he claimed he needed a walking stick, crutches or other means of support to be able to get around.

But Beddoe was regularly seen on stage in his posing pouch, tanned and oiled up for competitions.

Prosecutor Stuart McLeese said: "All the time he was in receipt of the higher rate of mobility disability allowance on the basis that he was virtually unable to walk.

investigation

"But the investigation discovered Mr Beddoe was a known bodybuilder and was involved in competitive body building.

"He won the Mr Wales Over 40 title along with the South Coast championships in 2009."

Department of Work and Pensions officials launched an investigation after two tip-offs that he was illegally claiming benefits while competing

in amateur bodybuilding contests.

Their investigation discovered that in one year alone he made 340 visits to his gym where he used weights for his training sessions.

Mr McLeese said: "Between 2008 and 2013 he visited the gym more than 1,100 times."

Merthyr Tydfil Crown Court heard Beddoe took up body building to build up the muscles around his spine after he was involved in an accident at the age of 30.

He legitimately claimed disability benefit at the time but failed to notify the department of working pensions that his condition had improved and he was being helped with pain management.

Lawrence Jones, defending, said: "Mr Beddoe has to accept that when his

medication improved and pain management improved he should have let the benefits agency know."

Beddoe, of Llwydcoed, Aberdare, admitted two charges of making dishonest representations to claim benefits and one of fraud between 2006 and 2013.

no remorse

Judge Recorder Richard Booth jailed him for six months saying his "disgraceful" offences were so serious that only a prison sentence was suitable.

The judge told him: "Your claim for disability reads 'I would injure myself without support. I need a frame or other means of support to be able to walk'.

"But you failed to disclose you were training as a bodybuilder and

exercising over a long period.

"You were awarded a higher rate for those who are unable to walk but I see that you made 1,100 visits to the gym between 2008 and 2013.

"You also passed yourself off as a role model to other bodybuilders at the gyms where you trained."

The court heard Beddoe - a former hairdresser before claiming benefits - had shown no remorse for his offences and had told investigators "everyone exaggerates their claims".

'well known figure'

Shaven-headed Beddoe, dressed in a pale blue shirt and black trousers, showed no emotion as he was led from the dock.

Beddoe was a member

of the JD gymnasium in Merthyr Tydfil and the Powerhouse gym in nearby Aberdare.

After the case Carolyn Davies, team fraud leader with the DWP said: "We were very surprised when we had two anonymous tip offs that a body builder was receiving disability benefits.

"He was very well known as a figure in the community where he lives - he was known and respected.

"It is our duty to ensure that benefit payments go to those who really need them and we are committed to cracking down on those who play the system.

"It's unfair that some people get support when they do not have a disability, while many people depend on the benefits system to provide a safety net."

Stephen Fry quits Twitter as it is 'unsafe' for him to tweet

■ Actor posts cryptic farewell message to more than 7.8million Twitter followers, explaining why he will not post updates for month

Stephen Fry, the actor and TV presenter who is one of Britain's most popular Twitter users, has quit the social network because it is "unsafe" for him to tweet.

He posted a cryptic farewell message to his more than 7.8million followers on Wednesday, explaining why he will not be posting updates for a month.

Despite this, he posted two more tweets within an hour before finally seeming to make good on his promise.

The 57-year-old, who hosts the popular quiz show *QI* on BBC1, said he is filming "in a place whence I've been advised it is safest not to tweet".

Fry's tweet sparked speculation from some fans that he is filming for *Star Wars* Episode VII, which is scheduled for release on December 18.

Another Twitter user said: "You're either filming in Parliament or a football club dressing room then. Good luck, see you in December."

Fry has built a huge following on Twitter, despite having previously "retired" from tweeting - only to come back again with a vengeance.

His previous tweet on

Wednesday night praised author Mari Hannah, who has been shortlisted for an award for her series of books about detective Kate Daniels.

Fry, who revealed in his new book in September that he once took cocaine at Buckingham Palace at the height of his addiction, left Twitter hours later.

Fry famously threatened to quit the social network in 2009 because he thought there was "too much aggression and unkindness around".

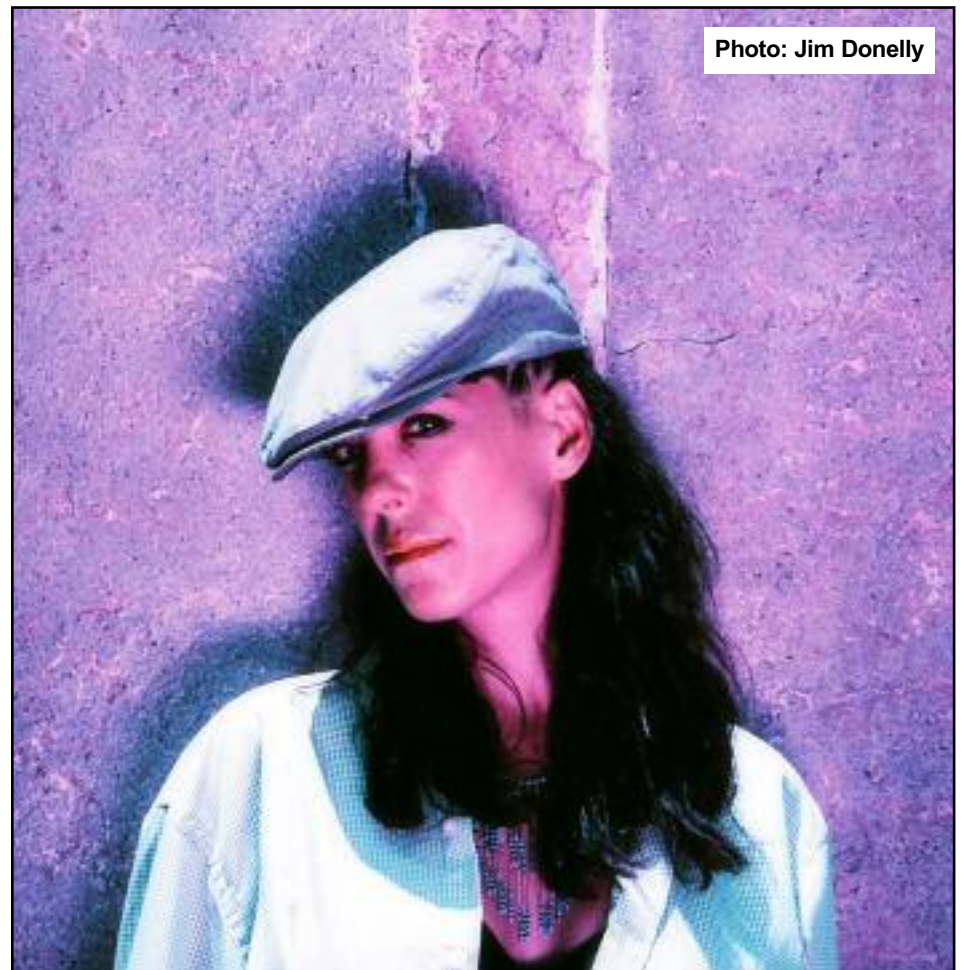

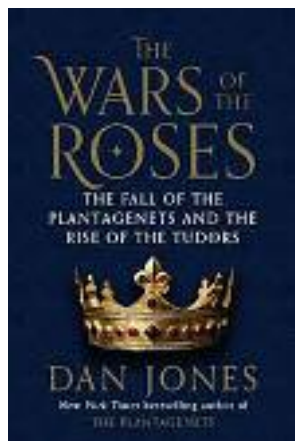

The Wars of the Roses: a tale of bloom and decay

■ Exclusive interview with author Dan Jones and a review of his book about the fall of the Plantagenets and the rise of the Tudors

Rating: ★★★★★



"I open the new book with a dramatic sequence describing the execution of Margaret Pole, cousin of king Henry VIII, in 1541," says *Wars of the Roses* author Dan Jones. "Margaret was 67 when she was beheaded, but the foreign ambassadors at the English court took her to be 80 or 90. She was beheaded by an incompetent deputy axeman. He took eight blows to kill her. Eight blows! Can you even begin to imagine?"

In the fifteenth century

there were five different kings in England. However, unlike *Game of Thrones*, there were no dragons. In the book we see the Lancasters and the Yorks, two different branches of the Plantagenet dynasty, fight to wear the crown. Many die in the civil war. Various Plantagenets ruled England for over three hundred years until greed and power corrupted them. They had a spectacular fall.

Jones descriptions of the

battles and his narrative take you back to the 15th century. He demystifies the fall of the Plantagenets as a family and their conflict and the rise of the Tudors. Jones' writing style will make you forget you're reading history, but in reality you'll be soaking up a lot of facts. Alive during that time were Joan of Arc, Henry V, whose military victories gained England much land in France and Richard III, who took possession of the crown over his young nephews, who disappeared into the Tower. A great gift for the history lover in your family.

"We are accustomed to thinking that the wars of the roses ended at Bosworth with the victory of Henry VII over Richard III in 1485," says Jones. "Far from it. They rumbled on, diminished and diluted but still

significant, for decades afterward. Decades."

The prequel to *The Wars of the Roses*, *The Plantagenets* has been made into a four-part documentary miniseries, with Jones as host. Premiering on Channel 5 in the UK November 26th.

"It's very cool and very different to most history documentaries," says Jones. "We're also working at the moment on developing *The Plantagenets* and *The Wars of the Roses* for drama series. That's the logical next step for me. You've had *The Tudors*, *The White Queen*, *The Borgias*, *Rome*, and so on. Anyway, all this I think suggests that there's a massive, massive appetite for good quality, epic historical drama. So it makes sense to me to start taking these incredible stories from the Plantagenet era in that

direction."

Jones says he takes delight in finding and including in his books what he calls weird stuff. "The best of all is from *The Plantagenets*," says Jones. "During a particularly turbulent period in the mid-thirteenth century a rebellious royal agent based in Essex was planning to firebomb London by tying incendiary devices to cockerels' feet and flying them over the city. Medieval drone warfare."

Jones has been studying Plantagenet history ever since he was a student at Cambridge 15 years ago. Besides writing several books, Jones is a journalist who writes regularly for the *Sunday Times*, the *Mail on Sunday*, the *Daily Telegraph*, and the *Spectator*. For five years he's written a column about sports for the *Evening Standard* in

As for Now You See Me 2, Jesse Eisenberg, Mark Ruffalo, Morgan Freeman and Michael Caine are all set to return. The film is set for release on June 10, 2016.

Jobs biopic: Christian 'Bales', Fassbender 'in talks'

Only a week ago we were praising the idea of Christian Bale playing Apple co-founder Steve Jobs in Danny Boyle's upcoming biopic of the tech pioneer...

But now it appears Christian has 'Baled' - and the new frontrunner for the role is the German-Irish star Michael Fassbender.

It was reported Monday that Bale had been conflicted about playing the high-tech whiz and decided that, after a lot of going back and forth, it was best he bow out of the project as he wasn't the right fit for the role.

Said to be structured around three of the high-profile presentations of Apple products that Jobs was famous for, the

biopic's script was penned by Sorkin and is based on Walter Isaacson's 2013 biography of Jobs.

The new version, in contrast, will focus mostly on three major speeches Jobs gave during his career.

Jobs - who died in 2011 from pancreatic cancer - gained a reputation as an excellent speaker, in addition to his work in creating and then transforming Apple Computers.

Arsenal manager Arsene Wenger said he was "annoyed" at a "very disappointing" 3-3 draw with Anderlecht on Tuesday night. The Gunners let a 3-0 lead slip to fall five points behind Champions League Group D leaders Borussia Dortmund with two games to play. "We had a poor defensive performance from the first until the last minute. We never looked comfortable and we got punished," said Wenger. "Annoyed? Yes. It is very disappointing. We were very poor."

England call up Berahino

West Brom striker named in Hodgson's squad for Slovenia

West Brom striker Saido Berahino has been named in the England squad for the first time by manager Roy Hodgson.

The 21-year-old could make his debut in the Euro 2016 qualifier with Slovenia at Wembley on 15 November.

Berahino, who was born in Burundi, has scored seven goals in 10 Premier League matches for the Baggies this season.

Michael Carrick, Stewart Downing and Theo Walcott are also included in a 26-man squad for the Slovenia game and friendly in Scotland on 18 November.

Manchester United midfielder Carrick was left out of Hodgson's squad for the World Cup in Brazil and has only just returned from an ankle injury he suffered in the summer.

Winger Downing, whose last cap came in May 2012, has earned a recall after

impressing for West Ham this term.

Arsenal winger Theo Walcott is recalled to the squad after recovering from a knee injury that kept him out for 10 months.

Hodgson said Berahino, who has scored 10 goals in 13 England Under-21 appearances, had been in contention for the recent qualifiers against Estonia and San Marino.

"He was obviously in our minds but we didn't choose him because of the importance of the two Under-21 qualifiers against Croatia," said Hodgson.

"But this time they only have a friendly match, so there's no reason to pass over his credentials yet again."

Hodgson added there was "never a realistic possibility" of picking Liverpool striker Daniel Sturridge for the squad.

He is suffering from a calf problem and has not played

since he strained a thigh muscle just before England's clash with Switzerland in September.

"We were hoping, of course, to get him back, but it hasn't worked out," Hodgson said.

"I have left a message for [Liverpool manager] Brendan [Rodgers]. The message was that it is pretty obvious that Daniel is not fit, and Brendan's not rung back to counter that he actually is."

Club-mate Glen Johnson has been left out even though he returned to action last month following a thigh injury.

If he plays against Slovenia, Wayne Rooney will earn his 100th cap.

England are top of

qualifying Group E, having won all three games. Slovenia are second, with

two wins and six points.

"They have a lot of players who play for top clubs in Europe," Hodgson said. "We regard them as a very serious rival."
