# JIHADISTS 'FUNDED BY UK WELFARE BENEFITS'

■ **Taxpayers' money is being claimed fraudulently and used by terrorists in countries such as Iraq and Syria, claims top counter-terrorism cop**

**Britain's benefits system is being abused to fund terrorism, a senior police officer has warned.**

Terri Nicholson, from the Metropolitan Police's counter-terrorism command unit, said that taxpayers' money was being claimed fraudulently and used by terrorists in countries such as Iraq and Syria.

She said there had been "a number of cases" recently of terrorists making fraudulent student loan claims to fund their activities.

MPs described the prospect of British money being used to bankroll potential terrorist plots on British soil as "sickening". Keith Vaz, chairman of the Commons home affairs committee, said he would in the coming weeks question Theresa May, the Home Secretary, over the "shocking" disclosures.

## 'safe haven'

Two brothers became the first Britons to be jailed for Syria-related terrorism offences, having gone to a

training camp in the country.

Another jihadist, who skipped bail to fight in Syria, this week used Twitter to mock the lapse in security that allowed him to flee.

Meanwhile, the family of Fusilier Lee Rigby claimed that Facebook failed in its "duty of care" when it missed messages in which one of his murderers discussed killing a soldier. Facebook was accused in a report of being a "safe haven for terrorism" after it failed to pass on information that could have prevented the killing of Fusilier Rigby in Woolwich, south-east London, last year.

## 'diverse fraud'

Miss Nicholson, a Met Assistant Commander, said terrorists were using "innovative" techniques to send money abroad. "We are seeing a diverse fraud, including substantial fraud online, abuse of

the benefits system, abuse of student loans, in order to fund terrorism," she said.

She also said women were being used to smuggle money out of Britain to fund terrorists abroad, as it is believed they will arouse less suspicion. Earlier this month, Amal El Wahabi, a British mother-of-two, was jailed for more than two years for trying to arrange to smuggle €20,000 (£16,000) to her husband, who is believed to be a jihadist fighting in Syria. She duped her friend, Nawal Msaad, into carrying the cash in her underwear.

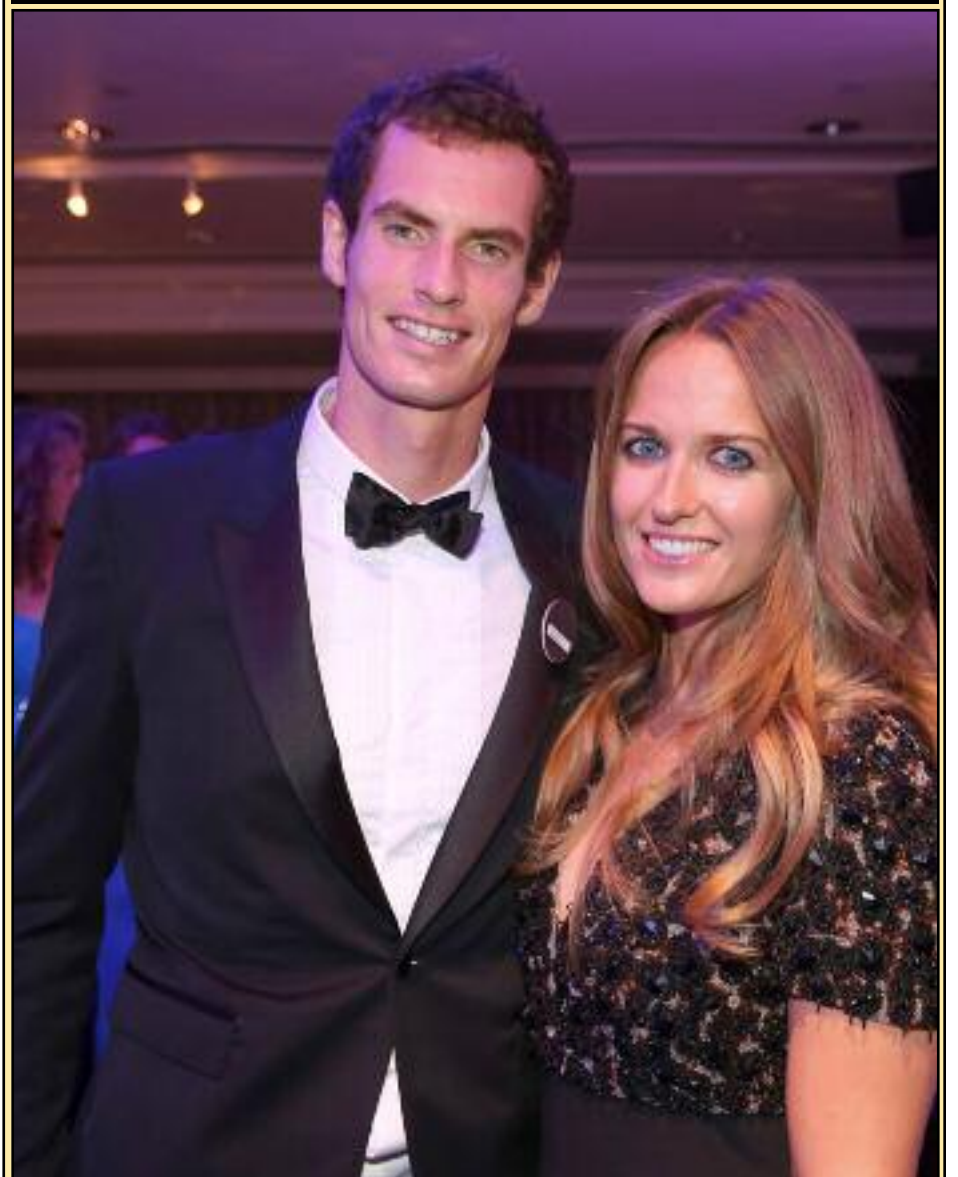
## 'shocking'

Philip Davies, the Tory MP, said of Miss Nicholson's claims: "I know the Government has been cracking down on benefit fraud. It seems to me that this shows that if anything, they need to go further."

He added: "It is sickening to think that

## Rich tea: expert's tastebuds insured for £1m

A professional tea taster has insured his tastebuds for £1m after five years of intensive training made him a "master blender".

There are more than 1,500 different varieties of tea and Sebastian Michaelis claims he can taste and grade any one of them in just 15 seconds.

He found his vocation after studying philosophy at university and then getting accepted to a graduate training programme.

Mr Michaelis works for the leading British tea company Tetley and uses a "slurp and spit" technique to "identify the finer notes" and judge the "zing, colour, sparkle and body".

He said the beverage now dominates his life, adding: "They spent a lot of money and time on me - that's why they've insured my tongue."

"I've had to travel round the world, visit producers, understand everything about tea and we use a special language."

Tetley says its experts can sometime taste anything up to 1,000 different teas in a day as they try to keep a consistent blend.

# Scots to control tax and spending

## ■ Historic reforms to go ahead after Labour drops opposition

The Scottish parliament is to be handed direct control over billions of pounds of income tax and welfare benefits after an £11bn cross-party deal which will lead to the biggest shakeup to Britain's taxation system in the modern era.

The historic move, which had been resisted by the Labour leadership in London, means powers to set income tax rates and bands are to be wholly devolved to Holyrood as the pro-UK parties move to outflank the Scottish National party, which has surged in popularity since the referendum on Scottish independence.

### backlash

High-level talks to agree the full package of new powers continued late into Wednesday as negotiators from all the main parties at Holyrood thrashed out the details of a deal due to be revealed in Edinburgh on Thursday morning.

The far-reaching reforms are due to include £3bn worth of welfare powers, including the housing elements of universal credit, attendance allowance and carers allowance, the work programme and winter fuel payments, as

well as air passenger duty. Along with the income tax powers, the total package is estimated by Treasury officials on the commission to be worth about £11bn.

But the deal led to an immediate backlash in England with a cross-party call from all the senior figures in English local government for a comparable devolution process in England. In a joint letter, officials including London's mayor Boris Johnson and six Labour leaders of English city councils called on the UK government to set up a similar commission to agree a "comparable package of measures for local government in England".

The Smith Commission, which was set up after pledges by the UK's three main party leaders in the last few days of the Scottish referendum campaign, is preparing to publish its heads of agreement.

Lord Smith of Kelvin, the head of the commission, has been working with Scotland's five main parties - Labour, the SNP, the Tories, the Liberal Democrats and the Greens - to reach broad agreement by St Andrew's

Day on 30 November in line with the timetable laid down by former prime minister Gordon Brown.

In the most significant move, Labour has abandoned its opposition to the full devolution of income tax to bring it into line with the four other parties in a bid to halt its plummeting poll ratings in Scotland in the face of a surge for the SNP.

Ed Miliband and Ed Balls, who are expected to offer broad support for the commission while saying the details will need to be studied with care, have decided to bite the bullet to avoid a further slide in

Labour support in changing the personal allowance.

It is understood that Balls won two important concessions that will give comfort to the Labour leadership in London. The personal tax allowance - the amount of income people can earn before they pay tax - will remain a UK matter that will continue to be decided by the chancellor of exchequer and voted on by MPs at Westminster.

This will make it impossible for a Scottish finance secretary to do what chancellors have done in the past - announce an income tax cut and pay for it by

In the second key concession, it is understood that the commission will say that there is still a UK income tax system. It is also expected to say there should not be two classes of MPs at Westminster. This is designed to guard against the Tories undermining a Labour chancellor, who may depend on the votes of Labour MPs from Scotland, by saying that he or she should hold a budget for the whole of the UK and a separate budget for England, Wales and Northern Ireland.

# Peaceful death at 90 for “Mad’ Frankie Fraser

■ Underworld enforcer was infamous for pulling victims’ teeth out with pliers

The criminal and former associate of the Kray twins, “Mad” Frankie Fraser, has died aged 90 in a London hospital.

He was known as an “enforcer”, meting out violence on behalf of the Krays and the Richardson gang in the 1960s.

His death was confirmed by Eddie Richardson who, with brother Charlie, formed the infamous London crime gang.

By the time he left prison for the final time in 1989, Fraser had served a total of 42 years for a range of offences.

More recently he established himself as a TV personality and published an autobiography.

He became critically ill on Saturday after undergoing surgery on his left leg at King’s College Hospital in south London.

Born near Waterloo station, central London, he was the fifth child of a poor family. His mother was of Norwegian-Irish stock and his father was half Native American. Both Frank and his sister, Eva, whom he adored, inherited their father’s features and his jet-black hair. The pair were the only ones of the children to embrace a life of crime.

## conviction

At the age of five, Fraser, running in the road to beg for cigarette cards, was knocked down, and from his injuries he developed meningitis. Nevertheless he was good at sports, captaining the football team at St Patrick’s school, Southwark, and boxing as an amateur. His first conviction was for

stealing cigarettes, and with the second he was sent to an approved school. In later life he would say that had there been an elder criminal member of the family to advise him, he would not have served his sentences in what was called the hard way.

Borstal was followed by prison, where in 1943 he met the influential London villain Billy Hill, for whom he worked on and off for more than a decade, culminating in his slashing of Hill’s rival Jack Spot in 1956 after the self-styled “kings of the underworld” had fallen out. Fraser received seven years.

## racketeering and fraud

After his release from jail in the early 1960s he was courted by both the Kray Twins and their South London rivals, the Richardson gang. He gave his allegiance to the latter and was a leading figure in their racketeering and fraud operations across south London in the 1960s.

Fraser’s methods of

torturing the gang’s victims earned him the nicknames “Mad Frankie” and “The Dentist” - he was reputed to pull out people’s teeth with pliers.

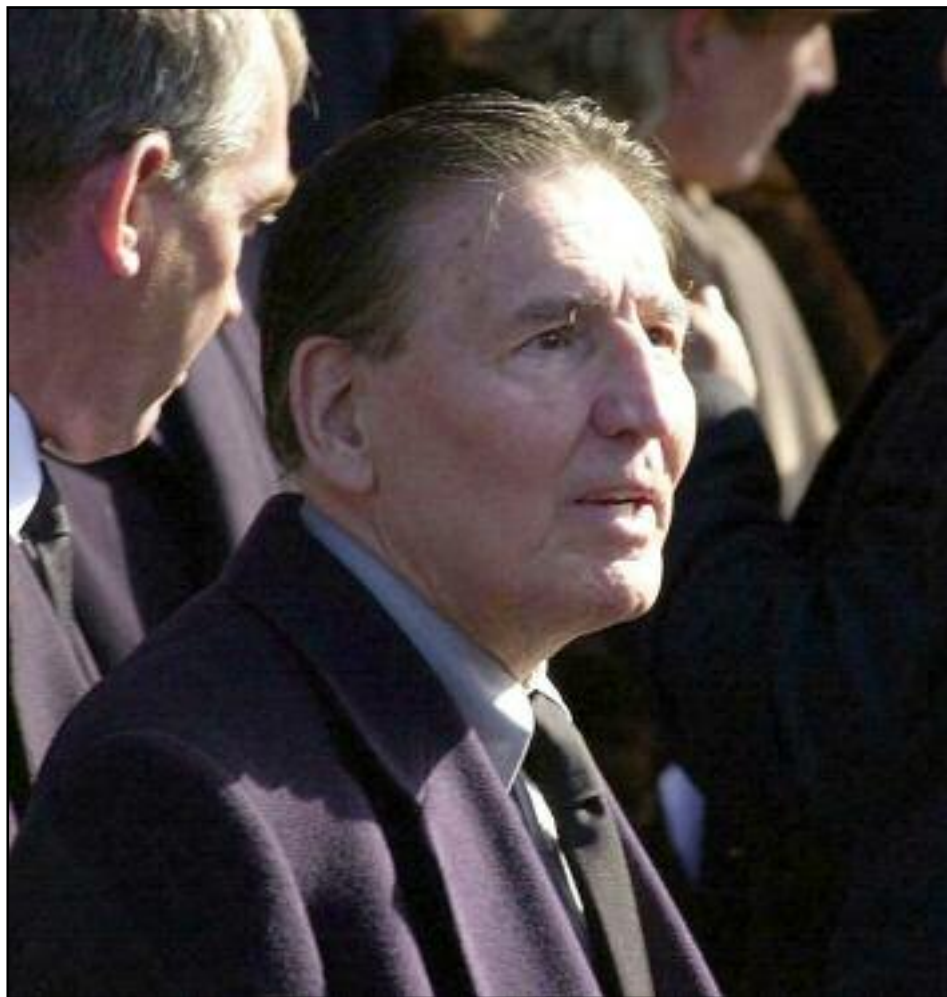
At the Richardson gang “torture” trial at the Old Bailey in 1967 he was jailed for 10 years. Two years later a further five years was added for leading a riot at Parkhurst Prison.

In 1975 he assaulted three prison officers, one of whom he attempted to hang.

After completing another sentence in 1989, Fraser tried to build a career as a celebrity, appearing on television chat shows, acting as a consultant on crime and taking a stage show to the Edinburgh Fringe Festival.

In 1997, he was called as a character witness at the trial of Charlie Kray on drugs charges.

Last year he was reported to have received an Asbo following an argument over a chair in the care home where he lived.

[UK money is funding terror plots] but whenever there is any money being doled out, it's obvious that terrorists will be trying to get their hands on as much of it as possible."

Kwasi Kwarteng, a Conservative member of the Commons work and pensions committee, said: "Ordinary people will be very, very concerned about this and it's something which the Government obviously has a duty to crack down on."

Mr Vaz said: "It is shocking that this is happening. We need to see assurances from government that the integrity of the student loan and benefits system has not been compromised, with the full cooperation of the banking network."

A spokesman for the Department for Work

and Pensions said: "No one should doubt our commitment to rooting out benefit fraud."

Ministers said up to 50 suspected jihadists a year are expected to be prevented from going to Syria or other terrorism hot spots under proposed powers to seize passports.

Around 15 terror suspects a year will also be placed under the revamped terrorism prevention and investigation measures (Tpims), which restrict their activities.

The measures are part of the Counter-Terrorism and Security Bill.

# British Muslims 'singled out' by new terror laws

British Muslim rights groups and ordinary faithful said they felt singled out by a tough new anti-terror law unveiled on Wednesday, labelling the planned legislation divisive and rushed.

While there is agreement on the need to prevent would-be British jihadists from joining the ranks of the Islamic State group, there is also unease over the government's hardline strategy.

"For us to live in the same community and work together, we have to fight together. I think these laws will separate us," said Fatima Ali, 46, a nurse.

"I think they were made too hastily," she said.

Britain has around 2.8 million Muslims, making up 4.4 percent of the population, and many are concentrated in London in ethnically diverse areas like Whitechapel where Ali works.

The area is home to the East London Mosque, billed as the city's oldest and as serving the country's largest Muslim congregation.

Stalls line the streets near the mosque selling headscarves and long

robes, and most shops nearby sell either Halal food or Islamic books.

A short walk down the road is Aldgate tube station, site of one of a series of coordinated bombings that killed 52 people in London in 2005, carried out by four radicalised young Muslim men.

"I don't think they can stop the terrorists with this law," said market trader Mohammed Ali, 55, against a backdrop of multi-coloured and sequined cloths.

"This law targets the Muslim community.... Just because one part of the community is criminal, it doesn't make the whole

community criminal," he said.

### 'Creating otherness'

The new laws would increase surveillance and relocation for people identified as Muslim radicals, force universities to bar extremist preachers and toughen laws against would-be jihadists planning to leave for Iraq and Syria and those returning.

There is broad support from the main parties in parliament for the draft Counter-Terrorism and Security Bill, which also includes the establishment of a civil liberties panel to monitor implementation.

But campaign groups

like Liberty and the Islamic Human Rights Commission (IHRC) have already come out against the Counter-Terrorism and Security Bill, defining it as hasty and counter-productive.

"The new anti-terror drive seems to be more geared to creating otherness in our society than security," IHRC chair Massoud Shadjareh told AFP.

"I don't think there has been any consultation with the Muslim community," he said, adding: "The consultation seems to be only with a narrow group of people who think like the government."

It is thought the Wimbledon champion popped the question to Ms Sears last Wednesday.

Earlier this year Murray, from Dunblane in Perthshire, joked during a question and answer session with fans that he was getting married after Wimbledon.

About an hour later, Murray told his 2.3 million followers: "3 things.. I don't smoke grass, I'm not getting married(yet) and I don't want to kill Rafael Nadal.."

It would appear that Murray has now proposed to Ms Sears, his partner of more than nine years.

Sussex-born Ms Sears, who is the daughter of former Lawn Tennis Association head of women's tennis Nigel Sears, met Murray at the US Open in 2005.

She was once described by future mother-in-law Judy Murray as "the best thing to happen to Andy".

## Glad to be grey: Knox-Johnston flies the flag for senior sportsmen and women

**GRANDFATHER and veteran yachtsman Sir Robin Knox-Johnston has delivered another resounding blow for the old guard of sport with a third place finish in the 3542-mile Route du Rhum race, from Saint-Malo in France to Guadeloupe in the Caribbean.**

Competing against the world's finest sailors in his appropriately named Grey Power yacht, the 75-year-old was the oldest competitor in a fleet of nearly 80, yet finished more than 12 hours faster (and 11

places better) than when he last contested the event 32 years ago.

"I'm just not ready for the slippers, pipe and TV," he said before setting sail. After crossing the finishing line he told reporters: "It's all in the mind. If you have the determination and the will to win, you can compete as long as your body allows. That all comes down to how well you have kept your body, of course. Do you keep busy and fit naturally? Because if you do, it is so much easier to

get up to a serious performance standard. It is harder as you get older and it takes more effort to reach the standard and so you have to work harder at it."

It's more than 45 years since he completed his record single-handed non-stop circumnavigation, sailing into Falmouth after 312 days.

### physically demanding

His latest odyssey took just over 20 days, and he plans to contest the 2018 edition with a smaller boat. "Everyone is

fixated by age, but I don't even bother with it," he said.

Yet finishing on the podium in an open sporting contest, especially one as physically demanding as single-handed sailing, is a remarkable feat.

Especially after an absence of seven years. Knox-Johnston is founder and chairman of the Clipper Round the World Race which gives ordinary mortals the opportunity to challenge themselves in one of his company's 70-foot

yachts.

The oldest crewman in the last edition was 74. Knox-Johnston said he could hardly exclude him, given that the American was younger than he was himself. The oldest woman was 74-year-old, self-confessed "dotty grandmother" Gil Sharpe, from Wimbledon. She had already ticked ascents of Machu Pichu and Kilimanjaro off her bucket list.

Sir Robin achieved legendary status in the boating world back in 1969 when he became the first person to sail solo and non-stop around the globe.

# A very expensive beer...

■ Bad start for Tower Bridge glass walkway as pane is smashed by beer bottle

A £1 million glass walkway across one of Britain's most famous bridges has been smashed by a beer bottle less than two weeks after the attraction opened.

Part of the top layer of Tower Bridge's transparent walkway was shattered 42m (138ft) above the river Thames in London.

The glass floor, which was unveiled on 10 November, gives visitors an unusual perspective of traffic crossing the river and bridge lifts.

Chris Earlie, head of Tower Bridge, said: "A sacrificial layer of glass on the new West Walkway at Tower Bridge Exhibition shattered on Friday evening, when an empty beer bottle fell from a tray being carried by a member of the catering team during an event. The floor was immediately inspected and covered to protect guests from glass splinters.

## 'no visitors at risk'

At 42m above the river, it is not for the faint-hearted. "There is that sense of trepidation," said Earlie told reporters when the

walkway opened. "It is more exciting I think because you are not actually that high, you can see everything in detail beneath you."

The glass panels are 11-metre long by 1.8-metre wide and run along the two high-level walkways of the bridge. Each walkway has six glass panels each weighing about over 1100lbs, representing the biggest change to the

exhibition since it opened to the public in 1982. One of these was smashed when a beer bottle was dropped on it.

"Tower Bridge Exhibition's engineering team attended the site on Saturday morning and the sacrificial glass panel was replaced on Sunday morning. The exhibition space remained open to the public as normal and no visitors were at risk," said Earlie.

## Sex and the City star slammed for Sefton Park comments

Liverpool Mayor Joe Anderson has hit back at comments from Sex and the City star Kim Cattrall criticising plans to sell Sefton Park Meadows.

The Liverpool-born actor said developing the area next to the park would "encroach on the people's land".

Mr Anderson said her comments were "ill-informed", asking "what does she really know of the issues that Liverpool faces?"

Campaigners are against plans to build on 11 acres of land on Park Avenue.

Cattrall, who was in Merseyside to pick up an International Arts Icon award at the Collective Honours event, told the crowd: "I sincerely hope it's not too late to turn

back on that decision."

She recalled playing in Sefton Park during her childhood and said she was aware of how much the park meant to youngsters.

"This is why I have spoken out against the plans to develop on local green spaces here in Liverpool. To do so is to encroach on the people's land."

## 'Ill-informed'

Mr Anderson said: "It's all very well for a Hollywood superstar to shout from the sidelines, but what does she really know of the issues that Liverpool faces?"

"She may have played in Sefton Park when she briefly lived in the city as a girl, but she left.

"I am still here and

having to deal with massive and savage Tory government cuts to our budget while devising ways to grow and sustain the city and protect its most vulnerable citizens."

"Her comments are totally out of context and ill-informed... since I became mayor, we have created more green space and there is more of it now than at any time in Liverpool's history.

The Liverpool mayor said the council was selling off 11 acres on Park Avenue, adjacent to Sefton Park but not within the 235-acre (95.1-hectare), Grade I-listed park.

Mr Anderson said 15 villas would be built on the land and "the money we get from that will be invested in our city and our parks."

## Air rage causes drunk Brit to ruin his own honeymoon

HAMILTON, Bermuda (Reuters) - A British man headed to his honeymoon on a Cuba-bound flight instead found himself grounded in Bermuda after drunkenly threatening the flight crew, with his wife continuing on to Cuba without him, authorities in Bermuda said on Tuesday.

Mohammed Khelya,

from Blackburn, Lancashire, had been drinking from a bottle of duty-free vodka before quarrelling with his wife on Monday when he was taken in handcuffs to the rear of the aircraft and forced its unscheduled landing, prosecutors said.

Appearing on Tuesday at a court in Hamilton, Bermuda's capital, a contrite Khelya pleaded

guilty to being drunk on the aircraft and to threatening flight staff.

"I don't know how I'm going to forgive myself," he said in court.

"I don't know how she's going to forgive me," he added, referring to his wife.

Khelya, 22, and his wife were among 311 passengers on board a Thomas Cook flight, which set out from

Manchester International Airport.

Several hours into the flight, after his wife changed seats to get away from him, Khelya appealed unsuccessfully to a crew member to see her.

"I'm going to kill you and I'm going to kill everyone after," Khelya told a crew member, using an expletive, according to

prosecutors.

As flight attendants moved a handcuffed Khelya to the back of the plane, he spat at other passengers, compelling crew members to use blankets to protect them, prosecutors said.

Diverted to the L.F. Wade International Airport, the flight was greeted by police officers, who escorted Khelya off the plane.

On Tuesday, Magistrate Khamisi Tokunbo fined Khelya \$2,000 for being drunk on the aircraft and another \$1,000 for his abusive behaviour towards flight staff. If Khelya fails to pay the fines, he faces four months in a Bermuda jail.

An attorney for Khelya could not immediately be reached for comment.

# James Bond set to downsize: spy to swap Aston for a Fiat

Aston Martin-loving spy James Bond will reportedly swap his beloved luxury car for a Fiat 500 in the new 007 movie.

The as-yet unnamed film will feature Daniel Craig as the British secret agent for a fourth time after his exploits in Casino Royale, Quantum Of Solace and Skyfall.

Bond will apparently drive the Fiat during a high-speed car chase through the street of Rome, with scenes due to be shot in February and March next year.

But the Italian vehicle will reportedly end up being crushed near the Vatican.

His Aston Martin DB5 came to an unfortunate end in Skyfall, where it

was blown up in the climax to the film.

Cars have played a prominent part in the Bond movies, with the DB5 making a number of appearances.

It featured for the first time in the third 007 film, Goldfinger (1964) when Sean Connery was Bond - and a DB5 was also in Craig's first outing in Casino Royale.

Rome will host three key action scenes for the new movie, including night-time chases, with one car ending up in the River Tiber, according to Italian news agency ANSA.

Bond will parachute from a helicopter onto Ponte Sisto, a 15th-century pedestrian bridge, it said.

There will also be scenes shot outside of Rome - in the Royal Palace of Caserta, known as the Versailles of Italy, in Campania, the report added.

The 24th instalment of the Bond franchise is reportedly set to start shooting at Pinewood Shepperton studios in the next few weeks and there will also be filming in Morocco.

The new movie, directed by Sam Mendes who was also at the helm for Skyfall, is expected to hit cinemas late next year.

## UK cancer survival rates ‘below Third World’

British patients are less likely to survive lung, liver and stomach cancer than those in some Third World countries, according to the most comprehensive ever international study of its kind.

New figures reveal 9.6% of lung cancer patients in the UK survive at least five years after diagnosis - compared with 10.7% in Malaysia.

Statistics for liver cancer show 9.3% in the UK survive - compared with 19.9% in Indonesia.

And 18.5% survive stomach cancer in the UK - compared with 28.6% in Puerto Rico.

Research published in *The Lancet* medical journal covers 26 million patients with 10 different cancers in 67 countries.

But while Britain ranks well for breast cancer and childhood leukaemia, the outlook for many other forms of the disease remains comparatively poor.

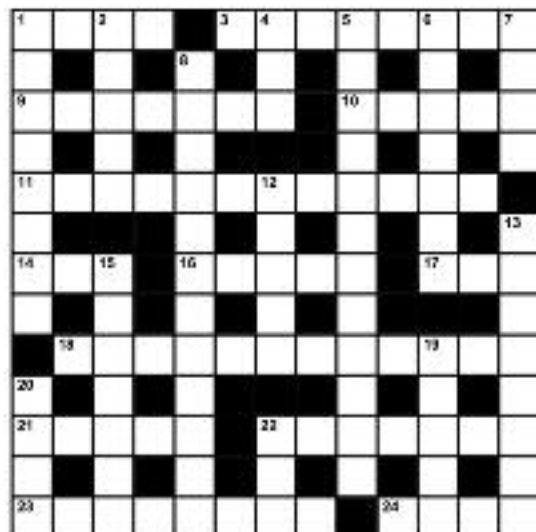

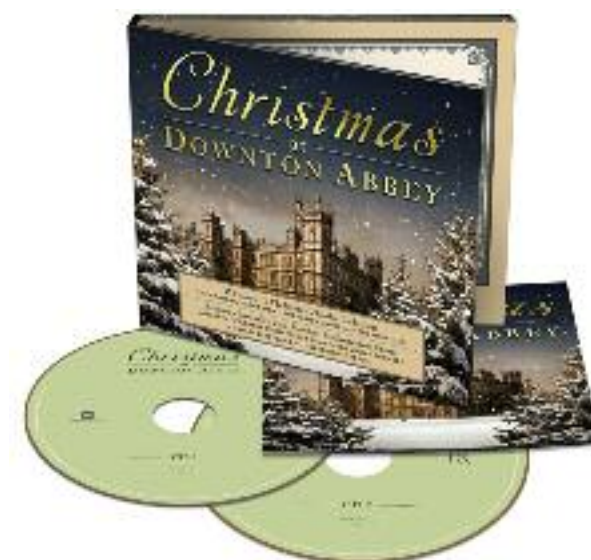

## Khan seeks victory to secure longed-for date with Mayweather

**AMIR KHAN’s ambitions for at finally proving himself one of the best fighters in the world likely rest on the outcome of his upcoming showdown with Devon Alexander in Las Vegas.**

Despite the brightest of starts to his career, winning Olympic silver in Athens at the tender of age of 17 and going on to win two world titles, Khan’s career falls firmly into the camp of ‘could do better’ after several surprising losses. The Bolton fighter will meet the highly-rated and former two-division world champ Alexander in a welterweight title bout on December 13th at the MGM Grand Garden that Khan simply MUST win if he is to have any hope of securing a big-money payday against the dominant force in fight game, Floyd Mayweather.

Khan now fights as part of the Golden Boy Promotions stable, whose president, Oscar De La Hoya recently told ESPN: “I do expect him (Khan) to get the Mayweather fight. He has been wanting the major names in boxing for quite

a while, because he deserves it.

“This is a tough fight that neither can look past, but obviously the big prize is the Pacquiaos of this world and the Mayweathers of this world. There is a lot on the line, this is high stakes.”

Khan took the Alexander fight ahead of a meeting with the IBF welterweight champion and British rival Kell Brook, believing that a victory over the American would give him a better chance of getting into the ring with either Mayweather or Pacquiao.

The pair may have faced each other 12 months ago, when Alexander held the IBF title, but Khan opted not to take the fight as he thought he was close to securing a contest with Mayweather, only for the American to take on Marcos Maidana instead.

Alexander went on to lose his crown to Shawn Porter in December last year, but proved he is still a threat in the welterweight division by comfortably outpointing the contender Jesús Soto Karass in June.

## Second F1 title is sweeter for Hamilton

Lewis Hamilton said his second world title felt more important to him than the first he won with McLaren in 2008.

The Mercedes driver clinched the championship with victory in Sunday’s Abu Dhabi Grand Prix, beating team-mate Nico Rosberg by 67 points.

Hamilton said: “It means so much more than the first one - it feels so long. I feel so blessed.

“It has been an incredible year. It feels like an out-of-body experience.”

The triumph meant Hamilton becomes only the fourth Briton to win two world titles, moving level with Jim Clark and Graham Hill. He is now one behind Sir Jackie Stewart.

Michael Schumacher is the all-time record holder with seven, while the most successful current driver is Sebastian Vettel on four. Another contemporary, Fernando Alonso, is also on two.

Hamilton, who ended the season with 11 victories compared to Rosberg’s five, said he had been faced with difficult emotions throughout race day at Yas Marina.

“It is very hard to soak all this up,” he said. “I didn’t sleep. I went to bed at 12, woke up 5am, went for a run and thought for sure I would be tired when I got to the race but I felt composed.

Hamilton was also congratulated on the in-car radio by Prince Harry, who was attending the race.

Hamilton said: “It’s really going to take some time to sink in.

“I don’t really drink so I will let everyone else get obliterated.”

The forward has now scored five goals in five Champions League games this season, taking his tally to 17 in all competitions this term.

“He’s our special player,” Kompany told ITV. “If you want to succeed at anything, you need a special player in special form, otherwise you just don’t win anything.”

City will reach the last 16 of the Champions League if they beat Roma in their final Group E game and CSKA Moscow fail to beat Bayern.

Aguero had put City ahead from the penalty spot after he was fouled by Mehdi Benatia, who was sent off for the challenge, but Bayern responded with goals from Xabi Alonso and Robert Lewandowski before half-time.

However, with five minutes remaining, Aguero ran through and calmly finished to equalise before hitting a dramatic winner soon after.

“I have always said

that Sergio is one of the best players in the world,” said Pellegrini.

“He played very well against Bayern Munich but I think also that the team played very well, especially in the second half.”

After seeing City come from behind, Kompany said: “We are better with our backs against the wall. We have shown with performances in the Premier League that we never give up, and we have done that again.”

City, Roma and CSKA Moscow are all level on five points, seven behind Bayern Munich, who have already won the group.

Pellegrini’s side travel to Roma for their final group game on 10 December.

Liverpool conceded a late equaliser at Bulgarian champions Ludogorets on Wednesday night - but are still just a win away from reaching the Champions League last 16.

The hosts led when Dani Abalo pounced on Reds keeper Simon Mignolet’s error, but Rickie Lambert headed in his first Champions

League goal to equalise. Jordan Henderson steered Liverpool ahead at the far post, before Georgi Terziev headed in the equaliser.

Liverpool will still qualify if they beat Basel at Anfield next month.

Despite an unconvincing performance in Bulgaria, Brendan Rodgers’s side remain in control of their European destiny after Basel were beaten 1-0 at reigning champions Real Madrid.

Basel’s defeat means the Reds are two points behind the Swiss side and will join the Spanish giants in the knockout stage with a win in their final group match.

Liverpool had lost their previous four matches in all competitions and before kick-off Rodgers urged his players to kick-start their faltering season with a vital win.

But their performance in near-freezing

conditions in Sofia will have done little to encourage the Anfield side that an upturn in their fortunes is on the way.

The visitors appeared to lack the confidence to cut through the ponderous Ludogorets backline and were once again uncertain in defence when the home side poured forward.

# ‘Perfect’ Blues leave Mourinho purring

## ■ Chelsea blow away Schalke in Champions League

Chelsea boss Jose Mourinho believes his team’s “perfect” performance in the 5-0 Champions League win at Schalke is one of the club’s finest away performances.

The Blues thrashed ex-boss Roberto Di Matteo’s side to qualify for the last 16 with one Group G game remaining.

“I don’t remember Chelsea playing this way away from home,” Mourinho said.

“Obviously, there have been great wins away from home with me, Roberto and other managers. But this was very impressive. Very complete.”

The Premier League leaders, who are now unbeaten in 19 matches across all competitions, continued their fine form with a clinical performance in Germany.

Chelsea led 3-0 at half-time after goals from John Terry, Willian and Schalke defender Jan Kirchhoff, before Didier Drogba and Ramires completed the rout in the final 15 minutes.

“I think they have to accept we were too strong for them,” added Mourinho, whose side inflicted Schalke’s first home defeat since April.

“When you lose against a team that

produces a perfect performance and a perfect result it’s not your fault.”

The Portuguese boss, 51, added: “At this moment we are a good team. Obviously we can lose and a bad result is waiting for us but the team is playing really well and we have big self-belief.”

Di Matteo, who coached the Blues to Champions League success in May 2012, said the result was the most painful he had suffered in his managerial career.

“It is certainly a disappointing night for us in terms of the scoreline, and also the

### Gunners book their berth into knockout stage

Yaya Sanogo scored his first goal for Arsenal as they defeated Borussia Dortmund and ensured their passage into the Champions League knockout stage on Wednesday night.

The 21-year-old netted after 19 appearances without a goal when he finished off a one-two with Santi Cazorla with a low shot early on.

Alexis Sanchez made it 2-0 after the break with a superb low curling shot.

Sanchez also had a shot pushed away, while Alex Oxlade-Chamberlain struck the crossbar with a dipping volley.

It was a mature performance by the Gunners who, like their opponents, have found solace in this competition this season from the struggles of the domestic league.

They quelled the threat of Dortmund on the counter-attack, with Jurgen Klopp’s side only seriously

troubling keeper Emiliano Martinez once, in stoppage time.

The Bundesliga outfit had named a strong side despite having secured their berth with four wins from four games but before they had a chance to establish themselves at the Emirates, they were a goal down.

That was scored by a player who was the source of some ridicule on social media when the teams were announced before the match.

Sanogo’s ungainly style has irked some fans and there was further astonishment when he was named ahead of Germany World Cup winner Lukas Podolski.

But he finally managed to temper some of that criticism when he converted his first effort after starting the move with a ball-juggle and backheel to Spaniard Cazorla.

With the Germans

already qualified and Arsenal almost there, the tempo of the game was sedate at times, although the Gunners picked up the pace after the break.

First Sanchez tested the Germany international keeper Roman Weidenfeller with a low shot after battling past two challenges, before the pacy Oxlade-Chamberlain produced a beautiful volley that failed to dip enough.

They finally managed a second when Sanchez, who flitted in and out of the game, cut inside from the left and bent an effort that beat Weidenfeller’s reach.

It was the Chile international’s seventh goal in his last six matches for the Gunners.

The win moves Arsenal to 10 points in Group D and a victory over Galatasaray coupled with Dortmund losing to Anderlecht in the final round of games would see Wenger’s side go through as winners.
