STANDING FIRM WITH FRANCE...

UK newspapers rally to their French counterparts after horrific Paris attack

Britain's newspapers rallied behind their French counterparts on Thursday following the horrific terror attack on magazine Charlie Hebdo that left 12 dead, urging them not to restrain their renowned spirit of provocation.

But they also called for a measured response, fearing the rise of Islamophobia and the far right.

Both the **Daily Mail** and **Daily Telegraph** ran with the front page headline "The War on Freedom" along with a photograph of the attack showing two attackers pointing their guns at a policeman lying on the pavement.

In the same vein, **The Times** led with "Attack on Freedom" on its front page while the **Guardian** called it an "Assault on Democracy."

The Guardian leapt to the defence of the controversial magazine, which angered Muslims by publishing cartoons of the Prophet

Mohammed, saying there was something "distinctly French about the form of offensiveness that Charlie Hebdo revelled in."

"Radicals, as the murdered journalists assuredly saw themselves, have always mocked Christian humbug, just as Charlie Hebdo did, and never seen any principled reason to show more deference to other faiths," said its editorial.

The **Financial Times** earlier fended off criticism after publishing an opinion piece by Europe Editor Tony Barber, which called Charlie Hebdo's provocation of Muslims "stupid" and "foolish".

But its editorial

insisted that journalists must speak their minds, regardless of whom it may offend.

"Charlie Hebdo may be a very different publication to our own, but the courage of its journalists - and their right to publish - cannot be placed in doubt. A free press is worth nothing if its practitioners do not feel free to speak."

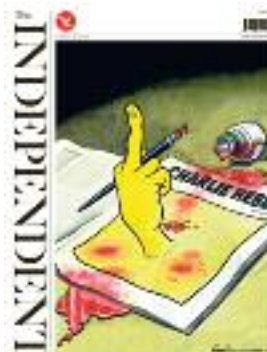
The **Times** also defended the right to criticise Islamists, saying they were prime targets "precisely because of their unconscionable threats and spurious claim to special status."

But it warned that French President Francois Hollande may

Cameron pledges support to France

"These events are a challenge to our security. But also a challenge to our values." - PM David Cameron

David Cameron has reiterated his support for the French people as an emergency government meeting was held on Thursday to discuss the implications of an attack on a French magazine for the UK.

Speaking in Manchester, where he has talking to business leaders, the Prime Minister said: "Everyone's thoughts will be with the French people. These events are a challenge to our security. But also a challenge to our values."

Soon after the Cobra meeting got under way, 24 hours after the attack on Charlie Hebdo magazine in France on Wednesday, police in London and other force areas held a minute's silence.

'terrible events'

Metropolitan Police Deputy Commissioner Craig Mackey was among a number of officers who held a tribute outside Scotland Yard to those who had

died.

"Today was about remembering our colleagues in France and remembering the terrible events of yesterday," he said.

"Our thoughts are with both the French people and our colleagues in the French police and security service for what they are doing at the moment."

Officers in Leicestershire, Greater Manchester, West Mercia, Warwickshire, the West Midlands and Durham also held similar tributes.

'evil attack'

ACPO vice president and Greater Manchester chief constable Sir Peter Fahy said: "All members of the British police forces are shocked at the savagery of this attack.

"In any democratic society it is the role of the police to protect basic human rights and our two French colleagues died protecting free speech. We stand in solidarity."

Members of the

security services and police attended the meeting chaired Home Secretary Theresa May.

Shortly afterwards it was announced security at Britain's ports and train stations had been tightened.

Earlier, Labour leader Ed Miliband had earlier tweeted: "We stand in solidarity with France against this evil attack by terrorists intent on attacking our democratic way of life & freedom of speech."

'worrying implications'

Leader of the Liberal Democrats Nick Clegg told his radio show on LBC on Thursday that the Cobra meeting was to double check that all the necessary measures to ensure UK security were in place.

He wrote on his twitter page in French on Wednesday night, saying: "British people are in solidarity with the French people. These acts of terror will never shake our commitment to freedom of expression."

Nigel Farage appeared

on Channel 4 News and said: "(The attacks) are truly horrific with obviously some very worrying implications for our civilisation."

He added that he believed the free movement of people across European borders did not aid the fight against attacks like those that happened in Paris.

Mr Clegg used his radio programme to criticise Mr Farage for making political capital out of the tragic events in France and implying British Muslims are "part of the problem".

MPs, peers, parliamentary staff and journalists gathered in Westminster Hall at noon to mark events by holding pens in the air.

find himself under pressure from the far right to "fight fire with fire".

"If France can fight it with unity instead, he will not have to," it said. "We are all Charlie now."

The Daily Telegraph's editorial also feared the fallout of the attack.

"A new book by the French author Michel Houellebecq, which provided the front cover for this week's Charlie Hebdo, envisages an election in which France's mainstream parties join forces to back a Muslim

candidate to stop (Front National leader) Marine Le Pen becoming president," it said.

"In the event, the new head of state introduces Sharia law to France. Such paranoia can easily be stoked by the murders in Paris. It needs to be resisted, otherwise the terrorists really will have won."

Royal sex scandal: Fergie stands by her (former) husband

■ Andrew ‘the greatest man there is’ insists the former Duchess of York

The Duchess of York has spoken out in defence of her former husband Prince Andrew following claims that he had sexual contact with an underage woman. Appearing in public for the first time since the allegations were made, Sarah Ferguson described the Prince as “the greatest man there is”.

The Duchess was on a skiing holiday in Verbier, Switzerland with Andrew and their youngest daughter Eugenie when news of the claims broke. While Prince Andrew returned home on Monday, his ex-wife has remained at the luxury ski lodge, and declined to comment directly on the allegations when asked by the Daily Mail if she was sticking by her former husband.

“The York family is a tight unit. We’ve always been a tight unit. He is the greatest man there is. It was the finest moment of my life in 1986 when I married him. He is a great man, the best man in the world,” she said.

‘emphatically denied’

Prince Andrew flew back from his skiing holiday on Sunday evening to hold talks with the monarch, senior aides and his legal team.

The Duke of York was named in court documents filed in Florida relating to how prosecutors handled the case against billionaire financier Jeffrey Epstein. The woman in the case

has been identified by the press as Virginia Roberts, and she has alleged that she was forced to be intimate with the royal when she was 17 – a minor under US law.

After the claims, Buckingham Palace took the unprecedented step of issuing a formal statement. “It is

emphatically denied that the Duke of York had any form of sexual contact or relationship with Virginia Roberts,” Buckingham Palace said on Saturday evening. “Any claim to the contrary is false and without foundation.”

It followed two earlier statements issued by the Palace – on Friday and Saturday afternoon –

which contained further denials that Prince Andrew engaged in any “impropriety with underage minors”.

Andrew is expected to go ahead with his scheduled public engagement in Switzerland on 21 January, hosting a reception for foreign ministers on behalf of the British government.

Hundreds of British jobs axed as US pulls out of three UK bases

■ US Defence Secretary Chuck Hagel said the Americans will leave RAF Mildenhall in Suffolk and RAF Alconbury and RAF Molesworth in Cambridgeshire

Hundreds of British jobs are to go after the US air force said it pulling out of three UK airbases.

US Defence Secretary Chuck Hagel said on Thursday that the Americans will leave RAF Mildenhall in Suffolk and RAF Alconbury and RAF Molesworth in Cambridgeshire.

The move is part of a programme to save £320 million (\$500million) a year across Europe. The USAF lease the RAF bases from Britain.

RAF Lakenheath, with two squadrons of new F-35 jets (48 of them) arriving by 2020, will be the aircraft's only European base after the changes.

The US Pentagon said the loss of about 2,000 US military and civilian personnel is due to their plans to relocate away from Mildenhall, which is currently used as a transport hub by the USAF and is home to air refuelling tankers and

special operations forces.

It has about 3,200 military personnel, with 400-500 UK civilian staff employed there.

However this figure will be offset by the addition of about 1,200 people stationed permanently at Lakenheath.

job losses

Matthew Hancock MP, a Business minister and MP for West Suffolk, said Mildenhall had a long and proud history of strong relations with the United States Air Force and the move "will come as a shock to many", he said.

He said: "I have met with the Defence Secretary, and others in government to ensure we can work, together with the American administration, to support the community.

"We will create a Mildenhall, Alconbury and Molesworth Working Group, which I will chair, inviting local LEPs, councils, the Ministry of

Defence, and US representatives to ensure no stone is left unturned in supporting Mildenhall and the surrounding area."

Mr Hagel said he understood it would mean job losses and thanked those who had supported the US Air Force.

He said: "I know that this will result in a reduction of our local host nations workforces at some locations; I value the tremendous support they provided us for decades."

We cannot stop every terror threat, says MI5 boss

The threat of a terror attack in the UK is increasing and the security services cannot be expected to stop every plot, the head of MI5 has warned.

Speaking after the attack on the French magazine Charlie Hebdo, Andrew Parker said police and MI5 had "stopped three UK terrorist plots" in recent months.

He said the number of Britons who have

travelled to Syria was now around 600.

It comes as security has been increased on the France/UK border following the Paris attack, which left 12 dead.

UK border staff had "intensified checks on passengers, on vehicles and goods coming from France" following the killings in France, Home Secretary Theresa May announced.

The move was a

"precautionary" measure and was not as a result of any specific intelligence, she added.

However, Mr Parker, who was named director general of MI5 in March 2013, warned the UK was facing "more complex and ambitious plots" by extremists.

The shootings in Paris were "a terrible reminder of the intentions of those who wish us harm," he said.

Scottish Labour leader slammed for 'mansion tax' to fund Scottish nurses

■ London not a 'cash cow' Labour colleague warns

Scottish Labour leader Jim Murphy has rejected claims he is trying to "buy" Scottish votes with money "expropriated" from London.

Mr Murphy created uproar earlier this week when he pledged that a UK-wide "mansion tax" would allow a future Labour government to create 1,000 new nursing posts in Scotland.

He said most of the money raised would come from London and the south east.

Labour MP Diane Abbott accused him of "unscrupulous" behaviour, but Mr Murphy insisted his plan was "sensible".

Mr Murphy compared the plan to spend money levied on English homes

on Scottish nurses with the way the oil wealth from the North Sea was shared around the UK.

"It's part of pooling and sharing your resources across these islands, it's pretty sensible," he told BBC Radio 4's World at One programme, and pointed out the property tax was Labour Party policy.

'Tax' on Londoners

Labour has pledged to impose what it calls a "mansion tax" - a levy on homes worth more than £2m across the UK to fund the NHS - if leader Ed Miliband wins the general election.

In his first major policy announcement, Mr Murphy said he would use Scotland's share of the

money to pay for extra nursing staff, if Labour wins May's UK General Election and then the Scottish Labour Party wins the Holyrood election in 2016.

But Ms Abbott, the Labour MP for Hackney who hopes to run for London mayor, told the World at One she was very surprised that Mr Murphy was "making these boasts".

"Jim Murphy is saying that he's going to be recruiting nurses from day one on the basis of this mansion tax. You can't recruit people on the basis that money that hasn't even been raised yet," she said.

"That's all got to be thought through - Jim Murphy isn't waiting for

that. He just thinks he can buy Scottish votes with money expropriated from London," she said.

Mr Murphy hit back by saying he did not have to consult Ms Abbott or clear things with Labour leader Ed Miliband over what he does in the Scottish Labour Party.

"When it comes to issues that are devolved - so health and education in Scotland - I am in charge. I am the leader of the Scottish Labour Party."

Reserved issues such as foreign affairs and welfare, he added, were

the responsibility of the Labour leader, who he said he looked forward to campaigning alongside for a Labour victory at the general election.

Conservative Party chairman Grant Shapps said Mr Murphy's comments showed "once again that Ed Miliband simply does not command the respect of his party".

A Labour spokesman said the "overwhelming majority" of money raised would be spent in England, "but as with any UK-wide tax, Scotland

will receive a share of the proceeds under the Barnett formula".

The policy announcement, made by Mr Murphy on Monday, has also faced criticism from some other London-based politicians.

Mayor of London, Boris Johnson, described the plan as "fiscally vindictive" to the south east of England and amounted to trying to "bribe the Scots to vote Labour", while Labour's Dame Tessa Jowell said London should not be treated as a "cash cow".

Corrupt cop busted...after coming to work in his brand new Ferrari

A policeman with a sideline as a gangster involved in prostitution and drugs was brought to justice after driving a £170,000 Ferrari to work.

Osman Iqbal, who was an officer based in Birmingham, was jailed in September for seven years for running a brothel.

Iqbal, 37, whose crimes can only now be reported in full for the first time, was in court again on Wednesday, when he admitted three misconduct offences.

Ch Insp Martin Brennan said Iqbal's "greed had been his downfall".

The crooked policeman's double life as a gangster was unveiled as a result of

his decision to drive the Ferrari to Kings Heath police station.

Colleagues became suspicious and West Midlands Police's counter-corruption unit began investigating.

brothels

Officers discovered Iqbal, from Ward End, had bank accounts for two non-existent businesses that were being used to launder "hundreds of thousands of pounds" from brothels in the Covent Garden and Marylebone areas of London.

During their investigations, detectives also found Iqbal had attempted to access police intelligence systems.

Iqbal was asked by

Nahiem Ajmal, a Birmingham religious leader, to obtain information on behalf of Sajad Khan, a mutual friend, about an investigation concerning Khan, West Midlands Police said.

It was for these crimes that Iqbal appeared in court on Wednesday, admitting three counts of misconduct in public office. Ajmal and Khan were both convicted of the same offence.

The lifting of restrictions means it can now be reported that Iqbal is already serving a seven-year sentence.

He was jailed in September along with other gang members after admitting conspiracy to run a brothel, conspiracy to

launder money and possession of Class A drugs with intent to supply.

Ch Insp Brennan, from the serious and organised crime unit, said: "Their greed was their downfall and when they were seen driving around in their supercars it didn't take us long to piece together exactly what they were up to and take action."

Insp Tracey McGrath said: "Occasionally there are people who disgracefully betray the public and even their own colleagues by exploiting their status for their own gain.

"Let me reassure people that my counter-corruption team are on to people like Iqbal and there's nowhere for them to hide.

"In this case we'll be looking to seize all the assets Iqbal acquired as a result of his criminal activity and his police pension too."

Ajmal, 35, from Bucklands Lane in Hodge Hill, and Khan, also 35, from Lodge Road in Hockley, are due to be sentenced along with Iqbal for misconduct in public office on 9 February.

O'Connell in the running for BAFTA's rising star award

The line-up for the Bafta awards, Britain's version of the Oscars, is completed by young actresses Shailene Woodley (The Fault in Our Stars, Divergent), Gugu Mbatha-Raw (Belle, Larry Crowne) and Margot Robbie (The Wolf of Wall Street).

O'Connell, 24, who is

soon to star alongside George Clooney in Jodie Foster's "Money Monster", rose to fame in British teen television drama series "Skins", before gaining critical acclaim for his role in film "71", which deals with interfaith clashes in Belfast in 1971.

Fellow Brit Mbatha-Raw, 31, enjoyed successful careers on the stage, playing alongside Jude Law in Hamlet, and in television (MI-5, Doctor Who) before moving to the big screen, starring with Julia Roberts and Tom Hanks in "Larry

Crowne."

Teller, 27, played the lead role in "Whiplash", which tells the story of a young jazz drummer attending the prestigious Manhattan Conservatory under the tutelage of a tyrannical teacher.

The film won the Grand Jury Prize at Sundance in January, and his Bafta nomination is likely to increase the clamour for Teller to receive this year's Oscar.

Cavern club owner Ray McFall dies

Former Cavern Club owner Ray McFall, who helped launch the careers of The Beatles, has died at the age of 88.

McFall owned the Liverpool club in the 1960s, changing it from a jazz venue to a rock 'n' roll club and booking Merseybeat bands like The Beatles.

The Fab Four went on to play at the legendary basement venue 292 times.

"It was Ray who opened it up to those early Merseybeat sessions, which led to the whole Merseybeat explosion," said Jon Keats, a director of the Cavern.

"It was completely his vision that moved the club forward, with what turned into the huge Merseybeat explosion

and The Beatles' success and Gerry and the Pacemakers and all the main bands.

"He changed The Cavern completely and allowed the rock 'n' roll into the club."

McFall took over the club in 1959 and, with compere Bob Wooler, opened it up to the city's young rock 'n' roll bands.

The Beatles first performed there in a lunchtime session on 9 February 1961 - but their legendary association with the club almost did not happen.

McFall had banned jeans from the club because he thought they signified a rough crowd. Guitarist George Harrison wore jeans to that first gig but managed to persuade the doorman to let him in. McFall was not pleased

at first - but was soon won over when he saw the band perform.

"The Beatles were sensational and I was smitten," he later said. "Completely, Absolutely, Instantly."

"I stood at the side, between the pillars, about halfway up the hall, and as soon as they started playing I was captivated by them.

"From that very first day, there was no stopping them. I said to Bob: 'What other lunchtimes have they got? We must have them regularly.'"

The venue also hosted gigs by The Rolling Stones, The Yardbirds, John Lee Hooker and Howlin' Wolf. But in 1966, McFall was declared bankrupt and the Cavern Club was forced to close.

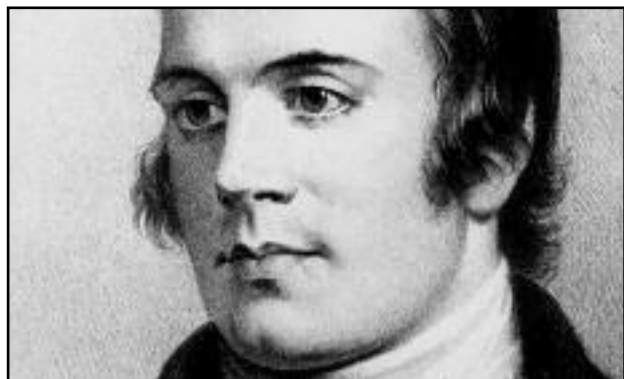

I was smuggled into the University of Mississippi when James Meredith enrolled and on the front lines of the Los Angeles Watts riots three years later. Then came the seventies with the Angela Davis and Daniel Ellsberg trials to cover. Not to mention the Patty Hearst conviction."

Happy New Year! This is my first warm winter ever and I think I can get used to it...I grew up in Arlington Heights, a suburb of Chicago, studied Theatre, Film, and Anthropology at Northwestern University in Evanston, IL, and after earning my Bachelor of Arts I lived in Chicago for eight months while performing in A Midsummer Night's Dream at Chicago Shakespeare Theatre. Four months ago, I fulfilled part of the goal I've had since age 14 by moving to Los Angeles, and now I'm in pursuit of the second part of the goal: making a career out of acting in television, film, and on stage. You can catch me at the end of February in my first episodic costar role as "Riley" on ABC's The Middle!

How did you hear about Brits in LA?

I learned of Brits in LA a little over four years ago after meeting Craig on set

of the independent feature, Return To The Hiding Place (set to release in the near future after making a hugely successful festival circuit), in which Craig stars and I have a supporting role. Was there a particular reason you chose LA?

I suppose many: 1) I've always wanted to live a part of my life away from the place I grew up, especially after spending my first 22 years in the same 30 mile radius; 2) Although my passion for acting started from a young age it didn't stem from my family being a theater-going family, so Broadway and New York City weren't ever first on my list - my family loves seeing movies together...so I figured I'd move to where that industry was; and 3) The weather and geography of Los Angeles and California beat Chicago's

hands down - and I love outdoorsy activities like skiing, hiking, and rock climbing.

What's one thing you miss from home?

From my childhood home, free food and rent ;) But actually, my friends in the city!

What do you find the biggest difference is living here versus Chicago?

So far, I'd have to say that the accessibility of public transportation and general size and layout of the two cities is what has made my experience differ most so far. Los Angeles feels far vaster due to the amount of time spent in traffic. 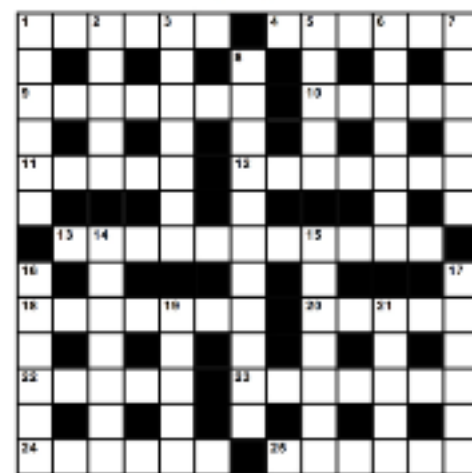

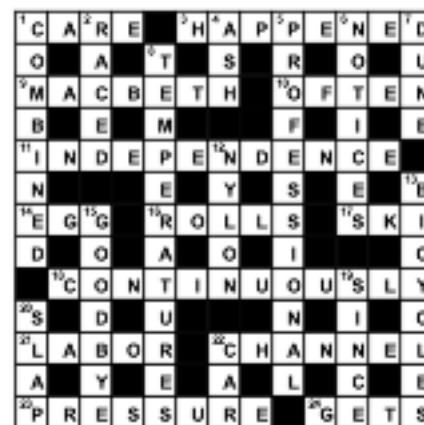

in the Premier League. But Allardyce conceded: 'There is no future for Winston Reid at West Ham at the moment. His contract finishes on June 30. He hasn't said he's going to sign or that he's not going to sign.

'I'm airing on the side that he isn't going to sign by the feel of it and look of it. Knowing how the football world works, talking to managers about the situation it's very unlikely Winston will sign for us given what people are saying to me.' Arsenal are considered the leading candidates for the player's signature as manager Arsene Wenger seeks to shore up his defence.

Liverpool have missed out on one of their top targets, Swiss midfielder Xherdan Shaqiri. Brendan Rodgers was keen to lure the Bayern Munich playmaker to Merseyside, but the player himself was keener on Italy as a destination, and has reportedly inked a deal with AC Milan. Rodgers has instead turned his attention to Manchester City and England midfielder James Milner. The 29-year-old's contract expires at the end of the

season. In what may be the most outlandish piece of transfer gossip of this window, the Daily Star reports this week that Chelsea are willing to trigger a £200m release clause to lure Lionel Messi to Stamford Bridge. There has been some upheaval at the Nou Camp this week and both Chelsea and Manchester United are said to be monitoring events, with Louis Van Gaal ready to make a huge bid for Luis Suarez in the unlikely event of the striker choosing to return to the Premiership. United are also reported to have made an offer for German central defender Mats Hummels, but Borussia Dortmund say the 26-year-old is not for sale. United also look set to miss out on on highly-rated Norwegian midfielder Martin Odegaard, 16, who may move to Real Madrid.

Chelsea goalkeeper Petr Cech, 32, could leave the club at the end of the season and has been linked with a move across London to Arsenal, according to the Telegraph, who also report that England winger Andros Townsend, 23, insists his long-term future is at

extension to that deal.

However, Valdes' arrival could lead to reserve keeper Anders Lindegaard leaving Old Trafford.

The Denmark international, 30, arrived in a £3.5m deal in January 2011 but has made only 19 Premier League appearances.

United's two other goalkeeping options are

21-year-old Sam Johnstone, who is on loan at Doncaster, and 24-year-old Ben Amos, who was criticised by Van Gaal for letting in Miralem Pjanic's 60-yard lob against Roma in pre-season.

Before last season started, Valdes confirmed he would leave Barcelona at the end of that campaign.

However, he tore an anterior cruciate ligament in March and missed the World Cup.

Tottenham despite being consistently linked with a move away from White Hart Lane. The player was reportedly part of an offer from West Brom, who sought to swap striker Saido Berahino for Townsend AND Aaron Lennon. Spurs keeper Hugo Lloris is also rumored to be the target of Real Madrid, although chairman Daniel Levy is expected to fight tooth and nail to keep what many consider to be the club's best player.

One player who Spurs are eager to show the door to is striker Emmanuel Adebayor. The Togo international is deemed surplus to requirements at the Lane and is expected to make a move to the MLS.

Arsenal have had a £5m bid for Dinamo Zagreb midfielder Marcelo Brozovic rejected. Everton, Liverpool, Tottenham, AC Milan and Valencia also want to sign the 22-year-old.

Liverpool and England striker Rickie Lambert, 32, has emerged as an early transfer target for new Crystal Palace manager, Alan Pardew, says the *Guardian*, while Aston Villa have opened talks with Manchester City about signing winger Scott Sinclair, 25.

Greek side Olympiakos have made an attempt to sign

Liverpool's Italy striker Mario Balotelli, 24, on loan until the end of the season, while Liverpool midfielder Suso, 21, is set to join AC Milan on a four-year deal, with the move likely to go through either in January or the summer.

Ipswich are set to sign Republic of Ireland striker Noel Hunt on Thursday on a free transfer. The 32-year-old, who was released by Leeds on Wednesday, had a loan spell at Portman Road earlier in the season.

Arsenal are set to make a £4m move for 17-year-old midfielder Krystian Bielik, after a £2.4m bid was rejected by his Polish club Legia Warsaw earlier this week.

Sunderland are one of a number of clubs looking at Celtic's £8m-rated centre-back Virgil van Dijk, 23. Also in the North-East, Remi Garde, 48, is keen to join Newcastle United as the club's new head coach - and is hoping to speak to managing director Lee Charnley this week to confirm his interest in the position, although Bournemouth manager Eddie Howe, whose side are top of the Championship, is also tipped for the job. However, several sources claim Ajax boss Frank De Boer remains the club's top target to replace Alan Pardew.

■ FA slap Chelsea boss with misconduct charge over his 'campaign' allegations

Jose Mourinho has been charged by the Football Association for claiming there is a "campaign" to influence referees' decisions against his Chelsea side.

Mourinho made his comments after his side were denied a penalty in the 1-1 draw with Southampton on 28 December.

Referee Anthony Taylor booked Cesc Fabregas for diving after going down in the box under Matt Targett's challenge.

Mourinho has been charged with misconduct and has until 18:00 GMT on 13 January to respond to the charge.

"It is alleged his remarks constitute improper conduct in that they allege and/or imply

bias on the part of a referee or referees and/or bring the game into disrepute," read an FA statement.

Chelsea subsequently announced that Mourinho would not attend Friday's news conference ahead of the weekend meeting with Newcastle.

After the draw at St Mary's, the Stamford Bridge manager told reporters: "The media, commentators, other managers are all doing it [putting pressure on referees]."

In his news conference later, he added: "There is a campaign against Chelsea. I don't know why there is this campaign and I do not care.

"Everybody knows it was a penalty."

Mourinho has also been issued with a formal warning for comments ahead of Chelsea's 2-0 win at Stoke on 22 December.

The Portuguese called on referee Neil Swarbrick to produce a strong performance at the Britannia Stadium.

"Having sought his observations on this matter, the FA has decided not to bring a disciplinary charge and instead issued him with a formal warning," added the statement.

"The FA prohibit participants from making any pre-match media comments, including comments of a positive nature concerning the appointed match officials for a particular fixture."

Valdes seals United switch

■ Former Barca keeper makes surprise move to Old Trafford

Former Barcelona goalkeeper Victor Valdes has signed for Manchester United as "the number two goalkeeper", said manager Louis van Gaal.

The 32-year-old Spain international (right) has penned an 18-month deal, with the option of another year.

Valdes had been training with United as he recovered from a serious knee injury after his Barca contract expired.

"I can already see this is a very special club," said Valdes, who will



deputise for David De Gea.

"I worked with Louis van Gaal during my time at Barcelona and to have the opportunity to work with him here at Manchester United is a dream come true."

Van Gaal said that Valdes had been "very impressive" during

training.

"He joins the club as the number two goalkeeper and is a great addition to the first team," the Dutchman added.

Valdes's arrival has caused some to question about the future of 24-year-old first-choice goalkeeper De Gea, who was the club's player of the year last season.

His contract is due to expire in 2016, although senior United sources have said they were relaxed about him signing an
