Snow closes schools and causes travel chaos – and the misery could last THREE WEEKS, experts warn

Brutal weather left much of the UK bruised and battered this week as schools and transport networks were closed with many main roads in the North left impassable.

The entire UK was issued with a yellow 'be aware' warning from the Met Office on Wednesday as snow fell and plunging temperatures arrived.

The extreme weather brought misery to hundreds of passengers at Manchester Airport, with the airport forced to stop all flights coming in and going out for several hours due to the extreme weather

accidents

Elsewhere more than a dozen rail services were halted - leaving commuters unable to get to work.

Hundreds of schools across the UK also closed their doors as the freezing weather took grip of the country.

Ambulances crews

were also kept busy as accidents were reported across the country.

Dozens of accidents were reported on the roads and motorways of the nation, leaving police and other agencies pleading for people to take care.

Merseyside Police said: "Take care on the regions roads today as the adverse weather takes its grip. Only travel if your journey is essential."

schools closed

Met Office forecaster Simon Partridge warned that the bad weather was likely to contune and people should be prepared for further disruption.

Main roads in Durham and Yorkshire were also shut as the

Highways Agency warned that heavy snow had fallen across the north.

And schools in Cumbria and Northern Ireland were forced to close as the fresh snow swept in.

UK's world-beating economy has fastest growth for seven years

BRITAIN'S surging economy is growing at the fastest rate for more than seven years, official figures have revealed.

The overall figure suggests the UK is on course to be confirmed as the fastest-growing major economy in the world.

And in another sign employment is rising, supermarket giant Waitrose announced on Tuesday that it was creating 2,000 jobs for 14 new outlets.

The firm also opened

two stores this month.

The latest evidence Britain's output is growing faster than at any time since 2007 was a massive boost to the Tories ahead of the general election in May.

Chancellor George Osborne claimed the Government was "protecting Britain from the economic storm".

He added: "With 100 days to go until the election now is not the time to abandon that plan and return Britain to

economic chaos."

David Cameron said on Twitter the figures showed "our economic plan is working".

However, some experts raised concerns the pace of growth slowed in the final three months of 2014.

GDP expanded by 0.5 per cent, less than the 0.6 per cent expected by the City.

Joe Grice, ONS chief economist, said it was "too early" to say if the slowdown was

continuing.

"The dominant services sector remains buoyant while contraction took place in industries like construction, mining and energy supply," he said.

The service sector grew

by 0.8 per cent between October and December.

Manufacturing rose by 0.1 per cent but construction fell by 0.1 per cent.

Economist Howard Archer said: "The disappointment with

growth in the fourth quarter was it looks unbalanced on the output side of the economy."

Shadow chancellor Ed Balls said: "Tory claims the economy is fixed will ring hollow with working people."

Ambassador summoned after Russian warplanes 'disrupt' British airspace

THE RUSSIAN AMBASSADOR was summoned to Downing Street on Thursday after Russian bombers were found flying close to British airspace, saying the incident had disrupted civil aviation.

The move comes after a string of similar incidents and amid tense relations with Moscow over the conflict in Ukraine and a London inquiry into the poisoning of former Russian spy Alexander Litvinenko.

The Ministry of Defence said such

incursions by Russian planes were currently running at around one a month and that the latest happened off the south coast of England.

"Russian aircraft manoeuvres....are part of an increasing pattern of out of area operations by Russian aircraft," the Foreign Office said in a statement.

'bears'

"While the Russian planes did not enter sovereign UK airspace and were escorted by RAF Typhoons throughout the time they were in the UK

area of interest, the Russian planes caused disruption to civil aviation.

"That is why we summoned the Russian Ambassador today to account for the incident."

The defence ministry said that the planes involved in the latest incident Wednesday were Tupolev Tu-95 bombers, known by their NATO classification as Russian "bears".

But a spokesman for the Civil Aviation Authority, which regulates aviation,

downplayed the incident, said he was "not sure where this idea has come from" that there had been disruption to civil aviation.

He suggested it may have been the two British Typhoons which caused any disruption as they may have flown through airspace near Bournemouth, southern England, where there is a small civilian airport.

'respect and caution'

"It was probably two Typhoons that were scrambled to intercept that caused some

disruption," he said.

The incident is seen by observers as just the latest in a war of nerves instigated by President Vladimir Putin to reassert Russian power.

"Putin wants to let the West know - especially the UK, America's closest ally - that Russia is still here,

is still a huge military power, and should be treated with respect and caution," said a source at the Foreign Office.

In November, four Russian navy warships were spotted sailing through the English Channel and were accompanied by a Royal Navy patrol boat.

Fergie time proves lucrative for 'retired' United boss

Sir Alex Ferguson made more than £2million during his first eight months in boardroom roles at Manchester United, accounts revealed this week.

The former manager's 26-year reign in charge of the football team came to an end in 2013, when he became a director and global ambassador for the club. Club accounts now reveal his reported £100,000-a-day roles allowed him to make £2,165,000 between October 2013 and June last year.

After stepping down to make way for the short-lived tenure of

David Moyes in the Old Trafford hotseat, Ferguson tried to keep a low profile for fear he would overshadow his replacement. But the club were keen to use Sir Alex's world-famous status to promote the Manchester United brand around the globe. He has travelled the world in his role, with duties including the unveiling of Park Ji-Sung as another ambassador for the club last October. Park became one of five other ambassadors working alongside Sir Alex, joining former greats Sir Bobby Charlton, Andrew Cole, Denis Law and Bryan

Robson. Ferguson topped football's managerial rich list shortly before his retirement, when his estimated £7million-a-year from United while he was manager led his estimated worth to be £34million. And club accounts suggest the Scotsman is still doing very nicely, thank you, making at least £1million from sales of his autobiography and more than £2million selling off part of his wine collection last year. He also has a number of other roles he carries out, having been appointed to a teaching

position at Harvard University in the US and heading an elite coaches forum for European footballing body Uefa.

The same accounts show Sir Bobby Charlton was also paid by United

in 2013-14 for 'consultancy services', although he made just £105,000.

A spokesman for Manchester United said: 'Sir Alex has been employed as an

ambassador for the club, providing support to the club as directed from time to time. As was the case during his time as manager, his contract is a private matter between the club and Sir Alex.'

West Yorkshire and Tyne and Wear due the adverse weather conditions.

Some passengers at Manchester Airport took to Twitter to vent their frustration.

Adrian Cole tweeted: "In Hale this morning and there's about 10mm

of snow, 2 mins up the road and they've shut Manchester airport!!! It's only snow FFS!!"

Northern Ireland was also badly hit, with more than 130 schools being forced to close across the region.

Of all the areas hit by the bad weather, London appeared to be the least affected.

Although temperatures were low and a warning issued, there was no snow

predicted for the capital.

Health experts have warned of the possible dangers and urged the vulnerable to stay warm and not to take unnecessary risks.

Dr Angie Bone, head of extreme events at Public Health England, said: 'Parts of England are really going to feel cold for the next few days so it's really important people take extra care when out and about.'

Church of England consecrates first female bishop

YORK: The Church of England consecrated its first woman bishop on Monday, the culmination of years of efforts by Church modernizers to overcome opposition from traditionalists - one of whom briefly shouted a protest during the service.

More than two decades after the Church allowed women to become priests, 48-year-old mother-of-two the Reverend Libby Lane became Bishop of Stockport in a ceremony at York Minster, the famous Gothic cathedral in northern England.

The protest came as John Sentamu, Archbishop of York, asked the congregation whether Lane should be consecrated as Bishop.

As the congregation chorused its approval, a lone man's voice shouted above them: "No, not in the Bible."

When Sentamu asked the question again, there was no dissent and the ceremony went ahead.

During the service, which ended in

applause, Sentamu and other bishops ceremonially laid their hands on Lane and prayed for her.

Earlier, Lane had spoken of what she hoped her consecration would achieve for women.

"If my appointment encourages a single young woman to lift her eyes up a bit and to realize that she has capacity and potential and that her environment or those around her don't need to dictate what is possible for her, then I'd be really honored" she said in an interview published by the Church.

deeply split

Her appointment, announced in December, has been hailed as a step forward for gender equality by Archbishop of Canterbury Justin Welby, spiritual head of the Church, and by many others including Prime Minister David Cameron.

However, a conservative minority say the Bible demands male leadership.

The worldwide

Anglican community has been deeply split over the issue of women clergy. Women already serve as bishops in the United States, Canada, Australia and New Zealand, but Anglican churches in many developing countries, particularly in Africa, do not ordain women as priests.

After years of debate, an attempt by the Church of England to bring in women bishops failed in 2012 when it was narrowly defeated by traditionalist lay members in a vote in the General Synod, the Church's governing body.

After that setback, the Church came up with new proposals which gained wider acceptance and were approved by the Synod last year.

Women have served as priests in the Church of England since 1994. Lane was ordained in 1994. She has been vicar of a church in the outskirts of Manchester since 2007, as well as Dean of Women in Ministry in the diocese of Chester.

Go metric, EU orders British railways

BRITAIN'S rail network is to go metric on the orders of the EU, it emerged this week, sparking fresh safety fears.

Brussels is to ban miles and yards from trackside signs with distances being given in kilometres and metres instead.

Until the changeover, train drivers on Britain's 10,072 miles - or 16,209km - of track will be forced to calculate speeds and distances in imperial and metric measurements.

Experts say it raises the risk of potentially catastrophic confusion, while train drivers' union Aslef has described the plans as an "unacceptable safety risk".

A risk analysis by the Rail Safety and Standards Board says problems could arise when staff are required to handle both trains

that are metric-compliant and others on which speed is still measured in miles per hour during the transition period.

The move is part of the installation of the European Rail Traffic Management System (ERTMS) on selected routes between now and the 2030s.

Trackside mile markers will be replaced by kilometre signs and staff rule books and training manuals will be rewritten after a directive from the European Railway Agency, an EU quango based in France.

Ukip MEP Jill Seymour said: "Here we go again with another bureaucratic directive..."

"Financial pressure on British rail companies is already forcing ticket prices up above inflation,

hitting all passengers in the pocket.

"These ill-considered and unnecessary plans can only make the pressure worse.

"The UK is clear that distance signs must be in miles, not kilometres.

"There is no reason for any change in that other than the EU flexing its muscles."

A test run of the system on the remote Cambrian line between Shrewsbury and the West Wales coast has been blamed for a series of problems, including five incidents in five months of trains passing red signals.

The Department for Transport applied to Brussels for an opt-out from the metrication directive in 2012 but was turned down.

Actress Maureen Lipman considering leaving the UK 'due to rise in anti-Semitism'

Maureen Lipman has said the rise of anti-Semitism in the UK has prompted her to consider leaving the country.

The Yorkshire-born Jewish actress said she had thought about moving to New York or Israel following an increase in the number of attacks against Jews.

Speaking to leading London local radio station LBC on Holocaust Memorial Day, she said: "When the going gets tough, the Jews get packing. It's crossed my mind that it's time to have a look around for another place to live. I've thought about going to New York. I've thought about going to Israel."

'depressing'

She said she did not understand the levels of hatred towards the Jewish community in the UK given what it gives back to society.

"There are 245,000 Jews in this country – what's to fear? We don't proselytise, we don't fly planes into buildings, we generally keep on the right side of the law. What is it? Because I don't understand it at all. We give in science and in art, we give, we

integrate, we help, we try, we are philanthropic and still they start – it starts – and it's very, very depressing."

'scapegoat'

The actress denied that the rise of anti-Semitism across Europe was linked to the Israel-Gaza conflict, adding that prejudice against Jewish people has been around for four centuries.

"When the economy dries up, then they turn on the usual scapegoat: the usual suspect - the Jew. There is one school of thought that says it's because of Israeli policies in the West Bank, it isn't. There's been anti-Semitism for the past 4,000 years."

no future

A recent YouGov poll found that 54 per cent of British Jews feared they had no future in the UK and a quarter had considered leaving the country in the last two years.

Another poll commissioned by YouGov found that 45 per cent of British people agreed with one of four anti-Semitic statements, while 25 per cent agreed with at least two.

Child porn has ruined my life, sobs Glitter in court

Gary Glitter broke down in tears this week as he explained to jurors why he had been in possession of child abuse images.

S o b b i n g uncontrollably, the 70-year-old said he had been in a bad place in his life, and was struggling financially, with alcohol and with drugs.

He issued a tearful apology to his fans, saying: "I lost my own dignity, and I am so sorry. I am very sorry."

Glitter, on trial under his real name Paul Gadd, denies 10 charges relating to three girls between 1975 and 1980.

In November 1997, when he went to pick up a Toshiba laptop he had handed to a PC World branch in Bristol, he was arrested, Southwark Crown Court in London heard.

'very bad place'

The engineer who examined the machine had discovered images on it related to child abuse.

Mr Gadd subsequently admitted responsibility for a "large number" of images - depicting a full range of sexual activity taking place between men and very young children - being on his computer.

He was jailed for four months in 1999 for the collection of 4,000 images.

In cross-examination, prosecutor John Price QC, asked the singer: "Why were you looking at pictures of men having sex with young children?"

Immediately breaking into sobs and reaching for a tissue, Mr Gadd

replied: "I was in a very bad place in my life at that time and I had a lot of very serious decisions to make about my future."

He added that he had invested £200,000 in his own career, and that his record company and fans were demanding a lot from him.

'I was abused'

He said that at that stage in his life he was not able to empathise with the child victims of the indecent images that were found on his computer, but added that he now recognised the damage caused to the vulnerable youngsters.

He said: "I was abused as a child, so maybe I was trying to work my own feelings out.

"Today it would not happen, I have no interest in looking at that awful porn now.

"[I have] absolutely no interest at all, it has destroyed my life, it has destroyed my family's life and it has most likely destroyed all those poor victims' lives. I have

total empathy for those poor children."

In this trial, he is accused of attempting to rape and indecently assaulting a girl under the age of 13 in 1975.

He was quizzed about the allegation that the youngster was lying in bed with a friend when he attacked her.

But Mr Gadd said he had no recollection of the girl, asserting that he did not try to rape her and that he had no clue why she had made up the allegations.

"I can't say why anybody would dislike me," he told jurors. I did not try to rape her or any other child."

"I have absolutely racked my brains to wonder why she could say such a terrible thing."

'Accomplished liar'

The court heard that in the mid-1970s his management concocted a story that he was retiring "for love", something that the singer went along with in an effort to boost concert sales.

Jurors were told that in his 1999 autobiography, Mr Gadd described his involvement in the ruse as an "Oscar winning performance".

Mr Price said: "What each of these three ladies has told us is true, isn't it? And you, Mr Gadd, are an accomplished liar."

The singer firmly replied: "I am not a liar. I believe that I have told the truth all through this, all through my life actually."

He is also charged with four counts of indecent assault on a fan in 1977 at hotels in Leicester and Birmingham when she was aged 12 and 13; plying the same girl with alcohol, and having unlawful sexual intercourse with her.

Two further charges allege he indecently assaulted a girl of 13 on a date between October 1979 and December 1980, in his dressing room at a venue in Watford where he was performing.

The trial has been adjourned until Monday.

The end of Downton Abbey? Julian Fellowes 'to ditch' ITV show later this year

■ Creator Julian Fellowes plans to abandon the period drama for lucrative new American project

BAD NEWS for Downton Abbey fans: according to several reports the creator of the wildly popular TV show Lord Julian Fellowes is to ditch the period drama to work on a lucrative project in America.

The sixth series of the popular programme is set to hit British screens later this year but it will be the last instalment, sources say.

Lord Fellowes, 65, is working on a new project about 19th century New York.

It is understood he will have no time to work on future storylines for the upstairs downstairs drama starring Hugh Bonneville as the Earl of Grantham.

The bombshell news

comes just days after the Downton cast was named the outstanding drama ensemble at the Screen Actors Guild Awards in Hollywood.

A source said: "It's an open secret that Downton is ending this year.

"Some of the actors are keen to let it be known they will be available for work after the summer. Some are interested in the US, where Downton is as popular as it is in the UK."

The season opener of the fifth series last year was the least-watched episode since Downton hit our screens four years ago.

More than one million fans dropped off compared to the fourth series curtain raiser in

2013, which was watched by a record high 9.51million.

Filming for the sixth series is set to start in the spring and will finish in the summer before airing on ITV from September.

A Downton source said: "The show is commissioned on a series by series basis and always has been.

'speculative stories'

"As in previous years we tend to find out if the show has been recommissioned towards the end of the run on ITV.

"We have had this speculation for years, since series two in fact. We film for six months of the year leaving the cast plenty of time to do other work.

"Of course ITV is always looking for other dramas - we are only on air for eight Sundays in a year, leaving 44 others to fill."

ITV added: "We wouldn't comment on speculative stories about our programmes."

Show stars Joanne Froggatt, Edith Carmichael and Allen Leech were all in Los Angeles for the awards last week and all three reportedly held

meetings about both TV and film roles.

Downton alumni Dan Stevens and Jessica Brown Findlay have already left the show for the bright lights of Hollywood so it's little surprise others are keen to try their luck.

And another source told how ITV chiefs are already desperately searching for a replacement to pull in the same audience levels as Downton. 'They want

something long-running and ambitious,' they said.

Fellowes had previously told the Wall Street Journal how he's looking forward to getting stuck into The Gilded Age, which is set to air on NBC.

He said: 'It will happen when Downton finishes, because I just couldn't do both at once. Downton is not going to go on forever. It won't be Perry Mason.'

'I'm such an idiot': Cumberbatch sorry for uttering the 'c' word

'I'm devastated to have caused offence': Benedict Cumberbatch issues grovelling apology after referring to black people as 'coloured' on US TV

Benedict Cumberbatch has apologised for referring to black people as 'coloured' on US television, saying he feels 'the complete fool' and is 'devastated to have caused offence'.

His grovelling apology came on Monday night following an interview on PBS talk show Tavis Smiley.

The 38-year old Sherlock actor used the term, which has sparked a racial outcry among viewers, when discussing the lack of

opportunities for black actors on British screens.

The heartfelt statement read:

'I'm devastated to have caused offence by using this outmoded terminology. I offer my sincere apologies.

'complete fool'

'I make no excuse for my being an idiot and know the damage is done. I can only hope this incident will highlight the need for correct usage of terminology that is

accurate and inoffensive.

'The most shaming aspect of this for me is that I was talking about racial inequality in the performing arts in the UK and the need for rapid improvements in our industry when I used the term.

'I feel the complete fool I am and while I am sorry to have offended people and to learn from my mistakes in such a public manner please be assured I have.

'I apologize again to

anyone who I offended for this thoughtless use of inappropriate language about an issue which affects friends of mine and which I care about deeply.'

During his interview, Tavis asked Benedict why he thought more and more black and white British actors were getting work in

Wild Card: it's a good bet

■ Latest Jason Statham vehicle is well worth a test drive

Anyone who knows me or who has read any of my reviews or interviews over the past few decades knows of my admiration and affection for action films, stunt work, Jason Statham and his fellow Brit, director Simon West.

Put all of those ingredients together, and toss in a screenplay by William Goldman, and I'm in. Needless to say, you can imagine my excitement for **Wild Card** as it not only blends all of these elements in this slick, as-to-be-expected reflective and brooding crime drama, but minimizes the action allows us to focus on character and the introspective nature of Statham's Nick Wild.

friend in need

Adapted by Goldman from his novel of the same name, **Wild Card** is not the typical Jason Statham-Simon West action movie (now their fourth teaming). While there are still more than sufficient displays of Statham's patented martial arts stylings to satisfy the most die-hard fan, not to mention some slick maneuvers with credit cards and teaspoons, West, Goldman and Statham allow us to sit back and enjoy the psychological gamesmanship of Nick Wild and a wacky cast of characters who represent every patented Las Vegas element imagined centered around a Mafioso-hinged plotline. In short, I'm wild about

Wild Card.

Nick Wild, a for-hire security/bodyguard, dreams of hitting a \$500K score at the blackjack tables so he can live out his life in peace on a boat in the calm waters off Corsica. But that's what makes Vegas, Vegas. It's all about dreams, dreams that one keeps chasing, and Nick has been chasing his for years. Always there for a friend in need, whether they can pay for his services or not, you get the sense that Nick will never hit paydirt and Corsica will always be just a dream.

When Nick gets a call for help from old girlfriend Holly who has been viciously beaten and dumped at an emergency room door, Nick hunts down the culprit, who is sequestered away at the Golden Nugget. Danny DeMarco is a vicious thug who is more into looking the part than playing smart, which makes him and his boys an easy target for Nick who just wants to "warn" DeMarco, but as we quickly see, a vengeful Holly has a more personal payback in mind.

riveting

Enter the young Cyrus Kinnick. A wimpy looking whiz kid from Boston seemingly on his own for the first time in his life, Cyrus believes he requires Nick's services as a bodyguard during his brief stay in Vegas. But it quickly becomes evident that not only is Cyrus not what he seems, but who's doing the protecting?

As Nick Wild, Jason Statham is perfection. Quiet, brooding, introspective but with a wild streak, yet, no one can build tension with

silence, stillness and just a stare like Statham. And he does just that in **Wild Card** making one extended gambling scene more riveting than all the action of three key scenes put together.

An interesting performance comes courtesy of Michael Angarano as Cyrus. Over the years we seen Angarano be timid or over confident, but as Cyrus he delivers a Nervous Nelly performance complete with lovely little nuances with his posture, his walk, his hands. It's the engaging play and chemistry between he and Statham that has you doubling down with interest.

There are nice cameo turns by Jason Alexander and Anne Heche as Pinky and Roxy, respectively and Sofia Vergara as the appropriately named DD. And I've gotta hand it to Goldman and West adding some great tongue-in-cheek double entendres to not only Statham's dialogue but a Pepsi placement nod with its spokesperson Vergara.

While set in present day, scribe William Goldman peppers **Wild Card** with the requisite stereotypical Vegas-mob elements we have so loved for decades while tailoring specifics to Statham's brand of performance. It's a lovely meld of old and new. The poignancy and raw visceral nature of the story and the characters, particularly that of Nick Wild, can resonate with each off us with just the slightest look at our own lives. Characters are fun, and thanks to some great story structure and dialogue in tandem with West's direction, we only need one scene with some of these characters to know who they are and

why they are in Nick's life. I would have liked to see the character of Cyrus fleshed out a bit more as he proves quite interesting in the hands of Angarano, yet given the "ships that pass in the night" idea of Vegas, the minimal depth works. Multi-textural and layered and as with all of Goldman's works, deeper and more engaging than what's on the surface.



Suspicion: a maze of mysteries at the old house

"*Suspicion* came from my love of classic Gothic mystery novels, particularly *Rebecca* by Daphne du Maurier," says author Alexandra Monir. "I loved that book so much growing up, that when it came time for me to start brainstorming a third novel, I kept coming back to my love of *Rebecca* and how much fun it would be to update the premise for a younger, 21st century audience. But then I started pulling in different story elements,



like the supernatural, and also exploring themes like the intense closeness between childhood friends and what happens to that closeness when people grow up, or when tragedy strikes. So ultimately the book isn't as much a retelling of *Rebecca* as it is a new story inspired by it."

An enchanting read, this Young Adult novel is perfect for anyone who

appreciates classic thrillers. There are secrets, mystery, magic and romance. *Suspicion* is set at Rockford Manor, a British country estate that has secrets. After Imogen's parents die in a fire there, she must go live with her guardians in America. She leaves behind her grandfather and cousin. Her guardians tell her to forget her old life, including Sebastian Stanhope, the neighbor boy she liked.

Imogen struggles with her move to New York, where she doesn't feel she belongs. She tries to forget. Now seventeen, Imogen has not forgotten her father's dying words to her: look to the maze. But the garden and its maze burned in the fire. Imogen, as the heir, must return to England. At the estate she can sense there is something not right.

Why did her parents and cousin die? Is her life in danger too? Who can she trust?

Monir says she did lots of research while writing the book. "The biggest thing I did was take a trip to England while writing the first draft of the book. I soaked in the culture, learned a ton about British life and history, and I visited the places featured in the story, particularly Blenheim Palace in Oxfordshire." Monir based the fictional Rockford Manor on that location, best known as the ancestral home of the Churchill family.

Suspicion is Monir's third book. Her debut novel was the time-travel YA romance *Timeless* in 2011, followed by its sequel *Timekeeper* in 2013. She is writing her fourth novel for Delacorte, the YA mystery *The Girl in*

the Picture.

Monir, a singer, has recorded a song from the book to go with the book's release. "I heard an old song while writing *Suspicion* that spoke to me and the story so much," says Monir. "I just had to feature it in the book. The song is *Autumn Leaves*, the English translation of a French classic. I ended up writing a really special scene in Chapter 12 where the song plays a pivotal role. When I shared this with my mom, she told me something amazing, that this is the same song my grandmother Monir Vakili, Iran's foremost opera singer and my namesake, used to sing all the time."

Alexandra Monir is based in Los Angeles. She was born in Marin County, north of San

Francisco.

Hard Men in Tights? Vinnie Jones ballet dances on ABC's 'Galavant'!


For the past 16 years, Vinnie Jones has been Hollywood's go-to British tough guy.

London rivals Tottenham.

The Spain international was charged by the Football Association on Wednesday over the incident.

He is being charged for the first of two alleged stamps that were not seen at the time by referee Michael Oliver.

Costa also appeared to stand on central defender Martin Skrtel in the Liverpool penalty box in the second half.

The first-half incident involving Can took place close to the technical area and prompted an angry response from the Liverpool player.

The disciplinary case is now set to be heard by an independent regulatory commission on Friday, after the British Weekly went to press, which will make a final ruling over whether Costa must serve the suspension for his charge.

Should the forward be found guilty, the first of a three-match ban would come in Chelsea's top-of-the-table clash against Manchester City on Saturday.

It is understood Costa is appealing with the full backing of Chelsea.

Chelsea cancelled their pre-match news conference for the game against City on Thursday afternoon.

Costa could also miss games against Aston Villa and Everton.

Liverpool manager Brendan Rodgers said after the League Cup semi-final: "He could easily hurdle over the young player and he directs his studs right on to his ankle, which could have been nasty."

Chelsea boss Jose Mourinho said after the game that he feels the Brazil-born player is being targeted unfairly, describing the stamps as "absolutely accidental" and claiming he was only "looking to the ball".

Murray into Aussie Open final

Andy Murray came storming back after a poor start to beat Tomas Berdych and reach his fourth Australian Open final on Friday.

The British number one lost a tense first set but recovered to win 6-7 (6-8) 6-0 6-3 7-5.

It will be the sixth seed's eighth Grand Slam final and first working with Amelie Mauresmo, with ex-coach Dani Vallverdu now in Berdych's corner.

Murray, 27, will play the winner of Friday's semi-final between Novak Djokovic and Stan Wawrinka.

"There was a little bit of extra tension - it was a big match," said Murray. "A lot was made about Dani Vallverdu, my former coach, working with Tomas.

"But we've been friends since we were 15 years old and I felt that the focus was unfair and unnecessary.

The Scot's hopes were under threat after losing a tension-filled opening set, but he turned it around with a brilliant lob early in the second and took control with seven straight games.

Berdych, 29, had started much the better and served for the set at 5-3, only for Murray to break straight back in a rally of huge forehands and celebrate wildly in the direction of the Czech's player box.

There was a definite edge to the contest, and some sharp words followed from Murray in the next game when Berdych complained about the balls.

Two more break points slipped by at 5-5 but Murray edged ahead in the tiebreak, earning the first set point, only for Berdych to save it impressively behind his serve and go on to clinch it.

Arsenal sign Paulista; Chelsea close in on Cuadrado

Arsenal have signed Villarreal defender Gabriel Paulista for 15m euros (£11.2m) with forward Joel Campbell joining the Spanish side on loan until the summer.

Brazilian Gabriel, 24, was ever-present for Villarreal this term and could face Aston Villa on Sunday.

Arsenal were granted a work permit for Gabriel, who can play at centre-back or full-back, on Monday, despite the fact he is uncapped and not a European Union citizen. He joined Villarreal from Brazilian club Vitoria in 2013.

Gabriel is available for selection for Arsenal's Premier League home game against Villa.

Campbell, 22, has signed a new long-term contract with the Gunners before heading to Villarreal for the rest of the

season. He signed for Arsenal in 2011 from Costa Rican club Deportivo Saprissa SAD but has yet to score for the Gunners.

Chelsea are set to complete the transfer of Fiorentina's Juan Cuadrado "within the next 48 hours" with Mohamed Salah potentially going the other way on loan, say reports from London.

Cuadrado, 26, signed a new contract including a buyout clause worth £27 million last summer, which Chelsea will have to match.

Sources added that the London club have not yet activated the clause but have reached agreement on personal terms with the Colombian winger.

Chelsea will pay around £23 million up front, with the rest of the fee made up of bonus clauses.

But in order to meet that and continue to adhere to financial fair play regulations, they may let Andre Schurrle leave Stamford Bridge for Wolfsburg now rather than in the summer.

Liverpool have made a bid to sign Burnley striker Danny Ings, 22, and plan to loan the England Under-21 striker back to the Claret's for the remainder of the season. Ings will be out of contract at Turf Moor at the end of the season and the relegation-threatened side are desperate to hang on to their most reliable source of goals, at least until their Premiership survival is assured.

Tottenham are still hoping to land Everton winger Kevin Mirallas,

27, before the transfer window shuts on Monday and are offering fellow winger Aaron Lennon, 27, in exchange. Everton have twice rebuffed bids for the player, who is reportedly keen to leave the club.

Manchester United and Chelsea are expected to lead a big-money chase for rising star Paul Pogba. The French midfielder has been in superb form for Juventus this year and this week the player's agent told the press Pogba was looking to move away from the Turin giants. Pogba signed for Manchester United as a teenager but left for Juventus when his contract expired, prompting harsh criticism from then-manager Sir Alex Ferguson.

TOTTENHAM survived a strong fightback from League One side Sheffield United Wednesday night to set up a League Cup final with Chelsea after another late goal from Christian Eriksen.

The young Dane's magnificent first-half free-kick put Spurs 2-0 up on aggregate and the London side looked to be cruising.

But then United's 18-year-old substitute Che Adams then struck twice from close range in three minutes, bringing the prospect of extra time into focus.

But Eriksen secured a 3-2 aggregate win with a composed low finish.

Spurs beat Chelsea in the League Cup final in 2008 for their last piece of silverware, and the two London sides will now meet again at Wembley on Sunday 1 March, just three days after Tottenham's Europa League trip away to Fiorentina.

Jose Mourinho's Blues will start as favourites but

Spurs will take confidence from both their superb 5-3 win over Chelsea on New Year's Day and the uncanny knack of Eriksen to score important late goals.

Four times this season, the Dane has scored decisive goals in the 87th minute or later.

The hosts needed to score the first goal and had the game's earliest chance when Spurs goalkeeper Michel Vorm retained despite a shocking mistake in their weekend FA Cup loss to Leicester - spilled a cross, but Jamie Murphy's shot was blocked on the line by former Blades defender Kyle Walker.

Harry Kane was a constant menace up front but passed up at least four good chances before Eriksen bent in a wonderful 25-yard free-kick off the inside of the post.

That left United needing to score twice to send the game to extra time, but despite an improved display they created little until a manic last 15 minutes.

Adams, a recent signing from non-league side Ilkeston Town, had only played 136 minutes of

professional football and scored his first senior goal with a composed finish at the back post from Ryan Flynn's excellent cross.

And when Adams controlled a Murphy cross to fire in with the help of an Eric Dier deflection two minutes later, Bramall Lane sensed another cup upset after the weekend's FA Cup heroics from Bradford and Middlesbrough.

But Eriksen steered

Spurs into the final with running on to Kane's pass left-footed from the edge two minutes remaining, to calmly slot home of the penalty area.
