# IT'S ROYAL BABY FEVER!

■ With latest Royal due any moment, excitement builds outside Kate's London hospital

Royal baby fever was rising this week in London's Paddington neighborhood, despite the best efforts of the authorities to dampen expectations ahead of the arrival of The Duchess of Cambridge's second child.

As the British Weekly went to press on Thursday night Kate's official due date came and went, while crowds were gathering outside the private Lindo Wing at St Mary's Hospital despite a line of metal barriers designed to keep the press pack at bay.

A smattering of hardy pensioners bedecked in Union flags had found their spots early in the week - and until late Thursday they were the only signs of the momentous event about to take place there, - the media having been banned from congregating outside the hospital until after 33-year-old Kate has been admitted in a bid to avoid a repeat of the 'Great Kate Wait' that heralded George's birth.

A royal source has indicated that an official announcement will be made only the day after

the birth. But despite the veneer of calm surrounding the final days of Kate's pregnancy, the reality is that behind the scenes every contingency has been prepared for with ruthless precision.

### red alert

The British press have reported that the mastermind behind Kate's meticulous preparations is - no surprise here - her mother Carole Middleton, a woman most often described as 'formidable' and who seems determined to not only protect her daughter from an event which, we now know, proved overwhelming for William's mother Diana, but also to ensure the Middleton clan are not overshadowed by the royal family. The whole of Kate's inner circle are on red alert (or, if the rumors of the baby's sex are

correct, pink alert) this week. Kate's brother James has returned from holiday in Los Angeles - where he has been with girlfriend Donna Air and her daughter Freya - all ready to 'Lindo hop', as he calls his expected dash to his sister's side in hospital.

Pippa is recently back in town after a brief trip to Geneva, to visit her hedge-fund manager boyfriend Nico Jackson, doubtless eager to put her recent whale meat gaffe behind her.

As for 60-year-old Carole Middleton, her bags have long been packed so she can be at her daughter's side at a moment's notice, her mobile phone is permanently on and her handbag is filled with endless 'to do' lists.

Carole, it is said, is already 'the interface between the tired Kate and the rest of the world',

and it is she who will be making sure that the hospital room remains calm and controlled when the time comes.

Kate is aiming for a natural birth, as she had with Prince George - no drugs unless absolutely necessary - and wants to be back home within 48 hours if there are no complications.

# Major predicts 'mayhem' if Labour and SNP strike post-election deal

■ Sturgeon 'will ask for the impossible and create merry hell if it is denied,' former PM warns

SIR JOHN MAJOR was plunged into a furious row this week after issuing a stark warning about the dangers of a post-election deal between Labour and the Scottish Nationalists.

The former Tory prime minister intervened in the general election campaign to forecast "mayhem" if Ed Miliband is propped up in Downing Street by Nicola Sturgeon.

And he claimed taxes in England would soar due to a "daily dose of blackmail" from the SNP.

"They will ask for the impossible and create merry hell if it is denied," he warned.

"The nightmare of a broken United Kingdom has not gone away.

"The separation debate is not over.

"The SNP is determined to prise apart the United Kingdom."

But Labour and the SNP reacted angrily to the Tory warnings.

Miss Sturgeon branded his comments

"an affront to democracy" and Mr Miliband accused Conservatives of "threatening the integrity of the United Kingdom".

Miss Sturgeon said: "My message to John Major is Scotland's voice deserves to be heard in whatever way the Scottish people choose, and voting SNP means Scotland's voice will be heard more loudly and strongly at Westminster than it has ever been heard before."

But former Tory Foreign Secretary William Hague backed Sir John's intervention.

He said: "I think John Major is absolutely right to say what he is going to say in his speech today and to point to the danger of people who want to break up the United Kingdom in effect running the United Kingdom, if they hold the balance of power in Parliament.

"That's not talking up the Scottish National Party.

"Voters across the


United Kingdom have to be aware of how serious this situation is, how serious this threat is, that it could actually happen."

But in a sign of Tory jitters about the campaign, Lord Tebbit suggested the focus on the SNP was a distraction.

The former Tory Cabinet minister said: "I think it's a huge scare tactic against Labour and whether the particular seat in the House of Commons is occupied by a Labour member or an SNP member perhaps it's not a great difference.

"Having bungled the Scottish referendum, it seems pointless to just irritate Scots by shouting at them from Westminster - the English are irritated into voting for Ukip, by being shouted at from Westminster - and the Scots are irritated similarly."

He said "the risk to the union comes from the SNP, not from anyone else".

## SNP 'could overcome 40-seat Tory majority', claims Sturgeon

Scottish nationalists could prop up a minority Labour administration even if Ed Miliband's party ends up with 40 fewer MPs than the Conservatives after the General Election, SNP leader Nicola Sturgeon has said.

Ms Sturgeon said that if David Cameron could not command a majority in the House of Commons dominated by "anti-Tory" parties then he will not be able to form a government, even if Conservatives are by far the largest single party.

Her comments came as Labour slipped below 30% in a mainstream opinion poll for the first time in the election campaign, taking 29% to the Tories' 33% in a

Survation survey for the Daily Mirror which could see Mr Miliband's party trailing by 25 MPs or more if repeated on May 7.

The developments came as independent economic analysts from the Institute for Fiscal Studies (IFS) said that there were "genuinely big differences" between the tax and spend policies of the major parties, which could see "substantial" cuts to public services under a Tory government which eliminated the deficit, while Labour would squeeze services less but allow borrowing to remain as high as £26 billion.

As expectations remained high of a hung Parliament with a contingent of as many as

50 SNP MPs after May 7, Ms Sturgeon was asked on BBC2's Newsnight whether her party would be ready to prop up a Labour government if the party had fewer seats than the Conservatives. She replied: "Yes. Even if the Tories are the largest party, if there is an anti Tory majority, my offer to Labour is to work together to keep the Tories out."

Asked if this would remain her position even if Mr Cameron had 30 more MPs than Mr Miliband, she confirmed: "If there is an anti Tory majority, yes, that's what I've been saying all along - I'm not sure why there's any confusion about it - that we would work with Labour to stop the Tories

getting into Downing Street."

And if the margin was as wide as 40 MPs, she said: "If they can't command a majority they can't be a government, that's the basic rule of how governments are formed I'd have thought."

Ms Sturgeon rejected the IFS finding of a "significant disconnect" between the SNP's claims to be an anti-austerity party and plans that implied it would be spending less than Labour by 2019/20. The IFS had not credited the SNP with any of the revenues it intends to raise from tackling tax avoidance and had assumed borrowing at 1.4% of GDP for 2019/20, when the SNP wanted it at 1.6%, she said.

### 'real choice'

The IFS accused the major parties of keeping voters "in the dark" by spelling out only the "broad outlines" of their tax and spend plans following the May 7 poll, though it singled out the Liberal Democrats for being more transparent than their rivals about their intentions.

The thinktank's deputy director Carl Emmerson said: "There are genuinely big differences between the main parties' fiscal plans.

"The electorate has a real choice, although it can at best see only the broad outlines of that choice."

Conservatives say they would eliminate the deficit by 2017/18 and start to run a surplus while Labour says it will reduce the deficit each year and balance the books "as soon as possible" during the five-year term.

# England and Sunderland footballer Adam Johnson charged with child sex offences

## Police warn public against identifying victim on social media

**ENGLAND football star Adam Johnson has been charged with child sex offences after being accused of having sex with a 15-year-old girl.**

The Sunderland midfielder was charged on Thursday with three offences of sexual activity with a child under 16 and one of grooming, Durham Police said.

It comes after the 27-year-old arrived at a police station to discover his fate after being accused of having sex with a 15-year-old girl.

### 'rumour and speculation'

Johnson, answered bail at Peterlee police station in County Durham, five miles from the £1.5m mansion in the leafy village of Castle Eden where he was arrested by police probing the schoolgirl's claims on March 2.

Johnson, dressed in a navy track suit and white trainers, arrived in a grey range rover with his Manchester-based lawyer.

The girl at the centre of

the allegations cannot be named for legal reasons.

Following Johnson's arrest the girl's mother said: "My priority is my daughter, I don't want to say anything else."

Police had to warn social media users not to identify the alleged victim.


A spokesman said: "Durham Constabulary is aware this investigation has resulted in considerable rumour and speculation, much of it on social media and in relation to the victim.

"This has caused distress to the victim and her family and is very unhelpful while we still have a number of actions to carry out as part of our inquiries.

"We stress again the warning we have already given, that anyone who publishes anything which may identify the victim of a sexual offence is committing a criminal act and will be dealt with accordingly."

## On one's birthday, Her Maj celebrates quietly...with some chocolate cake

On Tuesday, April 21, Queen Elizabeth II celebrated her 89th birthday. With a rare week off from official engagements, the royal spent the day quietly celebrating with family at Windsor Castle.

Her Majesty still went through her daily quota of government red boxes, as she does every day except Christmas Day, but was otherwise able to relax with the Duke of Edinburgh with her favorite indulgence, chocolate cake.

The Queen normally spends weekdays at Buckingham Palace during working periods of the year, but has decided to stay at Windsor, which she prefers, where she personally opened a selection of birthday cards sent to her from around the world.

Like the Duke of Edinburgh, the Queen dislikes the idea of anyone "making a fuss" over her birthday, this was a low key affair – and the fourth successive year that the Queen has celebrated her

birthday privately at Windsor, though two of her previous three birthdays were on a weekend.

According to Queen Elizabeth II's former personal chef, Darren McGrady, the queen loves to celebrate her birthday in the same way we do: with chocolate cake. And not just any chocolate cake – the same recipe she's requested for the past 80 years, which reportedly dates back to Queen Victoria's chef.

The Queen will be back in action on Saturday,

when she attends a service at Westminster Abbey to mark the centenary of the Gallipoli campaign in the First World War.

A 41-gun salute will be fired by the King's Troop Royal Horse Artillery from Green Park in central London at midday to

mark the occasion.

The Queen's official birthday is marked by Trooping the Colour in June.

## British schoolboy charged with Aussie bomb plot

### ■ 14-year-old 'planned to bomb Australian WW1 event'

A 14-YEAR-OLD British boy arrested in connection with an alleged plot to blow up spectators at a First World War celebration in Australia is to be charged with terror offences, the Crown Prosecution Service has said.

The teenager stands accused of two offences of inciting terrorism overseas - inciting an attack on an Anzac parade, and inciting another person to behead someone in Australia.

The boy, who cannot be

named for legal reasons, was arrested in Blackburn and was scheduled appear at Westminster Magistrates Court on Friday.

Police conducted a search of a property on April 2 and uncovered communication between a teenager in Blackburn and a man in Australia.

Greater Manchester Police (GMP) said they are working with authorities in Australia, where the planned commemoration will take on Saturday.

Australian police

confirmed a link between the arrest of the boy in Lancashire and their counter-terrorism operation.

### warrant

Officers there arrested five men on Saturday and two remain in custody.

The plot sparked a major anti-terror operation after authorities said they had uncovered a "credible terrorist threat".

In a statement released Thursday evening, GMP said: "A teenager has been charged following an

investigation by the North West Counter Terrorism Unit and Lancashire Constabulary.

"A 14-year-old boy who can't be named for legal reasons has been charged with two counts of inciting another person to commit an act of terrorism overseas.

"On April 2 2015, following the examination of a number of electronic devices, the North West Counter Terrorism Unit and officers from Lancashire Constabulary executed a warrant at an address in Blackburn, Lancashire.

"As part of this investigation, officers from North West Counter Terrorism Unit uncovered communication between a

teenager in Blackburn and a man in Australia."

Anzac Day is one of Australia's most important national celebrations, which falls

on April 25.

It marks the first significant battle involving the armies of Australia and New Zealand at Gallipoli.

### £40k reward for 40-year-old murders

The Metropolitan Police have offered a £40,000 reward for information on the linked murders of a bunny girl and a teenager forty years ago.

Eve Stratford, 22, who worked at London's Playboy club, was found with her throat slashed in her home in Leyton, east London, in March 1975.

Six months later, Lynne Weedon, 16, died after being attacked and raped near her home in Hounslow, west London.

A link was made in 2006 after matching DNA was found on the victims.

Investigating officer Detective Chief Inspector Noel McHugh said: "I firmly believe there is someone out there who has information about who carried out these murders.

"It's inconceivable the killer of Eve and Lynne has kept the perfect secret for 40 years."

# London man held over Wall Street's 2010 £500bn 'flash crash'

■ Lone trader Navinder Singh Sarao "significantly responsible" for causing the May 2010 market crash which saw the Dow Jones lose almost 1,000 points in a matter of minutes

A British man who allegedly helped to trigger a £500bn US stock market crash by manipulating financial markets on a massive scale from a suburban London semi, has been arrested at the request of US prosecutors.

Navinder Singh Sarao, 36, is accused of fraudulently making £27 million by using computer programmes to create fake trades on markets linked to the Chicago Mercantile Exchange.

US investigators say he was a major contributory factor to the so-called "Flash Crash" of May 6, 2010, when hundreds of billions of dollars was wiped off the value of the Dow Jones Industrial Average in just five minutes.

The US Department of Justice (DoJ) and the US Commodity Futures Trading Commission (CFTC) have simultaneously

charged Navinder Singh Sarao with manipulating the financial markets, alleging he made more than \$40m (£26.7m) from his activities over a period spanning more than five years.

## extradition

Mr Sarao, who ran his own one-man day trading company, was arrested at his parents' home in Hounslow, west London, on Tuesday.

He now faces extradition to the US after separate criminal and civil charges were filed against him for illegally manipulating the markets.

Neighbours of Mr Sarao in Hounslow, west London, said he was married with two children and lived quietly in a house opposite his parents' home, where his company Nav Sarao Futures was registered.

His parents, Nachattar Singh Sarao and Darshaw Kaur Sarao, bought the

house in 1982 and have lived there ever since. Apart from a well-maintained front garden with a brick wall around it, the pre-war semi is no different from any other in the street.

One neighbour said: "They are a quiet family, they say hello and goodbye, but that's about it. The parents both work and their son lives opposite with his wife and two daughters. No-one has ever suggested they are wealthy."

## 'significant factor'

Aitan Goelman, director of enforcement at the CFTC, said Mr Sarao was "extremely active" in the market ahead of and during the flash crash, which occurred on May 6, 2010.

"His conduct was at least significantly responsible for the order imbalance that in turn was one of the conditions that led to the flash crash," Mr

Goelman continued.

Mr Sarao was "a significant factor in market imbalance," he went on. "Market imbalance was one of the chief conditions that allowed the flash crash to occur."

On the day of the crash the Dow Jones Industrial Average fell by 998.5 points within a 45 minute

period, before recovering to end the day down 348 points. Ripple effects were felt on markets around the world, including in the UK.

Although a final figure of the impact of the crash has not been calculated, it is estimated that hundreds of billions of pounds was wiped from the value of

companies listed in the US and around the world.

The alleged actions of Mr Sarao are in part an example of the perils of high-frequency trading, a type of accelerated computer-based trading which has been blamed for increased volatility in the markets since the financial crisis.

## Paltrow files for divorce

A year after announcing their split, Gwyneth Paltrow has filed for divorce from Chris Martin, the Coldplay frontman. The actor cited "irreconcilable differences" as the reason for the separation.

The couple first announced their split in March 2014, declaring that after 10 years of marriage they would be "consciously uncoupling". According to the divorce papers, however, the pair had been separated for

almost a year before that announcement.

At the time, the couple put out a statement which read: "We have come to the conclusion that while we love each other very much we will remain separate. We are, however, and always will be a family, and in many ways we are closer than we have ever been. We are parents first and foremost, to two incredibly wonderful children and we ask for their and our space and privacy to be

respected at this difficult time."

Paltrow is to seek joint custody of the pair's two children, Apple and Moses.

In other Coldplay news, the band are reportedly working on the follow-up to 2014's Ghost Stories. A Head Full of Dreams will be the group's seventh album. The band are currently one of several rumoured to be headlining Glastonbury in the festival's showcase Sunday night slot.

# Tube stop rebranded for water company

■ Canada Water becomes Buxton Water - just for Sunday's Marathon

A Tube station is to be named after a sponsor for the first time - but just for one day.

In a deal worth £110,000 to Transport for London (TfL), Canada Water on the Underground's Jubilee line is to be called Buxton Water - on the day of the London Marathon on Sunday.

The Derbyshire-based company is one of the Marathon's sponsors, supplying the water for the thousands of runners in the 26-mile event.

Water will also be laid on for passengers at the station where the familiar circular roundels will have a new name for the day.

With the change only lasting 24 hours, Tube maps are not being

altered and the name outside the station is not being changed, nor is the name being changed on the London Overground station being served by Canada Water.

Station announcements and information on screens at other Jubilee stations will advise passengers of the name change.

TfL commercial development director Graeme Craig said: "For one day only, customers will see Canada Water station transformed into Buxton Water station as part of their support of the Virgin Money London Marathon.

"This is a significant deal and the revenue will be reinvested back into our network for the benefit of our customers."

Sponsorship of Tube stations is something that TfL has been looking at. Such a move was suggested by Conservatives on the London Assembly in 2013, although the cost of changing names and then, eventually, changing them back again is seen as a major stumbling block.

Mick Cash, general secretary of the RMT transport union, said: "This is the thin end of a very long wedge and opens the door for those with corporate power

and money to rip up the transport map of London and it fits the current ethos of smashing up ticket offices and replacing them with expensive retail outlets.

"The whole drive on our transport services is to allow private greed let rip as the principles of public service are sacrificed along with jobs and safety."

## Former Scotland skipper banned for drink driving

EX-SCOTLAND football captain Colin Hendry was banned from the road on Wednesday for 17 months after dropping his legal battle against a drink driving charge.

Hendry, 49, had admitted drinking but requested a "special reasons" hearing saying the amount he drank

was at odds with breath test readings.

But he was sentenced at once after Blackpool magistrates were told tests proved he was way over the limit.

Hendry gave a reading on February 21 of 63 micrograms per 100 millilitres of breath - the legal limit is 35 micrograms.

Lawyer Gwyn Lewis said Hendry apologised for wasting time but "will never understand how it is we came to the figure of 63".

He was fined £110 and ordered to pay £200 prosecution costs and a victim surcharge of £20.

His ban may be cut after he takes a driver improvement course.



# Maggie: how easily things fall apart

Exclusive interview with author Marie Maxwell and a review of her novel about a 15-year-old girl who learns what family really is



Rating: ★★★

**"It was only after it was finished and the initial draft had gone to my agent that there was a celebrity court case in UK covering a case with a sleazy music manager who was very much the same as the one in the book,"** says *Maggie* author Marie Maxwell. "It was a bit spooky. I was pleased it occurred after the book was written."

The book is set in the late 1960s and its central

character, Maggie Wheaton, is a teen who will soon turn 16. Confident and bright, yet emotional as most teens are, she lashes out at those who have her best interests at heart. She is impetuous and thinks there's always something better for her. Maggie's well-off parents had her late in life are old fashioned. A terrible accident on Maggie's birthday will change her

life forever.

*Maggie* captures the age of first infatuation and its effects. The characters struggle with the repercussions of past mistakes. The story is so in Maggie's head that other characters can seem neglected. Another point-of-view could have opened up the story. What are others in the book thinking and why? And while it's set in the 60s, the story doesn't plant enough historical references to root it there. It feels very modern.

*Maggie* is the third book in series. The first two are *Gracie* and *Ruby*. "I did a lot of overall research for all three sagas," says Maxwell. "But, *Maggie* needed less because I can remember quite a lot about the 60s. The 40s and 50s research was so engrossing I learned far more than I actually

needed. My first seven books [under her real name Bernardine Kennedy] didn't need as much research because they are more current and cover situations and circumstances I know about. The joy of research in the 21st century is the Internet. I especially loved the access to old photos and newsreel which really gave me the feel of the times I was writing about."

*Maggie* is Maxwell's tenth published book. "My first books were contemporary sagas which were quite gritty," says Maxwell. *Ruby*, *Gracie* and *Maggie* are gentler, post-war sagas.

Before writing books, Maxwell wrote many features for magazine and newspapers. "My writing career is actually quite long and varied. I've written about most things

over the years, eventually specialising in travel features which was great fun. I got to travel to nice places all over the world which was perfect for me because after being brought up abroad I have always suffered from itchy feet."

Maxwell says that that no matter how much you plan and plot a book and however much work you put into figuring out the storyline, the end result is always unpredictable. "The characters will change personality. The good guys can become the baddies or even die and the ending will be a bit of a surprise to me."

Maxwell is currently writing two books, a Bernardine Kennedy contemporary, and a fourth book, *Fay*, to follow on *Maggie*.

Maxwell lives in Southend-Sea, at the



# Henderson signs new five-year deal

## Football Shorts

Liverpool midfielder Jordan Henderson has signed a new five-year deal, worth £100,000-a-week.

It ends months of talks between the parties, with the ex-Sunderland player committed to the club until 2020.

"There has been talk about it for a while now," the 24-year-old told the club website.

"It's brilliant news for me to commit my future to this football club. I think, over the next few years, we can challenge and start winning trophies."

Liverpool's hopes of winning a trophy this season ended when they lost to Aston Villa in their FA Cup semi-final last

Sunday. "We've improved massively over the last few years, and I think the next phase for us is to start challenging for titles and trophies as well," added Henderson.

Liverpool also tied down striker Daniel Sturridge and midfielder Philippe Coutinho to new deals earlier this season.

Manager Brendan Rodgers said: "The owners are committed to creating a team that can grow, improve and ultimately win together."

"We have seen some very important contract renewals this season and I'm confident, under [chief executive] Ian Ayre's stewardship, we will see further

commitments made and more exciting talent secured and added to our squad."

England international Henderson joined Liverpool from the Black Cats in 2011 in a deal worth around £20m.

With Steven Gerrard leaving at the end of the season for Major League Soccer side LA Galaxy, Henderson is among the favourites to be the captain.

The vice captain has scored seven times in 55 games for Liverpool and England this campaign.

•Southampton boss Ronald Koeman has held a team meeting to warn his players not to let transfer speculation distract them in the final month of the season.

Koeman spoke to his squad on Thursday following a national newspaper story linking Saints midfielder Victor Wanyama with a summer move to Arsenal.

Wanyama dismissed the story and Koeman himself said it had no foundation.

"From Victor's part it is all rubbish and he never said that. I believe that," Koeman told BBC Radio Solent.

"We spoke together with the players. It's always at the end of the season there are a lot of rumours about contracts and the future of the players."

"We need our focus to be on the final five games. That is more important and that was the message to the players this morning."

"We want to finish the season how we started, playing good football with a lot of points."

•Aston Villa midfielder Jack Grealish has been warned about his off-field behaviour

after he was photographed apparently taking nitrous oxide.

Year-old pictures of Grealish, 19, seeming to take the legal high - known as laughing gas - from a balloon were printed in a newspaper on Thursday.

"I spoke to Jack first thing this morning as he came in," said manager Tim Sherwood.

"I explained to him his behaviour can't be tolerated."

"We can't condone that behaviour," Sherwood said of Grealish, who has not been fined for the incident.

"He is now in a responsible position as a professional footballer, he's got to make sure it won't happen again, he's assured me it won't."

The Villa academy

product has made 18 first-team appearances and was a pivotal figure in both goals in their 2-1 win over Liverpool in the FA Cup semi-final on Sunday.

•Tottenham boss Mauricio Pochettino joked that striker Harry Kane should buy his team-mates dinner after reaching 30 goals for the season.

Kane, 21, became the first Spurs player to reach the landmark since former striker Gary Lineker in 1991-92 after scoring in the 3-1 win over Newcastle.

Pochettino said: "Congratulations to him because he deserves this moment."

"I think he needs to pay for a dinner this week for his team-mates. The team work a lot and try to help him score."

# Rodgers: Nobody better than me for Liverpool job

■ Embattled boss fights back after another trophyless season casts new doubt over his future

Liverpool manager Brendan Rodgers says there is "nobody better" than him to lead the club and "very much" expects to be in charge at Anfield next season.

The Reds are fifth in the Premier League and lost to Aston Villa in the FA Cup semi-finals last weekend.

Rodgers, 42, is the first Liverpool boss not to win a trophy inside three seasons in charge since the 1950s.

"Do I expect to be manager next season? Very much so, yes. I don't think there's anyone better," Rodgers said.

"That's the reality of how I see it. Three months ago I was a tactical genius, performing to a good level.

"We lost a couple of games, some important games, and now you're not so good. But that is football, that's what will happen, people will speculate.

Rodgers succeeded club legend Kenny Dalglish as Liverpool manager in the summer of 2012 and guided the club to runners-up spot in the Premier League in his second season.

Outgoing Borussia Dortmund manager Jurgen Klopp has been linked with Rodgers' job, but the Northern Irishman says he is unaffected by the speculation.

"There will always be people linked with this job because it's such a great club," Rodgers added.

"In my time alone there have been lots of names mentioned.

"This is a club that's worldwide so there's absolutely no problem, it's something that happens all the time if you lose a couple of games.

"We've had former managers linked here with the job before and

that will continue for however long I'm here - whether you're doing good, bad or indifferent."

"Their representatives are speaking to the club but no update on them," Rodgers said.

"The likes of Jordon Ibe and Raheem Sterling are very important players for us and the club are working very hard behind the scenes to make sure we sign these players.

"It's very important you nail them to the club and that they're here for the best part of their careers. Raheem's representatives will speak to club and we hope to get that sorted."

"There was a lot of money spent last summer and a lot of players coming in. If you take the emotion out of last weekend, this was a team that probably overachieved last year," Rodgers explained.

"We brought in some

Holland and Ajax legend Ronald De Boer believes Depay's

relationship with former Dutch coach Van Gaal will ultimately swing the deal in United's favour.

"I don't want to say which club is more suitable for him," said De Boer.

"But if he goes to United he knows there's a Dutch coach there in Van Gaal who knows him from the World Cup.

"That's an advantage. He's one of the biggest talents in Europe - he has everything."
