SNP 'planning new independence vote'

■ Alex Salmond's former deputy claims party members will insist another referendum be 'first line' of 2016 Holyrood manifesto

The SNP will propose another independence referendum in its Scottish election manifesto, the former deputy leader has said amid fears over the party's influence on Ed Miliband after the election.

Jim Sillars told an English broadsheet this week that party members will demand a promise to hold another vote on independence will be the "first line" of the SNP's 2016 Holyrood manifesto.

He said any other move would be "astonishing" and likely trigger a backlash from the tens of thousands of new members who joined after Scots voted to stay in the Union last September.

Reacting to the comments, Nicola Sturgeon indicated the SNP could pledge a second referendum in principle in a future manifesto but said it would not necessarily trigger an immediate vote.

The SNP leader also repeatedly failed to rule out putting a pledge in next year's manifesto after being grilled on Mr Sillars's comments during First Minister's

Questions.

It will increase suspicion that the SNP will use its influence in Westminster after the election to break up the UK and add credence to Tory warnings over the impact of an Labour-SNP pact.

It comes as an Ipsos MORI poll indicated the SNP will win every seat in Scotland with more than half the country on course to back the Nationalists on May 7.

Mr Sillars became the first major SNP figure in the campaign to declare the party will propose a rerun of the independence vote next year.

"I would anticipate that a lot of people will be looking to next year's election, 2016 for the Scottish Parliament, to have a commitment for a mandate to hold a referendum when it suits us," Mr Sillars said.

"That is the key thing, no timetable attached. But a commitment in principle? No question, I think that is bound to be the case."

He added: "I can't see a membership of 100,000 which came in on the independence issue not demanding that in the manifesto. It would be astonishing if you joined the SNP because you desire independence as soon as you can possibly get it and not expect it to be in the manifesto."

Asked if there was any doubt the SNP would promise another independence vote next year, he replied: "Oh no. I can't see how it can be avoided, frankly."

While making it clear he did not speak for the leadership, Mr Sillars is one of the party's best known figures and continues to hold considerable clout with

members. He is often described as Alex Salmond's former mentor and served under him as deputy leader of the party in the early 1990s. Mr Sillars's comments back up Labour and Tory

claims that the SNP is secretly planning another independence vote despite promising last year's referendum was a "once in a generation" decision.

Ms Sturgeon has largely stopped discussing independence publicly and portrayed the SNP as a party that can be trusted governing in the UK-wide interest, offering England a "hand of friendship".

SNP is 'openly racist towards the English', claims Farage

■ 'All the talk about extremism within British politics is pointed towards Ukip when there are others who are far more guilty,' says Ukip leader

The Scottish National Party is "openly racist" towards English people, says Nigel Farage.

The leader of the UK Independence Party made the attack on the SNP and its supporters during a visit to Hartlepool in the north east of England on Wednesday.

He said: "The SNP are openly racist. The anti-English hostility and the kind of language that is used about and towards English people is totally extraordinary."

Mr Farage pointed to his treatment on a campaign stop in Edinburgh last year when he was locked into a pub by the police for his own protection before being rescued after being surrounded by SNP supporters.

'worst person'

He told ITV News: "If my supporters behaved in the way that some of those pro-independence supporters behaved in the referendum I'd have been painted out to be the worst person that had been seen for 70 years in

British politics.

"I was surrounded by people in the street shouting racist anti-English comments.

"When I say that I don't think we should have an open door to Poland, Latvia and Lithuania I'm accused of being racist and yet when it's the Scots being rude about the English you don't think it is.

'ironic'

"The fact is Ukip is a non-racist non-sectarian political party and we've got more members of black and ethnic minority standing for us than the Green Party or the Liberal Democrats. We're an all-embracing party.

"I think the one I blame is [former SNP leader] Alex Salmond. When I was attacked by a group of thugs in the street in Edinburgh with the most extraordinary anti-English sentiments being shouted, when Salmond was asked whether he condemned that behaviour he didn't."

Mr Farage said that the current SNP leader Nicola Sturgeon had not done

anything to stop the racial abuse of English people.

He said: "She hasn't stop anything to stop it. I haven't heard her say anything to encourage it."

Earlier he claimed that Ukip's support was being underestimated by pollsters because many were "sky kippers" who were reluctant to admit they were voting Ukip.

Condemning the "establishment" for saying that Ukip is full of "racist, bad, nasty, inward looking, backward looking people", he said this was why "people are actually frightened on telephone polls to say what they really think".

Later, speaking to around 100 supporters in a Hartlepool hotel, he appeared to lose his temper when two reporters asked again whether Ukip was a racist party.

He said the questions were "wholly unjustified, grossly unfair", adding that they led to "people out there who agree with Ukip to almost feel shy about talking about it such is the level of demonization".

told The Telegraph how the party could justify a second referendum after the election by playing on the idea of a betrayal on promises by Westminster.

"If we can achieve the kind of policy objectives we want to see, particularly around the anti-austerity and the devolution of powers, then that is fantastic. If they backslide then the dynamics change," the SNP source said.

"If they don't deliver what they promised last year, if they don't deliver the maximum devolution the Scottish people expect, then the Scottish people

themselves might begin to say 'hold on a minute, do we want another referendum?'"

When Mr Sillars was asked if he thought the "overriding drive" of Ms Sturgeon's leadership remained winning independence, he replied: "The desire for Scottish independence does not go away. It remains central to the whole political personality of the SNP and its leadership."

Ms Sturgeon was challenged by Kezia Dugdale, Scottish Labour's deputy leader, during First Minister's Questions at Holyrood about whether she agreed with Mr Sillars.

"I've got the greatest respect for Jim Sillars but the clue is in the title: former deputy leader of the SNP," Ms Sturgeon

said.

However the SNP leader repeatedly refused to rule out putting a second referendum in next year's manifesto for Scottish elections, saying it was up to the electorate.

Ms Sturgeon also indicated the SNP could pledge support in principle for another independence vote but the timing of a referendum would be up to the voters.

She said: "If the SNP ever does propose in a manifesto a second referendum that, in and of itself, does not bring about a referendum."

"People in Scotland first have to vote for that manifesto and give the SNP sufficient numbers in this parliament to get the legislation through. That's democracy."

5 days to go: Tories edge ahead but it's still anybody's race

In what is shaping up as the most unpredictable General Election in a generation, the Tories have edged into a narrow lead but up to ten million voters have still not made up their minds.

According to the pre-election poll published Friday by leading UK pollsters Ipsos MORI, the Conservatives are now five points in the lead with 35 per cent support, compared to 30 per cent for Labour.

With just days to go before Thursday's vote, competition is intensifying between the two parties. They have been neck-and-neck in most polls since the start of the year, but recently things have tipped more in the Conservatives' direction, with seven of the 10 main pollsters giving Cameron a lead based on their most recent surveys.

The outcome of this election has been unusually difficult for anyone to predict, partly because many voters are now choosing to support once marginal parties, such as the SNP and Ukip, instead of the two big parties.

"In Scotland Labour will pile up votes in second place in an awful lot of seats but win almost no seats, so their vote nationally will become much less efficient than it has been," said Philip Cowley, professor of parliamentary government at the University of Nottingham.

Still uncertain

Despite the Conservative party's

current lead, it is still difficult to make a definite prediction, according to the head of political research at Ipsos Mori. This is because of the UK's first-past-the-post voting system, which makes it harder for the Conservatives to win.

Labour could take charge with a lead of between 3.5 and 5.5 points, whereas the Conservatives would need between 8.5 and 10.

But in a development which will give both major parties hope, it has emerged that four in ten of those who plan to vote say they are totally undecided or could switch parties.

When those who say they are likely to vote but undecided are included, a startling 41 per cent of ballots – more than ten million – are up for grabs.

"There is still plenty left to play for," said Tom Mludzinski of polling company ComRes. "In this election, like no other in recent memory, even small shifts could be significant to the final outcome."

Keith Harris dead: Tributes pour in for Orville the Duck ventriloquist

■ Entertainer enjoyed greatest fame in 1980s before falling on hard times

Fans, fellow entertainers and politicians have paid tribute to Keith Harris, the ventriloquist famous for his act with a radioactive-green duck called Orville, following his death.

Harris, 67, who had been diagnosed with liver cancer, entertained generations of children with Orville, the nappy-wearing orphaned duck, and a monkey called Cuddles.

At the height of his fame, Harris was a regular on Saturday night television and put on private performances at birthday parties for Prince William and his brother Harry.

His sentimental 1982 single with the mournful Orville, *I Wish I Could Fly*, was a top five hit and sold more than 400,000 copies.

But Harris claimed to have lost £7m because he couldn't read contracts properly due to severe dyslexia and he continued to work up until his death. He was due to appear in a pantomime in Crewe later this year.

Robert C Kelly, Harris's agent, said the entertainer was first diagnosed with cancer in 2013 and became ill again in January.

Mr Kelly said: "Keith was not only a technically great ventriloquist, he was also a gifted mimic and an extraordinarily funny man both on stage and off.

"Perhaps even rarer than that in showbiz, he was a thoroughly decent man, a great friend and a wonderful father and husband."

Mr Kelly said Orville would now be retired. "There are no plans for Orville. That's the end."

Sajid Javid, Culture Secretary, said: "Very sad to hear that Keith Harris has died after a battle with cancer. Brought joy to my childhood."

With fellow entertainers including Keith Chegwin, Les Dennis and Aled Jones tweeting their sadness, "Keith Harris" became the number one trending topic in the UK.

Chegwin wrote: "So sad. A great entertainer and all round nice man

Keith Harris has passed away. Best wishes to his family at this sad time. RIP x."

Harris, who began his career playing summer seasons at holiday resorts, found fame through appearances on television variety shows.

He sank into depression when his 80s fame subsided but later re-connected with his audience, touring student unions with an adult-themed show, *Duck Off*.

Harris turned down a chance for renewed fame late in his career when he rejected an offer to appear on the sitcom *Extras*, claiming that Ricky Gervais's script was "pure filth". The role ended up going to Chegwin.

A metal plate was inserted into Harris's arm due to the weight of holding Orville over 40 years. However with television executives turning down his proposals for a new series with the duck, he became a regular at Butlin's to make ends meet.

Tugboat raid nets Britain's biggest-ever drugs bust

Britain's largest-ever drugs bust uncovered cocaine worth an estimated half a billion pounds hidden aboard a tug boat, it has been revealed.

The National Crime Agency (NCA) - dubbed "Britain's FBI" - confirmed more than three tonnes of the Class A drug have been found hidden on the vessel which was boarded by the Royal Navy off the coast of Aberdeen last week.

The ocean-going tug, the MV Hamal, was intercepted in the North Sea by the Royal Navy frigate HMS Somerset in a joint operation with the NCA and the Border Force.

John McGowan, senior investigating officer for the NCA, said: "The search of this vessel has been lengthy and painstaking, undertaken by hugely skilled specialists working in difficult conditions.

"The result is this massive discovery - believed to be the biggest single Class A drug seizure on record in the UK, and likely to be worth several hundred million pounds."

The Border Force cutter Valiant was also involved in the operation about 100 miles east of Aberdeen on Thursday last week.

An NCA spokesman said the cocaine had an estimated total weight in

excess of three tonnes with a potential street value of more than £500 million.

The seizure smashed the record for the largest-ever haul of illegal drugs found by the authorities.

Previously, the record was held by the discovery of 1.2 tonnes of cocaine in a luxury yacht at Southampton in 2011.

Officials said that incident, aboard the 65ft pleasure cruiser, the Louise, involved drugs with a street value of £300 million.

The nine-man crew of the Hamal, all Turkish nationals aged between 26 and 63, have been charged with drug trafficking offences.

McCanns win £358,000 libel payout

■ Former cop claimed couple had faked Maddie's abduction in best-selling book

A Portuguese court has awarded the parents of missing Madeleine McCann damages of £358,000 after a libel case.

Kate and Gerry McCann sued ex-police chief Goncalo Amaral, who led the search for their daughter, following claims he made about them in his book.

Madeleine went missing while on holiday in May 2007 and Mr Amaral had suggested the couple had faked her abduction.

The McCanns said they were "delighted" with the ruling but wanted to emphasise the case had never been about money.

In a statement issued by their spokesman Clarence Mitchell, they said: "It was entirely focused on the effect of the libels on our other children and the damage that was done to the search for Madeleine."

The former police officer can appeal against the ruling.

'Anxious and fearful'

In *The Truth Of The Lie*, Mr Amaral alleged Madeleine had died in the family's holiday apartment in Praia de Luz in the Algarve, and that her parents had simulated her abduction and hidden her body.

The McCanns, from Rothley in Leicestershire, said the claims exacerbated their anguish and discouraged people from coming forward with information after Madeleine disappeared.

Madeleine went missing in the Portuguese holiday resort of Praia da Luz, aged three.

Mr Amaral, who initially headed the

inquiry into Madeleine's disappearance, was taken off the case in October 2007.

His book, published in 2008, has been a bestseller in Portugal.

The McCanns were originally seeking 1.25m euros (almost £900,000) in damages from Mr Amaral, his publisher and a company that produced a documentary based on his book.

In a written verdict, a court in the Portuguese capital Lisbon ruled Mr Amaral should pay Mr and Mrs McCann 250,000 euros each in damages, plus interest in excess of 100,000 euros (£71,500).

The court also barred Mr Amaral and his publisher from selling the

book or issuing further editions. It also barred the producer of the film from selling the rights to broadcast or distribute it.

During the trial, Mrs McCann told the court that when she had first found out about the allegations she was "quite desperate because of the injustice I felt towards my daughter and our family as a whole".

"It was very painful to read and I also felt anxious and fearful because of the damage I felt it was doing here in Portugal," she said.

Portuguese authorities dropped their investigation into Madeleine's disappearance in 2008, but Scotland Yard started a

review in May 2011, after Prime Minister David Cameron responded to a plea from the McCanns.

In 2013, the Met Police opened a formal investigation, known as Operation Grange, which remains ongoing.

In June 2014 police officers used dogs to search several sites in the Praia de Luz resort, as well as "ground penetrating radar" to look for disturbed earth, but their searches did not yield any results.

In their statement, the McCanns said: "A lot has changed in the six years since we launched the action and we are pleased that there is still an active investigation in both Portugal and the UK."

Former Soviet emigrant named Britain's richest man

LONDON-BASED tycoon Len Blavatnik has been named Britain's richest man with a £13.17bn fortune, according to the 2015 Sunday Times Rich List.

The Ukrainian émigré, who moved to the US as a student in the 1980s before basing himself in Britain during the 2008 financial crisis, has a range of holdings from metals and oil to music publishing and digital media. He is best known as the owner of Warner Music and owns a £41m home in Kensington Palace Gardens. He has also donated £75m to Oxford University to found the Blavatnik School of Government.

He takes the top spot from brothers Sri and Gopi Hinduja, now worth £13bn.

The total wealth of the richest 1,000 individuals and families in Britain has more than doubled in the last 10 years to £547bn, the survey reported.

The Queen, who topped the first list in 1989, has dropped out of the top 300 for the

first time.

There are now 117 billionaires on the list, up from 104 in 2014, with 80 of them living in London.

More billionaires

The highest risers in terms of wealth are the retail family headed by Galen and George Weston, who run Selfridges and Primark in the UK.

Their fortune has grown by £3.7bn - more than 50% in a year - to £11bn.

Chelsea Football Club owner Roman Abramovich comes in at number 10 on the list with a fortune of £7.29bn, down £1.23bn on last year, while Virgin boss Sir Richard Branson has seen his wealth rise from £3.6bn to £4.1bn, making him 20th richest in Britain.

A personal fortune of £100m is now required to become one of the 1,000 richest people in the country, up £15m compared with last year's entry point of £85m.

In 1997 it took a fortune of just £15m to join Britain's richest 1,000 people.

British cheese: the march towards world dominion goes on...

■ British cheese used to have a bad reputation, but curd nerds all over the globe are now queuing up to buy imported Stinking Bishop and Colston Bassett Stilton

It used to be seen as the poor relation of the fromage world, but British cheese is now winning over curd nerds in New York, Madrid and (mon dieu!) even Paris.

UK cheese exports reached an all-time high last year, according to official figures: a 7 per cent rise in volumes, with the premium end of the market performing particularly well. British cheese specialist Neal's Yard Dairy has seen overseas demand grow rapidly in recent years – as any regular at a Santa Monica Whole Foods market can tell you. Today British artisanal cheesemakers send hundreds of tonnes of product to destinations including Spain, Belgium and Hong Kong, plus more than 200 customers in the US. But it is France where sales are growing fastest – up 20 per cent in the past year.

'quite trendy'

None of this is news to cheese monger Emmanuel Carbone, who works at Fromagerie Beaufils in Paris. The business has been selling British cheese from Neal's Yard for three years, including Montgomery's cheddar, Colston Bassett Stilton, Stinking Bishop and Sparkenhoe Red Leicester, and has seen sales soar.

"There used to be a belief that British cheese is really bad – that it's a plastic style from factories – but that is changing," he says. "If you give people a blind taste of Montgomery's cheddar

they say, 'Wow! Is this Parmesan? When we tell them it's cheddar they can't believe it.'"

Interest in British cheese has snowballed to the point that newspapers and TV shows regularly run reports on the rise of 'fromage Anglais'. "It's definitely quite trendy," said Carbone.

At rival Paris cheese shop Androuet, sales of British cheese grew by more than 10 per cent last year, according to British cheesemonger Paxton & Whitfield, which supplies its nine shops.

Paxton's MD Ros Windsor puts its popularity down to a new generation of globe-trotting cheesemongers, who have lived and worked and Britain, and retain their love of British cheese when they return home to France. She adds that the quality of British cheese can more than hold its own against anything made on the Continent.

'British ingenuity'

"British cheese is right up there at the top of the list. There are some outstanding British cheeses. The French wouldn't eat them if they didn't believe it was jolly good stuff."

Jason Hinds, sales director at Neal's Yard, echoes her sentiments, arguing that Britain has strengthened its position on the global cheese board thanks to the growing expertise of our artisan producers.

He points to cheese makers, such as Will and

Caroline Atkinson of Hill Farm Dairy in Somerset. They make a wrinkly rinded goats' cheese called Charolais. "Ten years ago there weren't many British mould-ripened goats' cheeses, but we've worked with them for seven years now and they really know their stuff," he says. "You won't find a Charolais with that quality of milk and the way they make it in small-scale volumes."

Alex James, the former Blur musician, who now makes his own award-winning cheese on his farm in Oxfordshire, said: "There are now more than 900 different kinds of cheese being made in the UK – way more than France. It's incredible considering during the Second World War and rationing, we only produced one kind. Many recipes were lost back then, but the renaissance of cheese-making in this country is a classic case of British ingenuity and resourcefulness. Many dairy farmers who were unable to get a fair price for their milk diversified into cheese-making."

Hinds adds: "When milk is 21p a litre, which is quite a few pence lower than the cost of production, the only way you've got a viable business is to transform that milk into a value-added product. Cheese is the answer."

Evil grandfather jailed after murdering baby girl...because she was a ginger

AN evil grandfather has been jailed for a minimum of 25 years for murdering his five-week-old granddaughter because she was "ginger" like her father whom he hated.

Mark Jones, 45, was babysitting Amelia Jones when he battered her head and tiny body. A court heard he attacked her so viciously her injuries were like a "car crash".

Jones attacked his granddaughter because he hated her ginger-haired father.

Prosecutor Paul Lewis said: "Mark Jones did not like the fact that Amelia Jones had ginger hair and looked like her father."

Amelia's father Ian Skillern, 41, had finished the relationship with Jones's daughter Sarah, 26, before baby Amelia was born.

Newport Crown Court heard Jones had pressured his daughter to end the relationship because he had an "obvious dislike" for Mr Skillern.

The court heard Jones had "the sole care" of Amelia on the night of November 17, 2012 when her mother was enjoying a rare night out

with her sister at the cinema.

At around 10.30pm Jones made a frantic 999 call – and told the emergency operator he had "gone to make a cuppa" when his granddaughter stopped breathing.

Paramedics and police rushed to the three-bed terraced house in Pontnewydd, South Wales, and found Jones in the lounge standing over the lifeless body of baby Amelia lying on the floor with a fractured skull.

She died in hospital two days later from "catastrophic brain injuries" – just 41 days into her short life.

A post-mortem examination revealed Amelia had suffered multiple fractures to her ribs, legs and skull in the two weeks before her death.

Amelia's mother Sarah was initially arrested along with her father Mr Skillern but the court heard it soon became apparent to police both were innocent.

Sarah told the jury how her father "didn't like" Amelia's dad after she started dating Mr Skillern.

Ms Jones told the court she started dating Mr

Skillern in 2011. She said her father and him would "stay out of each other's way".

She said: "He didn't like him, he didn't like the fact he used go to the pub and drink and he wasn't at home."

The court heard Jones was estranged from his daughter Sarah for most of her life but tried to rebuild their relationship after she was 16.

After his arrest Jones changed his story four times during police interviews.

At first he said Amelia had simply stopped breathing when he left her on the sofa to make a cup of tea.

Jones then changed his story to claim he dropped her on the floor after tripping up on a toy penguin on the floor.

He later claimed a teenage boy visiting the house had accidentally dropped Amelia while trying to use his phone.

But when the teenager told police it was a lie, Jones said he had "blacked out or fainted" while holding Amelia and had fallen to the ground.

Jones, of Pontnewydd, South Wales, denied murder. He was found guilty after a five-week trial.





My Witches of East End series became a TV show and I was able to get a little peek into Hollywood. With this book, I was able to work more closely with the

Disney creative team, and that was really interesting. I told my agent I wanted my next project to be fairytale retellings and that day I went to lunch with my Disney publisher. She asked me to write the prequel to The Descendants, about the teenage children of Disney's biggest villains. It was kismet."

The Descendants of which she speaks is not

the George Clooney movie set in Hawaii, but rather an upcoming Disney Channel original movie broadcasting this summer. The Isle of the Lost is the prequel to this story. What happens to the villains after the happily ever after for the heroes? What if Maleficent had a daughter? What would she be like? Intended for teens, if you love fairy tales and enjoy Once Upon a Time on ABC or the Disney film Into the Woods, you will enjoy reading this. The novel is engrossing, with humor and adventure. La Paz: an easy place to get hooked on the Sea of Cortez

■ If fun on the water floats your boat, you can't do better than this fabulous town on Baja's eastern coast, writes Neil Fletcher

JACQUES COUSTEAU famously described The Sea of Cortez as The World's Aquarium.

The legendary French oceanographer, marine biologist and broadcaster was captivated by the pristine waters between Baja California and continental Mexico, which enjoy one of the world's unique ocean environments, considered by some to be the most biologically rich body of water on earth.

And fortunately for us, it's all just a few short hours away.

Cousteau was not the only foreigner beguiled by the area. John Steinbeck visited La Paz when it was just a sleepy fisherman's village and was so enchanted that he made it the setting for both his 1947 novella, *The Pearl*, as well as his classic travel yarn, *The Log From The Sea of Cortez*.

As a fan of sea life, sailing and Mexico, I had long been intrigued by La Paz and this past Easter finally got it together to take a family trip down there. After a two hour flight from LAX to Los Cabos followed by a 100-mile drive north, the first thing I noticed was that these days the town is anything but sleepy. Its sprawling outskirts now comprise the fourth largest municipality in Mexico, thanks mainly to migrants from the mainland, drawn by its higher-than-average daily wages. But once you've negotiated the gritty outskirts and reached the town's historic seafront, the old magic of the town can still be felt, like a distant echo from Steinbeck's days.

The CostaBaja Resort

We were staying at the

CostaBaja Resort & Spa, sitting just out of town at the northern end of La Paz Bay and part of an upmarket complex which includes the CostaBaja marina. The hotel boasts an open and airy floor plan with a motif that accents the area's marine majesty. Our rooms were spotless and spacious with a modern design that incorporated an enclosed shower in the middle of the room – a nice touch for me but one which required a bit of choreography for our teenage son and daughter, who loved having their own room and the serviceable - but not very fast - wi-fi. Snapchat just won't wait, family trip or no.

The hotel boasts two very good restaurants. Mosaic is a good choice during the day and really hits the spot with a groaning breakfast buffet replete with both local and American choices. We particularly enjoyed the hotel's signature breakfast juice mix of cucumber, parsley and cactus - the perfect eye opener no matter how many margaritas we had enjoyed the night before. And then there is Steinbeck's, the resort's signature restaurant accenting local fish and seafood cooked over a mesquite wood grill. It also boasts my kind of education – tequila lessons no less, where you can enjoy some of the finest examples of Mexico's national drink while savoring lush views of both the adjacent marina and the resort's golf course. Indeed Steinbeck's bar became our nightly retreat for before dinner drinks and instantly joined a small group of my favorite watering holes anywhere in the world.

For those who prefer to wile away the heat of the day at the pool, CostaBaja has a compact but immaculate pool with a swim-up bar, serving inexpensive snacks sourced from local seafood. My kids preferred to decamp to the resort's Beach Club, a short golf cart ride away, (but out of sight of the parents), to enjoy the club's infinity pool and private beach while ordering drinks they could charge to their room. How very grown-up....

Service everywhere at the hotel was prompt, friendly and courteous, and everyone spoke excellent English. Special mention should also go to the resort's lap pool – which was kept at a bracingly chilly temperature and became my preferred way to cool off and burn some calories after a few hours by the pool.

For those visitors who are inclined to separate themselves from the outside world, the CostaBaja resort certainly has everything you need; and the marina right outside the hotel includes two very serviceable restaurants, the Odayaka sushi restaurant and the Marina Azul, where we enjoyed one of the best meals of our visit.

Hangin' with The Griz...

But La Paz is really all about the water. There are some 900 islands and inlets in the Sea of Cortez, with 244 now under UNESCO protection as World Heritage Bio-Reserves and the Isla Espiritu Santo group, which borders the northeast portion of the Bay of La Paz is rightly considered the crown jewel. Giant manta rays, whale sharks, colonies of sea lions, pods

of humpback, blue, sperm, fin and seasonal migrating gray whales are very common sights. Its warm, translucent waters, along with its fishing, scuba diving, snorkeling and kayaking are considered world class and as is so often the case, making the most of it is all about who you know. A quick drive along the town's Malecon (seafront) revealed myriad local operators promising to take you fishing, snorkeling, kayaking or diving, and of course the hotel itself had plenty of options. But we were lucky enough to have an introduction to a larger-than-life American expat whose local expertise turned our trip from enjoyable to truly

memorable.

Mike 'The Griz' Ritz is a towering, bear-like man (hence the nickname) whose love of fishing was spawned when he was just a tyke fishing with his father in Montana. Mike has lived in Baja for 30 years and is a tireless booster for the area. He is best known to outdoor enthusiasts for his TV shows *Adventures South of the Border*, *Chef on the Water* and *Discovering Mexico*, which air on Hunt TV worldwide and MegaCable in Mexico, Alive TV Outdoors and WCTV in the USA. Mike is also a regular host of Baja's FishTalk radio, sharing his unrivaled knowledge of the local conditions, and enjoys taking visitors for

some some of the best fishing they will ever enjoy. Mike is also the proud proprietor of the Mangrove Inn Baja just a couple of hours north at Puerto Adolfo Lopez Mateos on the Pacific side, which offers some of the best gray whale watching spots in Baja during the migration season. (mangroveinnbaja.com)

Mike treated us spectacularly well, filling us in on the best spots to visit, (both on the water and off), and even giving us the services of his boat and his superb skipper Enrique for one memorable day which included swimming with whale sharks in the plankton-rich waters just across the bay from our

hotel. These gentle giants lumber through the shallows at an easy pace, allowing visitors to enjoy their majesty up close and personal for minutes on end. To be within just a few feet of these wonderful creatures was an experience neither myself nor my children will ever forget.

But that was just the beginning. Later Enrique took us to frolic with

playful sea lions at the marine reserve on nearby Espiritu Santo island, before visiting one of the most magical and pristine beaches imaginable, which our family had completely to ourselves, with the dramatic backdrop of the arid and stark desert for which Baja is rightly famous. Later we visited the magnificent Balandra Beach – boasting a whole bay of crystal clear

thigh-high water - as well as the abandoned oyster farms which briefly made the La Paz the world's biggest pearl producer at the turn of the twentieth century. All in all it was a day full of jaw-dropping moments and unforgettable experiences. Thanks to Enrique and Mike for probably the best Good Friday I've ever spent...

No bad meals

But what about the food? Well, we ate out every night and never had a bad meal. Most visitors stick to the restaurants on the Malecon, the pick of which is the **Bismarkcito**, - a sprawling seafood establishment whose rear wall is dominated by a large portrait of the famous (or infamous) German battleship from which the place draws its name. Our meal included shrimp enchiladas, grilled marlin and the biggest lobster I've ever seen. With

four desserts, plus coffee and a couple of cocktails the bill came to \$100, which by California standards is a bargain.

But sticking to the Malecon alone would be a mistake. La Paz is known for having one of the most varied restaurant scenes in Mexico and as usual, straying off the beaten path reaps dividends; we also enjoyed the **Rancho Viejo** (three locations, we recommend the one on Manuel Marquez de Leon just off the Malecon) for the Molcajete de Arrachera, a truly delectable mix of marinated beef, nopal cactus, and cheese melded in a heavenly sauce served in a piping hot stone bowl (\$55 for four). The budget-minded also must not miss **El Mural**, a tiny but delightful pizza joint serving thin crust pizzas with a Mexican twist, each big enough to feed two. Dinner for four, with drinks, \$30 (corner of Oaxaca and Belisario Dominguez) Also great for those on a budget is **Mariscos El Tio** (Calle Bellosario Dominguez and Constitucion) a good choice for an inexpensive lunch, serving fresh seafood quesadillas and ceviches, plus unbeatable asada tacos served with a large tupperware box containing hot sauce, salsa, lime wedges and slaw (all

fresh from the kitchen). Lunch for four, \$20. Slightly more upmarket but still an excellent value is **Athena's**, one of two highly-rated Greek restaurants in town. The four of us enjoyed succulent chicken souvlaki, melt-in-your-mouth braised lamb and Greek salad and very quaffable retsina for about \$65. (1243 Francisco Madero) Sit on the lovely outdoor patio if you can.

But hands-down the best meal we enjoyed during our stay was at **Azul Marino** in the CostaBaja marina. Under the imaginative leadership of chef Cristina Kiewek this waterside hideaway has earned a sterling reputation for its stylish modern cuisine. I started with a cool and spicy Gazpacho de Andalusia appetizer followed by an intriguing thin crust Huitlacoche Pizza. For the uninitiated, Huitlacoche is corn smut - a blight caused by pathogenic fungus. It was a combination of nutty and earthy and sweet and really worked well with the tomato-based pizza sauce. The rest of the family played it safe, ordering beef tenderloin, which came in an unctuous red wine reduction with baby potatoes and green onions, a juicy pork

tenderloin with creamy mashed potatoes accented with blue cheese and a spaghetti bolognese - my son's go-to dish whenever confronted with a complicated menu. Add two desserts (crepes with nutella and vanilla ice cream with caramel), a margarita and a glass of rich, earthy Vino de Piedra, (a Mexican blend of tempranillo and cabernet sauvignon) and the bill came to a very respectable \$85. Expensive by local standards but good value in Santa Monica. Service was prompt and professional too. And the location, overlooking the boats snoozing quietly in their slips, could not have been better.

In sum, La Paz still remains a charming Baja alternative to party-central Cabo San Lucas. The weather is almost always beautiful, the seas are warm and teeming with life. If activities on or in the water are your thing, it's hard to imagine anywhere better. The people are friendly and the price is right. Best of all, you don't have to get on a 12-hour flight to enjoy it. It's perfect for a weeklong trip from Los Angeles. And while you're there, say hello to some whale sharks, it's an experience you will never forget.

Getting There: Alaska, American, Delta, United, US Airways and Aeromexico all fly daily to San Jose del Cabo airport. Round trip fares start around \$305. From the airport, it's a 100-mile drive to La Paz. The British Weekly recommends **BBB Rent A Car** (www.bbrentacar.com), for their fleet of late model sedans and minivans. Run by two expats, Israeli Sagi Walk and American Gary Greene, BBB is just minutes from the airport and makes the rental experience painless. BBB stands for 'bueno, bonito y barato' which translates as 'good, clean and inexpensive' - which is certainly was on all counts.

Where to stay: **CostaBaja Resort** is the best hotel in the region by some distance with friendly and efficient service. Rooms around \$225/night for a double. www.costabajaresort.com. Other good choices include the **Hyatt Place La Paz** (across the marina channel from the CostaBaja resort), or the centrally located and charming **Hotel Perla**. A budget-minded choice in the center of town which is also awash with old world charm is the venerable **La Posada San Miguel** (double room with a/c are around 300 pesos - \$20 at 15pesos/dollar).
