# EU POLL: WE WANT OUT!

## ■ More Britons back EU exit than favour staying put, latest poll reveals

**A new poll reveals that 40 per cent of Britons want to leave the European Union – compared to 38 per cent who want to remain.**

It is the second poll to show more people in favour of an exit than staying in the 28-member bloc.

The YouGov survey for The London Times also found that 16 per cent of people had yet to make up their minds.

In the previous YouGov poll some 41 per cent favoured an exit compared to 38 per cent wishing to stay.

It follows a difficult summer in Europe with the ongoing migrant crisis in the Mediterranean and months of talks with Greece on financial bail-outs.

The poll was also good news for the UKIP party, whose leader Nigel

Farage, speaking at his party's annual conference in Doncaster last week, said: "I think that something is changing out there and I believe we're on course to win the most historic and the most important political victory in any of our lifetimes."

David Cameron's renegotiations are

continuing on the continent as he hopes to secure a better deal for Britain.

He has promised to hold a referendum on Britain's membership of the European Union by the end of 2017 but some have said that it could come as early as next May. EU leaders have

warned that Mr Cameron's hopes of renegotiating Britain's position in Europe are "stalling" as he refuses to lay out his demands for change in writing.

European officials say Mr Cameron has failed to put forward concrete proposals for discussion at a time when the migrant crisis, the EU's biggest ideological clash for years, is monopolising the "bandwidth" of Brussels' creaking bureaucracy.

"We just haven't heard anything from the British about what they want for ages," said one EU diplomat. "It does seem to have stalled. It's very awkward for us all."

"There is not a word," another exasperated senior official added to

## Cameron's EU wishlist

David Cameron has promised to renegotiate the terms of Britain's membership of the EU. The process is secretive, but here's what we know about what Cameron will try and secure:

- Prevent Eurozone states from "ganging up" on Britain in access to the single market as they seek to integrate further

- Excusing Britain from the principle of ever closer union

- Giving more power to national parliaments to 'red card' EU plans

- Denying EU migrants access to in-work benefits for four years

- Ending child benefit payments to migrants' children overseas

- No free movement for new EU states until their economies develop

- Cut red tape, complete the single market in services and sign major trade deals with the US and Asia

- Full on' treaty change is essential

- The process is followed by an in-out referendum by the end of 2017

# Jeremy Corbyn under fire again as he pledges not to use nuclear weapons

■ Trident row exposes deep divisions within Labour leadership - again

**Jeremy Corbyn has faced criticism from senior Labour colleagues for saying he would not fire Britain's nuclear weapons if he were prime minister.**

Shadow defence secretary Maria Eagle said the words were "not helpful", while shadow foreign secretary Hilary Benn said Mr Corbyn should abide by the party's decision on renewing Trident.

Mr Corbyn said nuclear weapons "didn't do the USA much good on 9/11".

He added that he was elected leader on a platform opposing Trident renewal.

## 'mandate'

Prime Minister David Cameron said Mr Corbyn's comments showed Labour could not be trusted with Britain's national security.

Following the shadow cabinet criticism of his comments, Mr Corbyn was asked by the BBC's John Pienaar what the point of the Labour defence policy debate and review was.

He said: "The point of a

policy debate is to try and bring people with me."

In his conference address on Tuesday, Mr Corbyn said his landslide leadership win gave a "mandate" for his views on disarmament of Britain's nuclear weapons.

On Wednesday's BBC Radio 4 Today programme he said: "I am opposed to the use of nuclear weapons. I am opposed to the holding of nuclear weapons. I want to see a nuclear-free world. I believe it is possible.

"I do not think we should be renewing Trident... I think we should be promoting an international nuclear weapons convention which would lead to a nuclear-free world."

Spending "£100bn" on replacing Trident was misguided, he said, arguing that the money could be spent on more "conventional" equipment and forces, and protecting "high-skilled jobs" of Trident workers.

The Labour leader said 187 countries "don't feel the need to have a nuclear weapon to protect their

security", and asked "why should those five need it themselves?".

But it was his answer "no" to the question of whether he would ever press the nuclear button, which prompted some of his senior ministerial team to break ranks.

## 'potential enemy'

Ms Eagle said "I'm surprised he answered the question in the way that he did", saying it "undermined to some degree" Labour's policy process.

Labour's current policy was in favour of retaining a nuclear deterrent, she said, adding: "I don't think that a potential prime minister answering

a question like that, in the way in which he did, is helpful."

Mr Benn, Labour's shadow foreign secretary, said that while he wanted a nuclear-free world, "you have to negotiate them out of existence and not give them up independently".

He added: "I think a British prime minister has to have that option and the whole purpose of the deterrent of course is it is trying to deter a potential enemy because they're not sure what you're going to do and that puts them off."

And Labour MP John Woodcock, who supported Liz Kendall in the Labour leadership contest, said Mr Corbyn's

position would make the "grotesque horror of a nuclear holocaust" more likely.

But Mr Corbyn's comments were endorsed by his shadow chancellor John McDonnell who said: "I don't believe the use of nuclear weapons is morally or legally appropriate, therefore we have to accept that."

In a later interview the Labour leader responded angrily to the suggestion he would put his principles before national security.

"We are not under any threat from any nuclear power. We are not under threat from that. We are under threat from instability," he said.

## University ban for 'racist' sombreros

■ Free hats off the menu at freshers' fair in case they cause offence

A Mexican restaurant has been banned from handing out free sombreros to students because the publicity stunt was branded 'racist' by university officials.

Pedro's Tex-Mex Cantina, a Norwich restaurant, gave the hats to University of East Anglia students at a freshers' fair in the city in a bid to drum up business from the student population.

But officials at the students' union, where the fair was held last week, took the sombreros from students and ordered the restaurant to stop giving them out because they thought it was offensive for non-Mexicans to wear them.

The union said it breached an advertising policy sent to stallholders, which said: 'Discriminatory or stereotypical language or imagery aimed towards any group or individual based on characteristics will not be permitted as part of our advertising.'

The policy specifies 15 types of discrimination, some of which include colour, ethnic origin, and nationality.

The union said the sombreros were seen as racist and a form of 'cultural appropriation'. One first-year student told student newspaper The Tab: 'It's ridiculous – it's a comedy hat, not some sort of sacred religious dress. Who is going to get offended? Speedy Gonzales?'

Pedro's Tex-Mex Cantina is a family-owned restaurant that opened in 1991 in Norwich and features a variety of traditional Tex-Mex dishes,

including nachos, chilli and tacos.

Manager Matthew Ward was unavailable to comment, but an unnamed worker at the restaurant said: 'It's ridiculous.'

However, the Union defended their stance on the large hat.

Campaigns and Democracy officer Chris Jarvis said: 'We know that when it comes to cultural appropriation the issues can sometimes be difficult to understand and many don't realise that they may be about to cause offence or break a policy.'

'So we're discussing internally how we can improve our briefing to both external organisations and our own members so that people aren't caught out at the last minute.'

He added: 'At the SU we want all members feel safe and accepted, so at all events we try to ensure that there is no behaviour, language or imagery which could be considered racist, sexist, homophobic, transphobic or ableist.'

But Britain's premier Mexican group dedicated to promoting the Latin American country's cultural heritage praised Pedros for giving out the free sombreros.

Chairman Richard Maudslay said today: 'I would applaud any business of any nationality for doing anything to try to drum up business in a legitimate way, which this seems.'

'We are delighted to learn that there is a Mexican restaurant in Norwich and hope that they would like to join us to become members of the British Mexican Society.'

## Harry 'far too busy' to settle down

■ Prince actively raising funds for wounded veterans' charity...but he still finds time to fit in a game of catch with NFL legend Dan Marino

Seventeen months after splitting from dancer and actress Cressida Bonas, Prince Harry remains resolutely single.

And he looks likely to remain that way, if an interview he gave this week is anything to go by.

For Harry there may have been an occasional flirtation but the man once dubbed the Playboy Prince is a different character these days. He is concentrating on his royal duties and, most importantly, his work helping wounded soldiers rebuild their lives.

Harry, 31, spoke about his future this week when he joined veterans in Shropshire on a 17-mile stretch of the charity Walking with the Wounded's 1000 mile trek across Britain.

Asked if he was close to settling down, he said: 'No. There are a lot of things to be done before settling down.' He added: 'Everyone looks forward to settling down but in the meantime it's work as usual so let's crack on.'

### good terms

Cressida, 26, was among friends who joined him in a London pub to celebrate his birthday two weeks ago, leading to speculation that they were together again. But sources close to them, while certainly not ruling out them rekindling their love affair in the future, insist that for the moment they are just friends.

He has remained on good terms too with his other serious ex-girlfriend, Chelsy Davy, but friends think there is less chance of that romance rekindling.

The prince's busy spell of duties has included honoring Battle of Britain

heroes, opening the Rugby World Cup and attending matches and visiting the project to build homes for veterans and their families.

But it is his work with Britain's wounded warriors that remains his top priority, Harry told a news crew on Tuesday.

The prince, who left the army in June after a decade as an officer, told how he felt most at home with military veterans. He vowed to spend the rest of his life focusing on helping them get the

support they need, particular those with life-changing injuries and suffering mental health issues after time in the forces.

'I love spending time with those guys,' said Harry. 'I like to think I know roughly what they are going through as well.'

'It's hard to say that because everyone is unique but the main focus, from my point of view, is to make sure they get the best support possible because I now and more people are

starting to see, how valuable they are within society.'

But it wasn't all work for the fun-loving Prince; Harry teamed up with NFL legend Dan Marino on Thursday for an impromptu game of catch. The former Miami Dolphin quarterback was in England heading up the NFL's participation in the Walking Wounded project. And Marino even found time to compliment Harry's ball-handling skills, describing them as "great, actually."

## Woman jailed for killing convicted paedophile

■ Sarah Sands attacked 77-year-old neighbour Michael Pleasted within weeks of hearing he had sexually abused three children

A woman has been jailed for three-and-a-half years for manslaughter, after stabbing a convicted paedophile to death.

Sarah Sands, 32, wept as she was sentenced at the Old Bailey on Tuesday. Sands was cleared of murdering her neighbour, 77-year-old Michael Pleasted, but found guilty of manslaughter by reason of loss of control, in July.

On the evening of 28 November last year, she armed herself with a knife and stabbed Pleasted eight times at his flat in Canning Town, east London.

Sands, a mother of five, acted within weeks of hearing that Pleasted had sexually abused three children.

Judge Nicholas Cooke QC said it was a "truly exceptional case" as he reduced her sentence from seven years, taking into consideration her position as a single mother.

Sands has already been in custody for the past 10 months and could be released on parole and reunited with her family in as little as 11 months' time.

The judge stressed that Sands's case was unique because she had lost control rather than taken the law into her own hands and engaged in "vigilante conduct".

He said: "There must never be the slightest encouragement for mob rule."

Explaining his decision

to lower the jail term, the judge went on: "This was a case in which the defendant promptly gave herself up to the police in a highly stressed state, never disputed responsibility for the killing as a matter of fact, did not take the opportunity to get rid of evidence and demonstrated remorse."

After the "determined and sustained attack", Pleasted crawled from his living room and collapsed in the hallway, where he bled to death.

Within hours, Sands handed herself in to police, telling an officer: "Who houses a paedophile on an estate, like, seriously? He was, like, asking for trouble."

# Joan Collins: I'll never recover from losing my sister

## ■ Veteran actress pens moving tribute to late sibling Jackie

Joan Collins has written a tribute to her sister, Jackie, who died of breast cancer two weeks ago, aged 77.

In the online post entitled "A Tribute to My Beloved Sister," Joan confirmed what had long been reported — that she only found out about Jackie's illness two weeks before she died.

In actual fact, the novelist, who was affectionately called "The Queen of the Bonkbusters", had been diagnosed six-and-a-half years ago, but chose to keep the news secret.

Joan also revealed that she asked Jackie to get mammograms but she refused.

She wrote: "I used to

nag my sister about getting mammograms, as our darling mother Elsa had succumbed to the disease in 1962 when she was only in her early 50s. I was religious about doing mammograms regularly. Jackie however refused — she didn't even like going to doctors. Like my brother and I, she was needle-phobic."

When asked why she hadn't told her, Jackie replied: "I couldn't — I didn't want to upset you. I know all the problems you've been having in the past few years — I didn't want to burden you with mine."

Joan added that this was typical of Jackie, who "always put other

people, particularly family, ahead of herself".

Sadly, Joan said she didn't think she would ever recover from the sadness of losing her sister.

She ended her tribute with: "She will live on in the wonderful memories I have of her from our childhood and particularly from the last 15 years, during which we were closer than ever. I feel her spirit, I hear her wonderful laugh and I see her all the time in the hundreds of photos of her that are sprinkled around my home."

"She wasn't just a star - to me, she was an entire galaxy."

She has requested that people who read her

## Pipped off: pensioners fined for littering after they dropped few cherry stones

A retired couple who were enjoying a bag of cherries under a tree in the sunshine were slapped with a £160 fine by council workers who accused them of LITTERING.

Peter Marsh, 69, and his wife Gillian Green, 65, were each given an £80 on

the spot fine for leaving the cherry stones under the tree.

The couple claim the enforcement officers who approached them "behaved more like nightclub bouncers", and the experience left them "terrified".

They complained to

Canterbury City Council, arguing the response to no more than 15 cherry stones being left was "far too heavy-handed."

However, the council's environmental team said they must pay up after they sought legal advice.

The pair have now paid their fines but Peter

as an older age couple who wouldn't make a fuss.

"Surely a verbal warning would have been more appropriate - the way it was carried out was just disgusting."

A Canterbury City Council spokesman said there was a bin in "reasonable" distance of the couple which they should have used.

He said: "Litter in the city centre is a priority issue for the public, as shown in our residents' survey, and we seek to enforce fairly no matter the age or gender of the person who commits an offence."

"We consider that everything discarded improperly on the street is litter and we cannot differentiate between an item being large or small, cigarette end or food packaging, a half-melon or cherry leftovers."

"In this case, there was a bin within a reasonable distance for them to use."

continued to complain and they were finally refunded £40 each.

Retired management consultant Peter, from Deal, Kent, said: "We ate no more than 15 cherries between us and put the stones at the base of the tree."

"When we left to continue shopping, we were approached by two men who were quite intimidating. We thought they were policemen."

"They did say they were enforcement officers but didn't explain clearly what was happening."

"It was terrifying. They separated us and were far too heavy-handed. We are law-abiding people."

"We were scared at that point as we didn't really know what was going on."

"At all times they were very polite but wouldn't answer any of my questions and simply kept to their script, despite the fact they could see our discomfort."

Peter was in Canterbury for a hospital appointment and said he was "shaking" after being approached.

He added: "I believe we were deliberately targeted

## Enid Blyton's former home for sale...lashings of money needed

THE IDYLIC English country property Old Thatch in Buckinghamshire is not just an impressive Grade II listed 17th Century property, set in 1½ acres and currently on the market for £1.85 million...

It can also claim one of the most successful children's authors ever as a former owner – it is also a literary star in its own right.

Enid Blyton, author of the Noddy, Famous Five and Secret Seven books, lived at the property in Bourne End, Buckinghamshire, from 1929 to 1938, and it is where one of her best-loved characters, Brer Rabbit, was created in 1934.

Old Thatch also became the title for a whole series of her books. And one volume includes stories about a girl called Gillian (the name of Blyton's eldest daughter) and her adventures in the fields surrounding her home, and it specifically mentions the property. Old Thatch is the setting for Blyton's 1943 publication, The Mystery Of The Burnt Cottage.

Towards the end of the 1930s – and her time at Old Thatch – Blyton's first full-length books, Adventures Of The Wishing Chair and The Secret Island, were published as she moved towards her most successful period, creating the memorable Famous Five, the Secret Seven and Noddy.

### 'fairytale house'

Blyton, whose books have sold more than 600 million copies and have been translated into at least 80 languages, lived at the cottage with her first husband, Hugh Alexander Pollock, and their daughters, Gillian and Imogen.

Blyton and Pollock bought Old Thatch in the summer of 1929, and it is little wonder that the author was enchanted by it from the moment she saw it.

In her diaries, she described it as a 'fairytale house', adding: 'You enter through a funny old lych gate with a thatched roof and there are big fruit trees, and yew hedges, in which hosts of little birds have built their nests. Roses bloom everywhere.'

Many of the features that Blyton refers to in her diaries are still there, and as you wander around the gardens, you can imagine her sitting by the lily pond with her typewriter on her lap, working on her books in the peaceful and picturesque setting.

The quintessentially English gardens, which have been redesigned by the present owners, Jacky and David Hawthorne, are listed as being among the finest in Britain.

They have featured on the BBC's Gardeners' World programme, as well as in newspapers and magazines around the world.

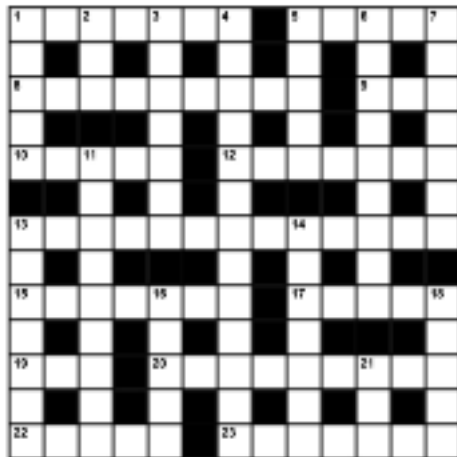

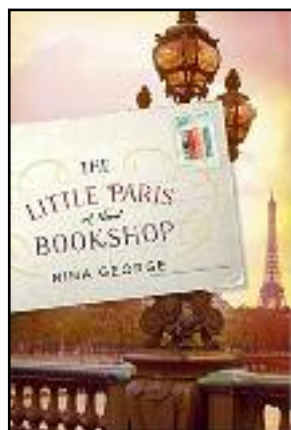

## The Little Paris Bookshop: plenty to read here....

Exclusive interview with author Nina George and a review of her novel about a man who cures people by giving them the right book to read



Rating: ★★★

"Books heal," says *The Little Paris Bookshop* author Nina George. "I've lived in books ever since I was a baby. It was only in their presence that I could find peace. Just as I was about to begin researching my story, in April 2011. My father died...in the middle of a sentence. He was my best friend and a mirror of myself. I think that books are about more than fame, popularity and power. And as I began to write about those things, I suddenly saw a path leading straight to myself

and to the story of Jean Perdu. I immortalized my father as Jean Perdu's father."

In the book Jean Perdu is a 50-year-old man living in Paris with his own literary apothecary, a boat full of books he sells only to the customers he feels needs them. He has a talent for picking the right book for his patrons because he's great at reading others, but not himself. He lost the love of his life to another man 20 years before and is still emotionally scared by it.

Perdu listens and observes people and he then knows what is the right book to help them get better. At the end of the book there are recipes and Jean Perdu's Emergency Literary Pharmacy list of books.

George's premise of a floating bookshop in Paris is enchanting. The description of local, food music and books are wonderful. The details make an engaging beginning but as the story continues it could have more emotional connection between the reader and the characters. An interesting detail would have been to focus on the people the book changes and how.

"Naturally I went to Provence during my research," says George. "Many of the places and a handful of the characters are real, for example Bonnieux and Sanary-sur-Mer. I raced

back and forth through the mountains of Provence at great speed, 1,000 miles, looking for places where I would feel...it."

"I came up with the idea of a ship full of books as I was sailing to New York on the Queen Mary II," says George. "It has the world's largest floating library containing 8,000 books. That's how many Jean Perdu has on board his floating Literary Apothecary, the pharmacie littéraire. Rue Montagnard, the location of Monsieur Perdu's Parisian apartment in the book, doesn't exist. I named it after a French smear-ripened cheese."

George has written 26 books, over 100 short stories, over 600 articles for columns and 3,000 reports and essays. With her husband Jo she writes French crime novels under the name Jean Bagnol. Her novel *The Moonlight Musician* received the

DeLiA, the German Prize for the best romance of the year. *The Game of Her Life*, a short story published in Ellery Queen's Mystery Magazine, won the Glauser for the best crime short story of the year. *The Little Paris Bookshop* is on the SPIEGEL bestseller list.

Georges says most of the players in the international book market are women, but that translators are male. "Men virtually rewrite the book," says Georges. "The Americans get all finicky when it comes to the graphic nature of my erotic scenes. They prefer to leave a lot of it up to the imagination...more Barbie doll sexlessness, less Anais Nin eroticism. It's because of the linguistic censorship that Apple imposes on e-books. Too much explicit sex means the book won't be sold through iBooks. However, the author has the final say. Always. And I want to keep the...."

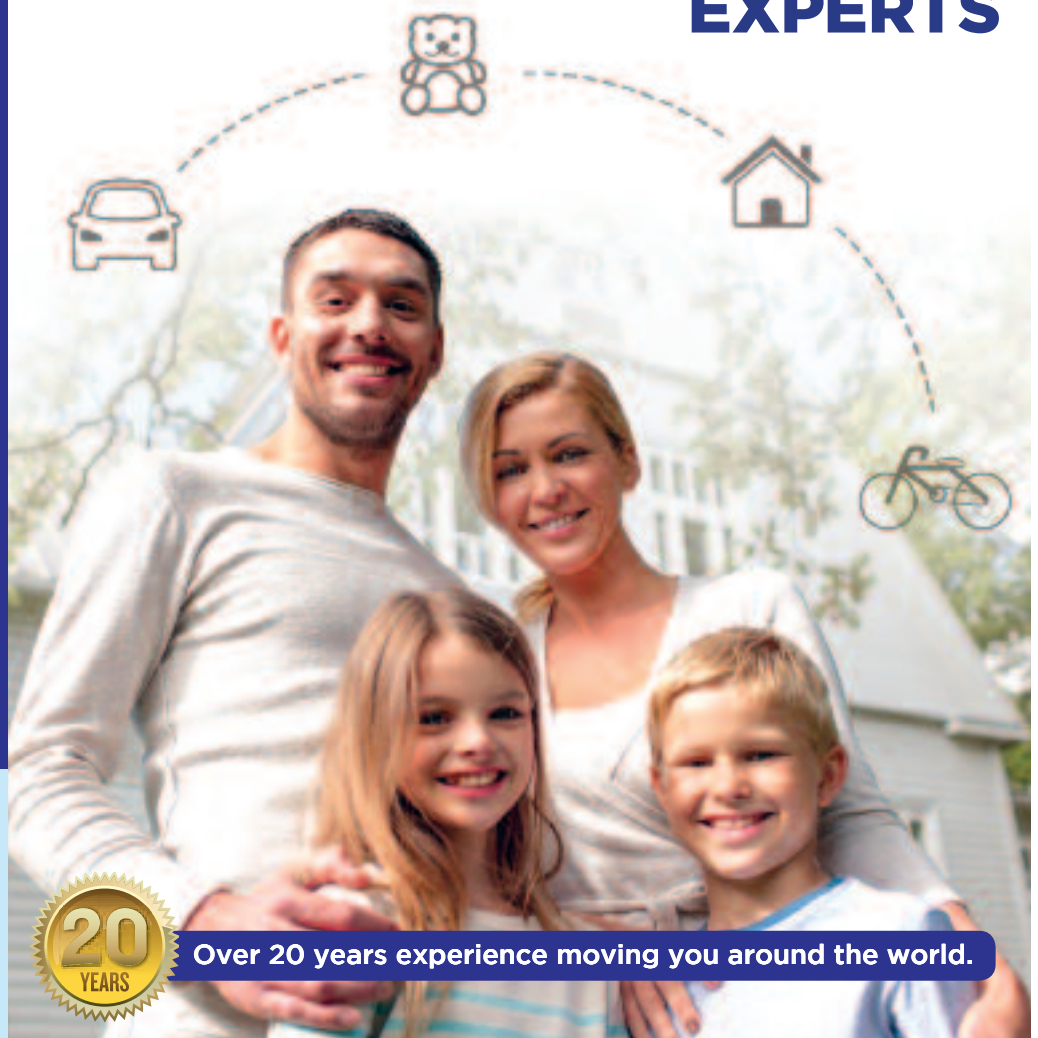

Wales took a huge step closer to the World Cup quarter-finals by beating Fiji 23-13 in a breathless Pool A clash on Thursday.

Warren Gatland's team scored tries through scrum-half Gareth Davies and hooker Scott Baldwin, with 13 points from fly-half Dan Biggar's boot, but missed a bonus point.

But Fiji struck back after the break with Vereniki Goneva rounding off a stunning 60-yard move.

Fiji paid for small mistakes, with Ben Volavola missing two easy penalties.

The result means Wales will reach the quarter-finals if Australia beat England at Twickenham on Saturday.

However if Stuart Lancaster's team beat the Wallabies, Wales will probably need to beat Australia on 10 October.

England's final game later that evening is against Pool A minnows

Uruguay and a bonus-point win is almost a formality for the hosts in Manchester.

If England finish on the same number of points as Gatland's team, Wales will go through thanks to their 28-25 win at Twickenham.

However, if Australia also finish on the same number of points as England and Wales then the top two will be decided on points difference.

## Unstoppable Hamilton equals Senna tally

Lewis Hamilton said it felt "unreal" after victory in the Japanese Grand Prix Sunday moved him level with his boyhood hero Ayrton Senna on 41 race wins.

"It's quite an emotional day. I'm full of joy and happiness and light," said the

30-year-old British driver.

Hamilton is now 48 points clear of Mercedes teammate Nico Rosberg in the title race.

Sunday was Hamilton's 162nd race, one more than Senna started in a career that ended tragically at Imola in 1994.

The Brazilian won twice at Suzuka in 1988 and 1993 and Hamilton's victory was also his second at the circuit.

"For me to win here at a race where I loved watching Ayrton drive and to match his wins, it doesn't feel real at the moment," he said.

## Wenger optimistic after latest Arsenal CL loss

Arsenal manager Arsene Wenger insists his side can still qualify for the Champions League last 16 despite sitting pointless at the bottom of Group F after losing to Olympiakos.

A 3-2 home defeat was Arsenal's second straight loss in the group stage, with two matches against German champions Bayern Munich to come next.

"It leaves us in a bad position but we are still in it," said Wenger.

"We have to get a result in our next game against Bayern Munich."

The Gunners dominated possession against the Greek side but went behind three times as Olympiakos secured their first win in England.

Theo Walcott and Alexis Sanchez cancelled out Felipe Pardo's opener for the visitors and an own goal by David Ospina, who Wenger had selected ahead of first-choice keeper Petr Cech.

But just 59 seconds after Arsenal's second equaliser, Alfred Finnbogason scored the winner.

When asked if it was his worst night in Europe, Wenger replied: "No. Sit on the bench and lose a final in 2006 and ask that question."

Tuesday's loss meant Arsenal, who have qualified from the group stage for the past 15 seasons, have lost their first two Champions League matches for the first time in their history in

the competition.

The last team to progress after losing their first two group matches were Galatasaray in 2012-13. Only nine sides have done it in the competition's history.

"We have to think we can deal with Dinamo Zagreb and Olympiakos away," said Wenger.

"Some aspects of our game were quite good but we lacked quality in our defensive concentration.

"The turning point was at 2-2. We had scored a goal and then straight away we gave them another goal to make it 3-2.

"We had 65% possession but we feel guilty because we gave easy goals away. We had a bit of bad luck as well."

Liverpool continued a stuttering start to their Europa League campaign as they drew 1-1 with FC Sion at Anfield on Thursday night.

Adam Lallana gave the hosts a perfect start, scoring from close range after Divock Origi's cross despite appearing to be offside in the build-up.

But the Swiss side then drew level through Ebenezer Assifuah's cute finish.

Origi and Lallana were both denied by Sion goalkeeper Andris Vanins, as Liverpool recorded a second consecutive draw in Group B.

There was a smattering of boos at the final whistle after frustration mounted against a team who are mid-table in the Swiss Super League.

The Reds have scored more than one goal on only one occasion this term under Brendan Rodgers but, with two games against Russian side Rubin

Kazan to come, the Liverpool boss will hope to achieve the victories they need to take charge of what appears to be a relatively easy group.

Tottenham conceded a late goal to draw against a poor Monaco side in the Europa League after dominating proceedings for most of the game.

At a lifeless Stade Louis II stadium, the home side grabbed a late equaliser through Stephan El Shaarawy, who headed in Nabil Dirar's brilliant cross.

Nacer Chadli struck a shot narrowly over the bar in the first half, before Erik Lamela gave Tottenham the lead by finishing off a slick team move.

Harry Kane could have grabbed a second but had a low shot and header saved.

Tottenham are unbeaten in Group J after a win over Azerbaijani side Qarabag in their opening match.

Against Monaco, they looked like coasting to the

three points after controlling most of the game, before two substitutes combined nine minutes from time to claim a point the hosts did not deserve.

Celtic threw away a two goal lead as they earned their second draw in the Europa League against Fenerbahce.

The home side were commanding in the first half and led through Leigh Griffiths and Kris Commons strikes.

Efe Ambrose committed the kind of calamity that has dogged him this season as he gifted a goal just before half-time, Fernandao netting.

The visitors took advantage of their lifeline and Brazilian Fernandao equalised just after the break.

Ronny Deila's side move on to two points, having drawn by the same scoreline against Ajax in the opening round of fixtures.

# Fuming Mou blames 'ridiculous moments'

Chelsea manager Jose Mourinho blamed "two ridiculous moments" after his side's Champions League loss to Porto on Tuesday.

The Blues suffered their fifth defeat of the season in all competitions after Maicon's second-half header gave the home

side a 2-1 victory. "We watch dozens and dozens of repetitions of Porto taking corners. We were completely ready for that," said Mourinho.

The Blues have now lost more games this season than the whole of 2014-15.

They endured just four losses in the last campaign, but have been beaten five times in 11 games this term.

Despite winning their opening Group F game 4-0 against Maccabi Tel Aviv, the London side were beaten in Portugal by Andre Andre's strike and Maicon's header, in between Willian's brilliant free-kick.

Chelsea are third in Group G, a point behind Porto and Dynamo Kiev.

They are also struggling in the Premier League, lying in 15th place, eight points behind leaders Manchester United.

Mourinho, who described his side's first-half display against Newcastle at the weekend as "minus one out of 10", was pleased he "got a performance" against Porto, who he managed from 2002-04.

"When the game is under control we concede a goal that is ridiculous," said Mourinho.

"They hit the post from a similar mistake. Apart from that the game was balanced. Two ridiculous moments and we were punished.

"The team played well and there were good reactions to the goals we conceded. We had chances to equalise and had desire.

"When you feel everything is going against you it is disappointing. The team tried until the end so I have nothing to say against them."

# City lucky to win, says Pellegrini

Manchester City did not deserve their last-minute Champions League victory at Borussia Monchengladbach, says Blues manager Manuel Pellegrini.

Sergio Aguero's penalty earned a 2-1 win Wednesday night, with keeper Joe Hart saving a penalty before the Germans took a 1-0 second-half lead.

Nicolas Otamendi scored the equaliser as City recovered from the 2-1 loss to Juventus in their opening Group D

game. "We had a bit of luck to win the game," said the 62-year-old Chilean.

City had been beaten in three of their four previous matches in all competitions, including Premier League losses to West Ham and Tottenham as well as the defeat by the Italian champions.

"Against Juventus and West Ham we didn't deserve to lose and maybe today we didn't deserve to win but we did," added Pellegrini.

But the victory - only

the third in their past 12 Champions League matches - boosted their hopes of reaching the knockout stage for a third successive season under Pellegrini.

City remain third in the group after two matches, level on three points with Spanish side Sevilla and three adrift of Juve.

England international Hart said his team were below their best against Monchengladbach, but disagreed with his manager about the final result.

"We were disjointed as

we had been in the last few games, but we deserved to win," said the 28-year-old.

"We had some really good chances. It may have come late but Sergio

Aguero is a cool guy and he will score.

"They've got some good movement - Kevin de Bruyne warned us about them. They've a very fit team and they

work themselves into the ground.

"We profited when they were a little bit tired at the end. They made a few mistakes and we kept our quality."

## Victorious United 'are suffering' says Van Gaal

Manchester United are "suffering" after six matches in 18 days, said boss Louis van Gaal following his side's 2-1 Champions League win over Wolfsburg on Wednesday night.

Juan Mata's first-half penalty and Chris Smalling's 53rd-minute goal gave United their first Group B victory.

The Premier League leaders, who visit Arsenal on Sunday, had to hold on as Wolfsburg pressed for an equaliser.

"A lot of players are very tired because of the accumulation of a lot of matches," said Van Gaal. United lost their first group game against PSV Eindhoven, but victory

over Wolfsburg means all four teams are level on three points after two matches.

"We have everything in our own hands and that is very important," said Van Gaal.

The Dutchman said his side showed "fantastic

"We score but after that it was suffering," he added.

Wins for United and Manchester City on Wednesday ended a miserable run for English clubs in Europe. With Arsenal and

Chelsea beaten on Tuesday, the four Premier League teams had lost five of their six group games this season.

When asked what he thought the problem was, Van Gaal pointed to the competitive nature of the domestic league.

"We have a rat race that is not always the same in other countries," he said. "We also have to play over Christmas."
