MPs approve measure which SNP warns will trigger 'end of union'

IN A DRAMATIC development at Westminster on Thursday Parliament voted for Scottish MPs to be excluded from votes affecting England in a move that the SNP warned will bring independence closer.

The changes were passed by 312 votes to 270 in the House of Commons on Thursday.

Pete Wishart, a Scottish National Party MP, warned that "the mood is darkening" in Scotland during the debate.

He added: "If this is an exercise in saving the Union you could not have contrived of a more inept way to save the Union."

'second class status'

"Support for independence is actually increasing."

It came as Kevin Brennan, a Labour MP, called on the Speaker to issue different coloured passes for members

from around the UK to make clear who would be banned from voting, after a fraught debate in the Commons.

Chris Grayling, the Leader of the House, claimed the changes would make Parliament fairer for English MPs.

But there was strong opposition from Labour, SNP and DUP members who warned the changes will create two classes of MP in the Commons.

Angus Robertson, Leader of the SNP in Westminster, tweeted: "Tories just pushed through second class status for Scottish MPs at Westminster. Whatever happened to the 'respect agenda'?"

Fish and chip diplomacy?

■ Cameron and Chinese leader solve the world's problems down the pub

China's president Xi Jinping enjoyed fish and chips and a pint of ale at a traditional English pub with David Cameron on Thursday as stunned regulars looked on.

The Prime Minister was entertaining Mr Xi at Chequers in Buckinghamshire on the third day of the Chinese state visit when they took the short journey to

The Plough at Cadsden. The world leaders sat at the bar with pints of IPA and enjoyed a basket of mini fish and chips with homemade tartare sauce before speaking to regular customers during the swift 20 minute visit ahead of a formal dinner with their wives.

Mr Xi had reportedly hinted that he wanted to enjoy authentic British

cuisine during his trip to the UK.

A source quoted in the Sunday Times said: 'The Chinese are desperate to order fish and chips. They've asked about it repeatedly.'

The Prime Minister, who famously once left daughter Nancy behind at The Plough after an afternoon out, joked with locals about the incident during the visit.

He said "I've been in here a few times."

"I'm not leaving my family here today."

Earlier the leaders met at Chequers where they enjoyed a walk around the grounds before heading inside for an hour long bilateral that focused on international affairs and China's role on the world stage.

And Owen Thompson, SNP MP and whip wrote: "The Tories ended the union today - not SNP and not the people of Scotland - result of this will have huge consequences for whole UK."

But Conservative MP John Redwood, who backed the plans, said it was time to give English MPs more power in Parliament.

He told the House: "Today is the chance to start to put right some of that injustice to

England; today is the chance to start to rebalance our precious United Kingdom.

"And in the week of Trafalgar Day, Mr Speaker, let me end by saying: England expects every English MP to do his duty or her duty."

'entirely reasonable'

Leader of the Commons Chris Grayling told the Today programme that the changes are "entirely reasonable".

He added: "Most of the parliamentary process will remain exactly the same."

"What it actually does is ensure that if we have a United Kingdom

Government that is seeking to impose a solution on England, let's say a radical plan for education reform which only applies in England, what it means is it can only do that if it gets the consent of English Members of Parliament.

"That, it seems to me, is entirely reasonable. We are devolving more powers to Scotland, Wales and Northern Ireland, we are creating a United Kingdom with a really strong devolved structure, and we are saying to people in England there's a bit of this for you. You've got some rights yourselves."

Most pooped on man in Britain demands action against guilty pigeons

■ Devon man so fed up with being the target of dirty birds that he is demanding his local council take action

A man can't enjoy his own garden because of pigeons roosting outside constantly POOING on him.

Daniel Norman is so fed up with being the target of the dirty birds that he is demanding his local council take action.

The pigeons are roosting in a derelict pool hall next to his house in Plymouth, Devon, and the 25-year-old wants officials to board it up to stop the rain of excrement every time he steps outside.

It has got so bad that he can't even hang out his washing to dry.

Daniel lives in social housing owned by Sanctuary Housing but, according to the driver's mate and warehouse worker, the housing association says it can't do anything to rectify the problem.

He said: "I've been fighting this case for the last five years.

"Because the building is not boarded up, the pigeons are going in there and roosting. If it was boarded up, it wouldn't be an issue.

"But that seems to be too much to ask."

Plymouth City Council now own the grade II listed property after a fire ravaged it nine years ago.

An inspector from environmental health visited Daniel's property and offered to send a team "every week" to clean up the mess - but made no offer to board-up the windows.

Labour Councillor Chris Penberthy, responsible for housing, previously said that the interior was in a "filthy state" and inhabited by breeding pigeons who

were "making a mess everywhere".

A Plymouth City Council spokeswoman said: "We are currently in the process of an enforced sale action under the Law of Property Act 1925...

"We understand the frustrations of local residents over the state of the building which is why after repeated requests to the owners to sort out the building we took tough action.

"Whilst the sale is going through we will review the current situation of the building to see if there are any additional steps we can take to secure the building."

A spokesperson from Sanctuary Housing said: "We sympathise with those living nearby and have repeatedly arranged for the garden to be cleaned.

"Our contractors also attempted to clear the area earlier this month, and we are speaking to Mr Norman in order to arrange an appointment so that the work can be carried out."

Widow's fury as triple police killer Harry Roberts celebrates passing his driving test

The wife of one of three policemen killed in a triple murder was left furious after photos of his murderer passing his driving test emerged this week.

Nearly a year after being released from prison, where he served 45 years, Harry Roberts was seen chuckling to himself while clutching his certificate after taking the test.

The picture has angered Gillian Wombwell, the widow of Detective Constable David Wombwell, one of the three unarmed officers he was convicted of killing in 1966.

'elated'

She said: 'He is free to come and go as he pleases while we live with the effect of his crimes every day. He has never shown any sign of remorse for his crimes. He will never change,' reported The Mirror.

The paper said he looked 'clearly elated' after his success in the test on Tuesday.

Roberts, now 79, who was jailed for life for shooting dead three unarmed policemen in 1966, was released from

prison last November.

He spent 48 years in jail after murdering Detective Sergeant Christopher Head, 30, Detective Constable David Wombwell, 25, and Constable Geoffrey Fox, 41, in west London.

'very frightened'

He was given a minimum of 30 years but served a further 18. In 2009, he was reportedly refused parole after threatening to kill a family he had worked for after they put a complaint in about him.

Roberts terrorised Joan Cartwright and her family when she complained about his behaviour while working on day release in her animal sanctuary in

the East Midlands, but she was unaware he would be coming out until he was released.

Amid great secrecy, he was taken from Littlehey Prison in Cambridgeshire to a bail hostel in the south of England, where he will be assessed pending an expected move to warden-controlled

accommodation - complete with panic alarm in case he feels threatened.

Mrs Cartwright said she felt 'very frightened' of the threat he posed. Police told her he was now a reformed man, but also gave her special codes to quote, should she need to call them.

Steve White, chairman of the Police Federation of England and Wales, told the Press Association that while Roberts may have served more than 40 years in prison, 'we must not lose sight that he was involved in the brutal murder of three unarmed police officers; their families condemned to a life sentence without their loved ones'.

Too much surveillance, says Bond

Daniel Craig has told Sky News he thinks there is "too much surveillance and too much information gathering" in the world.

The Bond star was talking as he promoted the 24th film in the franchise Spectre.

007 is no stranger to using surveillance methods himself and in Spectre a new high-tech intelligence agency is being created in London, which will make employees like Bond superfluous.

Director Sam Mendes said he shared concerns about the increasing creep of surveillance into private lives.

"I feel like there's a great danger that we lose all privacy," he said.

"It's of course a very good argument the Government and MI5 make about a need for surveillance in terms of the prevention of terrorism. However, it doesn't mean that everybody should be treated equally and everyone should, be equally guilty or should be treated as if they're guilty.

"There was a time when it was presumably accepted MI6 were the good guys but now the public is ambivalent about surveillance and about secret service and about the security services generally both national and international."

Ben Whishaw, who reprises his role as Q, said: "It's definitely worrying...the way it's heading."

This is the fourth time Craig has appeared as James Bond and despite previously saying he would rather "slit my wrists" than do a fifth film, the star said he is yet to make his mind up.

Delight for fans as famed cinema screens Spectre sneak preview

James Bond fans were in 00-heaven after his latest adventure Spectre was shown to the first audiences in the world this week.

The "first ever" screening of the movie, hosted at the Odeon Leicester Square in London, saw hundreds of lucky fans and press packed into the cinema, who cheered and clapped as the closing credits rolled.

Lasting over two hours, the 24th Bond film - which sees Daniel Craig in his fourth outing as the MI6 agent - was introduced by producers Barbara Broccoli and Michael G Wilson.

mixed reactions

With a thrilling opening scene set at the Dia de Muertos (Day of the Dead) festival in Mexico, Spectre delivered intense chase scenes, romance and some witty one-liners

from Bond and gadgets guru Q, played by Ben Whishaw.

The film - which follows the agent as he confronts enemies from his past, including his nemesis Franz Oberhauser, played by double Oscar winner Christoph Waltz - received mixed reactions following the screening.

Fans of the action franchise gave the latest adventure their approval with Heat's Boyd Hilton saying: "It has all the elements of a classic Bond film. It's satisfying for fans of the genre."

Super-fan Helen Newman agreed, saying: "I loved it. It's old-fashioned Bond. The humour is brilliant."

'no real shocks'

But others were disappointed with the latest offering.

Press Association film critic Damon Smith said: "From Skyfall to crestfallen. It was one

anticlimax to another although it was beautifully shot."

Darryl Smith from Scotland's Sunday Post called it "lacklustre", while Ming Yeung from Getty said it was "predictable".

Showbiz reporter Steve Hargrave said it was "solid and reliable but there were no real shocks or surprises".

ITN's Melissa Nathoo added: "It started phenomenally with an

impact but it didn't maintain it. It tried too hard but is still one of the better Bond films in recent times."

Spectre reunites Craig, 47, with director Sam Mendes, after 2012's Skyfall became the highest-grossing Bond film in history.

However, it may be their last 007 adventure together, with the film-maker saying Spectre is likely to be his last Bond film, while

Craig has also dropped hints.

Naomie Harris, Ralph Fiennes and Rory Kinnear return for Spectre, alongside newcomers to the franchise such as Andrew Scott, Dave Bautista and Bond girls Lea Seydoux, Monica Bellucci and Stephanie Sigman.

Spectre will be released on October 26 in the UK and November 6th in the US.

United star sues over lookalike Nazi doll

A Chinese toy manufacturer is being sued by Germany's football captain after it produced a lookalike doll dressed in a Nazi uniform.

Manchester United midfielder Bastian Schweinsteiger began legal proceedings after the figure named 'Bastian' appeared on sale through Hong Kong based Dragon in Dreams (DID).

The company also sells figures depicting former Soviet Union leader Joseph Stalin, British war leader Winston Churchill and civil-rights activist Martin Luther King.

A spokesman for the

31-year-old, who won the World Cup with Germany in 2014, told reporters he was taking legal action as German media angrily reacted at what they perceived to be a depiction of the player as a Nazi.

"Filth," said Munich's TZ newspaper while Stern magazine said "Scandal doll Bastian. That is what it looks like," next to a picture of the doll.

The resemblance to Germany captain Schweinsteiger is striking, although a spokesman for the company has insisted that it is purely coincidental.

"We think that all

Germans look like that. Bastian is also a very common name in Germany," spokesman Patrick Chan told Bild.

Media lawyer Ulrich Amelung told Bild that the doll was "a clear violation of Schwein-

steiger's personality rights" and "constituted a gross defamation and insult".

However users on the action figure community website One Sixth Warriors appeared to react more positively to

the doll.

User Mailalan said: "I like everything about this one. This one has lots of nicely done small details. I really like it. I agree that it is Bastian Schweinsteiger, the nose gives it away."



Provocative sign brews trouble for java lovers

A legal row is brewing over an “offensive” coffee shop sign in south London.

The managers of Fu**offee in Bermondsey Street have been told the building’s owners will personally destroy the sign or take them to court unless it is removed.

A letter dated October 20 from lawyers acting on behalf of the owners states: “We are instructed that you have either erected or allowed your sub-tenant to erect an offensive sign on the exterior of the building [...] without the permission or authority of our client and this constitutes a trespass.

“If you or your sub-tenant do not immediately remove the sign above the property shop front ‘F***offee’, and make good any damage caused to the exterior of the building, our client will have no option but to remove the sign themselves or issue court proceedings seeking an injunction requiring you to remove the sign.”

The letter also threatens: “Please note we reserve our client’s right to forfeit the lease.” F***offee’s manager Adrian Jones could not immediately be reached, but the shop tweeted a photograph of the letter along with the words:

“No humour please, we’re British.”

Supporters of the shop have already rounded on the owners, with one starting a petition that reads: “They have had a few anally retentive and gormless people complain about their name and now they have their money grabbing corporate landlord demand they take the sign down as it is deemed to be ‘offensive’.

“We, the undersigned, confirm we have a sense of humour and find the continued attack on our beloved F***offee an insult to freedom of expression, freedom of speech and humour.”

Ward councillor Damian O’Brien told the London *Evening Standard* the spat was a “storm in a coffee cup”, adding he had visited the café and liked its atmosphere.

But, he admitted, the shop had attracted a handful of complaints from people who live nearby – with some even contacting the police.

“They police don’t feel that there’s enough evidence to proceed,” he said. “If the word had started with a C, that would have been an entirely different case altogether.

“At the end of the day it’s a case of: ‘How liberal are you?’

No airbrushing, insists ageless Kate

■ Actress tells cosmetic giant she must be “truthful” about who she is

Kate Winslet has told a leading cosmetics company she will only promote their products on the condition they do not airbrush her image in their ads.

The actress is taking a personal stand against ‘unobtainable beauty standards’ perpetuated by the fashion and beauty industry in an attempt to be a better role model for young women.

The actress has a contractual agreement in place with L’Oréal to prevent additional editing of her appearance in the Lancome adverts she features in, making Winslet one of the few actresses to appear in beauty adverts without wrinkles being erased from images.

responsibility

The 40-year-old said successful women have a responsibility to promote confidence and strength among the younger generation. As a woman in the public eye, Winslet said she wanted to be a better role model by being “truthful” about who she is.

“I can only ever speak for myself and I can only ever do things that are important to me and it’s a hope that other people might follow suit but it does feel important to me because I do think we have a responsibility to the younger generation of women,” the actress told E! News.

Fellow L’Oreal poster girl for responsible change, Dame Helen Mirren, has already spoken for herself. “I am not gorgeous, I never was, but I was always OK-looking and I’m keen to stay that way,” Mirren said of her decision to shun the airbrushing for her first beauty campaign for L’Oreal. “I hope I can inspire other women

towards greater confidence by making the most of their natural good looks.”

Winslet, rumoured to have requested that airbrushing be reversed on a magazine cover back in 2009, agrees about the negative influence a photo’s false pretense can have on young girls; “I think they do look to magazines, I think they do look to women who have been successful in their chosen careers and they want people to look up to, and I would always want to be telling the truth about who I am to that generation because they’ve got to have strong leaders. We’re all responsible for raising strong young women, so these are things that are important to me.”

New battery-powered black cab design unveiled with on-board Wi-Fi

A new battery-powered Black Cab design has been unveiled, featuring Wi-Fi, a panoramic glass roof and the return of the iconic rear-hinged door.

Built by the London Taxi Company (TLC), the 'zero emission' TX5 is due to arrive on UK streets by the end of 2017.

The famous design icon will be updated to include a chassis made from lightweight aluminium and will also include a panoramic glass roof for the very first time on a Black Cab.

The next-gen cab will also feature built-in Wi-Fi and charging points for both drivers and passengers to power up their mobile devices.

Along with more legroom for the driver, six passenger seats and space for a wheelchair, the new cabs are also bringing back the rear-hinged door found on older cab designs.

While all of its 2,000 components have been designed from the ground up, the futuristic taxi maintains its famous look.

The London Taxi Company CEO Peter Johansen said: "The new vehicle has a wealth of new features, which will all be tried and tested and then tested again to provide a perfect balance of timeless design driven

by ground-breaking technology".

LTC's parent company, Chinese automotive manufacturer Zhejiang Geely Holding Group, will invest an additional \$50million in a factory in Ansty, Warwickshire, making it the first vehicle production facility to be built in the UK in more than 10 years.

The new cab was designed at Geely's design centre in Barcelona, led by British designers Peter Horbury and David Ancona.

Horbury, a former design chief at both Volvo and Ford, explained: "We were acutely aware of the huge responsibility that comes with introducing a new generation of design for what is already an instantly recognisable and iconic vehicle.

"We wanted to retain those aspects that make the London taxi what it is and what it stands for, while ensuring that the new design reflects everything that a 21st Century vehicle needs to be.

"We have sought to build on existing features such as the headlights, grille and strong roof lines. But we have also made sure that the new vehicle significantly builds on space and comfort levels for both passengers and drivers."

Music to our ears: Adele's latest album set for November 20th release

Award-winning singer Adele has confirmed November 20 as the global release date for her forthcoming album, 25.

Adele, 27, posted a message about her highly-anticipated third studio album on her newly-verified Instagram account.

The simple notification read: "25 out November 20th". Her very first post was accompanied by a black and white headshot of the London-born star.

Adele has also confirmed Hello as the debut single from 25. It will be available to buy and stream on Friday October 23, with the cinematic video for the track released on the same day.

Shot in the countryside surrounding Montreal, the video is directed by celebrated young Canadian director Xavier Dolan, who helmed feature films Mommy and Tom at the Farm.

'making up for lost time'

Oscar-winner Adele gave fans an insight into her third album via a Facebook and Twitter post on Wednesday, three days after she had teased a snippet from a song during a commercial break on TV's X Factor.

The Skyfall star's message said: "My last record was a break-up record and if I had to label this one I would call it a make-up record. I'm making up with myself."

She added: "Making up for lost time. Making up for everything I ever did and never did. But I haven't got time to hold onto the crumbs of my past like I used to. What's done is done."

Reflecting on her youth, Adele said she wished her years away. "When I turned 12 I just wanted to be 18. Then after that I

stopped wanting to be older," she wrote.

"Now I'm ticking 16-24 boxes just to see if I can brag it! I feel like I've spent my whole life so far wishing it away. Always wishing I was older, wishing I was somewhere else ... Wishing I hadn't ruined so many good things because I was scared or bored."

The Rolling in the Deep singer also revealed celebrating her 25th birthday felt like a

"turning point".

"Teetering on the edge of being an old adolescent and a fully-fledged adult, I made the decision to go into becoming who I'm going to be forever without a removal van of my old junk," she continued.

"I miss everything about my past, the good and the bad, but only because it won't come back. When I was in it, I wanted out! So typical. I'm on about being a teenager,

sitting around and chatting s**t, not caring about the future because it didn't matter then like it does now.

"The ability to be flippant about everything and there be no consequences. Even following and breaking rules ... is better than making the rules."

The singer became a mother in October 2012, when she gave birth to son Angelo with boyfriend Simon Konecki.

"Star pushed his luck too far and Meggie snapped - splitting Star's bottom beak right down the middle," Hayman, 69, told the Cheddar Valley Gazette.

"He gave her a stare, then promptly stood on her back. It was not pretty and not nice. We were so

scared we would lose Star.

"He had to be rushed to the vets and go under anaesthetic, which is always risky and could go either way with ducks and other small animals.

"Thankfully our Star is a tough cookie and it looks like he came out okay."

Lastly, how can we find out more about you?





Scrooge: so what happened next?

Exclusive interview
with author Charlie
Lovett and a review

"It was Christmas time and we were studying Arthurian legends," says The Further Adventures of Ebenezer Scrooge author Charlie Lovett. "I only had one student in my study hall at the end of the day, and he had a great sense of humor, so I started to, judiciously, introduce him to Monty Python and the Holy Grail. The combination of Christmas and parody gave me the idea to try writing a parody of

Dickens' A Christmas Carol."

The Further Adventures is a sequel to the original classic; revisiting the Scrooge backstory so his nephew's generation will remember the meaning of Christmas is charming. The sequel may be too much like the original, with so many lines from original book. Where Lovett matches the pacing of Dickens, the story might have benefited from

a more modern pace and faster start. True to the original, it's the same level of scary and makes a nice addition as a holiday gift.

In The Further Adventures of Ebenezer Scrooge Scrooge has changed. He's not been a curmudgeon for years. Twenty years after Scrooge was visited by three ghosts in A Christmas Carol, he's again visited by former partner Jacob Marley, who still has a few chains to remove before he can rest in peace.

"I actually wrote The Further Adventures of Ebenezer Scrooge almost eleven years ago," says Lovett. "I was working as a long-term substitute for a seventh grade English teacher who was on maternity leave. I worked on it every day during

study hall and then during Christmas vacation, which we spent in England. I even wrote as we sat in the pew at Canterbury Cathedral waiting for Christmas Eve services to start."

Lovett completed the book in early 2005 and shortly thereafter got his first agent. "He sent it to a few publishers who passed on it for a variety of reasons," says Lovett. "It wasn't long before my excitement about finally having an agent was replaced with silence from New York."

"Writing is a tough business," says Lovett. "Although I had never been dropped by an agent before, I had been rejected plenty of times. I put Scrooge in the bottom drawer and went on to the next project. Ten years

later, I was sitting in my editor's office looking at cover designs for my second novel. I mentioned that I had a Christmas book, a sequel to A Christmas Carol... Sometimes, success in publishing is all about patience."

Lovett wrote the New York Times bestselling novel The Bookman's Tale and the novel First Impressions. He's written many books of non-fiction and several on Lewis Carroll. He has nineteen published children's plays, performed in over 3500 productions in fifty states and twenty foreign countries.

Lovett is currently finishing his next novel, The Lost Manuscript. Set in an English cathedral library, the search is on for a missing medieval

manuscript.

Lovett was born and still lives in Winston-Salem, North Carolina, the son of an English professor and book collector. He and his wife spend five or six weeks a year in their cottage in Oxfordshire.



Bayern win gives us belief - Wenger

Arsenal's victory over Bayern Munich will raise belief at Emirates Stadium, says Gunners manager Arsene Wenger.

Wenger's side had lost their first two Champions League games but goals from Olivier Giroud and Mesut Ozil saw them beat the German champions 2-0 on Tuesday.

They remain bottom of Group F before a trip to Munich on 4 November

but can go top of the Premier League on Saturday.

"We had an absolute necessity to win and we did it in an intense, disciplined game," said Wenger.

"It can strengthen our belief and the belief of fans."

Bayern had won 12 games in a row before substitute Giroud headed home and Ozil converted Hector Bellerin's

injury-time cross to give Arsenal victory.

Wenger again started with Theo Walcott up front against Bayern, and the England forward was denied the opener in the first half by a sensational one-handed save from Manuel Neuer.

But Giroud put Arsenal ahead three minutes after replacing Walcott when Neuer flapped at Santi Cazorla's free-kick.

"Give him some credit,

it is not easy for Giroud," said Wenger.

"He had a little dip in form but he is coming back to his best. The focus and spirit he shows, he's a winner.

"When it doesn't work on the ground, he gives us options in the air. I like both Giroud and Walcott, it is just a question of making sure I use them in the right way."

Neuer admitted after the game that he was at fault for Giroud's goal.

"Unfortunately, I made an error so Arsenal took the lead," he said. "I don't care whether it was a handball by Giroud or not, I know I made the mistake.

"But life goes on. We played quite well, a draw would have been deserved."

While the German's stunning save from Walcott counted for nothing in the end, Arsenal goalkeeper Petr Cech's superb stop to deny Bayern striker Robert Lewandowski proved crucial.

"Cech kept us in the game and you can say the same for Neuer," said Wenger.

"There were two world-class keepers on the pitch."

Plenty to ponder for Klopp

Indifferent show from Reds as Anfield welcomes new boss

Liverpool boss Jurgen Klopp endured a frustrating first game at Anfield as the Reds were held to a 1-1 draw by 10-man Rubin Kazan in the Europa League on Thursday.

The visitors took the lead through Marko Devic's stunning half-volley but had captain Oleg Kuzmin sent off for a second yellow card soon after.

Liverpool responded as Emre Can stabbed in following a free-kick.

Substitute Christian Benetke hit the post late on as Liverpool were held to a third successive Group B draw.

Despite pressing late on, it was ultimately a difficult evening for Klopp and Liverpool as they struggled to break down their opponents for large periods of the match.

The result leaves Liverpool second in their

group on three points, four behind leaders FC Sion.

Tottenham slipped to third in Europa League Group J with their first loss of the campaign at Anderlecht.

Spurs took an early lead when Christian Eriksen capitalised on a mix-up in the hosts' defence.

But Guillaume Gillet rifled in an equaliser before Anderlecht top scorer Stefano Okaka secured victory late on.

Tottenham striker Harry Kane, a second-half substitute, failed to beat goalkeeper Silvio Proto after being played clean through at 1-1.

Both teams were committed to attack in an entertaining match but Spurs paid for wasting early chances, with Erik Lamela the most guilty.

Anderlecht, third in the Belgian Jupiler League,

kept Spurs goalkeeper Hugo Lloris busy throughout and were good value for their first victory in six European games.

The sides meet again at White Hart Lane on 5 November with only four points separating the four teams in the group after Monaco beat Qarabag 1-0 to go top.

Celtic's chances of a place in the knockout phase of the Europa League were reduced as Molde consolidated their lead at the top of Group A.

In atrocious conditions, Dedryck Boyata's slack pass paved the way for Ola Kamara to secure an early lead.

That was followed by a second from Vegard Forren on 18 minutes, which put the Norwegian champions in command.

Kris Commons reduced

Van Gaal: we are on track

Manchester United boss Louis van Gaal is confident his team can qualify from Champions League Group B despite drawing 1-1 at CSKA Moscow.

United are second in the group after winning only one of their opening three games and host CSKA and PSV Eindhoven before travelling to leaders Wolfsburg.

"We are very strong at home and I hope we can win these games so we are nearly qualified or qualified," he said.

"We are on schedule after the PSV defeat, which was strange for us."

Anthony Martial's second-half header earned a draw for United in freezing conditions after

the 19-year-old forward's handball had led to a first-half CSKA penalty.

David de Gea saved the spot-kick from Roman Eremenko, but CSKA's top scorer Seydou Doumbia reacted first to turn in the rebound.

Van Gaal described Martial's handball as a "present" but refused to blame the teenager, who took his season's tally to five goals after his £36m move from Monaco.

"He is a human being, he reacts and it is a stupid reaction but sometimes things will happen," the Dutch manager said. "It's the first time that it happens and if it's happening always with me it's a pity.

"But he was not affected

at half-time so I was very happy with his performance."

Martial played most of the game on the left wing, with Wayne Rooney preferred in the striker's role, while Jesse Lingard played on the right as he made his Champions League debut.

Van Gaal said his team lacked tempo in the first half and he brought on Marouane Fellaini to replace Bastian Schweinsteiger at half-time, with Memphis Depay introduced in place of Lingard with 10 minutes left.

Asked whether Martial would have been better suited to a striker's role, Van Gaal replied: "I don't
