# Honoring the fallen on Armistice Day

**A two-minute silence was observed across the UK on Wednesday to remember the nation's war dead on Armistice Day.**

The silence began at the 11th hour of the 11th day of the 11th month - the time in 1918 when the guns fell silent along the Western Front in Europe.

War memorials, offices, schools, town halls, and churches all hosted events.

The Princess Royal was at the National Memorial Arboretum in Staffordshire, while veterans and serving personnel laid wreaths at the Cenotaph in London.

**two minute silence**

The Royal British Legion held its annual Silence in the Square event in Trafalgar Square, featuring musical performances and readings, while the only flying Mk1 Swordfish - a World War Two bomber - dropped poppies from the air over Yeovilton, Somerset.

Services were also held at the Scottish Parliament in

Edinburgh, the Welsh National Assembly in Cardiff and Belfast City Hall.

Prime Minister David Cameron observed the two minute silence during his flight to Valletta, Malta, for a meeting with EU leaders, a Downing Street spokesman said.

Armistice Day follows similar ceremonies on Remembrance Sunday to pay tribute to all those who died in World Wars One and Two and in every conflict since.

The Queen led commemorations on Remembrance Sunday, but she is spent Armistice Day privately at Buckingham Palace with other members of the Royal Family.

Military representatives joined Princess Anne at the National Memorial Arboretum. Its Portland stone memorial is designed so that on the

11th hour of the 11th day of the 11th month, a shaft of sunlight dissects its inner and outer walls, falling on a bronze wreath sculpture.

**'tremendous service'**

The Duke and Duchess of Cornwall attended a Remembrance Day ceremony in Canberra, as part of their current tour of Australia and New Zealand.

The Prince of Wales met Malcolm Turnbull,

the Australian prime minister who once led the campaign for the country to abandon the monarchy.

Meanwhile, 19 British veterans were presented with France's highest distinction, the Légion d'honneur.

The ceremony - at the French ambassador's residence in London - was the latest in a series since the 70th anniversary of D-Day, when French President François Hollande

pledged to honour all those British veterans who had helped his country during World War Two.

Ambassador Sylvie Bermann said it was France's way of "thanking them for their tremendous service".

Armistice Day falls each year on 11 November to mark the day in 1918 when the World War One fighting stopped. The Allies and

Germany signed an armistice in a railway carriage in the Forest of Compiègne in France at 5am. Six hours later, at 11am, the conflict ceased.

King George V announced that a two-minute silence would be observed in 1919, four days before the first anniversary of Armistice Day. The silence continues to be observed every year on the 11th hour of the 11th day of the 11th month.

# Former Para held for Bloody Sunday shooting

A former British soldier who was arrested on suspicion of murdering three civil rights demonstrators in Londonderry on Bloody Sunday has been released on bail, police said.

The 66-year-old ex-paratrooper was detained by detectives from the Legacy Investigations Branch of the Police Service of Northern Ireland in Co Antrim on Tuesday morning.

He was the first person arrested by detectives probing the deaths of the 14 people killed after the Army opened fire on crowds of protesters in Derry's Bogside in January 1972.

The PSNI said: "A 66-year-old man arrested

by Legacy Investigation Branch detectives investigating events of Bloody Sunday has been released on bail pending further enquiries."

It is understood the pensioner was arrested on suspicion of the murders of William Nash, 19, John Young, 17, and Michael McDaid, 20, all of whom were shot dead in close proximity to one another at a rubble barricade on Rossville Street.

It is believed the former soldier is also being questioned about the attempted murder of William Nash's father Alexander. Mr Nash came to the barrier to save his son but was shot in the arm and body.

It is understood the soldier gave evidence to

the Government-commissioned inquiry into Bloody Sunday, undertaken by Lord Saville, under the cipher Lance Corporal J.

Thirteen people were killed by members of the Parachute Regiment on the day of the incident. Another victim of the shootings died in hospital four months later.

The PSNI's murder investigation into the events of Bloody Sunday was launched in 2012.

The probe was initiated after the Saville Inquiry found that none of the victims was posing a threat to soldiers when they were shot.

Following the publication of the Saville report in 2010, Prime Minister David Cameron

apologised for the Army's actions, branding them "unjustified and

unjustifiable".

In September, the PSNI announced their intention

to interview seven former soldiers about their involvement on the day.

## Scotland braces for Abigail

### Met Office debuts naming of storms

SCOTLAND was this week preparing for the first big storm of the autumn as Storm Abigail, the first weather system to be given a name under a new Met Office project, was forecast to lash the country with severe gales.

While much of Britain

continues to enjoy record mild temperatures for November, thanks to south-westerly winds, an Atlantic depression linked with that same weather pattern, is forecast to cause severe gales of 80mph or more for north-west Britain.

The Met Office has issued a yellow – "be

aware" – warning for the north and north-west of Scotland with high gusts in exposed areas risking travel disruption. It also warned that Storm Abigail could cause high waves to come over the top of seafronts.

The Met Office said: "A vigorous depression is expected to pass just to

the north-west of Scotland bringing a swathe of very strong winds on its eastern and southern flanks."

#### 'intensity'

Storm Abigail is the first such weather system affecting the British Isles to bear a name as part of the "name our storms" project, using names chosen by the public.

Eddy Carroll, chief meteorologist at the Met Office, said: "We now

have our first named storm. It's called Abigail ... and it is expected to come eastwards quite quickly ... bringing some very strong winds on its southern flank. There is inevitably some uncertainty about the track it's going to take and the ultimate intensity it is going to reach but there is quite a lot of evidence that it could be quite a deep feature bringing winds possibly as much as 80mph or

more."

It is hoped the name our storms project, inspired by storm warnings used in the US and elsewhere in the world, will help raise awareness of severe weather and ensure greater safety of the public.

Under the scheme, storms will be named when they are deemed to have the potential to cause a substantial impact in the UK and/or Ireland.

# Cumberbatch has a date at the Palace

■ Charitable works bring *Sherlock* star a CBE

**Benedict Cumberbatch has been made a CBE by the Queen at a ceremony at Buckingham Palace.**

The *Sherlock* star was honoured for his work as an actor and his charitable efforts.

The actor said after the ceremony: "It's fantastic, it's quite nerve-wracking, there is nothing really that prepares you for it.

"It's a unique occasion and I feel very privileged to be here and flattered to be recognised in this way."

He added: "It was wonderful, it was the first time I've ever met her and to meet her and be honoured by her was extraordinary."

The actor was joined at the ceremony by his theatre director wife Sophie Hunter.

Cumberbatch, who is currently filming the eponymous role in Marvel's *Doctor Strange*, recently completed a three-month run in Shakespeare's *Hamlet* at the Barbican.

He said: "[Her Majesty] asked me what I was doing at the moment, and I told her I had finished a three month run at the Barbican, which she knew of.

"And I told her I had just got back last night from filming in Nepal, *Doctor Strange* for Marvel, then I'll be going straight into the fourth series of *Sherlock*. She said: 'Oh, it never stops does it?'"

He added that the Queen "didn't let on" if she was a *Sherlock* fan or not, but said: "I know a lot of the household is, I have been assured they have watched a few episodes."

On receiving the letter

notifying him of his honour, Cumberbatch said: "I thought there had been a mistake. I thought someone had got something wrong."

But he said the honour would not stop him from speaking out on issues about which he feels strongly.

Last month, following a performance of *Hamlet*, he urged the audience to donate cash to the refugee crisis appeal.

"I think the power anybody in the public eye has, is to draw attention to

things that concern them at certain points in time, whether it be causes or politics, and I think I had a unique opportunity to do that at The Barbican with the money for the Save the Children appeal for Syria.

"I am in a very privileged position to have a voice and to have a certain amount of people listen to what I have to say.

"I don't know if this [the CBE] will change that, but I am certainly not going to change who I am because of it."

## Di's former lover 'tried to sell' letters from Prince William

**It's probably hard to think of a more despicable betrayal of a child's confidence than hoarding their letters for 30 years before trying to sell them to the highest bidder, but James Hewitt, the once-dashing cavalry officer who became Princess Diana's lover, stands accused of having done just that.**

It was reported at the weekend that Hewitt—who now lives in reduced circumstances with his mother in a two-bedroom flat in Devon according to the Daily Mail—attempted to sell thank-you cards written to him by a young Prince William for £15,000.

The Los Angeles-based dealer who was acting for Hewitt, Gary Zimet, said:

"I was told privacy was paramount because Hewitt was worried about the fall-out if it became public. He needs money, pure and simple."

But later Zimet claimed that the sale fell through because the letters had 'bad juju' about them.

Mr Zimet added that he was originally contacted Hewitt then after a period of silence he received an email offering to sell just two cards sent by Prince William. Sent by Hewitt's

friend Alan Darlow, the email states: "Hi Gary, just spoken to James. If you personally want the two William and Harry cards he wants 15,000 each."

One card, sent in April 1988 and signed "with love from William and

Harry", thanks Mr Hewitt for a "lovely morning" climbing on tanks, playing snooker and playing with guns.

The card is fronted by a picture of five chimpanzees labeled

## Woman who posed as man is jailed over sex assaults

**A woman who who posed as a man to dupe a female friend into having sex with her has been jailed for eight years for the "callous breach of trust".**

Gayle Newland, 25, persuaded her victim that she was in a relationship with a man named Kye Fortune. She told the woman to wear a blindfold during sexual encounters in which she used a prosthetic penis.

Newland, of Willaston, Cheshire, had claimed the pair had engaged in "role play and fantasy" when they had sex about ten times, but she was found guilty of three sexual assault charges after a trial at Chester crown court in September.

The court heard that the victim was tricked after Newland disguised her appearance and voice when they spoke on the phone during the two-year relationship.

She only discovered the truth when she removed her blindfold and saw Newland wearing the false penis in June 2013.

The victim told the court: "It may look ridiculous, I had no idea. I was desperate for love. I wasn't closing my eyes to what was happening, I wouldn't have gone along

with it."

The victim first came into contact with "Kye" on Facebook in 2011 and the pair became a couple.

The court heard that the former creative writing student would concoct excuses as to why they could not meet, claiming he had suffered from cancer and was involved in a car crash, and that the treatment had left him embarrassed about his body.

As their relationship progressed, the perpetrator suggested the victim meet "his friend" Newland.

The court heard the victim would hold long conversations with Kye before calling another number to talk to Newland, unaware that she was speaking to the same person using different mobile phones.

Kye eventually agreed to meet the victim, under strict "rules" that she must wear a blindfold and mask at all times.

The court heard the pair would lie on Newland's bed watching television, even though the victim was wearing a mask and could not see the screen.

She told police officers of the moment she uncovered the fraud: "Something just didn't

feel right, so I sat up on the bed.

"Something in my mind said pull it (the blindfold) off, pull it off.

"I pulled it off and Gayle was standing there with a strap-on prosthetic penis. I just couldn't believe it."

Newland claimed her accuser always knew that she was pretending to be a man as they both struggled with their sexuality.

## Councillor who announced closure of public toilets fined for urinating in street

**■ South Lanarkshire Council deputy leader 'embarrassed' after he is spotted urinating in town centre just months after he oversaw closure of public toilet**

**A council chief involved in closing public toilets has been left "embarrassed" after he was caught urinating in the street by police.**

South Lanarkshire Council's deputy leader, Jackie Burns, was spotted in the act in Hamilton town centre and was issued a £40 fixed penalty notice by police.

The incident, which happened on Saturday, came just months after the Labour councillor

oversaw the closure of public toilets in his council area.

Cllr Burns has since apologized and said he had been "embarrassed" by his actions near the Hamilton Palace nightclub.

He said: "I was in a taxi rank at the Bottom Cross in Hamilton and needed the toilet. I went down a lane to relieve myself and was approached by police, who gave me a £40 fine which I have duly paid. I am embarrassed by the incident and have apologised."

**'insulting and disgraceful'**

In May, Burns told residents of his Larkhall ward that the Scottish Government's spending cuts were to blame for toilet closures, which he blamed on its financial resettlement.

He previously said: "Unfortunately, as part of the Scottish Government's financial settlement, South Lanarkshire Council has had to cut £22 million

from its budget, which has resulted in all public conveniences in the council closing."

Mr Burns represents Larkhall and sits on a range of committees including social work, planning and education resources.

John Wilson, an MSP for Central Scotland, said: "I am disappointed by this behaviour. He should consider his position as deputy leader."

Christina McKelvie, MSP for Hamilton, Larkhall and Stonehouse criticised Cllr Jackie Burns for publicly urinating, saying his behaviour was "insulting and

disgraceful" to the community he serves.

She said: "Back in April, Larkhall community councillors managed to get a three month stay of execution from South Lanarkshire Council which wanted to close the public conveniences in Mr Burns' home town of Larkhall.

"They closed on June 30. Perhaps that is a matter of some regret to Mr Burns now? His public behaviour is insulting and disgraceful to the residents of Hamilton. This is certainly a very anti-social act and one that any right-thinking person will condemn."

Actor Rowan Atkinson's wife has been granted a divorce on the grounds of his "unreasonable behaviour" after he left her for a comedy actress half his age.

The Mr Bean and Blackadder star was not present at the

65-second proceedings in central London on Thursday.

Estranged wife Sunetra was granted a decree nisi against the 60-year-old by a district judge at the Central Family Court.

Atkinson married the

make-up artist in 1990. He has been dating 32-year-old Louise Ford for 18 months. Ford is best known in Britain for her role in Channel 4's popular Misfits TV show.

Divorce papers made public did not give any details relating to the

unreasonable behaviour ground.

Listed as Atkinson S D v R S, the case was the fourth in a list of 26 before District Judge Stephen Alderson for decrees and orders to be made under the "quickie" procedure.

The County Durham-born actor and his wife, who have two children, are reported to have split last year.

Andrew Newbury,

head of family law at Slater and Gordon, said: "Unreasonable behaviour is the most common ground for divorce.

"Even in the happiest of marriages, it's always possible to find behaviour which can be described as unreasonable."

Mr Newbury said such behaviour could include complaints that "she talks too much", or "he

never listens", or that a husband "always wants to go out with friends".

He added: "Although described as granting a divorce, the divorce itself won't be made final until Sunetra Atkinson applies for the decree absolute.

"She can do that six weeks after today. She may well be advised by her lawyers to delay the application until the financial settlement has been agreed."

Former Motörhead drummer Phil Taylor has passed away at the age of 61. According to former bandmate "Fast" Eddie Clarke, who posted the news on his Facebook page, "Philthy Phil" had been unwell for some time.

In a tribute, Clarke said: "My dear friend and brother passed away last night. He had been ill for sometime [sic] but that does not make it any easier when the time finally comes. I have known Phil since he was 21 and he was one hell of a character. Fortunately we made some fantastic music together and I have many many fond memories of our time together. Rest in Peace, Phil!"

Phil was a longtime fixture in Hollywood and could often be found at the late, lamented Cat & Fiddle on Sunset Boulevard and the short-lived Bailey

"Mummy, Reg, Harry, Ruth [and] William". Another card wishes Mr Hewitt a happy birthday.

Mr Darlow put a different spin on the story, claiming that Mr Hewitt was "totally fed up" with Mr Zimet's persistence and "he had made it quite clear he did not wish to sell. He therefore gave him a high figure to discourage him."

Jon Conway, the playwright who worked with Hewitt to produce the controversial play "Truth, Lies and Diana" - which Hewitt used to claim that his affair with Diana pre-dated the birth of Prince Harry, rather than beginning in 1986 as is often claimed - said that it was "impossible for James Hewitt to get a fair hearing" and argued that the media were displaying double standards by castigating Hewitt for offering the letters for sale yet quoting the text of the letters being offered.

"It's his property and he can do what he likes with it. There is an establishment effort to make sure James is kept 'out'."

## Avelynn: a cure for Outlander deprivation?

■ Exclusive interview with author Marissa Campbell and a review her novel about an English heiress and Viking raiders

"It was on a cold, *Outlander-less* night," says *Avelynn* author Marissa Campbell. "I had just finished my hard cover, fresh-off-the-shelf copy of Diana Gabaldon's *An Echo in the Bone*. (For the uninitiated, the book to which she refers is the seventh in the *Outlander* series of novels by Diana Gabaldon).

"I was staring at the final words feeling the mixed emotions of complete satisfaction and deep melancholy that comes from reading a fantastic book and knowing you have to wait another five years before the next book in the series comes out. What on Earth



was I supposed to do for the next five years? Then I had this crazy thought. Perhaps I should write a book for other lost and *Outlander-less* souls like myself."

Engaging. Our hero is the beautiful Avelynn, daughter of Ealdorman of Somerset. She was secretly taught pagan rituals by her mother and she knows how to fight with swords, write, and has even ruled in her father's absence. However, her father insists she marry Demas, who loves her wealth and

status, not her. Avelynn loves Alrik, a Viking raider. Can they be together? And what about her secret supernatural powers? Can she keep them hidden?

*Avelynn* is a ninth century Britain world of secret meetings, sex on the beach, witches, potions and Viking raids. We want to embrace Avelynn as a heroine. Why doesn't she fight alongside her fathers' men? Avelynn and Alrik are mismatched, from different worlds. Alrik could have rescued her, taken her away, then brought her back to help her father and brother. Or, she could have been captured and taken away then escape to come back to help her family. I would have liked more of a hero's journey from the heroes.

"I think the most surprising thing about writing the book was how long it took," says

Campbell. "How long every aspect of the process took. I spent six months alone just researching the time period before I put a single word on the page. I wanted a solid understanding of the world and its people first. Once I started writing, it took a year and a half until I finished the first draft. Editing took another eighteen months, though in fairness this was my first novel. Once I had my manuscript ready to go, I still had to find an agent and publisher. From the moment I began querying and receiving form rejections to the much anticipated release day, it took another year and a half to get *Avelynn* in stores."

"I couldn't travel to ninth century England, so I relied heavily on maps illustrating the lay of the land a thousand years ago, and books on native flora

and fauna," says Campbell. "I bought a lot of history books about the Anglo-Saxons and Vikings, but also spent time reading about the political powers and events on the continent. I read books on leechcraft, paganism, herbalism, and magic. Every little aspect of ninth century life... I had to cross-reference my facts constantly. For example, at one point in the story I needed to know if churches had bells. Turns out that a few did."

Campbell says that finding an agent and publisher has meant having all her dreams come true.

*Avelynn* is Campbell's first novel. About ten years ago, while working as a yoga teacher, Campbell wrote a spiritual self-help book with yoga teacher Annemarie Greenwood. *Life: Living in Fulfillment Every Day*

## Russia decision will be 'defining moment' of Coe's career, says Daley Thompson

Daley Thompson has urged his fellow British luminary Sebastian Coe, the head of world athletics, to "stand up and show some leadership" with his sport embroiled in crisis.

In the wake of a World Anti-Doping Agency commission which reported widespread, state-backed doping of Russian athletes, former decathlete Thompson said his friend and fellow double Olympic champion Coe had been presented with the "defining moment" of his IAAF presidency.

On Friday (Saturday morning, AEDT), the IAAF Council meet in Monaco to consider sanctions against the Russian athletics federation after a recommendation from the commission that it be suspended.

### 'serious consequences'

"What the whole situation needs is for its leader - and Seb Coe is the custodian of what I think is the greatest sport in the world - to stand up and show some leadership," Thompson told Talksport radio.

"He needs to let the people know, he needs to let the cheats know, and he needs to make sure all the other federations understand there are serious consequences to this. I reckon he needs to make some examples [of the cheats]."

"He has the best

interests of the sport in his heart. He cares about it passionately and he wants to see it thrive. I don't think he will allow this situation to continue. "He has to stand up and make some proper decisions, but not in a back-door diplomacy way. He needs to be upfront and let the public see what he's doing.

"If that means more

and more bad things come out, then so be it. Let's clear the decks and start again. This is going to be the defining moment of his presidency."

Russia hopes to prevent its athletes being banned from next year's Rio Olympics by claiming "irregularities" around its drug-testing system were down to the sport's "old leadership".

# Moyes tipped for Celtic job

■ Former Everton and United boss exits Real Sociedad  
 ■ Leeds also reportedly pursuing Scottish manager

**DAVID MOYES** has been made even money favourite by bookies to be the next Celtic manager after he was sacked by Real Sociedad.

The former Everton and Manchester United boss, who was axed at the weekend by the Spanish club along with his assistant, fellow Scot Billy McKinlay, had been in charge for exactly a year.

Now bookies believe Parkhead will be the next managerial destination for the 52-year-old who played for three seasons for Celtic from 1980.

Moyes, whose contract

was set to expire in June 2016, won 12 games out of 38 to guide Sociedad to a 12th-place finish in the 2014-15 La Liga campaign.

The former Preston and Everton gaffer spoke earlier this year about his desire to return to Celtic Park.

Moyes said: "I've always thought that some day. I always think you have to be ready to manage Celtic, you have to be prepared and ready for it.

"It's a worldwide club so you have to be prepared and ready when you go to Celtic. Glasgow is my home and it always

will be."

The move to Sociedad was the Glaswegian's first job after he was sacked as Manchester United manager in April 2014 following a 10-month spell in charge.

Moyes spent 11 years at Everton before succeeding Sir Alex Ferguson as boss at Old Trafford.

But Celtic are not the only club said to be monitoring Moyes. Yorkshire businessman Steve Parkin is also reportedly keen on signing Moyes to manage Leeds once his £30million takeover goes through.

Parkin is negotiating a

buyout at Elland Road with majority owner Massimo Cellino and feels the Scot is the right man to lead Leeds back into the Premier League after an 11-year absence.

Multi-millionaire Parkin hopes to gain control of his beloved Leeds within the next few weeks and is already planning their revival.

The haulage tycoon will

not dispense with current boss Steve Evans immediately and he recognises that the Scot has steadied Leeds, winning two and drawing two of his first five games.

## Rooney feels Spain pain

England boss Roy Hodgson has announced captain Wayne Rooney will not start Friday's friendly against Spain in Alicante.

Hodgson moved to quash any potential speculation over his decision, insisting he is simply keen to give all of England's forward players a chance to press their case ahead of Euro 2016.

Manchester United striker Rooney will, fitness permitting, instead feature against France next Tuesday.

Hodgson said: "Wayne's with me today because he's the captain of our team, he's the most important figure as a result, but he actually won't start the game tomorrow.

"I'm telling you that because Wayne and I are very anxious that we're not trying to fool anybody or bamboozle anybody when he's sat alongside me.

"That's for the very simple reason that we're looking at various combinations.

"Wayne is pencilled in against France on Tuesday."

Rooney understands the need to rotate the squad, adding: "It's important especially in these games that the manager has a chance to see as many players as he can before the tournament in the summer.

"As a player you want to play but you have to understand that there are bigger things to consider."

Hodgson has been happy with the players' attitudes during the five-day training camp in Spain, insisting the conditions will stand them in good stead for next year's European Championship.

He said: "It starts the players thinking and feeling about what it's going to be like next

summer, we're outside of a normal environment in England and we're preparing in a hotel away from home in good weather which has been very useful for us.

"I'm really pleased with the way the players have applied themselves with the energy and enthusiasm they've shown and I know they're very, very keen to show what they can do..."

"At the front we've got Wayne and Jamie Vardy, we've got Harry Kane and Ross Barkley, there's combinations there that interest me."

As for the rest of his line-up, and the identity of the captain in Rooney's absence, Hodgson was keeping his cards close to his chest.

"All I'm saying is what I've said about the team and the starting line-up," he said.

The match took place after the British Weekly went to press.
