FEARSOME FRANK BATTERS BRITAIN

■ No respite for the sodden north as sixth storm of the season brings widespread flooding and leaves thousands without power

THERE was no holiday relief for storm-tossed Britain this week as heavy rain and high winds from Storm Frank battered much of the country.

As the British Weekly went to press gales and further torrential downpours were expected in flood-affected parts of Cumbria and Croston, Lancashire, with residents being urged by officials to immediately evacuate their homes.

Sir Philip Dilley, the chairman of the Environment Agency (EA), was due to visit flood victims in Yorkshire after he returned from a two-week holiday to Barbados amid criticism at the timing of his break during some of the worst storms in decades.

Three severe flood warnings are in place in Croston, while across England and Wales more than 40 flood warnings and more than 80 lower-level flood alerts were in force at press

time.

About 5,500 homes are without power in Scotland, while more than 2,000 homes in Northern Ireland experienced overnight blackouts as Frank swept in from the Atlantic.

More than 90 flood warnings have also been issued north of the border, while a red weather warning was issued overnight for the Isle of Man, with up to 100mm of rain expected on high ground.

Lisa Pinney, a flood manager for the EA, said that river levels had been falling but the renewed rainfall increased the risk of further flooding in saturated areas like Cumbria, Lancashire and Yorkshire.

She added that persistent rainfall in Wales meant there was also a chance of flooding

in the west and southwest of England.

Ms Pinney said: "Overnight we've had some rain but more wind. Based on the forecast we've had, we're not expecting to see scenes like we've had over the past few days and not see flood defence over-topping, for example.

Horror storms finally put a damper on property prices

■ Experts warn of more to come as “we are building faster in the flood plain than anywhere else.”

THE SEEMINGLY unstoppable rise of British property prices has finally met its match – this winter’s brutal weather.

Real estate agents have warned that house prices in flood-hit northern towns will slump and some homes will be unsellable for at least a year following the latest storms.

Prices in flood-prone parts of Cockermouth, Cumbria, have collapsed by more than a quarter after the town was flooded three times in the past ten years, including in early December, Land Registry figures show.

Over the same period, average house prices have grown by 25 per cent, according to the Halifax, meaning that homeowners in Cockermouth are effectively nursing losses of about 50 per cent.

“Areas of York and Leeds hit by floods will be very difficult to sell in future if the experience of Cockermouth is anything to go by,” Martin Goode, a local estate agent, said. “Over the next year, these homes just won’t sell or, if they do, it will be at a very low price.

“My advice to

homeowners is to wait to see what the Environment Agency and the government will do before you even think of selling.”

Andrew Holmes, an estate agent in Kendal, another town in Cumbria that was flooded earlier this month, said: “The question isn’t value but sellability. Buyers are naturally going to be wary of recently flooded homes and will be asking lots of questions.

‘flood defences’

“If there is a straight choice between similar properties that have flooded and ones that have not then buyers will always choose the ones that haven’t.

“We had flooding here 12 years ago and, initially, none of the homes came on to the market because they just would not have sold but, gradually over time, they have bounced back and are selling again now.

“The damage to house prices is restricted to properties that have actually flooded rather than the town itself.”

The experience of towns such as Cockermouth suggests

that only landlords are prepared to buy in areas at high risk of flooding.

Mr Goode, whose estate agency office had two feet of floodwater at the start of the month, said: “Home-owning families don’t want to buy properties that will flood, but landlords are prepared to grab a bargain because the rental yield will be good.”

Those facing the biggest problem were owners of large family homes, he warned. “There are a few nice £400,000-plus homes in Cockermouth that have flooded more than once and I think, realistically, the owners would have to invest in their own flood defences if they want to sell.”

government plan

An adviser to the government warned that the country was “storing up problems for the future” by permitting building on flood-risk land.

Residential development in areas at risk of flooding within the next 30 years has increased by 1.2 per cent since 2011, compared with a rise of 0.7 per cent over the same period in areas thought to be safe for the

next 1,000 years, according to the Committee on Climate Change (CCC). “We are building faster in the flood plain than anywhere else,” Lord Krebs, a CCC subcommittee chairman, told The Daily Telegraph. He added that

problems could be made worse by increasingly extreme weather. “Today’s unprecedented may be tomorrow’s norm,” he warned.

This week it emerged that home and business owners in certain flood-stricken parts of the country now face ruin

because the prohibitively high cost of insurance for properties that have previously flooded.

A new government-backed initiative called Flood Re should help to drive down the cost of cover from April, but that will come too late for many.

"But we're aware the ground across the north of England is absolutely saturated. We're not complacent."

She said the agency and its partners were working with communities like those in Appleby, Cumbria, which has been flooded by Storm Eva and Storm Desmond this month, to make sure they were prepared.

Earlier, Sir Philip spoke to reporters outside his Edwardian apartment in Marylebone, west London, saying he would be "very happy to speak" to people when he got there.

'effective and efficient'

The EA chairman, who is believed to earn £100,000 a year, said: "My focus really is to go and see what's happening, to see the good work that's been going on, but most importantly to see the communities who have been affected."

Responding to questions about his whereabouts during the floods, he said: "Everybody can't be everywhere at the same time."

It followed another day of chaos caused by bad weather, particularly in the Yorkshire area.

On Tuesday night, soldiers were sent in to evacuate homes around a 300-year-old bridge after it started to collapse, prompting fears of flooding and a possible gas explosion.

Police have warned that looters are preying on empty properties in flood-affected areas as forecasters said further downpours and strong winds are expected to last into the weekend.

With Britain battered by the fourth powerful storm in a month this week, West Yorkshire police said opportunistic thieves had removed items left outside to dry in the Calderdale Valleys, while a bicycle shop in Todmorden reported that it was targeted.

Dozens of locals posted claims on Facebook that they had spotted people attempting to steal possessions.

A force spokeswoman said that "reassurance patrols" were being carried out, however a request by a local motorcycle group to help patrol the area had been turned down.

Most of the nine severe flood warnings issued by the Environment Agency – meaning potential loss of life – are centred on York, which was inundated on Boxing Day by Storm Eva.

With over four inches of rain falling in parts of Cumbria on Wednesday from Storm Frank, rising

to over six inches or more in exposed areas, further flooding was expected in the areas hammered by Storm Desmond on December 5.

Southwest Scotland is subject to an amber warning, with over six inches of rain possible in the most vulnerable areas during the sixth named storm of the season.

'further flooding'

Rory Stewart, the floods minister, warned that there could be a "very bad situation" for flood-affected areas in the coming days.

He told the BBC Radio 4 Today programme: "These emergency services personnel have been working really hard, so have volunteers."

"I'm now working my way across Yorkshire, heading back up to Cumbria."

"People have barely had a break for three and a half weeks because this has been going continually since early December."

"As you say, there's another front coming in, there could be more flooding again so we really need emergency services, voluntary groups, mountain rescue to rest to be ready for

what could be a very bad situation Wednesday, Thursday."

However, the water level of the river Foss in York is falling after the Foss Barrier, which was

opened on Boxing Day after its pumping station became "overwhelmed" by the deluge, was repaired by engineers on Tuesday.

Will Lang, a Met Office

meteorologist, said: "Everyone should be aware of the potential for disruption in places from further flooding and the impacts of the gales to transport."

7/7 suicide bomb plot couple jailed for life

■ Sana Ahmed Khan and secret husband Mohammed Rehman, 25, jailed for plotting terror outrage on anniversary of 7/7

A woman who planned an Isis-inspired suicide bombing with her secret husband was the driving force behind the plot which has now destroyed her parents' reputations, a court heard this week.

Sana Ahmed Khan, the daughter of a magistrate, sought out the Islamist justification for the atrocity before encouraging partner Mohammed Rehman to pursue her warped ideology.

The pair were just days away from launching their attack on a shopping centre or Tube network which would have left dozens dead, when they were arrested in July.

They were jailed for life on Wednesday after being convicted of planning a terror outrage around the tenth anniversary of the 7/7

London bombings.

Judge Mr Justice Baker warned they may never be released unless they renounce their Islamist view.

The family of Rehman, who have disowned him, said the pair had got what they deserved. Khan, 24, was the daughter of respectable middle class professionals, including a magistrate mother, who had brought her up to be "open, honest and tolerant" but she had turned to "hate them".

'call for jihad'

However, she begged for leniency in a letter to the judge in which she admitted she had shattered the good name of her family.

She wrote: "My mother, a judge herself, has lost her position, her child and the respect of friends and family.

"I employ you to have mercy when considering my sentence."

The judge rejected her pleas and jailed her for life with a minimum of 25 years.

He said: "Although I do not consider that it is likely that you were initially attracted by the excitement which appeared to be offered by engagement with the actions of Islamic State, I am satisfied that it was you who became interested in the theological justification of its aims, and thereafter encouraged Mohammed Rehman to pursue its ideology.

"Once you had gained that mindset, I am satisfied that you too determined to fulfil the Islamic State's call for jihad, by the carrying out of an act of terrorism within the United

Kingdom."

Sentencing Rehman, 25, to life with a minimum of 27 years, Mr Justice Baker said: "You had become a radicalised Islamist, committed to the ideology of Islamic State including the furtherance of those aims by committing an act of terrorism within the UK.

'ashamed of us'

"The type of act which you envisaged not only encompassed the use of explosive substances which would be used to maximum

effect so as to cause multiple injuries and fatalities, but specifically included a suicide bombing, an act which envisaged martyrdom."

The judge suggested Khan and Rehman, both from Reading, had turned to extremism after becoming disaffected from their families.

They married in a secret Islamic ceremony but have since divorced and turned on each other during the trial.

Rehman's family said he turned to terror to try and impress his well-to-do girlfriend.

His sister said: "She was this posh girl. Her family are very proper. And she made him feel beneath her. I think he was ashamed of us and that's why he didn't want our family to meet her family.

"They wear nice

clothes and speak really well. I knew he was seeing her and that he had a way of speaking to her, like he always wanted to impress her."

The couple idolised 7/7 bomber Shehzad Tanweer, and Rehman had made his own martyrdom video, the court was told.

He was caught after arousing suspicion from the police by going online as the "Silent Bomber" and asking Twitter followers where he should attack.

Khan, who has a degree in English from the University of Greenwich, in southeast London, had been funding the bomb factory with her wages and by taking out payday loans.

Mr Justice Baker said the pair remained a significant danger to the public.

Englishman makes record 7,400-mile rowboat voyage across the Pacific

....and now all he wants is a Ginger Nut

■ John Beeden rowed from Queensland to San Francisco in seven months

■ Expat rowed 15 hours a day in a 19ft boat during the mammoth journey

■ 53-year-old did trip after rowing across the Atlantic and finding it 'not hard enough'

A British father has celebrated reaching Australia after a seven-month solo-row across the Pacific Ocean with his favourite British biscuit.

Shortly after stepping off his boat in Cairns, Queensland, John Beeden, 53, said he was most looking forward to 'a ginger nut biscuit and a shower'.

Mr Beeden, from Sheffield, has become the first person to row solo from North America to Australia in one unbroken journey, but revealed he nearly gave up on the finish line.

severe weather

Mr Beeden touched land for the first time in 209 days as he arrived in Cairns, Queensland on



After leaving San Francisco, in June, Mr Beeden he rowed south of Hawaii, through the South Sea Islands by the Coral Sea and past the Great Barrier Reef to Cairns.

Saturday having rowed 7,400 nautical miles since setting off from San Francisco on June 1.

Mr Beeden, who lives in Toronto, Canada, took on the challenge after previously rowing the Atlantic in 53 days and not finding it challenging enough.

He had originally planned on finishing his Pacific row in November, and joining his wife Cheryl and teenage daughters for Christmas, but the trip ended up taking three months longer than expected due to severe weather.

'There were times I didn't think I could go on. When you keep getting pushed back hundreds of miles that you have already rowed you have to dig deep,' he told the Daily Express.

lost 25lbs

He revealed he was closest to giving up when he was just 54 miles from Cairns harbour, on Christmas Day, as weather conditions made it impossible for him to make headway.

'I didn't realise the Pacific was going to be so difficult. I have peered right over the edge a few times,' he told the paper.

After leaving San Francisco, he rowed south of Hawaii, through the South Sea Islands by the Coral Sea and past the Great Barrier Reef to Cairns.

Mr Beeden lost 25lbs during his journey, despite being on a 4,000-calories-a-day diet (including a fair few of his favourite ginger biscuits).

After stepping off his 19ft boat on Saturday,

Mr Beeden said: 'To be the first person to achieve something on this scale is incredible really.'

'I haven't processed it yet. Every day there was some massive challenge.'

'difficult challenge'

Mr Beeden told Sky News he had rowed for 15 hours a day during the challenge, which took 209 days.

'Every day there was some massive challenge,' he said. 'It was 10, 15, 100 times harder than I thought it would be.'

'It wasn't the record I was interested in. I did the Atlantic three years ago and, not that I found it easy, but it didn't push me as far as I thought it would so I went out looking for a difficult challenge and I found one that was definitely what I was looking for.'

Mr Beeden's highs and lows during the journey were documented on Twitter.

His final low came during the last push on Christmas Day when he tweeted: 'I'm exhausted,

heat & humidity horrible 2day.

'Have received some brilliant messages of support which will help get me to the finish line.'

Cheryl Beeden praised her husband and said that he would not stop aiming for more records. She said: 'He's an amazing guy, he's different than a lot of other people - he'll always fight to get the mile when he's having a bad day... he'll always be rowing.'

'I kind of think it's like childbirth because he says he's not going to get in another boat for a while - but I am sure in a couple of weeks he'll be having some other adventure, and I will have to restrain him a little bit.'

Tributes flow as Motorhead's 'Lemmy' Kilmister dies at 70

■ Hollywood resident dies at home just a few blocks from his beloved Rainbow Bar & Grill shortly after cancer diagnosis

Ian "Lemmy" Kilmister, founding member and singer in the British heavy metal band Motörhead, has died at his home in Hollywood at the age of 70, shortly after learning he had been diagnosed with cancer.

The band announced on their Facebook page that Lemmy learned of the disease on 26 December, and was at home when he died.

Lemmy, born Ian Fraser Kilmister, formed Motörhead in 1975 and was its only constant member, as singer and bassist. The band released 23 studio albums and are best known for their 1980 single Ace of Spades.

The Facebook post said: "There is no easy way to say this ... our mighty, noble friend Lemmy passed away today after a short battle with an extremely aggressive cancer. He had learned of the disease on 26

December, and was at home, sitting in front of his favorite video game from The Rainbow which had recently made it's way down the street, with his family.

"We will say more in the coming days, but for now, please ... play Motörhead loud, play Hawkwind loud, play Lemmy's music LOUD. Have a drink or few and share stories."

It was the second Motorhead death in less than two months, with former drummer Phil Taylor passing away aged 61 in November.

"The world seems a really empty place right now. I am having trouble finding the words ... He will live on in our hearts. RIP Lemmy!"

Lemmy's public struggles with illness intensified in recent years. The singer underwent surgery to have an implantable defibrillator placed in his chest in 2013,

and has cancelled shows in recent years due to exhaustion and a haematoma.

The band had been scheduled to tour the UK and France in early 2016.

Lemmy was born in Burslem, Staffordshire, on Christmas Eve in 1945. His musical career began in the early 1960s and he was, for a time, a roadie for Jimi Hendrix. He played in several rock bands, including the Rockin' Vickers, Sam Gopal and Hawkwind, before founding Motörhead (originally named Bastard).

'a great man'

He wrote in his autobiography, White Line Fever, that he had been fired from Hawkwind for "doing the wrong drugs".

Motörhead's loud, fast style was a pioneering force in heavy metal. Lemmy's vocal growl and aggressive bass playing

has been emulated by countless other bands, but the singer joked that he largely learned on the job, telling Spin in 2012 that "the volume's loud so nobody really notices that much".

The band's highest-rating record was the 1981 live album No Sleep 'Til Hammersmith, which peaked at number one on the UK album charts – a testament to the band's crushing onstage performances.

Other highlights from Motörhead's extensive discography include their second and third albums, Overkill and Bomber, both

recorded in 1979, and several high-rating singles in the early 1980s. The Ace of Spades album reached number four in the UK charts, and the single number 15. Despite the band's success, Lemmy said in interviews over the years that he had made more money from writing Ozzy Osbourne's 1991 hit Mama I'm Coming Home than from the entire Motörhead catalogue.

He told the Guardian earlier this year: "I didn't really want to be in the lifestyle without the music. And I didn't want to be in the music without

the lifestyle."

Among those to pay tribute to Lemmy after his death was announced were Megadeth founder Dave Mustaine, Gene Simmons, the Kiss frontman, and Motley Crue's Vince Neil and Nikki Sixx, and rapper Ice T.

Bernie Marsden of Whitesnake tweeted: "Spent many a evening chatting with him, especially about Hendrix! A great man. RIP x."

James Kottak of the Scorpions said Lemmy was "a true friend ... the real deal ... RIP you will rock & roll forever".

The New Year is here and once again we are all making New Years resolutions.

Was there a particular reason you chose LA?

So we came back in winter of 2007 and tied the knot. What do you miss most from home?

The “chippys” - Sausage supper, King Rib supper (which during my US-based eating adventures I have discovered is essentially a deep fried McRib minus the bbq sauce.) I am lucky to live close to a UK shop/restaurant in Burbank called The Buchanan Arms where I can go to get my fix of Irn Bru and Monster Munch. King of the Hill. Because I love propane and propane accessories.

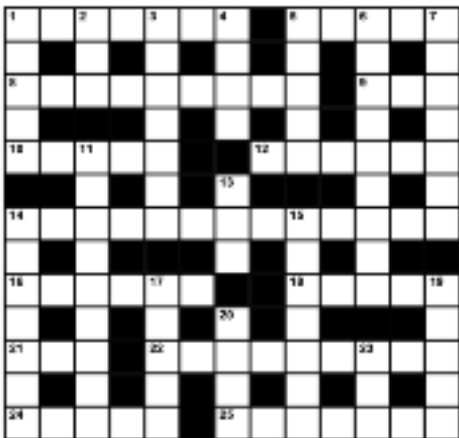

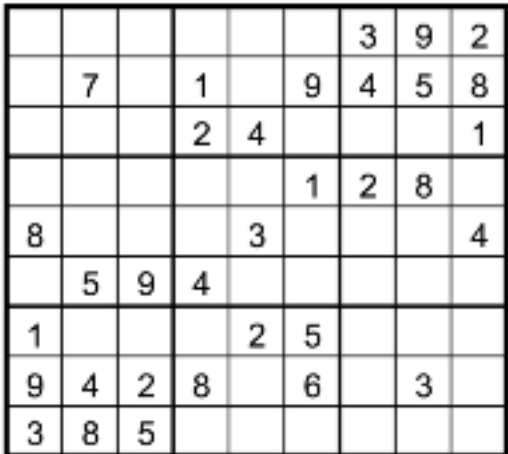

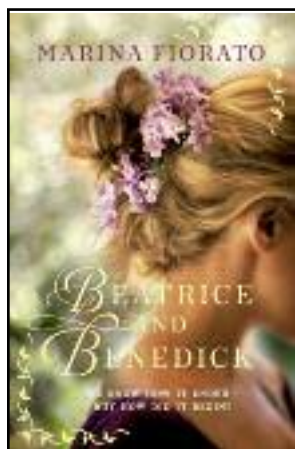

Beatrice and Benedick: Much Ado about the backstory

*Exclusive interview
with author
Marina Fiorato and a
review of her new novel
based on Shakespeare's
Much Ado about
Nothing*

"I've had the idea in my head since I studied **Much Ado About Nothing** at school," says **Beatrice and Benedick** author **Marina Fiorato**. "We would take turns as a class to read the various parts, and it was my turn to play Beatrice when she says to Benedick, I know you of old. Then, later in the text, Beatrice says that Benedick once won her heart 'with false dice.' Aha, I thought, they didn't just meet. They had a love affair. And that was the basis of the book, the story of that first,



unsuccessful relationship, how they parted, and what brought them back together again."

Beatrice and Benedick is a fun story about Shakespeare's ultimate couple at odds. Plato once wrote in *The Republic*, "The beginning is the most important part of the work." That seems true of Beatrice and Benedick. Fiorato writing is so witty and engaging at the beginning it seems an extension of Shakespeare's

play. Readers may prefer she had kept the focus on *Much Ado* rather than bring elements from other of the Bard's plays into her story, which seem a distraction. Surprisingly not a distraction, Fiorato raises an unexpected question... Was Shakespeare actually Italian?

Fiorato's novel starts with the story of how Beatrice and Benedick originally met and why they parted. Beatrice meets Benedick, a young soldier working for a lord from Spain, while staying in Sicily with her uncle. Due to a misunderstanding they part at odds. Benedick sails to England with the ill-fated Spanish Armada. Beatrice returns to her home in the North and an unwanted betrothal. Benedick fights for his life on ship. Beatrice fights an

arranged marriage. When the two meet again there's animosity and tension, but there is still a spark between the two.

Fiorato, who studied Shakespeare at Oxford University, says she relied a great deal on libraries for her research. "I live about ten minutes from the British Library, and the same distance from the British Museum where there is a First Folio," says Fiorato. "We are very lucky in the UK to have some truly fantastic libraries. I've also in my researches used the Bodleian Library. And of course, there is a specialist Shakespeare Collection at Stratford-upon-Avon."

Fiorato traveled to Sicily during her research. "I'd never been there prior to the writing of this book. As someone with Northern Italian heritage [Fiorato's father is from

Venice] I wasn't sure what to expect from somewhere so far south. But, the Sicilians were absolutely lovely and couldn't have been more helpful. I spent time in Taormina, Syracuse, Messina and Palermo, and had a wonderful time. One highlight was being taken up to the summit of Mount Etna by a local guide, accompanied by his tame foxes."

Fiorato spoke about the book at the Stratford-upon-Avon Book Festival, where the Royal Shakespeare Company preformed *Much Ado about Nothing*. "It was pretty special to talk about the characters in Shakespeare's birthplace and then see a company as prestigious as the Royal Shakespeare Company performing straight afterward," says Fiorato. "Because the play was

being staged by the traveling company, there was a wooden thrust stage and a small cast in Tudor costume in the grounds of a stunning English castle garden, just as the play would have first been performed."

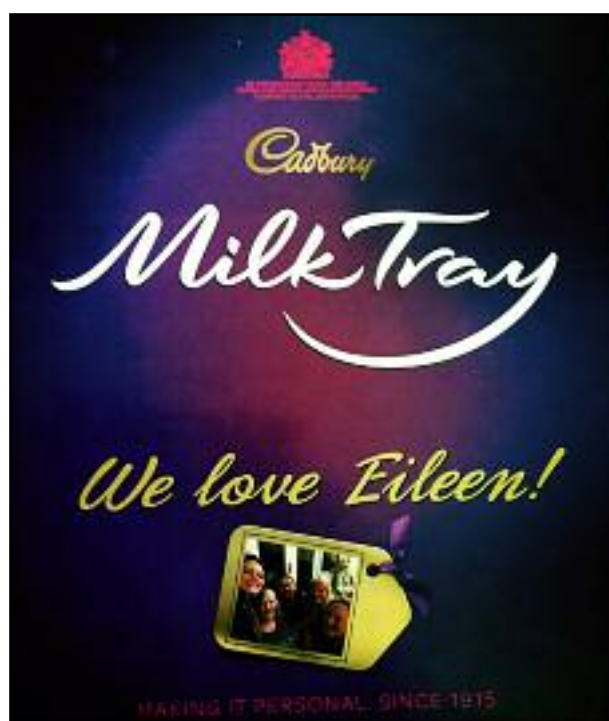

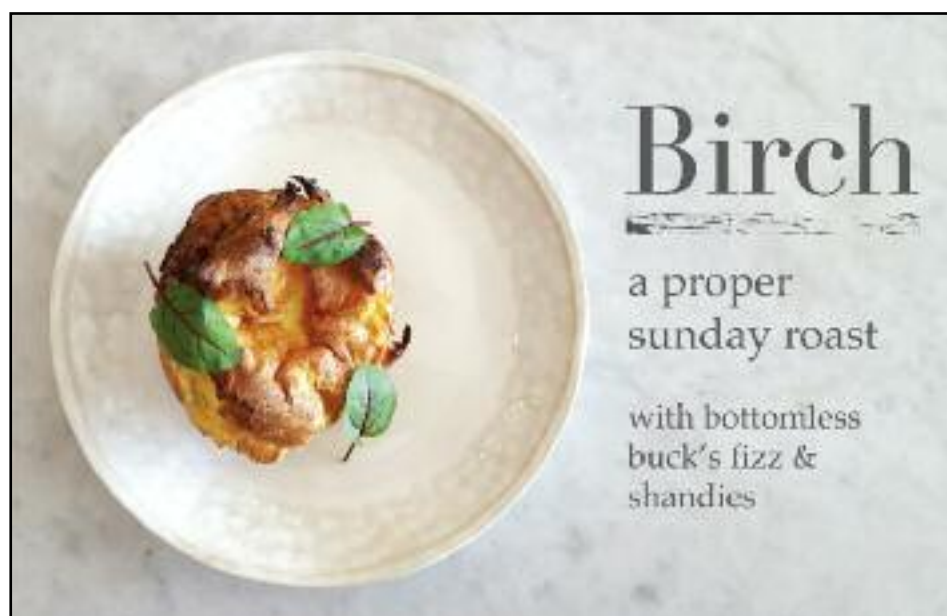

"Unfortunately we cannot announce anything at the moment about this player because nothing has yet been concluded."

Wenger is prepared to gamble and allow Mathieu Debuchy to leave on loan next month despite the right back being able to cover for injuries across the backline.

The 30-year-old, who is

wanted by Roma, has started only two league games and is concerned about his place in the France squad for the European Championship finals. "It's not impossible [that he will leave]," Wenger said. "I'm happy if he stays but we'll have to wait and see."

Alexis Sánchez will not be risked against Newcastle United on Saturday, meaning that the striker is likely to return from a hamstring injury when Arsenal start their defence of the FA Cup against Sunderland a week later.

He has been out for four weeks since suffering the injury in the 1-1 draw away to Norwich City.

First Test joy for England

CRICKET: Battle-tested England stun hosts with comprehensive victory in Durban

First Test: Durban
England (303 & 326) beat
South Africa (214 & 174)
by 241 runs

England got the new year off to the best possible start by claiming six wickets for just 38 runs on day five of the first Test against South Africa to seal an emphatic 241-run win in Durban.

South Africa resumed on Wednesday on 136-4 in search of a distant 416 but lost four wickets for seven runs in the first nine overs.

Moeen Ali removed dangerman AB de Villiers with the third ball and Steven Finn finished with 4-42 as the hosts were all out before lunch for 174.

The second of the four-match series begins in Cape Town on Saturday.

It was only England's second Test victory away from home since 2012 and their largest in terms of runs against South Africa since the Proteas were readmitted to international cricket in 1991.

In contrast it was a fourth defeat in the past five Tests for South Africa, whose position at the top of the Test rankings is under increasing threat from India.

The South Africans have gone seven matches

without a Test victory, which equals their longest run without a win since their readmission.

In the 138-year history of Test cricket, only three teams have avoided defeat from being four wickets down on the final day.

And it soon became apparent South Africa would not alter that statistic when star batsman De Villiers missed a turning off-break from Moeen and was given out lbw and upheld on review.

England captain Alastair Cook said: "The lads played really well. It was tough to bat but the way Nick Compton (who made a battling 85) played after being out of Test cricket for a while, he was a rock in the first innings to give us a platform, and then we bowled well in both innings."

Match-winning Moeen

Former England spinner Graeme Swann described the De Villiers wicket as "massive for Moeen, because he will have gone to bed very nervous that people expect him to win the game".

Having made that crucial breakthrough, Moeen produced another wicket maiden in his next over, drawing Temba

Bavuma out of his crease and allowing Jonny Bairstow to atone for his spurned leg-side stumping of De Villiers on day four.

Bairstow calmly whipped off the bails to record England's first stumping for 38 Tests, since Mumbai 2012.

After Finn bowled Dale Steyn, Moeen trapped Kyle Abbott lbw as England grabbed the first four wickets of the day in quick succession.

Chris Woakes captured his first wicket of the match when Dane Piedt was caught off the inside edge onto the pad and fittingly the final wicket went to Stuart Broad, who took 4-25 in the first innings.

After an hour and three quarters of play on the final day, Broad pinned last man Morne Morkel lbw to claim his 320th Test wicket.

Moeen, who finished with match figures of 7-116, who was named man of the match.

England's dominance was built day by day, rather than through any one performance in a particular session. Taylor, Bairstow and Broad all contributed useful first innings knocks to boost England's first innings to

303, although Steyn and Morkel, with four wickets each, constantly looked dangerous for the hosts. Once the tourists took the field, Broad's 4-25 haul and Moeen's 4-69 ensured the visitors would enjoy a

healthy first innings lead despite Elgar's heroic 118 for South Africa.

The second innings followed much the same script, with Compton, Root, Taylor and Bairstow all contributing plenty of

runs without any of them reaching three figures, but doing enough to allow England to reach the vital 300 mark, leaving South Africa a mountain to climb, one that ultimately proved beyond them.
