





Tributes have poured in this week to ‘national treasure’ Sir Terry Wogan, who has succumbed to cancer at the age of 77.

The BBC announced the veteran TV star, known for his long stints presenting Eurovision and the Children In Need charity appeal, died after a short but “brave” battle with the illness.

The broadcasting legend, whose career

spanned six decades, passed away surrounded by his loved ones.

In a statement, his family said: “Sir Terry Wogan died today after a short but brave battle with cancer.

“He passed away surrounded by his family.

While we understand he will be missed by many, the family ask that their privacy is respected at this time.”

A close friend said Sir Terry was close to death and “suffering” when he last saw on him on Thursday.

Brian D’Arcy, who often worked with Sir Terry on the airwaves, said he knew the meeting would be their last.

He said: “He was quite ill at that stage and I knew it wasn’t long. We prepared for the worst, and, thank God, Terry got out of his suffering.”

Villagers in his home village of Taplow, Buckinghamshire, said they had no idea the

broadcaster was so badly ill.

Pub landlord Ian Burne said: “We would see his wife Helen around in the village and often see him in his Rolls Royce coming out of his house.

“He opened up the cricket club here in Taplow and used to do the commentary on celebrity cricket days which they staged.

“Nobody had any idea

he was suffering from cancer. It must have been very quick.”

Wogan’s BBC colleague Clare Balding tweeted: “Devastated about Terry Wogan.

“Grew up listening to him & have been privileged to know & work with him. Warm, generous & supremely talented.”

Chris Evans, who took over Sir Terry's breakfast show in 2009, said: "We are all so terribly sad upon hearing of the passing of Terry. I can't put into words how the whole Radio 2 family is feeling."

To many of us Terry was Radio 2. We still can't believe it."

Prime Minister David Cameron also paid tribute to Sir Terry and his "huge talent".

He said: "My thoughts are with Terry Wogan's family. Britain has lost a huge talent - someone millions came to feel was their own special friend."


"I grew up listening to him on the radio and watching him on TV. His charm and wit always made me smile."

BBC Director General Tony Hall described Sir Terry as a "national treasure".

He said: "Terry truly was a national treasure. Today we've lost a wonderful friend. He was a lovely, lovely man and our thoughts are with his wife and family."

"For 50 years Sir Terry graced our screens and airwaves. His warmth, wit and geniality meant that for millions he was a part of the family."

running gags

A master of Irish whimsy, Wogan enchanted millions of radio listeners with his gentle flights of fancy, running gags and droll observations. During his parallel TV career, he made good use of an ironically arched eyebrow, and a twinkling good humour. People loved listening to him because he made them feel better. His personal motto was "be kind".

Michael Terence Wogan was born in Limerick in 1938, the son of a grocery

store manager, and educated at austere Jesuit schools in a town he later described as having "not a lot of Christianity... but plenty of religion". On leaving school, he spent four years working in a Dublin bank before answering an advert for a job at RTE Radio. Almost 10,000 people applied; Wogan got it. Within a few years, he had become the presenter of a live quiz show, Jackpot, and had married Helen Joyce, a former model described as one of the most beautiful women in Ireland. Their first child, a daughter named Vanessa, died at three weeks, a tragedy that extinguished Wogan's

remaining Catholic faith. They would go on to have three more children. Journalists sent to dig up dirt on Wogan always came back empty-handed; there was never a whiff of scandal.

In 1969 Wogan moved to England, where he worked first as a DJ on Radio 1 before getting his own breakfast slot on Radio 2, Wake up to Wogan, in 1972. From 1979, he also hosted the TV show Blankety Blank, famed for its cheap set and low-grade celebrity panel. Wogan's great skill was in letting the viewer feel they were in on the

joke: yes, the show was rubbish, but there was fun to be had. Blankety Blank pulled in more than 20 million viewers at its peak. He began providing commentary for the Eurovision Song Contest in the 1970s, and found it similarly "rich in comic potential".

In 1982, he was awarded his own chat show; Wogan was on thrice weekly, and often made headlines. George Best came on drunk, sat down, and told him: "Terry, I like screwing." The interview lasted about 20 seconds. David Icke informed Wogan that he was the son of God. Anne Bancroft refused to speak at all. By the mid-1980s, Wogan was the BBC's highest-paid performer - and he believed he was worth every penny. Genial and often entertaining, his chat show remained popular, yet it was axed in 1992 to make way for the ill-fated soap Eldorado. "For a period in the late Eighties, early Nineties, I was probably the best-known face in the country," Wogan observed, years later.

Wogan returned to radio, where the loyal listeners he referred to as TOGs (Terry's Old Geezers or Gals) tuned in to listen to his wry, stream-of-consciousness ramblings, inspired by his love of James Joyce; his pointed digs at BBC top brass; and his self-deprecating jokes, all delivered in a voice as rich and gentle as Baileys Irish Cream.

News in brief:

Lost underground...

More than 300,000 items of lost property were handed into Transport for London last year. Among them were the usual books, bags, keys and umbrellas - but a few were rather more puzzling. Some were the kind of items that make you "scratch your head", said one staff member, and wonder "what they were doing carrying it" - or how they forgot it. These included a prosthetic leg, a life-size stuffed Spider-Man doll, a full drum kit and a large fitted carpet. Some 22% of goods are claimed; the rest are given to charity, or recycled.

New Potter story coming

A new story by Beatrix Potter featuring Peter Rabbit is to be published. The Tale of Kitty-in-Boots, the story of a "a well-behaved prime black Kitty cat, who leads rather a double life", was sent to her publisher in 1914 but never printed. The manuscript was rediscovered by publisher Jo Hanks after she saw a reference to the tale in a 1970s book about Potter.

Online overtakes TV for young Britons

For the first time, young people in the UK are spending more time online than watching television, a new survey shows. Children spend an average of three hours a day online and 2.1 hours watching TV. The annual survey, by charity Childwise, also found the Netflix video streaming service was used more than any TV channel.

EU: in/out vote could come this summer

■ PM outlines new deal over migrant benefits

Britain could hold its EU membership referendum within "a few months", declared David Cameron this week as he welcomed a draft deal published by Donald Tusk, the president of the European Council.

The document, released after intense talks between No. 10 and European diplomats over the past two weeks, broadly addresses the main renegotiation priorities raised by Downing Street. The proposals include a "red card" system that would allow parliaments to block EU plans, and an "emergency brake" that would allow governments to restrict new migrants' access to in-work benefits for up to four years. The proposals will still need to be approved by the other 27 EU leaders. Cameron is hoping that they will do so at a summit on 18-19 February, enabling him to call a referendum on his preferred date of 23 June.

Tusk said the draft deal was "a good basis for a compromise", but Cameron's Eurosceptic critics – who have been in disarray lately as a result of infighting between rival referendum campaigns – denounced it as a "choreographed charade" that would make no real difference.

Cameron is an "excellent" leader in many ways, says **The Sun**. "But there is no getting away from it: his 'renegotiation'... has produced a steaming pile of manure." He promised to transform our relationship with the EU, yet this deal barely changes a thing."

42 years on....Lord Lucan is finally presumed dead

■ Son now free to claim ancestral title

Lord Lucan is now presumed to be dead, a High Court judge has ruled.

A death certificate has been issued 42 years after the peer vanished when his children's nanny Sandra Rivett was bludgeoned to death in London.

He was declared dead in 1999, despite dozens of unverified sightings, but the new ruling gives his son the right to inherit the family title.

His son, Lord Bingham, said: "I am very happy with the judgment of the court in this matter."

Speaking outside the court, he added: "It has been a very long time coming."

Ms Rivett's son, 49-year-old Neil Berriman said: "I think [Lucan is] dead. It is fantastic and I am very pleased for [Bingham]."

Lucan disappeared the night Ms Rivett was murdered at 46 Lower Belgrave St, Belgravia, on 7 November, 1974.

He drove to a friend's house in East Sussex in a borrowed car, which was later found abandoned in Newhaven with bloodstains inside.

The mystery of his whereabouts has excited decades of speculation.

'Admitted crime'

Lady Lucan said at the time of the killing that her husband admitted committing the crime, although he said it was a mistake. It has been reported that she believes Lucan jumped to his death from a ferry leaving Newhaven.

The first reported sightings of Lucan occurred soon after the murder. In January 1975 he

"closure."

Speaking outside the High Court he accepted that some would view the title Lord Lucan as a tainted title but it was his family name and he wanted the right to use it.

Next to him in court sat Neil Berriman, the son of Sandra Rivett, the nanny brutally killed in the Lucan family home in November 1974. The pair have struck up a friendship based on their shared history.

Although Neil Berriman did not object to the legal ruling, he said he still feels strongly that his mother is the forgotten victim who is still awaiting justice.

was supposedly spotted in Melbourne, Australia, and five months later he was apparently spotted in France.

Police in Cape Town went so far as to check fingerprints on a beer glass, reputedly held by the peer.

In 2012, Lucan's brother Hugh Bingham said he was "sure" the missing peer fled to Africa following the nanny's murder. But he then said he was unsure if his sibling was alive or dead.

'closure'

The author of one book claimed an intruder murdered the nanny and attacked Lady Lucan. In another book, a former senior Scotland Yard detective said that Lucan fled to Goa where he lived a hippy lifestyle as Barry

Halpin until his death in 1996.

Other "sightings" of Lucan located him in an ex-Nazi colony in Paraguay, a sheep station in the Australian outback, backpacking on Mount

Etna and working as a waiter in San Francisco.

George Bingham now becomes Lord Lucan in addition to the eighth Earl of Lucan. He had always said this legal process had been about gaining

court, Mr Berriman said the case remained shrouded in mystery.

"Maybe the police know more than they let on. But at the end we have to get to the truth and justice for Sandra."

Miss Marple actor Geraldine McEwan dies aged 82

■ Actor known for playing Agatha Christie character in ITV series died in London's Charing Cross hospital, her family said

Geraldine McEwan, the actress known for playing Agatha Christie's elderly sleuth, Miss Marple, has died at the age of 82.

She played the spinster detective Jane Marple in 12 TV shows on ITV from 2004 to 2009. But her career spanned decades on the small screen and in theatre and films, including box office hits such as Robin Hood: Prince of Thieves starring as the witch Mortiana. She won a Bafta for best actress in 1991 for her role in the TV serial of Oranges Are Not the Only Fruit.

Her son Greg, an actor

and screenwriter, and daughter Claudia said in a statement: "Following a stroke at the end of October and a period in hospital, Geraldine McEwan passed away peacefully on 30 January. Her family would like to thank the staff at Charing Cross hospital who cared for her incredibly well."

McEwan started work as an assistant stage manager at the Theatre Royal, Windsor, near her Berkshire home, at the age of 14. McEwan announced she was retiring from the role of Miss Marple in 2008.

She said at the time: "Of course, it is terribly disappointing to have to pass the baton on, but it has been a marvellous experience to inhabit this role for the last few years, and I am sure that my successor, whomever she may be, will thoroughly enjoy her time with the production team – and with the extraordinarily talented group of writers and actors that they come up with for each series.

"It's been an absolute pleasure to work on Miss Marple since 2003, and I leave with fond memories."



McEwan starred in the role of the spinster detective Jane Marple in 12 TV films.

Her first stage role came in 1946 at the Theatre Royal as an attendant of Hippolyta in A Midsummer Night's Dream, and her West End debut was in 1951 as Christine Deed at the Vaudeville in Who Goes There!


'generous and kind'

In the late 1950s and early 1960s she spent several seasons with the Royal Shakespeare Company.

McEwan worked with Sir Laurence Olivier, Dirk Bogarde, Kenneth Williams, Kevin Costner and Alan Rickman.

Tributes to the actress were posted on social media, with "Geraldine McEwan" trending on Twitter. Actor John Challis, who played Boycie in Only Fools And Horses, said: "Dear Geraldine McEwan – a highlight of my career working with you at the NT [National Theatre] in The Rivals. Generous and kind to all of us. God bless you." Charlie Lawson, who plays Jim McDonald in Coronation Street, said: "The sad death of another fine actress, Geraldine McEwan, today. Check out The Prime of Miss Jean Brodie. Great performance."

And the official Olivier Awards account tweeted: "Sorry to hear that actress Geraldine McEwan had died, aged 82. Our thoughts are with her friends and family. RIP."



Meet John Fletcher: giving the gift of life

John Fletcher is a man on a mission.

The 69-year-old vet (pictured, above), from Fife, became one of the UK's first "altruistic" kidney donors ten years ago, and he is now leading a campaign to encourage others to follow suit. He knows it won't be easy, says Kate Hilpern in **The Independent**. When he first proposed becoming a donor, even his GP "looked at me as if I was mad". It's an attitude he finds infuriating "because almost all of us have two kidneys and only need one, which means the vast majority of us are in a position to give the gift of life really

quite easily". One person a day dies, on average, waiting for a kidney in Britain, and more than 5,500 are on the waiting list and dependent on dialysis – a miserable experience that costs about £30,000 a year. One donor can save the NHS a fortune. But Fletcher says the best reason for giving a kidney is the fulfilment it provides. His went to a woman with five children; she told him he'd enabled her to be a mother again. "I don't know how the idea came to me that I wanted to donate," he says, "but it's been one of the most satisfying things I've ever done."

Tributes flow for Frank Finlay

STARS of the screen and family members have paid tribute to actor Frank Finlay, who died aged 89 surrounded by his family at his home in Weybridge, Surrey this week.

Widely respected in his profession, his family said he was 'renowned for his kindness and generosity', adding that his death was an 'inestimable loss to the acting world'.

Two of his children, Daniel and Cathy, added: "Our dad was a magnificent actor - honest, uncompromisingly truthful, rigorous, fearless and funny. As a loving

father and besotted grandpa, he held his family at the centre of his life."

Born in 1926, Mr Finlay left school at the age of 14 and worked as a butchers apprentice at the family firm, Toppings, in Albert Road in Bolton.

He landed his first professional role in Scotland in 1951, and won a scholarship to London's Royal Academy of Dramatic Art. He did not appear in the West End until he was 31, and after making a series of acclaimed performances in various plays was invited to join Laurence

Olivier's National Theatre Company.

He starred opposite the legendary actor in Othello before reprising his role on the big screen, for which he was nominated for a best supporting actor Oscar for his portrayal of Iago in the 1965 film.

Mr. Finlay enjoyed a busy career on the small screen in late 1960s and early 1970s, being perhaps best known for his roles in Casanova, Bouquet of Barbed Wire and its successor, Antother Bouquet.

He was awarded the CBE in the 1984 New Year's Honours list.

Stop the music, Adele tells Trump

Pop star Adele has issued a statement to distance herself from Donald Trump, after he used her music at his rallies.

The Republican presidential candidate, whose slogan is "Make America great again", has recently been playing Adele's hit Rolling In The Deep as his "warm-up" music.

"Adele has not given permission for her music to be used for any political campaigning," her spokesman confirmed.

It is not the first time Trump has been criticised for appropriating pop songs.

Lawyers for Aerosmith star Steven Tyler sent Trump's campaign a cease-and-desist letter last year, after the politician played the band's hit single Dream On at numerous rallies around the US.

The letter said Trump's use of the song gave "a false impression" he endorsed Mr Trump's presidential bid.

End of the road for the Land Rover

■ 60 years on, a British motoring icon rumbles into the sunset

ANOTHER CLASSIC British icon bit the dust last week, as the final Land Rover Defender rolled off the production line in Solihull.

The definitive British off-road vehicle, which has won fans from Gloucestershire to Mombasa, from the Falklands to Mongolia, was conceived in 1946 by Rover's chief engineer Maurice Wilks and his brother Spencer who had seen the success of the US Army's iconic Jeep and decided they could improve on it. Two years later the first Land Rover was born, boasting permanent four-wheel drive and a set of crawler gears so low you could climb out and have a smoke on the bonnet while the vehicle wound itself across a muddy field.

The Land Rover was an instant hit, with the first year's production of

8,000 quickly selling out. Rover quickly ramped up production to cope with the demand, and 24,000 Landies rolled off the production line in the next year.

Soon enough, Land Rovers were being produced at the heady rate of 1,000 a week, eclipsing sales of the saloon cars Rover had become known for.

Last year, the two millionth example was built, making it one of Britain's most popular cars and although changes have been made over the years

– the Defender name didn't appear until 1990, for instance – at its core it remains the same rugged aluminum-bodied 4x4 that carried countless numbers of soldiers, adventurers, and even royalty across some of the most rugged terrain on earth. And despite emerging in the shadow of the Jeep, the Defender has grown into a legend of competing stature – in many parts of the world, its utilitarian reputation has entirely overshadowed its comparatively domesticated American counterpart.

Land Rover has been struggling to keep up with the EU's ever-more-stringent emissions regulations, and had announced that the end was in sight for the Defender as early as 2013. But even with three years to accept the inevitable, there were still plenty of tears as the team in Solihull said goodbye to their – and the country's – iconic motor last week.

Land Rover will replace the Defender with an all-new version. Its styling and specification are closely-guarded secrets, though it's thought it'll break cover for the first time next year.

Until then, farmers – and Her Majesty – will have to look elsewhere for their ultimate go-anywhere vehicle

Ankle tags for Foyle's driver

■ Actress Honeysuckle Weeks under curfew after speeding in her BMW with a child in the back

Foyle's War star Honeysuckle Weeks must wear an electronic tag after she was caught speeding in her BMW with a child in the back without a proper seatbelt.

The 36-year-old, who was already banned from driving, must adhere to a four-week curfew forcing her to stay at home at night, magistrates have ruled.

The star, who played driver Samantha Stewart in the ITV wartime crime drama, broke the 50mph limit on the A3 in south-west London on August 17 last year.

It then emerged she had already had her licence taken away and

police found the child in the back of the car was not wearing the regulation seat belt.

She has one child, Wade, born in 2011, but it is not clear if her four-year-old was the child involved.

Weeks, of Harrow,

appeared at Wimbledon Magistrates Court under her married name of Stormonth-Darling and pleaded guilty to driving while disqualified from driving.

She was given an electronic ankle tag stopping her leaving

home between 9pm and 7am and was disqualified from driving for four months.


Weeks also admitted speeding and was fined £250, with £85 costs and ordered to pay a £60 victim surcharge.

There was no separate

penalty for the offence of her child passenger - aged between three and thirteen years-old - not wearing the regulation seat belt.

A charge of driving without insurance was withdrawn by the prosecution.

Fiennes to star as Jacko?

Hard on the heels of the “lily white” Oscars controversy, the makers of a new comedy film have caused a stir by casting Joseph Fiennes – the British actor best known for his role in *Shakespeare in Love* – as Michael Jackson.

Fiennes, (above) 45, told the press he was surprised when he was cast as Jackson, who died in 2009 aged 50 – but defended the decision to give him the job. “I’m a white, middle-class guy from London,” he said. “I’m as shocked as you may be.” But he added that Jackson’s “pigmentation issue” meant that by the end of the singer’s life, his skin tone was “probably closer to my colour than his original colour”.

- **PHIL COLLINS** has quietly rekindled his relationship with his third wife, six years after he paid her £25m in a divorce settlement – then the biggest by a celebrity in British legal history. Collins has often spoken of his misery after Orianne Cevey moved to Miami, taking their sons with her. He turned to drink, and became seriously ill. But while in Miami, Cevey’s subsequent marriage collapsed, and she was left partially paralysed by an operation to cure a slipped disc. Last year, Collins moved from Switzerland to Florida to be closer to his sons; and it seems one thing led to another. “We’ve been together for a while,” he told *Billboard* last week, “and nobody’s noticed.”

- **DAVID BOWIE** left an estate worth \$100m – a fortune by normal standards, but relatively little for a megastar. (Elton John is believed to be worth \$480m.) Bowie left most of his money to his wife, Iman, and two children, Alexandria, 15, and Duncan, 44, but also made two bequests to close friends. He left \$2m to Corinne Schwab, his assistant of 43 years, whom he credited with saving his life in the mid-1970s; and \$1m to Marion Skene, the Scottish nanny who looked after his son when Bowie and his first wife, Angie, were “messed up” on drugs, and after their divorce. Duncan Jones has in the past said that he has always regarded Skene as his mother.

Last orders for veteran rockers Status Quo

■ 2016 marks last year of performing for the band, a chart staple in the UK since 1967

VETERAN rockers Status Quo have announced that their current tour will be their last, giving their fans up until December to see an outfit that have been part of the British music world since 1967.

The rock veterans – Francis Rossi, Rick Parfitt, Andy Bown, John ‘Rhino’ Edwards and Leon Cave – will tour England, Scotland and Wales this summer, Europe in October, plus some final British performance dates in December including a big farewell concert expected on New Year’s Eve.

The band started life as The Spectres in 1962 when founders Rossi and Alan Lancaster were still a pair of schoolboys at an East London comprehensive. After several line up changes they morphed into The Status Quo in 1967 and just Status Quo in 1969. From their first hit, *Pictures of Matchstick*

Men in 1967 to their most recent foray into the charts in 2010, the band had enjoyed over 60 chart hits in the UK, with 22 of these reaching the Top 10. In 1991, Status Quo received a Brit Award for Outstanding Contribution to Music.

‘hard to maintain’

They released over 30 albums and changed their line up over ten times throughout their 50 year career.

Founding member Rossi, 66 explained: “It’s getting harder and harder for us to play those shows. It’s 30 years since we last said we were stopping but this is a final decision,” he explained. He stressed that the band may still do “the odd special” and said: “There’s more to come from us in the years ahead, but we won’t tour the electric set ever again.”

Guitarist Parfitt, who

joined the band in 1967, said that the show “hurts now, physically”.

The 67-year-old said: “It’s hard to maintain that level of energy and without that it’s not really a Quo show. So we don’t feel we should continue.”

He continued: “This is definitely the end of our lives on the road with the electric set, life won’t be the same for us – or many of the fans – but we can’t go on at this pace any more.”

Where Phil Collins is cool...

Phil Collins has never been much liked in Britain, says Will Hodgkinson in *The Times*.

He sold millions of albums in the 1980s and 1990s – only to be dismissed as terminally uncool. Yet in America’s hip-hop community, Collins has long been a hero. He first became aware of this while watching a documentary about Ice-T.

“A journalist was looking through his record collection. He pulled out one of my albums and said in a disparaging voice: ‘Phil Collins?’ And Ice-T said: ‘Hey, don’t mess with Phil!’ I thought: ‘My God, has anyone else seen this?’” Pharrell Williams has cited Collins as an influence; and in an article posted online in 2009,



Alan McGee, of Creation Records, described him as the godfather of modern culture. “I liked that. He

said I was on the ground level of hip-hop. Then I made the mistake of reading the [reader]

comments.” What did they say? “The gist of it was: ‘Yes, but he’s still a turd.’”

From a member who is now a friend: If you are looking to stay longer, get yourself a bank account and credit card.







The God's Eye View: you ARE being watched


Exclusive interview
with author Barry
Eisler and a review
of his novel about
domestic spying and
the Internet

"I'd been playing around with a novel based on a top-secret government surveillance program for quite a few years when the Snowden revelations shocked the world in the summer of 2013," says *The God's Eye View* author Barry Eisler.

"The programs Snowden revealed were appalling, yes, but what would be the even worse ones, the ones that would leak later, if at all?"

This thriller may scare you. A government agency's powerful director is collecting information on every person in America, innocent or guilty. The ABC series *Scandal* has



explored a similar world of domestic surveillance. Modern spies and revelations of how much you may be being spied upon right now is described in 18 pages of notes at the back of the book. While the plot is speculative, the details, what the government does in the name of security, are quite real.

NSA director Theodore Anders wants to collect every phone call, email, and keystroke tapped on the Internet. He believes

unlimited surveillance is the only way to keep America safe. Evelyn Gallagher wants to keep her job so she can afford the private school for her deaf son Dash. She manages the NSA's camera network and facial recognition program. She notices a project code-name God's Eye, that seems related to the mysterious deaths of journalists and whistleblowers. How safe is a country where she may lose her life for knowing too much?

Barry Eisler worked for three years as a spy with the CIA Directorate of Operations. "One of the things they taught me at the CIA...that sometimes it pays to cover up the commission of a serious crime by confessing to a lesser one," says Eisler. "Informed by the abuses of the J. Edgar Hoover years, the history of COINTELPRO (the government program

which spied on anti-Vietnam war activists and civil rights leaders, among others), the allegations of NSA whistleblower Russ Tice, and most of all by Snowden's revelations themselves, became the foundation for *The God's Eye View*, with an all-seeing surveillance state. I thought, Hmmm, powerful actors doing terrible things for reasons they believe are good... my kind of villainy"

Eisler says that *The Intercept*, the online news outlet that features heavily in his story, was a great source for his research, both for their reporting on the NSA and the underlying documents they provided. He also follows Bart Gellman's reporting, whose notorious presentation at Purdue University in 2015 freaked out administrators when they found out it included leaked top

secret documents. Eisler says staying on top of whistle-blower Edward Snowden's revelations is a challenge, and led to him creating a list of recommended books, films, and articles on his website.

"What's sadly unsurprising is the way real-world events have continued to catch up to my fiction since I turned in the manuscript," says Eisler. "An extremely suspicious suicide of a reporter and activist at Istanbul Airport. Police monitoring members of parliament in the UK. The secret service digging up dirt to discredit a congressman. The NSA's top lawyer talking about how a terror attack would be helpful for government anti-encryption efforts. The car hack assassination sequence being proven more and more credible. And, how the NSA's XKeyscore vacuums

up countless people's emails, browsing histories, passwords, and other private communications."

Reportedly, fans of Eisler's book include members of the National Security Council. "The name of the novel itself getting support from Admiral Michael Rogers, the head of the NSA," says Eisler.

■ It's hard, says Scot after getting beaten in Australian final yet for fifth time

Andy Murray was in left in chastened mood this week following his latest defeat at the hands of Novak Djokovic.

The Scot spoke only briefly following his straight-sets defeat in the Australian Open final, saying he was keen to be reunited with his pregnant wife Kim and describing his loss as "hard".

The pair's first child is due in the next two weeks and the Briton went to the airport soon after his loss in Melbourne.

"I'm proud I got into this position," said the world number two, who suffered his fifth final defeat in Melbourne.

"I'm just quite looking forward to getting home now."

Murray, 28, was beaten 6-1 7-5 7-6 (7-3) by world number one Djokovic, who claimed his sixth Australian Open title, tying the record of Australia's Roy Emerson.

"Regardless of today's result, it's been hard," added Murray, who thanked his wife for allowing him to play in Melbourne.

"Had I lost in the third or fourth round, it still would have been difficult with everything that happened, but she's been amazing and handled everything unbelievably well.

"I have to thank her for allowing me to play and

stay here with everything that was going on. It was tough."

There was an added incentive to return home early when his father-in-law Nigel Sears, who coaches Ana Ivanovic, collapsed while watching the Serb at Melbourne Park.

"It was the closest I've been to leaving a Grand Slam," said Murray. "It

was a tough couple of days, but thankfully he's fine now."

The Scot left Rod Laver Arena with the local time past 23:00 to carry out his media duties, before heading for the airport.

"It feels like for five days I've been held on almost every single flight," he said. "The first one out of here, I'm leaving."

Delia: I'm not quitting

Ronny Deila has insisted that he will never quit as Celtic manager.

Following defeats by Ross County and Aberdeen in the space of four days, the Norwegian is adamant he has the support of the club's hierarchy.

Deila (right) is also confident Celtic will retain the Premiership title.

"I don't consider it," he said of his position. "I talk with the players all the time, the board, we're in this together and we're going to turn it around together."

• Bolton fighter to meet Mexican for WBC middleweight crown

Amir Khan has confirmed he will fight the Mexican Saúl "Canelo" Álvarez for the WBC middleweight title on 7 May in Las Vegas.

The 29-year-old from Bolton will move up to a catchweight of 155lbs to fight Álvarez, who has only been beaten once in his 48-fight career: on a majority decision by Floyd Mayweather in September 2013.

Khan confirmed the fight on Tuesday through his Twitter account. He wrote: "Delighted to announce i will be fighting @Canelo May

7th Cinco De Mayo, Las Vegas for the 155lbs @WBCBoxing title!"

The fight, which will be promoted by Oscar De La Hoya's Golden Boy Promotions, will be Álvarez's first defence of the title he won in November against Miguel Cotto.

"As the middleweight champion of the world, I will take on the best fighters in the sport and on Cinco De Mayo weekend, I look forward to making the first defence of my titles," he said in a statement. "Amir was a decorated amateur, a two-time

world champion and is in the prime of his career. Fans are in for a great fight on 7 May."

Khan added: "I know Canelo fights the best and wouldn't pass up the opportunity to face me like others have. My goal is to always fight the biggest names and the best fighters, that is why I'm excited for this fight. Also, I would like to thank my team and Golden Boy Promotions for this opportunity. I know I have the speed and ability to beat him and will give my fans what they deserve on 7 May."

Bruno's comeback hopes dashed

Frank Bruno's hopes of returning to the boxing ring have been dashed after he was told his application for a licence would be declined.

The 54-year-old former heavyweight boxing champion posted on Twitter that the British Boxing Board of Control had informed his agent that "should I apply for a licence this would not be granted".

His agent, Dave Davies, confirmed on Monday the board had been in touch, saying: "Frank, like many other former sports stars, misses the good times when he was in the boxing ring and watching his son train has reignited his wish to return to the ring.

"However we have had confirmation today ... that should an application for a boxing licence be

received from Frank it would be declined. As agents for Frank we must respect and accept their decision."

Bruno, who has bipolar disorder, acknowledged he had "certainly set Twitter talking" after he announced on ITV's This Morning that he was "coming back into boxing" to help him cope with the effects of his medication.

Allegri 'has signed Blues deal' say reports

Massimiliano Allegri has agreed a four-year deal to become the next Chelsea manager, according to several unconfirmed reports on Thursday.

Chelsea have been in the market for a new manager since sacking Jose Mourinho in December, with the Blues mounting the worst title defence in Premier League history under the Portuguese.

Interim boss Guus Hiddink is yet to lose a match since assuming control at Stamford Bridge, but will leave the club at the end of the season.

And according to leading Italian sports website *Calciomercato*, his replacement will be Juventus boss Allegri,



(ao who has agreed a four-year deal worth £5.3million a year to join Chelsea next season.

Roman Abramovich was reportedly keen on Pep Guardiola before he agreed to join Manchester City as a replacement for Manuel Pellegrini, who has also been heavily linked with the Blues.

Allegri boasts an impressive managerial

record, though, having guided Juventus to a domestic double and the Champions League final during his first season in charge, and is currently presiding over a club record run of 13 straight wins.

It's claimed that Allegri's desire to manage in the Premier League has been a driving factor in the move.

curtailed in 2012".

Roberto Mancini was City boss at the time, and led them to the domestic title that year.

Pellegrini succeeded the Italian in 2013 and

took the club to a Premier League and League Cup double the following season.

He has won 64 of his 99 Premier League games as a manager, a record only eclipsed by Jose Mourinho, who won 73 of his opening 99 league matches as Chelsea boss.

City could yet win four trophies under Pellegrini this season.

They are already through to the final of the League Cup and are second in the league behind Leicester City.

The Blues are also through to the knockout stages of the Champions League and will play Chelsea in the fifth round of the FA Cup.

"I talked to the club and I will finish my contract on the original date," said Pellegrini on Monday.

"They are not doing anything behind me. I knew this a month ago. But I don't think it's good, this rumour and speculation about different things. I would prefer to finish the speculation today. That's why I told the press, I told the players, and I spoke with the club two weeks ago saying that I would do it."

Why City went for Pep Guardiola was Barcelona's most

successful manager ever, bringing home 14 trophies in four years, including three La Liga titles and two Champions Leagues.

He then took a year's break before joining Bayern in 2013, following the club's Champions League, Bundesliga and German Cup treble under Jupp Heynckes.

He won the league twice in his two full seasons with Bayern, who are eight points clear in his third campaign. He is yet to win the Champions League with the German club and has been knocked out at the semi-final stage twice.

They face Italian giants Juventus in the last 16 of Europe's elite club competition in February and Guardiola said: "Winning the Champions League would make my time here complete."

Liverpool manager Jurgen Klopp spoke to the media before his side's game with Leicester on Tuesday, and said of Guardiola's appointment: "He is one of the best managers in the world, no doubt about this."

Chelsea captain John Terry could stay at the club after all after his contract expires in the summer, says boss Guus Hiddink.

■ Jamie's wonder strike leaves Ranieri purring

Jamie Vardy has been likened to Dutch legend Marco van Basten following his stunning strike against Liverpool.

The Leicester City frontman enhanced his growing reputation with a 30-yard shot that flew past Reds keeper Simon Mignolet on Tuesday.

It was the first of two goals for the England international in a 2-0 win.

Speaking ahead of Saturday's match with Manchester City, Leicester boss Claudio Ranieri said the goal was "amazing - you can put him with Van Basten".

Dutch great Van Basten scored some brilliant goals in his career, including a memorable volley against the USSR in the final of the 1988 European Championship.

The strike helped give the Netherlands a 2-0 win in the final.

Meanwhile, Spurs manager Mauricio Pochettino says Vardy is as good as his own Harry Kane and Manchester City striker Sergio Aguero.

Vardy is the Premier League's top scorer this season with 18, three above fellow England

striker Kane in joint second.

Argentine Aguerro, who cost City a reported £38m in 2011, won last season's Golden Boot with 26 goals.

"Today Vardy and Kane show big quality and the same quality as Aguerro," Pochettino said.

"They are all different and come from different circumstances but today Vardy and Kane are at the same level as Aguerro."
