

Paul Daniels dead at 77

Magician was fixture on British television for three decades

Magician Paul Daniels has died aged 77, after being diagnosed with a brain tumour.

He was at his Berkshire home with wife Debbie McGee when he died in the early hours of Thursday.

"Debbie and the family would like to thank everyone for their support and asks that their privacy be respected at this sad time," his publicist said.

Daniels was born Newton Edward Daniels in Middlesbrough and developed his magic skills in working men's clubs, making his TV debut on talent series Opportunity Knocks.

He then took over the primetime Saturday night slot with his BBC show, which started in 1979.

difficult

Daniels was known for a string of catchphrases, including the line: "You'll like this... not a lot, but you'll like it."

Although Daniels had a reputation for being difficult behind the scenes and fell out with BBC managers who dropped his show in the 1990s, there was no doubting his popularity - or his talent.

He had recently returned from hospital to his Berkshire home, having been diagnosed in February. It was initially suspected he had suffered a stroke after he fell at home, but

it was then discovered he had an inoperable tumour.

His son, Martin Daniels, said at the time: "He has said before, 'When it's your time it's your time' and that's how he is trying to face up to things."

special effects

As well as McGee, who had been his on-stage assistant, Daniels leaves his three sons from a previous marriage - Martin, Paul and Gary.

Gary Daniels tweeted a picture of a rabbit in a magician's hat with a tear in its eye, by friend and artist Helen Martin, and wrote: "It is with incredible sadness that I can confirm that Dad, Paul Daniels, passed away overnight."

In addition to his magic, Daniels presented game shows in the 1980s and '90s, including Wipeout, Every Second Counts and Odd One Out.

He also designed special effects for the stage productions of Cats and Phantom Of The Opera, and was commissioned by the English National Ballet to create magical effects for The Nutcracker.

Daniels had continued touring with his magic show and was booked to perform at venues across the UK this

year, according to his website, before news of his illness emerged.

He supported a number of charities during his life, taking part in fundraising events and entertaining children at Great Ormond Street Hospital.

A fundraising website has been set up by his family to raise money for charities, including a brain tumour charity and the Royal Berks charity, based at the Reading hospital which treated Daniels.

'Outstanding showman'

The Magic Circle said Daniels had "been an inspiration to many magicians" and is of "legendary status" in the world of magic.

In a statement, it said: "At the height of his career The Paul Daniels Magic Show on BBC One pulled more than 20 million viewers - that was more than one third of the British population regularly tuning in on a Saturday night to watch a magician make them laugh and witness feats of wonder such as his famous Chop Cup routine.

"In this day and age of fragmented media platforms, no other magician is likely to be able to achieve such a TV ratings record."

PM summoned before MPs to answer for Libya

■ Fallout continues from Obama's 'distracted' claim

David Cameron has been summoned to appear before MPs over Libya, amid controversy about UK involvement in the war-torn country.

The move comes after US President Barack Obama criticised the Prime Minister for his actions over Libya.

The American leader said European nations, including the UK, had joined the US military action to prevent a massacre in the north African state back in 2011, but then failed to prevent the country becoming a "mess" following the overthrow of Colonel Muammar

Gaddafi.

Mr Obama put some of the blame for chaos in Libya on Mr Cameron becoming "distracted" by other priorities

There have also been claims - denied by the Government - that the UK could send 1,000 ground troops to the conflict-hit north African state as part of an international force of 6,000.

'conventional forces'

The Commons Foreign Affairs Committee said it had been told, during a visit to the region, that the force would train the Libyan army and provide security for the newly-

appointed national unity government.

Libya's UN-backed Government of National Accord, currently based in Tunisia's capital Tunis, is also set to request airstrikes against Islamic State targets, according to the MPs.

A Government spokesman said what the committee had been told was "wrong on a number of counts".

Mr Cameron has also told MPs any plans to send "conventional forces" for training in Libya would be put before Parliament for debate.

Appearing before the

committee in February, Foreign Office Minister Tobias Ellwood said the UK was prepared to "advise, assist, support and train" a national unity government in taking on IS, adding: "We are not going in there to hold and take ground."

Speaking on Sky news, select committee chairman Crispin Blunt said of extending the invitation to the PM to give evidence: "It is an issue that is extremely profound, it has gone on for quite a long time.

"I think that he

deserves a proper opportunity to be able to give a decent explanation as to the decisions that he took and the decisions we are faced with now as a country, given the rather fragile state of the political reconciliation such as it is in Libya."

Even split on Brexit

LONDON (Reuters) - Support for Britain to stay in the European Union was level with that for a withdrawal from the 28-member bloc at 36 percent, an online TNS opinion poll suggested on Thursday.

Support for the "in" campaign was unchanged from a month ago while the "out" campaign fell from 39 percent, the poll showed.

TNS said 28 percent of those who intended to vote did not know

whether to back or oppose membership, up from 25 percent a month ago.

"The major problem for the 'Remain' campaign at present is that their support draws significantly on younger people who are traditionally less likely to turn out in elections," said Luke Taylor, head of social and political attitudes at TNS UK.

TNS interviewed a sample of 1,216 adults between March 10 and March 14.

ANOTHER Top Gear uproar after Cenotaph 'donut' stunt

■ New host Evans issues apology after shocking display at nation's most sacred monument to war dead

TOP GEAR found itself at the center of yet ANOTHER controversy this week after a high-powered Ford Mustang carrying Matt LeBlanc performed a controversial stunt near the famed Cenotaph war memorial.

In a segment which has provoked fury from the Armed forces and beyond, the Mustang shattered Sunday's early morning calm as it drove at high speed past the Whitehall landmark, THEN performed a series of 'donut' turns next to the memorial, wreathing the sacred site in acrid smoke and scarring the road with rubber burns.

Despite an immediate apology from Top Gear host Chris Evans – who recently replaced the controversial Jeremy Clarkson – the backlash continued to unfold during the week, with growing calls for the resignation of Katie Taylor, the BBC's £188,000-a-year head of entertainment.

Senior soldiers suggested that the executive should consider her position – and criticised the Ministry of Defence for allowing Top Gear to film on its property in the first place.

The corporation has now repeated Mr Evans' apology but also said that

stunt driver Ken Block, who was behind the wheel with Mr LeBlanc in the passenger seat, stayed a fair distance from the monument to Britain's war dead.

A spokesman said: 'The driver of the car was briefed by production prior to filming as to where to drive and to not do any manoeuvres close to the monument, an instruction to which he fully adhered'.

'disrespectful'

The BBC also blamed the 'angle' of long lens photographs for making the stunt look closer to the monument, although images and video show tyre marks just a few feet from the Cenotaph and also the neighbouring Woman of World War Two monument.

It was sculpted by artist John W Mills and unveiled by the Queen in 2005, and Mr Mills, 83, said the stunt shows 'a disregard for what the public think. It's totally self-aggrandising. It's not only disrespectful, it's stupid.'

Eans, 49, who took over presenting the show after Jeremy Clarkson was sacked for hitting a producer, said it had been 'unwise to be anywhere near the Cenotaph' and told Radio 2 breakfast show listeners: 'I would like to apologise unreservedly'.

He also admitted he did 'completely understand all this furore' but added: 'This isn't a shoot I'm particularly involved in. I was away with family over the weekend'.

Mr Evans said: 'If it was my decision, then I would say, that particular scene

shouldn't be shown and I think everyone will agree.

'The images on the front page of the papers today - it doesn't matter what actually happened, it doesn't matter what the circumstances were that could explain this away; what is important about this is what these images look like.

'They look entirely disrespectful, which

of course was not, and would never be, the intention of the Top Gear team or Matt.

'So, on behalf of the Top Gear team and Matt I would like to apologise unreservedly for what these images seem to portray.

'There's been some very incendiary comments involved and written alongside these pictures and I

completely understand all this furore.

'But the Top Gear team would never, ever do that. Retrospectively, it was unwise to be anywhere near the cenotaph with this motorcar. Again,

we would like to unreservedly apologise for what these pictures seem to portray, which was never the intention of the Top Gear team.'

Both were said to have seen the hour-long blessing at St Bride's, the spiritual home of Britain's media, as their 'big day'.

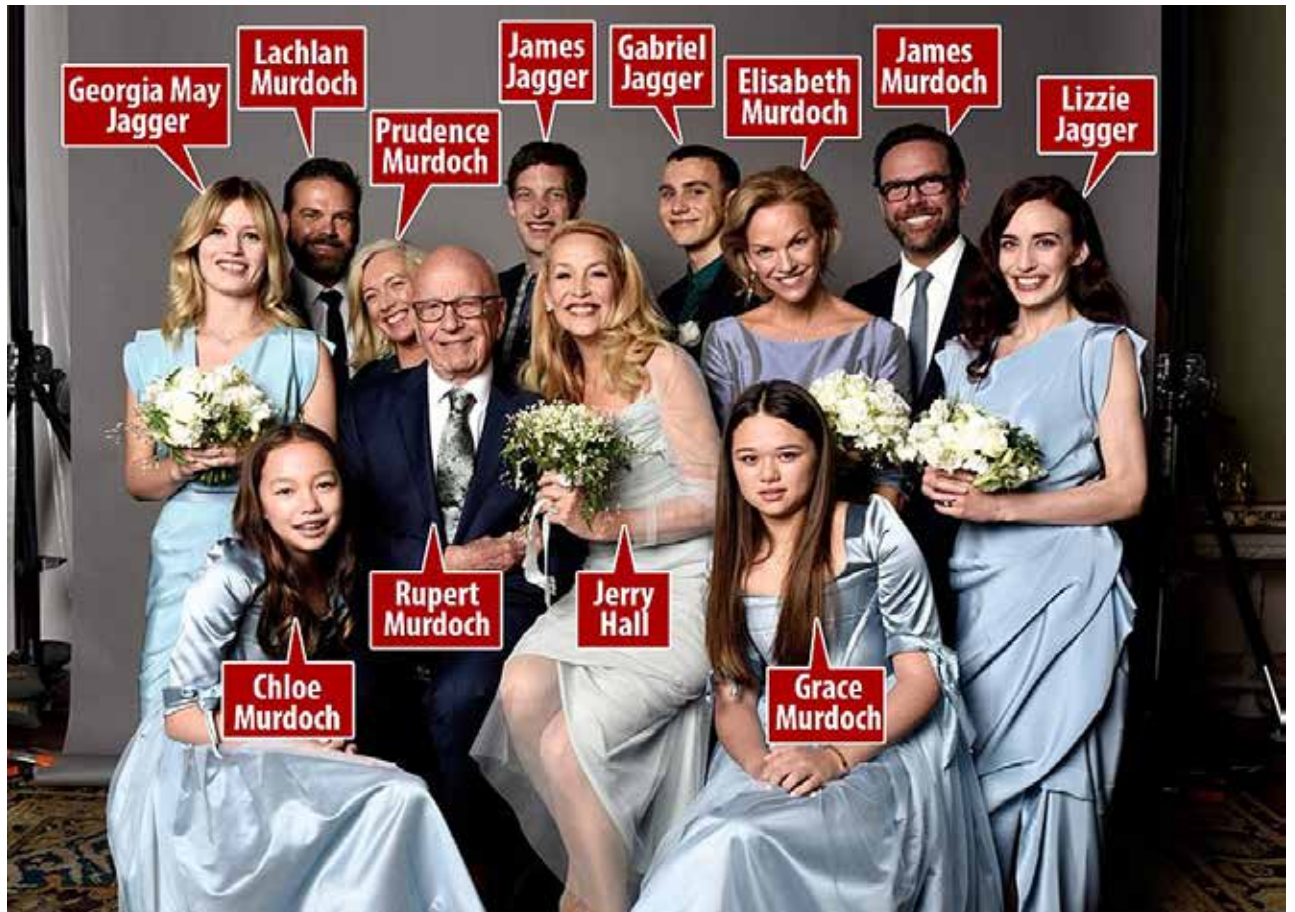
The photo which was tweeted by Hall today was taken during the latter celebration.

newspapers.

Wyman said after the ceremony: 'Jerry has simply not stopped smiling. She was ecstatic – they both were – it was a fantastic service.'

It is the fourth marriage for Murdoch, who owns Fox News Channel, movie studio Twenty-First Century Fox, publisher HarperCollins and newspapers The Sun and The Times in Britain.

It is the first official marriage for Texas-born Hall. She and Jagger had a private Hindu marriage ceremony in Bali, Indonesia, in 1990. During divorce proceedings in 1999 a British court declared the marriage invalid.

Murdoch and Hall reaffirmed their marriage vows at an hour-long church service, which included music by Wagner, Schubert and Vivaldi and the hymns 'Jerusalem' and 'Amazing Grace.'

Harris denies new assault charges

Rolf Harris has denied seven charges of indecent assault - including some against children - as he appeared in court via video link from prison.

The allegations, dating from 1971 to 2004, relate to seven females who were aged between 12 and 27.

One of the alleged victims was disabled.

Harris (pictured, above) is alleged to have molested a girl under the age of 14 at BBC Television Centre in 1983 - and then indecently assaulted a woman in the same building 21 years later.

The Australian-born artist wore a grey suit, white shirt and multi-coloured tie as he pleaded not guilty to all charges at Westminster Magistrates' Court.

He gave his address as "HMP Stafford".

Harris' family issued a statement which was read outside court.

In it, they said: "We are disappointed and saddened that the CPS have decided to take Rolf, who will be 86 years old at the end of March, on another trial.

"Nevertheless he has, as he has always done, cooperated with the authorities.

"We, for our part, will do all we can as a family to assist him in proving his innocence."

The defendant was told to appear at London's Southwark Crown Court on 14 April.

Thunderbirds pioneer Sylvia Anderson passes away at 88

Sylvia Anderson, best known as the voice of Lady Penelope in the TV show *Thunderbirds*, has died after a short illness, her family has confirmed.

Anderson co-created the hit science-fiction puppet series, which ran from 1965, with her late husband Gerry.

In a career spanning five decades, she also worked on shows *Joe 90* and *Captain Scarlet*, and for US TV network HBO.

She died at her Berkshire home, aged 88. Her daughter described her as "a mother and a legend".

"Her intelligence was phenomenal but her creativity and tenacity unchallenged. She was a force in every way," Dee Anderson said.

Her former husband Gerry Anderson died in 2012 after suffering from Alzheimer's.

Nick Williams, Chairman of Fanderson - a fan club dedicated to the work of Gerry and Sylvia Anderson - said she was a "huge influence" on the entertainment industry.

"She was one of the first really prominent women in the film and TV industry," he said, adding that Anderson leaves behind "an amazing legacy of fantastic television, really groundbreaking entertainment."

Puppet pioneers

Born in south London to a boxing promoter and a dressmaker, Sylvia Anderson graduated from the London School of Economics with a degree in sociology and political science.

She spent several years in the US and worked as a journalist before returning to the UK and joining a TV production company, where she met her future husband.

When he started his own company, AP Films, she joined him, and the couple began making puppet shows.

They developed a production technique using electronic marionette puppets, called *Supermarionation*, in which the voices were recorded first, and when the puppets were filmed, the electric signal from the taped dialogue was hooked up to sensors in the puppets' heads.

That made the puppets' lips move perfectly in time with the soundtrack.

In 1963, the couple came up with the idea for *Thunderbirds*, which told the story of the Tracy family who form a secret organisation dedicated to saving human life, set in the future as well as co-creating and writing the series, Anderson worked on character development and costume design.

The character of Lady Penelope, a glamorous agent, was modelled on Anderson's own appearance, and she also provided her characteristic aristocratic voice.

The success of *Thunderbirds* led to two feature films and a toy and merchandise empire.

Three new programmes were made last year to mark the 50th anniversary of the series.

Charity work

Other shows which the couple worked on include *Stingray*, *Fireball XL5* and *Secret Service*.

However, the partnership ended when they divorced in 1981.

Sylvia went on to work as head of programming for HBO in the UK, and write several books.

Her last public interview was on the *Graham Norton Show*

on BBC Radio 2 with actor David Graham, who also provided voices for *Thunderbirds*, in December.

Her family said she was suffering or in need of support", and worked with many charities, including Breast Cancer Care.

ELP keyboardist Keith Emerson shoots himself in Santa Monica

THE BRITISH COMMUNITY in Santa Monica lost one of its more famous members last week, with the death of musician Keith Emerson, keyboardist of the English supergroup Emerson, Lake & Palmer and one of the key figures of the progressive-rock era in the 1970s.

Emerson was found dead on Friday at his home on Fifth Street in Ocean Park, the apparent victim of a self-inflicted gunshot wound. Emerson's death was confirmed by Martin Darvill, an associate of Mr. Emerson's longtime manager, Stewart Young.

"We're all pretty stunned," a female neighbor who lives across the street from Emerson's condominium, told the *British Weekly* this week. "Keith was a really easy-going guy but he kept himself to himself. He really kept 'British

musicians' hours', because we hardly ever saw him during the day."

The neighbor added that it was 'common knowledge' Emerson was suffering from some kind of ailment to his hands which made playing difficult for him. "That may have contributed to his mental state, but we'll never know now," she added.

psychedelic rock

Another neighbor and fellow British expat added: "I've lived here for twenty years and I've only seen him a handful of times, which was when his beloved parrot, Smokey, went missing. He'd walk round the neighborhood calling the parrot's name, which was how I got to know him. About six months later I saw him walking down the street with the parrot on his shoulder. Keith was overjoyed, he told me the parrot had been

missing for months then one day flew through his open window."

Keith Noel Emerson was born in Todmorden, Yorkshire, on Nov. 2, 1944, while his father, an amateur musician, was serving with the British Army. He took piano lessons from an early age and joined a blues band, Gary Farr and the T-Bones, before helping to form the Nice, which combined psychedelic rock, jazz and symphonic music. The band lasted from 1967 to 1970, and toured with Jimi Hendrix and Pink Floyd.

He left the Nice in 1970 and joined forces with guitarist Greg Lake, who had played in King Crimson, and drummer Carl Palmer, who had played with the Crazy World of Arthur Brown and Atomic Rooster. With the advance from the band's first album, Mr. Emerson bought his first Moog synthesizer,

and he became one of the instrument's most enthusiastic promoters.

Emerson, Lake & Palmer lasted from 1970 to 1979, making seven albums, then reformed in 1991 and stayed together until 1998. The band played a single reunion concert at the High Voltage Festival in London in 2010.

Emerson, Lake & Palmer's tours were complicated and expensive, often using

quadraphonic sound: According to an article in *New Musical Express* in 1974, the group traveled with 40 tons of equipment. In some mid-'70s performances, Mr. Emerson rose above the stage on a wire while seated at the bench of a grand piano, which was strapped in place and spinning end over end as he appeared to keep playing. (Mr. Lake later explained that the piano had no insides.)

In more recent years Emerson he had been leading the Keith Emerson Band, which was preparing to tour Japan next month.

Mr. Emerson lived in Santa Monica with his companion, Mari Kawaguchi. She survives him, as do two sons, Aaron Ole Emerson and Damon Keith Emerson, both from his marriage to Elinor Emerson.

life in Australia...

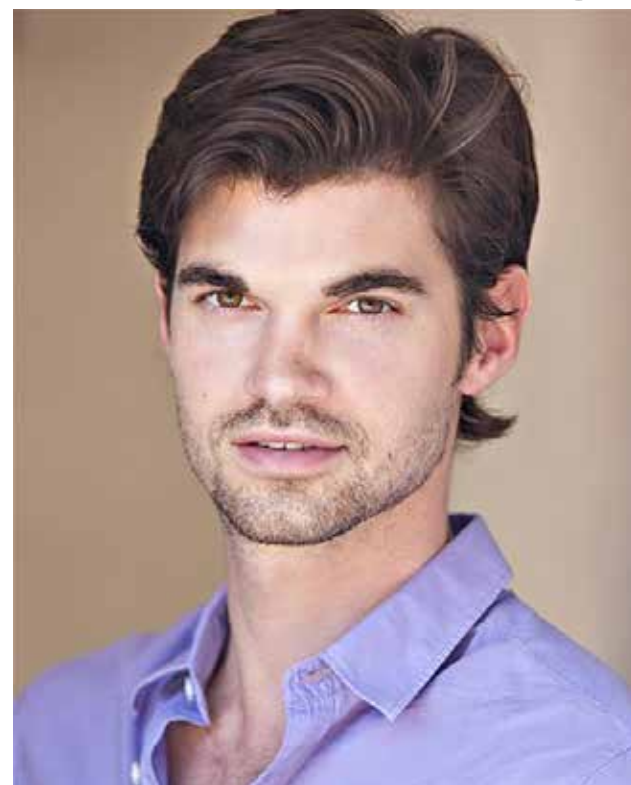
Lots of Our members join our group Brits in LA seeking out words of wisdom – what is the best piece of advice you've been given?

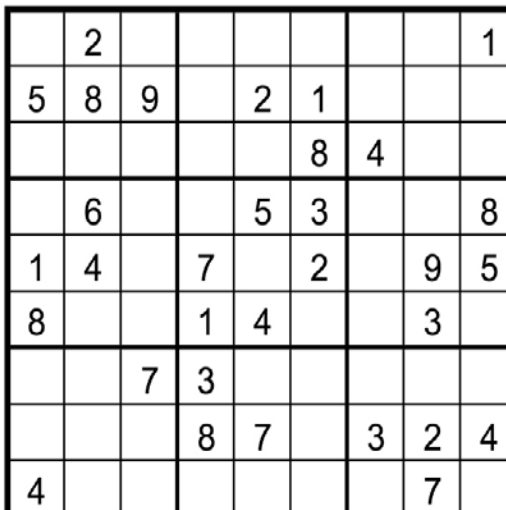

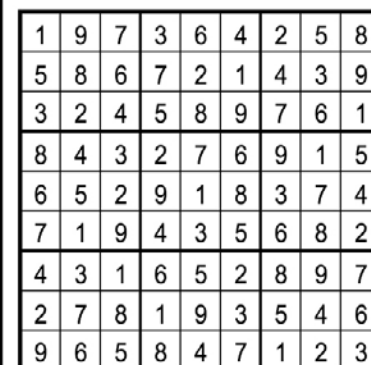

The Madwoman Upstairs: to Brontë and back

Exclusive interview
with author
Catherine Lowell
and a review of her
book about a girl
studying at Oxford
who must solve
a Brontë family
mystery

“It’s been fun seeing just how fiercely the Brontës are loved, and how alive their legacy is,” says *The Madwoman Upstairs* author Catherine Lowell. “During conversations about this book, I’ve learned that people seem to relate to one Brontë in particular. It’s as if identifying your inner Brontë is a form of personality test...I’m an Emily.”

The Brontë sisters, Charlotte, Emily, and Anne, were a nineteenth-century literary family associated with the

village of Haworth in the West Riding of Yorkshire, England. Charlotte’s *Jane Eyre*, Emily’s *Wuthering Heights*, and Anne’s *The Tenant of Wildfell Hall*, all became recognized as literary masterpieces. For their passion, their stories attracted attention and even censure when published, in particular *Wuthering Heights*, which explored the hypocrisy of Victorian morals. One Victorian critic described the book as, “vulgar depravity and unnatural horrors.”

The Madwoman Upstairs is a modern story with an intriguing Gothic twist. Set in Oxford, Lowell’s story mixes romance, history and mystery in a wonderful tale. A girl, the last descendant of the Brontë family, encounters all the twists and turns that life can throw at her while seeking the legacy that her father left. Sometimes Lowell gives the reader figure it out. If you are a fan of the Brontës you will enjoy this romp through their lives.

Samantha Whipple, the last Brontë descendant, was home-taught by her late eccentric father. There is speculation that there is a hidden manuscript. She receives a box with a bookmark. It reminds her of a game her father played with her as a child, leaving her clues. Books she thought lost in a fire start appearing in her room. She has no time for games, she has classes

to attend. Her professor at Oxford, James Oliver, is younger than other professors and constantly challenging her about literature. Can Sam finish her first year and solve the family mystery?

“The idea first took root in college, when I was trying to internally justify choosing to study English,” says Lowell. “I remember thinking though all the practical uses of an English degree. Books generally teach extremely valuable but vague life skills...like empathy. But what are the real-world problem-solving skills you can learn from literature? This became a fun thought experiment. How would an engineer, for example, analyze a novel? Then, I studied at Oxford for a term, where I had terrible insomnia. The first chapter was borne out of hours bored and awake.”

“While I had always loved the Brontë novels, my research left me

with a deep respect for the authors,” says Lowell. “They were extraordinarily brave women, who wrote their novels during a time when writing as a woman was a form of social suicide. My research also showed me a very human portrait of three now larger-than-life authors. I had always loved their books as a kid, and became increasingly interested in the underdog, Anne, a bit of whom I believe lives in all of us.”

This is Lowell’s first novel. “Growing up, I wrote fractured fairy tales featuring burly princesses and a hungry chipmunk named Francine,” says Lowell.

Lowell says she reread all her old copies of Brontë novels. She researched lives of the Brontës at libraries. The original home of the Brontës, the parsonage at Haworth in Yorkshire, is now the Brontë Parsonage Museum with hundreds

of thousands of visitors yearly.

Lowell is currently writing her second novel. She is based in New York City and was born in California. She doesn’t have a website yet, but says it’s coming soon. She has upcoming book events on the East and West Coasts.

Wenger hails Barcelona 'art'

Barcelona have "two or three players who transform normal life into art", says Arsenal manager Arsene Wenger.

The Gunners went out of the Champions League at the last-16 stage for the sixth straight season on Wednesday night after a 5-1 aggregate loss against

Barcelona.

The La Liga side's front three of Lionel Messi, Neymar and Luis Suarez were all on target.

"In the final third, Barcelona's passing accuracy and creativity is exceptional," said Wenger.

Arsenal missed numerous chances in the game, with Danny Welbeck hitting the woodwork and Alexis Sanchez twice coming close.

Having also gone out of the FA Cup in a shock defeat against Watford last weekend, the Premier League is Arsenal's only hope of a trophy this season. They are currently 11 points behind leaders Leicester with a game in hand.

Wenger feels the result could have been different if they managed to add to Mohamed Elneny's crisp effort in the second half.

"I felt, at 1-1, they were wobbling and insecure," said Wenger. "We could not take our chance to score the second goal to put ourselves in a good position."

"We created plenty of dangerous situations and the quality of our game was good. When we lost the second goal, we lost the edge."

SIX NATIONS: England coach eyes Grand Slam

England head coach Eddie Jones has challenged his side to claim a first Six Nations Grand Slam in 13 years.

Saturday's 25-21 win over Wales at Twickenham means England can secure a clean sweep if they beat France in Paris next weekend.

"All we've got to do now is worry about preparing well. If we prepare well, we'll play well," Australian Jones told reporters.

"It's definitely on and

the aim for us now is to win the Grand Slam."

Wales almost pulled off a remarkable comeback against England, though, fighting back from 16-0 down at half-time to within four points.

It was reminiscent of the sides' World Cup meeting last year, when Wales overturned a 10-point deficit to effectively knock England out at the group stage, but this time the hosts hung on.

Manchester City will be without captain Vincent Kompany for at least a month after he injured a calf against Champions League opponents Dynamo Kiev.

The Belgium defender, 29, has started just 13 games in the Premier League this season and has had 14 calf injuries since signing in 2008.

Brazilian leaves Reds in the pink

Philippe Coutinho's brilliant solo goal killed Manchester United's hopes of a Europa League comeback and sent Liverpool into the last eight in comfort at Old Trafford on Thursday night.

Jurgen Klopp's side were protecting a two-goal lead from the first leg at Anfield but Anthony Martial's 32nd-minute penalty offered United brief hope after he was fouled by Nathaniel Clyne.

Jesse Lingard and Juan Mata had missed clear opportunities for United but Liverpool were also a threat as David de Gea saved superbly from Coutinho while Daniel Sturridge hit the bar with a free-kick and Jordan Henderson missed an open goal.

The away goal Liverpool threatened, and which left United needing four on the

night, came right on half-time when Coutinho beat Guillermo Varela with ease before lifting a near-post finish past De Gea.

It ended the game as a contest with United unable to rouse themselves again as Liverpool completed the formalities to win the first European meeting between the two clubs.

Sadly, the final stages of the match were marred by clashes between supporters near the Liverpool corner of the ground - and it remains to be seen if Uefa take any action.

brilliant dribble

Manchester United, in the first half at least, played with a pace, and showed a spirit and endeavour, that has rarely been displayed at Old Trafford this season - but the task was too much.

And that was down to the lamentable performance at Anfield last Thursday when Liverpool dominated every facet of the first leg

to secure a two-goal lead that could actually have been much more.

It left United vulnerable to one goal from Liverpool that would leave them needing four, and so it proved when Coutinho's brilliant dribble provided that crucial away strike.

United, from that point on, looked like

the team they have been for most of this season - pedestrian, uninspired and struggling to illuminate an Old Trafford stage that has suffered much this

season.

And there was suffering in hearing songs of celebration from 3,000 Liverpool fans tucked away in one corner of the stadium

as their arch-rivals celebrated victory in the first European meeting between the two sides and a place in the last eight of the Europa League.

Dortmund complete Spurs demolition

Tottenham Hotspur were unable to produce a shock second-leg comeback as Borussia Dortmund cruised into the Europa League quarter-finals on Thursday.

Trailing 3-0 from the first leg, Spurs needed to score at least five times when Pierre-Emerick Aubameyang's swerving shot flew into the far corner.

And the Gabon striker fired in the German side's second after a swift counter.

Son Heung-min reduced the arrears as toothless Spurs failed to make the last-eight for a third successive year.

Few would have backed Tottenham to turn around

this last-16 tie at White Hart Lane against the inform Bundesliga giants.

The damage was done seven days earlier in Germany when Spurs manager Mauricio Pochettino decided to play a weakened and inexperienced team against one of the favourites to win the Europa League.

But the reasoning behind the Argentine's decision was clear - his main priority this season is leading the north London club to the English league title for the first time since 1961.

Second-placed Tottenham are five points behind Premier League leaders Leicester and, with another important top-flight game looming against Bournemouth on Sunday, Pochettino again decided to leave top

scorer Harry Kane on the bench.

Without their talisman, the home side never looked like troubling a Dortmund team which had not been beaten in their 13 previous matches.

Spurs had 61% possession, without dominating the territory inside the Dortmund third, and only managed one shot on target - Son's second-half consolation goal.

But that only came because of a defensive mistake from away centre-back Neven Subotic, whose weak backpass was pounced on and punished by the South Korea international. And he enhanced his burgeoning reputation with two clinical finishes at White Hart Lane, taking his tally to 35 goals in all competitions this season.
