



# Prince hails Queen's 'life of dedication'

■ Charles pays tribute to "a life that has inspired and encouraged millions of people..."

**PRINCE Charles led tributes to the Queen for her 90th birthday on Thursday, declaring that her life has defined our age.**

The heir to the throne described the years since her 21st birthday speech in South Africa back in 1947 – when she vowed to devote her life to service – as the Age of Elizabeth.

"As we celebrate her 90th birthday, she, like all of us, can reflect on a life that has inspired and encouraged millions of people in the United Kingdom, the Commonwealth and around the world," said Charles, 67, who will host a private Royal Family dinner for the Queen at Windsor on Thursday evening.

"In many ways, it's a life that has defined our age."

Sixty-nine years ago the then Princess Elizabeth took to the airwaves to broadcast the speech to the Empire from Cape Town, where she was on tour with her parents and younger sister, Princess Margaret.

"I declare before you all that my whole life, whether it be long or short, shall be devoted to your service and

the service of our great imperial family to which we all belong," she vowed.

In a special documentary shown on British television on Thursday evening, the Queen and Charles were shown sitting together reflecting on a selection of the Royal Family's home movies shot by the monarch herself, Prince Philip, and by her father King George VI and the Queen Mother.

Among contributors were Charles, Princess Anne, Prince William, Prince Harry, the Queen's niece Lady Sarah Chatto and three of the Queen's cousins, Princess Alexandra, the Duke of Kent and Margaret Rhodes.

The Queen spent much of Thursday morning plowing her way through an especially large bag of birthday mail. The Royal Mail traces its origins back to 1516 when Henry VIII knighted Brian Tuke, the first Master of the Posts.

So to commemorate the 500th anniversary of

the postal service she and Prince Philip visited her local Royal Mail delivery office on Wednesday, just a short walk from Windsor Castle.

Dressed in a cerise Stewart Parvin outfit with matching hat by Rachel Trevor-Morgan, the Queen was given an early rendition of Happy Birthday, met Britain's longest-serving postman and was introduced to Janette Warburton, 60, who delivers the mail to staff at the castle.

The Queen, whose own mail goes via London and is delivered by a special royal postman, was also given flowers by what may well be the youngest person to hand her a bouquet, 18-month-old Charlie Capper.

During her tour of the office, now renamed the Queen Elizabeth Delivery Office in her honour, Moya Greene, the Royal Mail's chief executive, told her that the service now delivers a billion parcels a year.

"I've probably added to that," the Queen quipped.

# NONSENSE! Critics slam Osborne's Brexit sums as 'gobbledegook'

AS THE war of words surrounding Britain's pivotal in/out EU referendum continued to heat up, Chancellor George Osborne seemed to score a massive own goal this week by issuing a complicated mathematical equation to explain why the country is better off sticking with Europe.

The lengthy algebraic formulas in a Whitehall document published by Osborne were used by

Treasury economists to forecast the impact of a Brexit. None included figures used to arrive at their conclusions – specifically that leaving the EU would reduce national income by 6.2 per cent and cost every household £4,300 a year by 2030.

And accompanying text supposed to explain the bewildering calculations only made things worse.

It read: "The HM

Treasury analysis below uses a gravity model specification with country-pair fixed effects, recognising that more recent empirical studies have included other explanatory variables."

Tory MP Tom Pursglove said of the document: "This looks like complete gobbledegook. Few voters will make head or tail of what it's all about.

"Officials may use

baffling formulas to try to prove whatever they like but nobody is really going to understand what they are on about.

"The referendum debate is about whether we can regain control of our borders, stop sending £350million to Brussels every week and take back control of our country."

Osborne was also plunged into a row over mass immigration after claiming that quitting the EU would make Britain

"permanently poorer". His 200-page Treasury dossier suggested that cutting ties with Brussels would leave a massive black hole in public finances.

But critics pointed out that the forecast assumed that the Government will fail to deliver a cut in migration even if the UK quits the EU. A senior Tory minister rubbished the dossier as "extraordinarily biased".

Energy minister Andrea Leadsom,

a former Treasury colleague of the Chancellor, said: "A much fairer way to present this argument would be to also look at the impact if we remain in – on further migration, further pressure on public services, security and so on. You have to present a balanced view."

Former Tory chancellor Lord Lamont said the Treasury forecast was "spurious and entirely unbelievable."

## Brexiters fury at US 'meddlers'

ANGER over American interference in the EU referendum campaign intensified this week after eight former US Treasury chiefs urged Britons not to vote to cut ties with Brussels.

In a joint letter, the senior figures in both the Democrat and Republican parties warned that quitting the EU was "risky".

But campaigners for a "leave" in the in-or-out referendum on June 23 were furious about the American attempts to influence the outcome of the vote, with senior Tory MP Liam Fox accusing the eight former Treasury chiefs as being out of touch.

The former defence secretary said: "I respect their authority, but some of them do go back a long way.

"The most important failure of the analysis is that they have failed to take into account the decline and failure of the European economy itself.

"With a falling share of world trade, a smaller and less important destination for UK exports, and with chronic unemployment. If you look at Britain's unemployment rate of 5.1%, the European Union averages 8.9%, and the eurozone is 10.3% - that is a failing European economy."

## Beefy backs Brexit

■ Sir Ian Botham is on the front foot, going to bat for the Leave campaign and aiming to knock the EU for six

Sir Ian Botham has waded into the Brexit debate, slamming the European Union as "corrupt" and a "racket".

The cricket legend said it's "insane" that Britain doesn't have the freedom to reach agreements to trade freely with natural allies in the Commonwealth.

And he said the £350m a week Britain pays the Union in membership fees "staggering".

He used a cricket metaphor to back up his argument.

Writing in the Sunday Times, the man nicknamed 'Beefy' thundered: "Cricket is a game where you achieve the greatest success when you are confident in your own ability to go out and stand proud. Britain has that spirit"

Botham's column came after Work and Pensions Secretary Stephen Crabb warned quitting the EU would cause an "economic rupture" with "disastrous consequences for families.

Writing in The Sunday Telegraph, Mr Crabb warned of the "self-harm" that a vote to leave would cause.

Lost jobs and livelihoods take an enormous, indelible toll on families and

communities," he said. "No-one should be complacent about the potential consequences for working people and their families if Britain votes to exit the EU. This is not a theoretical debate."

# William: I'll avoid politics, just like my granny does...

**PRINCE William** wants to be a non-interventionist monarch like the Queen, rather than one taking up issues like Prince Charles.

In an interview to mark his grandmother's 90th birthday, William admitted he thinks about what sort of King he might be and how to modernise the monarchy.

He also defended himself against allegations that he is "workshy".

The second-in-line said his grandmother and father fully support him working only 20 hours per week as an air ambulance pilot and doing occasional royal duties so he can spend time with his children.

In the interview with the BBC's Nicholas Witchell broadcast on Wednesday, William, 33, compared his grandmother's approach to that of his father.

## 'challenge'

Prince Charles has made it clear that as King he would like to bring together politicians and decisionmakers and make "interventions" on issues such as global warming.

William said: "I've got my grandmother who takes, if you like, more of a passive role. She's above politics, very much away from it all and keeps silent.

"And I've got my father who minds an awful lot about many of the causes he's involved in and really digs down into his charitable areas as much as he can.

"I think in the Queen, I have an extraordinary example of somebody who's done an enormous amount of good and she's probably the best role model I could have."

He added: "The Royal Family has to modernise and develop

as it goes along and it has to stay relevant and that's the challenge for me."

William said he was focusing on being a father and a pilot but would be the "first person to accept" duties when it came time for his grandmother to hand over.

He said: "I take my responsibilities very seriously. But it's about finding your own way at the right time and if you're not careful duty can weigh you down at a very early age. I really think you have got to develop into the duty role."

Asked if Prince George had become aware that

he was not part of a normal family, William replied: "Well, as far as we're concerned, within our family unit we are a normal family.

"I love my children the same way any father does and I hope George loves me the same way any son does his father."

## George steals the show at shoot

Prince George is appearing on his first stamp after a secret photo shoot captured the Queen and her three direct heirs to commemorate Her Majesty's 90th birthday.

As this behind the scenes picture shows, the two-year-old future king had to stand on blocks to make him the right height for the picture. And while Prince George's parents often describe him as "naughty", the photographer who took the picture said he was a delight.

Ranald Mackechnie, who has not even told his wife he took the picture, said: "He was absolutely charming, as you can see from the picture. You only have a short window of opportunity with small children, but Prince George was on good form and everyone seemed to enjoy seeing him enjoy the day.

"He was fascinated by my lights and all the kit, and he was quite happy standing on the blocks. I took maybe 80 or 100 shots, but when I saw this one I knew straight away that was it."

He said: "Because the picture was going to be turned into stamps on a sheet, each person's head had to be in exactly the right place. A millimetre the wrong way on the final stamp sheet would have made the perforations too close together, so I had to make sure everyone was spaced the right distance apart."

He had computer monitors in the room with templates of the final stamp sheet so he could make sure each person's head fitted into the right frame.

Buckingham Palace had supplied Prince George's exact height so he could work out how to get his face a similar height to the Queen, the Prince of Wales and the Duke of Cambridge.

## Maddy detective to sue McCanns

**THE former police chief who claimed Madeleine McCann's parents faked her abduction is now planning to sue the couple for compensation, it emerged this week.**

Goncalo Amaral, 56, heaped further heartache on Kate and Gerry McCann by claiming his seven-year libel battle with them had harmed his reputation and caused him financial losses.

### 'seething'

The claims came just hours after appeal judges in Portugal overturned a court order in which the couple were awarded £395,000 in damages.

Kate and Gerry – who have always categorically denied Amaral's claims – were said to be "seething" after the ruling and will lodge an appeal at the country's Supreme Court.

The decision paves the way for the former detective to rake in a fortune from the sale of his 2008 book *The Truth Of The Lie*, in which he made his hurtful allegation.

After the latest development, a source close to the couple said: "Kate and Gerry only took civil action against Mr Amaral in the first place to stop him spouting his malicious lies.

Now it looks like they will be repeated again and he's talking about suing them."

The family friend added: "It was never about them winning damages, which will now be put on hold while they appeal to Portugal's Supreme Court against this ruling. This could continue for years."

### 'financial losses'

Madeleine vanished during a family holiday in the Algarve resort of Praia da Luz in May 2007, days before her fourth birthday.

Amaral's lawyer, Miguel Cruz Rodrigues, said: "The court decision reinforces our aim to go for a claim against the McCanns for damages over what have been years of financial losses in which my client's good name has been called into question."

Last April, Kate and Gerry, both 48, of Rothley, Leics, won the long-running libel battle after first issuing a writ against Amaral in June 2009.

But the ruling was overturned on Tuesday by three appeal judges in Lisbon who described Amaral's book as "a legitimate exercise".

Publishers in Portugal are expected to rush out new copies of the book.

Clarence Mitchell, the couple's spokesman, said that anyone trying to publish the book in Britain will face "immediate action" from their lawyers.

The book has never been translated into English.

# Man claimed as 'rightful king of England' dies in Australia

An Australian man who some claim is the rightful king of England – the 14th Earl of Loudoun, has died in his hometown where he worked as a forklift truck driver.

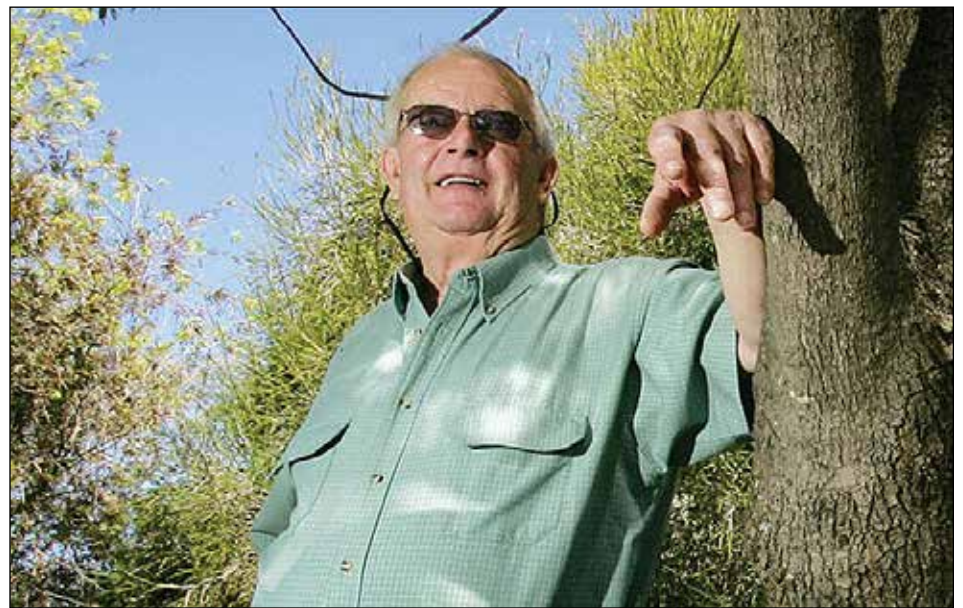
Michael Abney-Hastings, or "King Michael", was a British-born expat down under who made international headlines in 2004 when a Channel 4 documentary suggested that King Edward IV was conceived illegitimately. It said the crown should have been passed down the Plantagenet line – ending at Abney-Hastings.

The reluctant would-be king was born in Sussex and went to school at Ampleforth College in Yorkshire but moved as a teenager with his family to the small Australian town of Jerilderie, population 768, about 400 miles from Sydney.

His "claim" to the throne first became apparent after the documentary, Britain's Real Monarch, put forward a thesis by a historian, Dr Michael Jones, who said King Edward, who reigned from 1461 to 1483, was conceived when his parents were 100 miles apart.

At the time, according to a document unearthed by Dr Jones in a library in Rouen, Edward's supposed father, Richard, 3rd Duke of York, was said to be fighting the French near Paris, while his mother, Lady Cecily Neville, was at court in Rouen.

Furthermore, Lady Cecily was said to be spending a great deal of time with a local archer named Blaybourne and the two were rumoured to be having an affair. King Louis XI of France is said to have once claimed about King Edward: "His name is not King Edward

– everybody knows his name is Blaybourne."

It was therefore proposed that Abney-Hastings, the direct descendant of George Plantagenet, 1st Duke of Clarence and brother of Edward IV, should be the rightful King.

When the claim was raised with Abney-Hastings at his farm in Jerilderie, he said he had been elected to the local shire council and would prefer to focus on his duties as councillor.

"When they told me I

was surprised all right," he said. "But I don't think it will worry us too much. Titles don't mean much out here and I have no intention of leaving Jerilderie ... Why would you want to be King anyway? They can't do anything without someone on their back."

Abney-Hastings, who was 69, was widowed but has several children. He once joked that his eldest son would have to wait until he died before pressing a claim to the throne.

"He'll have to wait," he said. "It's not available till I go."

He had been battling a debilitating illness and had been in and out of hospital in the lead-up to his death on Saturday.

Though he did not budge from his support for Australia to become a republic, he did once note that his friends and family stood up and broke into God Save the King at a Christmas dinner shortly after the documentary was broadcast.

# Victoria Wood dies suddenly at 62

## ■ TV comedy star in secret cancer battle

Comedian, singer and writer Victoria Wood has died after "a short but brave" battle with cancer aged 62.

Her publicist said the star "died peacefully at her north London

home with family" on Wednesday.

Wood's long-time comedy partner Julie Walters said she was "too heart sore to comment - the loss of her is incalculable".

Wood found fame in the 1980s and was best known for her BBC sketch Acorn Antiques and comedy Dinnerladies.

She won five Baftas including two for her one-off ITV drama Housewife, 49.

Wood got her first break on the TV talent show New Faces in 1974, while still a student at Birmingham University.

She established herself as a comedy star with her hit show Victoria Wood: As Seen On TV and went on to create the popular BBC comedies Acorn Antiques and Dinnerladies, featuring her long-time collaborator Julie Walters.

The pair became friends in the 1970s and first worked together on TV in 1981 on the comedy sketch show Wood and Walters.

Acorn Antiques also spawned a musical, which Wood wrote and was directed by Trevor Nunn in 2005.

### 'Truly brilliant'

Fellow comedians have been paying tribute, including Jennifer Saunders, who tweeted: "Can't believe Vic has gone. She was truly an inspiration and had so much left to give and we won't see it. She was so funny."

Sir Lenny Henry said: "I am devastated - this is very, very sad news. Victoria will be sorely missed. Always funny, she worked incredibly hard. A killer stand-up and a fantastic songwriter. My condolences to all her family."

Catherine Tate said: "The news is devastating. It's so shocking and sad. We have lost an incredible talent who was a huge influence and inspiration to so many - a true game changer."

John Cleese tweeted: "Shocked by news of Victoria Wood.

I worked with her last year and was reminded of just what a superlative performer she was. Only 62!"

Wood appeared on BBC One's That's Life! in 1976, which brought her into millions of homes on a frequent basis.

The show's presenter and Childline founder Dame Esther Rantzen

was also among those who paid tribute.

"I think she is one of our greatest comic writers and performers, but she could also deal with serious issue as well, and she's a huge loss," Dame Esther said.

"She did a one-woman show for Childline where I felt hugely privileged to interview her and she

told the story of her life with such wit. She just held us all enchanted for a whole evening."

Harry Potter author JK Rowling retweeted a link to a video of Wood performing one of her comedy songs, Reincarnation Song, saying: "Watch and weep. 62 is far too young. RIP Victoria Wood."



## Scottish takeaway lovers top UK's fast food chart

SCOTLAND'S fast food lovers spend £102 a year more on takeaways than those in the rest of the UK, according to new research.

Takeaway spending north of the Border has soared over the past 12 months with many people admitting that they simply "can't be bothered to cook".

While fast food spending has fallen across the entire UK, it has gone up by 11 per cent in Scotland with a typical person buying a takeaway 128 times a year.

The worrying details came to light in the fourth annual Food Spend Report by money-saving website VoucherCodes.co.uk.

It found that the typical Scottish adult spends £3,757 each year on food - £77 more than the UK average of £3,680.

Of that, almost a fifth (£695) goes towards buying takeaways, 12 per cent on eating out (£462) and the rest on groceries (£2,601).

Glasgow spends more on takeaways than anywhere else in the country - averaging £777 a person annually, while Edinburgh is the lowest spending city at £627.

Chinese restaurants retained their title as the country's favourite take-out, followed by fish and chips and Indian.

A third of people say they favour takeaways over home cooking because they "can't be bothered to cook" while 17 per cent said they just do not have the time.

The news will spark concerns among health campaigners with 65 per cent of Scottish adults classed as overweight, including 28 per cent who are obese.

Last weekend, Nicola Sturgeon unveiled that the SNP is planning to introduce a "national chef" to tackle the country's obesity crisis if it is re-elected next month.

And Anita Nail, consumer editor of VoucherCodes.co.uk, insisted moving away from takeaways would also boost bank balances too.

She said: "With all of us living such busy lives, it's not surprising that more money is being spent on takeaways because many Scots 'can't be bothered to cook'.

# American Cinematheque revisits Laurel & Hardy

**TIMES AND TASTES** may change, but the appeal of some comedy classics remains undimmed throughout the years.... Laurel & Hardy being a case in point.

The classic pairing of the American Oliver Hardy and his English partner Stan Laurel have delighted audiences throughout the decades and their appeal never seems to fade. Which is why next month's short Laurel & Hardy festival at the Egyptian Theatre in Hollywood and the Aero Theatre in Santa Monica promises to be such a treat.

The brief festival is titled Laurel & Hardy: The Original Odd Couple, and runs May 6th-8th with three days of hilarity from the legendary duo, with full restorations of a dozen shorts, including *The Music box* (an Academy Award-winning short), *Busy Bodies*, *Helpmates*, *Towed in a Hole*, as well as two features, *Way Out West* and the rarely-screened *The Flying Deuces*. These prints have been photochemically restored from the original 35mm nitrate originals, and digitally 'cleaned', - meaning they haven't looked this good since their original release.

The program also includes 35mm prints of *The Devil's Brother* and *Bonnie Scotland*.

Laurel and Hardy were among the most successful and beloved comedy teams in film history. Stan Laurel first left England as part of Fred Karno's troupe (in which he understudied Charlie Chaplin), while Georgia-born Oliver Hardy got his start in the booming pre-WWI Florida movie industry; the two

first crossed paths in Hollywood at the Hal Roach Studios in 1921.

At first glance, the pair could not have been more mismatched - one thin and childlike onscreen, the other heavysset and haughty. They were very different off-screen as well, with Laurel a focused comedic strategist, while Hardy was more easygoing and content working in front of the camera. Perhaps it was these complementary styles that made the partnership so enduring, lasting nearly 30 years with appearances in more than 100 films together.

## Six tips to keep you in shape when you travel

*WITH SUMMER coming up it's easy to think of your vacation as an opportunity to slacken off on your fitness goals and indulge more than you should. But it doesn't have to be that way! By following these simple rules you may discover that your summer holidays are the best chance you'll have all year to improve your health and fitness.*

### 1. Set a goal to come home in better shape than when you left.

This is the key to it all: The next time you travel, a time when most people surrender to stress, fast food and busy schedules - set a goal to come back in better shape than when you left...

Naturally, you're not going to make huge shifts in body composition over a short trip that lasts just days, but you might burn a pound or two of fat. You might look visibly better in the mirror when you get back. You might get stronger. You might break a personal record in the gym. Maybe you

simply have a string of better-than-usual workouts, so you know you made progress.

### 2. Have a plan and schedule your time tightly.

Biggest mistake ever: "I'll just wing it when I get there." No matter where you are, you must have a meal (food) plan and a training plan - in writing (not just in your head) - and schedule it into your calendar. You schedule every other meeting or appointment in your date book - and you have to make a travel itinerary anyway - so why not include appointments with the gym and the kitchen?

When you travel, or any time your usual environment or routine changes, make sure you create a new plan or modify your usual plan to accommodate for the changes:

### 3. Book a hotel with a kitchen and go food shopping.

For me, this is the king

of nutrition strategies on all extended trips: Book a hotel with a kitchen. I continue to be stunned at how many people complain about how hard it is to eat when traveling. But if you have a kitchen and go food shopping the day you check in, your meal planning and prep is NO DIFFERENT than it is when you're home. If you're on a particularly strict nutrition plan, such as a competition diet, I recommend picking up a portable food cooler and some Tupperware and then, provided that you have a kitchen, you can cook and pack anything and keep it fresh during the day. This is what most top bodybuilders and physique athletes do.

### 4. Use snacks, portable foods and mini-meals and pack them with you on busy days.

If you're traveling on business or with a very tight schedule, you'll need to think ahead and plan for where you're going to be and what

you're going to eat and when you're going to eat it. Sometimes, a formal sit down meal is not possible or convenient, but you do have options.

Learn how to make a variety of portable meals, including several different types of "oatmeal pancakes," tuna burgers and healthy sandwiches. Any one of those I can eat in a car, on a plane or even while sitting in a seminar room. Fruit and nuts are available almost everywhere, even in airports and if you pack protein shakes or meal replacements, eating on the go is EASY!

(Important note: don't forget to cook before you leave for the airport and pack a meal and snacks in your carry-on bag. I've NEVER eaten airline food before - I always have my own.)

### 5. Look out for local gyms and hotel fitness facilities in advance

You don't have to skip a beat in your training

when traveling - all it takes is some planning. Where are you going to exercise when you arrive at your destination? Naturally, this depends on your personality and training style. I know quite a few people who are willing and able to workout anywhere - even in their hotel room - even with no equipment at all.

### 6. Make every problem a non-recurring event

Even well laid plans can have a wrench thrown in the works due to unexpected events, ranging from flight delays to seminars or meetings running late. Don't beat yourself up - it's not your fault if that happens... once. If it happens twice... then you can look in the mirror at who is to blame for the recurring problem.

# Meet a Member: Richard Bence

Meet Richard Bence from London who moved to LA a year ago to pursue journalism

## Was there a particular reason you chose LA?

That LA is having a 'moment' is well documented, but I didn't really know what to expect; it was more of a hunch, an innate calling. There is such an amazing and inspiring mix of people here from the worlds of art, film, technology, music, architecture, fashion and food, all doing interesting things. It just made sense, professionally speaking, for me to plant myself here at the epicenter of this creative explosion, rather than New York.

## What do you miss most from home?

I think it's the reassuring

sensibleness of everything at home. Here things can go to DEFCON 1 very quickly. Maybe being bundled together on a small island has required us to work stuff out without too much fuss, or perhaps we've just had more time to learn the art of compromise. America was born out of revolution, so it makes sense that things get so heated otherwise they'd still be ruled by Queeny! Obviously the gun thing is something I will never get my head around and if I watch the news I can suddenly feel like I've stepped into the twilight zone. But then I see a hummingbird on my balcony in the middle of February and I forget all about the negative stuff. LA is my idea of paradise but the public transport sucks; in London the bus and tube

are great levelers, here you don't have cause to rub shoulders with your fellow man so much. People moan about the tube but when you get to a place like LA you realize how good we have it back home. I'll never grumble again!

## What was your first impression of LA and has it changed since? If so why?

I stayed with a fellow Brit in the Franklin Hills (Silverlake) when I first arrived back in October 2014. He lived at the top of a vertiginous street with a beautiful deck and killer views of the shimmering city below. I fell in love with LA right there and then. I was immediately struck by how incredibly lush it was, despite the drought. Coming from London I'm used to living somewhere that

isn't a picture postcard. I prefer it that way. It's the simultaneous ugliness and beauty of the urban jungle that I love and there are still fallow patches that haven't been sanitized or blighted by boring chains like most British high streets (if I never see Costa coffee again I'll be very happy). I think it's the flora and the fauna that I'm so smitten by here in LA.

## What do you find the biggest difference is living here versus London?

Well, besides the coyotes, cacti and the canyons, I guess it's the drinking culture (or lack of). In London, alcohol is inserted into every social situation by default, regardless of whether it's a birth, death, marriage or leaving do. Here, people are less bothered about getting hammered and staying out late. I'm an early bird so the rhythm of Los Angeles suits me better. The great outdoors inspires me and here you are cradled by nature so energetically I am more 'at home' here than I was in London.

## Do you have a hidden gem in LA that you want to share with us?

At 38 I was still on the

Not so hidden anymore I guess, but Downtown is definitely worth a visit. I love it down there; it's like an Art Deco time capsule. I'm an architecture geek so can spend hours wandering around, stumbling upon some relic from the 20's or 30's. Fortunately there is a whole movement pushing for its preservation. Make sure you check out Cicada restaurant in the Oviatt Building (617 Olive St). Built in 1927, it was the first Art Deco building in LA, with interiors by Lalique, and serves as the inspiration for Lady Gaga's spooky Hotel Cortez in American Horror Story: Hotel.

## What would you suggest to others who are thinking about making the move here?

At 38 I was still on the

right side of 40 and wanted to give this a go before I lost my nerve. If you only have yourself to consider, as I did, just do it. So many people avoid taking risks and end up regretting it. I realise that taking risks is in itself a privilege, and I get that not everyone can just up sticks and start over.

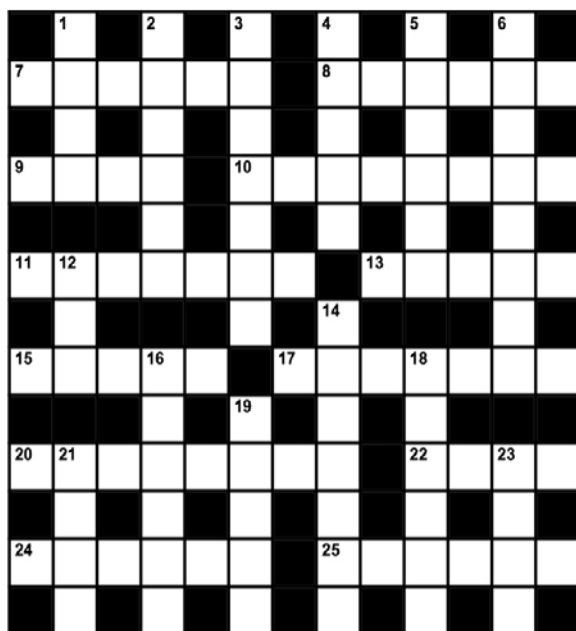

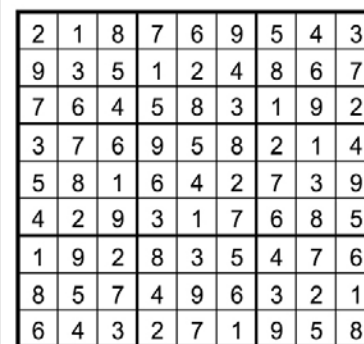

# Death Sits Down to Dinner: dig right in...

Exclusive interview  
with author Tessa  
Arlen and a review  
of her second novel  
in the Countess of  
Montfort mysteries  
Rating: ★★★



**"Churchill was in love with the idea of flight and its possibilities in wartime,"** says *Death Sits Down to Dinner* author Tessa Arlen. "He was so enthralled by his first experience of taking the controls of the Farman biplane that he was being taught to fly, that he invited his young instructor to his birthday party. The novel starts with my fictitious version of this celebration. And, I include Captain Gilbert Vernon Wildman-Lushington, such a wonderful name, as a guest."

*Death Sits Down to Dinner* is a great escape, to slip back into the

glitter and glamour of a lost era. Arlen's series features a female aristocrat who solves mysteries, a theme that's trending in mystery novels. Rhys Bowen with her Royal Spyness series and Carola Dunn with her Daisy Dalrymple series are two examples. Arlen's writing is immersive, dropping you into the time she's writing about. This is a cozy mystery. You can easily picture what Arlen is writing about and her descriptions help move the story forward.

It's England before WWI. During a lavish dinner party at the home of Hermione Kingsley, in honor of Winston Churchill's 39th birthday, Sir Reginald Cholmondeley, long time friend of the hostess, is found dead in the dining room. Clementine Talbot, the Countess of Montfort, with the help of Edith Jackson, the housekeeper at the family's country estate, starts looking into the background of the people at the party. The pair may be able to find out details no professional detective can.

"I decided to write a mystery because I have always enjoyed the style of the Golden Age," says Arlen. "Penning a group of eccentrics up in a country house. Stirring things up with a murder and when all hell breaks loose... everyone reverts to type. I have always loved that

tiny window of time called the Edwardian era. A complete contrast to the Victorian era of stuffy morality and the self-congratulatory days of great Empire. Life for the privileged few in the 1900s was still idyllic thanks to their servants, their money and the rigidity of the class system, whereas the have-nots had a much grimmer time of it."

For research, Arlen read Vita Sackville-West's *The Edwardians* which describes aristocratic life in England's colossal country houses as populated with a most astonishing array of eccentrics and snobs. A wonderful book written by a working butler, Eric Horne's *What the Butler Winked At* she found immensely useful for understanding the hierarchical life of servants below stairs. Barbara Tuchman's *The Proud Tower* for the political and social

climate in Britain before the Great War. She also read fiction of the time.

"I hugely enjoyed the novelist Elinor's Glyn's *Three Weeks*," says Arlen. "Elinor Glyn was married to a landowner who was a complete spendthrift and a chronic gambler. She wrote romance novels to keep them out of debt and was the equivalent of a New York Times bestseller. *Three Weeks* caused quite a stir when it first published. It is the story of an exotic but aging Balkan queen who seduces a young English aristocrat in Switzerland, of all places, and was apparently inspired by Glyn's affair with the young Lord Alistair Innes Ker, sixteen years her junior."

"The racy parts of the book scandalized Edwardian society as the seduction took place on a tiger skin, probably representing the wildly passionate and daring nature of the book's

protagonist," says Arlen. "It was considered to be really improper reading at the time, but today just comes off as hilariously daft and the passionate bits are of course quite innocent."

Arlen lives with her family on Bainbridge Island in Puget Sound, Washington.

# Sanchez lifts lackluster Gunners

ARSENAL shrugged off a tepid challenge from West Brom Thursday night courtesy of two Alexis Sanchez goals, that keep the Gunners firmly in the box seat for a Champions League place, but doubtless left some fans – those who didn't stay away – wondering about what might have been.

Sanchez scored twice – his fourth and fifth in his last four games – as the Gunners beat a West Brom side lacking urgency. The win takes Arsenal back to third two points above City, four above United but judging by the large swathes of empty seats at kick off many fans feel the remaining matches of the season are not worth their attention.

Wenger made three changes to the team that drew so limply with Crystal Palace at the weekend, bringing in Olivier Giroud for Danny Welbeck while Per Mertesacker returned to defence at Gabriel's expense and Aaron Ramsey was included in midfield instead of Francis Coquelin.

Albion, who won the return fixture in November 2-1, brought in Sandro for Salomon Rondon to thicken up their midfield following their disappointing, double-penalty spurning defeat to Watford on Saturday.

But the midfield was not thick enough. In the sixth minute Arsenal pounced, Ramsey rolling the ball into Sanchez who had moved into the middle from the right wing where Wenger

## Mori 'sorry' for horror tackle

Everton defender Ramiro Funes Mori has issued a public apology after his red card against Liverpool on Wednesday night.

The centre-back was shown a straight red card for his challenge on Divock Origi, which led to the striker being taken from the field on a stretcher amid fears he had suffered a serious ankle injury.

Funes Mori appeared incredulous when first shown the red card by referee Robert Madley, and he then pulled on the club badge on his shirt in an attempted show of pride.

The Argentine star has since had second thoughts, however, and issued a public apology on Twitter on Thursday afternoon as he faces up to a three-game ban.

He has also apologised to Origi, who is expected to undergo further scans to discover the extent of the injury – although his ankle is not thought to be broken.

"I very much regret what happened yesterday," Funes Mori said in a statement posted on Twitter.

"It was never my intention to harm a rival nor my colleagues leaving the field.

"And regarding Divock Origi, I fervently hope it's nothing serious and know that it was never my intention to hurt. I ask my apologies for what happened."

Funes Mori is unlikely to receive any sympathy from under-fire Everton manager Roberto Martinez, however, with the Spaniard admitting he had no defence for his defender.

"I just felt it was a challenge that he should have avoided," said Martinez. "He got carried away with the motion of the derby – maybe because it was his first one.

"I can understand the referee giving the red card but we didn't cope with the emotions of the occasion and we didn't

control ourselves well enough."

It was a night of horror for Everton, who were humiliated 4-0 by their crosstown rivals.

And Liverpool manager Jurgen Klopp admitted after the game that Origi's injury had taken the shine off his side's wonderful display.

"Everything is okay – apart from Divock," said the Liverpool manager.

"Usually after 4-0 I don't know how to keep my smile off my face but it is pretty easy. If you told me before the game we would win 4-0 I thought I'd feel different.

"It is a big shadow on the game to be honest. Everyone who saw the pictures said maybe it is broken – it is not. We have to wait for a final assessment, it is too early.

"I went to Divock in the medical room and I saw him smiling. The ankle is twisted and we have to wait to see what has happened to the ligaments."
