BIRMINGHAM BOMBINGS: new inquests on the way

■ *"I have serious concerns that advanced notice of the bombs may have been available to the police and that they failed to take the necessary steps to protect life." - senior coroner for Birmingham*

Fresh inquests are to be held into the deaths of 21 people in the Birmingham pub bombings after years of campaigning by victims' relatives.

The senior coroner for Birmingham and Solihull Louise Hunt announced the decision on Thursday after holding several review hearings and receiving "significant" new information about the double bombing on November 21, 1974.

During the recent hearings, families of some of those killed in the blasts in the Mulberry Bush and Tavern in the Town pubs put forward a claim that the British state had knowledge of the attacks planned by the IRA before they were carried out.

potential warnings

Setting out the reasons for her ruling, Ms Hunt said there was evidence that West Midlands Police had missed two potential warnings of the bomb attacks, including a comment made by men linked to IRA that "Birmingham would be hit next week".

That overheard conversation was reported to police on November 10 1974, but Ms Hunt said there was "no indication that the police took any active steps in response to

it".
 On the day of the attack, a second tip-off to the police was not followed up, she added.

Ms Hunt went on: "I have serious concerns that advanced notice of the bombs may have been available to the police and that they failed to take the necessary steps to protect life."

Concluding, she said: "This is specifically in respect of the two matters I have identified.

"It is only in respect of that issue that I consider there is sufficient reason to resume an inquest to investigate the circumstances of these deaths.

"So I am satisfied that the inquest should be resumed."

'we'll never get justice'

She said claims that police were protecting a mole in the IRA cell were unfounded, and neither did the emergency services response that night contribute to the deaths.

The pub bombings, widely acknowledged to be the work of the IRA,

left 222 injured and led to one of Britain's worst miscarriages of justice in the convictions of the Birmingham Six.

Speaking outside the coroner's court, one of the men released in 1991 Paddy Hill welcomed the ruling.

He said: "We'll never get justice but I tell you one thing that we can get and that's the one thing we deserve the most - the truth.

"It's not so much me, I know the truth, I want this for the families.

"They've had their whole worlds collapsed twice, once when we got convicted and they had something to focus on - thought we'd got the guilty people in prison.

"Then we get released and ever since, they've been fighting for this for 20 years."

He went on: "I've known the truth all along. It's about time the British public knew the truth."

But Mr Hill said he was "sceptical" the truth would actually emerge.

"Birmingham police couldn't spell the word

EU rules force UK to let in terror suspects, claims Justice Secretary

Michael Gove has claimed that as Justice Secretary he is unable to stop terror suspects and criminals from entering Britain because of EU rules.

The leading Vote Leave campaigner revealed his 'frustration' at the impact of EU laws on free movement on his ability to keep the country safe.

Mr Gove's claims will heighten further growing scrutiny of Britain's border security days after it emerged people smugglers have begun sending boats into the English Channel. In one well publicized case, a pair of Sussex men were charged with smuggling 18 Albanians into the country in a boat they boat on eBay for just £3,000

Gove's claims come as the Home Office has come under fire for not providing enough patrols of the south east England coast as the migrant crisis continues to grip Europe.

He said: 'As Justice Secretary, I have experienced the frustration at our inability to refuse entry to those with a criminal record and even some who are suspected of terrorist links.'

He has pushed tough new immigration rules on the latest leg of the Vote Leave battle bus

tour which has seen him - together with leading campaigners Boris Johnson and Priti Patel.

The Justice Secretary has vowed to press ahead with 'emergency measures' to rein in the European Court of Justice if Britain backs Brexit on June 23.

'restore control'

Mr Gove has insisted such a vote would 'liberate' David Cameron and allow him to finally make progress on meeting a pledge to reduce immigration to the 'tens of thousands'.

The publication last week of official migration figures revealing net immigration was running at more than 330,000 forced the referendum spotlight onto immigration and away from the economy.

Speaking on the campaign trail yesterday, Mr Gove said: 'The only way he can fulfil that pledge is by leaving the EU.'

'He's the Prime Minister who sets policy, he will set policy on 23 June but we just want to liberate him to be able to fulfil the manifesto pledge we all stood on.'

'It is straightforwardly the case that we cannot control our borders in the European Union.'

'Last year, 77,000 people

came from the EU to Britain without a job offer, so these weren't people that our economy needed.

'Of course, if we leave the European Union we

can restore control.

'It will be up to a future government and up to the public in future to decide what level we want migration to be.

'Inside the EU there's no chance of controlling the numbers of people who come here.

'Outside the European Union we can control it.'

Merkel warns Britain 'you will never get results you want if you leave EU'

Angela Merkel, the German Chancellor, has weighed into the Brexit debate, warning at a press conference in Berlin "you'll never get the results you want if you're not in the room".

Speaking after her talks with Nato Secretary-General Jens Stoltenberg in Berlin, she said: "You will never get a really good result in negotiations, particularly on very important issues, when you're not in the room and giving input.

"I personally hope and wish that Britain will stay part and parcel of the European Union."

Commenting on the interventions by EU leaders into the UK's referendum debate, Boris Johnson said the bloc's elites had "hit the panic button".

CORBYN: EU exit not the answer

LABOUR LEADER Jeremy Corbyn has appealed to voters to back "In" at the upcoming EU referendum, defending immigration and rejecting criticism that he is not campaigning hard enough.

Strategists of the In campaign say Corbyn, elected leader of Labour last year on a wave of enthusiasm for change, may help convince thousands of undecided voters in the north of Britain to back remaining in the EU and persuade younger supporters to vote at the referendum on June 23.

Corbyn, who voted "No" to the EU's predecessor, the European Economic Community, in a 1975 referendum, said the blame for problems caused by immigration lay not with the EU, but with the Conservative government and employers.

"Let's not turn this into blaming people who travel, work and migrate around Europe," he told Labour members and supporters.

"Let's instead ensure governments respond to the needs of all communities and that unscrupulous employers that are grossly exploiting migrant workers and trying to limit their rights need to be dealt with."

Bidding goodbye to the British Home Stores...

YET ANOTHER great British institution is headed for the knacker's yard with the news this week that department stores group BHS is to be wound down after administrators failed to find a buyer for the 88-year-old chain, threatening over 10,000 jobs and creating huge vacant sites in town centres struggling to cope with changing shopping habits.

The failure to find a buyer will likely increase the focus on previous owner, billionaire Philip Green, who sold the chain to a group of little-known investors led by a previous bankrupt called Dominic Chappell for one pound in March 2015.

All of BHS's 163 stores will hold closing-down sales over coming weeks and 8,000 staff are likely to be laid off, advisers Duff & Phelps said on Thursday. Another 3,000 workers not directly employed by BHS are also at risk.

The chain, which once targeted a similar mid-market customer as bigger rival Mark & Spencer, failed to keep pace with changes including the rise of cheaper, more fashionable stores like Primark (part of AB Foods) and online competition.

"The British high street is changing and in these turbulent times for retailers, BHS has fallen as another victim of the seismic shifts we are seeing," said administrator Philip Duffy after BHS became the latest casualty of a tough market which already this week claimed tailoring chain Austin Reed.

Its closure, one of the biggest failures in the UK retail sector since Woolworths in 2008, came after none of the multiple offers for the

business were able to complete a deal due to the working capital required to secure the company's future, administrators added.

Up to 10 bidders were reported to have been interested in rescuing the stores, including Mike Ashley, owner of Sports Direct, who had said he was in talks before administrators were called in.

pension deficit

Green had paid £200 million for BHS in 2000, and he took about £400 million in dividends in the early years of ownership, according to company accounts.

But the business had been loss-making for seven years when it was

sold and it has a deficit in its pension fund of more than £500 million

"Sir Philip is saddened and disappointed by the news and had hoped that the business would be sold as a going concern," a spokesman said.

The British government said the failure to rescue the business was devastating news for all those that work at BHS.

Business Minister Anna Soubry said the government had already announced an accelerated Insolvency Service investigation into the activity of former BHS directors.

"Any issues of misconduct will be taken extremely seriously," Soubry said.

The pensions regulator is also investigating whether Green's Arcadia Group sought to avoid its responsibilities in the deal, and should be pursued for a

contribution to make good BHS's £571 million pension deficit.

Green is also due to be questioned on June 15 by British legislators on the Work & Pensions and

Business Committees. "The staff will want answers about how things went so badly wrong on his watch," the opposition Labour party said in a statement.

Bank unveils plastic banknotes

THE BANK OF England unveiled its first plastic banknote on Thursday, and the prominent image of Winston Churchill it displays could not have been more perfectly timed for Brexit campaigners.

The central bank said in 2013 that Churchill would appear on its next £5 note, which will be the first to be made from a very thin plastic. The

durable and harder to forge than paper ones.

"By adopting polymer, we're aligning with international best practice, alongside Australia, New Zealand, and Canada," BoE Governor Mark Carney said.

"As Churchill did, we may have to wait a while for the Americans to join up," he said, alluding to the United States

after Britain.

Carney was speaking as the Bank showed off its final design for the new note at Churchill's birthplace, the 18th-century Blenheim Palace, eight miles north of Oxford.

Inevitably, the appearance of Churchill on the notes was seized upon by campaigners ahead of the June 23 EU referendum.

Veterans for Britain, a group representing



former service personnel which wants a so-called Brexit, pressed its claim that the wartime prime minister saw Britain as friendly towards a

developing union in Europe after the war, but separate to it.

"It's wonderful that Churchill is on the fiver

Uproar as BBC bonkbuster uncovers the many loves of Louis the Phwoar-teenth

■ Auntie takes a new tack with racy epic 'Versailles'

THE BBC has come under more fire – and some praise – after the debut of its new costume drama Versailles which features some of the raciest scenes ever seen on British TV.

The BBC Two bonkbuster shocked viewers with a romp after only TWO minutes of part two on Wednesday night. Dubbed “porn dressed up in a cravat and tights”, the hotly anticipated 10-parter had seven sexual scenes in its first episode. The costume drama is set in 17th-century France and tells the story of its womanising Sun King and his court in explicit detail. This week's show saw Louis XIV romp with a series of women including Henriette, played by Swiss actress Noemie Schmidt. The striking brunette had emerged moments earlier in a wet, see-through slip after a swim. French actress Alexia Giordano

also bared all as she straddled Louis, played by British actor George Blagden. The steamy scenes also feature British actress Anna Brewster as Madame de Montespan, who had seven children by the King.

Viewers took to Twitter to vent both their approval and disgust at the series, which has already proved a hit in France. Blagden's sister Katie said she found the raunchy beginning difficult to watch, tweeting: “Can we have a family and friends screener of #Versailles where I don't have to see my bro naked?”

'fact of life'

Meanwhile Seansheep188 tweeted: “Goodness... I wasn't taught this in school in regards to Louis XIV” Greg Hope said: “You've got to love a bit soft porn on the BBC”. But Jamie Johnston tweeted: “Oh dear. Given up

on #Versailles already. Quelle rubbish.” Another user said: “We're bailing on #Versailles. It is Le Silly.”

David Wolstencroft, one of the writers of Versailles, has denied the show is dominated by sex, saying it contained “honest depictions of sexuality” of women in the court of Louis XIV. The king, who died in 1715, married young but was free to bed whoever he chose. Mr Wolstencroft said the sex was integral to the show, which he said was “a sophisticated and elevated piece of drama”. He said: “Sex is a fact of life. If you look at the honesty of what the show is doing, the depiction of it as a function of power, the context of it, rather than avoiding the subject entirely, which would be laughable.”

The drama was co-written by Simon Mirren, nephew of Dame Helen Mirren. Mr Wolstencroft said: “It's actually a very

carefully organised, much thought about, calculated way by Simon and I of exploring power. “If you want to get titillated and count the nipples, go ahead but that's not the way French audiences have consumed it... and the way I think English audiences will consume it. I think they'll look at it and say, ‘What was all that fuss?’”

The show is said to have cost over £20million and another

series has already been commissioned. Actor Alexander Vlahos, who plays the French king's brother Philippe I, Duke of Orleans has described the lavish 9.30pm series as “tame” despite the controversy. He said: “Is it raunchy? I don't think it is. It just so happens that life at that time, in that

court, was bloody crazy.” But Sam Burnett, of TV standards pressure group Mediawatch UK, said on Wednesday: “Dressing up pornography and violence in a cravat and tights does not make it cultural.”

The show is set for its US debut in October on the Ovation channel.

truth. They're rotten,” he told reporters.

Julie Hambleton, whose 18-year-old sister Maxine was among the victims, welcomed the decision, saying it was “way beyond our expectations” as she urged the Government to ensure victims' families were given legal aid.

Her voice trembling with emotion, Ms Hambleton said: “This is the most seismic day for all of us.

“I hope that our fathers, brothers, sisters, mothers are looking down and they're proud.”

She added: “Our loved ones did not ask to be murdered that night.

“All we want is to be heard so we can get the truth, justice and accountability.”

Ms Hambleton also called for the original bombers to “come forward, do the right thing”.

Former West Midlands Police officer Bill Craig, whose 34-year-old brother James died in the attacks, said he believed the pub bombings investigation would be “another Hillsborough”.

He said: “It's very complex, and it'll be a long process, but in the end this will end up as another Hillsborough.”

West Midlands Police's barristers had objected in principle to the resumption of the inquests, arguing the coroner neither had the powers nor the “evidential basis” to order fresh inquests.

However, speaking after the ruling, Chief Constable Dave Thompson said in a statement: “I hope the new inquest provides answers to families.”

Carla Lane, creator of The Liver Birds and Bread, dead at 87

Television writer Carla Lane, who created shows including 1980s Liverpool sitcom *Bread*, has died aged 87.

Lane, who was born in Liverpool and later became known for her animal rights activism, also wrote *Butterflies* and co-wrote *The Liver Birds*.

She died at Stapely Care Home on Tuesday, her family confirmed.

They paid tribute to her "quick wit, determination and passion" which "brought Liverpool to life on screen for others to share".

The family said: "With heavy hearts we said goodbye to our darling Carla today.

"But with smiles on our faces we also take this opportunity to reflect on her incredible achievements all of which make us so unbelievably proud to be part of her family."

Lane first became known for *The Liver Birds*, a sitcom which focused on the lives of two women who shared a flat together in Liverpool, co-writing and creating the programme with her friend and fellow Liverpoolian Myra Taylor.

The programme aired from 1969 to 1979 and returned for a one-off series in 1996.

Her next sitcom,

Butterflies, which aired from 1978 to 1983, focused on the lives of the Parkinson family and helped launch the career of actor Nicholas Lyndhurst.

'special lady'

Lane then created and wrote *Bread*, which focused on the working class Boswell family as they struggled through the city's high unemployment and poor prospects in the late 1980s. It aired for seven series between 1986 and 1991.

Much of her work focused on women's lives and featured frustrated housewives and working class matriarchs.

She received an OBE for services to writing in 1989 but returned it to the then Prime Minister Tony Blair in 2002 in disgust at animal cruelty.

In 1995, Lane was given a Royal Television Society award for her Outstanding

Contribution to British Television.

Lane later became known for looking after hundreds of rescue animals - running an animal sanctuary from her mansion in Horsted Keynes, Sussex, until 2009 - and was a close friend of Sir Paul McCartney's late wife Linda.

Speaking to the Observer in 2008 about their friendship, Lane said: "She had a lot of good friends, but we were friendship-struck from moment one.

"We used to sit on the lawn with our two puppies, kicking leaves, and looking at them. We were like two scientists trying to find out why people don't like animals, and what we'd do to them, if we only could."

Lane also had an animal sanctuary named after her.

Fran Ellis, founder and trustee at the Carla Lane Animals in Need

who want to keep Britain in the EU have also previously invoked Churchill. Prime Minister David Cameron said last month that his predecessor's legacy showed that "isolationism has never served this country well."

A new plastic £10 note featuring the author of

Churchill replaces 19th-century prison reformer Elizabeth Fry, who has appeared on the fiver since 2001.

"We changed the name of our charity to recognise the work done by this special lady. Her name will live on in all we do," she said.

Mzimba said Lane was someone that "understood people and that's why she was able to write them so well... there was a real degree of honesty".

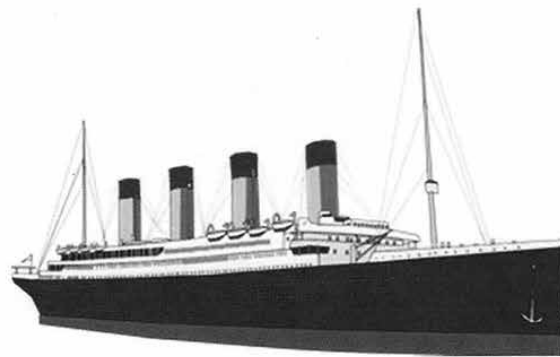

But Jolly Good lovers need not fear, the business is being taken over by Raul Dorado from Ye Olde King's Head in Santa Monica, who told us this week that he will be using Martin's ingredients and processes to ensure the high quality and authentic taste that we have all come

to love.

"I've had a wonderful 37 years doing this job," Martin told the British Weekly this week. "It's been a great run and I've made a lot of friends. I know the business is in good hands and now it's time to do some traveling and enjoy my family."

Weigh yourself weekly: stay on track!

Health & Fitness with Ricky Parcell

To use weigh-ins and body fat tests without the process turning into an emotional roller coaster, you need to understand that strange numbers or results are bound to show up from time to time due to natural body-weight fluctuations.

There will also be good weeks and bad weeks based on your compliance rate and life circumstances or passing events!

A simple re-frame in your mind helps you handle the ups, the downs and the uncertainties:

If you had a result you didn't want one week, you look at it as feedback, not failure.

Think of your numbers as a navigation system, like one you'd find in an airplane or rocket. When

your progress feedback shows that you're not heading in the right direction, that's not a failure, that's simply a signal to make a course correction. If a pilot quit every time a plane was slightly off course, no one would ever get anywhere, so don't get frustrated and angry, just change course.

Successful people don't even worry about one week off course. They simply change their approach, increase their compliance and get back to work. They don't worry about an odd one-week fluctuation in weight or body fat. They focus on their long-term goal and their progress trend over time without obsessing over it!

There are 4 main ways to measure yourself –

1. Underwater weighing - Submerging the body in a tank for a few seconds

underwater in a special tank.

2. Bio impedance - A harmless electric pulse sent around the body to record body fat.

3. Calipers - Pinching specific areas of the body to measure fat with a special instrument.

4. Tape measure - Using a tape to measure the body at the hips and waist...

At www.thebodycamp.com in ibiza, we use a very accurate and expensive system and scales linked to a laptop for our guests. This then prints off vast amounts of information on fat mass, fat free mass, BMI and bone density etc. This system uses bio-impedance. But we also like using the tape measure too!

After attending our retreat, we recommend guests consider weighing themselves once a week

for an "official" progress report. Monday is a good day because it helps keep a lot of people in check over the weekend!

In addition, why not get a measuring tape and measure your waist size (women may also want to measure hips too).

What's more, waist measurement is a scientifically-proven benchmark for metabolic and cardiovascular health risks.

Metabolic syndrome is a cluster of symptoms that are linked to risk of diabetes and cardiovascular disease. One of the risk factors is abdominal circumference of 35 inches or more for women or 40 inches or more for men. That makes the waist size / abdominal circumference measurement a good one to monitor for both health and body fat tracking reasons.

Track these numbers, and combine that feedback with an assessment of how you look in the mirror every week, and you should have no difficulty navigating your way to your goal without a body fat test.

Don't become obsessed with pursuing any specific body fat number, thinking that it's some kind of



"holy grail" achievement.

It's true: The body fat percentage number really doesn't matter if you are happy with the way you look. Also keep in mind that two people can look completely different at the same body fat percentage – one visibly much leaner than the other. That is to say, "people wear their body fat differently."

But measuring the change in the numbers and seeing your progress

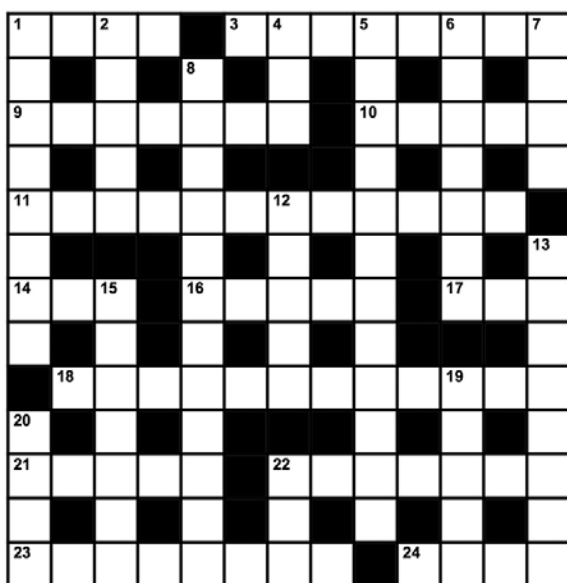
move in the right direction does matter. Use your body fat test results as an educational tool to understand body composition and also as a tracking tool to monitor your personal progress over time and you can't go wrong.

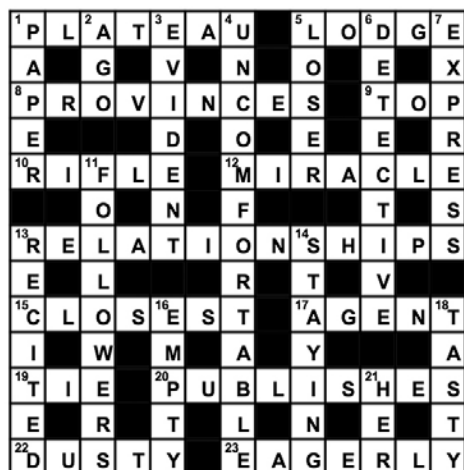

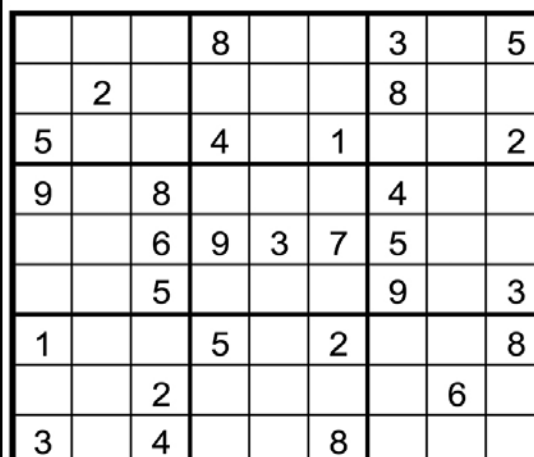

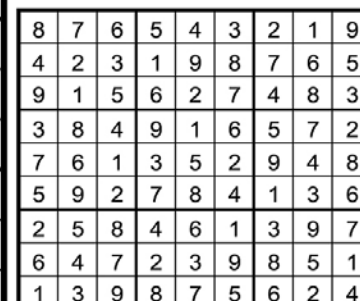
SUDOKU by Myles Mellor and Susan Flanagan

"Back in 2011, I brainstormed a few different ideas, but this was the obvious one to run with as my debut novel," says *Billy and Me* author Giovanna Fletcher. "My life has changed dramatically since writing this book. I've got married, had two children, written three further novels, two novellas and signed deals for even more. Before writing this novel I was writing book reviews for magazines and little entertainment

pieces here and there. Plus I already had a deep love of books, especially ones in this genre. That massively helped."

Billy and Me is a charming delight, a fast read. It's sweet and the characters are nice. They have a few flaws. Sophie is insecure and has been her whole life. Her employer Molly helps her come out of her shell. The misunderstandings and details about Sophie's childhood create most of the drama. The romance

builds rapidly between Billy and Sophie. Two people from different worlds, but the same. Billy is actually shy. A great beach or airport read. Released in the UK in 2013, this is the book's first release in America.

Sophie May loves working at the local teashop. She's happy in the small village she grew up in. She bakes. Someday she hopes to have her own teashop. When a production company comes to town to film a new version of *Pride and Prejudice*, the whole town is excited. Sophie has no idea that the cute guy who comes to the teashop is the hot actor who has the role of Mr. Darcy. Billy finds being around Sophie relaxing. Because she has no idea he's a star, he can be himself. How will shy Sophie handle the pressure when she finds out her

new beau is a famous actor? Fletcher believes in doing research as direct experience, in the first person. "My acting background allowed me to look at the writing process a little differently. I think life is one big piece of research. I listen to people, make note of conversations or places I've been. I try to be aware of how situations make me and others feel. Quite simply, I think being open and mindful are two of the most important tools in storytelling. Elsewhere, I've joined the crazy world of YouTube and become a roving reporter for a British morning TV show. It might not all be directly down to writing my books, but I definitely think that by creating these pieces of work I gave myself a voice."

Fletcher writes a weekly blog for HELLO!

She's written the novels *You're the One That I Want*, *Dream a Little Dream*, *Always With Love* and the novellas *Christmas With Billy and Me* and *Dream a Little Christmas Dream*.

Billy and Me has yet to be optioned for television or film. Fletcher says she may consider *Billy and Me* for theater. "I'm more confident and far happier than I was five years ago when I was chasing the dream of becoming an actor. I'd still love to act, but now I've found other things I enjoy and happen to be good at."

Fletcher recently completed the page proofs of her fourth novel, *Always With Love*, a sequel to *Billy and Me* to release on Kindle on June 2nd, 2016.

Fletcher was born in Essex and now lives with her husband in Middlesex.

There was a lot of families also walking with me down the same road, it was about 2.30pm and just in-front of me appeared three Hispanic men, one had a knife and just as I saw the knife the closest gang member smashed me in the face, I staggered but stayed on my feet and then another gang member kicked me in the mouth and shoved my

head into a wall, I was knocked out but came around quickly to see the three running off with my bag. I then stood up, blood everywhere, a family quick on the scene and the neighbours all coming to see if I was ok. A chap came up to me on his bike and said he tried to chase the robbers who then threatened him with a knife. I have to be thankful for the police and ambulance services who arrived at the scene three minutes after it happened. I filed a report, they quickly took me to the hospital

where I was stitched up across both lips and underneath and diagnosed with severe concussion. The police thankfully retrieved my bag with all of my goods in it but later news in the week about my front teeth being cracked, means my LA Adventure is over for now as I have to fly back for two veneers. now have to get fixed up and wait in the UK until my visa is processed and I am estimating November."

So I'm not sharing

these stories to scare you, but as advice to remember to remain vigilant, because LA isn't always full of airheads and Valley girls. Criminals exist everywhere, so let's all be a little bit street smart and make sure this doesn't happen more frequently...or the very least that we can be a little more prepared.

Was there a particular reason you chose LA?

CAPTAIN FANTASTIC: Alastair Cook milks the applause after reaching 10,000 runs

Cook reaches run milestone as England beat Sri Lanka

England captain Alastair Cook has become the youngest player to score 10,000 Test runs.

Aged 31, five months and five days, he achieved the landmark by reaching five on the fourth day of the second Test against Sri Lanka at Chester-le-Street earlier this week.

He brought up the milestone with a leg-side clip for four off Nuwan Pradeep and saluted the England balcony.

"It's a very special moment for me," Cook said. "You forget about all the hard times you have as a cricketer."

He beat India legend Sachin Tendulkar's record of 31 years, 10 months and 20 days, which has stood since 2005.

Cook went on to make 47 not out as England won the Test by nine wickets.

Speaking after the match the Essex batsman said of reaching the landmark: "It's certainly driven me personally. To score 10,000 runs was one of those goals.

"It's those seven o'clock nets with Goochy [his mentor Graham Gooch], the hard yards away from

today that you put in to get here."

England coach Trevor Bayliss praised Cook as a "phenomenal batsman".

England's leading Test run-scorer with a batting average of 46.49, Cook is the 12th player in history to 10,000 runs, and only the second opener.

Brian Lara, Kumar Sangakkara, Ricky Ponting, Rahul Dravid, Mahela Jayawardene, Sunil Gavaskar, Jacques Kallis, Allan Border, Shivnarine Chandernepaul and Steve Waugh are the other batsmen to reach the milestone.

No Pep vendetta this time, insists Mourinho

Jose Mourinho insists he has no plans to reignite his personal rivalry with Pep Guardiola as it could affect Manchester United's chances of winning the Premier League.

Guardiola and Mourinho will face each other for the first time in English football when they take charge of Manchester City and United respectively next season.

The two managers share a history of animosity stemming from their time in charge of Spanish giants Barcelona and Real Madrid.

However, Mourinho says he cannot afford to focus on Guardiola next year, as he admits he did at times in Spain, as United face a greater number of rivals in England.

"[What has happened in the past] does not

allow me to be innocent. For two years Pep and I were in a league where the champion would be either me or him, Real Madrid or Barcelona," Mourinho told a group of football coaches in Lisbon on Tuesday.

"In a situation like this, individual fights make sense because they can influence things. But in the Premier League, if I focus on him and Manchester City, and he on me and Manchester United, someone else is going to win the league."

Mourinho began his duties as United's new manager on Monday and was given a guided tour of the club's training facilities by Sir Bobby Charlton and executive vice-chairman Ed Woodward.

The Portuguese has already secured the long-term signings of young talents Marcus Rashford and Cameron Borthwick-

Jackson but remained coy when questioned on the possible signing of Sweden striker Zlatan Ibrahimovic.

"My good friends always rave about me," Mourinho said, responding to Ibrahimovic's complimentary comments earlier this month.

Murray books semi berth

Andy Murray booked a French Open semi-final date with Stan Wawrinka after finally finding his best form against home favourite Richard Gasquet in Paris.

Murray lost the first set from 5-2 up and let a similar lead slip in the second before taking the tie-break, and going on to win 5-7 7-6 (7-3) 6-0 6-2.

Third seed Wawrinka beat Spain's Albert Ramos-Vinolas 6-2 6-1 7-6 (9-7).

Murray has now won his last 10 matches, having won the Italian Open last month, and is through to his fourth French Open and 19th Grand Slam semi-final.

Murray had won all four previous Grand Slam meetings with Gasquet but gave the Frenchman every opportunity to improve on that record.

The Briton earned a 5-2 lead before his early success with drop shots disappeared, and double faults at key times helped

Gasquet run through five straight games.

A similar pattern followed in the second set, as Murray again failed to serve out from 5-2 and fell 3-1 down in the tie-break, but he gathered himself to finally take control with six straight points.

The Parisian crowd had been hoping their man could emulate Yannick Noah's title-winning run of 1983, but Gasquet's challenge faded dramatically in the third set.

After the first two sets took well over two hours, Murray raced through the third in 27 minutes, and a sharp forehand volley gave him the decisive breakthrough early in the fourth.

"Stop it!" shouted Murray after his fourth double fault of the afternoon but it did not signal another collapse, and the world number two reeled off 13 of the last 15 games to win in three hours and 23 minutes.

Bellew grabs cruiserweight title

BRITISH BOXING has a new world champion this week after Tony Bellew knocked out Ilunga Makabu in the third round to claim the WBC cruiserweight title at Goodison Park. Bellew became the UK's thirteenth current world champion and described his victory as a "miracle win" after suffering damaged hands and a fractured rib in training camp.

"It was the worst camp I've ever had," revealed Bellew on Monday.

"Boxers will always say how they had a brilliant camp and whatever. But this was awful. I was in a hyperbaric chamber on oxygen four weeks ago. I had detached a rib. I was f****. I was travelling back and forth to Sheffield after two hours of treatment every morning and then sparring."

Dave Coldwell, Bellew's unheralded trainer who deserves great credit for his calmness in the corner, also revealed that the cruiserweight had had problems with his hands coming into the world title fight.

Bellew also called out David Haye, the former unified cruiserweight champion, demanding that the Londoner drop back down from heavyweight to the 200lb weight limit to face him. It would mean Haye losing a stone and a half, which may be very unlikely at this stage in his career.

"You've gone long enough fighting those clowns," Bellew said after his victory. "Come and fight me and I'll smash through you."

SMALL JOY FOR ENGLAND

■ Late winner from defender does little to hide English failings

A LATE HEADED goal from Chris Smalling provided the scantest of positive signs for England as Roy Hodgson's men labored to a 1-0 victory over ten-man Portugal at Wembley on Thursday night.

Any English fans hoping for a comprehensive victory following the team's heroics against Germany to send their boys into Euro 2016 flying high they were in for a disappointing night, as an experimental formation featuring both Jamie Vardy and Harry Kane largely failed to trouble a disciplined Portuguese backline.

Not even with the early sending off of Bruno Alves for a ridiculous head high kick on Harry Kane were England able to fashion an advantage, with Kane laboring to find any penetration or space and Vardy never targeted by the sort of through balls on which he feasted last term for Leicester City.

Only Kyle Walker distinguished himself although Raheem Sterling and Jack Wilshere both provided lively cameos off the bench late on.

The main positive for Hodgson was that there were no fresh injury concerns as he now turns his attention to the Euro 2016 opener against Russia in Marseille on 11 June.

England's team sheet looked packed with positive attacking intent - but once they lined up the system looked ill-suited to the team Hodgson had selected.

The biggest victim was Tottenham's Dele Alli, who looked so outstanding playing in an advanced central role in the 3-2 win against Germany in March, but was out of sorts and shunted to the margins by England's formation.

Alli was restricted to the left to allow Wayne Rooney to play through the middle, while Jamie Vardy and Kane, with 49 Premier League goals between them this season, barely got within sight of each other all night.

Vardy and Kane were seemingly handed the responsibility of providing width but instead they were stretched so far apart as to be rendered completely ineffective.

The pair have all the

makings of a potent partnership but not when they are virtual strangers. It is something Hodgson must work on before England face Russia.

Rooney was as industrious as ever but the muddled manner in which this formation performed will again raise questions about his role in England's team.

Rooney, 30, brings much to the side but is he really a better bet in the number 10 role than Alli?

The game's only goal came four minutes from time, headed in by Chris Smalling to give England their third straight victory in Euro 2016 warm-up matches although it would be fair to say that of all their friendlies this final one was the most unusual. It took them 30 minutes with a one-man advantage finally to pick off the opposition with a goal from a centre-back, although perhaps the home support should be grateful for small mercies.

If the performance was off-key it was equally hard to figure out what it was Roy Hodgson was trying to achieve at times other than shoehorn as many of his five strikers for Euro 2016 into one

forward line. He started the game with three of them - Wayne Rooney, Harry Kane and Jamie Vardy - none of whom seemed quite able to interpret the role being asked of them, and with two simply out of

position.

By the end of the game he had Daniel Sturridge as the centre-forward with Raheem Sterling and Adam Lallana either side of him, all three of them second half substitutes but unable to break the

deadlock against the ten men of Portugal until Smalling intervened. Hodgson might have five strikers at his disposal but his attacking department did not look like the sum of their parts for most of the night.
