



# Blair damned by Chilcot verdict

- **KEY FINDINGS: Iraq War not 'last resort'; intelligence case 'not justified', post war plans 'wholly inadequate'**
- **Corbyn apologizes for 'disastrous decision' to go to war**
- **British service personnel died "unnecessarily and without just cause and purpose", says spokesman**

Tony Blair overstated the threat posed by Saddam Hussein, sent ill-prepared troops into battle and had "wholly inadequate" plans for the aftermath, the UK's Iraq War inquiry has said.

Chairman Sir John Chilcot said the 2003 invasion was not the "last resort" action presented to MPs and the public.

There was no "imminent threat" from Saddam - and the intelligence case was "not justified", he said.

Mr Blair apologised for any mistakes made but not the decision to go to war.

The report, which has taken seven years, is on the Iraq Inquiry website.

Prime Minister David Cameron, who voted for war in 2003, told MPs it was important to "really learn the lessons for the future" and to improve the workings of government and how it treats legal advice.

And he added: "Sending our brave troops on to the battlefield without the right equipment was unacceptable and, whatever else we learn from this conflict, we must all pledge this will never happen again."

### 'false pretext'

Labour leader Jeremy Corbyn - who voted against military action - said the report proved the Iraq War had been an "act of military aggression launched on a false pretext", something he said which has "long been regarded as illegal by the overwhelming weight of international opinion".

After meeting relatives

of British service people killed in Iraq, Mr Corbyn said: "I now apologise sincerely on behalf of my party for the disastrous decision to go to war."

He urged the UK to back moves to give the International Criminal Court "the power to prosecute those responsible for the crime of military aggression".

A spokesman for some of the families of the 179 British service personnel and civilians killed in Iraq between 2003 and 2009 said their loved ones had died "unnecessarily and without just cause and purpose".

He said all options were being considered,

including asking those responsible for the failures identified in the report to "answer for their actions in the courts if such process is found to be viable".

In a statement to the media, his voice at times

cracking with emotion, the former Labour prime minister said the decision to commit troops was the "most agonising and momentous" decision in his decade as prime minister, adding that he

would "carry it with me for the rest of my days".

"I feel deeply and sincerely in a way that no words can properly convey the grief and

# It's all over for the Labour rebels

■ Uprising dies away as Corbyn refuses to quit  
 ■ "It's finished. He will win easily in a second contest"

Labour rebels were in full retreat this week after admitting that Jeremy Corbyn cannot be removed and would "win easily" if a leadership election is triggered.

One senior Labour MP said of the revolt: "It's finished" as it emerged that lengthy talks between union bosses and Tom Watson, the party's deputy leader, had failed to find a solution to the deadlock.

MPs have now pinned their hopes on a challenge by Angela Eagle, despite many believing that she will not beat Mr Corbyn because of his support among members.

It follows weeks of

stalemate between the Labour leader's office and MPs who want to see Mr Corbyn step down without having to trigger a leadership campaign.

One senior MP said: "It's finished. He will win easily in a second contest if he is on the ballot, it's everything we wanted to avoid."

They added: "He is losing support of the membership by the day, there is no doubt about that, but they just sign up new members to replace them. He is Teflon in that sense."

Another Labour source admitted that Mr Corbyn has "dug his heels in" and "isn't going

anywhere", adding: "It's grim."

MPs had mounted a campaign to remove the Labour leader after he sacked Hilary Benn as shadow foreign secretary following the EU referendum.

In the following week almost every shadow minister in Mr Corbyn's top team resigned and a vote of no confidence in the leader won the support of over 80 per cent of MPs who voted.

However Mr Corbyn and his allies, including John McDonnell, the shadow chancellor, have refused to back down and allow a new leader to be appointed, citing

the mandate he won from Labour voters in September.

A Labour MP told reporters: "There are more talks planned, but when one side's red

line is that Jeremy stays in post and the other side says he has to go, it is impossible to find a compromise. It's done.

"It's no good. It's possible that the PLP

would consider some kind of executive role for Jeremy if he were to stand aside as leader but his team just won't consider that option, they know where the power lies."

## Corbyn 'sorry' on behalf of Labour for Iraq war and hints at Blair legal action

**JEREMY CORBYN has apologised for the Iraq War on behalf of the Labour Party following Wednesday's release of the Chilcot report into the 2003 invasion.**

The Labour leader, a life-long anti-war campaigner and fierce critic of the intervention in the Middle East state, risked sparking a new rift in his party with his comments on Sir John Chilcot's findings.

Speaking on Wednesday evening at a Westminster event attended by the families of fallen service personnel in Iraq, Mr Corbyn said: "Politicians and political parties can only grow stronger by acknowledging when they get it wrong and by facing up to their mistakes.

"So I now apologise sincerely on behalf of my party for the disastrous decision to go to war in

Iraq in March 2003.

"That apology is owed first of all to the people of Iraq. Hundreds of thousands of lives have been lost and the country is still living with the devastating consequences of the war and the forces it unleashed."

Mr Corbyn's decision to issue an apology late in the day and not earlier in Parliament sparked

sorrow of those who lost ones they loved in Iraq - whether our armed forces, the armed forces of other nations or Iraqis.

"The intelligence assessments made at the time of going to war turned out to be wrong, the aftermath turned out to be more hostile, protracted and bloody than ever we imagined... and a nation whose people we wanted to set free from the evil of Saddam became instead victims of sectarian terrorism.

"For all of this, I express more sorrow, regret and apology than you may ever know or can believe."

But he was defiant on the central decision to go to war, saying "there were no lies, Parliament and Cabinet were not misled, there was no secret commitment to war, intelligence was not falsified and the decision was made in good faith".

In a nearly two hour news conference he said he would never agree that those who died or were injured in Iraq "made their sacrifice in vain" as they had played their part in "the defining global security struggle of the 21st century against the terrorism and violence which the world over destroys lives, divides communities".

Quizzed about what he was apologising for, he said: "There is no inconsistency in expressing my sorrow for those that have lost their lives - my regret and my apology for the mistakes - but still saying I believe the decision was right. There is no inconsistency in that."

He said the US would have launched an invasion "either with or us or without us", adding: "I had to decide. I thought of Saddam and his record, the character of his regime. I thought of our alliance with America and its importance to us in the post 9/11 world and I weighed it carefully with the heaviest of hearts."

**Veteran republican Ivor Bell will stand trial for involvement in the 1972 murder of mother of 10 Jean McConville, a judge in Northern Ireland has ruled.**

Bell, 79, is charged with aiding and abetting the kidnap, killing and secret burial of the widow.

The pensioner, who is also charged with IRA membership, appeared at Belfast Magistrates' Court on Wednesday, where he was told the high-profile case would proceed to the Crown Court.

District Judge Amanda Henderson said: "There is a case to answer at this stage."

Bell denies all the charges against him. Judge Henderson's decision followed a two-day preliminary inquiry at the Laganside court

complex last week.

The judge said she was "satisfied" the strength of the evidence was sufficient to meet the threshold to return the accused for trial.

Throughout the brief hearing, Bell stood in the dock beside a prison guard, wearing a blue coat, grey and white striped shirt and grey cardigan.

On the advice of his solicitor he replied "no" when asked if he had any response or intended to call witnesses.

Mrs McConville, 37, was dragged from her home in Belfast's Divis flats complex by an IRA gang of up to 12 men and women in late 1972.

She was accused of passing information to the British Army - an allegation later discredited by the

Repeating that suggestion tonight, he said: "We now know that parliament was misled in the run-up to war and MPs should now decide how it should deal with that 13 years later just as all those who took the decisions laid bare in the Chilcot report must face up to the consequences, whatever they may be."

Northern Ireland Police Ombudsman.

The widow was shot in the back of the head and secretly buried 50 miles from her home, becoming one of the "Disappeared" victims of the sectarian conflict.

It was not until 1999 that the IRA admitted the murder when information was passed to police in the Irish Republic.

Her remains were eventually found on Shelling Hill beach in Co Louth by a member

of the public in August 2003. Nobody has been convicted of her murder. Part of the case against Bell is based on the content of tapes police secured from an oral history archive collated by Boston College in the United States.

Academics interviewed a series of former republican and loyalist paramilitaries for their Belfast Project on the understanding that the accounts of the Troubles would remain unpublished until their

deaths.

But that undertaking was rendered meaningless when Police Service of Northern Ireland (PSNI) detectives investigating Mrs McConville's death won a court battle in the US to secure the recordings.

It is alleged that one of the interviews was given by Bell - a claim the defendant denies - and he was first charged in March 2014.

A trial date has yet to be confirmed.

suggestions he was too scared to make the comments in front of his backbench MPs.

# “Customer is king and we are the customer”

## ■ Farage tells Strasbourg: UK has ‘strong hand’

**NIGEL FARAGE** announced this week that he was leaving the political stage, but not before warning Britain’s next prime minister not to “sell out” on a Brexit deal and recognise the “strong hand” the UK has in EU exit talks.

The Ukip leader urged the next Tory leader, who will be elected by September 9, to remember the “customer is king and we are the customer” when it comes to negotiating a new trade relationship with Europe.

He also said the next occupant of Number 10 would come to regret backtracking on the

referendum result by signing up to the EU’s free movement rules against the will of voters and leave the country in a situation like Norway.

Speaking at a press conference in Strasbourg, Mr Farage branded Britain’s current relationship with the EU “rubbish” and insisted even if there is no deal agreed by the time the UK formally exits the bloc the country would be “better than where we are now”.

The life-long anti-EU campaigner, who announced his resignation as Ukip leader this week, noted how Britain has a sizeable and growing

trade deficit with the EU.

He told reporters: “I hope we see strong prime minister that recognises in the commercial world it’s the customer that is king and we are the customer, we are the buyer.”

Adding he was “bullish” about Britain’s prospects outside of the EU, Mr Farage said German car manufacturers and French wine and champagne produces would be “putting big pressure” on their political leaders for a “common sense deal to be reached with the UK”.

Mr Farage dismissed the clamour among politicians for Britain to remain part of the EU’s single market,

hitting out at the negative impact of the “protectionist club”.

He said: “The customs union that is called the ‘single market’ as if it’s some sort of soft cuddly puppy effectively is a protectionist club.

“What it means for

European consumers is... everything we buy from all over the world is more expensive as a result of being part of this club.

“It rather suits big companies to be part of something that keeps consumer prices more expensive.”

The outgoing Ukip leader, who will be replaced at the head of the party by September, said even if he was wrong about Britain’s future economic prospects the eurozone is “likely to be more troubled and more plagued” than the UK.

## May leads the field in Tory race

Theresa May and Andrea Leadsom will battle it out to become the next leader of the Conservative Party after Michael Gove was eliminated from the contest.

After the second MPs’ ballot on Thursday, Home Secretary Mrs May finished with 199 votes, Energy Minister Mrs Leadsom 84 and Mr Gove, the justice secretary, 46.

Conservative members will now decide the winning candidate, with the result due on 9 September.

The winner will become

the UK’s second female prime minister.

Mr Cameron resigned after finishing on the losing side in the UK’s EU referendum, in which there was a vote for the UK to leave.

The results were announced at Westminster by Conservative MP Graham Brady, the chairman of the backbench 1922 Committee.

There had originally been five contenders to succeed Mr Cameron, with MPs voting in two rounds to get that number down to two.

The contest now moves to its final stage with the Conservative Party’s 150,000-strong membership deciding between Mrs May, a Remain campaigner with a long track record in government, and Mrs Leadsom, a leading light of the Brexit campaign who has stressed her City and business background.

Speaking after the results were announced, Mrs May said she had secured support from all wings of the Conservative Party and pledged to bring the Tories together.

## Clarke brands Tory race a ‘fiasco’

Ex-Conservative chancellor Ken Clarke has called the Tory leadership contest a “fiasco” and made disparaging remarks about the candidates.

Footage of the veteran MP preparing for an interview was released by Sky News.

He said Andrea Leadsom had said some “extremely stupid things” and predicted Michael Gove would take the UK to war “with three countries at once”.

He was talking to ex-foreign secretary Sir Malcolm Rifkind. Neither appeared to realise they were being recorded.

Mr Clarke, who has himself lost out when standing for Conservative leader three times, said he would probably end up supporting Home Secretary Theresa May.

He praised her but said she was a “bloody difficult woman”, telling Sir Malcolm: “But you and I worked for Margaret Thatcher.”

Turning to his assessment of Brexit campaigner and energy minister Mrs Leadsom, the Europhile Conservative MP said: “She’s not one of the mindless, tiny band of lunatics, who think we can have a sort of glorious

economic future outside the single market.

“So long as she understands that she is not to deliver on some of the extremely stupid things that she’s been saying.”

Justice Secretary Michael Gove is criticised by both men, with Sir Malcolm saying he does not mind who wins as long as Mr Gove is not in the final two.

Mr Clarke doubts Mr Gove would win the backing of Tory members, adding: “I think with Michael as prime minister we’d go to war with at least three countries at once.”

# Actor comic and writer Caroline Aherne dead at 52

## ■ Talented performer created award-winning Mrs Merton and The Royle Family

**Caroline Aherne, the award-winning actor and comedian, has died at the age of 52 after suffering from cancer, her publicist announced on Tuesday**

Aherne, who co-wrote, directed and starred in *The Royle Family*, revealed two years ago she had been undergoing treatment for lung cancer in her home city of Manchester. She was born with a rare form of retina cancer and later received treatment for bladder cancer.

"Caroline Aherne has sadly passed away after a brave battle with cancer," her publicist Neil Reading said. "The Bafta award-winning writer and comedy actor died earlier today at her home in Timperley, Greater Manchester. She was 52. The family ask for privacy at this very sad time."

Aherne created some of British comedy's best-loved characters: lazy daughter Denise in *The Royle Family*, acerbic chat show host Mrs Merton – which first aired on BBC2 in 1995 – and memorable *Fast Show* characters such as the *Checkout Girl* and *Poula Fisch*, a

TV weather girl in an unnamed country where the sun was always "scorchio!"

Ahern was born to a working class Manchester family with an alcoholic father. From an early age she developed the role of the family joker and gained an ability to accurately mimic characters on television.

"Nobody else in the family was like that," her brother recalled.

"But she was funny from the time she was really little."

By the time she was 15 Aherne had taken the decision to become a writer, after seeing the Mike Leigh play *Abigail's Party* on BBC TV.

She was extremely bright, achieving nine Grade A O-Levels at a local convent school before going on to study drama at Liverpool Polytechnic.

One of her first jobs was with the BBC in Manchester, as secretary to Janet Street Porter, but the performance bug was already ingrained in her.

She became a regular on the Manchester comedy circuit in the character of

Mitzi Goldberg, a spoof country and western singer.

Aherne's career was boosted when she met Craig Cash, with whom she worked on Manchester's KFM indie radio station.

He encouraged her to further develop the character of an agony aunt called Mrs Merton and sent tapes to the presenter Martin Kelner, who played them on his Radio 2 show.

The *Mrs Merton Show* launched on BBC TV in 1995 and ran for five seasons.

A series of guest stars were subjected to gentle but often extremely embarrassing questions in front of a live audience of pensioners.

"And what first attracted you to the millionaire Paul Daniels?" was one of the gems aimed at guest Debbie McGee.

Carol Thatcher was asked if she had been breast-fed, while George Best was quizzed as to whether it was playing all that football that made him so thirsty.

But by the third series of *Mrs Merton*, Aherne was feeling the pressure

of the continual live performances, and her personal life was beginning to unravel.

Her marriage to New Order bassist Peter Hook collapsed and a *Mrs Merton* series filmed in Las Vegas was not a success.

### Retreat

Her dependency on alcohol increased and she began suffering long periods of depression.

It culminated in a well-publicised suicide attempt in 1998 and Aherne took herself off for rehab.

"I actually have no recollection of it," she said later.

"But I'd been down for a



while, and my mind was whizzing at night, so I was drinking to sleep."

The *Royle Family* was created after she and friend Craig Cash, who played gormless Dave

Best in the show, threw themselves into their work after her suicide attempt. The show won four gongs at the 1999 British Comedy Awards including best actress for Aherne.

The *Mrs Merton Christmas Show* won the best talk show Bafta in 1997, while *The Royle Family* collected best sitcom award in 2000 and 2007. Aherne was nominated for Baftas for her performance in both shows, as well as her directing of *The Royle Family* in 2001.

BBC director general Tony Hall said: "She was a brilliant, award winning comedy writer and performer, much loved by audiences – especially for *The Royle Family* and *Mrs Merton* and for her wonderful voicing of many shows. Our thoughts are with her family and friends."

## End of the road for Evans at Top Gear

**Chris Evans has announced he is leaving his role as a presenter on BBC Two's Top Gear after one series.**

He tweeted: "Stepping down from *Top Gear*. Gave it my best shot but sometimes that's not enough.

"I feel like my standing aside is the single best thing I can now do to help the cause."

His resignation comes after falling ratings for the show – which hit a series low on Sunday night, with an average of 1.9 million viewers.

According to reports

the remaining five presenters – Matt LeBlanc, Rory Reid, Chris Harris, Sabine Schmitz and Eddie Jordan – will return for the next series, which is due to begin filming in September.

It is also believed Evans's decision to leave was his alone, and that he told the BBC last week he was stepping down, saying he was not a good fit for the programme.

*Top Gear* is one of the BBC's most important shows. It's brought millions of viewers to the BBC, many of whom aren't big users

of other BBC services. And internationally it's worth tens of millions of pounds to BBC Worldwide.

The Sun claimed the presenter's role "was a car crash from the very start".

"The main attraction is meant to be presenters and the sense of humour and attitude. Chris Evans will go down as the Davie Moyes of *Top Gear*," Ally Ross said, referencing the football manager who had to take over Manchester United after the departure of Sir Alex Ferguson.

# New OED finds room for budgie smugglers

**Budgie smugglers, glamping and listicles are some of the more eye-catching new entries to the Oxford English Dictionary (OED).**

The latest update also includes the likes of "bovver", made famous by comedian Catherine Tate.

A number of internet slang acronyms such as FWIW and ICYMI have also made the new list.

They are some of the more than 1,000 new words and senses, and nearly 2,000 fully revised or expanded entries.

"Budgie smugglers" is an Australian term used since the 1990s that refers

to a pair of tight men's swimming trunks.

"Glamping" is a shortened form of the phrase "glamorous camping", used to describe a camping with luxuries and accommodation more associated with hotel stays.

"Listicles" are a recent invention of the internet age, describing online newspaper or magazine articles presented in the form of a list.

In the latest update, the OED acknowledges the "inescapable factor of modern life is our increasing reliance on computers and digital communications".

It has included acronyms such as FWIW, short for "for what it's worth", and ICYMI, "in case you missed it", which are used frequently on social media and in text messaging.

"Bovver" makes the list thanks to Catherine Tate's teenage character Lauren's much-repeated catchphrase "Am I bovvered?"

The next update to the OED is due in September.

## Elizabethan Espionage: a ruff business?

Exclusive interview with author Patrick Martin and a review of his new book about Catholic espionage in Elizabethan England  
Rating: ★★★★★



"I began work on a book on the rivalry between Edward Coke and Francis Bacon to become attorney general of England 1593 to 1594," says *Elizabethan Espionage* author Patrick Martin. "As I focused on their work on Catholic conspiracies, I encountered spy letters under various aliases...especially the names Robinson and Rivers. These letters were often intriguing and eventually, after collecting and transcribing a number of them, I realized they were all related to one William Sterrell."

*Elizabethan Espionage* brings to light the unrecognized role of William Sterrell and the intelligence network

established by himself, Jesuit priests in England and English Catholic exiles abroad. After Elizabeth destroyed the Spanish Armada in 1588, ending a potential invasion, the Catholics in England were on their own. They devised an ingenious network of Jesuits who relayed intelligence to Brussels, Antwerp, Madrid and Rome. Oxford philosopher William Sterrell, a member of the British government, worked for both the Earl of Essex and for the 4th Earl of Worcester, secret sponsors of the Jesuits.

Sterrell's clandestine spy network went undetected for 400 years.

Martin brings the details to life of how Sterrell was able to engineer his network. He reveals original letters and documents that have never been published, the details of how people moved around...and the unfortunate end to those who were discovered. A vivid read.

"As I worked on his identity and background, I learned he (Sterrell) was formerly a philosophy lecturer and fellow of Magdalen College, Oxford," says Martin. "Pressured into working as a spy for the Earl of Essex by Thomas Phelippes the Decipherer and Francis Bacon. By the time I collected about 250 of his letters, I set about writing his biography, together with John Finnis of University College, Oxford. We collaborated on a series of articles. I put the book into its present

form over the past three years."

Most English spying in the Elizabethan period related to religious matters. The book explores the deceptions and false plots devised by Elizabeth's spymaster, Sir Francis Walsingham, to bring about the execution of Mary Queen of Scots.

For research, Martin began with the English State Papers Domestic, then printed out the underlying documents referred to in those volumes from microfilm in the LSU library and the Folger Shakespeare Library in Washington D. C. He made two trips to Oxford University for original materials in the Bodleian Library, visited the British Archives at Kew Gardens and spent a week in the Jesuit archives in London."

Martin, a law professor with a Ph.D. in history, retired from teaching to devote himself to writing. He's the author

or co-author of books on oil and gas law, legal philosophy, and regulation of the energy industry. In collaboration with Professor Finnis, they've written a series of articles on Sterrell, Shakespeare, Ben Jonson, and Thomas Thorpe [publisher of Shakespeare's Sonnets]. They are writing a related book on the Fourth Earl of Worcester, Shakespeare, and Sterrell.

Martin has recently completed writing two novels. *Nasty, Brutish and Short: The Philosopher and the Prince, Paris Exiles, 1646* is about Thomas Hobbes and Prince Charles. *A Crafty Scout* is about a law student in New Orleans in the summer of 2015 who becomes involved in the Louisiana movie industry. Martin is writing three non-fiction books: *The Seductions of Philosophy, Beams Not Falling: The Existentialism of O'Neill, Hammett, Camus and Percy,* and *The Earl, the Playwright and the Spy*. He's also

working on a two-part novel set in Louisiana in the 1800s.

Martin lives in Clinton, Louisiana, north of Baton Rouge. He was born in Bastrop, Louisiana, in 1945.

"He played extremely well. That first set was a tough one for him to lose, and I ran away with the second but he fought right until the end and it was a great match."

Murray remains on course to reach a third Wimbledon final but only after surviving the first significant examination of this year's campaign.

The Briton was calling for support from his team and checking his motivational notes at the changeovers as Tsonga launched an impressive fightback in the third and fourth sets.

Murray looked to have done the hard work when he saved three set points on his way to clinching a dramatic opening tie-break after 77 minutes.

Tsonga, 31, had beaten the Scot just once in the last eight years and never on grass, and the second

set disappeared in just 25 minutes as Murray apparently closed in on victory.

However, the Frenchman began to fire on serve, giving him the confidence to attack the net and take on the Murray second serve with his huge forehand.

That tactic brought Tsonga the only break of the third set and, despite a heavy fall at the start of the fourth, he continued to look the more threatening of the two players.

Murray, so assured through his first four matches, was now on edge and even a potentially decisive break for 4-2 could not settle him, Tsonga breaking straight back with another heavy forehand winner.

When two winners flew from the usually weaker Tsonga backhand on break points, Murray found it hard to contain his frustration, and a brilliant pass down the line helped the 12th seed level at two sets all. A second Centre Court comeback of the day loomed when the Frenchman earned a break point at the start of the decider but he could only find the net with a backhand, and a relieved Murray finally regained control.

The Scot began to find his range on the forehand and closed in on the net to break for 2-0, before powering into a 5-0 lead and serving out after nearly four hours.

## Giggs has the 'steel' to succeed as a manager, says Fergie

### United legend leaves Old Trafford after 29 years

Former Manchester United boss Sir Alex Ferguson says it was time for Ryan Giggs to leave the club and that he has the "steel" to succeed in management.

Giggs, 42, ended a 29-year stay at United after new boss Jose Mourinho decided not to retain him on his staff.

Ferguson says long-time rival Mourinho was right to go with "his own man" - long-time

assistant Rui Faria.

The 74-year-old told BBC Sport: "It is time Ryan stood on his own feet, got out there and accepted the challenge."

Ferguson thinks his former charge, who was assistant to former United manager Louis van Gaal, has the qualities to make it on his own.

"I talk about his poker face," said the Old Trafford legend, who stepped down as

manager in 2013. "He has a bit of steel about him.

"It is such a highly intense results industry, you need people who go into it to have a bit of steel about them, a bit of character and personality."

Former Chelsea boss Mourinho, who succeeded Van Gaal, has worked with Faria in his six previous managerial jobs.

"You have got to

have, in your assistant, someone you have trusted all your life," said Ferguson.

"When I came to United, I brought Archie Knox because he was a valuable person for me. I trusted him 100%. Jose Mourinho has had his assistant for years and, quite rightly, has stuck by his own man.

"If Jose hadn't had an assistant, I know he would have taken Ryan."

# No regrets, says Bale

**“We have to be proud” says Welsh superstar as Portugal end Euro 2016 dream**

**Gareth Bale says Wales “can have no regrets” after a 2-0 loss to Portugal in the Euro 2016 semi-final ended their hopes of a first major tournament win.**

Two goals in three second-half minutes sealed their fate in Lyon Wednesday night.

“We have to be proud of ourselves,” the forward said. “We have given everything on the pitch and off the pitch and tried to enjoy the experience.”

Prime Minister David Cameron said Wales had “inspired a nation and made Britain proud” with their exploits in France.

First Minister of Wales Carwyn Jones said he was “sad it’s over” but “very proud again”.

Chris Coleman’s side upset the odds to reach the last four as the likes of England, Italy, Spain and Croatia were knocked out in earlier rounds.

But he admitted: “It hurts that we lost. The players are gutted, but they need to look back and see they have done their country proud.”

Reaching the semi-finals was a historic moment for Wales.

Their previous best tournament result came in 1958, when they reached the quarter-finals of the World Cup in their last appearance at

a major finals.

After a goalless first half, Cristiano Ronaldo broke the deadlock on 50 minutes with a magnificent header.

Three minutes later, his shot was diverted past Wayne Hennessey in the Wales goal by former Manchester United teammate Nani.

## ‘A beautiful dream’

Wales began the tournament as one of the outsiders but caused a shock by topping Group B, finishing above England despite losing to their neighbours.

They then edged past Northern Ireland in the last 16 before upsetting a highly regarded Belgium side 3-1 in the last eight.

Their exploits earned rave reviews back home, securing a good luck message from the Prince of Wales before Wednesday’s game against Portugal.

Footballers past and present, politicians, celebrities and other sportsmen and women were also full of praise for the Wales team.

Welsh rock band The Manic Street Preachers, who performed the country’s Euro anthem Together Stronger, tweeted that the campaign had been “a beautiful dream” and thanked the team from “the bottom of our

hearts”.

Former Wales midfielder and BBC pundit Robbie Savage said: “The boys have made us all so proud of our country,” while Wales rugby union wing George North tweeted: “Gutted but what an unbelievable tournament!”

Boxer Enzo Maccarinelli said Wales had achieved more than anyone thought possible, while cyclist Geraint Thomas, busy riding in the Tour de France, said: “The dream is over... but the boys have done themselves and Wales proud!”

Five months before Coleman was appointed in 2012, Wales were ranked 117th in the world. They reached a high of eighth in October last year, one month after moving above for England for the first time ever.

Wales were 26th before the tournament began but when Fifa updates its list on 14 July, they are set to rise to 11th - above England again.
