'One Nation' May named new PM

■ As rivals fall away, UK's second woman Prime Minister enjoys quick coronation

The UK's new prime minister Theresa May has vowed to lead a "one nation" government that works for all not just the "privileged few".

Speaking outside 10 Downing Street after being appointed by the Queen, she said it would be her mission to "build a better Britain".

She promised to give people who were "just managing" and "working around the clock" more control over their lives.

Mrs May is the UK's second female prime minister, after Margaret Thatcher.

Mrs May later began appointing Cabinet members, with Philip Hammond - foreign secretary under Mr Cameron - becoming chancellor and Boris Johnson becoming the new foreign secretary.

'Burning injustice'

Mrs May's husband Philip was standing behind her as she made her first public speech in the role, highlighting the "precious bond" between England, Scotland, Wales and Northern Ireland and between "every one

of us".

"That means fighting against the burning injustice that if you're born poor you will die on average nine years earlier than others," she said.

For an "ordinary working class family", she added, "life is much harder than many people in Westminster realize".

Speaking directly to people who were "just managing", she said: "The government I lead will be driven, not by the interests of the privileged few, but by yours. We will do everything we can to give you more control over your lives."

In his farewell statement outside Downing Street, Mr Cameron said Mrs May would provide "strong and stable leadership" and wished her well in her negotiations on Britain's exit from the EU.

Like Mr Cameron, Mrs May campaigned to remain in the EU but

has said she will respect the will of the people, as expressed in 23 June's referendum, saying: "Brexit means Brexit".

She has moved quickly to fill key roles in her cabinet.

'economic uncertainty'

Amber Rudd is the new home secretary, David Davis has been given the new role of Brexit secretary and Liam Fox becomes international trade secretary. Michael Fallon remains in the role of defence secretary.

Mr Johnson, Mr Davis and Mr Fox all supported the campaign to leave the EU.

Mrs May, 59, suddenly won the Conservative leadership contest after rival candidate Andrea Leadsom pulled out on Monday.

Labour's deputy leader, Tom Watson, offered his congratulations to Mrs May but warned she would have to deal with the "enormous

economic uncertainty and insecurity" caused by leaving the EU.

He said: "We've today had warm words from our new prime minister about the need to stand up for more than a 'privileged few'."

"The sentiments are good ones but just like her predecessor the rhetoric is much better than the reality."

Mrs May also vowed to keep the underprivileged uppermost in her policies: "When we take the big calls, we'll think not of the powerful, but you," she said.

"When we pass new laws, we'll listen not to the mighty, but to you. When it comes to taxes, we'll prioritise not the wealthy, but you."

"When it comes to opportunity, we won't entrench the advantages of the fortunate few, we will do everything we can to help anybody, whatever your background, to go as far as your talents will take you."

She also paid tribute to her predecessor, David Cameron, saying he had been a "great, modern prime minister".

Mrs May arrived at Downing Street from Buckingham Palace, where she officially accepted the Queen's invitation to form a new government.

Earlier the Queen accepted Mr Cameron's resignation as prime minister.

Jobs for the girls!

Theresa May marked her first full day as Prime Minister on Thursday with a swift and sweeping reconstruction of her cabinet, removing four senior ministers, including Michael Gove the justice secretary and Nicky Morgan, the education secretary, and promoting ministers including Justine Greening and Liz Truss.

The departure of Gove was among May's first moves on Thursday, after she made six key appointments the evening before. Among the other casualties were John Whittingdale, the culture secretary, and Oliver Letwin the Cabinet Office minister.

demise

Stephen Crabb, the work and pensions secretary and one of the contenders for David Cameron's job, said he had resigned from the government "in the best interests of my family".

This came in the wake of a story in the Times in which it was revealed that Crabb, who is married, had sent sexually explicit social media messages to a young woman.

Despite numerous reports that Jeremy Hunt was going to lose his job as health secretary, Downing Street said he would remain in the role. Hunt tweeted that reports of his demise had been greatly exaggerated:

Theresa Villiers, the Northern Ireland secretary, left after refusing a move. She said on her Facebook page: "The new prime minister was kind enough to offer me a role but it was not one which I felt I could take on." Villiers did not say what role she turned down.

Justice Secretary

In the first new appointment of the morning Truss, previously environment secretary, emerged from No 10 Downing Street to announce she had been appointed justice secretary and lord chancellor. She is the first woman in either role.

Greening has been promoted to education secretary and minister for women and equalities, moving from international development. She is the first education secretary to have attended

comprehensive school and will run a beefed up department, taking in higher and further education from the department for business, innovation and skills.

big job for Boris

The transport secretary, Patrick McLoughlin, had been moved to become chancellor of the Duchy of Lancaster and Conservative party chairman, No 10 said. The former, non-portfolio job does not usually come with full cabinet status, though incumbents often attend.

Gavin Williamson, a Staffordshire MP who spent nearly three years as David Cameron's parliamentary private secretary, was promoted to become chief whip, Downing Street said.

Gove, who fell out badly with May over religious extremism when she was home secretary and he was education secretary, was dismissed on Thursday morning, according to sources.

Gove had stood against May to replace Cameron as Conservative leader but fell in the second round of

voting. Shortly after his departure was confirmed, he wished best of luck to the new government.

Earlier, the new chancellor, Mr Hammond, said there would be "no emergency Budget" when asked about his first priorities as chancellor.

His predecessor George Osborne warned during the EU referendum campaign that he would have to cut public spending and increase taxes in an emergency Budget if there was a vote for Brexit.

In a move that surprised the political world, Mrs May put Mr Johnson - one of the most prominent figures of the campaign to leave the EU - in charge of the Foreign and Commonwealth Office. Mr Johnson, who has said

he is "very humbled" and "very proud" at the appointment, is no stranger to controversy - or gaffes - on the international stage.

During the EU referendum campaign, he drew criticism for comments he made about US President Barack Obama, who he said had an "ancestral dislike" of the UK because of his

"part-Kenyan" heritage.

In 2015, Mr Johnson had to cancel planned public events in the West Bank because of security fears after he criticised backers of a boycott on Israeli goods, and he has previously described Hillary Clinton - US presidential hopeful - as having "a steely blue stare, like a sadistic nurse in a mental hospital".

Britain's second female PM: who is she, where does she come from and what does she believe in?

Theresa May became the new Conservative Party leader and Britain's second female prime minister on Wednesday, taking charge at one of the most turbulent times in recent political history.

But just who is the new face in Downing Street? For one thing the 59-year-old has been one of the longest serving home secretaries in British history and her cerebral, no-nonsense but intensely rational approach to her previous jobs have many in Westminster hoping she is the right person at the right time as the fallout from the UK's vote to leave the EU smashed possible rivals out of contention.

'unity' candidate

Long known to have nurtured leadership hopes, Mrs May - whose friends recall her early ambition to be the UK's first female PM - could have reasonably expected to have had to wait until at least 2018 to have a shot at Downing Street.

But the EU referendum which David Cameron called and lost - the year after leading the party to its first election win in 23 years - turned political certainties on their head and, as other candidates fell by the wayside after the PM's own resignation, Mrs May emerged as the "unity" candidate to succeed him.

That her party should rally round her at such a time of national uncertainty is testament not only to the respect in which she is held across the party but to the fact that, in a world where political reputations can be shredded in an instant, Mrs May is the ultimate

political survivor.

She has coped with being one of only a small number of women in the upper echelons of the Conservative Party for 17 years and has been prepared to tell her party some hard truths - famously informing activists at the 2002 conference that "you know what some people call us - the nasty party".

firmly middle class

Even before entering Downing Street, she made history by becoming the second longest serving home secretary in the past 100 years.

The daughter of a Church of England vicar, Hubert, who died from injuries sustained in a car crash when she was only 25, Theresa May comes from a firmly Home Counties middle class background. Born in Sussex but raised largely in Oxfordshire, Mrs May attended a state primary, an independent convent school and then a grammar school in the village of

Wheatley, which became the Wheatley Park Comprehensive School during her time there.

Friends recall a tall, fashion-conscious young woman who from an early age spoke of her ambition to be the first woman prime minister.

Like Margaret Thatcher, she went to Oxford University to study and in her third year she met her husband Philip, who was president of the Oxford Union, a well-known breeding ground for future political leaders.

The story has it that they were introduced at a Conservative Association disco by the subsequent Pakistani prime minister Benazir Bhutto. They married in 1980.

Her university friend Pat Frankland, speaking in 2011 on a BBC Radio 4 profile of the then home secretary, said: "I cannot remember a time when she did not have political ambitions.

"I well remember, at the time, that she did want to become the first woman prime minister and she

was quite irritated when Margaret Thatcher got there first."

After graduating with a degree in Geography, May went to work in the City, initially starting work at the Bank of England and later rising to become head of the European Affairs Unit of the Association for Payment Clearing Services.

One Nation Conservative

But it was already clear that she saw her future in politics. She was elected as a local councillor in Merton, south London, and served her ward for a

decade, rising to become deputy leader. However, she was soon setting her sights even higher.

She was elected MP for Maidenhead in 1997 and quickly impressed her colleagues with her brains and work ethic. She served in the shadow cabinets of William Hague, Iain Duncan Smith, Michael Howard and David Cameron, being named Home Secretary following the 2010 general election. She is considered a One Nation Conservative, the term coined by the 19th century Prime Minister Benjamin Disraeli to

describe a the belief that societies exist and develop organically, and that members within them have obligations towards each other. There is particular emphasis on the paternalistic obligation of the upper classes to those classes below them, social reform and economic mobility for the working classes.

Mrs May has also become a confidante as well as role model for aspiring female MPs - told prospective candidates before the 2015 election that "there is always a seat out there with your name on it".

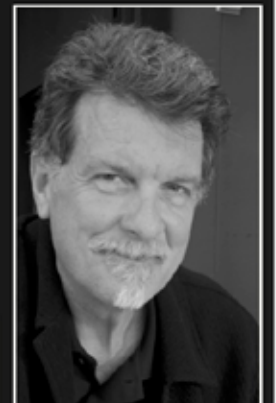

Cameron says goodbye, describing top job as 'greatest honour' of his life

■ Departing PM says he leaves UK 'much stronger'
 ■ Predicts May will provide "strong and stable leadership"

David Cameron said being prime minister had been "the greatest honour" of his life as said his farewells to Downing Street before leaving for Buckingham Palace to tender his resignation.

Flanked by his wife and children outside No. 10, he said the UK was "much stronger" than when he took over.

Earlier Mr Cameron took PMQs for the final time, telling MPs he would "miss the roar of the crowd".

Mr Cameron told reporters he had "not got every decision right" but adding: "I do believe that today, our country is much stronger."

MPs also joined in with the clapping, including leader Jeremy Corbyn.

Mr Cameron told his MPs that he intended to stay in public life and would be "willing them on", saying "nothing is impossible". In his final remarks, he reprised a comment he made to Tony Blair during his first PMQs as opposition leader in 2005, saying: "I was the future once."

warm wishes

He dismissed suggestions he will look to take over as the host of Top Gear or England manager, joking they "sound even harder"

than being PM.

He also stressed his love for Larry the Downing Street cat - amid rumours that he was not a fan - a point he later emphasised on Twitter and swapped warm wishes with Jeremy Corbyn, saying he had almost come to admire the Labour leader's "tenacity" in hanging on to his job.

'Amazing moments'

Defending his economic, social and foreign affairs achievements, Mr Cameron said there had been "many amazing moments" over the past six years of "public

service in the national interest".

Mr Cameron "warmly congratulated" Theresa May, who sat next to him during the session, on her election and told Mr Corbyn that "when it came to female prime ministers I am pleased to say pretty soon it is going be two-nil".

Mr Corbyn said that although he had often disagreed with the PM, he thanked him for his

service over the last six years and praised him for his backing for equal marriage and his efforts to secure the release of Shaker Aamer from Guantanamo Bay.

The Labour leader also paid tribute to Mr Cameron's wife Samantha and his family, who watched the proceedings from the public gallery. His daughters Nancy and Florence were seen to

give their father a wave and cheer him on during the session.

Earlier, Mr Cameron told the Telegraph he came into Downing Street to "lead people through difficult decisions so together we could reach better times", adding "as I leave today, I hope people will see a stronger country, a thriving economy, and more chances to get on in life."

'continued success'

"Politicians like to talk about policies, but in the end it's about people's lives," he said, pointing to the government's record on employment, the NHS and defence.

He wished Mrs May well, saying she would provide "strong and stable leadership", and paid tribute to his wife Samantha and his children.

As the family left for the final time, he said his only wish was "continued success for this great country that I love so very much".

A statement from Buckingham Palace confirmed he had tendered his resignation as prime minister and the Queen was "graciously pleased" to accept.

In the Commons, Conservative MPs rose as one to applaud Mr Cameron at the end of his 182nd PMQs session as prime minister, as did former Lib Dem Deputy Prime Minister Nick Clegg. Labour

The new Foreign Secretary: French blast 'liar' Boris

France's foreign minister has said his newly-appointed British counterpart, Boris Johnson, is a liar with "his back against the wall".

In comments to Europe 1 radio, Jean-Marc Ayrault said Mr Johnson had lied to the British people during the recent EU referendum campaign and would now be under pressure "to defend his country".

He said France needed a negotiating partner who was credible and reliable.

The former London mayor led the campaign to take Britain out of the EU.

He was expected to stand for the Conservative party leadership in the wake of the referendum result, but did not put himself forward after key colleagues withdrew support.

His appointment as foreign secretary has surprised many politicians and commentators around the world, who have recalled his history of

undiplomatic or offensive comments.

Mr Ayrault said: "I am not at all worried about Boris Johnson, but you know his style, his method during the campaign - he lied a lot to the British people and now it is him who has his back against the wall."

"[He has] his back against the wall to defend his country but also with his back against the wall the relationship with Europe should be clear.

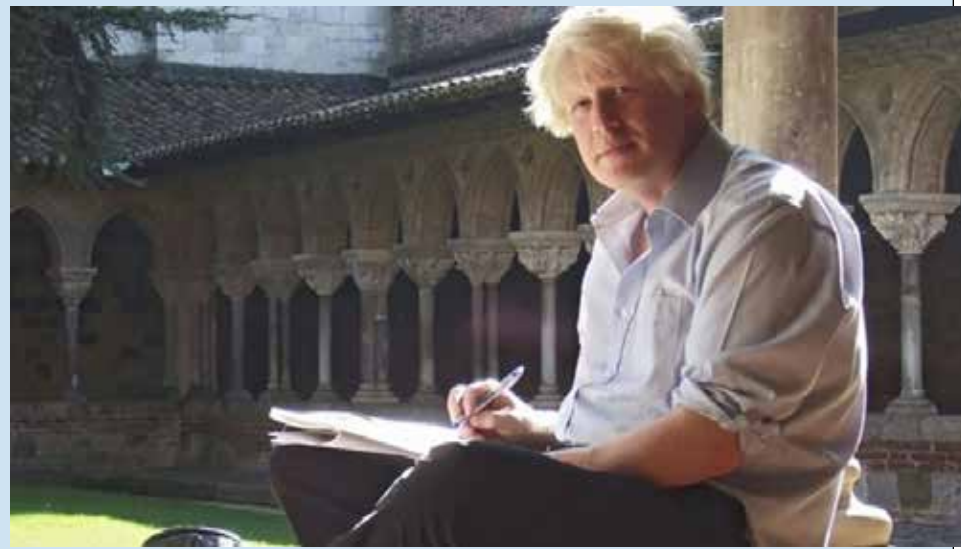
"I need a partner with whom I can negotiate and who is clear, credible and reliable," he added.

"We cannot let this ambiguous, blurred situation drag on... in the interests of the British themselves."

United States

The *Washington Post* publishes a round-up of "undiplomatic" things Mr Johnson has said during his time in public life.

"To be sure, Johnson is an unusual candidate for the job. The former journalist is known for his

deliberately provocative manner, ruffled appearance and penchant for sometimes-insulting commentary," it says.

It reminds its readers that just two months ago, "a poem he concocted about Turkish President Recep Tayyip Erdogan having sexual congress with a goat won the first-place prize in a contest sponsored by Spectator magazine."

Washington Post writer Ishaan Tharoor also writes that Mr Johnson

"has controversially bucked the Western trend and praised Syrian President Bashar al-Assad for battling the Islamic State, no matter its parallel campaign of violence on Syria's civilian population".

"A Short History of Boris Johnson Insulting Foreign Leaders" is how the website of American culture and politics magazine, *The Atlantic*, reports the story of Mr Johnson's comeback.

"The brash and flamboyant politician, the UK's new foreign secretary, is one of the more cosmopolitan figures on the world stage - but he's also one of the least diplomatic," it says.

Apparently stifling a laugh on hearing the news of Mr Johnson's new job, state department spokesman Mark Toner said the US would always work with the UK because of the "special relationship" between the two countries.

Obama snubs May as world leaders call to congratulate new Prime Minister

THERE WAS TALK of a presidential snub at Westminster this week as Barack Obama was notably slow to call Britain's new Prime Minister to offer his congratulations.

Number 10's newest occupant received calls from leaders in Germany, France and Ireland by Thursday lunchtime but at press time heard nothing from America's outgoing White House chief.

German chancellor Angela Merkel was the first leader to phone Mrs May when she called from Kyrgyzstan to applaud David Cameron's successor.

France's president Francois Hollande called the Prime Minister to wish her well in the new role and discussed with Mrs May the importance of maintaining a close relationship between Britain and France.

And the Irish Taoiseach Enda Kenny also spoke with Theresa May as he offered to visit London soon to discuss the ties between the two leaders' countries.

When asked why the Prime Minister had not received a call from the US, a Downing Street spokesperson

told the Daily Express: "These are calls we've received, we will put out a statement when we receive more."

The snub comes in the wake of Mrs May's first cabinet appointments, which included former London Mayor and prominent Brexit campaigner Boris Johnson as the new Foreign Secretary.

Mr Johnson infamously offended Mr Obama during the EU referendum campaign when he suggested the President's Kenyan heritage means that he resents Britain.

In all of the congratulatory conversations so far, the Prime Minister has expressed the importance to respect the result of the EU referendum.

Mrs May has previously stated that "Brexit means Brexit" when questioned over whether Britain and Leave supporters have been given a further boost after the appointment of prominent Eurosceptics David David and Liam Fox to the roles of Brexit Secretary and International Trade Secretary.

'Nervous' prince takes HIV Test

■ 'Groundbreaking' event broadcast live on the Royal Family's Facebook page

■ Fifth in line to the throne wanted to remove stigma around being tested

■ 'Gay, straight, black, white, ginger – why wouldn't you have a test?'

Prince Harry has been tested for HIV in an effort to raise awareness about the condition and encourage others to get checked out.

The prince walked into a sexual health clinic in Burrell Street, central London, during the week to have the finger-prick test - for which he tested negative.

The 31-year-old has made raising awareness about HIV and Aids a major element of his public work.

There are more than 100,000 people living with HIV in the UK.

The prince had to wait only a few moments to get his results, while his blood sample was mixed with chemicals and poured into a test tray.

'Test for everybody'

The negative result was indicated by a blue spot seen in the tray. However, if two spots had appeared he would have needed further tests

to confirm if he was HIV-positive.

The procedure was carried out by Robert Palmer, a lead health adviser and psychosexual counsellor, who said the prince was "anxious".

Asked about the significance of a member of the Royal Family getting tested for HIV, Mr Palmer added: "It means this is a test for

everybody - it doesn't matter who you are, it's a good idea to have an HIV test."

The average HIV prevalence in the UK - for those aged over 15 years old - is 1.9 per 1,000 population. However for gay men the rate jumps to 48.7 per 1,000. Black African women are the second most at-risk group with a prevalence

rate of 43.7 per 1,000.

Latest figures from Public Health England in 2014 estimated 18,100 people were unaware of their infection and at risk of unknowingly passing on the virus.

Mr Palmer reiterated that many people taking daily medication to manage their HIV lead 'long, full lives' with a partner and a healthy sex life.

Harry added: 'Gay, straight, black, white, ginger, whatever – why wouldn't you just have a test?'

'We all shouldn't be on the other side of the river saying "you should get the test", it should be normalized, everybody should get it.'

Clinics in London and throughout the country offer the rapid result tests, Mr Palmer explained.

Hunger strike threat from sex ASBO man

A MAN who cannot have sex without giving police 24 hours notice is to appear before a court after threatening to go on hunger strike.

The single father was cleared of rape earlier this year but still given a temporary 'Sex Abso' by North Yorkshire Police.

Under the terms of the Sexual Risk Order, the 40-year-old must give police 24 hours notice if he wants to have sex with a new partner - something he says is ruining his life.

He is also banned from using any technology that uses internet and cannot later be checked by police

- including everything from PIN-locked phones to certain types of lifts and intercoms.

'utterly unliveable'

In response, the man has threatened to go on hunger strike in order to overrule the unusual restriction.

He is set to appear

before York Magistrates' Court next week for a case management hearing about the order - which police want to make permanent.

In a statement, the man said: "I intend to commence hunger strike in protest over the SRO to which I am subject.

"I protest that even

though a jury found me unanimously not guilty, after nearly two years I still find myself being punished for a crime that never happened.

"I protest to being subject to an order that is unlawful in almost every syllable, is unjustified and is so extreme as to be utterly unliveable."

Foul-mouthed drunk banned from SWEARING anywhere in Britain...

A YOB who constantly uses bad language in public has been banned from SWEARING – anywhere in the UK.

Foul-mouthed David Bellman, 44, regularly launches a series of F-word tirades in the street after drinking sessions.

During the latest incident he used bad language and racial and homophobic slurs in his home town of Bodmin, Cornwall.

He has now been banned from being drunk anywhere in public by magistrates who also banned him from swearing anywhere in Britain.

Bellman was handed the criminal behaviour order (CBO) after he was arrested for subjecting railway staff and passengers to a "tirade of abuse" at Par train station.

He swore at staff repeatedly on July 7, the day he was released from Exeter prison.

Magistrates were told he had a pattern of similar persistent behaviour, mostly in the Truro area.

Sergeant Marc Sayers, the neighbourhood team leader at Truro police, said that Bellman had been a persistent menace in the city over a short time.

He carried out "numerous public order and drunk and disorderly offences" including racially abusing a female worker as she attempted to serve him at Burger King.

In June he was jailed at Truro Magistrates' Court for distressing conduct.

"He subjected innocent members of the public to a tirade of vile and offensive language as well as homophobic and racial terms while under the influence of alcohol," said Sergeant Sayers.

"His behaviour caused harassment, alarm and distress to retailers and visitors to Truro city centre.

This was behaviour that no one should have to experience."

He added that Bellman had refused to engage with any support offered and

his "continued antisocial behaviour could no longer be tolerated".

The three-year CBO states that Bellman must not be found in a state of drunkenness in any public space or place the public has access to or be found in possession of an open container of alcohol in the city centre.

He must not use swear words, make threats, use physical gestures, use visual representation, cause nuisance or obstruction that would cause any person offence, intimidation or distress directly or indirectly within the UK.

Tom Styles, of Cornwall Council's antisocial behaviour (ASB) team, said: "This is a great example of the multi-agency work done by police, British Transport Police, [drug and alcohol treatment charity] Addaction, Crown Prosecution and Cornwall Council's ASB team who continue to work closely together to deal with antisocial behaviour in Cornwall."

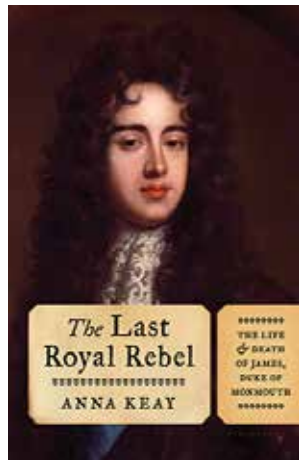

"After seeing numerous fascinating original paintings and other material, he took me to his strong room. He showed me, in an old velvet box, a breathtaking thing. Here was Monmouth's gorgeous diamond-studded Great George, part of the insignia of the ancient order of the Garter. These were



son James Monmouth played in the politics of seventeenth century England. Keay's choice of words evokes the time, the triumphs and disappointments. The king, Charles I, has been killed. Cromwell has taken over England. How charming and dissolute both Charles II and James were. For English history lovers, you'll learn quite a bit about this royal pair.

the jeweled objects he prized most, given to him by his father when he was just 13 and taken by him into exile twenty years later. They were then the objects he pawned to a Rotterdam merchant to raise the money to equip his three ships for his invasion, using the funds to buy canons and breastplates, gunpowder and a printing press."

Keay takes a rare look at the death of King Charles II, the Restoration of the monarchy and role his

King Charles II had many illegitimate children. James lived with his mother Lucy Walters, an English girl who was brought to the Netherlands by her mother, who later leaves, stranding Lucy who has to make her own way by whatever means she can. Lucy uses James as a pawn to get money from Charles. Charles wants his son away from Lucy's bad influence. Launching three kidnap attempts, the third is successful. Once Charles is back in England and taken his

rightful place he brings his son to England. James life is glamorous, yet fraught with danger.

Anna Keay grew up in the west Highlands of Scotland, in a remote farmhouse. "When I was at Oxford University I had a summer job working in Inveraray Castle, the seat of the Dukes of Argyll and the Clan Campbell. As I took people on tours of the building, in my tartan skirt, I pointed out the Earl of Argyll who was executed for treason in 1685. He led the Scottish wing of Monmouth's rebellion. I was always intrigued about these two young aristocrats who looked like the most elegant courtiers leading an armed invasion of Britain." Ten years later, while working as a curator at the royal palaces in London, the buildings that the Duke of Monmouth had called home before he joined forces against his uncle James II, Keay decided

to write the book.

"What I love about this period in history that national politics were personal and personal relationships political," says Keay. "Monmouth was the illegitimate son of Charles II, conceived when his parents were both 18. His life, from the moment he was kidnapped from his mother when he was eight to his execution at 36, was a journey through the highs and lows of British political history in the age of revolution."

Monmouth fought with d'Artagnan, talked politics with John Locke, danced with Nell Gwyn, campaigned with Louis XIV, planned buildings with Christopher Wren and was adored by his father Charles II. Yes, the d'Artagnan of *The Three Musketeers* novel, which was inspired by the life of Charles de Batz-Castelmore d'Artagnan, Louis XIV's captain of the Musketeers of the

Guard who died at the Siege of Maastricht in the Franco-Dutch War in 1673.

Keay lives in London and in Norfolk in a medieval merchant's house near the sea. She was born in the West of Scotland in a remote farmhouse, where her father still resides.

Strictly bad news: Len Goodman waltzes off hit dance show...!!

Len Goodman has broken fans' hearts by waltzing away from the smash hit UK TV show *Strictly Come Dancing* after more than a decade on the panel.

The veteran performer has been with the popular reality TV show since it hit our screens in 2004, but he has now confirmed his shock departure.

Len, 72, has confirmed this year's series will be his last as he wants to hand the role of head judge to a younger replacement.

He said in a statement: "In 2004, I was asked to take part in a brand new BBC Saturday night show and who would have thought me, old Len Goodman, would still be part of this amazing series more than 10 years on.

"This adventure began when I was 60 and now that I've reached my 70s, I've decided after this year it's time to hand the role of Head Judge to someone else."

Louise Rainbow, Executive Producer of *Strictly Come Dancing*, expressed her sadness about Len's departure, but insisted TV bosses plan to make this series



the best yet.

She said: "We are absolutely delighted that [hosts] Tess, Claudia and our judges are all returning for another year. Whilst we will be sad to say goodbye to Len, as our way of saying thank you, we are all determined to make this series the most spectacular, most glittery and entertaining yet."

Len has devoted the majority of his life to dancing, spending years as a professional on the ballroom competition circuit before joining

Strictly in 2004.

He has remained on the panel for 12 years and also judged on the US version on the show, *Dancing With The Stars*.

Len's 'Lexit' is the latest blow for the dancing show following the departure of beloved host Bruce Forsyth.

The veteran entertainer had been with *Strictly* since the beginning, but stepped down from his role as host of the live shows in April, 2014.

Wales rise above England in latest FIFA rankings

Wales have moved above England and up to 11th in the Fifa world rankings after their run to the semi-finals of Euro 2016.

Chris Coleman's men have jumped 15 places and are two above managerless England, who dropped two spots after losing to Iceland in the last 16.

Northern Ireland fell two spots to 28th despite an impressive Euros campaign, while Scotland fell to 50th after failing to qualify.

Republic of Ireland moved up to 31st.

Martin O'Neill's side beat Italy during the tournament before losing to France in the last 16.

Wales' campaign was their best performance at a major international tournament, although they actually reached a higher position in the rankings - eighth - in October 2015, as they edged closer to Euro 2016 qualification.

Fellow Euro 2016 surprise package Iceland

rose to their highest ranking after reaching the quarter-finals of Euro 2016, moving up 12 places to 22nd.

The top five teams remained the same, with Argentina ranked first ahead of Belgium, Colombia, Germany and Chile.

Euro 2016 winners Portugal and defeated finalists France moved up two and 10 places respectively to sit sixth and seventh, with Spain, Brazil and Italy rounding off the top 10.

Gunners face £80m fee for Higuain

Arsenal must pay Napoli 94m euros (£80m) to sign Argentina striker Gonzalo Higuain, according to a source close to the Italian club.

Reports on Tuesday suggested the 28-year-old's representatives are set for talks with the English side.

"There are no direct offers," the source told a British reporter.

"Only by meeting the release clause of 94,376,000 euros will

the player leave Napoli. Otherwise Higuain will stay for the remaining two years of his deal."

Gareth Bale's £85m move from Tottenham to Real Madrid in 2013 is the most expensive transfer in football history, surpassing the £80m Real paid Manchester United for Cristiano Ronaldo in 2009.

Team GB set record medal target

Team GB have been set a target of making Rio 2016 their most successful overseas Olympics by winning 48 medals.

UK Sport has invested £350m of public money into elite sport since London 2012 and wants between 47 and 79 medals when the Games begin on 5 August.

GB finished with 65 medals at London 2012, surpassing its previous best of 47 at the 2008 Beijing Olympics.

UK Sport wants at least 121 Paralympic medals to beat the London 2012 total, setting the target range as 113-165.

Paralympics GB won 120 medals (34 gold, 43 silver and 43 bronze).

Liz Nichol, UK Sport chief, said there is an "aspirational goal" to surpass both Olympic and Paralympic medal tallies from London 2012, but that it would be "incredibly challenging".

Director of performance Simon Timson previously said that if the "stars align and things go perfectly", 79 medals is the maximum GB could win.

In their home Games four years ago, GB finished third in the medals table behind USA and China with 29 gold,

17 silver and 19 bronze.

Sport statistics company Infostrada are forecasting GB will finish fourth in the Rio 2016 medal table with 51 - 18 gold, 16 silver and 17 bronze.

No host country has ever improved on its medal tally at the next summer Games.

Tim Hollingsworth, British Paralympic Association chief, said it was sending its "most competitive team ever to the most competitive Paralympic Games ever".

He described the medal target as an "ambitious one".

Celtic suffer shock loss to Gib minnows

Celtic suffered arguably the worst defeat in their history when they were humbled by Gibraltarian part-timers Lincoln Red Imps in the Champions League second qualifying round on Tuesday.

Lee Casciaro's second-half goal did the damage, the Ministry of Defence police officer outfoxing Efe Ambrose to score.

Leigh Griffiths twice hit the bar, but Celtic could not salvage anything from Brendan Rodgers' first game in charge.

The second leg is at Celtic Park next Wednesday.

And while the Scottish champions remain favourites to progress to the third qualifying round, serious improvement will be

needed.

Chelsea have made a £27m offer for Leicester City's N'Golo Kanté and are refusing to sanction the sale of Nemanja Matic to Juventus before they know if their pursuit of the France international will be successful.

The Premier League champions are desperate to hold on to Kanté and have offered him a new improved contract but the player is open to a move to join up with Antonio Conte at Stamford Bridge.

Kanté signed a four-year deal at Leicester when joining from Caen for £5.6m last summer. The new deal would extend that deal by a year and significantly improve his salary.

Chelsea's offer of £27m plus £3m in add-ons is likely to be rejected by Leicester. It then remains to be seen how much they are prepared to raise their bid by and how hard the player pushes for a move.

Matic's future, meanwhile, is up in the air until a decision is reached on Kanté. Juventus made an inquiry for the Serbia midfielder on Wednesday but were told that he is staying at the club until they have signed another central midfielder.

Conte has so far signed the Marseille forward Michy Batshuayi and wants to bring Roma's Radja Nainggolan and Real Madrid's Álvaro Morata to Stamford Bridge as well.

Big Sam set for England talks

Black Cats give go-ahead for FA speak to Allardyce

Sunderland have given the Football Association (FA) permission to speak to their manager Sam Allardyce about the position of England boss.

But the Premier League club say they want Allardyce to stay, insisting he is "very much key to our plans".

Sunderland claim speculation about Allardyce has been "extremely damaging" and have urged the FA to "bring about a swift resolution to the matter".

England are searching for a new boss after Roy Hodgson quit on 28 June.

He resigned after the national team were knocked out of Euro 2016 at the last-16 stage by Iceland.

Photographs that appeared to show Allardyce, 61, at the home of FA vice-chairman David Gill were published in the media in midweek.

Allardyce had been on tour with Sunderland in Austria until he returned home at the start of the week, reportedly on transfer business.

Sunderland said they agreed to let Allardyce speak with the FA as a "potential candidate" after he requested permission, but are upset discussions did not remain confidential.

"After what was an extremely challenging season, we are keen to see a period of stability, both on and off the field, and we want him to remain as manager of our football club," read a club statement issued on Wednesday.

Kevin Davies, who played under Allardyce at Bolton, thinks his former boss would be a good choice for England.

"Where we are now as a nation, I think he is probably the right man," said Davies, who earned one England cap during his career.

"Motivation-wise, he is fantastic, the best I have ever worked with. He knows how to get the best out of a player.

"He has a lot of other strengths, too. He surrounds himself with the best people in the best roles, which allows him to plan and get the best out of his squad."

Davies also thinks Allardyce will improve morale in the dressing room.

"The atmosphere he will create will be similar to Wales or Iceland... that spirit, that togetherness, along with the ability that we have lacked," said Davies.

"I think he has always thrived on being the underdog and I think England are going to go into a lot of games as underdogs in the future, so it probably will suit the way England are at the moment."

Allardyce is not the only Premier League manager linked with the England job.

Arsenal's Arsene Wenger, Bournemouth's Eddie Howe and Hull City's Steve Bruce have

all been touted as possible candidates.

United States boss Jurgen Klinsmann and former England manager Glenn Hoddle have also been linked with the job, but Allardyce is the frontrunner.

The former West Ham, Newcastle, Bolton and Blackburn boss, who has one year left on his Sunderland contract, won a lot of plaudits for keeping the Black Cats in the Premier League last season.

England begin their 2018 World Cup qualifying campaign on 4 September, when they face Slovakia in Trnava.

The England manager will be chosen by a three-man panel - Gill, FA technical director Dan Ashworth and chief executive Martin Glenn.

They want the next boss to be a strong-minded, tactically savvy manager who will build a clear team identity and help shape the team into a cohesive unit.

Allardyce was previously interviewed for the role in 2006 after Sven-Goran Eriksson left following that year's World Cup.

Eriksson's assistant Steve McClaren got the job instead but he failed to guide England to qualification for the 2008 European Championship.

The best is yet to come, vows Murray



ANDY MURRAY says he hopes he is yet to reach the best part of his career, after beating Milos Raonic on Sunday to win his second Wimbledon title.

The world number two has won two previous Grand Slam titles - the 2012 US Open and Wimbledon in 2013.

"I still feel like my best tennis is ahead of me, that I have an opportunity to win more," said the 29-year-old, who beat Raonic 6-4 7-6 (7-3) 7-6 (7-2).

"Everyone's time comes at different stages. Hopefully mine is to come."

Shortly after the win Murray decided to sit out this week's Davis Cup quarter-final against Serbia in Belgrade, a move supported by team captain Leon Smith.

"Quite rightly he has to look after his body and his mind. He's got his eyes set on getting some rest and really making a big push for the Olympics, US Open and beyond."
