'Creepy clowns' warned as terror craze sweeps UK

■ "Dressing up as a clown to scare people may seem a joke but it is no laughing matter."

WORRIED British police chiefs have issued warnings to pranksters in sinister clown outfits who terrify people in the street.

Hundreds of victims of the bizarre craze have reported white-faced figures – some armed with knives – leaping out on them.

One police force received 14 complaints in just 24 hours and another has dealt with a total of 18 frightened callers.

In one incident, a clown tried to get into a woman's car before chasing her. Shaneice Price, 22, of Bloxwich, West Midlands, said: "He followed me into a pub. He pointed and gestured that he would slit my throat, stared at me for five minutes and then left."

In another case, a woman in Whitwick, Leicestershire, gave birth prematurely after a 17-year-old clown leaped out on her.

Senior officers said many victims were at risk and warned the intimidating pranksters that they could face charges.

Chief Superintendent Andy Boyd, of Thames Valley Police, the force hit by 14 calls, said: "We do not want to stop people enjoying themselves.

"But we want them to think of the impact of their behaviour on others and themselves.

'deeply upsetting'

"Their actions can cause fear and anxiety. This could be perceived to be intimidating and threatening which could lead to public order offences, arrest and a criminal record."

Superintendent Mark Pannone, of Cumbria Police, said his force had nine reports of so-called "killer clowns" last Sunday.

"Dressing up as a clown to scare people may seem a joke but it is no laughing matter," he said.

"Fear of such incidents is deeply upsetting children in Cumbria and causing

a great deal of distress. It will not be tolerated."

The craze began in America and has swept Britain in recent weeks. Clowns have been seen in places including Hemel Hempstead, Hertfordshire, Chorley, Lancashire, Manchester

and Liverpool. In Norwich, a 30-year old man was arrested on suspicion of public order offences after allegedly dressing as a clown and jumping out on a woman in a park, screaming and chasing her.

In Chester-le-Street,

County Durham, a masked man carrying a knife left children aged 11 and 12 "upset and distressed".

Police in Gwent, South Wales, had 18 reports of clowns rampaging through gardens, peering through windows and

lurking in public places.

Chief Inspector Paul Staniforth said: "This has the potential to cause shock and panic.

"We're extremely concerned. It could result in somebody becoming seriously injured or unwell."

Scotland's debt is WORSE than Greece – and rest of UK funds cash black hole

SCOTLAND has the highest public spending deficit in the European Union, beating Greece to take top spot, it has been revealed

While the rest of the UK has faced years of belt-tightening, new research carried out by the TaxPayers' Alliance reveals that the Scottish deficit, at 9.5 per cent of gross domestic product (GDP), is twice that of the rest of the nation.

The Taxpayers' Alliance said Scotland's overspending is such a chronic problem that the issue needs tackling irrespective of the independence question, as the country ran up a fiscal deficit of £14.8bn in 2015-16.

And the pressure group said an independent Scotland would have to carry out drastic measures to balance its books including cutting all spending on police, transport, and agriculture, increase basic rate income tax to 39 per cent and double VAT to 40 per cent.

In addition, health spending would also have to be cut by 82 per cent.

Scotland offers its students free university places, free personal care for needy over 65s and free prescriptions.

By contrast, students in England have to pay tuition fees, elderly care

is means-tested and prescriptions cost £8.40.

John O'Connell, chief executive of the TaxPayers' Alliance, said, "The Scottish government has been relying on an unsustainable situation, depending on English subsidies to plug an ever-increasing deficit.

"It is crucial that spending is reined in so that taxpayers across the country - current and future - aren't saddled with high tax bills and crippling debts."

'huge deficit'

The group said Scotland's public spending remains far in excess of England's with spending per head being 20 per cent higher, heavily subsidised by taxpayers elsewhere.

The report also highlighted that Scotland has run a deficit every year since devolution in 1999 despite sometimes record oil prices.

Mr O'Connell added: "Scottish taxpayers face a huge deficit that must be tackled.

"Politicians in Holyrood must do the responsible thing and commit to getting the public finances under control."

To become an EU member, an independent Scotland would be forced to tackle its deficit as any deficit over 3 per cent of GDP is deemed excessive

by the EU.

Now the SNP has been urged to tackle its "decade-long failure of Scotland's economy" with opponents rounding on Scotland's First Minister Nicola Sturgeon ahead of this week's SNP conference after it emerged that the country's gross domestic product grew by just 0.4 per cent between April and June - compared to 0.7 per cent recorded UK-wide.

Scottish Government figures published on Wednesday showed that the 0.4 per cent increase in Scotland's onshore economy - not including North Sea oil and gas extraction - was driven by the dominant services sector, which accounts for three quarters of the country's economy.

It expanded by 0.5 per cent quarter on quarter, while production improved by 0.3 per cent.

However, a contraction in the construction sector deepened with output falling 1.9 per cent in the second quarter, following a 1.5 per cent slump in the first three months of the year.

Scottish Conservative economy spokesman Dean Lockhart welcomed the growth but added: "We have to recognise that economic growth of 0.4 per cent simply isn't good enough when you compare that to the rest

Abbott rises in Labour reshuffle

Jeremy Corbyn promoted his long-time ally Diane Abbott to shadow home secretary last week.

Abbott, who was once romantically involved with Corbyn, replaced Andy Burnham, who had resigned in order to concentrate on his bid to become the mayor of Manchester. The reshuffle also saw Baroness Chakrabarti, the former director of civil rights group Liberty, appointed shadow attorney general. Corbyn found places for several MPs who in the summer had quit his front bench in protest at his leadership, including Keir Starmer, who was made shadow Brexit secretary. Corbyn's allies described it as a "unifying" reshuffle. However, many MPs were angered by the

firing of Dame Rosie Winterton as chief whip after her criticism of Corbyn during his recent re-election campaign

New threats to trolls

Internet trolls who whip up hate mobs online could face criminal charges under new Crown Prosecution Service guidelines. The guidelines state that it can be a crime to encourage others to repeat "grossly offensive" messages, and to share private information so that individuals can be targeted - a practice known as "doxxing". It can also be a crime to try to humiliate people by posting doctored images of them online.

Poll watch

When asked to name the single-most important

issue facing Britain today, 23% of voters cite Europe, putting it top of the list, ahead of immigration (20%) and the NHS (10%).

(Ipsos Mori/The Guardian) In an election tomorrow, 43% of adults would vote Tory, up two points since last month, and 26% Labour, down two points. 11% would vote for UKIP, 8% Lib Dem, and 6% Green. If repeated at the next election, the Tory lead would give the party a majority of 125 in the House of Commons. (ICM/The Times).

Rod Temperton: from Cleethorpes to Thriller

■ Reclusive songwriter from Cleethorpes,, who died last week, made an unlikely leap from fish factory worker to penning countless Top 10 hits - including the best-selling single in history

When Michael Jackson died in 2009, a mirror at his home was found covered in Post-it notes bearing uplifting messages. Among them was one that simply said, "Call Temperton."

There followed a rush among journalists to track down the author of some of Jackson's biggest-selling songs, including the international smash hit *Thriller*. Yet he wasn't easy to find, said *The Times* this week. Rod Temperton, who has died of cancer aged 66, was a reclusive type who told his publishers not to reveal his personal information. The

one time he made an exception was when he agreed to be interviewed for a radio documentary in 2006. Suitably enough, it aired under the title *The Invisible*

Man. Afterwards, he retreated into obscurity, safe in the knowledge that few people "really knew the enigmatic Rod Temperton – even though the whole world knew

his songs".

Temperton traced his love of music back to his childhood growing up in the seaside town of Cleethorpes in Lincolnshire. His father, who ran a garage, used to place the radio by the young Rodney's pillow, and he would fall asleep listening to Radio Luxembourg. Encouraged by his music teacher at school, he learnt to play the drums and keyboard. There followed a stint working in a fish factory, until, in 1974, he answered an advertisement in the music magazine *Melody Maker* and joined a touring American band named Heatwave as keyboard player.

Temperton provided them with their biggest hit, *Boogie Nights*, just one of a string of his compositions to enter the Top 40. After quitting the band, he penned songs for the likes of Donna Summer, Aretha Franklin and Chaka Khan.

Oscar nomination

Yet it's the songs he wrote for Jackson that he'll be remembered for, said *The Daily Telegraph*. Recruited by the producer Quincy Jones, he penned *Off the Wall* and *Rock with You* for the "King of Pop" – along with the exuberant *Thriller*, which, with the help of a 14-minute video by John Landis, became the

biggest-selling single ever recorded by an African-American artist.

Other notable achievements in his career included an Oscar nomination for his music for the film *The Color Purple* in 1985. The secret to songwriting, he said once, was to please yourself first. It's only when you "feel the hairs stand up on the back of your hand" that you're ready to go public. Yet as time went by, Temperton made so much money from royalties that he put his feet up, said *The Times*. He divided his latter years between homes in Kent, France, Los Angeles and Fiji, which he shared with his wife, Kathy.

Justin time for a kickabout!

He's one of the world's biggest megastars with millions of pounds to his name and a jetset lifestyle to boot.

But Justin Bieber didn't appear to let fame go to his head this week when he casually dropped into a north London school for a kickabout.

The 22-year-old Canadian pop sensation, who is worth an estimated £165million, turned up at Highgate School and played football with some pupils.

Dressed low-key in a pair of grey skinny jeans, a waterproof coat and orange trainers, the world-famous singer joined in for a quick PE session.

His appearance sent

many fans at the school into overdrive, with many shocked to see the four-times number one artist at the £20,000-a-year school.

Rachel Kiki wrote: 'I'm screaming JUSTIN BIEBER just turned up + played football with all my mates. Why is he here and why did he want to play with us.'

Another pupil shared a short video clip of the megastar taking, and scoring, a penalty.

He smashed it into the top of the net as one pupil ran towards the camera in delight.

Bieber is currently in the capital for a three-night stint at the O2 Arena as part of his UK 'Purpose' tour.

The best-selling male Canadian artist, who has more than 100million sales to his name, flew into Luton Airport on a private jet on Monday afternoon.

Tesco and Unilever make peace after brief skirmish over Marmite

TALK ABOUT a tempest in a Marmite Pot.

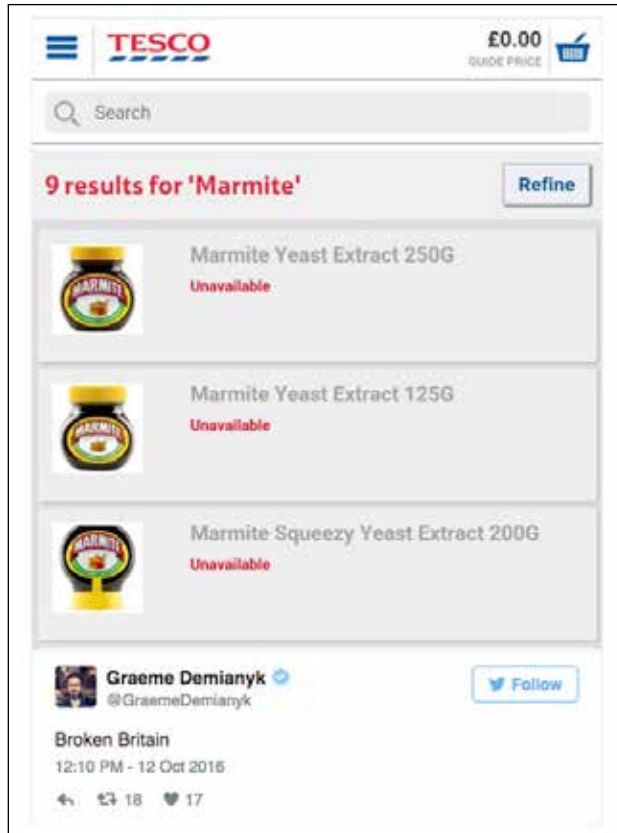
Fans of the love-it-or-hate-it spread across the world breathed a sigh of relief this week as Tesco and Unilever finally made a deal to end a business dispute which had seen the yeast extract removed the supermarket's online shopping portal.

Tesco had stopped selling major household brands including as Marmite, Flora and Persil detergent to its online customers following a row with Unilever, one of its main suppliers.

Tesco confirmed Wednesday night it had reached a 'satisfactory' agreement with the £2bn Anglo-Dutch consumer goods manufacturer following an extraordinary stand-off.

Supplies of top brands including Marmite, Flora, Persil and PG Tips had been halted to the supermarket chain after Tesco refused to agree to a 10 per cent price rise.

MPs blamed Pro-EU

Unilever for using Brexit as an excuse to hike up prices and momentum quickly grew behind a shoppers' campaign to boycott Marmite.

Sir Gerald Howarth said it was 'outrageous' that the firm would 'exploit' customers in

that way while Peter Bone added: 'It is Unilever trying to make more money.'

However, Unilever and Tesco managed to reach an agreement with the manufacturer issuing a statement confirming shelves would soon be

restocked with the 200 top brands it had halted delivery on. It would not confirm whether it had backed down over the price hike but it is thought Tesco came out of the row on top.

panicked shoppers

In a statement, Unilever said: 'Unilever is pleased to confirm that the supply situation with Tesco in the UK and Ireland has now been successfully resolved. We have been working together closely to reach this resolution and ensure our much-loved brands are once again fully available.'

'For all those that missed us, thanks for the love.'

Hinting that it had not been forced to adhere to the 10 per cent price rise, Tesco added: 'We always put our customers first and are pleased it has been resolved to our satisfaction.' A spokesman said products would be re-stocked 'soon'.

Marmite was still in stock in some Tesco branches but the remaining jars were being snapped up by panicked shoppers fearful of a shortage.

Critics had accused Unilever of using Britain's decision to leave the European Union as an 'excuse to raise prices'.

Sir Gerald said: 'I think it's pretty outrageous that Unilever is seeking to exploit their customers using a fall in the value of the pound.'

Meanwhile, Tory MP Peter Bone told *MailOnline*: 'It is absurd. Marmite is made in this country from ingredients made in this country.'

'To hike like this seems to be price gouging by

Unilever. Well done to Tesco for saying, 'on your bike'.

'I think we are going to see a lot of this kind of thing, trying to blame price rises on Brexit.'

'If it is made in this country how does the Pound have anything to do with it?

'It is Unilever trying to make more money.'

'Tesco have done what is right and if Unilever cannot sell their products then what are they going to do?'

Conservative MP Jacob Rees-Mogg added: 'Unilever has half a point, some of its costs may have gone up, but I think 10 per cent is profiteering.'

'They are basically using a story people know about to maximise their profit.'

'You would have thought that their customers will be unhappy that they are making the most of the fall in the Pound rather than just maintaining their margins.'

'Tesco as so often is doing a fantastic job standing up for its customers. Well done Tesco.'

Morecambe and Wise: New statue unveiled on 75th anniversary of first performance

FOR two decades the widows of legendary comedy duo Morecambe and Wise have waited patiently for this moment.

Now at last the first statue of the pair together will be unveiled in Blackpool on Friday. During their 43-year partnership Eric and Ernie performed more than 1,000 times in Blackpool, which has been dubbed their spiritual home.

So it is a fitting tribute that the foyer of the Winter Gardens will house the huge bronze sculpture. Costing £75,000 and funded by donations, it was commissioned to celebrate the 75th anniversary of the pair's first appearance on stage together in Nottingham in 1941.

Although individual statues exist in their home towns of Morecambe in Lancashire and Morley in Leeds, this is the first to celebrate them as a double act. Morecambe's widow Joan said the unveiling is a day she and Doreen, Wise's widow, "never expected to happen".

cracking jokes

"We never dreamt of seeing a statue unveiled to both Eric and Ernie in Blackpool, a town that we have so many happy memories of, from all the many shows the boys performed there over the years," she said.

"It will be a day that will live with us for ever."

Eric Bartholomew and Ernest Wiseman, as they were then, first met as teenagers in 1939 at a talent contest in Blackpool, which Morecambe won. By chance, two years later they were each booked separately to appear at the Nottingham Empire, supporting top of the bill singer Adelaide Hall.

After days of listening to them cracking jokes in rehearsals, Eric's mother Sadie suggested

they would be better as a double act. There was just one problem: nobody rated Bartholomew and Wise as a name for them.

Years later Eric recalled the moment: "My mother was talking to Adelaide Hall and explaining to her how nobody liked the name Bartholomew and Wise. Adelaide's husband Bert Hicks overheard and said that he had a friend who called himself Rochester because he came from Rochester in Minnesota."

"He asked my mother where she came from and she said, 'Morecambe', to which he replied, 'That's a good name. Call him Morecambe.'"

As Morecambe and Wise they became stars of theatres across the country, but their TV debut in 1954, a show called *Running Wild*, was an unmitigated disaster. Universally panned by critics, one particularly scathing review read: "Definition of the week, TV set – the box in which

they buried Morecambe and Wise."

Eric carried the review with him until his final days, long after the pair had subsequently become television sensations, with their various shows attracting audiences of more than 20 million at a time.

"Eric would transfer the review from jacket to jacket. He kept it in his breast pocket," Joan revealed in an interview in 2012.

Christmas specials

"They never knew how long their success was going to last."

So popular was the long-running *Morecambe And Wise Show*, which first aired on BBC Two in 1968, that the pair boasted guest stars including Shirley Bassey, Sir Elton John, and André Previn.

Their Christmas specials became as much a part of British festivities as turkey and crackers, with up to 28 million

viewers tuning in.

Still, the pair paid a heavy price for their stratospheric success. In 1968, aged 42, Eric had a heart attack but defied doctors' orders to take a year off work.

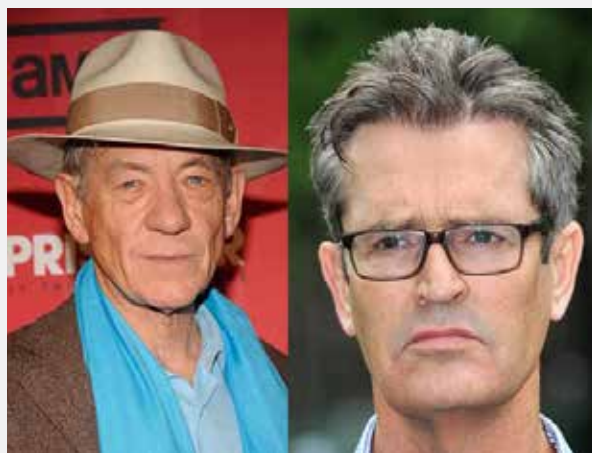
"They had to learn

new stuff every week because they were so popular and they were in constant demand," Joan said.

"They even went across the Atlantic to do the Ed Sullivan show. It was overwhelming and

that was why Eric had his first heart attack."

He had a second heart attack in 1979 followed by a third fatal one in 1984. After Eric's death Ernie moved to Florida and he too died of heart failure in 1999.

"I don't think it's helpful to others, especially younger people, that someone of his standing should propagate that point of view, which doesn't really hold water."



Liam Gallagher: The last real rock star?

Liam Gallagher despairs of modern pop stars. Back in his heyday as Oasis frontman, Gallagher did the whole rock'n'roll shtick: getting high, boasting endlessly, punching photographers, starting pointless feuds with other bands. Today's big stars, by contrast, will hardly even give a quote to the press. "Sad, isn't it? Nobody's got anything to say any more," he told Jonathan Dean in *The Sunday Times*. "They're all scaredy-cats." A great band requires more than just music, he says. "If it's all about music, then it's Coldplay. The most rock'n'roll thing Chris Martin did was wear a leather jacket. I thought, 'Go on, lad. That's a start.' There's no excuse for young bands to act like grown men," he adds sadly. "I get up to more mischief in my butcher's than they do on their f***ing tours. Maybe it's just where we're from. I guess it goes back to the working-class thing. A lot of music these days is by middle-class kids. The s***-kickers aren't breaking through."

Local News

The Continental Shop: iconic British store in Los Angeles provided a taste of home for stars and regular expats alike

Last week's news - broken exclusively by the British Weekly - that the Continental Shop in Santa Monica was to close its doors for good prompted a flurry of calls and emails from local Brits dismayed that an icon of the expatriate community was coming to an end. In response we are publishing a more complete history of the shop, courtesy of owner Michael Clewer:

"The shop was founded in the 1930s by a Hungarian émigré named Mr. Farenc, but after the war he seems to have disappeared and his wife took over, adding British and European goods to the shop's offerings. By the time Brian Clewer arrived in Los Angeles and started up his long-running radio show, *Cynic's Choice*, Mrs. Farenc had been joined in the business by her sister. After a few years of advertising on Brian's radio show *Cynic's Choice*, the two sisters decided to retire and offered the shop to Brian Clewer who bought it in 1967.

Laker Airways

The shop had been located in various storefronts on Vermont Avenue and Wilshire Boulevard. Brian first had the shop during his tenure across from the Ambassador Hotel, but in 1970 a large retail space became available below the famous Coconut Grove and that started an almost 20-year incarnation as one of the famous shops in the Ambassador. Also at this stage, Brian started up the travel side of the business becoming the largest retailer of Laker Airways tickets in the United States. It also helped that Laker had a tiny ticketing office just next door to the shop hidden by the Doorman's office at the

Porte Cochere.

"When the Ambassador announced its closure in 1989 Brian and his wife Suzanne started searching for space in Santa Monica where the British community had long congregated, and the shop relocated to 407 Santa Monica Blvd for 2 1/2 years until that building was condemned to be replaced by a multi-storey office/retail building...something that never happened. After that location the shop moved to the current store on Wilshire, where it has remained for the last 26 years.

Celebrities

"There have been many celebrities who have made their way to the Continental Shop. Anna Russel, famous for her 30-minute telling of Wagner's Ring Cycle, came in many times to sign albums and visit Brian who played her tracks from her albums on his radio show. One time she had a signing on a rather hot day and instead of sitting in a chair at the desk provided, she took a seat in the open freezer/cooler that was in the shop, happily signing and greeting people while keeping very cool. Another time Gracie Fields and her husband Boris Alperovici were in town, staying at the Beverly Wilshire Hotel. Not thinking anything of the miles from Beverly Hills to the Ambassador Hotel they walked to the shop and delighted customers that day with some of her many famous songs. After their time at the hotel, they refused the offer of a cab and walked back to Beverly Hills. Angela Lansbury started shopping here in the 1980s as well, making her trek from the Westside to the Ambassador and becoming a dear friend

to the family and staff of the shop.

"Once in Santa Monica more celebrities could be spotted crossing the threshold including actors such as Roddy McDowell, Stewart Granger, Faye Dunaway, Lynn Redgrave, Sir Anthony Hopkins, Patrick Stewart, Juliet Mills and husband Maxwell Caulfield, Judge Reinhold, John Mahoney, Jane Leeves, Kelsey Grammer, Jamie Leigh Curtis, Lyndsay Wagner and Jane Krakowski. Other regulars included film directors Val Guest, Mick Jackson, Jack Cardiff, John Frankenheimer and Ken Annakin, while musicians who visited included Morrissey, Matt Goss, Ozzie Osbourne, and David Bowie and his supermodel wife Iman. When answering the telephone at the shop it was sometimes surprising who could be on the other end of the line, many times it was Naomi Campbell ordering a few chocolates and tea, actor Werner Klemperer ordering a Royal Shakespeare video of a play he was going to be in, Eddie Rabbit ordering some videos or Elizabeth Taylor and her staff ordering some tea and biscuits.

Moving into travel

"In addition to the above, some of the most beautiful women that ever were seen in British cinema made the Continental Shop their local stop for groceries from home. In addition to Angela Lansbury were Jean Simmons, Maureen O'Hara, Hazel Court and Sarah Douglas. Angela, Jean, Hazel and Sarah came in frequently and have been great and dear friends. I remember one morning coming into the office and hearing a woman singing in

the shop, it was Jean Simmons doing her song and dance routine from *The Way to the Stars* for Brian Clewer. Brian and Jean had both started at Rank Studios at about the same time, Jean in front of the camera and Brian in the advertising department. On one of Brian's first days at Rank he arrived at the same time as Jean and held the door open for her, they both would joke that Brian was still doing it 60 years later. Of special note is the lengthy friendship with the Dotrice family also, Roy and Kay would come in frequently when they lived here, along with their daughters Karen, Michelle and Yvette, along with Karen's children who we've watched grow up and move on to university.

"In the late 1960's Brian was working for Cardillo Travel and brought his travel expertise to the Continental Shop, opening Ambassador International Travel, later named Continental Travel Shop. He led many tours to the Middle East, including one tour with Ann Miller, who would always be 30 minutes late so that she would make an entrance with the other assembled tourists waiting on her. In the 1970's Brian also was leading tours to Rio, once with 150 clients for a hotel opening. After the collapse of Laker Airways, there was a huge void in the market for lower cost airline tickets so of course Brian was right in the fray, chartering planes from major and minor carriers to get to London. We still

have many customers who have been buying their plane tickets since they first arrived in Los Angeles 30 and 40 years ago."

Michael told the BW that he plans to continue the air ticket side of the business with his contacts in the business after the closure of the shop. He also added that the thing they will miss more than anything are all the wonderful customers who have come in over the years, some only once a year, but they are all going to be missed.

"They are some of the nicest people in the world, always a friendly smile and a big hello for the staff," said Michael. "Over the years they have become family, especially after the loss of Brian and Suzanne."



Kirkin' O' the Tartans set for Sunday

SUNDAY, October 16th sees the annual 'Kirkin' O' The Tartans ceremony at Beverly Hills Presbyterian Church, 505 N. Rodeo Drive in Beverly Hills.

The address will be given by Dr. Lloyd Ogilvie, chaplain to the US Senate from 1995-2003. The ceremony begins at 11am.

While the service celebrates Scotland and Scottish heritage, it is a truly a Scottish-American custom. If one searches the Internet for information, stories abound of the Kirkin's roots being in days of the Act of Proscription enacted following the battle of Culloden, when the wearing of the kilt was banned in the Highlands - according to the legend, Highlanders hid pieces of tartan and brought them to church to be secretly blessed at a particular point in the service.

The Rev. Peter

Marshall, originally from Coatbridge, Scotland, was the pastor of the New York Avenue Presbyterian Church in Washington DC, and served as Chaplain of the United States Senate before his untimely death in 1949. Rev. Marshall is believed to be the originator of the Kirkin' o' the Tartan service on this side of the pond. During the Second World War Marshall held prayer services at New York Avenue to raise funds for British war relief. At one of the services on April 27, 1941 Rev. Marshall gave a sermon entitled "the Kirkin' o' the Tartans" -and thus a legend was born.

All are welcome at the church continues the tradition, and there will be an informal lunch following the service at the Robin Hood Pub, 13640 Burbank Boulevard (at Woodman) in Van Nuys following the event.

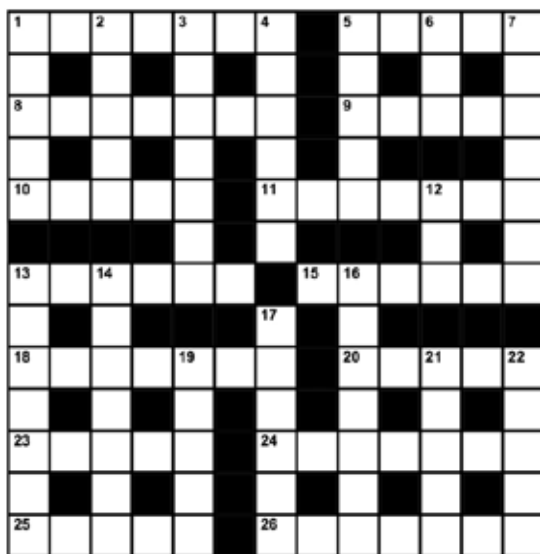
Are you working on anything at the moment?

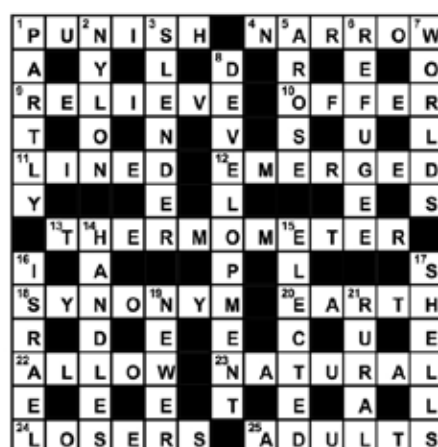

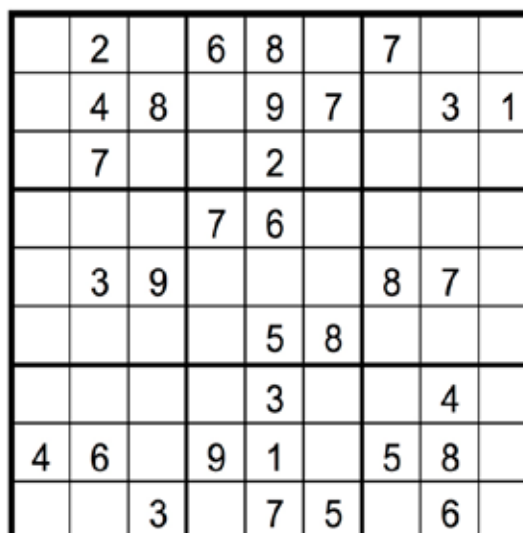

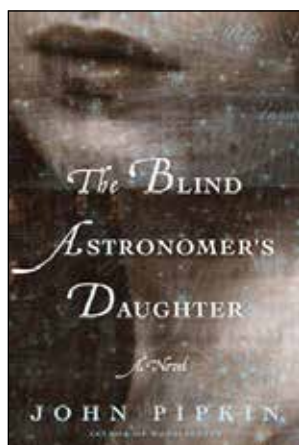

The Blind Astronomer's Daughter: reaching for the stars

Exclusive interview
with author John
Pipkin about his
new novel featuring
a girl who takes
over where her
father left off to
advance astronomy

"I first began thinking

about the central ideas of this novel during a trip to Ireland several years ago," says *The Blind Astronomer's Daughter* author John Pipkin. "I was in graduate school, researching the poets of the late-eighteenth and early-nineteenth centuries in the collections at the National Library of Ireland in Dublin. During a visit to the ruins of the poet Mary Tighe's house in Inistioge, Kilkenny, I began thinking about the concurrence of historical events like the Irish Rebellion of 1798,



the Romantic Period, and the dawn of modern science and astronomy."

The *Blind Astronomer's Daughter* is Caroline, adopted as a baby after astronomer Arthur Ainsworth and his wife lose their twin baby girls. As Caroline grows up she helps her father with his obsession, living a sheltered life aiding her father and peering through her own telescope at the sky and the world around her. Family tragedy soon follows when the tortured Arthur kills himself,

and Caroline must leave Ireland for London, also abandoning Finnegan O'Siodha, the local blacksmith with whom she has fallen in love. She later discovers her father's legacy for her: not just the wreck of an unfinished telescope, but a cryptic atlas which holds the secret to finding new worlds. She must navigate her way not just through scientific inquiry and unfulfilled love, but deal with the political currents of Ireland in rebellion.

This is an inspiring story of a woman who advances astronomy behind the scenes by making the mirrors used in telescopes. And adding to the intriguing framework the author has given Caroline a physical disability. The story jumps around quite a bit, across time frame and location. It could have been more engaging if it

was just about the heroine Caroline and her impressions of all around her.

"I've been living with these characters and their stories for quite awhile," says Pipkin. "The novel involves multiple interwoven plot lines that developed over time. Some of the characters did not begin to find their way into the story until the third or fourth draft. This is my second novel, but the ideas for the story actually preceded my first book."

Pipkin did his book research at the National Library of Ireland in Dublin, at the British Library in London, and at the Harry Ransom Center at the University of Texas at Austin. "The Herschel Family Papers at the Harry Ransom Center provided a wealth of information and inspiration about the brother-sister astronomers

William and Caroline Herschel, including the handwritten journals of Caroline, and a collection of little note cards looped with string, which appear in the novel."

Pipkin's first novel, *Woodsburner*, is an historical novel inspired by the forest fire accidentally started by Henry David Thoreau in 1844 in the woods of Concord, Massachusetts. The book won the NYC Center for Fiction's First Novel Prize, The Texas Institute of Letters Steven Turner First Novel Prize, and the Massachusetts Center for the Book Novel Prize. It was named One of the Best Books of 2009 by the San Francisco Chronicle, the Washington Post, and the Christian Science Monitor.

Pipkin teaches creative writing and literature at Southwestern University and is currently working on a novel about the

They are all over town or visit TraderJoes.com to find the nearest one for you.

Ralphs, Albertson's, Vons and Pavilions got lots of votes too, and but you must make sure to sign up for their loyalty cards as this will save you at least 20%, if not more. I have the Vons app on my phone which offers extra discount coupons and also the occasional free item, plus Ralphs and Vons give you discounts on petrol at Shell and Chevron. People suggest avoiding Whole Foods aka 'Whole Paycheck' but again if you download their app they also offer discounts, this week's coupon offers \$5 off fruit and veg! Sprouts was a runner up, and get a

special mention for their bread which is less sweet and more similar to British bread apparently, but they are not everywhere so you might need to make a special trip. A few people recommended the recently opened Aldi (there is one in Inglewood) who coincidentally own Trader Joes. Special mentions for Vallarta, Ranch 99 and Farm Boy - none of which I have heard of but am definitely going to check out as they were spoken so highly of. Another great saving tip we have for you is 20% off tickets for the pantomime at Pasadena Playhouse - it is produced by Lythgoe Family Productions, so you know it will be authentic! Heavyweight champ Fury has license revoked

Tyson Fury has had his license to fight temporarily revoked the day after he gave up his world heavyweight titles to focus on mental health problems.

Fury, 28, has not fought since beating Wladimir Klitschko in November 2015 and has twice withdrawn from rematches.

The British Boxing Board of Control confirmed his license was suspended "pending further investigation into anti-doping and medical issues".

Fury was charged with a doping offence by the UK's anti-doping body in June.

On Wednesday, Fury vacated his WBO and WBA world heavyweight titles, saying he was unable to defend them because of his health.

He will now have to meet with the BBBofC before a decision is taken

on whether he can fight again.

He has an appeal hearing for his doping offence scheduled for November.

Earlier this month, Fury appeared to announce his retirement on Twitter, before backtracking several hours later.

He later revealed in an interview with Rolling Stone magazine that he was taking cocaine to help deal with depression.

Fury's uncle and trainer, Peter Fury, believes the former champion still has a future in the sport.

He told BBC Radio 5 live: "Once he produces all of his records of what he's been through, then I don't think the boxing board will have any option but to give him his license back.

"This is a guy that's needed medical treatment. Once the

powers that be say he's fit to box, then there's no reason why he can't be reinstated.

"He's at the pinnacle of his career. He's only 28. He's got a massive future."

Peter Fury also claimed that Fury would be "welcomed with open arms" by the boxing world once he does decide to return.

Meanwhile, promoter Eddie Hearn has said a deal is "very close" for British heavyweight champion Anthony Joshua to defend his IBF title against Klitschko, with the vacated WBA belt also on the line.

It is thought New Zealand's Joseph Parker and Mexico's Andy Ruiz Jr could now contest the WBO title.

Mick Hennessy, Fury's promoter, is confident that he will be back in the ring and says he remains "unbeatable" in the heavyweight division.

Hull make Phelan permanent boss - for now

Hull City have appointed caretaker manager Mike Phelan as their new head coach.

Phelan had been in temporary charge since Steve Bruce's departure in the summer, with the club currently 15th in the Premier League table.

A good start saw the 54-year-old named manager of the month for August.

In September, Phelan revealed he was offered the job on a full-time basis but there had since been no contact amid the club's search for a new owner.

"I'm very relieved," Phelan said on the club website. "It's been a while in coming."

Phelan added he was "looking forward" to the first full-time management role of his career, saying: "It's exciting to step over that threshold."

The newly-promoted Tigers surprised many by winning their first two games of the season despite a summer of turmoil and stretched playing resources.

Since then, however, they have gone five games in the league without a further win, picking up just one point. They have reached the fourth round of the EFL Cup, and travel to Bristol City next.

Hull, who have beaten champions Leicester and Swansea this season, visit Bournemouth on Saturday.

The club also confirmed on Thursday that Stephen Clemence had left the club to join Aston Villa as first-team coach under Bruce.

Gordon Strachan is to carry on as Scotland manager following a poor start to the World Cup qualifying campaign, BBC Scotland reported on Thursday.

The 59-year-old was considering his future

following Tuesday's 3-0 defeat in Slovakia.

But the former Celtic and Middlesbrough boss has decided to remain for the next game against England, at least.

Scotland visit Wembley on 11 November, trailing the group leaders by three points after three games.

Strachan signed a two-year deal in the summer after failing to lead the national side to Euro 2016.

He succeeded Craig Levein in January 2013 and has been in charge for 32 games, with a 47% win record.

In 19 competitive matches, Strachan has won eight but a run of only three victories - against Gibraltar, twice, and Malta - in the past nine has put his position under increased scrutiny.

'I inherited a mess' - Southgate

■ England manager upbeat despite toothless draw in Slovenia

England interim manager Gareth Southgate said he had inherited "a mess", after the midweek goalless draw in Slovenia in 2018 World Cup qualifying.

Southgate succeeded Sam Allardyce last month, initially for four games, and led England to a home win over Malta before Tuesday's draw in Ljubljana.

England, who top Group F, had keeper Joe Hart to thank for a point.

"With the overall objective of qualifying, we have kept the team on track," said Southgate.

The draw means England remain top of the group with seven points, two more than Lithuania and Slovenia.

Southgate, 46, stepped up from his role as England Under-21 boss to take temporary control of the senior team following Allardyce's departure.

His next game is a World Cup qualifier against Scotland at Wembley on 11 November, followed four days later by a friendly with Spain, as the Football Association searches for a permanent successor.

Allardyce, 61, left his post after one game following a Daily Telegraph investigation claiming he offered advice on how to "get around" rules on player transfers.

That followed England's disastrous Euro 2016 campaign, which saw Roy Hodgson resign after an embarrassing last-16 defeat by minnows Iceland.

Slovenia, ranked 67th in the world, had the best chances in the game, while England failed to register a shot on target in the first half and managed just three overall - their lowest in a competitive game since v Costa Rica at the 2014 World Cup.

Southgate had dropped captain Wayne Rooney, but the Manchester United forward came on for the last 20 minutes.

And Southgate got an unlikely boost on Thursday when Arsene Wenger told reporters he was the right man to take the job on a long-term basis.

Wenger, whose club contract runs to the summer, has been linked with the job.

Bruce in at Villa

Aston Villa have named former Hull City and Birmingham City boss Steve Bruce as their new manager.

Former Manchester United captain Bruce, 55, who left Hull in July, succeeds Roberto di Matteo, who was sacked on 3 October, at Villa Park.

Bruce, who has lived in the Midlands since first joining Birmingham as a player in 1996, takes over with Villa 19th in the Championship table.

His first game in charge is at home to local rivals Wolves on Saturday.

Wenger said Southgate "has accumulated experiences and is a good observer of what's going on in the national team."

Of his own links to the role, the 66-year-old Frenchman added: "I focus on my job, that's what it is about."

Wenger continued: "We're in a job where you get questioned, especially if you have less experience, and the only answer he can give is by showing the decisions he makes are right."

"There's always a demand for big names but the most important thing is the person's competency. He has a good opportunity and I'm happy he has a chance to show he has the quality."

Speaking before his side's game against Swansea on Saturday, Wenger added that 21-year-old defender Hector Bellerin would be offered a new contract by the club.

The Arsenal right-back has been linked with a move, with both Barcelona and Manchester City said to be interested, but Wenger said he was "surprised" by the speculation surrounding the Spain international, who progressed through

Barcelona's La Masia academy before joining Arsenal in 2011.

"He has nearly three

years to go and we always try get the players to the level where we think they deserve to be. So we try

to extend, certainly, his contract," said Wenger.

"For me, his long-term future is here."
