FOOTBALL PROBE: HUNDREDS ABUSED?

THE SEXUAL ABUSE scandal that has rocked English football over the past week has prompted investigations by EIGHT separate police forces looking into allegations that now number in the hundreds.

At press time there have been 250 reports made to police and more than 50 calls were made to an NSPCC hotline set up for sexual abuse victims in football in the initial hours of opening on Monday.

More than 20 former players have spoken out about alleged abuse, including former Newcastle player Derek Bell, who waived his anonymity to the *Guardian*.

'heartache'

Bell told the newspaper in a story published on Tuesday that he was subjected to "horrendous" sexual abuse from youth team coach Barry Bennell at his local boys football club in the 1970s.

He said: "It was pure, unbelievable heartache. Thinking my mam and dad were next door and he was performing these sexual acts. He had groomed us for a couple of years and... he thought it was normal.

"Deep down in my mind I knew it wasn't normal, but I was so scared to speak and come out and say it wasn't right.

It was just, horrendous."

Former Crewe Alexandra coach Bennell has been charged with eight counts of child abuse, prosecutors said. Bennell, who has already served three jail terms for previous child sex offences, has faced a slew of new allegations by at least 20 former footballers spanning three decades beginning in the 1970s when he was working for Crewe Alexandra, Manchester City and Stoke City.

"Following a review of the evidence, in accordance with the Code for Crown Prosecutors, Mr Bennell, 62, has today been charged with eight offences of sexual assault against a boy under the age of 14," said a statement from the Crown Prosecution Service (CPS).

Bennell will appear in court on Dec 14.

The latest charges stem from Cheshire Police but six other police forces are investigating accusations made against him in a scandal Football Association (FA) chairman Greg Clarke has

called "the greatest crisis" in English football.

Former Northern Ireland international Mark Williams also spoke out on Tuesday, with Sky News revealing he had waived his anonymity and released a statement claiming he too was abused.

It read: "My life has been affected irreversibly both personally and professionally and it has been soul-destroying to carry this burden for 30 years.

"I have felt chained down by fear of speaking

out."

'biggest crisis'

Police Scotland is the latest force to confirm it is looking into allegations following claims of sexual abuse by former players, as the Football Association begins an internal review.

A Police Scotland spokesman said the force was "working with both Operation Hydrant and the NSPCC to ensure there is a co-ordinated UK police response".

In the House of Lords, Baroness Chisholm said: "Since this has come out,

Nuttall elected new UKIP leader

Farage's replacement vows to 'replace Labour'

Paul Nuttall has been elected leader of the UK Independence Party, replacing Nigel Farage.

The 39-year-old Member of the European Parliament, who served as UKIP's deputy leader for six years, won 62.6% of support among party members.

He promised to "put the great back into Britain" and force the government to "give us a real Brexit".

Mr Nuttall defeated former deputy chairwoman Suzanne Evans and ex-soldier John Rees-Evans.

It was UKIP's second

leadership election this year, previous winner Diane James having quit after 18 days in the role. Mr Farage acted as interim leader while the second leadership race took place.

In his acceptance speech, Mr Nuttall, a former history lecturer who played football for Tranmere Rovers as a boy, said: "The country needs a strong UKIP more than ever before. If UKIP is to be an electoral force, there will be an impetus on Theresa May and her government to give us a real Brexit."

He added: "I want

to replace the Labour Party and make UKIP the patriotic voice of working people."

Appearing on BBC Two's Daily Politics, Mr Nuttall said the party would be "speaking the language of ordinary working people... we're going to move into the areas the Labour Party has neglected", dismissing Labour leader Jeremy Corbyn and John McDonnell and Diane Abbott as part of "a North London Islington set".

He said: "We will be focusing on the issues

that really matter to working-class people on doorsteps - immigration, crime, defence, foreign aid, ensuring that British people are put to the top of the queue in the job market."

Ms Evans said Mr Nuttall had her "full

support", saying she was glad he won such a decisive victory because it gave him a "huge mandate" to unite the party.

Mr Nuttall, who was born in Bootle, Merseyside and was UKIP deputy leader from

2010 until September this year, attracted 9,622 votes.

Ms Evans came second with 2,973 votes (19.3%) and Mr Rees-Evans third with 2,775 votes (18.1%). There were 32,757 ballot papers sent out, with 15,405 votes cast.

its overarching probe, Culture Secretary Karen Bradley told MPs.

And ministers are writing to all national sporting bodies to ask them to "redouble their efforts" to protect children in the wake of the scandal.

'quick and timely'

FA chairman Greg Clarke has admitted he does not know if the abuse in football was covered up by the authorities, as he scrambles to respond to "the biggest crisis" he has ever seen face the game.

A spokesman for Cambridgeshire Police said the force had

received "multiple historical allegations from the NSPCC of abuse related to football in Cambridgeshire", adding that the inquiries were "received recently" and were being looked into.

The Metropolitan, Staffordshire, Greater Manchester, Hampshire, Cheshire and Northumbria police forces are all also investigating allegations of abuse.

Chelsea, meanwhile

have retained a law firm to carry out an investigation concerning an one of its 1970s employees, who is now dead.

A spokesman said the club would provide the FA with "any relevant information arising out of the club's investigation".

Darragh MacAnthony, Peterborough owner and chairman, said the Cambridgeshire club would assist the police, the FA, the Professional

Footballers' Association and football's other governing bodies in the child sex abuse investigation.

He said: "If anyone is found guilty of any offences, we hope they will be severely dealt with by those authorities in a quick and timely manner.

"We encourage anybody with any information relating to this matter to come forward so we can help

the authorities as best we can going forward and... will ensure our football club leads by example throughout this process with full transparency and honesty, top to bottom."

A Cambridge spokesman said the club has been contacted by Cambridgeshire Police about historical disclosures of child sexual abuse.

He said: "The correspondence indicated

that, as a result of the publicity, some referrals have been shared with Cambridgeshire Police. From what we have been told these date back to the 1990s and earlier.

"Cambridge United will treat any and every allegation of this nature with the utmost seriousness. The club is still awaiting further detail from Cambridgeshire Police and will co-operate fully in any investigation."

Bristow blasted for 'poof' tweet

Former world darts champ Eric Bristow has spoken up in relation to the football scandal, though not in the nicest of ways.

The 59-year-old has since apologized for a number of offensive tweets he sent, which

have also cost him his job as a regular contributor to darts coverage at Sky Sports.

He wrote on Twitter: "Might be a looney but if some football coach was touching me when I was a kid as I got older I would have went back

and sorted that poof out."

Another tweet read: "Dart players tough guys footballers wimps".

In a heated interview with Piers Morgan on ITV's *Good Morning Britain*, Bristow defended his tweets, saying he was trying to encourage

children to report abuse immediately.

"I want youngsters now to go out and complain straight away. There's no point complaining 30 years later," he said.

"It was worded wrong. I apologise, it was a miswording. They are not wimps," he explained.

Bristow was previously

a victim of dartsitis - a debilitating psychological condition that ruined his career when he could not release the dart for fear of missing.

The British media have suggested that he should be one who would understand psychological trauma instead of making such comments.

Trump is right on NATO spending - Johnson

Britain will support US President-elect Donald Trump's campaign to get Nato countries to spend more on defence, Boris Johnson has announced.

The Foreign Secretary said that cannot be justified that the US pays for 70% of Nato spending.

In a speech to the Royal Institute of International Affairs at Chatham House, Johnson said the UK must "redouble our resolve and to defend and preserve the best of the rules-based international order", before adding that UK's resolve to fulfil its Nato obligations is "unbreakable" in a world where democracy is "in retreat".

During his election campaign, Mr Trump was critical of Nato, describing the Western military alliance as obsolete.

He suggested that the US would think twice about coming to the aid of any Nato ally under attack if it had not paid its "fair share".

'More brutal system'

The UK, which meets the commitment to spend 2% of GDP on defence, has also been urging other countries to increase their contribution.

"If we fail, then we risk reverting to an older and more brutal system where the strong are free to devour the weak where might is always right and the rules and institutions we have so painstakingly built fade away into irrelevance. We cannot allow this to happen," said Mr. Johnson.

"We have to acknowledge that in many respects the world is not in good shape. We have the cult of the strong man, we have democracy in retreat, we have an arc of instability across the Middle East from Iraq to Syria to Libya. What is the answer of the UK, is it to cower and put the pillow over our heads? Emphatically not."

Zara Phillips is PREGNANT with second child: Queen and Mike Tindall 'delighted'

■ Latest royal baby is due in late spring and will be Queen's sixth great-grandchild

ZARA and Mike Tindall are expecting their second child, a spokeswoman for the couple has confirmed.

Zara, whose mother is the Queen's only daughter Princess Anne and father is Captain Mark Phillips, married Mike Tindall in 2011 and they had Mia in January 2014 at Gloucestershire Royal Hospital.

The new baby, who will be 18th in line to the throne, is due around late spring, and will be the Queen and Duke of Edinburgh's sixth great-grandchild.

Tindall once revealed that when Mia first met William and Kate's baby son George, the result was "carnage", with most of George's food going on the table rather than in his mouth.

Earlier this year, Mia was pictured holding

the Queen's famous black handbag when the monarch posed for an Annie Leibovitz photograph with her great-grandchildren to mark her 90th birthday.

The family live on the Princess Royal's Gatcombe Park country estate in Gloucestershire after meeting during England's Rugby World Cup-winning campaign in Australia in 2003.

back in the saddle

Buckingham Palace said the Queen and the Royal Family were delighted by Zara's pregnancy.

A spokesman said: "The Queen and the Duke of Edinburgh and members of the Royal Family are delighted with the news."

Zara has followed in the footsteps of both her parents with her love of

horses and won silver in the London 2012 Olympics during the team event, where their medals were presented by her mother.

Zara missed out on the Rio Olympics this year after she failed to make the British Equestrian Federation's nominated rider list. She last competed at the end of October, when the eventing season ended, but will not compete again until after her baby is born, as the season does not start again until March.

During her first pregnancy Mrs Tindall carried on riding until she was several months pregnant. A spokesman for Mrs Tindall said there were "no plans" for her retire from riding, meaning she is likely to be back in the saddle some time next year.

Harry joins in minute's silence for Castro while on Caribbean tour

Former Cuban dictator described as 'good friend' to island nation

PRINCE HARRY'S diplomatic duties this week included his unexpected participation in a minute's silence for Fidel Castro as the Prince joined dignitaries from St Vincent and the Grenadines.

The prince was attending a reception in St Vincent's capital hosted by the Caribbean country's governor general Sir Frederick Ballantyne who asked his guests to mark the death of the long-lived Cuban leader.

Among the guests was Prime Minister Dr Ralph Gonsalves, leader of the country's ruling Unity Labour Party, who described Castro as a good friend of his country.

The Communist ex-president died aged 90 sparking celebrations among relatives of anti-Castro activists in his homeland and in Miami.

Castro's death was announced by his brother after many years of poor health.

insurgency

The dictator led the Caribbean island for more than five decades and was the world's third longest serving head of state, behind only Queen Elizabeth II and the late Thai King.

Castro surged to power after he led an insurgency against US-backed dictator Fulgencio Batista in the 1950s, assuming power in a bloody revolution.

He had been in poor

health for many years, reportedly blighted by intestinal problems.

Prince Harry is on a visit the country as part of a 15-day tour of the Caribbean.

Fawlty Towers' 'Manuel' star Andrew Sachs dead at 86

Fawlty Towers star Andrew Sachs, who played hapless Spanish waiter Manuel in the BBC sitcom, has died aged 86, his family has confirmed.

The actor died on 23 November and was buried on Thursday, according to an interview with his wife Melody in the Daily Mail.

She told the newspaper that Sachs was diagnosed with dementia four years ago.

On his role of Manuel, Sachs said in 2014: "It was just a part I was playing and people seemed to laugh."

Manuel was one of the most imitated comedy characters of the 1970s. The waiter, who famously hailed from Barcelona, often said little more than the word "Que?" to generate laughs, but arguably his most famous line was "I know nothing".

The waiter was regularly shown being hit by John Cleese's hotel manager character, Basil Fawlty.

"I never got upset when he hit me," Sachs said in 2014.

"He's my friend, I must say yes, yes [it hurt], several times, more than once."

Cleese, 77, who was also the co-creator of Fawlty Towers, paid tribute to "a very sweet, gentle and kind man".

He wrote on Twitter: "Just heard about Andy Sachs. Very sad."

"A very sweet gentle and kind man and a truly great farceur. I first saw him in Habeas Corpus on stage in 1973.

"I could not have found a better Manuel. Inspired."

Sachs had dozens of other acting roles, both serious and comic, including stints in TV's two biggest soaps.

In 2009, he played the role of Ramsey Clegg, half-brother of Norris Cole, in ITV's Coronation Street and in 2015 he briefly joined the BBC's EastEnders as Cyril Bishop.

He inadvertently became the subject of headlines in 2008 when he received a series of lewd

answerphone messages from Russell Brand and fellow BBC Radio 2 presenter Jonathan Ross, relating to his granddaughter.

The so-called Sachsgate affair resulted in Brand and the controller of Radio 2 resigning. Ross was suspended from broadcasting for three months and a review was held into the way BBC output was vetted.

Andreas Siegfried Sachs was born in Berlin in 1930, the son of a Jewish insurance broker and a Catholic librarian.

The family fled Germany, where Nazism was on the rise, in 1938 and moved to London.

Blackadder actor Tony Robinson, a friend of Sachs, told BBC Radio 5 Live that Sachs was "very modest" and said that "it really came as a surprise to him that he had the success that he did".

"People know him for that one comedy performance but he was actually a magnificently talented man in a number of fields," Robinson said.

Police chief who bared her breasts at junior colleague keeps her job

A police chief who pulled down her top and exposed her breast to a junior colleague will be allowed to keep her job after she was described as a 'role model'.

Rebekah Sutcliffe, Assistant Chief Constable with Greater Manchester Police, was annoyed with the other female police officer because she'd had a boob job.

She berated Superintendent Sarah Jackson as a 'laughing stock' who would be judged professionally 'on the size of her tits'.

Claiming her 'credibility was zero' because of her breast augmentation, she then exposed her own breast.

"Look at these, look at these, these are the breasts of someone who has had three children. They are ugly but I don't feel the need to pump myself full of silicone to get self-esteem," she said.

But despite a disciplinary panel ruling she had behaved 'shockingly' and 'cruelly', they recommended she should not be sacked.

A panel found her gross misconduct had taken Ms Sutcliffe to 'the very precipice of dismissal'.

'mortified'

But they said she should receive a final written warning rather than getting the sack.

Ms Sutcliffe, 47, admitted misconduct in failing to treat Ms Jackson with respect or courtesy and that she abused her position and authority.

She also acknowledged that her actions discredited the police service.

However she had denied it amounted to gross misconduct.

The incident happened after a police dinner on May 6 at Manchester's Hilton Hotel.

Ms Jackson said she was 'shocked, mortified, embarrassed

and ashamed' at the comments made by her superior.

Announcing the panel's recommendation, panel chair Rachel Crasnow QC said: 'Assistant Chief Constable Sutcliffe allowed herself to drink too much and when drunk behaved shockingly, cruelly and hurtfully to Sarah Jackson and she stupidly exposed her breast.

'role model'

She said Ms Sutcliffe – who has served GMP for 23 years – had 'let herself down' and that 'her behaviour fell far below the conduct to be expected of any police officer and a role model of her rank'.

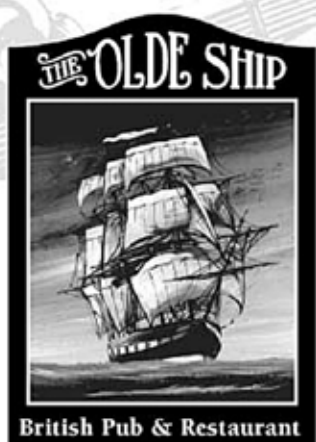
She added though that a chief officer with 'a slightly weaker record would not have been able to survive this'.

Earlier, Sutcliffe's counsel, John Beggs QC said the 'sheer quality and quantity' of the character references – more than 200 pages – before the panel 'entitle you to come to a decision which is not career-ending'.

He said many of the statements from senior and subordinate officers spoke of her as 'inspirational', 'visionary' and 'a strong leader'.

A further hearing in public is expected in the New Year when police will make the final decision on Ms Sutcliffe's future.

The singer had a two-inch vertical gash underneath his right eye.

Buckingham Palace yesterday refused to comment on the incident, which occurred earlier this month at a dinner party given by the Princess at her family's residence.

Sheeran (25) and fellow singer Blunt (42) were among the 20 guests at the party at Royal Lodge in Windsor Great Park in Berkshire, England, three miles south of Windsor

When Blunt, a former British Army officer, joked that he would like to become Sir James Blunt, the Princess enthusiastically obliged by fetching a ceremonial sword to "dub" him.

As she said "Arise Sir James", she swung the blade over her shoulder, unaware that Sheeran was standing behind her.

Sheeran, who was at the party with his girlfriend Cherry Seaborn, went to the local hospital where accident and emergency

staff patched him up, allowing him to return to the party later.

The Duke of York was in Mexico on a trade mission, but his ex-wife the Duchess of York, who is also known to have staged mock knighting ceremonies in the past, was at the party.

Dickie Arbiter, the Queen's former press secretary, said: "I hate to say it, but it's a case of like mother like daughter."

A source said: "The Princess must have misjudged the weight of the sword or something and, instead of lightly tapping him on the

shoulder, she swung it back, not knowing Ed was standing right behind her.

"A couple of the guests said Ed could have been seriously injured but he really played it down. He was the perfect gentleman and told her it was just an accident."

Freezing Britain: December roars in with snow and ice

FOR ONCE the forecasters seem to have got it right: Britain is set for the coldest winter in years with December already bringing plunging temperatures and snowfall through much of the country.

Most of the UK saw subzero temperatures this week, with the mercury plummeting to -9 in some places, as the new month provided no respite to what was the coldest November in six years.

The frigid conditions even spread to London, which is traditionally milder than the rest of the country, as the capital shivered through several subzero nights which left the water in Trafalgar Square's fountains frozen over.

At the same time deer were seen leaping about a frost-and-ice-covered Richmond Park.

But while the bookies have been slashing the odds of a white Christmas, the Met

Office has been more measured in its forecast, stating on Tuesday that "Temperatures on the whole will continue to be on the cold side, but as the more unsettled weather spreads across the north of the country, milder interludes are more likely here at last."

The Met Office has also issued a yellow weather warning because of 'dense, freezing fog' in the south west.

'Freezing fog is likely to be most prevalent

along river valleys and over lowland areas, but isolated fog patches are possible elsewhere,' the

chief forecaster said. 'Visibility will be less than 100 metres in places.' The meteorological

So you need to (slightly) up your protein intake - include a portion of fish, chicken, turkey, low fat cheese, eggs, soya, beans, lentils or yoghurt with each meal. Studies have also shown that protein blunts your appetite more than carbohydrate or fat. If you skimp on protein you could find yourself still hungry after you've eaten.

Snooze to lose: Aim to get at least eight hours of sleep every night to stop yourself from snacking. Research published in the American Journal of Clinical Nutrition found those who were restricted to just five and a half hours of sleep ate significantly larger amounts of high-carb snacks during their waking hours than those sleeping for eight and a half hours a night. A lack of sleep boosts levels of ghrelin, the 'hunger hormone'.

Watch those evening nibbles: Overeat in the evening? Then most of the treats (simple carbs) will be stored as body fat. It also increases your

risk of developing type 2 diabetes. Aim to eat the majority of your daily meals during the morning and afternoon - spread over breakfast, lunch and two or three snacks. This will help boost your metabolic rate and promote fat burning.

Rule of three: If you're presented with a wide variety of sweet foods you're likely to eat more, according to research from Tuft's University in the US. So when you're faced with a glorious choice, opt for just two or three types rather than a bit of everything.

Drink before you eat: Women who drank a large glass of water before breakfast or lunch consumed 13% less food, according to a study published in the Journal of the American Dietetic Association. Water distends the stomach, leaving you feeling full and less likely to overeat. Knock back a glass of water

15 minutes before you tuck into your spaghetti and you might even leave a few spoonfuls!

Bulk Up: Make your first course a bowl of veggie soup, some fresh fruit, or a salad with less dressing. Eating fiber-rich foods before a meal can help reduce your food intake. A 2004 study at Pennsylvania State University found that people who ate a large salad before their meal consumed 12 per cent less.....

Stop looking at food: Turns out it's not our bottomless bellies that are to blame for our penchant for second helpings, but our eyes. Vision is a huge appetite stimulant. Studies show we eat 50 per cent more if food is left within our field of vision. So next time you have a Chinese takeaway, dish up your plate in the kitchen rather than leaving containers in tantalising view on the

table in your dining room.

Practice portion control: It may sound obvious but eating off a bigger plate makes you eat more. Researchers at Cornell University, New York, found that people ate 45% more food when given a large portion, even when they disliked the food. Also, the size of the plate you eat from, the bowls you serve yourself from and the utensils you use can make a big difference to amount you eat. A 2005 US study found when people serve themselves from bigger bowls and use larger serving spoons, they serve themselves at least 31 per cent more. Try using large bowls for foods like salad and small ones for ice cream.

Fruit, not juice: Juice is healthy but actual fruit is better. Downing a glass of orange juice is not the same as if you eat a whole orange instead -



NOT SO HARD: get plenty of sleep, and eat lots of fruit

you will get more fiber and still get your daily vitamin C quota.

Slow down! Sit down and slow down your meal rather than eating on the run. People eat up to 15% more when they rush at mealtimes. Scoffing your meal means that your hypothalamus -

the part of the brain that senses when you are full - doesn't receive the right signals and explains why you may feel hungrier sooner.

Meet *Raymond-Kym Suttle from London who moved to LA 3 years ago to pursue acting/comedy/dance, writing, directing, filmmaking and choreography.*

Was there a particular reason you chose LA?

Sunshine: I'm very happy to enjoy one season all year round. Aside from the weather, I kept watching TV and films and wishing I could be in them and realized that if I wanted to be in the running to be cast in them, then I had to be where they were being made.

What do you miss most from home?

Reasonably priced yet healthy meals to grab on the go like sandwiches from Pret a Manger, and the little salad pots from Marks & Spencer that used to be £3 for two, but who knows what's

happened since Brexit...

What was your first impression of LA and has it changed since? If so, why?

I first came to LA in about 2002, to stay with a friend I'd made online. I had a great time. I came back a few times after that and noticed that a lot of the city was starting to look run down, there were pot-holes in the roads and it seemed like no money was spent on the infrastructure. I also came here before mobile phones were in everyone's hands and I preferred it then because people looked at you, smiled, connected more often. That still happens but not as much.

What do you find the biggest difference is living here versus London?

Attitude. I spent most of my adult life in

London but in fact grew up in Zimbabwe until I was 16. As a result I have a different take on British behaviour - I was often frustrated by the unwritten rules of British social and professional interactions, which seem to frown upon people being direct. LA also seems to bring out the simmering peculiarities of people (oh the tales I could tell), but the biggest positive difference for me is the 'anything is possible' attitude I often encounter here. There are so many opportunities and people seem willing to at least meet you. I always find it odd in London how difficult it is to get a meeting with an agent or casting director, especially if you haven't got the 'right' credentials like RADA on your CV. There's a thinly veiled irritation that seems to say: who on earth do you think you are bothering

us? In LA, I love the fact that agents and casting directors do their job and meet you because they never know who might be the next big thing and their next meal ticket.

Do you have a hidden gem in LA that you want to share with us?

I'm not sure how hidden it is but I do love Republic of Pie on Magnolia, between Lankershim & Vineland. It has a great atmosphere, live music most evenings, fantastic pies, cakes, baked goods and beverages. The banana and chocolate bread pudding is divine. And my personal favourite drink: chai latte made with hazelnut milk.

What would you suggest to others who are thinking about making the move here?

I have a long, long list of suggestions... But primarily: **Have a LOT of money saved up**; moving country is expensive and there are all sorts of things you didn't factor in cropping up. **Nowhere and everywhere in LA is central.** When looking for a place to live, find an area you like, and feel safe. If you have a 'regular' job where you're going to work at the same place

every day then sure, find somewhere close to where you work so that you don't lose hours of your life commuting. **Find a group** of people you can meet with regularly whether it be an acting class, a hiking group, or a local coffee shop where you get to know the servers personally - LA can be isolating and it makes a huge difference to have a place/event that you can go to and be known by name. **Be a good, reliable, available friend** and make sure you develop a reputation for being dependable.

Don't be afraid to tell people to f**k off. If someone isn't good for you don't be afraid to walk away. I'm a loyal and dependable friend - and rightly or wrongly, I expect my friends to treat me the same.

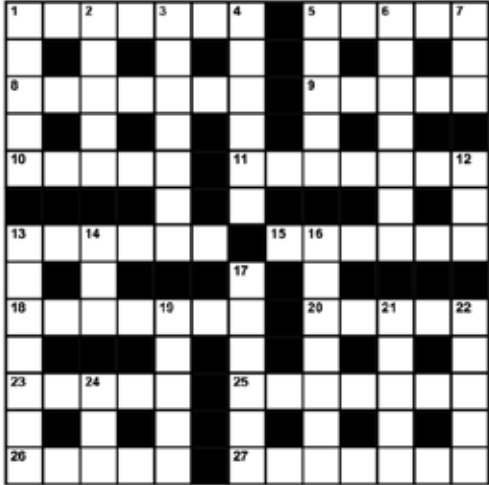

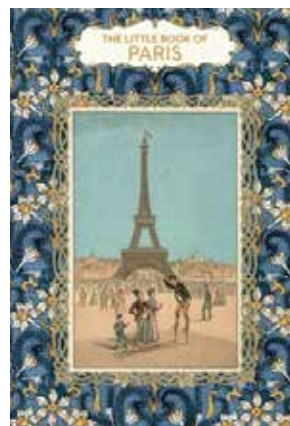

Manchester United eased into the EFL Cup semi-finals as they beat West Ham with manager Jose Mourinho absent from the Old Trafford dugout. The Portuguese, given a one-match touchline ban before Wednesday night's game, stayed out of view as United set up a last-four tie against Hull

City. Zlatan Ibrahimovic clipped in the opening goal inside two minutes before former United youngster Ashley Fletcher equalised as he pounced on David de Gea's error. Anthony Martial re-established the home side's lead shortly after half-time, drilling Henrikh

Mkhitaryan's cross past Hammers keeper Adrian. The France international extended United's lead when he stroked in Antonio Valencia's low cross after a well-worked team move, with Ibrahimovic adding the gloss by tapping in with virtually the last kick of the game.

Saints dump misfiring Gunners

Southampton progressed to the semi-finals of the EFL Cup for the first time since 1987 thanks to a convincing victory over a below-par and under-strength Arsenal on Wednesday night.

Goals from Jordy Clasie - his first for the club - and Ryan Bertrand secured victory for a Southampton side which inflicted a first defeat on the Gunners since the opening day of the season.

Manager Arsene Wenger, who has never won this competition during his 20-year reign in north London, had made 10 changes to the Arsenal team which beat Bournemouth 3-1 in the Premier League on Sunday and paid the price.

In Aaron Ramsey, Alex Iwobi and Mohamed Elneny, the Gunners had Premier League regulars in their starting line-up - but without Alexis Sanchez, Theo Walcott, Olivier Giroud and Mesut Ozil, they lacked guile and bite.

Southampton, who had only won once in their last 23 visits to Arsenal, deserved the victory and will play Liverpool in the two-legged semi-finals, with the first leg at St Mary's in the week commencing 9 January.

During his tenure as Arsenal manager, Wenger has regularly used this tournament to give games to those on the fringes of the first team. That perhaps explains why they have won only one of their last six quarter-finals in the competition.

The majority of Wednesday's starting line-up had defeated Nottingham Forest and Reading this season, but Southampton were a different prospect - a Premier League side with a game plan and nous.

Arsenal's £17m summer signing Lucas Perez started for the first time since the 2-0 win over Reading on 25 October, but was a peripheral figure as he and his team-mates lacked energy and urgency, especially in the first half.

Reds hail teenage tyro

Teenager Ben Woodburn eclipsed Michael Owen as Liverpool's youngest goalscorer as the Reds edged past Championship side Leeds United in the EFL Cup quarter-finals at Anfield Tuesday night.

The Premier League hosts huffed and puffed before Divock Origi stole behind the Leeds defence to sweep in Trent Alexander-Arnold's right-wing cross from close range.

They secured a place in the last four when Wales Under-19 international Woodburn, aged 17 years and 45 days, fired in the second to beat Owen's record by 98 days.

Liverpool hit a post through Georginio Wijnaldum shortly before the opener, but the scoreline was somewhat harsh on the Yorkshire side.

Leeds winger Kemar Roofe curled against the inside of a post shortly after half-time.

Hadi Sacko spurned a good opportunity for the visitors in the opening 10 minutes, and Kyle Bartley nodded a free header wide after the break.

Klopp's squad has been hurt by injuries to Philippe Coutinho, Roberto Firmino, Daniel Sturridge and Adam Lallana, forcing him to rotate his squad.

Without that attacking threat, the home side lacked fluency and potency in the final third until they clicked in the final 15 minutes to reach a record 17th League Cup semi-final.

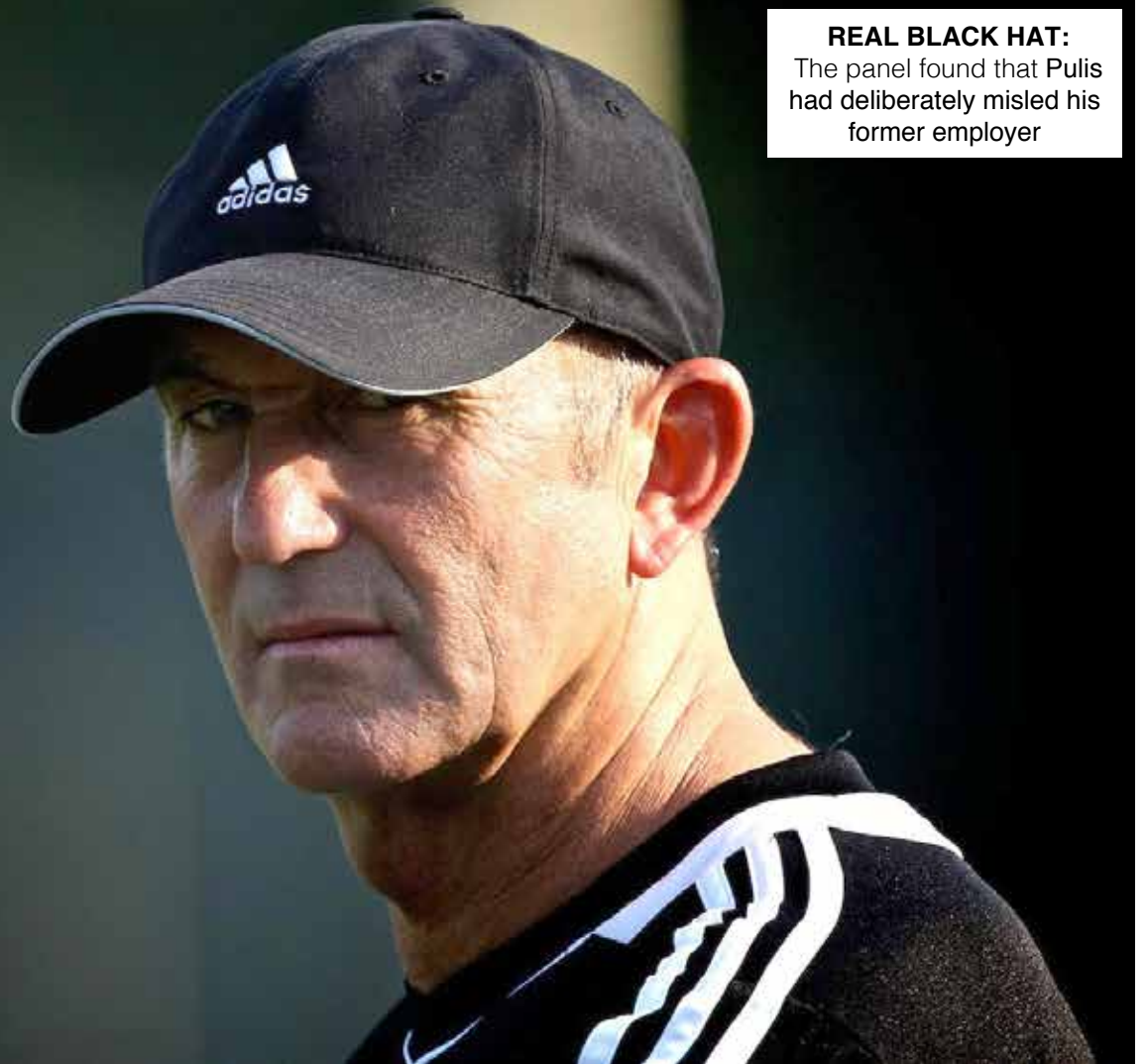

PULIS LOSES PALACE BATTLE

■ WBA boss facing £3.7m payout after 'disgraceful' treatment of London club

West Bromwich Albion manager Tony Pulis has lost a £3.7m High Court battle with former club Crystal Palace.

A Premier League Managers' Arbitration Tribunal ruled earlier this year Pulis should pay £3.7m damages to the club in a dispute about the way he left at the start of the 2014-15 season.

Palace bosses said Pulis told them he was committed to the club but left two days after getting a £2m bonus.

Pulis, 56, denied deceiving them into paying the bonus.

He challenged the order in the High Court but a judge ruled against him.

Details of the case have emerged in a written ruling published by Sir Michael Burton on Monday.

Pulis had a contract with the south London club which promised him the bonus if he kept them in the Premier League at the end of the 2013-14 season and stayed in the manager's job until 31

August 2014.

He secured Palace's place in the top flight but did not stay until the required date, instead asking for the bonus earlier than agreed and then informing the club a day later he wanted to leave.

He departed Palace the next day, on 14 August, on the eve of the new season.

Pulis said his reason for asking for the bonus early was due to an imminent purchase of land for his children and he "urgently needed the money" to enable that, the arbitration tribunal heard.

And he said had decided to leave the club as a result of a "heated" players' meeting on 12 August but the panel rejected that claim, with the judgement saying the meeting had actually happened on 8 August.

"Since the panel has concluded that the heated players' meeting occurred on 8 August, Mr Pulis's explanation for his sudden desire to leave the club cannot be true. There

must therefore be another reason," it said.

The ruling also said: "There was in truth no pressing need for the money at all, since at no time was there a plot of land on the market which Mr Pulis was remotely close to purchasing."

The panel concluded it was satisfied Pulis intended to give the club the "false impression" he had a pressing need for the money.

"His motive in doing so was to secure early payment of £2m," the tribunal panel said.

Pulis had said he only wanted to leave if it was "mutually agreeable for him to leave on the eve of the new season", and that it had been "mutually agreeable".

The panel declared that Pulis had not told the truth and had "deliberately misled" Palace chairman Steve Parish.

"By any standards his conduct [prior to and during the litigation] has been shown to be disgraceful," the panel said.
