Key May aide forced out over computer porn cover-up

- Deputy PM lied about knowledge of material
- Harassment claim by Tory activist 'plausible'

Theresa May has forced Damian Green, her deputy and closest ally, to resign after he admitted making "inaccurate and misleading" statements about pornography found on his parliamentary computer.

In the biggest resignation of the ongoing Westminster sex scandal, Mr Green was found to have lied when he denied knowledge of material discovered on his Commons computer by police in 2008.

A Cabinet Office inquiry also concluded that allegations of inappropriate behaviour towards Kate Maltby, a Tory activist and journalist 30 years his junior, were "plausible".

In a letter to Mr Green released by Downing Street at 9pm on the last day before parliamentary recess, Mrs May said it was with "deep regret" that she had asked him to step down but his conduct fell short of the "high standards" the public demanded. She rounded on former police officers for divulging the contents of Mr Green's computer, which were uncovered during a leaks inquiry but remained secret for nine

years.

Mr Green, 61, maintains that he never downloaded or viewed pornography on his parliamentary computer but in his letter to Mrs May said he should have been "clear" in statements last month that he had been aware of the allegations against him at the time. He had told The Sunday Times that the claims were "completely untrue" and attacked "disreputable political smears from a discredited police officer".

There will be deep disquiet among senior Tories that two former police officers broke ethical guidelines to make public accusations about Mr Green's behaviour — which did not break the law — to discredit him. David Davis, the Brexit secretary, said he would step down if Mr Green were forced to resign over the police allegations. A spokesman for Mr Davis said he agreed with the prime minister's decision, however. The former officers' actions are the subject of a Scotland Yard inquiry.

Mrs May must now conduct an unwelcome

reshuffle. There is no requirement to have a deputy but she will have to fill Mr Green's posts as Cabinet Office minister and as chairman of several committees. It also robs her of a friend she has known since Oxford University.

The move follows a seven-week inquiry into his behaviour by the Cabinet Office ethics tsar Sue Gray, which was prompted by Ms Maltby's allegations. Last month she alleged that Mr Green "fleetingly" touched her knee during a meeting in a pub in 2015, and a year later sent her a suggestive text message after she was pictured wearing a corset.

While the inquiry was under way, two former police officers accused Mr Green of having pornography on his office computer in 2008. Mr Green denied knowing about the pornography claims at the time. In fact, he spoke to police lawyers about the material in 2008 and police raised it with him in 2013, he confirmed in his resignation letter.

A Metropolitan Police source said the force would continue its inquiry into the leaking of information about

Mr Green. "The Met will still want to make clear that you can't use information that you come across in the course of employment. There is concern about that breach of trust," the source said, adding: "He [Mr Green] might have got away with the sin of watching it, but it's always the cover-up."

The former Tory chief whip Andrew Mitchell said Mr Green's breaches of the ministerial code were "dwarfed by the extraordinary behaviour of the police".

Jeremy Hunt, the health secretary, said Mrs May had no choice but to sack her deputy and did so with a "very heavy heart"

because Britain rightly held ministers to higher standards than many countries. "He lied on a particular incident. Lots of people who understand the context would appreciate why that might have happened, but that doesn't make it any more acceptable," Mr Hunt told the BBC.

Abu Hamza begs for return to UK jail

Conditions in US prison too harsh for firebrand preacher

HATE preacher Abu Hamza desperately wants to come back to the UK — after complaining that life in his American jail is "too tough".

The former imam — notorious for his inflammatory sermons at Finsbury Park mosque in north London — is demanding a swift return to the British prison system.

The 59-year-old is apparently "hopeful"

about his appeal to transfer and his lawyers have said he would return to a UK jail "in a second" if he could.

Hamza was extradited to the US five years ago after the British Government spent a decade and almost £1million in legal fees trying to boot him out of the UK. He was given a life sentence for terrorism and kidnapping offences in New York in January 2015 and has since been

mostly kept in solitary confinement in a special unit. He complains of "inhuman and degrading" conditions in the "supermax" prison in Florence, Colorado, which "breach his human rights".

Using his real name, Mostafa Kamel Mostafa, court documents give details of his "cell-sized cage". Egyptian-born Hamza says the cell is unsuitable for a double

When Harry quizzed Obama for the BBC...

■ Prince enjoys 'genuine rapport' with former President

PRINCE Harry has interviewed former US President Barack Obama for BBC Radio 4's Today programme.

The interview is part of Harry's guest editorship of the programme and features the predecessor to Donald Trump sharing his memories of the day he left office and his hopes for his post-presidential life.

Kensington Palace said the interview was recorded in Toronto in September during the Invictus Games and will be broadcast on December 27.

Radio 4 tweeted a video clip showing Harry and Mr Obama

warming up ahead of the chat, with the former president joking: "Do I need a British accent?"

Harry told his interviewee that if he used long pauses between answers he would probably get "the face".

When Harry showed him what he meant, Mr Obama said: "I don't want to see that face."

Twiddling a pen, Harry tells Mr Obama: "You're excited about this, I'm nervous about this, that's what's quite funny."

Mr Obama replies: "I'll interview you if you want."

But Harry was not

keen and said: "No, no, let's keep it this way."

A spokesman for the Prince said the conversation features Mr Obama talking about his plans to focus on cultivating the next generation of leaders through the Obama Foundation.

Harry, who was recently at the inaugural summit of the Obama Foundation in Chicago, has forged a strong bond with the Obamas, through his work with servicemen and his trips to America, with one royal aide commenting that the two enjoyed 'a genuine rapport'.

At this year's Invictus

Games, Mr Obama reportedly quizzed Harry on his romance with Meghan Markle as they watched the wheelchair basketball.

Mr Obama was among those to congratulate Harry and Meghan

on their engagement, writing on Twitter: "Michelle and I are delighted to congratulate Prince Harry and Meghan Markle on their engagement."

"We wish you a lifetime of joy and

happiness together."

The couple will be married at St George's Chapel, Windsor on May 19 next year. Mr Obama and his wife Michelle are expected to be on the guest list for the wedding.

amputee and "the stumps in both arms are subject to regular outbreaks of infection, increasing in severity".

The appeal reveals how, while in Belmarsh prison, south-east London, he could mingle with other inmates, would be seen by a nurse or doctor five times a week and had daily access to a healthcare aide. He now

has just "one hour per day" of recreation time. Hamza, who is blind in one eye and suffers from diabetes and psoriasis, must take at least two showers a day because of a neurological condition that causes excessive sweating, it has been claimed.

His lawyers are demanding that he now be moved from the prison, claiming that his treatment breaches Article 3 of the UK Human Rights Act, which prohibits

torture and inhuman or degrading treatment.

Michael Bachrach, one of Hamza's appeal lawyers, revealed: "Abu Hamza would go back to Belmarsh in a second if he could. "We strongly believe that the conditions of his confinement violate the expectations of the European Convention On Human Rights and the promises that were made by the United States Government to the [British and European] courts."

18 year sentence for serial abuser pedophile priest

■ Laurence Soper just the latest in string of men convicted of assaults at Catholic school for boys

An ex-Catholic priest who abused boys at a London school in the 1970s and 1980s has been jailed for 18 years.

Laurence Soper, 74, fled to Kosovo with £182,000 from the Vatican bank in a bid to avoid prosecution for abusing boys at the independent St Benedict's School, in Ealing, where he taught.

He was extradited to face 19 charges of indecent and serious sexual assault against 10 former pupils.

He is the fourth man to be convicted of molesting children at the school.

Sentencing, Judge Anthony Bate said Soper's conduct was "the most appalling breach of trust" and he had "subverted the rules of the Benedictine order and teachings of the Catholic Church".

He said the former abbot and headmaster's life would now be "overshadowed by the proven catalogue of vile

abuse".

An Old Bailey jury took 14 hours to find Soper guilty of all charges on 6 December.

Prosecutor Gillian Etherton QC told how the victims were subjected to "sadistic" beatings by Soper for "fake reasons" and on many occasions "with what can only have been a sexual motive".

The "reasons" included kicking a football in the wrong direction, failing to use double margins and using the wrong staircase.

St Benedict's apologised for the "serious wrongs of the past".

Soper's victims, who cannot be named for legal reasons, were supported by relatives in court when he was sentenced earlier.

One victim suffered from nightmares and flashbacks after the abuse, but chose not to come forward out of fear of more beatings, the jury

heard during the trial.

'Numb the pain'

One victim said he was left faithless and suicidal.

In a statement read out in court, he said he wanted to be a vet or pilot before his life was ruined.

He said he began drinking to "numb the pain of what was happening to him".

Having been brought up a strict Catholic, he said he had since lost his faith, adding: "I have tried countless times to take my own life - I just could not cope."

Soper is the latest in a string of men to face allegations relating to their work at St Benedict's.

In 2009, Father David Pearce, 75, nicknamed the "devil in a dog collar", was jailed after he admitted 11 charges of indecent assault dating back to 1972.

Between 2003 and 2009, "master

of discipline" John Maestri, 78, of Chatham in Kent, admitted five indecent assaults against children at St Benedict's in the 1980s and was jailed.

In 2010, John Skelton was convicted of indecent assaults against two complainants said to have occurred in 1983.

Father Anthony Gee faced accusations of abuse, but no further action was taken although civil action was brought against him.

In 2010, Abbot Shipperlee announced an independent review of safeguarding arrangements, policies and procedures.

The following year, Lord Carlile produced a damning report calling for tougher rules to protect all faith pupils and stripped monks of control at the school.

Soper resigned as an abbot at the £5,000-a-term school in 2000 and moved to Rome, during which time victims started to

come forward.

He then skipped bail and spent six years living in Kosovo, with a European Arrest Warrant issued for his extradition.

Judge Bate said: "You have been a clandestine sex offender since your early 30s. Your disgrace is complete."

Soper was attacked while on remand at Wormwood Scrubs prison, the court heard. He is now being held in segregation for his own protection.

Only way is porridge for ex boyfriend of TV star Ferne

REALITY TV star Ferne McCann's ex-boyfriend was jailed for 20 years on Wednesday for wounding 14 people in a horrific nightclub acid attack.

Arthur Collins was left reeling by the severe sentence as a judge condemned the recent surge in assaults using corrosive liquids.

Noel Lucas QC said: "The public are understandably frightened by the rise in this horrendous criminality."

Collins, 25, hurled acid over innocent partygoers after clashing with three men at the Mangle club in Hackney, east London. Police suspect the attack was part of a drugs feud

"that has unfortunately drawn members of the public into it".

Victims told how their faces, necks and arms were blistered as the substance, similar to battery acid, hit them on the crowded dance floor. Three were temporarily blinded and one still has blurred vision in one eye.

Collins, wearing a T-shirt with "Candy Killer" on it, caused mayhem at the club in the early hours of Easter Bank Holiday Monday. He went on the run before he was tracked down and Tasered by police in Higham Ferrers, Northants, a week later.

It emerged that ex-scaffolder Collins was a drug dealer who had

a cannabis farm at his home in Broxbourne, Herts. Collins denied all charges and claimed he believed the liquid was a date rape drug. But jurors at London's Wood Green Crown Court found him guilty of five counts of grievous bodily harm with intent and nine of actual bodily harm last month. After he was found guilty, police branded Collins a "barbaric coward".

'despicable act'

At his sentencing, female relatives shouted "love you Arth" as he was jailed.

Judge Lucas called Collins an "accomplished liar" and said he had shown no remorse for his

victims. The judge said: "This was a despicable act. You knew precisely what strong acid would do to human skin."

Collins threatened to throw acid over a previous girlfriend's

mother and have her raped, the court heard. He was told he will spend two thirds of his sentence, 15 years, behind bars because he is so dangerous. Prisoners are usually freed after half

their sentence and spend the remainder on licence.

Ms McCann, star of the hit reality shot The Only Way Is Essex, split up with him and has since given birth to their daughter, Sunday.

Gaelic sign spelling errors went uncorrected for years - because NOBODY noticed them

A series of Gaelic signs on a popular tourist route in the Highlands have had spelling mistakes corrected eight years after they were installed — because no one had noticed they were wrong.

Transport Scotland has now admitted that contractors cut corners when the signs along the Great Glen cycle route were erected and did not get the official Gaelic placenames body to translate them.

The errors have cost Transport Scotland £1,725 to put right — but probably a lot more in embarrassment.

The mix-up was disclosed in a document released under Freedom of Information legislation.

According to the document, a series of signs were installed in

Gaelic on the Great Glen cycle route in 2007. They stayed in place until 2015 when a member of the public complained that 17 of them were wrong, mostly with incorrect spellings, some with inaccurate translations and one with an accent in the wrong place.

The village of Clunes was displayed as Na Clualnean when it should have been Na Cluainean. Seven signs to “town centre” were written as Baile mor ionad when they should have read Meadhan a’ Bhaile.

The village of Dores was inscribed on a sign as Dora when it should have been Duras while the Great Glen Way was written as Slighe a’ Ghlinn Mhóir when it should have been Slighe a’ Ghlinne Mhóir.

The smallest mistake

occurred on five signs pointing the way to the Caledonian Canal which should have been displayed as An Canàl Cailleannach, with the grave accent on the second ‘a’ of canal, but the accent was missing, resulting in all of them being changed.

It was only after the document was released on Tuesday that Transport Scotland admitted that officials had not bothered to use the official place names translation service, based at Sabhal Mor Òstaig, the Gaelic college on Skye.

Transport Scotland said: “A number of signs on the Great Glen Cycle Way had to be replaced in 2015 after incorrect translations were brought to our attention by a member of the public.

“Our contractor failed

to use the services of our translator and the signs were corrected as quickly as possible after the mistakes were drawn to our attention.”

The decision to display place names around Scotland in Gaelic has proved to be contentious. The SNP administration has been a determined backer of the plan, claiming it will help keep the ancient language of the Highlands and Islands from dying out.

But other people have

said money is being wasted on a language that few people outside the islands speak.

Generally, signs are only substituted with bilingual versions when they need to be replaced and while the Scottish government invests about £28 million in Gaelic every year, it spends only about £285,000 a year on road signs.

However, Transport Scotland is not the first national body to get in a mess over Gaelic

translations.

Last week, VisitScotland was criticised for basing a tourism campaign on what it claimed was the Gaelic equivalent of the Danish word hygge, which means snug and cosy.

Scotland’s national tourism body claimed the Gaelic translation of hygge was còsagach — until Gaelic experts claimed that còsagach meant nothing of the sort and actually could be most closely translated as “full of holes”.

Jail term for multi-mobile phone thief

A PICKPOCKET who stole 53 mobile phones at a rock concert, stashing them in a swimming costume worn under his clothes, has been jailed for three years.

Romanian building worker Alin Marin, 22, swiped the phones from fans watching British rock duo Royal Blood. He was arrested shortly after the concert at Arena Birmingham on November 18. The phones were found in a nearby car park.

West Midlands officers were mingling with the crowd that night in a covert operation after thieves targeted fans of the band at performances earlier this year. Marin, of no fixed address, admitted theft at Birmingham Crown Court.

Farah scores upset win in farcical SPOTY

In a stunning upset, Mo Farah beat odds-on favourite Anthony Joshua to win BBC Sports Personality of the Year on Sunday night after six years of being shunned in the public vote.

The four-time Olympic champion, who retired from the track this summer to switch to road-running, had failed even to make the top three for the award since 2010. And yet to his palpable astonishment, he seized the main prize at last, despite having chosen not to attend the event in person.

On an evening when the pre-event form guide was shredded, with motorcyclist Jonathan Rea runner-up and Paralympian Jonnie Peacock third, Farah acknowledged that he wished he had turned up to collect the

trophy in person but claimed that his son Hussein’s sickness had kept him in London.

“I can’t stop staring at it,” Farah said. “We have amazing superstars in Joshua and Lewis Hamilton. I didn’t imagine this was ever going to happen.”

In farcical scenes, Farah, who was appearing via satellite link from a set at St Mary’s University, found that the video connection failed at the crucial moment, as he began to speak to the crowds at Liverpool’s Echo Arena. Earlier in the evening the broadcast had been interrupted as his young son spoke over him throughout and interfered with the microphone.

Either way, this result was a colossal surprise, with Joshua, the runaway favourite

after his vanquishing of Wladimir Klitschko, shut out of the top three. Not since Princess Anne beat George Best and Barry John in 1971 had there been such unexpected, if not bizarre, voting.

“I don’t know if I’m the greatest distance

runner ever – I leave that to the public and you guys,” Farah said.

“Haile Gebrselassie had said, ‘This is Mo’s time. I’m not going to always be on top of my game always, so this is my moment and I’m just going to have to make

the most of it, enjoy it. I’m just proud of what I’ve achieved over the years. It’s been a long journey and it’s been up and down. But one thing that really drives me is that I enjoy what I do, and you can’t take that away from me.”

Getting to the Heart of Robin Hood

THEATRE REVIEW: new take on classic British tale at the Annenberg Centre is well worth an evening of your time, says **Catherine Siggins**

With a hey nonny-nonny and a ho-ho-ho, it's Christmas once again Breeps, and what better way to enjoy it then by going to see 'The Heart of Robin Hood', brought to you in co-production by The Wallis Annenberg Centre for the Performing Arts in Beverly Hills and the award-winning Icelandic theatre company Venturport. Written by British writer, David Farr, who penned the BBC's excellent TV series 'The Night Manager', this reworking of the classic tale of British daring-do will have you rooting for the goodies and booing at the dastardly doings of the baddies.

King Richard The Lion Heart is off crusading in the Holy Land and has left Blighty at the mercy of his dastardly brother Prince John. The peasantry is oppressed, forced to pay even more taxes to fund John's army so he can take over the country. Messing with his plans for national domination are a gang of tree dwelling brutes led by Robin Hood, who steals from the rich and...well, says sod the poor and keeps the money. Robin is lacking a heart, a misanthrope to boot, and looking out for himself and his mates. Meanwhile in Nottingham castle, Lady Marion, distraught by

John's tyrannical reign, decides to save the lives of two orphaned children of a murdered subject by running off to Sherwood with her servant Pierre to find Robin Hood. When Robin refuses to help her in her quest, she takes matters into her own hands and starts her own gang, much to the annoyance of Robin and his crew. Co-Directors Gisli Örn Gardarsson and Selma Björnsdóttir have turned this tale on it's head, literally. They have their good-looking talented ensemble cast bouncing, sliding, tumbling, swinging, singing and fighting their way through this inventive

and funny production, to a great soundtrack of live music and songs by Icelandic pop singer Salka Sól. Choosing not to set it in ye olde Medieval times, they've opted for a visual mash up of eras, courtesy of costume designer Emma Ryott who dresses the cast in garb from Medieval to the 18th century. Scenic designer Borkur Jónsson has created a versatile forest set that doubles as a climbing wall, slide, battlements, and green sward as required. David Farr has written Lady Marion as the kick-ass heroine of the story, while Robin goes through a miraculous moral transformation thanks to her good example, though his falling in love with Marion seems a bit far-fetched given that he only saw her once before he violently insulted her out of Sherwood. Gardarsson and Björnsdóttir have the cast run riot with a heightened performance style, high levels of energy, and macabre physical comedy, so this production would be best described as an action-panto for CW fans, if you like. The incredibly hardworking, humorous, and athletic ensemble cast is led by Luke Forbes who is troubled and hunky as Robin Hood,

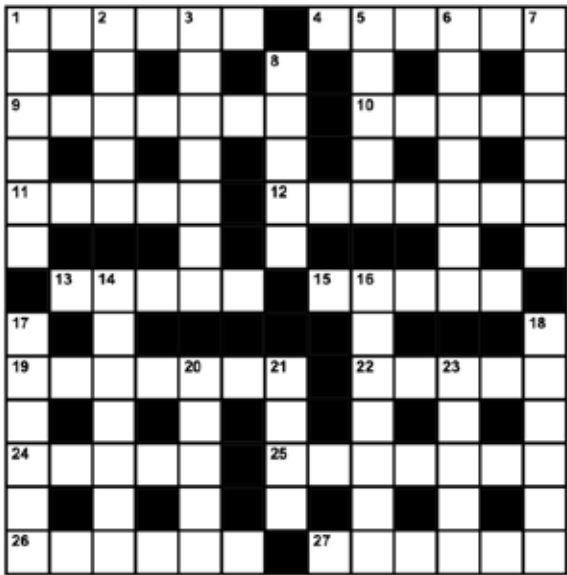
Christina Bennett Lind as the rebellious, principled, cross-dressing Maid Marion, Daniel Franzese zestfully camping it up as foppish Pierre, and Erik del Barco Soleglad as the deliciously evil Prince John. The cast give energetic performances all round, though at times some of their strong, occasionally wandering, regional accents left some American audience members baffled as to what they were saying.

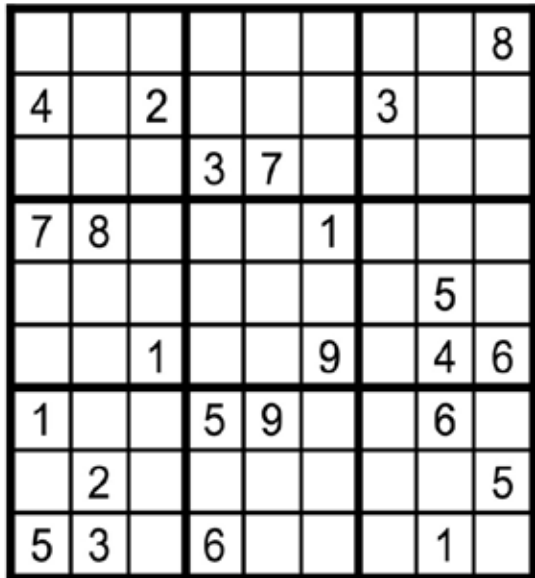

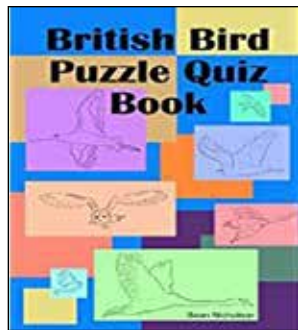

Christmas in LA: with snow and ice...if you know where to look!

The weather outside is frightful, but I doubt we will be seeing real snow in Los Angeles any time soon.

For those of you who are out of town the current temperature is an icy 52 degrees (that's 11 in celsius!). I was quite surprised to learn that LA used to get snowfall every now and then, although the last reported flake that fell was back in 1962. But of course that wouldn't stop us from missing out, for after all we live in Hollywood!

Let it (fake) snow....

If you really can't live without the white stuff this time of year, there are loads of options to choose from too: **Pershing Square** in Downtown has their annual outdoor ice rink in place until January 15th, and don't forget the popular outdoor ice rink in **Santa Monica**, which can be found on Fifth Street and Arizona Avenue, which runs through till January 15th, and doesn't close till midnight on the weekends!

Ye Olde King's Head in Santa Monica is a great bet on Christmas Eve, with snow machines blanketing the pavement between Second Street and Ocean Avenue. And if you're in the mood for some tubing and ice skating try **Snow Day LA**, a full-on winter adventure park at Dodger Stadium. But hurry! It ends tonight (Dec 23rd), there are still tickets available for the evening session 6-10.30pm so if you are game visit snowdayla.com.

The Grove shopping mall has transformed into a Winter Wonderland,

and delight in roasted chestnuts as real snow falls from above.'

If you want it to feel a little more authentic you can head up to Big Bear Mountain which is only a two hour drive from Hollywood (when the roads are clear). They may not have much of the real stuff at the moment, but they have impressive machines that pick up the slack. I actually learned to ski there about fifteen years ago, on a mix of real and fake snow, and highly recommend it. Visit bigbearmountainresort.com for more info.

If that doesn't get you into the Christmas spirit perhaps you should try going to Midnight Mass. There are plenty of options to choose from, I'm not religious but am rather partial to the Episcopalian service at St Thomas of the Apostle Church in Hollywood. I might be slightly influenced by the fact that Father Ian hails from Wales, but I also like their official statement that reads 'Whether you are young or old, gay or

with a huge Santa's Grotto, which isn't cheap to visit (starts at \$30) however 5% does go to Children's Hospital Los Angeles. You can catch the snow fall (for free!) every evening at 7 and 8 pm, through December 25.

And the venerable **Beverly Wilshire Hotel** is even getting in on the act - they have erected an edible oversized Gingerbread House in their lobby, and if you go along on or before Christmas Day December 25, 2017, from 6:00 to 8:00 pm, you 'can revel in quintessential winter weather underneath the property's porte cochère

Meet A Member: Louise Houghton

Meet Louise Houghton from Kent, UK who moved to LA less than a year ago to pursue her career as a host and producer.

Was there a particular reason you chose LA?

Even before I came to LA I knew it was a place I wanted to live. I have had the opportunity to live between London and Berlin for the last six years as I was working for Deutsche Welle, an international TV channel, but Berlin never called to me like LA did.

I grew up by the coast in Kent and went across the country to the coast of Wales to Aberystwyth University. Having the chance to live in a city where I could pursue my career and have the ocean in my life, was a dream come true.

What do you miss most from home?

Whilst I was so keen to come here, I never once contemplated how hard it would be to move across the other side of the world. I knew no one! I missed my friends and family so much. The support, encouragement, laughs and ability to be 100% myself was gone after 2pm and those back home were in bed! The time difference is the killer but, I am sure that is something all Brits have to tackle and it gets easier with time.

Apart from that, I miss

food with less sugar and salt!! I used to have low blood pressure but moving to LA has sorted that out! Oat milk is the best in coffee and you can't get that here easily. Other than that it is not really the usual things I miss....it is crumpets and oat cakes and German bread! And strangely tinned mackerel!

What was your first impression of LA and has it changed since?

I loved how relaxed I always felt being here before I moved. To me it was always a place where I felt so positive and motivated. It's amazing how quickly the relaxed holiday vibe fades when it becomes 'home' though and you have to deal with all the usual stresses and strains of daily life.

What do you find the biggest difference is living here versus EUROPE?

Well, aside from the obvious comment of the weather, I think the size of the city is a massive difference. It amazes me every day how big the streets are and how long it takes to travel just a few blocks! For a place that seems to be all about the lifestyle, you really have to make time to exercise here too, I'm realizing that! In Berlin and London, it was easy to live an active lifestyle. I would walk or cycle to

most places in Berlin. I lived on the 5th floor of an apartment building without an elevator. It was just normal to walk 10,000 steps without even thinking about it. Here, you have to make time in your day to move your body and it wasn't until I started getting issues with my back that I really noticed the difference!

Do you have a hidden gem in LA that you want to share with us?

I live in Venice and the canals are a beautiful sanctuary to me. I also love being by the ocean and on the top of the mountains. The views on the Paseo Miramar hiking trail are amazing but I'm sure a lot of people will have already explored that trail if they like hiking.

What would you suggest to others who are thinking about making the move here?

I'd say that is a great idea to visit before you land on that plane! Everyone I met on my recce was very friendly and helpful and this certainly made me feel like I had a few connections when I came over, which was comforting.

The previous visits also helped give me an idea of where I wanted to look for an apartment and they helped me feel like I knew where a few things were when I moved over. I'd also suggest when you

arrive to just get out there and do things. I signed up to Bumble BFF, MeetUp, BritsinLA, and other groups which provided a great way of having fun and meeting new people. I love now being able to walk down the street or into my local café or yoga studio and know people. That sense of community is important in making it feel like home and the quicker you feel that, the less you will miss the previous one!

Lots of our members join our group Brits in LA seeking out words of wisdom - what is the best piece of advice you've been given?

No Matter what you do, hold on to your dream. It is called the land of opportunity for a reason. My advice would be to always trust and listen to your intuition.

Lastly, how can we find out more about you? Are you working on anything at the moment?

Being a creative person, I have so many projects in development! I have heard that that is normal here and it is very exciting. At Christmas, I will be back hosting EUROMAXX, the

a competitive absence of almost six months, at the Brisbane International in less than two weeks. The Briton's initial plans were to travel to Australia in good time before Christmas to acclimatise to the conditions and gain an advantage on other players with such an early arrival, but he has still not departed.

But reports suggest Murray's pre-season

preparations have not been without difficulties as he still contends with the hip problems that have plagued him since early June. He returned to London last week, a few days earlier than expected, from his Miami training block.

Murray insisted last month during an appearance in Glasgow for an exhibition match against Roger Federer that

he will return to the tour only when he is fully fit, admitting that he had made a mistake in attempting to compete at the US Open in August. "I'll come back when I'm ready and 100 per cent fit," Murray said.

Sitting alongside him at the time was Federer, a man with recent experience of returning from a sustained injury-enforced absence, who urged: "Take your time, however long it takes."

Murray would be wise to heed such advice if he is still feeling discomfort in his right hip. Last month, he was still walking with a

visible limp.

While Murray and his camp were publicly positive about his progress after the defeat by Federer in Glasgow, a number of seasoned observers were not as optimistic. Murray's movement improved during the match, but there was still clearly some way to go to reach the level required for a five-set match.

If Murray does not play in Australia then more than six months will have passed since his last competitive match, and, at the age of 30, he would surely give surgery serious

consideration. This would rule him out until the start of the grass-court season in June, at the earliest, and mean he dropped outside the top 150.

Rampant Aussies blow England away

■ Hosts regain the Ashes in dominant display in Perth

■ Steve Smith revels in Bradman-esque run of form

■ "Root and Cook have done next to nothing"

ENGLAND face a miserable festive season Down Under after a humiliating loss in Perth that cost them the series - and the Ashes.

England surrendered the famous old urn Monday morning as they were crushed by Australia at the WACA by an innings and 41 runs - handing their rivals an unassailable 3-0 lead with two Tests to play. And several former players are under no illusion as to where the blame lies - pointing the finger at the failure of senior players to stand up and be counted.

"Joe Root and Alastair Cook have done next to nothing," said former England spinner Graeme Swann.

"The senior guys who you expect to stand up and outshine the rookies have done the exact opposite. The shining lights have been Mark Stoneman and Dawid

Malan."

Former England captain Michael Vaughan believes Root must now make changes both for the future and to avoid a 5-0 whitewash Down Under. "Joe needs to take 10 players out with him that are desperate to be out there in the middle in the next Test in a week's time," he said.

But while most of England's players have hardly performed there is no doubt they have also suffered from one of the great batting performances in recent years from Aussie captain Steve Smith.

Smith added an unbeaten 229 to the 141 not out he made in the first Test and averages more than 200 in the series. He is winning the Ashes for his country and his heavy scoring, consistency and thirst for runs are drawing comparisons with the greatest of them all, Sir

Donald Bradman.

Smith made his maiden century in the fifth Test against England in August 2013. Since then, he has taken his tally of three-figure scores to 22. No one else has made more than 17 in the same period.

In that timeframe, he averages 72.76. Of other batsmen to have played more than 30 matches in that period, only New Zealand captain Kane Williamson's 64.89 comes close.

Still, we're talking about a relatively small sample when you consider the history of Test cricket goes back to 1877.

So consider this: during his merciless torture of the England attack on Saturday, Smith raised his career average to 62.89 - better than all to have ever played the game, with the exception of Bradman. Among those greats Smith

has eclipsed: Sachin Tendulkar, Viv Richards, Len Hutton, Brian Lara and Jack Hobbs, to name a few.

The International Cricket Council has applied its ranking system historically, coming up with an all-

time list. Smith is fifth, behind Bradman, Hutton, Hobbs, Ricky Ponting and level with Peter May.

Birmingham named host city for 2022 Commonwealth Games

Birmingham has been named host city for the 2022 Commonwealth Games - the most expensive sports event to be held in Britain since the London Olympics.

The city's bid was the only one submitted to the Commonwealth Games Federation (CGF) by the deadline of 30 September, after it was chosen ahead of Liverpool as Britain's candidate.

The CGF initially deemed the city's bid was "not fully compliant".

However, it has now been confirmed as the

host of the £750m event.

West Midlands mayor Andy Street described the announcement as a "fantastic Christmas present for our region".

The bidding process has been beset with problems, with the South African city of Durban awarded the Games in 2015 before being stripped of the event because it did not meet the CGF criteria.

After Birmingham's bid was initially deemed to not meet the necessary criteria, previously interested cities such as Victoria in Canada

and Kuala Lumpur in Malaysia were given another two months to apply, but none came forward.

Birmingham's organisers will now move forward with plans to build the UK's largest permanent athletics stadium, supplemented by four indoor arenas.

The decision will also enable the council to pursue the purchase of land for the athletes' village in Perry Barr, one of the city's northern suburbs.

This will be the third time the Commonwealth

Games has been held in Britain since the turn of the century, after Manchester and Glasgow staged the event in 2002 and 2014

respectively.

The Games are expected to take place between 27 July and 7 August 2022.

Louise Martin,

president of the CGF, said Canada, Malaysia and Australia have all expressed interest in hosting the Games in 2026 or 2030.

Swans sack Clement

Swansea City have sacked manager Paul Clement with the club bottom of the Premier League, having won just three league games this season.

Clement, 45, took charge in January with Swansea in the relegation zone and guided them to a 15th-place finish.

Chairman Huw Jenkins said that changing the manager halfway through a season "was the last thing we wanted to do".

He said: "We felt we couldn't leave it any longer and needed to make a change to give the best chance of an uplift."

Swansea announced that assistant managers Nigel Gibbs and Karl Halabi have also left the

club.

The Welsh club says it will give a further update on replacement coaching staff "within the next 24 hours".

Before joining Swansea, Clement had worked as Carlo Ancelotti's assistant manager at Chelsea, Paris St-Germain and Real Madrid.

He had one, short-lived managerial stint at Derby County which ended in 2016 and he was then reunited with Ancelotti at Bayern Munich.

Clement joined Swansea on a two-and-a-half-year deal in January, becoming the club's third boss of the 2016-17 season following the departures of Bob Bradley and Francesco

Guidolin.

We had three different manager last season and as a result we all wanted to give Paul as much time as possible to turn things around," Jenkins added.

"Paul has been at the club for 12 months and what he achieved in the second half of last season to keep us in the top flight was a tremendous feat.

"For that, and his effort and commitment this season, it goes without saying that the club thanks him for his work, together with Nigel and Karl."

The Swans were bottom of the table when Clement took charge but he oversaw a remarkable escape from relegation after a strong end to the

campaign.

However, a summer of poor dealings in the transfer market sowed

the seeds for a dreadful start to the current term.

Last season's leading scorer Fernando Llorente

and player of the year Gylfi Sigurdsson were sold but not adequately replaced.

the visitors' dressing room as he made his way to post-match interviews.

A one-pint milk carton - which had been in the City dressing room for tea and coffee - was thrown at Mourinho. The United manager did not get splattered but a member of his staff was.

City's Brazil goalkeeper Ederson and Mourinho exchanged angry words in Portuguese - but Mourinho carried out his post-match media engagements as normal and made no mention of the row.

Arteta was left with a cut after he was hit by a plastic drinks bottle, but it is not known who threw it and sources from both clubs said no punches were thrown.

Afterwards, Manchester City manager Pep Guardiola said he was sorry if his side's celebrations had offended Manchester United, but that his players "have to enjoy

those moments".

"If we offended United - not just one player, not Jose-Manchester United, then I apologise," the Spaniard said.

"We have to enjoy those moments. If the people cannot understand that then I'm sorry. We won a derby.

"If we were not correct than I apologise to all of Manchester United. Our intentions was not that. It was to celebrate inside the locker room."

Mourinho, meanwhile, said the incident was "a question of diversity in behaviour, diversity in education".

The FA also asked the Manchester United boss to clarify comments he made before the derby.

In his pre-match news conference on

the Friday before the game, Mourinho said the referee needed to be aware of City's "tactical fouling".

Mourinho suggested City players go to ground easily, saying: "A little bit of wind and they fall."

He added that he did not think he would be allowed to make a political statement on the touchline like Guardiola, who has recently worn a yellow ribbon - a symbol of protest against the imprisonment of pro-independence politicians in the Spanish region of Catalonia.

But the FA said that, "following a review of the evidence provided by the club", it will take no formal action against Mourinho.

City 'will wait' on Sanchez bid

Manchester City remain keen on Alexis Sanchez but may wait until the summer before making another attempt to sign the Arsenal forward.

City had a bid accepted for the 29-year-old Chilean on deadline day in August but the move collapsed.

Blues manager Pep Guardiola has discussed transfer targets for the next 18 months with the club's hierarchy.

There are fears signing Sanchez in January could disturb the balance of Guardiola's table-topping squad.

It is understood City think Arsenal believe keeping the former Barcelona player was a mistake and would be willing to do business next month.

However, with Guardiola's side 11 points clear at the top of the Premier League, there is a feeling bringing in Sanchez then may cause disruption.

City and Arsenal agreed a deal for the striker in the summer, but it was dependent on the

Gunners replacing him.

When they were unable to sign Monaco forward Thomas Lemar, Sanchez's move was scuppered.

It is felt he still wants to work with Guardiola and, despite interest from Paris St-Germain among others, would join City at the end of the season, when he will be available on a free transfer.

With midfielder Yaya Toure's contract expiring in the summer, Guardiola would like to sign a defensive midfielder, a central defender and another attacker to take him through to the end of the 2018-19 season.

Talks have taken place over Southampton's Virgil van Dijk, while West Brom's Jonny Evans - who City were keen to sign in the summer - and Real Sociedad's Inigo Martinez are possible alternatives.

• **West Brom captain Jonny Evans** is set to leave next month after the club failed to persuade the Northern Ireland defender to sign a new contract.

Evans has 18 months on his present deal and it's understood he has no intention of extending his stay at the Hawthorns.

Manchester City, Arsenal and Leicester all expressed interest in the former Manchester United man in the summer.

The West Brom boss at the time, Tony Pulis, refused to do business because he did not have a replacement.

Despite the arrival of Alan Pardew, Evans, 29, has still not signed a new deal.

Unless that situation changes, it is understood West Brom will listen to offers, although given Evans' contract position, it is highly unlikely they will get the £30m fee it was hoped they would receive in the summer.

Pardew said: "I think you have to be realistic in these situations. Jonny is a top player, other clubs were interested in him in the summer. We know that and he knows that, we have to be intelligent and straightforward dealing with it."

Robins derail mighty United

BRISTOL CITY pulled off one of the biggest upsets in recent years in English football by knocking out holders Manchester United on Wednesday to reach the semi-finals of the Carabao Cup.

Korey Smith's turn and strike in the final minute of time added on booked a semi-final against Premier League leaders Manchester City.

After an even first hour, Joe Bryan's rasping left-foot strike across goal into the top corner gave the Robins a shock lead at a packed Ashton Gate.

Their advantage lasted just eight minutes, with Zlatan Ibrahimovic marking his first start since 20 April with a low free-kick past Luke Steele, before Smith struck.

There were jubilant scenes at the final whistle, with much of the sell-out crowd rushing on to the pitch in celebration and taking selfies with some of the City players.

Despite fielding a side showing 10 changes, United manager Jose Mourinho had recalled

Paul Pogba after a three-match ban and picked a forward line of Ibrahimovic, Marcus Rashford and Anthony Martial.

The visitors did carve out numerous opportunities from open play, with Ibrahimovic and Rashford both striking the woodwork before half-time.

But, despite clearly tiring towards the end, City continued to throw numbers forward and were rewarded with Smith's dramatic winner - making United the fourth Premier League side they have knocked out this season, after Watford, Stoke and Crystal Palace.

Mourinho, the most successful manager in the history of the competition, will rue a number of missed chances, even though the two sides were well-matched.

The visitors hit the woodwork twice before half-time, while Bristol City goalkeeper Steele produced two brilliant saves to deny Romelu Lukaku - brought on

with half an hour to go - a fourth goal in five games.

Rashford and Martial curled further efforts wide of the post either side of the break, while twice late on United failed to make the most of clear

openings on the counter-attack.

But they were never able to take full control of the tie as they would have hoped. They were harassed and harried in possession and, be

it through tenacious defending or sloppy play, were subsequently unable to sustain long periods of pressure.

United, 11 points adrift of leaders Manchester City in the Premier

League, will now likely look at the FA Cup and Champions League as their best hopes of silverware in 2017-18 - with this tie surely considered a missed opportunity.

FA: No action over United-City fracas

Manchester United and Manchester City will face no action over an incident that took place in the tunnel after the derby on 10 December, the Football Association has said.

United boss Jose Mourinho had water and milk thrown at him and City coach Mikel Arteta suffered a cut head during a post-match row.

The FA said it considered evidence from "clubs and independent eyewitnesses".

Mourinho will also not face action from the FA over his pre-match comments.

However, the FA

has reminded the Portuguese that any further public comments about match officials may result in disciplinary action.

The tunnel incident arose after what United viewed as an excessive celebration following City's 2-1 win at Old Trafford, which sent them 11 points clear at the top of the Premier League.

City's players celebrated in front of their fans after the final whistle.

After the players headed down the tunnel, it is understood that Mourinho made his feelings known outside
