Month of misery ahead as Nordic blasts tightens its grip

BRITAIN is facing a month of freezing temperatures as a frigid weather system maintains an icy hold on the country, forecasters have predicted.

Tuesday night marked the coldest night for six years in the UK with the mercury plummeting to -15C (5F) in places. Temperatures were so low in some areas that road grit failed to take effect. Swathes of the UK have been blanketed in snow and elderly people and those with poor health conditions have been warned to take extra care. Charities and safety

campaigners have now warned people to avoid going out for too long during the worst of the weather over the coming days and to stock up on essentials. The Met Office on Wednesday extended severe weather warnings for snow and ice across Scotland and northern and western Britain, while bookmaker Coral has slashed odds on this winter ending up the

coldest on record from 3-1 to 6-4.

And while Scotland, northern England and Wales saw heavy snowfall, the big freeze also caused travel mayhem further south. British Airways cancelled more than 80 short-haul flights to and from Heathrow because of the bad weather, including services to Manchester, Dublin, Edinburgh and elsewhere. More than

10,000 passengers were re-booked on other flights. A spokesman for the airline said: "We are sorry for any disruption to our customers' travel plans and will do all we can to minimise the effect the weather has on our operations."

Heavy snowfall also led to rush-hour chaos on transport networks. Kent Police urged drivers to take extra care after a spate of crashes on the M20 during heavy snow. James Madden, forecaster for Exacta Weather, said thermometers across

Britain would sink into double-minus figures over the next few nights. Public Health England has issued a level three cold weather health alert across England until Friday. It said: "Prolonged periods of cold weather can be dangerous, especially for the very young, very old or those with chronic diseases."

Dr Angie Bone, of PHE's Extreme Events team, added: "In events like this, it's possible that some people who are not in the best of health will stay at home, rather than risk venturing out in cold and

icy conditions, and this can lead to feeling more isolated than usual. That's why as this colder period continues we should all check in on those we know, whether they're friends, family or neighbours, who may be at risk, and offer to lend them a helping hand."

Malcolm Booth, of the National Federation of Occupational Pensioners, said: "We must not forget the risk of the cold to older citizens. "It is especially important to follow advice, keep warm and avoid going out in the worst of the weather."

May combats Tory rebellion with Brexit pledge

■ No customs union in our future, insists embattled PM

Theresa May has sought to pacify Eurosceptic colleagues within her party by categorically ruling out the idea of the UK remaining in any sort of customs union with the EU after Brexit.

The move followed reports that rebels were plotting to replace the beleaguered PM with their "dream team" of Boris Johnson, Michael Gove and Jacob Rees-Mogg. No. 10 will instead seek a looser form of customs arrangement. Yet EU officials insisted that Britain would face unavoidable trade barriers if it left the bloc's customs union. They also poured cold water on May's suggestion last week that EU migrants who came to the UK during the post-Brexit transition period wouldn't have the same residency rights as those already in place. The PM had said those migrants would have to be treated differently, insisting that Brexit supporters "didn't vote for nothing to change".

The pro-EU ex-business minister Anna Soubry said the Tory front bench was "in hock to 35 hard ideological Brexiters", and called on May to "get a spine" and sling them out.

"I'm not going to stay in a party," she said, "which has been taken over by the likes of Jacob Rees-Mogg and Boris Johnson."

'least worst option'

Britain's leading newspapers were divided on both sides, as usual, with **The Independent** scoffing at the prospects of 'the gang of three' being able to dethrone May. "It's odd to see Johnson, Gove and Rees-Mogg being touted as 'the dream team'" said the paper. "There are very good reasons why neither of the first two men won the Tory leadership election. That prize went to the party's 'least worst option', Theresa May – although even she has proved incapable of setting any clear Brexit goals. Not so, said the **Daily Mail**. The PM made it "patently clear" in two speeches last year that we would be leaving both the single market and the customs union. And she knows what she wants from the forthcoming trade talks: "a free-trade agreement with Europe and as close to frictionless borders as possible". Nobody is being sold out here. "So could over-excitable Tory Brexiters please just calm

down."

The PM will never be able to pacify the Brexit "ayatollahs", said Rafael Behr in **The Guardian**. They won't be happy until every thread connecting us to the EU has been cut. "It's said around Whitehall that even the most cavalier ministerial Leavers sobered up when they grasped the facts of the Irish border problem."

But nothing stops Rees-Mogg and other true believers "agitating for harder, faster rupture". May is in a fix, said Anushka Asthana in the same paper. On the one hand, there's no majority in Parliament for the sort of hard Brexit that Rees-Mogg et al want. On the other, there are more than enough of these rebels to hold her hostage.

The Irish border issue is threatening to derail the March EU summit at which the UK hopes to agree a transition deal and begin trade talks. The EU wants to publish a full legal text of December's interim, but that included ambiguities about Ireland that will be almost impossible to replicate in legal terms. "The fudge will not survive," said one senior EU diplomat.

The EU also wants to

have the legal power to punish the UK if it fails to abide by EU laws until December 2020, the scheduled end of the transition period. Sanctions for non-compliance could include curbs on cross-border financial services, airline operating rights or the free flow of goods to the EU27.

Scottish cops in stand-off with fluffy toy



You don't want to toy around with tigers, which is why police in Peterhead, Scotland, sprang into action Saturday night.

It started when local farmer Bruce Grubb called the North East Police to report the presence of a large fearsome cat with stripes on his farm.

"I got the fright of my life," Grubb told **The Scottish Sun**.

The creature appeared to be crouched on a ramp in Grubb's barn.

Officers immediately dispatched several vehicles, including an armed response team

to the farm. In addition, police contacted a nearby wildlife park to check if a tiger might have escaped, according to the BBC.

There was a 45-minute standoff before officers realized the tiger in question was just a giant stuffed toy, according to the **New York Post**.

Inspector George Cordinor told the BBC he was happy at how the responding officers handled the situation, and emphasized that Grubb wasn't a prankster.

"Our ultimate aim is to protect the public and keep our officers safe when faced with

uncertain situations. Until you know exactly what you are dealing with, every option has to be considered," he said. "We appreciate that it was a false call made with genuine good intent."

The North East Police had fun with the call on Facebook a few days later, saying "officers had a roaring shift on Saturday night."

In addition, UK Cop Humour, a Facebook page geared toward British law enforcement, had lots of fun with the incident by posting pictures of people in tiger suits that it claimed could be "negotiators."

Bulger mother's fury as son's killer is jailed for kiddie porn

■ Denise Fergus accuses justice system of 'collusion and cover-up' as Jon Venables is sentenced over new offences

The mother of murdered toddler James Bulger has accused the criminal justice system of "collusion and cover-up" after it emerged one of her son's killers was not prosecuted for breaching a ban on accessing the internet.

Jon Venables might still have been behind bars had the Crown Prosecution Service decided to prosecute him two years ago for breaching the terms

of a Sexual Offences Prevention Order (SOPO) preventing him going online.

Instead he was arrested in July last year on suspicion of possessing indecent images of children, including a paedophile manual downloaded from the internet on how to "have sex with little girls... safely."

Venables, now 36, was on Wednesday sentenced at the Old

Bailey to a further three years and four months (40 months) in prison after pleading guilty to downloading explicitly indecent images.

It emerged in court that in June 2015 the CPS had decided not to prosecute Venables for breaching his SOPO. It is further understood the Probation Service did not regard the offence as serious enough to warrant an immediate return to prison.

Instead he was simply cautioned, and remained on licence for an earlier offence of being in possession of dozens of hard-core indecent images of children and posing in an online chat room as a woman offering up her eight-year-old daughter for sexual abuse.

Two-year-old son James was tortured and murdered by the then 10-year-old Venables and Robert Thompson, also 10, after they abducted him from a shopping centre in Bootle, Merseyside, on February 12, 1993.

The two killers were sentenced to detention at her Majesty's pleasure and released on licence in 2001, at the age of 18.

James' mother Denise Fergus said on Wednesday: "We heard in court Venables breached his parole terms in 2015 by gaining access to the internet.

"However, we also heard this was covered up in that authorities dealt with him by way of a police caution rather than him being brought back to court for a breach of his parole."

Speaking through

Chris Johnson, of the Justice for James Campaign, Ms Fergus called for a public inquiry into the case, describing the earlier decision not to prosecute as "fundamentally wrong and part of a pattern of collusion between the authorities and Venables".

Police arrested Venables during a routine search of his home in the West Midlands in July last year, during which officers found his lap top hidden behind the head board of his bed.

An examination of the HP computer found a total of 1,170 indecent

images of children, with a third of them of the most serious nature, involving adults, including women, raping and abusing children aged 6 to 13.

Police also found a

manual downloaded from the 'dark web', which purported to offer advice to paedophiles on how to have sex with children as young as two without leaving physical marks.



Fergie 'to be invited to wedding' as Harry seeks to heal royal family rift

PRINCE Harry is to attempt to heal a family rift by inviting Sarah, Duchess of York, to his wedding to Meghan Markle.

The Prince's aunt will be on the guest list for the wedding at St George's Chapel, Windsor Castle, on May 19, it was reported this week – in spite of claims that she has been snubbed. The 58-year-old was not invited to the Duke and Duchess of Cambridge's wedding in 2011 and spoke afterwards about the hurt it caused her.

Harry, 33, is understood to be keen to avoid causing her further pain. The Prince is close to Princess Eugenie and her fiancé Jack Brooksbank and has maintained cordial relations with Eugenie's mother, who got on famously with Princess Diana. Nevertheless, the invitation for Sarah, who still shares a home with Prince Andrew despite their divorce, will still surprise many royal observers. Invitations have not yet been sent out. Someone else hoping for an invitation to the wedding, according to one unconfirmed report yesterday, is Geri Horner, who hopes the Spice Girls can launch their comeback by performing at the wedding. A source said: "She has been told that Meghan was a big fan of the Spice Girls." Kensington Palace declined to comment.

Trump rebuked for claim that NHS is 'going broke'

■ NHS chief and health secretary hit back at president's tweet

The head of the NHS goaded President Trump this week with an invitation to visit British hospitals so that he could see healthcare delivered at half the cost of the US system.

Simon Stevens intervened in a transatlantic spat which started when the US president tweeted that the NHS was "going broke and not working". Echoing comments made by Nigel Farage, the former Ukip leader, on Fox News Tuesday morning, the president wrote: "The Democrats are pushing for Universal HealthCare while thousands of people are marching in the UK because their U[niversal] system is going broke and not working."

Thousands demonstrated in London on Saturday over what they claim is an NHS funding crisis. The

march was organised by two pressure groups: the People's Assembly Against Austerity and Health Campaigns Together.

'brilliant doctors'

Mr Trump's remarks drew a rebuke from Jeremy Hunt, the health secretary, which was then supported by Downing Street. Mr Hunt tweeted: "I may disagree with claims made on that march but not ONE of them wants to live in a system where 28 million people have no cover. NHS may have challenges but I'm proud to be from the country that invented universal coverage — where all get care no matter the size of their bank balance."

Mr Stevens, chief executive of NHS England, told MPs: "Our invitation in the NHS, should the president be visiting later this

year, would be to spend time with the brilliant doctors, hospitals, technology experts, scientists; hear about the cataract services, the hip replacements, the modern scanners, the world-first liver, heart and lung transplant, the genomic revolution, all under way here in the NHS, and go away understanding that healthcare for everybody delivered at half the cost of the US healthcare system is something people in this country are deeply and rightly committed to."

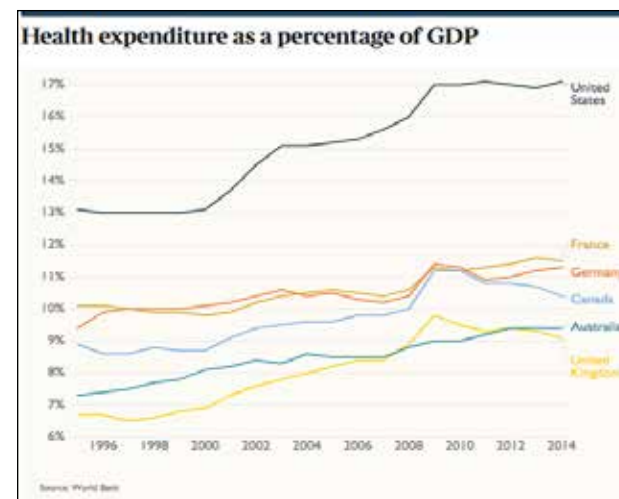
Mr Trump is expected to visit the UK this summer. He cancelled a trip in the new year, saying he disagreed with the relocation of the US embassy, which he was due to open.

that more women are dying of pregnancy-related complications in the US than in any other developed country: there are 26.4 deaths per 100,000 live births, according to a recent investigation that put the UK rate at 9.2 deaths per 100,000 live births. In 2014, average life expectancy at birth in the US was 78.8 years, compared with 81.4 years in the UK.



Britain's earliest inhabitants were black, latest research shows

■ DNA testing reveals 'Cheddar man' was blue eyed and dark-skinned

The people who lived in Britain 300 generations ago were black, new research has suggested.

DNA tests on the oldest complete skeleton discovered in Britain indicate that he had "dark to black" skin and blue eyes.

Cheddar Man, who died in his 20s about 9,000 years ago, has been described as the first modern Briton as he marked the start of continuous habitation of the island. All previous human populations who attempted to settle in Britain had been wiped out, and modern-day Britons are descended from the same pool of people as he was.

The research by the Natural History Museum and University College London is the first attempt to pinpoint the skin tone of Britons from the Mesolithic era using DNA.

It suggests that lighter skin pigmentations did not develop among northern Europeans until much later than thought. Past representations of Cheddar Man, whose skeleton was found in a Somerset cave in 1903, depicted him as white.

The research also challenges assumptions around British ethnic identity. Yoan Diekmann, of UCL, said: "What may seem a truth - that people who feel British should have white skin - through time it's not at all something that is an immutable truth."

skin pigments

The study builds on findings that suggest southern Europeans had darker skin pigments up to 7,000 years ago. Humans in areas with relatively low levels of sunlight developed lighter skins to

absorb more Vitamin D, scientists believe.

Iain Mathieson, assistant professor of genetics at the University of Pennsylvania, who did not work on the project, said the findings were in line with studies suggesting the emergence of genes linked to lighter skin. Researchers also established that Cheddar Man was not related to earlier humans whose remains were in the same caves. They are thought to have practised cannibalism.

In addition to his "dark to black" skin pigment, researchers are now confident that Cheddar Man had striking blue eyes, gently curled black hair, wide cheekbones and a delicate chin. He stood 5ft 5 in tall and had an excellent set of teeth.

"It's that combination of features that make him look not like anyone that

you'd see today," said Ian Barnes, an expert in ancient DNA at the Natural History Museum. "Not just dark skin and blue eyes, because you can get that combination, but also face shape."

Cheddar Man's people are thought to have come to Britain about 11,700 years ago, crossing Doggerland, which once connected the country to continental Europe.

Although humans are known to have lived in Britain far earlier - at least 900,000 years ago - all previous colonisations had died out, meaning the new arrivals were exploring virgin territory.

The tribes were hunter-gatherers who made harpoons to spear fish and used rudimentary bows and arrows to kill red deer and wild boar. They are thought to have fanned out across the south and

Midlands. Academics estimate that the total population of Britain at this time of the Mesolithic period was just 12,000.

Cheddar Man's skeleton was discovered more than a century ago in Gough's Cave in Cheddar Gorge, Somerset.

Well preserved by the cool limestone surroundings, the bones were transferred to the Natural History Museum for public display until recent breakthroughs in DNA sequencing made it possible to unlock their secrets.

In a joint project between the museum and University College London (UCL), filmed for a Channel 4 documentary, researchers drilled into his skull to obtain bone powder that could be tested for DNA.

The results were combined with high-tech skull scans to reconstruct Cheddar Man's face using 3D printing. The model makers, Adrie and Alfons Kennis, from the Netherlands, stressed that their creation was an interpretation rather than a portrait, but was rooted in scientific data.

Most valuable British car ever to be auctioned

The most valuable British motor car ever to be offered at a European auction has been unveiled at the Bonhams Grand Palais sale in Paris.

Understood to be worth up to £15m, the 1961 Aston Martin DB4 GT Zagato "2 VEV" is an exceptionally rare car racing version of an already-rare sports car. A total of 19 of this model were produced, but "2 VEV" is one of just two lightweight cars optimised for competition.

It has a slightly different silhouette to the 'normal' DB4 GT Zagato, with a lowered roof line, Frenched headlights and different wings to make it more streamlined.

Jim Clark most notably drove '2 VEV' to confront the all-conquering Ferraris in the RAC Tourist Trophy race at Goodwood in both 1961 and 1962. He brought the car home fourth behind contemporary team leader

Roy Salvadori's sister car '1 VEV' in the 1961 race, but in 1962 he became involved in a multi-car accident. Just after re-joining the race following a pit stop, the future World Champion spun at Madgwick Corner in the path of race leader John Surtees's Ferrari 250 GTO. The two cars collided and crashed into the safety bank, only to be joined a few laps later by Robin Benson's Ferrari 250 GT SWB which careered into both of them. The scene, involving three of the most valuable 1960s motor cars in today's market, has become one of the most celebrated images in motorsport.

The car later achieved success in historic racing throughout the 1980s-90s campaigned by Roger St John Hart and then, for the family, by prominent Aston Martin Owners' Club personality Nick Cussons. It remains in track-ready condition.

A growing number of Britons are taking up "plogging" to tackle the menace of litter. A fitness trend that originated in Sweden, it involves simply going for a run with a sack and filling it with rubbish as you go. Ploggers have been spotted as far afield as Thailand and are now being seen all over the UK. A hero of the movement is the US humorist David Sedaris, who has picked up so much litter on walks around his home in West Sussex, he has a rubbish truck named after him.

Ian Anderson does not live in a typical rock star party pad.

Home for the Jethro Tull frontman is an 18th century manor house in Wiltshire, with an elegant interior. He is, of course, not a young man any more – but he insists the stories of rock 'n' roll wild men were always "a fabrication, part of the razzmatazz of showbusiness. Even Alex Harvey, who admittedly sometimes went on stage covered in blood after some dressing room spats, was a sweetie really."

Anderson still makes music, and he used to run a fish farm business turning over £12m a year, says Fred Redwood in *The Daily Telegraph*. He's well off – but he could have been a lot richer had he paid less in tax.

"Bonio, or whatever his name is, said stashing his cash overseas was just down to smart people he has

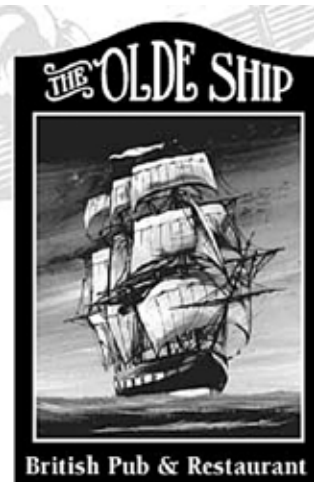
working for him trying to be sensible," he says, with barely concealed disdain. "So I take it I'm not smart and sensible. Ah well, nobody's

perfect. I paid tax at 83% in the 1970s, and although I was advised to move to Switzerland, I stayed here. I don't regret it. I'm proud to

pay tax at 50%. I think of it as half for me and half for the NHS, schools and all the other things we need to function as a society."

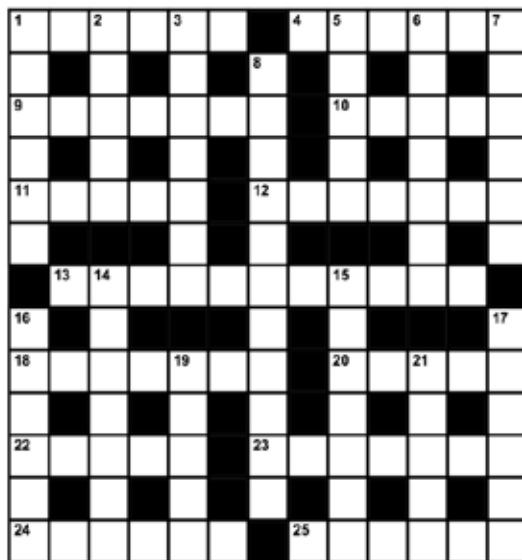

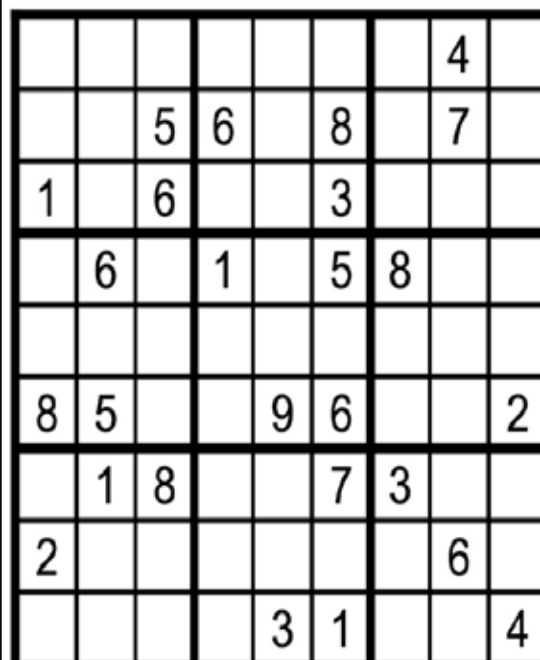

The Sea Before Us: dive right in



Exclusive interview with Sarah Sundin, discussing her new novel, a WW2 romance between an American naval officer and a British Wren

SARAH SUNDIN'S latest novel, *The Sea Before Us*, is an absorbing tale of a wartime love affair between American officer Wyatt Paxton and British Wren Dorothy Fairfax. In a recent interview Sundin told us how her love of Britain started young.

"I was one of those teenagers who woke up in the middle of the night to watch Charles and

Diana's wedding," says Sundin. "I'm a lifelong Anglophile. Raised on British books and movies. British history has depth and breadth lacking in U.S. history. That legacy appeals to me."

"In *The Sea Before Us*, I played with these historical differences.... While exploring town, Dorothy comments on the new buildings, and Wyatt realizes they're older than anything in his hometown in Texas."

Lt Wyatt Paxton is an American naval officer in 1944 London working on the Allied invasion of France. Dorothy Fairfax is in the Women's Royal Naval Service. Using family photos, she is

piecing together a map of Normandy. Wyatt's plan is to use the map to pick targets to bomb on D-day. As they work together they become friends. Will Wyatt's plans destroy Dorothy's family estate?

"When I was doing research on the US Navy in World War II for my *Waves of Freedom* series, I read about the naval aspect of D-day," says Sundin. "I was fascinated by the daring actions of the U.S. destroyers off Omaha Beach. The *Sunrise at Normandy* series tells of three estranged brothers who fight on D-day from the sea, the air, and the ground. In *The Sea Before Us*, I was able to put my hero,

Wyatt Paxton, on one of those destroyers and also have him involved with D-day planning in London, where he works with my heroine, Dorothy Fairfax."

All of Sundin's novels are set during World War II. She has researched the naval aspects and planning of D-day, the Women's Royal Naval Service, and life in Britain during World War II. On a trip to England and Normandy she toured Southwick House, Adm. Sir Bertram Ramsay's Allied Naval Headquarters for D-day, the location where Gen. Dwight Eisenhower made his famous decision to launch the invasion on June 6th,

1944.

The Sea Before Us is the first book in Sundin's fourth series. Her *Wings of Glory* series is about B-17 bomber pilots based in England. *Wings of the Nightingale* is flight nurses in the Mediterranean. *Wave of Freedom* is U.S. naval officers based in Boston fighting in the Battle of the Atlantic. Her novels *Through Waters Deep* and *When Tides Turn* were named to Booklist's 101 Best Romance Novels of the Last 10 Years. *Through Waters Deep* won and INSPY award and was a Carol Award finalist.

Sundin recently finished writing her second book in the *Sunrise at Normandy*

series. *The Sky Above Us* follows a P-51 fighter pilot and a Red Cross volunteer. Sundin is starting the third book in the series, *The Land Beneath Us*.

At peace with his past and passionate about his present and future, pop veteran Nick Heyward has found contentment with his place in music history.

The former frontman of Haircut 100 says, "I'm not Mozart and I'm not Prince, but I do what I do at the level I do and I'm

doing what I love."

Having won widespread critical acclaim for his most recent solo album, Woodland Echoes, it's the old hits that have brought Nick to the Los Angeles area in recent days for a pair of sold out local 80's concerts sharing the bill with contemporaries such as Boy George and A Flock of Seagulls.

He still enjoys performing the likes of Love Plus One and Fantastic Day, explaining, "I genuinely love singing those songs. It's an honour to do so. People connect with certain music, art resonates, and I know as a fan myself that's a powerful thing."

Trim and still boyish at 57, he doesn't look too much older than he did in his days of Top of the Pops appearances – and that's largely down to careful weight management. "Something happens to English people when abroad," he adds. "You become more English, your accent becomes more English. Sarah will say to me things like

"That's such an English thing to do."

With his love life and work life going well, another source of joy is that Nick's son Oliver, from his first marriage, has followed him into the music business and works as a sound engineer, including on his Woodland Echoes album. "I prayed for a situation like this and he's really good," says Nick, who revels in the creativity and freedom of life as an independent recording artist.

"With the emergence of the internet you

can make music at home now, away from the sometimes sterile environment of a recording studio, be inspired by the environment around you, and share your work on social media."

The message Nick wants to share is simply this, "Do what you love. And if you don't love what you do, change the way you think about it and suddenly there's a new opportunity to feel fulfilled."

Confirmed! Spice Girls set for BIG comeback!

Hoorah! Spice Girls fans all over the world rejoiced when the famous five-piece came together at Geri Horner's home last Friday afternoon.

Oo-er!

And on Monday, Emma Bunton opened up about their shock reunion, teasing that there's lots "exciting things to come" for the ladies. Emma admitted that they had to make last-minute plans, opting to meet at Geri's house in Hertfordshire rather than somewhere in central London.

In a recent interview Emma divulged: "At first, actually, it was supposed to be at a hotel. But the morning of the meeting there was quite a lot of press speculation and we thought 'Oh, maybe we need to go somewhere a bit more private.' Geri's was the nearest so we were like, 'We're coming to yours!'"

The mum-of-two confessed that it was a "lovely afternoon" of catching up, saying: "Obviously, we've seen each other individually, but actually all together

in one room was at the Olympics. It was just like, Friday, we thought we would all catch up, everyone was in town, let's do this, let's catch up."

She added: "But I don't think any of us were expecting, we had such a lovely afternoon. We sat down, we had lunch together, we sat round."

The girl group—Emma, Victoria Beckham, Mel B and Mel C—propelled to worldwide fame in the nineties, and sold more than 31 million copies of the debut album, *Spice*. They released their debut single *Wannabe* in 1996 and last year celebrated two decades in the spotlight.

Elaborating further about their reunion, Emma continued: "We reminisced about the old times, we were talking about the kids, and it was lovely. And then we all sat around Geri's table and we got takeaway in, got sushi and some salads and drank tea and a little bit of prosecco, and it was just so lovely to see everyone. I loved it, really good fun."

Earlier this week ginger Geri revealed she had all but given up on a band reunion after plans for an anniversary tour in 2016 stalled.

Ginger Spice, who hosted the top-secret get together where she and her bandmates

reportedly thrashed out plans for a tour and other business ventures with their old manager Simon Fuller.

And she still can't believe Fuller pulled off the shock reunion, almost six years after the Spice Girls last performed together at the closing ceremony of the 2012 Olympics in London.

Geri told *The Sun* she felt sure any hope of a tour was dashed when plans to hit the road to celebrate the 20th anniversary of the release of *Wannabe*, the group's breakout single, fell apart.

"We all pushed for it, like, 'Come on, let's try and make it happen'. It didn't," she tells the tabloid. "You get to a

point where you go, 'Do you know what, just let it go...' And I was having a baby. I'd really sort of let it go."

Geri turned to a career as a British TV personality, but now the Spice Girls reunion is all she's thinking about: "When it finally came together the other day, we all came and sat around and went, 'Maybe we should do something'. And we all agreed."

"It was really nice to reflect on the past. Then we looked at the new generation as well and thought, 'We should think about them. That's important to us'."

And even though she was the first one to quit the band in the late

1990s, Geri insists she has never fallen out with her bandmates: "Regardless of whether we were in a band singing together, I still want to know that they're happy and well and support them individually or collectively. I really do care about them."

"We've had so many amazing memories. Whatever we decide to do, however it unfolds, it will be something joyful and very connective."

Reports suggest the Spice Girls are close to finalizing details for a tour of Britain and America, which will begin at the end of the summer.

I'm looking forward to this one, I for one will be front row and center!

Struggling Conte ‘at the brink’

Antonio Conte’s precarious position at Chelsea “is the nature of the beast” under owner Roman Abramovich, says former midfielder Andy Townsend. Chelsea suffered a second consecutive league loss at Watford on Monday and are fourth, 19 points off the pace. Conte guided the Blues to the title in his debut season but his future has repeatedly been questioned this term. But multiple sources indicate that the club being in the top four, Champions League and FA Cup means Conte will not be sacked

imminently. Furthermore, his position was not discussed following the Watford defeat, after which the Italian gave his players three days off. Townsend said the way things are done at Chelsea means “we are starting to think about a manager on the brink”. Speaking on BBC Radio 5 live, he added: “I don’t think he should be and I honestly don’t think the players want to see the back of him. “It does not seem five minutes ago that they seemed united and the

spirit was unbreakable between manager, owner and players and everything was rosy in the garden.” After the Blues’ second straight three-goal defeat, the manager said “the club have to take another decision” if they think he is not doing a good enough job. Conte has received the backing of captain Gary Cahill and goalkeeper Thibaut Courtois, who said “we believe in him and we believe in our team” after the 4-1 defeat by Watford. Monday’s defeat followed a 3-0 home loss to Bournemouth, to leave Chelsea with just two wins in 10 games this year. “Clearly there is something wrong and something going on in the corridors of power that the manager does not like, but if you go to war with Abramovich, you lose, there is only one winner,” said Townsend. “I think Antonio Conte is a diligent manager and I think he has shown he can get the best out of good players, and I believe he is the right man to continue at that club.”

60 years on: victims of Munich tragedy are remembered

IN an echo of the Munich air disaster sixty years ago, snow fell at Old Trafford on Tuesday as Manchester United stars past and present gathered to remember the victims.

On February 6, 1958, eight of Sir Matt Busby's promising youngsters died when their plane crashed on the ice-packed runway of Munich-Riem Airport. From that doomed team of would-be champions, only Sir Bobby Charlton, now 80, and goalkeeper Harry Gregg, 85, still survive. But this week over 5,000 fans, the playing staff and ex-stars including Denis Law, 77, sang hymns, heard psalms and chorused along to the moving poem *The Flowers Of Manchester*. At 3.04pm – the time of the disaster – all eyes were drawn to Sir Bobby's haunted expression as the names of his lost team-mates echoed throughout the East Stand. Behind him, sporting a black Man United baseball cap, Northern Irishman Gregg wiped away tears with a handkerchief.

'grief and anguish'
United club chaplain Rev John Boyers told the crowd: "We are gathered here at Old Trafford and linked to so many people in varied locations. There are many thousands throughout this city, around our nation and in countries across the world who join in solemn remembrance of the tragedy on a slush-covered runway.
"When Munich happened a wave of grief and anguish swept though the nation and in Manchester united all, United and City supporters alike. It mattered not if you were Red or Blue, they stood together, wept together

and mourned together."
Former manager Sir Alex Ferguson and United director Michael Edelson both gave readings from the Bible while club executive vice-chairman Ed Woodward read "We Will Remember Them".
The trio all wore matching commemorative ties featuring names of those who perished in Munich. United manager Jose Mourinho joined club captain Michael Carrick to lay wreaths at the end of the service. Events commemorating the 60th anniversary were also held in Munich and Belgrade.
The Babes were flying back from a European Cup tie against Red Star Belgrade when they

landed at Munich to refuel. Captain James Thain aborted two take-offs but when he tried a third time at 3.04pm, disaster struck. Twenty-three of the 44 on British European Airways Flight 609 were killed or later succumbed to their injuries. They included Busby Babes Geoff Bent, 25, Roger Byrne, 28, Eddie Colman, 21, Duncan Edwards, 21, Mark Jones, 24, David Pegg, 22, Tommy Taylor, 26, and Billy Whelan, 22. Eight newspaper journalists, Alf Clarke, Donny Davies, George Follows, Tom Jackson, Archie Ledbrooke, Frank Swift, Eric Thompson and Daily Express reporter Henry Rose, also died in the tragedy.



Suspended sentence in tax case for Sanchez

Manchester United striker Alexis Sanchez (above) has accepted a 16-month suspended jail sentence for tax fraud in return for avoiding a trial.
The ex-Barcelona player faced going to trial in Spain over unpaid taxes amounting to around 1m euro (£886,000).
The unpaid taxes derive from image rights deals in 2012 and 2013.
When Sanchez, 29, was first accused in 2016, his agent said the Chile forward had "fully obeyed" laws and his

image rights income "has been declared".
Sanchez, who joined United from Arsenal last month, is rumoured to be the highest paid player in the Premier League following the transfer, earning £14m a year after tax.
He is one of a number of high-profile players to have fallen foul of the tax laws in Spain.
Last month, Real Madrid's Croatia midfielder Luka Modric paid Spanish fiscal authorities close to 1m euro to settle his own image rights tax case.

Barcelona's Lionel Messi and Real Madrid's Cristiano Ronaldo have also faced tax charges in recent years.

Spurs finally outclass minnows

Tottenham Hotspur cruised into the fifth round of the FA Cup with a comfortable 2-0 victory over League Two side Newport County at Wembley Wednesday night.

Spurs needed a late Harry Kane goal to rescue a 1-1 draw in the first meeting, but never looked in danger in the replay once Moussa Sissoko's cross diverted in off Newport's Dan Butler.

A fine finish from Erik Lamela gave Mauricio Pochettino's side a comfortable advantage at the interval that they never looked like surrendering.

There are 75 places between Spurs and the Welsh side but there were no scares for the hosts this time around with the gulf in class obvious as the Premier League side strolled through to a fifth-round visit to Rochdale.

Newport showed tremendous resilience to keep the score down, but did not manage a shot on target until the final seconds when Padraig Amond shot straight

at Spurs keeper Michel Vorm.

Spurs made 10 changes from the side that drew at Liverpool on Sunday and left a lot of big names on the bench - but there could be no accusing the hosts of taking the threat of Newport lightly after their scare at Rodney Parade.

They left their talisman Kane on the bench, with Christian Eriksen also out of the starting XI, but there was no mistaking the quality coming into the side with Lamela, Sissoko and Fernando Llorente all recalled and Son Heung-min retaining his place.

They were able to recall defender Toby Alderweireld for the first time since their win over Real Madrid on 1 November, and England left-back Danny Rose also returned for his first appearance since Boxing Day with Tottenham heading into the final stretch of the season largely injury free.

Newport goalkeeper Joe Day also made several excellent stops to deny Eriksen and Lamela,

while Llorente might have had a hat-trick on another night as Spurs failed to show a clinical touch.

Tottenham's 26th-minute opener shortly before the half-hour mark was cruel on County, with Sissoko firing in a shot that struck Butler and totally wrong-footed Joe Day in the County goal.

The contest was effectively over eight minutes later after more bright work from Son who teed up Lamela to finish smartly from close range, and only a brilliant double-save by Day prevented Spurs going into the interval out of sight.
