NHS LEFT STUNNED BY BREAST CANCER GAFFE

Screening blunder may have caused up to 270 deaths

THE NATIONAL HEALTH Service has been engulfed by one of the worst scandals in its history as it emerged that an IT error meant 450,000 patients in England missed crucial breast cancer screenings – which may have caused the deaths of as many as 270 women.

Families now face the distressing possibility that loved ones who have recently died from breast cancer may have missed opportunities for early diagnosis. Women receiving breast cancer treatment, including those with a terminal diagnosis, may also receive letters informing them of missed screenings in the coming months.

The government has ordered an independent inquiry into the scandal, which Public Health England (PHE) only unearthed in January after almost a decade of errors, Health Secretary Jeremy Hunt announced this week.

He said between 135 and 270 women “may have had their lives shortened as a result” of the missed letters, which were due to be sent out automatically to older women registered with

their GPs.

He said the numbers may be considerably lower, but that statistical modelling suggested there were “likely to be some people in this group who would have been alive today if this had not happened”.

Hunt told the House of Commons that because of a computer algorithm failure an estimated 450,000 women aged between 68 and 71 were not invited to their final breast screening between 2009 and the start of 2018.

‘incredibly distressing’

He said the error was a serious failure of the screening programme.

He apologised “wholeheartedly and unreservedly for the suffering caused”, and said: “Tragically there are likely to be some people in this group who would have been alive

today if this failure had not happened.”

Of the women who missed screenings, 309,000 were still alive and would be contacted before the end of May, and the first 65,000 notifications would be sent out this week, Hunt said.

The letters will tell women under 72 that they will automatically be sent an invitation for a catchup screening, and those 72 and over will be given access to a helpline to decide whether a screening is appropriate, he said.

Hunt said his department would contact the families of women who had died of breast cancer and who believed they had missed a screening, to apologise, and offer a process to establish whether the missed scan led to shortening of their life. “We recognise this will

be incredibly distressing for some families,” he said.

Family members would have their concerns investigated and compensation may be payable if the error is found to have led to an earlier death, he said.

Many families will be “deeply disturbed by these revelations,” Hunt said, especially those recently diagnosed with breast cancer or those who were recently

bereaved. “For them and others, it is incredibly upsetting to know that you did not receive an invitation to screening at a correct time and totally devastating to hear you may have lost or be about to lose a loved one because of administrative incompetence.”

The issue came to light because of an upgrade to the IT system for the breast screening invitation programme.

Dr Jenny Harries, PHE’s deputy medical director, said the body was “very sorry for these faults in the system”.

She said: “We have carried out urgent work to identify the problem and have fixed it. Additional failsafe systems have been introduced to ensure the problem does not reoccur.”

Rudd pays price for Windrush fiasco

Home Secretary quits; replaced by Communities Secretary Sajid Javid

Amber Rudd has resigned as home secretary, saying she "inadvertently misled" MPs over targets for removing illegal immigrants.

The Windrush scandal had heaped pressure on Ms Rudd, who faced renewed criticism after saying she did not know about Home Office removals targets.

She was swiftly replaced by Communities Secretary Sajid Javid, the son of Pakistani immigrants and a former hedge fund manager in The City of London. Prime Minister May said she was "very sorry" to see Ms Rudd go.

'misleading Parliament'

Shadow home secretary Diane Abbott said Ms Rudd had "done the right thing" but added that the "architect of this crisis" - the prime minister - must come before the Commons to explain "whether she knew that Amber Rudd was misleading Parliament and the public last week".

Ms Rudd told MPs last week the Home Office did not have targets for removing

illegal immigrants, but on Sunday the *Guardian* published a letter in which Ms Rudd set out her "ambitious but deliverable" aim to deport 10% more illegal immigrants over the "next few years" to Theresa May.

Ms Rudd is the fourth person forced to resign from the cabinet in the last six months - following Sir Michael Fallon, Priti Patel and Damian Green.

Transport Secretary Chris Grayling denied the government was in chaos, telling BBC Radio 4's Today the spate of recent resignations were "unwanted noise" but there were always "up and downs" in politics.

Ms Rudd, who had been due to make a Commons

statement on Monday afternoon, telephoned the prime minister on Sunday evening to tell her of the decision amid intensifying opposition demands for her to quit.

In her resignation letter, Ms Rudd said she took "full responsibility" for the fact she was not aware of "information provided to (her) office which makes mention of targets".

In response, Mrs May said she believed Ms Rudd had given her evidence to the Commons "in good faith" but that she understood her decision to resign and take "responsibility for inadvertently misleading the home affairs select committee".

She should "take

great pride" in what she achieved at the Home Office, Mrs May added.

The controversy began when it emerged that some migrants from Commonwealth countries, who were encouraged to settle in the UK from the late 1940s to 1973, were being wrongly declared illegal immigrants.

"honest and principled"

Ms Rudd came under fire for the government's treatment of these people - known as the Windrush generation - and their relatives and the wider impact of its "hostile environment" policy designed to deter illegal immigration.

She told MPs last Wednesday there were no removals targets

for illegal immigrants - comments subsequently contradicted by a 2015 inspection report. She later admitted "local" targets for voluntary removals had been set but she told the Commons on Thursday she had not been aware of them.

But the *Guardian* reported a June 2017 memo from an official, copied to Ms Rudd, that referred to targets. The newspaper also published a letter at the weekend, from January 2017, where Ms Rudd told Theresa May about plans to restructure her department and increase removals "over the next few years".

Sources told the BBC that on Saturday and Sunday Ms Rudd and her officials did a thorough

search of all documents and found other references to operational targets which she felt she should have been aware of.

Conservative MPs paid tribute to their colleague.

Leader of the House Andrea Leadsom called Ms Rudd "honest and principled" while Foreign Secretary Boris Johnson said she had done "a great job during last year's terrorist attacks and cares deeply about the people she serves".

Labour MP David Lammy said the home secretary had quit because she "didn't know what was going on" in her department and she had clearly "lost the confidence" of her officials.

designed to find out whether extra screening would protect older women from breast cancer.

Set up in 2009, the AgeX trial ran in 65 breast cancer units across England, but a computer glitch meant women randomly selected for the trial had their final routine screenings before their 70th birthday cancelled. Half will then have had additional screenings as part of the

trial, but half will not, totalling an estimated 450,000 women.

The inquiry is likely to raise questions for Labour, under whom the IT errors occurred, as well as for the Conservatives as to why the glitch was not picked up sooner.

The inquiry will be chaired by Lynda Thomas, the chief executive of Macmillan cancer support and Prof Martin Gore, consultant medical oncologist at the Royal Marsden. It will review the entire breast screening programme and report back in six months.

Jonathan Ashworth, the shadow health secretary, said Hunt must give assurances that checks were being carried out to make sure that no one was missing out on screenings for other cancers. "Eight years is a long time for an error of this magnitude to go undetected," he said, adding that ministers must investigate whether early warning signs were missed.

Labour MP Lisa Nandy said she had concerns about whether overstretched NHS screening services would be able to meet the extra demand.

“Eyes of the world” on Scotland, claims Sturgeon as minimum alcohol pricing is introduced

■ **“Bold and brave” policy is expected to save hundreds of lives**

Nicola Sturgeon said the “eyes of the world” were on Scotland this week as minimum pricing of alcohol is finally introduced on Monday after a six-year court battle.

The First Minister said the “bold and brave” policy is expected to save hundreds of lives over the next five years in a radical approach to tackle Scotland’s “troubled relationship” with drink.

But opponents claim that it will mean “drastic

increases” for Scots drinkers and the public have been misled over suggestions that only strong lagers and ciders will rise in price. The new minimum price of 50p per unit of alcohol means a bottle of vodka will now cost at least £13.13 and whisky would cost at least £14. The measure is backed by all political parties at Holyrood and medical leaders in Scotland.

The plans were first passed by the Scottish Parliament in 2012, but

were delayed after a legal challenge by the Scottish Whisky Association (SWA) which was finally kicked out by the Court of Session last year. Alcohol misuse costs Scotland £3.6 billion each year. As a nation Scots drink 40 per cent more than the low-risk drinking guidelines of 14 units per week for men and women.

‘clear and proven link’

Ms Sturgeon said on Monday: “I am extremely proud that the eyes of the

world will once again be on Scotland with the introduction of this legislation. “Our action is bold and it is brave, and shows once again that we are leading the way in introducing innovative solutions to public health challenges.

“Given the clear and proven link between consumption and harm, minimum unit pricing is the most effective and efficient way to tackle the cheap, high strength alcohol that causes so much damage to so many families.”

Deaths through alcohol misuse in Scotland are 54 per cent higher than England and Wales and six times higher in the country’s most deprived areas. It is now estimated that 392 lives will be saved in the first five years of implementation, according to government research. The British Medical Association (BMA) says there is a “proven link” between alcohol price and consumption and has been a vocal backer of the minimum pricing.

said: “Minimum unit pricing is a policy that will help to save lives and reduce alcohol harms in Scotland. It will help to reduce the burden of alcohol on our health service, on Scottish society, and most importantly on individuals and their families. “This is an important milestone for Scotland, and many

other parts of the world will now be watching the implementation of minimum unit pricing with great interest.”

But opponents say that alcohol consumption in Scotland is already falling and question what further impact minimum pricing will have.

Bulgers bid to end Venables anonymity

CHILD killer Jon Venables could lose his secret identity after James Bulger’s father this week began a legal challenge to his right to anonymity.

Ralph Bulger joined with his brother Jimmy to claim at the High Court that Venables should be stripped of his name because he has reoffended. But Denise Fergus, the mother of the two-year-old victim, has said she fears vigilante action if Venables is unmasked.

Ms Fergus, 50, who is not involved in the case, said in a statement: “I understand the motivation for the application, but my concern is that if Venables were known by his own name, it could lead to vigilante action and innocent people being hurt.”

The case is being considered by Sir James Munby, the most senior family judge in England and Wales. He has given the legal team a month to prepare the case. The application is to vary or discharge an injunction,

originally granted in 2001, which “prevents identification of the person previously known as Jon Venables”.

Mr Bulger and his brother are represented by solicitor-advocate Robin Makin, who said that he needed material dating back up to 19 years to prepare his case. He said the injunction was granted on the basis that Venables was rehabilitated. But he had since been convicted on two separate occasions, most recently in February. James was kidnapped

and murdered by 10-year-olds Venables and Robert Thompson after they snatched him from a shopping centre in Bootle, Merseyside, in February 1993. They led him to a remote railway line where they tortured and then beat him to death. The killers were later granted lifelong anonymity by a High Court judge and following their release were given new identities. But Venables has since been convicted and sent back to jail over indecent images of children.

£1m home bonanza as price boom rolls on

SALES of homes costing £1million or more are soaring to record numbers across Britain, a survey has found.

Areas far from London and its traditional commuter belt are recording the biggest rises as the property boom pushes more houses into the top end of the market.

The number of properties which sold for at least seven figures in England and Wales rose by six per cent in 2017 to 19,100, according to Land Registry data.

The increase, fuelled by growing demand in regions where prices are traditionally lower, came despite a rise in stamp duty for more expensive properties.

The biggest annual increase in £1million-plus sales came in Yorkshire (40 per cent), followed by the North-west (36 per cent) and the West Midlands (19 per cent).

A total of 18 local authorities outside London recorded 100 or more such transactions in the last year, up from 14 in 2016.

Elmbridge in Surrey was the area which saw the biggest boom, where 22 per cent of homes sold for more than £1million.

The East of England saw annual house price growth of 5.2 per cent in 2017. And the most active prime markets were in St Albans, Epping Forest and Cambridge.

In the North-west, Cheshire East enjoyed a 38 per cent rise in £1million-plus sales compared to 2016.

Other areas with year-on-year rises included Cheltenham, North Hertfordshire and

Birmingham. An increase in prime market activity has come alongside strong annual house price growth in each of these areas, up 8.1, 6.1 and 5.5 per cent respectively – a factor that will have helped push a number of properties over the £1million threshold.

Despite the growth in the regions, London still accounted for the majority of Britain's million poundplus sales last year.

A huge 64 per cent of all properties sold in swish Kensington and Chelsea changed hands for seven-figure sums, along with 51 per cent in Westminster. The two London boroughs were the only parts of England and Wales in which more than 50 per cent of properties sold for more

than £1million.

Oliver Knight, of estate agents Knight Frank which analysed the figures, said: "The rise in £1million sales volumes in the

past 12 months points to some relatively active prime markets across the country, even with higher stamp duty.

"And the pick-up

in transactions hasn't taken place in a uniform manner. The most notable rises came in markets outside of London and the traditional commuter zone."

lifestyle economics at the Institute of Economic Affairs, said: "Shoppers in Scotland will see drastic increases in the price of their favourite drinks. "It will become clear that minimum pricing is not a targeted measure that will only affect a few strong ciders.

"The public has been misled about this policy from the outset. Back-of-the-envelope calculations have been used to justify a nationwide rip-off that

will raise the cost of living for all but the very rich."

And despite the cross-party support at Holyrood Tory health spokesman Miles Briggs sounded a note of caution. He said: "We're awaiting with interest to see what effect the introduction of minimum pricing has on Scotland's relationship with alcohol. This is new territory and we need to analyse what effect this will have on consumer behaviour."

Despite the SWA challenge, the move

does have some support within the drinks industry, with leading brewers Tennent's among the long-term advocates. Norman Loughery, off-trade sales director at Tennent's owner C&C, said: "We strongly believe that the industry must play its part in tackling alcohol abuse and will therefore continue to work with relevant bodies in the territories in which we operate, including Ireland and Northern Ireland, to seek the introduction of minimum unit pricing

legislation."

Meanwhile, campaigners south of the Border said more than 1,000 lives could be lost if England fails to mirror Scotland's reforms to alcohol pricing within five years. The Alcohol Health Alliance UK (AHA) launched an intervention with the Children's Society and homelessness charity Thames Reach today. They said that a delay of five years could lead to more than 1,000 people dying in England from alcohol-related problems.

I've cut back on booze and coke, sobs mum who beat up three cops

A BEAUTY therapist who launched a vicious attack on three police officers during a drink and drugs binge told a judge she had cut down her habit – to two bottles of wine a weekend.

Sarah Fallows, 30, punched PC Tracey Hallworth in the face and spat at, punched and kicked two other officers when they tried to calm her during a white wine and cocaine-crazed meltdown. It happened in October after Fallows, of Bramhall, Stockport, had rowed earlier with her boyfriend, town magistrates heard.

Fallows, who has a five-year old daughter, admitted three charges of assaulting police and criminal damage to a police handcuff holster. She wiped away tears as she insisted she had now cut her drinking to two bottles of wine at a weekend and reduced her cocaine use. The court heard officers were called to the home of Fallows' mother Diane, who was worried her daughter had an alcohol-fuelled

mental health problem. Fallows then attacked PC Rachel Walton and PC Luke Osbaldeston as they tried to detain her and later punched PC Hallworth, who was trying to calm her down after she was taken to hospital.

PC Hallworth said: "I don't expect to have to go home to my four-year-old granddaughter and explain why her nanna has a black eye."

PCs Walton and Osbaldeston suffered cuts and grazes to their hands. Jailing Fallows for eight weeks, suspended for a year, District Judge John Temperley told her: "If it was not for your personal difficulties, you would be going straight to prison today. "You need to accept the help you are being offered and to continue to cut down on your alcohol use and need to stop using cocaine. I want this to be a wake-up call."

Fallows was told to pay PC Hallworth £100 compensation and to pay PC Walton and PC Osbaldeston £150 damages.

Queen's grandson-in-law shows off his new nose

The action man was clearly enjoying himself as he waded through mud and climbed walls at the obstacle course in Pippingford Park, East Sussex. And he showed off a very different profile with his new nose free of

the trademark bump.

Zara and Mike have a daughter, Mia Grace, 4, and are expecting another child this year.

Speaking about his nose three years ago, he compared it to a pug dog. He admitted: "I don't really want to get it fixed but it looks like I might actually breathe very well."

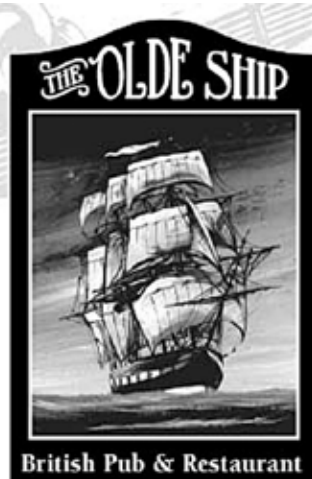
"I guess it's something similar to a pug. The

excited about – we are a duo, we tap a lot of genres but lean electro-rock and electro-pop – I invite you to hear/see more at lightshadowsmusic.com.

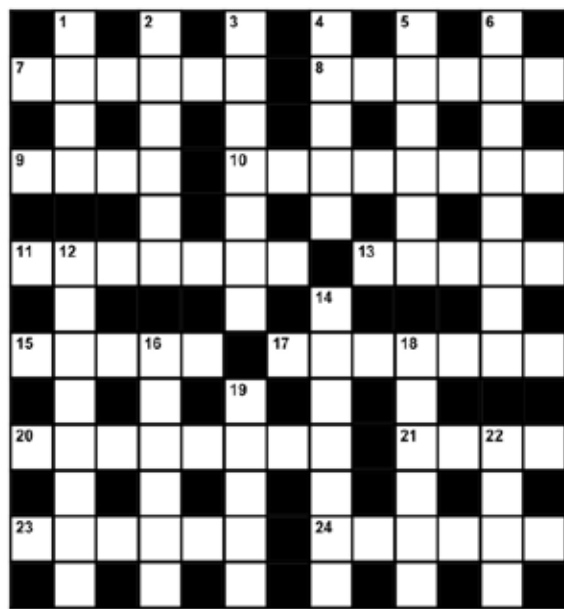

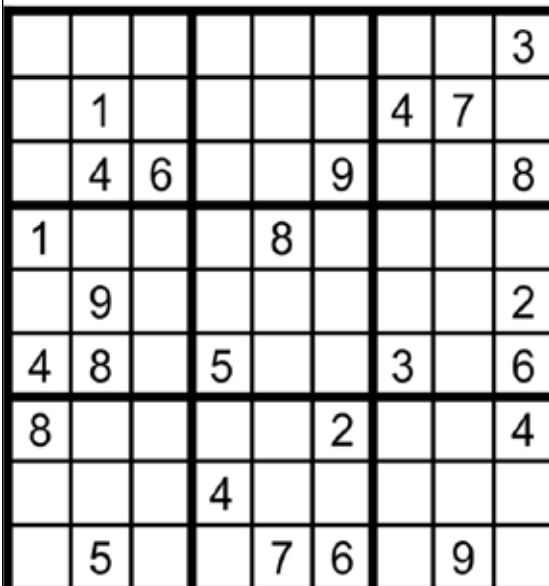

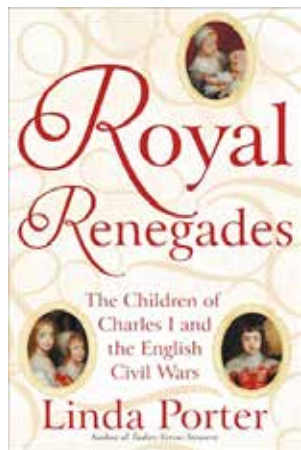

Royal Renegades: Charles's other children...

Exclusive interview with author Linda Porter discussing her new book about the children of Charles I and the English Civil Wars



"I suspect if you stopped eight out of ten people on a British street they would be surprised to learn that we executed Charles I for treason in 1649 and were a republic for eleven years afterwards," says *Royal Renegade* author Linda Porter.

"It is the sort of thing that would give the Brexit brigade the shivers. I had previously written three books about the Tudors, the last of which covered

also the Stewarts in Scotland, as opposed to the Stuarts in England, so it was something of a natural progression, I suppose. I love the period of the English Civil Wars, the fulcrum of our history, in my view, though sadly neglected in schools here nowadays."

After the English Civil War and the execution of King Charles I, his son Charles II bided his time to reclaim the throne eleven years later. But King Charles I had six other surviving children. What happened to them?

Porter sheds new life on the lives of Charles II siblings and reveals all sorts of drama in this family of royals. Mary, the Princess Royal, became the child bride of the Prince of Orange in the Netherlands. Mary was the first daughter

of a British sovereign to hold the title Princess Royal. Later her son became William III of England.

"Even where people are aware of the Civil Wars, few know that Charles I had five surviving children at the start of the conflict and a sixth, his youngest daughter, actually born during the wars, at Exeter in 1644," says Porter.

"Their experiences as a family are a microcosm of what happened to many people during this tumultuous period and the children's stories are, almost universally, very tragic. This is not a tale with a happy ending."

Porter says she took the same approach to research this book that she always does.

"First I read the latest scholarly books on the topic," says Porter.

"Then I look at more standard monographs. Then at printed sources and then at archival sources. This is how I was taught to do historical research many years ago, and it is second nature to me. In terms of sources, there is much more material available on the seventeenth century than the Tudor period, simply because it is closer to us in time. I also consult academic specialists in the period."

"I go to the normal places one goes in the UK for archival research," says Porter. "The British Library and the National Archives. I also look at private family papers where accessible. Many people describe themselves as historians. But, do not have a background in history, do not in my view, know how to do historical research

properly. People with a background in journalism are particularly prone to dash off history books."

"Readers should be aware that there is more to the history of the British Isles than the Tudors," says Porter. "I am quite relieved to have escaped them. I would like to write about the French Revolution, which is where I started out as an historian. As it happens, I prefer French history. But, most British publishers feel, rightly or wrongly, that there is a better market for British history. My favorite period is the French Revolution... the crossroads, where the eighteenth century enters the modern world."

Porter has written three other books, on Mary Tudor, Katherine Parr and the backstory

of Mary Queen of Scots. Porter won the 2004 Daily Mail Biographers Club Prize, for a book on the Bonapartes (yet to be published). He is currently writing a book on the mistresses of Charles II.

No, that's not Rob Ford walking the streets of Toronto again...

Its former Homeland star Damian Lewis!

The *Billions* actor was spotted filming an upcoming movie centered on the former Toronto mayor, baring an uncanny resemblance to the controversial late politician.

Oo-er! The casting of the British actor - who made his name in the HBO miniseries *Band of Brothers* - as Ford for *Run This Town* was originally met with some skepticism online, given the red-haired thesp looks nothing like Ford. But the pictures of Lewis on set in full makeup and wardrobe may put any such quibbles to rest.

Lewis was seen wearing a body suit and sporting short cropped hair that was bleached to resemble Ford's.

In order to complete his transformation, Lewis had to spend an entire afternoon being covered in silicon strips and breathing through a small hole as the production team worked to mold his portly new physique.

legal custody, the child's father, without the consent of the parents, the mother or the father with legal custody, is guilty of a Class I felony. This subsection is not applicable if legal custody has been granted by court order to the person taking or withholding the child.

(3) Any parent, or any person acting pursuant to directions from the parent, who does any of the following is guilty of a Class F felony:

(a) Intentionally hides a child from the child's other parent.

(b) After being served with process in an action affecting the family but prior to the issuance of a temporary or final order determining child custody rights, takes the child or causes the child to leave with intent to deprive the other parent of physical custody as defined in sec. 822.02(9).

(c) After issuance of a temporary or final order specifying joint legal custody rights and periods of physical placement, takes a child from or causes a child to leave the other parent in violation of the order or withholds a child for more than 12 hours beyond the court-approved period of physical placement or visitation period.

(4) (a) It is an affirmative defense to prosecution for violation of this section if the action:

1. Is taken by a parent or by a person authorized by a parent to protect his or her child in a situation in which

the parent or authorized person reasonably believes that there is a threat of physical harm or sexual assault to the child;

2. Is taken by a parent fleeing in a situation in which the parent reasonably believes that there is a threat of physical harm or sexual assault to himself or herself;

3. Is consented to by the other parent or any other person or agency having legal custody of the child; or

4. Is otherwise authorized by law. (b) A defendant who raises an affirmative defense has the burden of proving the defense by a preponderance of the evidence.

(5) The venue of an action under this section is prescribed in sec. 971.19(8).

(6) In addition to any other penalties provided for violation of this section, a court may order a violator to pay restitution, regardless of whether the violator is placed on probation under s. 973.09, to provide reimbursement for any reasonable expenses incurred by any person or any governmental entity in locating and returning the child. Any such amounts paid by the violator shall be paid to the person or governmental entity which incurred the expense on a prorated basis. Upon the application of any interested party, the court shall hold an evidentiary hearing to determine the amount of reasonable expenses.

Coleman out at Black Cats as Short finalizes sale deal

Chris Coleman has been "released from his contract" as Sunderland manager, while owner Ellis Short has confirmed he has agreed a deal to sell the club.

An "international consortium of football investors", led by Eastleigh chairman Stewart Donald, will take over Sunderland subject to EFL approval.

The Black Cats were relegated to League One after losing to Burton on 21 April, their second successive relegation.

Coleman left his job as Wales manager to replace Simon Grayson in November.

The 47-year-old guided his country to the semi-finals at Euro 2016, but is now out of work having

won just five of his 29 games in charge at the Stadium of Light.

In a statement, Short said he had paid off all debts owed by the club, leaving them "debt free for the first time since years before" his takeover in 2008.

Sunderland had been listed in Uefa's annual report as having the 13th highest debt in Europe, more than clubs including Paris St-Germain, Porto and Newcastle.

In February, Short said he would be willing to give the club away for free to a buyer willing to take on the club's debts.

"For a club with one of the best fanbases, stadium and academies in the UK to find itself in League

One is unacceptable," said Donald.

"We have a carefully thought-through plan to restructure the club, make it sustainable and, with the help of the fans, to restore its sense of pride and reconnect it with the local community."

Sunderland chief executive Martin Bain last week said "being sold would be a game-changer" and that "it won't take a lot to make this club great again".

Short said he had rejected higher offers for the club to sell to Donald, who has since announced he has put Eastleigh up for sale, having owned the club though his company Bridle Insurance since November 2011.

Gerrard on brink of 'Gers' move

STEVEN GERRARD is on the verge of becoming the new Rangers boss.

At press time the Liverpool legend was closing in on a three-year deal and his first job in management, and after a week of talks sources close to the Glasgow club say a deal is imminent.

Speaking on Tuesday night Gerrard said: "Yes, there are truth in rumours. I've held initial talks with Rangers, and the plan is to pick them

up in a couple of days time.

Gerrard reportedly returned from watching Liverpool in Rome on Wednesday to meet with an Ibrox delegation headed up by director of football Mark Allen and managing director Stewart Robertson for further talks about the job.

During the discussions it's believed Gerrard was given the assurances he'd been seeking concerning

Gers' finances.

Liverpool icon Gerrard wants a war-chest so he can rebuild Rangers in the summer, and mount a serious challenge to champions Celtic next season.

It's now clear Gerrard WILL be backed by chairman Dave King and the new investors he hopes to secure in the coming days.

Costa ends Wenger's final dream

EUROPA LEAGUE: Controversial striker hurts Gunners AGAIN as Arsenal fall at semi-final stage

ARSENE WENGER'S hopes of bowing out from Arsenal with some silverware were dashed at the Wanda Metropolitano stadium on Thursday night, as they were beaten 2-1 on aggregate by Atletico Madrid in the Europa League semi-final.

Former Chelsea striker Diego Costa returned to haunt the Gunners again and it was his composed chip on the brink of half-time which ended Arsenal's European hopes.

Antoine Griezmann slipped the crucial pass through to Costa after coming close with a powerful strike from a tight angle.

Arsenal were crestfallen going into the break but almost responded within minutes of the restart when Aaron Ramsey found himself through on goal. His touch let him

down and the chance was wasted - as were a number of opportunities for the visitors throughout the second half.

A bad night was made worse for Arsenal when captain Laurent Koscielny was carried off after tearing his Achilles.

Two-time champions Atletico will now face Red Bull Salzburg in their third Europa League final in eight years in Lyon on 16 May.

Defeat for Arsenal means they will miss out on Champions League football for the second straight season.

Wenger, who will leave the Gunners at the end of the season after 22 years in charge, has never won a European trophy with the club.

And there was a sense of inevitability when Costa's chipped effort hit the back of the net. Indeed

for much of both legs the Spanish outfit looked sharper and more street wise than their opponents. Under Diego Simeone Atletico have progressed to a series of domestic and European finals, and with their miserly defence operating at the peak of their powers, a happy ending for Wenger never really looked on the cards.

Costa caused the Gunners many problems during his time at Chelsea - most notably in September 2015 when he was involved in the sending off of two Arsenal players.

He was a threat from the off in Madrid, shrugging off a weak challenge from Nacho Monreal to create an opening which he should have buried.

His link-up play with Griezmann was a threat throughout and Arsenal were susceptible on the counter-attack as they pushed for a goal in the second half.

Costa came close to turning provider for his strike partner but Calum Chambers was on hand to block Griezmann's effort.

He was typically feisty too - getting into a spat with Shkodran Mustafi

and receiving a yellow card for it.

But Arsenal were ultimately made to suffer

for their missed chances and conceding a late away

goal in the first leg, having played against 10 men for

80 minutes at the Emirates and only scoring once from 28 shots in a game they totally dominated.

...but it's another night to remember for the Reds

Liverpool survived a torrid night in Rome on Wednesday to reach their first Champions League final for since 2007, advancing 7-6 on aggregate despite losing a dramatic second leg to Roma.

A journey that started on 15 August in Germany against Hoffenheim in the play-off round will end on 26 May when Jurgen Klopp's men face 12-time winners Real Madrid in Kiev.

Liverpool conceded three times in the second half in Rome to lose for the first time in the competition this season but Klopp and his players celebrated wildly in front of 5,000 travelling fans after the final whistle at the Stadio Olimpico.

Leading 5-2 after a devastating first-leg performance at Anfield,

Liverpool went further ahead when Sadio Mane finished from Roberto Firmino's clever pass.

An own goal by Milner, after Dejan Lovren's attempted clearance cannoned off his teammate, levelled the scores on the night before Georginio Wijnaldum's header made it 2-1, and 7-3 on aggregate.

Edin Dzeko gave the home side hope with his side's second goal before Radja Nainggolan added two late strikes, including a stoppage-time penalty.

However, Liverpool just about kept their hosts at bay to become the first Premier League club to reach the Champions League final since Roberto di Matteo's Chelsea beat Bayern Munich on penalties in 2012.
