## New demand for extra armed police after three days of violence leaves public in fear

**EXTRA police officers supported by armed units were ordered on to the streets on Tuesday after an unprecedented Bank Holiday weekend of violence.**

Five people were killed and at least six injured as a spate of shootings and stabbings swept the country. On Monday night armed officers were shot at in Oxford and returned fire at a gunman before laying siege to a house in the centre of the university city. This incident saw one of the bloodiest three-day spells on record draw to a close and led to calls for more armed police to be deployed in Britain's gun crime hotspots. Ex-MP and anti-knife campaigner Nick de Bois, who sits on the Government's new anti-violent crime task force, called for more officers with weapons in the UK's high crime areas.

He said: "We should be prepared to deploy such resources in hotspots where gun crime is prevalent."

### **distraught mother**

The Tory politician added that priority should be given to tackling drugs

and the gangs pushing them – reportedly the source of much of the violence. The calls came after six shootings and six stabbings took place in London, Liverpool, Luton, Macclesfield and Oxford between Saturday and Monday night. Bank Holiday Monday saw armed police patrols mingling with crowds at seaside resorts like Brighton.

### **'reckless and brazen'**

And the distraught mother of a youngster gunned down and killed in Southwark, south London, called for an end to the bloodshed. Pretana Morgan, whose 17-year-old son Rhyhiem Ainsworth Barton was shot dead on Saturday, said: "Let my son be the last and be an example to everyone. Just let it stop. What must be, must be."

She added: "It's not about race, it's not about nation, it's not about

culture. "Nothing. It's just a human race.

"Just one human race. So children, please let my son be the last."

Her words were echoed by Tottenham MP David Lammy, who said: "Enough, enough.

"My heart goes out to families grieving children and teenagers. So many

shattered lives, families and communities."

Across the city, a 43-year-old man was stabbed in Ealing, west London, after a motoring dispute a residential street on Saturday night. Scotland Yard said the victim, who was in a stable condition in hospital yesterday, was believed to have been attacked after criticizing

the driving of the suspect, who then drove away.

The violence continued with a 22-year-old man shot on Sunday night in south-east London.

He suffered non-life-threatening wounds in the shooting in New Cross Road, Lewisham, at about 6.30pm and no arrests have been made at press time.

Two stabbings took place in Luton on Sunday, with a 20-year-old man knifed to death and another man left with serious but non-life-threatening leg injuries after an unconnected incident.

Two teenage boys, one aged just 13, were shot in broad daylight in Harrow, **cont. on page 2, col. 4**

# Tories 'facing civil war' over customs union

Hardline Brexiteers threaten no confidence vote if May presses ahead with plans for frictionless border

**DISAGREEMENTS over the UK's future customs relationship with the EU have put the Conservative Party on the brink of a civil war that "could be the end of Theresa May" as Prime Minister, a senior Tory has warned.**

As MPs returned to Parliament following Monday's bank holiday, Mrs May faced a stark warning that Brexiteers will not put up with her plans to create a new partnership with the European Union which could tie Britain to Brussels rule for years to come.

That comes after a weekend during which Mrs May sent Remainer Business Secretary Greg Clark out to television studios to defend her plans.

He claimed that thousands of jobs could be lost at manufacturers such as car maker Toyota if the customs partnership does not happen.

But Environment Secretary Michael Gove, the former leader of Vote Leave, hit back by backing a Twitter thread attacking the controversial proposal.

Mr Gove described as "helpful" a series of posts by former aide Henry Newman – now director of the Open Europe think-tank – that described resurrecting the customs partnership as "surely misguided".

Mrs May is understood to support a plan devised by civil servant Olly Robbins that would turn Britain into the EU's tax collector in an attempt to sort out customs problems after Brexit and create a frictionless border between Northern Ireland and Ireland.

Many thought the plan was "dead" after a Brexit "war cabinet" last week when Home Secretary Sajid Javid joined Brexiteers to vote down the option. Last week, it emerged that if Mrs May ignores them on this issue, Brexit Secretary David Davis is likely to resign. If that happens other ministers are expected to follow, and senior backbenchers have said there will also be the 48 signatures needed from Tory MPs to trigger a vote of no confidence in Mrs May's leadership.

On Monday night night a senior Tory MP said:

"That threat [of a vote of no confidence] has not gone away. This could be the end of Theresa May. "She may not realize it but we are on the brink here. She needs to listen to her parties and her Cabinet who have given a very strong message."

Senior Tory Brexiteers have been lining up to hit back at attempts to tie Britain to EU customs arrangements and the single market. Former Tory leader Iain Duncan Smith, writing on the Conservative Home website, said: "Despite the crucial Cabinet subcommittee on Brexit negotiations and strategy deciding that the scheme isn't fit for purpose, some in Downing Street are, incredibly, now briefing that after a few tweaks it can be presented again."

Former Brexit minister David Jones also warned: "They ought to understand the customs partnership is dead and finished and they should give up."

Labour, the Lib Dems and Scottish National Party are hoping to get together with Tory Remainers including Anna Soubry to vote

through an amendment to the trade bill forcing Britain to stay under Brussels rule in a full

customs union. This would turn Britain into a country like Turkey which has no say over its

trade policy and cannot create separate free trade agreements with outside countries.

## England fans 'will be safe' at World Cup

RUSSIA has given the UK "assurances" about plans to keep fans safe during next month's World Cup, MPs heard this week.

Foreign Office minister Harriett Baldwin said Britain would have "at least as" many of its own police officers in Russia during the tournament as any other country. Officials in Moscow say they have drawn up a "blacklist" of known

football hooligans. About 10,000 England supporters have tickets for the World Cup.

Tory MP Priti Patel asked if authorities feared a repeat of the clashes between English and Russian fans at Euro 2016, which were widely blamed on Russian thugs.

Ms Baldwin said: "We welcome the fact that since that event in Marseille, the group

that was alleged to have been involved has been effectively banned."

She added that in addition to the list of known Russian troublemakers, about 1,800 England fans were subject to travel bans. Ms Baldwin told MPs that police cooperation continued between UK and Russia despite the poisoning of Sergei Skripal and his daughter Yulia.

north-west London.

It emerged Monday that the 13-year-old, who had been at a wedding, was hit in the head when a drug deal on a busy suburban street went wrong.

Police said the "innocent bystander" was walking with his parents when he was hit on the back of the head by stray shotgun pellets.

A gunman had unleashed two shots as he fired across the street

at a 15-year-old boy he had met for a Sunday lunchtime drug deal.

The 13-year-old was tended to by shocked passers-by outside Specsavers on Wealdstone High Street in north-west London before armed police arrived. Both boys are being treated in hospital.

Harrow Borough Commander Detective Chief Superintendent Simon Rose said: "This was a callous, reckless and brazen act, without any thought by those responsible for the fact that there were families

with children and people in the high street enjoying their weekend. This was quite simply appalling."

A 39-year-old man was arrested on Sunday and has now been released under investigation.

Fatah Warsame, 20, from Cardiff, died after being stabbed in Liverpool city centre early on Sunday morning. And 53-year-old known gangland fixer John Kinsella was also gunned down in St Helens, Merseyside.

A man aged 37 was also stabbed to death in Macclesfield, Cheshire.

# Violent attacks soar in the shires

## Drug gangs take turf wars into heart of rural England

A KNIFE crime epidemic is spreading from cities to rural areas in Britain as drug gangs target new custom, according to shock new figures.

Experts say counties surrounding major cities have seen an explosion in violence as criminals increasingly cross county lines. Home Office figures reveal knife crime in Hertfordshire, Warwickshire, Cambridgeshire, Hampshire, Essex and Norfolk doubled in three years. The alarming

statistics suggest people are now more likely to be a victim of a knife attack in Bedfordshire than in Greater Manchester or Merseyside.

It emerged last month that London's murder rate had overtaken New York's in February and March. Knife crime was up 20 per cent in the capital over three years. But in the home counties the rise since 2014 is far higher. Knife crime incidents in Norfolk are up 274 per cent. Hertfordshire is also

up 150 per cent from 229 incidents in 2014 to 573 in 2017. North Wales is up 134 per cent, Hampshire up 102 per cent, Cambridgeshire up 83 per cent, Warwickshire up 180 per cent, Bedfordshire up 86 per cent, Essex up 86 per cent and Thames Valley up 50 per cent.

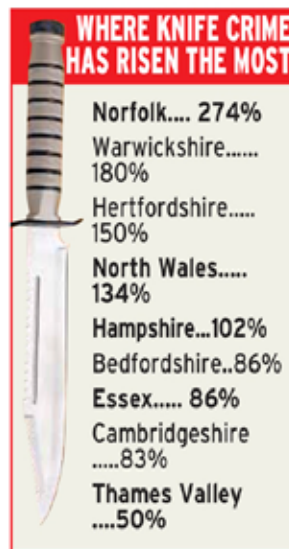
Vince O'Brien, head of drugs operations at the National Crime Agency, said rises were fuelled by gangs seeking new customers.

"There is an increasing level of violence coming from city gangs establishing themselves in new drugs markets in rural areas," he said. "Counties which surround London are being affected."

A Home Office report links rising violence to "county lines" drug dealing, where city gangs sell drugs direct

to users in the provinces, forcing out local dealers usually by violence. There are now 720 known drug operations that export heroin and cocaine from big cities to rural areas, most from London, Merseyside and Manchester. A crime agency report revealed gangs often bring knives

and acid to defend themselves from rivals and expand their turf. Andy Higgins, research director for the Police Foundation think tank, said: "Although the highest volume of knife crime is in London, some of the largest increases in recent years have been in the county forces."

## Brits can get cocaine at their door 'faster than a pizza'

**COCAINE** can be delivered quicker than a pizza in England and Scotland, according to a survey of drug users.

Dealers compete through speed of delivery and - at 30 minutes - offer some of the fastest rates in the world. Drugs gangs are avoiding street dealing by turning to the so-called dark web to sell to customers. Some orders are sent through letterboxes. It is feared that easy access and higher purity of cocaine

are "likely to lead to escalating use" which could harm people. Drug users in England were found to consume the second highest amount of cocaine in a single session (0.7g) beaten only by Scotland in the world.

The Global Drugs Survey questioned 1,000 cocaine users in England and 500 in Scotland. The study said: "The rise of encrypted social media platforms makes ordering relatively safe. With many cities covered with CCTV

cameras, traditional street dealing is becoming less attractive."

Some 36.8 per cent of users surveyed in England said they could get cocaine within 30 minutes and 37.4 per cent in Scotland - placing them fifth and sixth in world rankings. This compares with 12.2 per cent of people in England and 19.8 per cent in Scotland who could get a pizza in the same time. The report surveyed 130,000 users in 44 countries.

# Sit back and relax: it's Eurovision time again

Now expats can join the fun as venerable song contest is available on these shores

FOR SOME, it may come as a surprise to learn that the world's most popular live entertainment show is the venerable Eurovision Song Contest.

That cheesy old competition from our youth may be best remembered by many of us as an annual outrage when worthy talents including Pearl Carr, Matt Munro, Cliff Richard, Mary Hopkin and Clodagh Rodgers were beaten into second place (or worse) not by the quality of another country's music, but rather by some 'nul points' stitch-up and bloc voting from our devious continental rivals, who routinely engineered wins for talentless one-hit wonders who have deservedly faded into the mists of time.

But for every mediocre Eurovision winner we

don't remember – like Severine (1971), Vicky Leandros (1972) and Corinne Hermes (1983) there is, of course, Abba, winners with Waterloo in 1974 before going on to worldwide pop dominance, proving that occasionally a gem can emerge from the dross.

## global phenomenon

This year's contest sees 43 countries from around the world take the stage in Lisbon – a far cry from the first contest in Switzerland in 1956, when there were just 14 entries - two each from seven West European nations. Participation by countries behind the Iron Curtain would have been unthinkable. But socialist Yugoslavia joined in 1961, and the competition since then has become ever more international and inclusive.

Israel first appeared

in 1973; Australia, which broadcast the competition without taking part since the 1980s, has been sending contestants since 2015.

Despite its distinctly "euro" sensibility - which can be puzzling to the uninitiated - Eurovision is now a global phenomenon with fans all over the world. In the age of video streaming and social media, it has never been easier to follow.

Which is good news for Eurovision super fan James Sheen, 54, from Colchester, who hosted watching parties for 20 years in his backyard but now travels to attend the contest in person.

"I couldn't go any higher with the parties," he said on Wednesday in a telephone interview from the Altice Arena in Lisbon, the site of this year's competition. "I

want to be with more Eurovision people."

Mr. Sheen said that he held his first Eurovision party in 1991. Each year, the shindigs grew more elaborate as he added score sheets, themed food, colored spotlights, a sound system and a smoke machine.

## spirit of togetherness

His 10th party, in 2005, coincided with Eurovision's 50th anniversary; Mr. Sheen pulled out all the stops.

The mother of a regular guest baked a two-tier cake in the national colors of the host country that year, Denmark.

"I got 50 gold, helium-filled balloons and tied flags from each of the countries with ribbons to them," he said.

Mr. Sheen said his earliest memory of Eurovision was as a child in 1972, the year the New Seekers represented Britain with "Beg, Steal or Borrow." From those earliest days, for him, Eurovision was about community. "It's all about friends and extended family," he said.

The parties were Mr. Sheen's way of replicating the spirit of togetherness that Eurovision represents. "It's always been a great way to bring people together and to appreciate each other's culture," he said. He added that doing so was all the more important in today's political climate in Europe.

"People always want to talk about Brexit and how you see it politically," he said. "The politicians argue about this, that and the other; we argue about a song."

In 2011, Mr. Sheen drove to Düsseldorf, Germany, to be in the audience for the first time. While the parties were dear to him, nothing beat the thrill of the real

thing, he said. And he hasn't looked back.

"When you get here, you know you're in the family," he said.

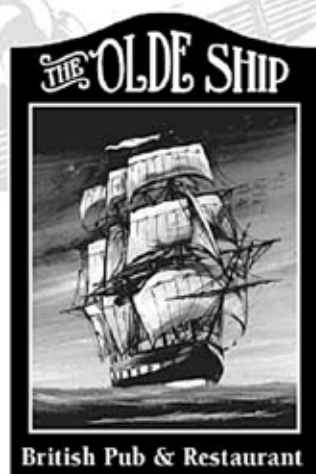

# Meet A Member: Paula Gardner

Meet Paula Gardner from New Orleans who moved to LA in 1975 to pursue her British boyfriend, Kim Gardner. He later became her husband and would open the world-renowned Cat & Fiddle Pub in Hollywood in 1982.

## Tell us about how you moved to LA...and how you first met Kim?

When I first met Kim he still lived in London, so I visited him there many times. I met his lovely mother, whose hand-written recipes on onionskin letter paper were the inspiration for dishes we still serve at the pub. Kim and I eventually decided to settle down in Hollywood. He wanted to open his own pub there because there wasn't one! His dad always said, "That boy would do anything for a pint!" Kim was a bassist in the British Invasion scene of the 60s and 70s so his friends included the likes of Ron Wood, Rod Stewart, Eric

Clapton, Jeff Beck, etc. The Cat & Fiddle became a hub for the entertainment industry – you never knew who'd pop in!

Kim and I had 3 girls, Ashlee, Camille and Eva. We continued to visit family in London regularly and of course frequented many pubs. One in particular, the Portobello Gold, we always referred to as our "sister pub." The kids couldn't wait to go to there to play the pokies, which afforded us some time to knock back a few pints! Portobello Road antique market shopping sprees provided most of the décor you see at the Cat & Fiddle.

36 years later, the Cat & Fiddle remains family run. Ashlee is my partner and Camille's consulting company is also an integral part of the operation. Eva is Johnny-on-the-spot when she is not on tour as a bassist for artists such as P!nk and Cher.

I lived here in the late

1960s and always loved the energy. There used to be so many cars on West Sunset going to the Whisky and other clubs that traffic would be at a standstill – people would turn up the music on their radio, get out of their cars and dance in the street. I used to see Janis Joplin's psychedelic Porsche on Highland Ave where she lived. I was so inundated with the music scene at that time – it was so new, fresh and vibrant. There was much more artistic freedom in Los Angeles at the time than in the South. While we were dating, Kim was recording an album for Capitol records in Hollywood. I met him here and we decided to stay – the rest is history!

## What do you miss most from home?

I miss the Southern hospitality and charm. I used to miss the food – fabulous restaurants and down home cooking – but Los Angeles is now very

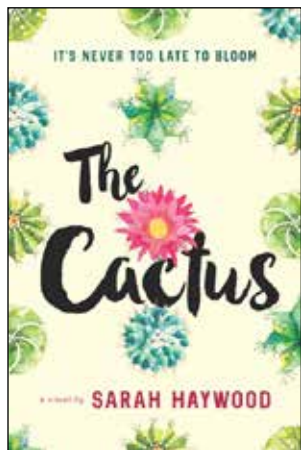

## The Cactus: dealing with life's thorny issues

Exclusive interview with author Sarah Haywood discussing her novel about a control freak who discovers she's pregnant



**LOSING CONTROL.** It's what Susan Green, the thoroughly modern heroine of Sarah Haywood's new book *The Cactus* fears most. At 45, Susan is a modern metropolitan woman living in London and with a job for which she is perfectly suited. Her home, her career and her love life are all under strict control.

But her life of order and logic goes to pieces when her mother dies and Susan finds she's about to become a

mother herself. Susan is certainly not interested in marrying the father, Richard. And when she finds out that her brother Edward has somehow tricked her late mother into favouring him in her will, and that the family house will go to Edward unless she takes him to court, the storyline spins into action.

With change comes secrets uncovered and personal realizations. And soon Susan realizes that friends and emotions may be necessary after all. Haywood's novel is humorous and reveals the vulnerability of someone who believes she's above all that. It poses the question: do we ever really have control over anything in our lives?

"The will dispute plot was inspired by my work with the Legal

Services Ombudsman investigating complaints about lawyers," says Haywood.

"I was inspired by women I know who are feisty, strong-minded, not very touchy-feely, but who are wonderful, kind, interesting people when you get to know them. The pregnancy storyline was inspired by my own journey to motherhood, which caused me to open up my life to new experiences and people."

For her research, Haywood studied books on probate and procedures for challenging a will.

"The *Cactus* was written as part of my MA in Creative Writing, so I was able to use the university library for research," says Haywood. "When I discovered that the book would be pitched in the U.S., I carried out

further research to check that the legal issues were similar. I also researched the symptoms, diagnosis and treatment of mini-strokes, together with the effect they could have on mental capacity. I discussed the medical issues with a friend who's a specialist in geriatric medicine."

"As a former lawyer, I had a good general understanding of the legal issues in *The Cactus*," says Haywood. "When investigating complaints concerning wills, it was often apparent to me that the source of the complainant's unhappiness was not the actions of a lawyer, but was their relationship with the deceased or another family member, or simply with the hand that life had dealt them. That's the case with Susan."

The *Cactus* is

Haywood's first novel. She has written a number of short stories. WHSmith in the UK announced in February that Haywood is one of twelve debut writers for their Fresh Talent campaign. *The Cactus* has yet to be optioned for film or TV.

"The most surprising thing to me was the length of time it takes for a book to be published, both in the UK and the U.S.," says Haywood. "My novel sold quickly. I naively thought it would be on the shelves soon afterwards, not appreciating how much work is involved in bringing a book to publication. Ironing out the differences between U.S. and UK vocabulary was a minor challenge."

Haywood is currently writing a novel about three generations of women who are finding their own voice. She's

also written the opening chapters of a historical novel for children that explores a warren of mysterious tunnels dug under Liverpool in the early nineteenth century.

Haywood is based in Liverpool, and spent ten years working in Manchester and studying there for her MA. She was born in Birmingham.

# Stateside Wazza? Rooney agrees deal 'in principle' for move to DC

Wayne Rooney has agreed a deal in principle that could see him leave Everton for Major League Soccer side DC United this summer in a £12.5m deal.

The footballer's representatives have been in the US to negotiate terms and the former England skipper is willing to leave the Premier League club.

Nothing has been signed yet and uncertainty over Everton boss Sam Allardyce's position means the forward, 32, could stay at Goodison Park.

Rooney rejoined Everton in July 2017.

He spent 13 seasons at Manchester United after signing from Everton as an 18-year-old, becoming their record goalscorer and winning five Premier League titles and the Champions League.

It is understood Rooney has been offered a contract

until the end of the 2020 MLS season. The US transfer window does not open until July.

Earlier this week, Allardyce said Rooney wants to stay and dismissed suggestions England's record goalscorer is frustrated with his role.

"It would have to be massive for him to want leave Everton," the former England manager told Talksport. "I've not had a problem from day one with Wayne (but) the Wayne Rooney saga continues on doesn't it?"

Allardyce's future is also uncertain at the club, with fans not happy with his style of play.

Rooney, who is halfway through a two-year deal at Goodison Park, has played 31 times in the league this season with four appearances from the bench.

He reacted angrily to

Rooney is Everton's top scorer with 11 goals this season.
