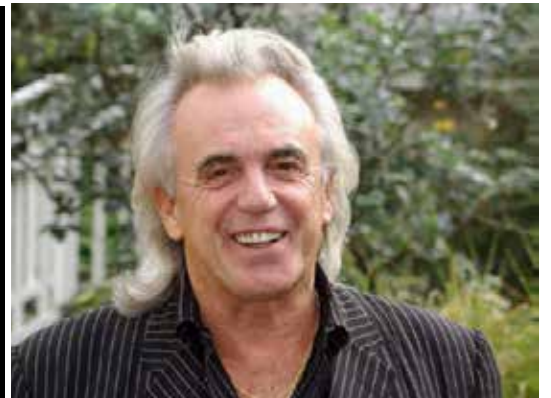

# CLEARED FOR TAKEOFF!

- Third runway at Heathrow finally given the go-ahead
- Transport Secretary hails ‘historic moment’

**THE long-awaited £14billion Heathrow Airport expansion is set to go ahead after being backed by the Government and many MPs this week.**

Diehard opponents include Foreign Secretary Boris Johnson – who once threatened to “lie down in front of bulldozers” to stop a third runway being built – and various local authorities, residents and green groups, who are threatening court action.

But ministers are confident they will win parliamentary approval after nearly two decades of wrangling.

The Commons will be asked to vote by July 11 after a Cabinet sub-committee chaired by Prime Minister Theresa May gave it the go-ahead. Ministers with objections or constituency interests – like Uxbridge and South Ruislip MP Mr Johnson – can ask Mrs May for leave to break normal rules of “collective responsibility” and voice their views in local media.

But they cannot campaign or speak

against the policy in the Commons.

The Tories expect to impose a three-line whip, meaning any minister who rebelled could be dismissed. There is speculation globetrotting Mr Johnson may find himself on official business, sparing him the dilemma.

**‘major infrastructure’**

Subject to planning approval, the privately-funded airport project will start in 2021 and be complete by 2026. The Prime Minister declared that the decision “demonstrates this government’s commitment to deliver the jobs and major infrastructure that this country needs to thrive as we leave the European Union”.

Transport Secretary Chris Grayling told the Commons it was “a historic moment” as he formally unveiled the Airports National Policy

Statement, which set out the plan. He said: “The time for action is now. Heathrow is already full and the evidence shows the remaining London airports won’t be far behind.

**regional links**

“Despite being the busiest two-runway airport in the world, Heathrow’s capacity constraints means that it is falling behind its global competitors,

impacting the UK’s economy and global trading opportunities.”

Mr Grayling said expansion would benefit the whole of the UK, with up to 15 per cent of slots on the new runway expected to accommodate extra domestic flights, boosting regional links and encouraging more competition and low-cost fares. Nearby communities are in line for a £2.6billion fund to

pay for noise insulation and other measures. Heathrow has offered 125 per cent of market value to owners of the hundreds of homes that will be demolished, plus moving costs. Mr Grayling also outlined a new six-and-a-half hour ban on scheduled night flights and also pledged: “We will grant development consent only if we are satisfied that a new runway would not impact the

UK’s compliance with air quality obligations.”

MPs on all sides backed the expansion, but Labour frontbench spokesman Andy McDonald reserved judgment, saying the plans must pass key tests. And Labour leader Jeremy Corbyn spelt out noise, pollution and economic considerations, as well as noting that two existing airports – Stansted and Luton

– were under capacity. Prominent Tories also joined Lib Dem and Green protests. Ex-transport secretary Justine Greening said the decision was “not only wrong for the UK and its competitiveness, it is wrong for the London communities who will be blighted by the pollution from an expanded Heathrow”.

Shadow Chancellor John McDonnell also joined the fray, highlighting the potential multimillion-pound cost to the taxpayer in the event that the government, including any future Labour administration, should change its mind on expansion.

“There appears to be no end date to this agreement,” he said. “This means that taxpayers could be left picking up a bill of multiple millions of pounds if the government does not proceed with developing the Heathrow north-west runway scheme.

“I am extremely concerned that through this agreement the government has tied itself into a considerable liability that could fall upon the taxpayers’ shoulders and preempts the decision of parliament on this matter.”

# Police probe ‘dead hitman’ in Thorpe plot

**POLICE who believed a suspect in the Jeremy Thorpe scandal was dead this week revealed they have found him alive – but they said they will not reopen the investigation.**

Gwent Police said they had located Andrew Newton in Dorking, Surrey, living under the name Hann Redwin. The 72-year-old was allegedly hired to kill Norman Scott, the ex-lover of former Liberal leader Thorpe. Police defended their initial conclusion that he was dead, insisting the assumption had “reasonable grounds”.

“However, recent information obtained by the force indicated that this may not be correct,” the police said. “Having confirmed his status and whereabouts, officers spoke to Mr Redwin who is unable to provide any additional evidence to that which has already been obtained in the original inquiry.

“Gwent Police is satisfied there is no basis to re-refer the matter to the CPS and the investigation remains

closed.”

The announcement came after Mr Redwin’s friend Patsy Frankham, 61, spoke out at her home in Dorking, Surrey – where police came looking for him on Sunday. “Mr Redwin is a friend but he does not live here,” she said. Asked where he was, she replied: “I do not know. He could be the other side of Paris for all I know.”

Miss Frankham said she thought police were carrying out a “publicity stunt” for A Very English Scandal, the hit BBC1 drama about the Thorpe affair. She said: “The police came and had a film made of them knocking on my door when they knew I wasn’t there. Is this a publicity stunt? I don’t know.”

Thorpe was acquitted at a 1979 Old Bailey trial of a plot to murder Mr Scott – the North Devon MP’s lover in the 1960s when homosexuality was illegal. The court heard Newton tried to shoot ex-model Mr Scott, only to be thwarted when the gun jammed. He did kill his Great Dane,

Rinka, and was jailed for possessing a firearm. After Mr Thorpe’s death four years ago, Dennis Meighan, a schoolfriend of Newton’s, claimed he offered him £13,500, to silence Mr Scott. Now 71, he said he turned down the offer and went to police but claimed they covered up his claims to protect the politician’s reputation. Gwent Police began investigating his allegations two years ago, but dropped the probe believing Newton had died. After the revelation he was alive, Mr Scott, 78, said: “I just don’t think anyone tried hard enough to look for him.”

## Nine nabbed over Grenfell fraud

**Nine people have been arrested over allegations of fraud in connection with the Grenfell Tower fire.**

Eight men and one woman were detained by officers during raids at about 07:00 BST on Thursday at 11 addresses,

mainly in west London, the Met Police said.

In a briefing, the force said two of the people arrested are linked but that all of the alleged offences are separate.

The value of the alleged frauds range from £25,000 to £100,000.

“All those arrests are in connection with what we believe to be fraudulent claims for housing and/or support of one kind or another, arising out of false claims from people that they were associated with Grenfell Tower,” Det Supt Matt Bonner said.

# Jail for UKs first all-female terror cell whose bloody plans were foiled

■ London family were radicalized by hate preacher Anjem Choundary

BRITAIN'S first all-female terror cell was put behind bars this week as it emerged the bloodthirsty women were inspired by hate preacher Anjem Choundary.

Safaa Boular, 18, her sister Rizlaine, 22, and their mother Mina Dich, 44, aimed to unleash carnage on the streets with knives, guns, hand grenades or vehicles.

In conversations bugged by police, they joked about staging a Mad Hatter's tea party – code for a mass-casualty attack on the streets of London.

## “enduring influence”

Dreaming of becoming martyrs for Islamic State, they fuelled their blood lust by poring over ghastly videos of beheadings and battlefield dead. They hoarded pictures of female martyrs – women in burkas wielding assault rifles – and small children carrying guns.

They also kept images of Choundary, whose hate-filled rants have inspired a generation of jihadists including Michael Adebolajo – one of the killers of soldier Lee Rigby.

A security source said: “This case shows the enduring influence of Choundary in poisoning the minds of men and women who plan and carry out acts of terrorism in this country.”

Targets for the Mad Hatter attack included crowded streets around the Palace of Westminster and the British Museum. Rizlaine Boular and Dich also carried out “hostile reconnaissance” at the headquarters of MI6 on the south bank of the River Thames in London.

## “enduring influence”

Rizlaine later practised stabbing victims with a six-inch kitchen knife, sparking fears she might be planning to attack MI6 spies outside their offices.

Police bugged their conversations and Safaa was heard sneering at the victims of the Westminster Bridge attack in March last year. With mock sympathy, she said she would lay flowers at the scene.

On Monday Safaa was found guilty at the Old Bailey of preparing acts of terrorism. Her sister and mother admitted the same offence at an earlier hearing.

Safaa is one of the youngest females to be charged with terror crimes. The trio will be sentenced at a later date. Khawla Barghouthi, 21, of Willesden, north-west London, admitted failing to inform the authorities about a terror plot. She will be sentenced with them.

Deputy Assistant

Commissioner Dean Haydon, of the Metropolitan Police, said: “All three women were filled with hate and toxic ideology and were determined to carry out a terrorist attack. Had they been successful, it could well have resulted in people being killed or seriously injured.”

Rizlaine's stabbing rehearsal at her home in Willesden was bugged by Scotland Yard and helped to prompt the decision to send in armed police. Dressed in a burka, she allegedly tried to attack one of the heavily armed marksmen and was shot four times in the stomach at close range. She survived after receiving first aid from the armed officers at the scene.

## extremist views

Investigators discovered how Safaa Boular was the dominant figure in the cell. She was only 16 when she was “inspired” by coverage of the Paris massacres in November 2015, when IS killers slaughtered 130 people and wounded more than 400 in gun and bomb attacks. Safaa first wanted to travel to Syria and become a jihadi bride by marrying an IS fighter whom she met online. She and Coventry-born Naweed Hussain,

32, discussed blowing themselves up with suicide belts in the war zone, the Old Bailey heard. He fuelled her extremist views by sending her images of atrocities in Syria, including beheadings and other executions, the jury was told. Hussain also sent her £3,000 so she could travel to Syria for her wedding. But the marriage plan was thwarted when police seized her passport and Hussain was later killed in Raqqa. Safaa and her fiancé never met but were sometimes in contact via the internet for up to 12

hours a day. She later claimed that she was an innocent young girl and accused the IS man of “grooming” her for sex and extremism. But Mr Haydon said: “Safaa Boular is not an innocent teenager. She is confident, articulate, intelligent and mature.”

“If we had not arrested her, there is no doubt she would have carried out an attack on the streets of London, causing injury and death.”

The women also hoarded images of radical preachers Khalid Yasin and UK-born Muslim

convert Trevor Brooks, also known as Abu Izzadeen. Normally in a full-body burka, Safaa wore Western clothes throughout her trial in an attempt to convince jurors she had spurned fundamentalism.

## Arrest made over death of 100-year old

A man has been arrested on suspicion of murdering a 100-year-old woman who died after her neck was broken when her bag was stolen.

Zofija Kaczan was approached from behind and pushed to the ground in the Normanton area of

Derby at about 08:45 BST on 28 May.

She died on Wednesday after suffering multiple injuries in the attack.

A 39-year-old man who was first held on suspicion of robbing Mrs Kaczan has now been arrested over her death.

Following the robbery,

Mrs Kaczan's green handbag was found dumped a few hundred yards away at the junction of Moore Street and Normanton Road.

Det Ch Insp Darren De'ath, from Derbyshire Police, described what happened to Mrs Kaczan as “absolutely horrific” and “disgusting”.

# Radio host Nicholas Parsons, 94, misses first Just A Minute Show in 50 years

LISTENERS questioned whether it was “the apocalypse” as Just A Minute was broadcast without its chair Nicholas Parsons this week for the first time in more than 50 years.

The presenter, 94, has been on the BBC Radio 4 panel game since its inception in December 1967, but missed Monday night’s instalment. Gyles Brandreth filled in for him – prompting an outpouring of worried messages on social media from Parsons’

fans. BBC head of radio comedy Julia McKenzie was quick to assure listeners that Parsons was just enjoying a rare “couple of days off”. She tweeted: “Just to reassure those listening to the very unexpected Just A Minute on BBC Radio 4 at the moment – the apocalypse is not upon us – Gyles kindly stepped in to give Nicholas Parsons a couple of days off.

“NP is totally fine and is still the guv’nor as per the last 50 years.”

However, plenty of people still posted messages online saying that Just A Minute without Parsons felt like the end of the world. One said: “The latest sign of the impending apocalypse. Nicholas Parsons is not in the chair for Just A Minute.” Another fan said: “OMG what is happening. Nicholas Parsons isn’t presenting Just A Minute. End of days. BBC Radio 4.”

Another said: “Somewhere, the captain

of a nuclear submarine is trying to work out what it means when Nicholas Parsons isn’t hosting Just A Minute.” And one person suggested it was like “the ravens leaving the Tower of London”. Ms McKenzie responded to some of the comments, assuring the concerned fans: “He’s totally fine – we thought we’d allow him a day off after 50 years.” She replied to another message by saying: “Yes don’t worry he is fine and well – just a day off.” Another

tweet read: “NP is totally fine. Just taken a couple of days off – he has a 50-year perfect attendance record so we thought that was probably OK.”

# Salad days are over...now Heinz labels condiment Sandwich Cream

FOR more than a century it has been a staple product in millions of kitchen larders across Britain. But now Heinz is set to ditch the name of its famous Salad Cream for the first time in 104 years – changing it to Sandwich Cream.

Department store chain House of Fraser is to close 31 of its 59 shops, affecting 6,000 jobs, as part of a rescue deal.

If the plan is approved, 2,000 House of Fraser jobs will go, along with 4,000 brand and concession roles.

The stores scheduled for closure, which include its flagship London Oxford Street store, will stay open until early 2019, House of Fraser said.

The firm’s boss said the decision to close stores was “as tough as it gets”.

The maker claims that as only 14 per cent of buyers used the yellow sauce on salads, the old name no longer reflects its modern purpose. But the news has caused consternation among some traditionalists, including those who rallied to save the brand a few years ago. Comedian Jim Davidson, 64, described the move as diabolical. He said: “That’s it, proof the world has gone totally mad. No more salads for me then. I’ll have no choice but to eat burger and chips.

“I’ll be a fat man. Have they not thought about the effect on the nation’s waistline?”

“Salad cream is the only reason to eat a salad.”

Parent group Kraft Heinz said it was working with brand design specialist Jones Knowles Ritchie on overhauling one of Britain’s most enduring kitchen favourites, launched in 1914. A Heinz spokesman told trade journal The Grocer: “The name no longer fairly represents the product’s ingredients

or usage occasions. There are consumers now who haven’t grown up with the brand in the household and just don’t know about the iconic zingy flavour or what to eat it with.”

Its own research discovered just 14 per cent used the cream on salad. Other popular uses now include as an accompaniment to tuna, ham or cheese in sandwiches, usually as an alternative to mayonnaise. According to The Grocer, it is also considering the name sandwich cream in a bid to appeal to younger shoppers. UK sales of the brand dipped 5.4 per cent to £28.8million last year. The consultation process means the earliest a new name will be introduced is in September. In 1999 it was revealed that Heinz was about to ditch the brand. But a protest, by shoppers alongside several celebrity campaigners such as Denise van Outen and Graham Norton, saved the brand. The publicity helped sales and Heinz took advantage by relaunching new-



look packaging and putting the price up. The spokesman added: “As a market-leading business, Kraft Heinz continues to audit its portfolio to meet the needs of consumers.”

Salad Cream was launched by Heinz for the UK market. It became

popular during the Second World War when tomato ketchup was in short supply. It is now seen as a cheap low-fat alternative to mayonnaise. In 2010 Heinz launched a new limited edition lemon-and-black pepper flavoured salad cream.

## RAF chief defends ISIS bombings

Britain's top military officer has defended RAF bombing of the so-called Islamic State (IS).

Air Chief Marshal Sir Stuart Peach said IS was a "really wicked and evil enemy" that used civilians as human shields.

He said the RAF had carried out "the most carefully planned air campaign in history" and was "meticulous" in trying to avoid civilian casualties.

Amnesty International has criticised the UK for its role in attacks on the Syrian city of Raqqa.

It claimed that the US-led coalition had been responsible for killing hundreds of civilians in Raqqa alone and it called on the Ministry of Defence to "come clean" over Britain's role.

But Air Chief Marshal Peach, who earlier in his career served as a navigator in a Tornado jet, does not accept the charge.

He said any allegation of civilian harm, with evidence of time and place, was properly investigated.

# Last orders as Glynn, Minder's lovable barman, dies aged 87

GLYNN Edwards, the actor best known for playing Dave the barman in TV hit *Minder*, has died aged 87.

Mr Edwards became a national star playing the landlord of the Winchester Club in the popular show, which ran for 10 series between 1979 and 1994.

His gullible bartender was teamed with George Cole, who played roguish car dealer Arthur Daley, and Dennis Waterman, who played Arthur's bodyguard Terry McCann, in the ITV comedy-drama, which regularly pulled in 16 million viewers.

In spite of his success in the role, Mr Edwards's part was initially a small one.

Earlier this year he told the *Daily Express*: "It was just one day's work initially, and seeing the script made me realise why - there were only a couple of lines. My agent persuaded me to accept it, explaining that the part

may grow and, of course, it did."

Such was his fame in the role, Mr Edwards would hire himself out as a celebrity barman at weddings and parties during *Minder*'s run.

The actor trained at the Central School of Speech and Drama in London, before appearing in films and TV.

His big screen debut was 1957's *The Heart Within*, but his breakthrough role came in the 1964 classic *Zulu*, where he played soldier William Allen.

He went on to make several movies with *Zulu* co-star Michael Caine, appearing in hits *The Ipcress File* and *Get Carter*.

On the small screen, his most notable pre-*Minder* roll was as Frank Spencer's neighbour, Mr Lewis, in *Some Mothers Do 'Ave 'Em*.

Mr Edwards also made appearances in TV shows *The Saint*, alongside Roger Moore, and *Bless This House*, with Sid

James.

Mr Edwards, who died on May 23, was married three times.

His first marriage was to George And Mildred star Yootha Joyce and his second to Christine Pilgrim, with both ending in divorce.

His third wife, Valerie, who he married in 1984, survives him, along with four stepchildren and a son by Ms Pilgrim.

## Boris warns of Brexit 'meltdown'

Boris Johnson reportedly warned there may be a Brexit "meltdown" in comments made at a private dinner this week.

The foreign secretary also referred to the Treasury as the "heart of Remain", according to a report by BuzzFeed.

In recorded comments to the campaign group Conservative Way Forward he also reportedly said he was "increasingly admiring of Donald Trump".

Friends of Mr Johnson said they were disappointed remarks made at a private event had been covertly recorded.

The foreign secretary was apparently speaking

to a group in a private room after an Institute of Directors reception on Wednesday night.

According to BuzzFeed, he said that the prime minister was "going to go into a phase where we are much more combative with Brussels".

'all right in the end'

He reportedly added: "You've got to face the fact there may now be a meltdown. OK? I don't want anybody to panic during the meltdown. No panic. Pro bono publico, no bloody panic. It's going to be all right in the end."

He was said to have described concerns over the border between Northern Ireland and

the Irish Republic as "pure millennium bug stuff" and suggested Chancellor Philip Hammond's department was "basically the heart of Remain".

On the US president, who is preparing for an historic summit with North Korea's leader Kim Jong-un, Mr Johnson reportedly said: "I have become more and more convinced that there is method in his madness."

He added: "He'd go in bloody hard... There'd be all sorts of breakdowns, all sorts of chaos. Everyone would think he'd gone mad. But actually you might get somewhere."

"It's a very, very good thought."

**What do you miss most**

**from home?**

Apart from friends and family, Sainsbury's own medium cheddar cheese and public transport! I don't drive and although Ubers and Lyft are great to get around, buses and trains are few and far between. Coming from London I am used to dashing around the city on the flowing amounts of public transport, or by foot.

**What was your first impression of LA and has it changed since?**

Beauty, palm trees, heat, hikes, open laptops in coffee shops with scripts, actors (!) the Hollywood Bowl, rooftops and smiley happy people! I landed in a heatwave and literally never stopped for the first month! I was exploring every nook and cranny and doing all the typical LA 'must dos'. Friends and friends of friends were incredibly

**Lastly, how can we find out more about you?**

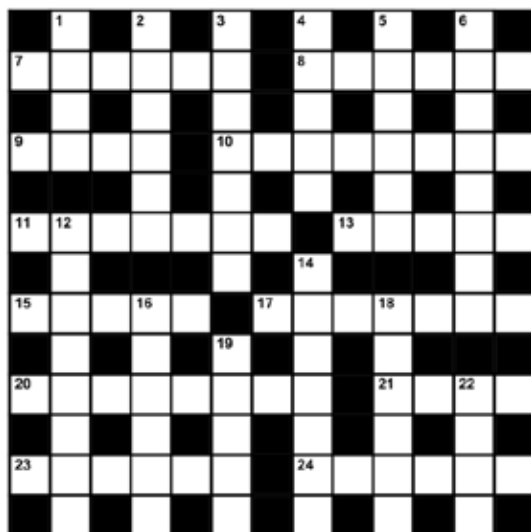

## The Queen's Embroiderer: devil in the details

■ Exclusive interview with Joan DeJean and her new historical novel based on a true story of star-crossed lovers in France and their exile to the new city of New Orleans in 1719



"I thought of calling my book *Love in a Time of Stock Market Fever*," says *Queen's Embroiderer* author Joan DeJean. "It is both a great, star-crossed love story and a cautionary tale about the lengths to which men can be driven by the dream of windfall profits. To understand the story, I follow two Parisian dynasties...the families of Louise Magoulet and Louis Chevrot, the Montagues and Capulets of this story...from 1600 to 1789, the two centuries during which the Bourbon monarchy made France the most powerful nation

in Europe and Versailles the most famous court in the world."

The story moves from Paris, Versailles, the Bastille to the Louisiana territory, where Frenchwomen were forcibly exiled to marry colonists. In 1719 Paris, the world's first millionaires are buying everything in sight. The stock market is surging. The Chevrot and Magoulet families gain wealth but then both fall in the first stock market crash. Louise Magoulet's family are master embroiderers for Queen Marie-Thérèse and her husband King Louis XIV. Louis Chevrot's family were lawyers who built their wealth on the emerging financial industry. Like Romeo and Juliet, Louis and Louise meet and fall in love, upsetting their families' plans.

"This book began with an image, the earliest surviving image of a

real shop with a known owner: the Parisian shop of a master embroiderer whose official title was *The Queen's Embroiderer*," says DeJean. "I was working on an article on the first upscale fashion boutiques for *Luxury*, a periodical edited by Jonathan Faiers, professor of Fashion at Winchester School of Art, and I wanted to feature that image."

The image is in the collections of Waddesdon Manor, the renowned National Trust property in Buckinghamshire, but archivist Phillippa Plock couldn't say whether Jean Magoulet, the *Queen's Embroiderer*, actually owned the furniture depicted in the image of his shop. DeJean set off for what she expected would be a day or two in France's National Archives in Paris.

"In the National Archives, I found two documents," says DeJean. "The first, Magoulet's

letter of appointment as the *Queen's Embroiderer*, was no surprise. The second stopped me in my tracks. August 5, 1719. Lock Marie Louise Magoulet up in prison and ship her off to Louisiana. In 1719, such a royal decree was unequivocal. Marie Louise Magoulet had been accused of prostitution and was being deported to the newly founded city of New Orleans as an undesirable."

DeJean eventually did find a record of the furniture, that Magoulet did indeed own everything depicted in the image. But by then, she no longer cared much about chairs.

"I wanted to answer these interrelated questions," says DeJean. "How could a father have done that to his own child? And how was he able to get away with it? The answers to those questions all took me to the Scottish economist

John Law and to the phenomenon known as the *Mississippi Bubble*."

The *Mississippi Bubble* was the first great stock market speculation. In seven months, stock in a trading company directed by Law rose from 500 livres (the French currency, pre-Franc) to over 10,000. Meanwhile, Jean Magoulet declared his daughter a prostitute. The reason? Money. To get his hands on a small sum that was legally hers. When the stock crashed, and the economies of France, England, and Holland collapsed.

"I spent long days going over prison files and the records' of Parisian notaries," says DeJean. "I also got to do less traditional and less ordinary research. Textile and embroidery curators, especially Susan North of the V and A, gave me a first-hand introduction to the wonders, and the work is truly wondrous,

of the great embroiderers of the early 18th century."

DeJean is currently writing a book about the other women, nearly a hundred of them, who were also accused of prostitution in 1719 in Paris and shipped off with Louise Magoulet.

DeJean is based in Philadelphia and spends several months a year in Paris. She was born in Louisiana.

## “King of Clubs” Peter Stringfellow dead at 77

THE WORLD of nightlife lost one of its icons this week with the death of Peter Stringfellow, the night club entrepreneur who rose from humble beginnings to host the A-list, millionaires, and royalty at his London establishments.

Stringfellow died of cancer at 77, it was announced Thursday.

Brought up in a hardscrabble steel town in northern England, Stringfellow began his life as an impresario after he was briefly imprisoned for a scam involving fake carpets.

He founded the Black Cat club - held on Friday nights in a church hall in his local town of Sheffield, which he rented for about £30 a time.

He famously booked the Beatles for £85, as well as the Kinks and the Rolling Stones. By his mid-twenties he had made it to London and founded the King Mojo club, where talents including Jimi Hendrix, the Who, Pink Floyd, Eric Clapton, Rod Stewart, and Elton John all played.

He moved on to Leeds where he opened Cinderella’s nightclub,

followed shortly by Rockefeller’s next door, and cemented his reputation as a northern club mogul with the opening of the Millionaire’s Club in Manchester.

Inevitably he soon made the move to the capital, coming to nationwide prominence with the opening of Stringfellows in London’s Covent Garden in 1980. In those halcyon days Stringfellows was

clubs in Paris, New York, Miami and Beverly Hills – the last being a huge disappointment. It opened in 1990, lasted less than a year and cost Stringfellow at least £4m in losses.

But as the nightclub business began to fade in the 1990s he Stringfellow pivoted to turn his clubs

into high class strip joints, and his London location later became notorious for its “Cabaret of Angels” with lap dancing table-side, which operated three days a week.

The venue’s website describes itself as “the most famous gentleman’s club in the world” and

“not a private club but a club for private people.”

Stringfellow leaves behind his 27-year-old wife Bella Wright, and his four children Rosabella, Angelo, Scott and Karen.

He was also a grandfather to Taylor, Jamie, Thomas and Isabelle.

## England finally end Test misery

■ Root's men square series after routing Pakistan in Leeds

England's cricket team finally put their miserable run behind them by surging to victory over Pakistan by an innings and 55 runs to win the second Test and draw the series 1-1.

Jos Buttler thrilled the crowd with his full range of strokeplay in a sparkling 80 not out to take England to 363 in their second innings - a 189-run lead.

And after Pakistan were reduced to 42-3, it never seemed likely that the game would reach day four at Headingley.

Off-spinner Dom Bess claimed his maiden Test wicket in returning 3-33, while Stuart Broad took 3-28 as Pakistan were 134 all out in their second innings.

It was a limp capitulation by the tourists, who failed to get anywhere near the performance of their nine-wicket win at Lord's.

For England, this was an ideal response to an awful display in London and ends a run of eight Tests without a win.

Their challenge now is to replicate this when they meet India over a five-Test series that begins in August.

Before then, they enter a period of limited-overs cricket against India and Australia after playing a one-day international against Scotland in Edinburgh on 10 June.

Last week's defeat at Lord's was not only the first time England have lost the opening Test of a home summer since 1995, but one of their worst home performances in recent memory.

They took severe criticism, but bounced back by displaying all the qualities they were lacking in London.

England took advantage of a swinging ball to dismiss Pakistan for 174 on day one and controlled the game from then on. Overall, this was a performance full of energy, determination and old-fashioned Test values.

And so, the question is: which is the real England? The one so poor last week, or so impressive in Leeds?

Skipper Root has insisted that their recent results have been indicative of a team underperforming, rather than one that is not good enough.

Only if England can play like this on a regular basis will he be proved right.

## Unhappy Yaya blasts Pep

Manchester City boss Pep Guardiola "often has problems with Africans", says ex-Blues midfielder Yaya Toure.

The Ivorian, who left City in May after eight years at the club, says he wants to "break the myth" about Guardiola, whom he describes as "jealous".

"Maybe we Africans are not always treated by some in the same way as others," said Toure in an interview with France Football.

Premier League champions City have declined to comment on Toure's views.

Before his departure, the club named one of their training pitches after him and unveiled a mosaic of him at their training complex.

This summer they are set to sign France-born Algerian international Riyad Mahrez from Leicester City.

Toure, an Ivory Coast international, played for Guardiola at Barcelona for two seasons until he was sold to City in 2010 for £24m.

He won six major trophies in England but started just one Premier League game in City's latest title-winning campaign - their final home fixture of the season against Brighton.

Prior to that game, Guardiola said: "Yaya came here at the start of the journey. Where we are now is because of what he has done."

"The Brighton game we will give him what he deserves, one of the most beautiful farewells a player can receive."

Toure completed 86 minutes against Brighton, having featured for 142 minutes in the league prior to that this season.

He believes that was "not down to physics",

saying he sought data from the club's trainers to compare himself to younger players.

Guardiola won six league titles as a player at Barcelona and has added a further seven as a manager during spells with the Catalan club, Bayern Munich and City.

Toure said: "I do not know why but I have the impression that he was jealous, he took me for a rival. As if I made him a little shade."

"He was cruel to me. I came to wonder if it was not because of my colour."

"I am not the first to talk about these differences in treatment. In Barca, some have also asked the question."

"When we realise he often has problems with Africans wherever he goes, I ask myself questions."

"I want to be the one who breaks the myth of Guardiola."

## £47m Fred the Red

Manchester United have reached an agreement to sign Brazil midfielder Fred from Shakhtar Donetsk for a reported £47m.

The 25-year-old, who has been selected for this summer's World Cup, is set to become Old Trafford boss Jose Mourinho's first signing of the summer.

United are also closing in on Porto's 19-year-old defender Diogo Dalot and should complete the deal this week.

Dalot has a £17.4m release clause and is

understood to have had his medical.

The transfer should hasten the exits of Italian full-back Matteo Darmian, who has been strongly linked with Juventus, and Netherlands defender Daley Blind, neither of whom has a long-term future under Mourinho.

Fred is in Brazil's World Cup squad and appeared as an 82nd-minute substitute for his country as they beat Croatia 2-0 in a friendly at Anfield on Sunday.

England concluded their World Cup preparations in impressive fashion by comfortably beating Costa Rica 2-0 at Elland Road on Thursday.

Manager Gareth Southgate made 10 changes from Saturday's win against Nigeria at Wembley - and was rewarded with some fine individual displays and a commanding team performance in their final friendly before they depart for Russia.

Manchester United forward Marcus Rashford was the standout performer, pressing his World Cup claims with an outstanding first-half strike to put England ahead and threatening throughout.

Burnley goalkeeper Nick Pope was given his debut as a second-half replacement for Jack Butland as Southgate made a host of changes, and Danny Welbeck - another substitute - wrapped up a thoroughly deserved win with a diving header from Dele Alli's ball.

Rashford has had a frustrating season at Old Trafford, where his starting appearances have been restricted, and his confidence appeared drained in the closing months of the campaign.

That meant his hopes of a starting place in England's World Cup line-up have drifted slightly - but this was an electrifying reminder of just what the 20-year-old
