MAY FACING NEW BREXIT REVOLT

■ Fresh showdown looms after redrafted wording on 'meaningful vote' deemed 'unacceptable'

EMBATTLED Prime Minister Theresa May is facing yet ANOTHER showdown with Conservative rebels after they rejected a government-drafted amendment to the EU withdrawal bill on Thursday.

The former minister Anna Soubry said she and her colleagues felt "badly let down" after they believed they had reached an agreement with the government – only to find the text had been redrafted at the last minute. The former attorney general Dominic Grieve held negotiations with the government over the precise wording of the amendment, which was aimed at making it more difficult for Britain to crash out of the EU without MPs being given a meaningful vote.

But he said the final version, which was tabled by the government at the last moment on Thursday evening, was "unacceptable".

Rebel peers now plan to table Grieve's original text when the bill goes back to the House of Lords on Monday – giving MPs a second chance to debate it when it is bounced

back to the Commons on Wednesday, in the arcane parliamentary process known as "ping pong".

More than a dozen Tory rebels believed they had been given a personal assurance by the prime minister, in a face-to-face meeting on Tuesday, that their concerns about the risk of a no-deal Brexit would be addressed.

But instead of Grieve's clause 5C, which would have allowed MPs to "direct" the government in the event of no deal, the new amendment just promised a debate on a motion "in neutral terms". Grieve, who tabled the original amendment, said this new draft was "unacceptable", because this phrase meant it would be impossible for MPs to amend the government's proposals – and force ministers to change their minds.

"It is unacceptable. At the end of the

process something was inexplicably changed, which had not been agreed. The government has made the motion unamendable, contrary to the usual methods of the House of Commons and therefore it cannot be accepted," he said.

Brexiteers denied that they had demanded the last-minute change to the bill, insisting it was the government that was determined not to allow MPs to tie ministers' hands at a crucial phase in the process of extricating Britain from the EU.

Some leavers are keen for Grieve and his colleagues to be confronted – and, they believe, defeated – to prevent the government using the tricky parliamentary arithmetic as an excuse for sliding towards an ever-softer Brexit.

The row is the latest challenge for May as **cont. on page 2, col. 4**

Collymore's 'Uncle Tom' jibe at TV rival Wrighty

■ Former Liverpool star dismisses Wright and others as 'comedians'

FORMER England strikers Ian Wright and Stan Collymore were at the centre of an extraordinary public racism row this week.

The pair re-ignited a long-running feud after Collymore, 47, blasted Wright with a foul-mouthed rant on social media. After an exchange of messages, Collymore appeared to dismiss Wright, 54, as an "Uncle Tom" – an offensive term meaning a black person who is

subservient to whites. The former footballers are in Russia covering the World Cup which kicks off on Thursday. While Wright is working for ITV, Collymore has his own show on Russian state television channel RT. The row erupted after Collymore gave a newspaper interview in which he discussed diversity in football and the lack of opportunities for black players in broadcasting. He suggested Wright and

fellow TV pundit Chris Kamara were successful broadcasters because they were "comedians". Collymore also hit out at former Spurs midfielder Jermaine Jenas and England female star Alex Scott. He said: "To be a black pundit you either need to be a comedian, like Chris Kamara or Ian Wright, or Jermaine Jenas and Alex Scott who are completely inoffensive. What you're not allowed to do is call out the status quo, which

is what I do."

But Wright hit back on Twitter saying: "Representation matters. Opportunities matter. I feel sorry for you but you have to let the chip on your shoulder go and take some responsibility for why broadcasters and brands won't be associated with you."

Wright then posted

a picture of himself and Kamara laughing. Collymore wrote back: "You know what you are, Ian, and always have been, which is why only you are employed by every British broadcaster. The epitome of a Tom."

Collymore was at the centre of a storm during the 1998 World Cup when he attacked then-

girlfriend Ulrika Jonsson in a bar. Collymore added in the interview: "Opportunities have been denied to me and it's got nothing to with what happened with Ulrika Jonsson. "No, it's because I've become increasingly outspoken and that's not allowed in this country if you're not white."

1200 surrender passports ahead of tournament

she seeks to balance the conflicting demands of the two wings of her warring party, in a hung parliament that makes winning every vote a challenge.

Grieve's amendment represented the only defeat for the government as the bill went through the House of Commons in December. A cross-party group of peers, led by the former Tory cabinet minister Lord Hailsham, then sought to strengthen it as the legislation went through the House of Lords.

May only bought off a looming rebellion in the Commons on Tuesday by holding a face-to-face meeting with MPs in her Westminster office in the closing moments of a fraught debate.

They believed they had been offered talks on a new clause c; but May subsequently insisted "the government's hand in the negotiations cannot be tied by parliament",

adding that she would not countenance any amendment that would allow parliament to "overturn the will of the British people".

A spokesman for insisted: "We have listened to those across the House who called for the ability to express their views, in the unlikely event that our preferred scenario did not come to pass."

He added that the government amendment "ensures that in all circumstances parliament can hold government to account, while also allowing government to deliver on the will of the British people as expressed in the referendum.

"But this remains hypothetical and the government is confident we will agree a good deal with the EU which parliament will support."

Soubry, who rejected the prime minister's assurances and voted against the government earlier this week, suggested the amendment had been tabled "without consultation", after the rebels believed they had a deal.

12 DEFEATED AMENDMENTS

Vote 1 Lords Amendment 110: Proposed to prevent the Government from using special powers to re-write EU regulations without parliamentary scrutiny. Government win by 22 votes.

Vote 2 Lords Amendment 128: Proposed strengthening parliamentary scrutiny of the use of secondary legislation. Government win by 21 votes.

Vote 3 Lords Amendment 37: Proposed removing the "11pm March 29 2018" exit date from the Bill and refers instead simply to "exit day". Government win by 25 votes.

Vote 10 Lords Amendment 45: Proposed further restrictions on the use of ministerial powers. Government win by 11 votes.

Vote 11 Lords Amendment 20: Proposed making the use of powers to implement a withdrawal agreement dependent upon Parliamentary approval of a mandate for negotiations on the UK's future relationship with the EU. Government win by 20 votes.

Vote 12 A series of Lords amendments relating to the transfer of EU powers to the Scottish Parliament and other devolved assemblies. Government win by 281 votes.

England ready to 'do some damage' says upbeat Kane

■ England skipper vows his team will 'take this tournament head-on'

THE Three Lions roared into Russia on Monday vowing to be brave – and to “do some damage” at the World Cup.

Captain Harry Kane admitted previous England teams had been “passive” and focused too much on dodging defeat. None has made the semis of a major tournament since 1996. But Kane said the team he led off the plane at St Petersburg airport was a new England determined to “take this tournament head-on”.

The Spurs star, hoping to be the first England skipper to lift the World Cup since Bobby Moore

52 years ago, said: “The aim is to be aggressive and brave in possession. In this team we wear our heart on our sleeve. We’re proud to be here, we will work hard, be energetic.

“We have a lot of attacking flair that can do some damage.

‘not the finished article’

“If we play with a smile on our face, enjoy our football, enjoy being in a tournament, then I think we will get results.”

Striker Marcus Rashford tweeted the England photo of the players in smart M&S three-piece suits and ties with the passionate

message: “Time to show the World what we’re about.” In one picture of the 23-man squad they are all seen holding up placards reading: “Show Racism The Red Card.”

The team flew to Russia aboard a 737-400 hired by the FA from VIP charter firm GainJet. They looked relaxed in trainers, T-shirts and tracksuits, some in baseball caps and with earphones slung round their necks. Tottenham duo Danny Rose and Eric Dier hugged each other as they boarded while Man Utd’s Jesse Lingard gave a thumbs-up. As they were in the air,

former England captain Wayne Rooney tweeted: “Good luck lads.”

Manager Gareth Southgate admitted his team was “not the finished article” but insisted they had

a “real desire and determination” to play

for their country and entertain fans. Shortly after their arrival in Russia England checked into the remote ForRestMix Club in the

village of Repino, where in between training the players can relax by playing table tennis or the computer game Fortnite. Both the hotel and training camp are heavily guarded.

Police say they will continue working to trace the remaining 58.

Police minister Nick Hurd said the action would ensure “thugs” would not “ruin the tournament for real fans”.

About 10,000 people from the UK are expected to travel to Russia for the World Cup.

‘genuine fans’

Supporters are being encouraged to be “good guests”, read up on the host cities and carry £200 in roubles at all times to cover emergency expenses.

In March, English police had to reassure Russian authorities only “genuine fans” would make the journey, after more than 100 supporters were arrested when England played the Netherlands in Amsterdam.

There were also violent clashes between Russia and England supporters when the two countries played each other in Marseille

at Euro 2016.

As well as the banning orders, police will be deployed at major UK ports during the World Cup to stop known troublemakers from travelling to Russia.

A delegation from the UK will travel to the country to work with their police counterparts during the tournament.

Football banning orders are imposed by courts and can last for up to 10 years.

There are currently 327 banned individuals who do not hold passports and they are not required to report to police.

Two years ago 1,406 people were ordered to surrender their passports prior to Euro 2016 in France, while 1,456 were asked to give them up before the 2014 World Cup in Brazil.

Deputy Chief Constable Mark Roberts, the national lead for football policing, said: “A comprehensive policing operation has been in place across the country to account for passports of those on banning orders, which has once again seen only a handful of those outstanding.”

Williams in hot water over opening performance?

Robbie Williams may have broken Russian law by kicking off the World Cup tournament on Thursday by giving middle finger to camera

The Take That singer flips his middle finger during a performance of ‘Rock DJ’ may have broken Russian law after flicking his middle finger at watching fans during the World Cup opening ceremony.

The country clamped down on explicit language in the arts in July 2014, banning the use of swear words in the arts.

Those who break the law will face “fines of between \$70 and \$1,400 depending on whether they’re an individual, an official or an organisation.”

The 44-year-old singer flipped his middle finger during a performance of “Rock DJ” at the Luzhniki Stadium in Moscow ahead of Russia’s opening match against Saudi Arabia.

Social media lit up in reaction, with one person tweeting: “Robbie Williams swearing at the camera at the opening ceremony of the World Cup just shows you what a tactless and classless

person he is. Absolutely disrespectful and coupled with a nonchalant performance. He won’t

care though. He will still get paid millions for it.” Williams - dressed in a red leopard print suit

- performed a number of hit tracks alongside Russian opera singer Aida Garifullina.

Jail for BA pilot four times over limit before flight

■ Court hears 'third pilot' downed three double vodkas before work on a night flight from Gatwick

A BRITISH Airways pilot who reported for duty more than four times over the drink limit was jailed on Monday.

Julian Monaghan, 49, had drunk wine and vodka before turning up for a night trip from Gatwick to Mauritius. He was arrested on board a Boeing 777 by armed police after a technician making pre-flight checks smelled booze on his breath. The father of two did not react as he was sentenced to eight months by a judge who told him he had put the safety of the aircraft and all those aboard at risk.

Lewes Crown Court in Sussex heard

Monaghan's career had "gone up in smoke", he would never work as a commercial pilot again and his teenage son had not spoken to him since the incident. Judge Janet Waddicor told him it must have been humiliating to be arrested and it was a "personal tragedy" he had lost his career. But she added: "What better deterrent for a pilot as to what can happen if you drink than to see what has happened to you."

South Africa-based Monaghan, who was dressed in a dark blue suit and white shirt, had pleaded guilty to reporting for duty while over the limit at

a previous hearing. The court had been told he had one glass of wine on an overnight flight to Gatwick from Cape Town, on which he travelled as a passenger. He had nothing to eat but then drank three vodkas with Diet Pepsi by 11.15am. After he was arrested aboard the jet due to take off at 8.20pm police found a reading of 86mg of alcohol per 100mg of blood. That was more than four times the 20mg limit allowed for pilots and above the drink-drive limit of 80mg. Pilots must follow a strict "bottle to throttle" policy forbidding them from drinking eight

hours before a flight. Monaghan, who was chewing gum when arrested, had been rostered as the jet's "third pilot" and had intended to sleep for several hours in a bunk until he was needed. But Judge Waddicor said he would have been called on to "step into the breach" if

anything had happened to the two other pilots.

She added: "The safety of passengers and public confidence in pilots is critical."

Emelyn Jones, mitigating, told the court: "This is a sad case from a personal perspective. He is a man of exemplary character who grew up

wanting to be a pilot as a boy. "He bitterly regrets what happened." After the hearing Monaghan, who had worked for BA for 17 years and was a senior first officer, was led to a prison van in handcuffs. The airline said his behaviour had been "completely unacceptable".

Eunice Gayson, first Bond Girl, dead at 90

Eunice Gayson - the actress who played the first "Bond girl" - has died at the age of 90.

Eunice played Sylvia Trench in 007's 1962 debut, Dr No.

During the filming Gayson helped calm Sean Connery's nerves so he could deliver the spy's most famous catchphrase - giving his name as "Bond, James Bond" - for the first time.

Gayson was seen as the first Bond girl, wearing a red, off-the-shoulder dress that showed off her dark hair and alabaster skin. Coolly, despite losing at chemin-de-fer to James Bond, played by Sean Connery, her character proposes raising the stakes. "I admire your courage, Miss, er..." remarks Bond, a cigarette dangling from his lips. "Trench," she says. "Sylvia Trench. I admire your luck, Mr..."

In the film, Connery's immortal line - "Bond,

James Bond" - is delivered smoothly. This was, however, entirely thanks to Gayson. He ruined take after take, babbling "Bond, Sean Bond" and even "James Connery".

Exasperated, the film's director, Terence Young, begged Gayson to take Connery for a liquid lunch. "I'd known Sean for years and I'd never seen him so nervous," Gayson recalled. Connery was on the wagon. "Oh I'm dying for a drink," she said, "do you want one?" The teetotal Gayson pretended to down her tippie, persuading Connery to join her "just for one".

Two glasses later Connery returned to the set in lighter mood. Now relaxed, he delivered his line with ease. "It was so wonderful," recalled Gayson. "The day took off from that moment."

She later appeared later in considerably less: a large white shirt and a

pair of heels, tapping a golf ball on Bond's living-room carpet. The director wanted her to be a regular Bond girl. "The running gag was meant to be that he always got whipped away whenever we got to the nitty-gritty," she said in 2012. Although Sylvia Trench reappears in From Russia with Love (1963), Gayson's character was dropped from future Bond films. Young had wanted to cast her as Miss Moneybags, but Gayson had signed up for the London production of The Sound of Music. He invented the part of Sylvia Trench for her. "I just want you in the film," Young told Gayson. "You're lucky. Whenever you are in a film I've directed it is a success."

So Gayson begged Oscar Hammerstein for "day release". He agreed on condition that she was flown by helicopter from the Dr No set every day to the Westminster helipad

near the Palace Theatre, the venue for The Sound of Music.

Gayson's success in The Sound of Music meant at one point she was earning £1,000 a week, and £500 for an hour's work opening a supermarket, but her decision to marry again in 1968 was financially disastrous. She renounced the stage to support her husband, the actor Brian Jackson,

with his plans to open a photography studio. They grew apart after Jackson went to South Africa for work, and when he broke a promise to fly back on a given date, Gayson divorced him. She never remarried, although her admirers were many. After the divorce her production company folded with £25,000 of debt.

A new low came in

1974, when Gayson was arrested for stealing 13 bottles of shoe polish. She said she had been in shock after a double dose of bad news. Her former father-in-law had been diagnosed with cancer. The same day the sale of her home in Haslemere, Surrey, collapsed. In the previous four years she had only worked for three weeks, it was reported at the hearing.

■ Couple laugh off divorce rumors - despite arriving and leaving in separate cars

THE Beckhams put on a united front this week as they were pictured together for the first time since they were forced to deny "ridiculous" divorce claims.

David and Victoria looked happy and relaxed as they spent their afternoon at a London fashion show. The superstar pair have been at the centre of "embarrassing" rumours and have denied "laughable" claims of an impending split. Victoria, 44, looked

delighted to be joining her husband at the Kent & Curwen label show in London after they arrived in separate cars. The couple sat together at a table in the front row with British Vogue editor-in-chief Edward Enninful positioned between them. The pair exchanged smiles across the table and at one point, Victoria reached across Mr Enninful to grasp her husband's hand in a show of affection. The former Spice Girl looked summery in a flowing

white dress and later posted a picture of David on social media, saying she was "so proud" of the fashion collection which he had helped create.

fever pitch

The Beckhams were forced to shoot down the split claims after the rumor mill went into overdrive on Friday. Bookmakers even suspended betting on the couplesplitting as rumors reached fever pitch. On Saturday, Victoria appeared pensive as

she was pictured out and about in the capital. As her representatives batted away the claims as "embarrassing", Victoria looked customarily chic, wearing a loose blue shirt tucked into dark trousers. She covered her eyes with large sunglasses and made a quick exit from a Mayfair hotel. David, 43, jetted back from a whistlestop business trip to the US and showed no signs of stress. He was a star guest at the prestigious London Fashion Week Men's event. The former

England captain looked stylishly low-key in a tan-coloured jacket and brown trousers which he teamed with suede shoes. Victoria was said to be "taken aback" by the claims of a break-up on social media at the weekend and jokingly asked David, while still in America, "are you divorcing me?"

A friend of the couple said they had laughed about the claims and it was a "mystery" as to how they had started. A spokesman for David has branded them "embarrassing

and laughable". A spokeswoman for Victoria said the claims were "fake news". Meanwhile, the couple, who have been married for almost 19 years, are set to pose with the children in a photo shoot for fashion bible Vogue. The couple and Brooklyn, 19, Romeo, 15, Cruz, 13 and Harper, six, will appear on the cover. An insider at the magazine said it was a "coup" to get the family together for the feature which will celebrate Victoria's life as a "businesswoman, mother and wife".

Guilt: twinning a psychological battle

■ Exclusive interview with Amanda Robson, author of a new psychological thriller set in Bristol



"I have always loved psychological thrillers, especially the historical dual timeline novels by Kate Mosse: *Labyrinth*, *Sepulchre* and *Citadel*, as well as by Barbara Robson: *Lady of Hay*, *Sands of Time* and *River of Destiny*," says *Guilt* author Amanda Robson. "*The Lollipop Shoes* by Joanne Harris has also greatly inspired me. Psychological thrillers have an intensity that I find totally absorbing. Their mind game play. I love people-watching, anticipating reaction and consequence."

In Robson's new book *Guilt*, fraternal twins Zara and Miranda are very close but very different. Zara is sensitive, social and artistic. Miranda is the practical one. Zara is going to art school and moves in with Miranda, an accountant living in Bristol. Zara meets Sebastian, a master manipulator. She is easily manipulated by Sebastian, and Miranda isn't safe either. Dark and disturbing, this psychological thriller shatters the close family bonds of the two sisters. The story is told from three different points of view.

"I dreamed of writing a novel from the age of twelve," says Robson. "But, I had a scientific career and the enjoyment of being a stay-at-home mum for many years before I finally made time to follow my dream. My advice to aspiring writers is keep persevering.

Second, treasure your imagination. Believe in yourself. A lot of people can write in grammatically correct sentences, but only some people can do that and tell a good story as well."

During Robson's research, she spoke with experts in the medical profession and the police.

"Since a murder trial is pivotal to the novel, I visited a criminal barrister in Bristol, and subsequently watched the murder trial he was defending," says Robson. "A contact of his, a female ex-prisoner, also very kindly invited me to her home and described her experiences at the local prison with me in detail, therefore the prison scenes are as accurate as possible."

"My main protagonists Zara and Miranda were brought up in the dormitory town outside Liverpool, where I lived

as a child," says Robson. "Forty years on, I took the opportunity to revisit my childhood home town. I found it a rather unnerving experience, as physically everything was so familiar and yet I no longer belonged."

Robson's story of women manipulated springs from her own experiences with sexual harassment as a young woman in the workplace in the 1980s. For months her manager would speak to and touch her inappropriately. Her complaints to Personnel did nothing. The manager tried to sabotage her transfer to another department in the company. Robson says she vividly recalls a toxic combination of shame, discomfort, fear, frustration and anger. Emotions she channeled into her novel.

This is the Robson's second published novel. Her novel *Obsession* was released in the UK

and the U.S. last year. She is also a co-author of a medical book on cyanide poisoning. *Obsession* hit the Kindle top 100, staying there for weeks, and reached #1 on the iBooks bestseller list. *Guilt* has yet to be optioned for film or TV.

Robson has a physiology degree from London University with and a Masters from City University. She worked in medical research at The London School of Hygiene and Tropical Medicine and at the Poisons Unit at Guy's Hospital.

Robson takes six months to write a novel. "Working very long hours, I have tight deadlines for my novels," says Robson. "My PR team does a good job getting me opportunities in the press and media. I have lots of exciting extra projects, like writing blogs, magazine articles or short stories. But this

means I work long hours, including weekends and from time to time when I am supposed to be on a family holiday. I am not complaining though. I wouldn't swap this job for the world."

This couple went public with their romance last March when they were spotted kissing and dancing in LA, but now Cara Delevingne and Paris Jackson have amicably decided to call it a day.

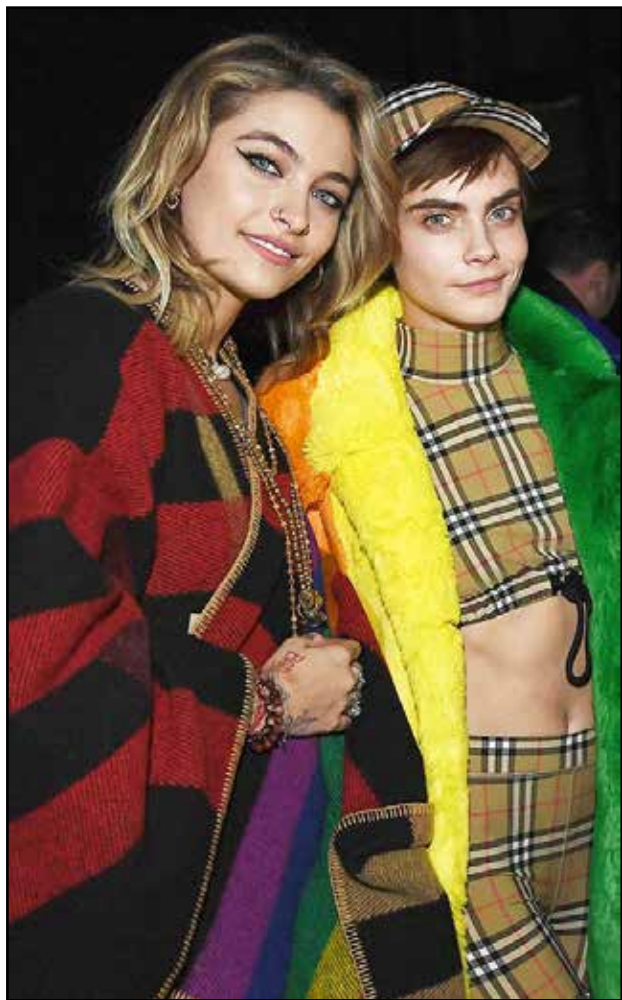

Top-ranked England left stunned by Scotland in ODI

ENGLAND'S number one-ranked one-day cricket team were in shock this week after losing a one-day international against the minnows from north of the border, Scotland.

Eoin Morgan's team were favourites for next year's World Cup on home soil after winning their past six series – and that included tours of Australia and New Zealand. That tag will have to be rapidly reassessed after this humbling by a side who have not even qualified for the tournament and are 13th in the world.

That England were pushed towards defeat by a batsman in Calum Macleod who is currently playing club cricket in Kent makes this story all the more remarkable.

Macleod's sensational unbeaten 140 meant Morgan's men were left needing 372 to win on this postage stamp of a ground. That would have been a record chase for England. Yet the brutal truth is they should still have won this contest after their reply got off to a flying start when Jonny Bairstow became the first Englishman in ODI history to hit three successive hundreds. It was a collapse of 5-56 midway through the innings that lost Morgan's men this match and gave Scotland their first win against the Auld Enemy in cricket. The run-out of Joe Root in the 27th over of the chase proved crucial. England were coasting on 220-2 when Alex Hales called for a non-existent single that

left Root out of his ground following a sharp throw from Mark Watt. With just 152 runs needed off 23 overs, England were still overwhelming favourites to win. But the wickets kept falling. Skipper Morgan was in fine touch as he reached 20 from 15 balls. But he was caught at short midwicket by Scotland captain Kyle Coetzer after a loose shot to Alasdair Evans. That left England at 245-4 and they were five down the very next ball when Hales inexplicably hit Richie Berrington straight to point. Sam Billings, sending a Watt full toss to short midwicket, and David Willey, edging Evans behind, then departed to leave England seven down and still needing 96 to win from 13.3 overs. A 71-run

stand between Moeen Ali, the last recognized batsman, and Liam Plunkett revived England hopes. But 25 runs were still needed to win from 27 balls when Moeen holed out to Watt.

That brought Adil Rashid to the crease but, with 11 needed from the final two overs, he was sensationally run out by Macleod to leave England nine wickets down. Cue bedlam when four balls later Safyaan Sharif

trapped Mark Wood lbw to seal a famous victory.

And the Scots had rightly fancied their chances at the halfway mark after Macleod's batting heroics. The 29-year-old Glaswegian is currently playing for Hampshire's second team and Bexley Cricket Club in Kent. However, he cut England's attack to ribbons during his power-packed 94-ball knock. Macleod plundered 19 of Scotland's 53 boundaries

as they posted their record total in ODIs. His hundred had come in 70 deliveries – and that was also the fastest by anyone for Scotland. England were missing Chris Woakes, who was out with a thigh injury, and the absence of the man who has become the leader of this team's one-day attack was keenly felt as the hosts took full advantage of a flat pitch and lightning-quick outfield.

Allardyce, 63, who has since gone on to manage Crystal Palace and Everton, was only at the helm for a World Cup qualifier in Slovakia in September 2016.

Adam Lallana's injury-time goal gave England a 1-0 win before Allardyce's reign ended after only 67 days, making him the national side's shortest-serving full-time manager.

He left after he was filmed by undercover reporters from the Daily Telegraph posing as businessmen for a meeting at which Allardyce reportedly said it was "not a problem" to bypass rules on third-party player ownership, and claimed he knew of agents who were "doing it all the time".

The Telegraph investigation also claimed

that a £400,000 deal was struck for Allardyce to represent the company to Far East investors and to be a keynote speaker at events – although he stressed he would have to "run that by" his employers.

The FA called his conduct inappropriate and Allardyce made a "wholehearted apology" – adding that he recognised some of his comments had "caused embarrassment".

Nearly two years on, as the England team head to Russia for the World Cup, Allardyce said:

"Jealous is what I feel. Massively disappointed. That should be me there. Unfortunately because of the circumstances that wasn't the case.

"One night I was playing golf – next day they said you can't carry on. And I still don't know why... because in the cold light of day, there was no substance, nothing behind it.

"If a bit more time was taken, a bit more patience, I believe I should still be the England manager."

Southgate replaced Allardyce and guided England to the top of their World Cup qualifying group unbeaten, with seven wins and two draws from his matches in charge.

The former coach said: "I've bounced back now – and while I will be extremely jealous I will be watching Gareth and the lads and hope they do extremely well."

Asked whether managing the national team was an impossible task, Allardyce added: "It's not the impossible job because people keep doing it. You've got to take the opportunity – it's the greatest challenge there is.

"I'm really proud to be the man in the spotlight, even though it wasn't for long enough. It will always be one of the biggest moments in my career."

Hoops close to record fee for Edouard

Celtic have agreed a club record fee with Paris St-Germain for striker Odsonne Edouard and talks are "progressing" on a permanent deal.

The 20-year-old spent last season on loan at Celtic from PSG, scoring 11 goals.

BBC Scotland understand the French side were hoping to receive a transfer fee in excess of £8m.

Celtic's record outlay is the £6m paid for both Chris Sutton and John Hartson in 2000 and 2001, respectively.

Speaking in March after Edouard scored the decisive goal in a 3-2 victory over Rangers at Ibrox, Celtic boss Brendan Rodgers said: "He is one of the best young players I have worked with – his movement, his touch, his all-round play."

Edouard scored two more derby goals in a 5-0 win at Celtic Park in late April.

However, his season was curtailed by a hamstring injury which forced him to miss the

club's Scottish Cup final success.

PSG need to sell 60m euros (£52.9m) worth of players by the end of June, to comply with financial fair play (FFP) rules.

Young: We Need A Fast Start!

■ "We are here, looking to do well in training and win our first match."

Ashley Young expects England to shed their tag of slow starters when they open their World Cup campaign against Tunisia on Monday.

England last started a major tournament with a win at the 2006 World Cup.

And Manchester United left-back Young expects this squad to reverse that trend in the searing heat of Volgograd.

"You can see in our last two games against Nigeria and Costa Rica that we've started brightly and on the front foot and scored early goals," he said.

"If you start like that in tournaments it could put teams on the back foot and that's what we're looking to do in the first game."

After Monday's Group G opener against Tunisia, England will face Panama on 24 June and

Belgium on 28 June.

Speaking after their first training session in Zelenogorsk, 32-year-old Young said: "It is always important to make a good start in a tournament.

"We want to get off to winning ways. We know each game is going to be tough but we're fully prepared for that first game.

"You can talk about what has happened historically. We are here, looking to do well in training and win our first match."

Young says England's players are pleased with the facilities at their hotel in Repino and at their training base, where they held an open session on Tuesday. They were welcomed by local officials and then spent time at the end signing autographs.

"The facilities are brilliant," said Young, the oldest member of the

squad. "Everything is there for us. The Football Association has done a magnificent job for us.

"It is a fantastic environment with lots of things to do in there. A lot has been said about getting bored but there will be nothing like that at all. The boys won't be getting bored in the hotel - there are plenty of things to do."

Young said that while there is always pressure on an England squad at

the start of a World Cup, he is confident Gareth Southgate's squad can cope with it.

"We just want to get out here and get the tournament started. Everything is there for us," he added.

"There is a feeling of

excitement around the squad and the staff. We are fully prepared and ready for the tournament to start now.

"There is always pressure. There is more pressure because it's a World Cup but I think every player in this squad

has dealt with pressure and is able to go and handle it. It is a young squad but also a squad with experience as well.

"When you're a kid you want to play in the big tournaments and I'm as excited as anyone else out there."



Allardyce 'jealous' of Southgate

Former England boss Sam Allardyce says he is "jealous" of Gareth Southgate and believes it should be him leading the national team at the World Cup.

Allardyce (pictured,

above) left his post as England coach by mutual agreement in September 2016 after only one match in charge.

His exit followed claims by a newspaper that he gave advice on how to "get

around" player transfer rules.

In a BBC documentary to air on Sunday, Allardyce said of his departure: "That decision was made very hastily."

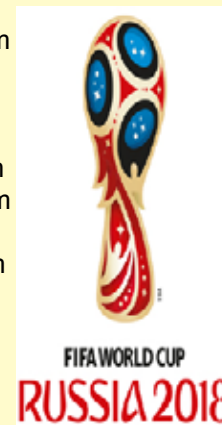
