Trump visit: 100,000 protesters expected

■ Steel fencing and concrete bollards erected around US Ambassador's residence

LONDON Police were facing an enormous extra workload this week as it emerged 100,000 protesters were expected during President Trump's four-day visit to Britain.

At press time on Thursday the capital saw the biggest mobilisation of officers since the 2011 riots, needed to deal with the patchwork of groups criticizing the US president's politics and morals. It is estimated that it will cost up to £10 million.

In anticipation of the unprecedented vitriol directed at a serving president, the US embassy told Americans to keep a low profile and "exercise caution if unexpectedly in the vicinity of large gatherings that may become violent".

Mr Trump landed Thursday afternoon before attending a black-tie dinner at Blenheim Palace in his honour, where protesters will plan to gather at the gates. He was scheduled to spend his only night in London at the US ambassador's official residence, Winfield House in Regent's

Park, which has been surrounded by a 9ft-high steel fence and concrete bollards.

Residents said the fencing had never been deployed round the ambassador's residence for a presidential visit before. Workmen erecting the "ring of steel" said that they had been called "murderers" and asked how they slept at night by people walking through the park.

angry baby

Pauline Watson, 73, from St John's Wood, north London, said the security fence cutting through the park was "absolutely disgusting . . . It looks like a war zone. He has brought his wall to England and it's ridiculous. When Obama came here there was nothing like this. It shows you just how hated the man is."

An all-night protest on the perimeter fence

called Keep Trump Awake was scheduled to start at 8pm. Protesters are encouraged to bring pots and pans, drums and vuvuzelas.

On Friday Mr Trump was scheduled to visit Sandhurst with Theresa May before a working lunch at Chequers. A farmer whose field is on the flight path has allowed a crop circle to be made in his wheat field which spells out "F*** Trump".

The main protests were scheduled to take place in London on Friday, including a 20ft high inflatable of Mr Trump depicted as an angry baby in a nappy in Parliament Square. More than 50,000 people were expected to join the Together Against Trump march and rally, organised by left-wing campaign groups including the Stop the War Coalition. Chris Nineham, its vice-chairman, has said

the movement's aim is "opposing the West". It takes a pro-Kremlin line in international conflicts and its patrons include Diane Abbott, the shadow home secretary.

A Women's March is also expected to have tens of thousands of protesters. While these demonstrations take place Mr Trump and his wife, Melania,

after passing over the offending wheatfield in Buckinghamshire, were expected to travel to Windsor Castle to meet the Queen before flying **cont. on page 5, col. 1**

Embattled May faces new Tory rebellion

■ Davis and Johnson resign over PM's Brexit plan, Tory leadership contest expected during autumn session

THERESA MAY'S fragile grip on power grew ever weaker this week as she faced a rebellion by dozens of her own MPs in a Commons vote that they hope will deliver a blow to her Chequers plan for Brexit.

Hot on the heels of the resignation of both David Davis and Foreign Secretary Boris Johnson at the weekend over her plan, which she outlined at an emergency meeting at her country seat at Chequers on Saturday, came news that one of her principal rivals for leadership of the party, Jacob Rees-Mogg, who leads the European Research Group of Brexiteer Tory MPs, was tabling amendments to a bill that would challenge the plan.

'dilemma'

"Unfortunately Chequers was a breakdown in trust," he said. "Brexit meant Brexit, but now it appears Brexit means remaining subject to European laws."

He told The Sun: "I believe this will help the government stick to the promises it made. It may resolve the dilemma the prime minister faces. Does

she rely on Labour votes to achieve Brexit or does she change her mind and go back to Lancaster House? Will she stick to her earlier words?"

One of the four amendments to the customs and trade bill, which returns to the Commons next week, demands that the UK scraps an offer to collect taxes and duties on behalf of the EU unless the remaining 27 member states pledge to do the same for Britain. This is explicitly designed to kill Mrs May's customs proposal.

A second would force the government to commit itself in law not to allow a customs border down the Irish Sea. This is largely uncontroversial and could easily be accepted by the government.

The others would require the UK to have a separate VAT regime from the EU and force the prime minister to table primary legislation if she wishes to keep Britain in the customs union.

Brexiteers know that these amendments will not be passed into law since Labour will not vote with the Tory rebels. The amendments are designed

as a show of numerical strength to demonstrate how many Brexiteers are prepared to defy Mrs May in the division lobbies, with some predicting upwards of 30 rebels.

'in turmoil'

The prime minister is also facing a rebellion from some Remain MPs on the same legislation.

The 2017 election result means that even with DUP support it would only take about six Brexiteers to vote against the final withdrawal agreement, meaning that it would only pass with help from the opposition.

In a further blow, President Trump said that he wanted to speak to his "friend" Boris Johnson during his three-day visit, which started on Wednesday. He declared Britain to be "in turmoil".

The prime minister's team was openly criticized the former chief of staff to David Davis. The Tory former MP Stewart Jackson said that Mrs May's chief Europe adviser, Oliver Robbins, wanted a "Hotel California Brexit" where Britain checks out but never leaves. He also

attacked Mrs May's communications director, Robbie Gibb, as an "ersatz Brexiteer".

Mr Jackson's outburst came after it was claimed that he was blocked from acting as an aide to the new Brexit secretary, Dominic Raab. In the worst Tory infighting since the EU referendum, leaked messages from hard Brexiteers on WhatsApp revealed the discomfort with Mrs May's stance.

"battle lines"

In a message written after Mr Davis quit as Brexit secretary on Sunday, Laurence Robertson, the MP for Tewkesbury, said: "The sycophants and careerists will rally round the PM and her position, whereas the rest of us will be fighting for the future of our country. Those will be the battle lines."

Meanwhile Downing Street has opened talks with Labour and other opposition parties, to the anger of many Tories. However, they still look likely to refuse to support Mrs May's eventual deal.

In the event that Mrs May's deal is voted down, Britain is likely to head to a no-deal Brexit, although this too may be blocked by further parliamentary votes resulting in gridlock and constitutional chaos.

Downing Street denied as "categorically wrong" claims in The Spectator that Mrs May refused to change parts of the Chequers agreement because she said that they had been cleared with Angela Merkel, the German chancellor.

And former Conservative leader Lord Hague of Richmond also

weighed in, saying that Mrs May's deal was the best possible within the constraints and warned his fellow Brexiteers to "think very hard" before voting it down. He told *Today* on BBC Radio 4: "That is the point at which they are going to endanger everything they have been trying to achieve."

England fans 'proud' despite heartbreaking Croatia loss

■ "You've had an incredible World Cup, made history, and gave us fans something to believe in."

Proud England fans praised the World Cup team despite their loss against Croatia Wednesday night.

Celebrities and supporters in Russia and those at home described Gareth Southgate's young players as heroes for making it to the semi-finals and uniting the country.

The Duke of Cambridge, who is president of the Football Association, told the players that they should hold their heads high and not be disappointed. He said: "You've had an incredible World Cup, made history, and gave us fans something to believe in. We know there is more to come from this England team."

Thousands of fans gathered at outdoor screenings across Britain last night for the knockout games as World Cup fever gained momentum. The scenes were more subdued than the drunken chaos that

followed the quarter-final victory against Sweden last weekend, when police dealt with 387 football-related incidents.

In the wake of the defeat, supporters have thanked the team for restoring pride in English football. Gary Lineker said: "Utterly choked but this young side gave absolutely everything. It's a huge step forward and they will get better."

'Sad. Proud. Annoyed.'

David Baddiel, co-writer of the Three Lions song, the unofficial anthem of England's World Cup journey, tweeted: "Thank to the England team, and manager, for giving us this beautiful world cup run. It's been a ride."

Stephen Fry wrote: "Sad. Proud. Annoyed. Relieved. Disappointed. Unsurprised. Impressed. Vexed. Gutted. Elated. Deflated. Despondent. Encouraged. Defeated.

Defiant. Broken. Resilient. Inspired. Silly. All those things."

After an emotional end to the match, in which the manager embraced every player on the pitch, Southgate said: "The dressing room and all of the staff is in a very difficult place at the moment. Having said that, what I will say is that I am remarkably proud of the group of players that have really advanced. It's impossible to say anything to them to make them feel better at this moment of time."

England fans in Moscow celebrated despite the defeat, with many saying that this

was the best England team in years. Andy Bradley, 42, from Hull, said: "Seventy minutes we battered them. We take it on the chin, we move on. England we're proud of you."

However, for some the disappointment was too great and many are expected to return to the UK in the coming days despite Saturday's match against Belgium to secure third place.

Parv Moondi, 49, from Norwich, said: "We had our flights booked for next Monday — we booked two flights, we weren't that optimistic, we have flights tomorrow as well."

Millions tune in to watch England drop out

England's semi-final defeat to Croatia was the most-watched television event since the funeral of Princess Diana.

An average of 24.3 million people watched Gareth Southgate's team go out of the World Cup on ITV1 Wednesday night.

This is higher than the 23.4 million average audience for the London 2012 Olympics opening ceremony, the last blockbuster event on British television.

Ratings for the England game peaked at 26.6 million between 9.30pm and 9.35pm during the final moments of extra time as the Three Lions chased an equaliser.

This represents an 84 per cent share of all people watching television at that time. The figures do not take into account fans who watched England's 2-1 defeat in pubs or on outdoor big screens.

The average viewing figures are bigger than the audiences for both the opening and closing ceremonies of London 2012, and Torvill and Dean

in 1994 at the Lillehammer Winter Olympics.

The funeral of Princess Diana in 1997 was watched by about 32 million people, while England's triumph over West Germany in the 1966 World Cup final was seen by a combined audience of 32.3 million on BBC and ITV.

Wednesday night's average of 24.3 million was the biggest television audience for a football match broadcast on a single channel.

England's semi-final against West Germany

at Italia '90 was shown on ITV and BBC, as was England v Argentina in Mexico 1986.

The tie was also viewed 4.3 million times on ITV Hub, the streaming service's greatest number for live programming.

The viewing figures - nearly half the total population of the UK - outstrip those for all other England games at this year's tournament in Russia.

The quarter-final against Sweden on Saturday afternoon was watched by

nearly 20 million people on BBC One, while 24 million saw England's first knockout game against Colombia on ITV.

The high ratings demonstrate the continued appeal of live broadcast television for major sporting fixtures and national events, despite the rise of streaming services.

Meanwhile, people watching the England-Croatia game on YouTube TV in the US had their viewing disrupted when the service went down.

Thai cave diver insists: “we are not heroes”

“We are very happy that the boys are out and safe.”

One of the British divers who helped to save 12 schoolboys and their football coach from a flooded cave in Thailand arrived back in Britain on Thursday, declaring: “We are not heroes.”

John Volanthen and Rick Stanton were the first divers to reach the stranded group in an underground network in Chiang Rai province and there have been calls for them to be honoured.

However, asked about a possible award, Mr Volanthen, 47, an IT consultant from Bristol, said: “We are not heroes. What we do is very calculating, very calm, it’s quite the opposite. That’s what we do. We take it one step at a time, and hopefully - as we’ve managed to in this case - we come up with the result.”

Mr Volanthen flew in from Bangkok and, as he walked into the arrivals hall, a tearful woman, believed to be Thai, who may have been on the plane with him, pressed a box of chocolates on to him, hugged him and said: “Thank you so much for everything you have done for us.”

He replied: “We were pleased it worked out.”

‘very relieved’

Mr Volanthen also spoke of the relief he felt at seeing the boys rescued after an 18-day ordeal in the Tham Luang caves. “We are very happy that the boys are out and safe.”

Asked what he thought when he and Mr Stanton first found the boys, two and a half miles into the cave complex, he said: “Relief is the word I would use

to describe it. We are very pleased, and we are very relieved that they are all alive. At that point we realised the enormity of the situation, and that’s perhaps why it took a while to get them all out.”

Praising the work of Richard Harris, the Australian doctor who went into the cave to give each of the boys the medical all-clear before they were evacuated, he said: “Dr Harris, he’s very good, he’s got a very good bedside manner, he’s got a very bouncy Australian accent and they seemed to find that quite relaxing and reassuring.”

‘bittersweet’

Mr Volanthen, who has shunned media attention, emphasized that the rescue was the work

of a large international team. Describing the conditions, he said that the cave was “obviously flooded, dark, poor visibility under water, so a lot of difficulty. But with a strong international team we were able to overcome those difficulties and ultimately the results speak for themselves.”

Mr Volanthen also paid tribute to the Thai navy diver Saman Kunan, who died while replenishing oxygen canisters, saying that his death

brought a “bittersweet” taste to an otherwise “excellent” operation. “Our condolences to Saman and his family,” he said. “It’s an absolute tragedy.”

Earlier, as they passed through Bangkok airport, Mr Volanthen and Jason Mallinson, another diver, were given free flights to Thailand for life.

Wirasak Kowsoorad, the tourism minister, presented them with medals and certificates and said: “This is to

show our appreciation, our prime minister asked for you to be given this. Thank you so much for your effort. It was a great rescue and we very appreciate it.

“Now, both of you, you will always be welcome, any time, you have so many friends here.”

Arkhom Termpittayapaisith, the transport minister, shook their hands and said: “Consider it free tickets to Thailand, any time”.

Former ambassador to Washington hospitalized after brutal London attack

Sir Christopher Meyer, the former ambassador to the US, is in hospital after two youths attacked him at Victoria station in London.

Sir Christopher, 74, was left with injuries to his left eye, nose and lip after the assault.

His wife, Baroness Meyer, said that he was taking the Tube home when he was attacked. “He looks terrible. His left eye is like a golf ball and bleeding, the nose looks like it could be broken,” she said.

“He hasn’t had an x-ray yet. He doesn’t remember anything. The first thing he remembers is the police.

“At first I thought

that the attack was politically motivated. He is opinionated, and sometimes people have different opinions, but the police told me they believe that it is more likely that they might have wanted to rob him.

“Nothing was taken, but the transport police intervened quickly.”

long career

Lady Meyer believes that police have made two arrests in connection with the attack.

Sir Christopher is active on Twitter, where he frequently expresses political opinions. He recently called for Britain to engage with President Trump during

his visit, and not to turn its back on him.

Sir Christopher joined the Foreign and Commonwealth Office in 1966 and spent his early years as a diplomat in Russia and Spain. He was also ambassador to Germany.

Before taking up his post in Washington he served as a government spokesman and chief press secretary to Sir John Major, then the prime minister, from 1994-96.

His long career has included a stint as chief speech writer for three foreign secretaries: James Callaghan, Anthony Crosland and David Owen.

He was chairman of the now defunct Press Complaints Commission for six years from 2003.

Sir Christopher was the longest serving British ambassador to the US since the Second World War and his

time in Washington coincided with 9/11 and the preparation for war in Iraq, as well as the wars in Kosovo, Sierra Leone and Afghanistan.

Gun crime, knife crime, murder and robbery have risen every year for the past three

years in England and Wales, and there have been about 81 murders in London alone this year, compared with 116 last year. The rate is already at a ten-year high and should it continue it will exceed the 2003 peak of 180.

He's done it again! 'Sick' Baron Cohen dupes Palin

'Borat' and 'Ali G' star fools former VP candidate by posing as a wounded vet

BRITISH comic actor Sacha Baron Cohen may have bagged one of the biggest trophies of his career, by duping former Republican vice-presidential candidate Sarah Palin.

The former governor of Alaska and darling of the country's right wing, said Cohen "duped" her in an interview by posing as a wounded military veteran.

The Borat star has been secretly filming for a new satirical comedy series that will air on TV next week.

It was revealed on Monday the show - titled *Who is America?* - would explore "diverse individuals" in the US "across the political and cultural spectrum".

Palin wrote on Facebook: "Yup - we were duped. Ya' got me,

Sacha. Feel better?"

She went on: "I join a long list of American public personalities who have fallen victim to the evil, exploitive, sick 'humour' of the British 'comedian' Sacha Baron Cohen, enabled and sponsored by CBS/Showtime."

Baron Cohen is best known for hoaxing interviewees as comedy characters Ali G, Borat Sagdiyev and fashion reporter Bruno, all of whom inspired big-screen films.

Palin, the former governor of Alaska, said she received a request to contribute to a "legit historical documentary" and travelled across the US with one of her daughters.

She wrote: "Baron Cohen (I presume) had heavily disguised himself as a disabled US Veteran, fake wheelchair and all.

"Out of respect for what I was led to believe would be a thoughtful

discussion with someone who had served in uniform, I sat through a long 'interview' full of Hollywoodism's disrespect and sarcasm - but finally had enough and literally, physically removed my mic and walked out, much to Cohen's chagrin.

'How dare you'

"The disrespect of our US military and middle-class Americans via Cohen's

foreign commentaries under the guise of interview questions was perverse."

Palin, who asked for the proceeds from the program to be donated to charity, added: "Mock politicians and innocent public personalities all you want, if that lets you sleep at night, but HOW DARE YOU mock those who have fought and served our country. Truly sick."

Last week, the comedian teased his comeback with a preview clip showing former US vice president Dick Cheney apparently agreeing to autograph a "waterboard kit" - in reality a plastic water jug.

Who is America? will premiere on Showtime in the US on Sunday and the network has promised it will show the comedian and actor "as you've never seen him before".

Le Bon denies assault claim

Duran Duran star Simon Le Bon has denied sexually assaulting a fan, saying her story is "simply untrue".

Shereen Hariri said the singer groped her while signing autographs at the record store where she worked in 1995.

Writing on Facebook, she said Le Bon was posing for photos when he grabbed her "butt cheek" and started "making his way down my butt to my genitals".

"I was shocked and completely frozen," she continued, adding that she is not seeking compensation, only an apology.

Hariri, who is now 47 and works as a therapist in Los Angeles, said she was "afraid of the consequences" of confronting the star after the incident.

"If I made a scene, I'd

be in the press: The 'Girl Who Accused Simon Le Bon'. I'd probably be fired, rejected, ignored, even hated," she wrote.

She changed her mind after the release of Donald Trump's notorious "grab them by the pussy" tape in October 2016.

"I decided that time's up. I'm not holding this secret anymore," she wrote in her statement.

In response, Le Bon posted a message on Duran Duran's official Facebook page, challenging her depiction of the 1995 incident, at The Warehouse music store in Los Angeles.

"The behaviour that Ms Hariri has accused me of, would have been just as inappropriate and unacceptable to me then as it is today. But the allegation is simply untrue."

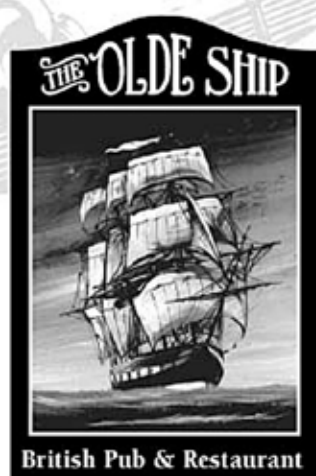
Police have objected

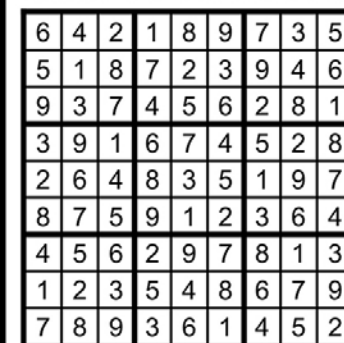

Not Impossible: Pegg 'feared death' through drink and depression

Actor Simon Pegg has revealed he spent years hiding an alcohol addiction before it reached a point where his wife had enough and he ended up in rehab where he got the help he so desperately needed.

The film star, who has battled depression since the age of 18 and coped with the condition by drinking, thinks his alcoholism would have killed him if he hadn't gone to rehab.

The Sean of the Dead star, now in a healthy state as he promotes the latest installment of the franchise Mission: Impossible — Fallout, remembers all too clearly just a few years ago, he was living a much different reality.

Oo-er! After playing field agent Benji Dunn in the third blockbuster opposite Tom Cruise, Pegg opened up about his battle with depression and alcoholism in a new interview with the UK's Guardian.

"When I watch that film back, I can see where I was then, which was

fairly lost, and unhappy, and an alcoholic," he told the publication.

"It was awful, terrible," he added. "It owned me."

He describes the years that followed as "the crisis years" but it wasn't until later that he sought help.

Pegg said his "crisis years" were marked by a dependence on alcohol to numb feelings of sadness.

"I would feel like - I'm in a film with Tom Cruise, I've got the part of Scotty in "Star Trek." This should be making me feel happy," he said. "But

it wasn't."

Pegg said rehab and seeking help from Alcoholics Anonymous helped him get on the path toward health.

Pegg went into recovery as shooting started on 2011's Mission: Impossible — Ghost Protocol.

"I don't think I would be here now if I hadn't had help," he said.

With so much negativity swirling around the world these days, the way to survive is to stand up and face your demons... Brave man Simon, well done... I commend you!

Conte to leave Chelsea

Chelsea are set to announce the departure of manager Antonio Conte after two years in charge.

The club have refused to comment on the status of the 48-year-old, who won the Premier League title in his first season and the FA Cup in May.

Conte took pre-season training this week but his future has been a source of contention and ex-Napoli manager Maurizio Sarri expected to take over.

The Blues have reportedly agreed on a compensation package for Sarri, 59.

Should Sarri be appointed, he would be Chelsea's ninth full-time manager since Roman Abramovich bought the club in 2003.

During three years with Napoli, Sarri has not won a major honour but has guided the club to finishes of second, third and second again - behind Juventus in 2017-18. The former Empoli manager was named Serie A Coach of the Year in 2016-17.

Conte's future was

under scrutiny even as his side beat Manchester United to lift the FA Cup in May but he remained in place and took pre-season training this week with those players not at the World Cup.

However, his exit has been anticipated all summer after the Blues missed out on Champions League qualification due to a fifth-place finish in the Premier League.

May's FA Cup final success means Conte - who managed Juventus from 2011 to 2014 - has won a major trophy in each of his last five seasons as a club manager.

In all it proved a

fractious campaign for the west-London club, with Conte outspoken about the congested Christmas fixture list and on times visibly agitated in news conferences when questioned about a public war of words with Manchester United manager Jose Mourinho.

Chelsea ultimately finished 30 points behind Premier League champions Manchester City and exited the Champions League at the last-16 stage after a 4-1 aggregate defeat to Barcelona.

In mid-October, the Blues were beaten by a Crystal Palace side who had gone into the match with no points from seven games, prompting Conte to dismiss rumours of unrest over his training schedule.

After Christmas they suffered back-to-back league defeats twice - first by Bournemouth and Watford, and then against Manchester City and Manchester United - and a run of four-straight wins late in the campaign could not secure a top-four finish.

Moscow, but Ivan Perisic levelled for Croatia before Mario Mandzukic scored the winning goal in the 109th minute.

"English journalists, pundits from television, they underestimated Croatia and that was a huge mistake," Real Madrid's Modric told ITV. "They should be more humble and respect more opponents."

"All these words from them we take, we were reading and we were saying, 'OK, today we will see who will be tired.'"

England face Croatia in October and November in the new Uefa Nations League.

Croatia, whose previous best World Cup performance was a third-place finish in 1998, face France in Moscow on Sunday.

"It is the biggest success in Croatian history in sport and we have to be proud," added Modric.

Croatia defender Dejan Lovren said Modric deserves to win the Ballon d'Or if they win Sunday's final, describing his team-mate as the "best midfield player in the world".

The Liverpool centre-

back also believes he should be considered one of the world's best defenders.

Lovren, 29, made 43 appearances for Liverpool last season as they finished fourth in the Premier League and reached the Champions League final.

But he was criticised for some of his performances during the season, and received a death threat after October's 4-1 defeat by Tottenham.

"I think people should recognise that I am also one of the best defenders in the world and not just talk nonsense," he told Bein Sports.

and you can't guarantee they'll come again," said Southgate.

"But equally we want to be a team who hit quarter-finals, semi-finals and finals. We've proved to ourselves and our country that's possible.

"A lot of teams who go on to win trophies lose in quarter-finals or semi-finals first.

'remarkably proud'

"At the moment we all feel the pain of defeat. I don't think realistically we expected to be here. But once you're here and played as well as we did, you want to take those opportunities in life. The dressing room is a difficult place at the moment.

"I'm remarkably proud of the group of players - the reaction of the supporters compared to two years ago shows the country are proud of the way we played."

While Croatia play France in Sunday's final, England face Belgium in Saturday's third place play-off.

England won the World Cup in 1966, while Belgium have never reached a final - and both sides have lost their only previous third place play-off ties.

"It's not a game any team wants to play in," Southgate said.

"We have two days to

prepare. We will want to give a performance of huge pride.

"Every time we wear the shirt we want to play well and win. It's going to be a really difficult task. We've made such strides with our supporters and public that we want to continue to do that."

'small margins'

England captain Harry Kane told BBC Radio 5 live: "It's been an amazing run but it hurts to lose, it really hurts. We wanted to go on and win it and we thought we had enough to go through but it wasn't to be.

"In big games, small margins make the difference and they had a ball that fell their way at the end and he stuck it away. We played well at the start and in extra time but we missed a few chances to kill them off.

"There are a lot of positives to take from this tournament. It's a big stepping stone from two years ago."

Right-back Trippier, who scored the early goal but went off injured in extra time leaving his side a man down, told BBC Radio 5 live: "Obviously we are feeling disappointed but we have grown as a team through the tournament and handled certain games and a penalty shootout well.

"You need to take chances in the semi-final

of a World Cup and had we got that second goal, things would have been different. They had their spells in the game, which we knew would happen, but we are very proud of ourselves and all of the staff.

'great run'

"It wasn't meant to be. Tonight shows how far we have come as a team and a nation. We have connected with the fans and I hope they know how hard we tried to make them proud."

England goalkeeper Jordan Pickford said: "It's been a great run. We went ahead early and sometimes you might say it was too early but it just shows our character, we never stopped until the end.

"We hold our heads high and it shows how much we've come on as a unit and as a country. Look at the fans at the end, two years ago it wasn't like that.

"I hope it's just the start, this tournament, as long as we keep performing and keep playing the way we can. Tonight wasn't our night but hopefully the future is bright."

Pickford added: "These are the times you learn from. We would like to get to the final, we would like to win it but as a person and as a team you learn more by not getting through and hopefully we come back stronger."
