



# 'A BETTER BRITAIN'?

## ■ PM stuns Tory Party conference as she comes out swinging (and dancing)

**THERESA May has launched a vigorous counter-attack against the forces seeking to end both Brexit and her tenure at Number 10 by telling the Tory Party Conference "Together, we can build a better Britain."**

The Prime Minister astonished many veteran political observers by sashaying onto the main stage in Birmingham on Wednesday to the strains of Abba's disco anthem "Dancing Queen" before delivering a barnstorming speech, in which she urged the UK to "recapture the spirit of common purpose" shown in the world wars as next year's EU exit looms. She warned Brussels that Britain was "not afraid" to quit the bloc without a trade deal.

### 'pivotal moment'

Unveiling an ambitious vision for Britain's independent future, she declared that "austerity is over". She vowed to transform the NHS, raise spending on public services and free councils to build tens of thousands more homes. "We stand at a pivotal moment in our history," she told the conference, adding: "When we come together there is no limit to what we can achieve."

In choosing the Abba anthem to make her debut, May made

light of her much-mocked gyrations with schoolchildren during her recent African visit when she was dubbed "The Maybot". And in addition to striking an upbeat and defiant tone for the country's future dealings with Brussels, she also delivered her most scathing onslaught to date on Jeremy Corbyn's Labour Party.

### 'freetrade deal'

The Tories need to end their infighting over Brexit and pull together to help the push for a deal with the EU, the Prime Minister said. While setting out a clear case for her proposals for the future relationship with Brussels, she conspicuously did not once refer to them as the "Chequers plan". In a sign that Downing Street wants to rebrand the package after criticism from Brexiteers, she referred to her blueprint as a "freetrade deal". She warned they could not expect a "perfect Brexit".

Mrs May said: "Our proposal is for a free-trade deal that provides for frictionless trade in

goods. "It would protect hundreds of thousands of jobs in the just-in-time supply chains our manufacturing firms rely on.

"Businesses wouldn't face costly checks when they export to the EU, so they can invest with confidence.

"And it would protect our precious Union – the seamless border in Northern Ireland, a bedrock of peace and stability, would see no change whatsoever."

In a direct appeal to her squabbling MPs, she said: "Those of us who do respect the result – whichever side of the question we stood on two years ago – need to come together now.

### Second vote

"If we don't – if we all go off in different directions in pursuit of our own visions of the perfect Brexit – we risk ending up with no Brexit at all."

The snub from EU leaders to Britain's offer at a summit in Austria showed the talks were reaching their "toughest phase", she said. "You

saw in Salzburg that I am standing up for Britain. What we are proposing is very challenging for the EU. But if we stick together and hold our nerve I know we can get a deal that delivers for Britain," she added. Mrs May said quitting the EU without a deal could be "tough at first" but the "resilience and ingenuity of the British people would see us through".

She said: "Some people ask me to rule out no deal. But if I did that I would weaken our negotiating position and have to agree to whatever the EU offers." Voters' faith in democracy would be shaken if Remain campaigners succeeded in their demand for a fresh referendum, the Prime Minister warned. "There are plenty of prominent people in

British politics – in Parliament and out of it – who want to stop Brexit in its tracks," she said. "Their latest plan is to hold a second referendum – they call it a 'People's Vote'. But we had the people's vote – the people voted to leave. A second referendum would be a 'politicians' vote', politicians telling people they got it wrong the first time and should try again."

# UK exposes 'reckless' Russian cyber attacks

**"The GRU's actions are reckless and indiscriminate. They try to undermine elections in other countries."**

**BRITISH spies have exposed more "reckless and indiscriminate" cyber attacks by Russia's GRU agency, it emerged this week.**

Defence experts warned that hackers have targeted political parties, banks, businesses, media and sports institutions trying to influence elections and cause chaos worldwide.

They fear Russia is developing cyber weapons which could "cripple modern society" in an all-out attack.

The warnings, following crucial work by the National Cyber Security Centre, came as President Vladimir Putin dismissed Salisbury poisoning target Sergei Skripal as a traitor.

He labelled the former spy "simply a scumbag" and ridiculed the idea that Kremlin agents had been sent to Britain to kill anyone as "rubbish".

GRU hackers operate using a dozen different names or tags such as Fancy Bear and BadRabbit.

Earlier this year intelligence chiefs discovered the GRU

had targeted financial, energy and government sectors in the Ukraine, disrupting rail and air travel.

In 2017 they infected thousands of internet routers across the world and demanded ransom payments.

British cycling champions Sir Bradley Wiggins and Chris Froome both came under fire after Fancy Bear hackers stole athletes' medical records from the World Anti-Doping Agency.

**'traitor to the motherland'**

And the same criminals are being blamed for an attack on America's Democratic Party, which was aimed at rocking a presidential campaign.

Foreign Secretary Jeremy Hunt said: "These cyber attacks serve no legitimate national security interest, instead impacting the ability of people to go about their lives free from interference and even to enjoy sport. "The GRU's actions are reckless and indiscriminate. They try to undermine elections

in other countries. They are even prepared to damage Russian companies and Russian citizens.

"This behaviour demonstrates their desire to operate without regard to law or established norms and to do so with a feeling of impunity."

Dr Julian Lewis, chairman of Parliament's Defence Select Committee, said: "What we are seeing is, just like how they have used oil and gas to strong-arm its neighbours, Russia is using its digital arsenal both to intimidate and develop the capability that could potentially cripple modern society.

"If they were to launch it on a fullscale basis, that would be tantamount to an act of war."

President Putin on Monday claimed Mr Skripal, who was poisoned with his daughter Yulia in March, was a "traitor to the motherland" who had served five years in prison. He said: "I see that some of your colleagues are pushing the theory that Mr

Skripal was almost some kind of human rights activist. He was simply a scumbag."

The Russian president also insulted Charlie Rowley and his former partner Dawn Sturgess,

who died after handling the nerve agent, as he yet again denied any Moscow involvement. He said: "What, did some guys rock up and start poisoning homeless people over there? What

rubbish."

But Tory MP Bob Seely, an expert on Russia, said: "This appears to be a GRU-planned poisoning and the order can only have come from the Russian head of state."

## What is the Chequers plan?

**The Government's Brexit white paper covers four areas: economic partnership, security partnership, future areas of cooperation such as aviation and nuclear power, and the frameworks needed to enforce the agreement.**

It is aimed at ensuring trade cooperation, with no hard border for Northern Ireland, and global trade deals for the UK.

The white paper acknowledges that the UK will have more barriers to trade once it leaves the EU, and gives additional details on the Government's latest proposed customs system: the Facilitated Customs Arrangement, in which the UK will collect tariffs on behalf of the EU.

On agriculture and trade the UK and EU would agree a "common rulebook for all goods including agri-foods", with British ministers committing in a treaty to ongoing harmonisation with EU rules when necessary to provide for frictionless trade at ports and the border with Ireland.

The UK Parliament would have the ability to



choose not to incorporate future rules, but the government accepts there would be "consequences" for trade. "Regulatory flexibility" for services, with the UK recognising neither side will enjoy "current levels of access" to each other's markets.

The agreement says it will end free movement of people "giving the UK back control over how many people enter the country".

A "mobility framework" will be set up to allow UK and EU citizens to travel to each other's territories, and apply for study and work.

In her foreword, May insists that the UK will leave the single market, customs union, common agricultural policy and the

commons fisheries policy, "take back control of our money, laws, and borders, and begin a new exciting chapter in our nation's history". The European Court of Justice will no longer have jurisdiction in Britain, she says.

However, she acknowledges that the withdrawal "requires pragmatism and compromise from both sides".

How did the Chequers plan get its name?

The white paper is officially named The Future Relationship between the United Kingdom and the European Union. However, it is nicknamed the Chequers plan because it was agreed by the Cabinet at Chequers, the PM's country residence.

# Jack and Eugenie: everything you need to know about the NEXT royal wedding....

## ■ Nuptials scheduled for Friday in Windsor

**Hot on the heels of Prince Harry and Meghan Markle, the second royal wedding of the year is fast approaching.**

Same venue, different people - Princess Eugenie and Jack Brooksbank are the couple tying the knot on 12 October.

So what can you expect this time around? Here's everything you need to know:

Eugenie is the Queen's granddaughter and the second daughter of Prince Andrew and Sarah, Duchess of York.

The 28-year-old is ninth in line to the throne, just behind her sister Beatrice.

The sisters are widely remembered for their headline-grabbing outfits at Prince William and Catherine's wedding in 2011.

Her full title is Her Royal Highness Princess Eugenie of York. She has no official surname, but uses "York."

She will keep her royal title when she marries and will have the option to take her husband's surname.

### 'love at first sight'

The princess, who studied English and history of art at Newcastle University, is a director at contemporary art gallery Hauser and Wirth in London.

Eugenie, a recent convert to Instagram, is close to both her parents who divorced when she was a child but remain friends.

She was named after one of Queen Victoria's granddaughters - Victoria Eugenie of Battenberg - and her name is pronounced "YOO-jun-nee", according to her mother.

Brooksbank is a brand manager for Casamigos Tequila, which was co-

founded by George Clooney and former manager of Mayfair club Mahiki, and met the princess when she was 20, on a skiing trip to Verbier in the Swiss Alps. The groom-to-be, 32, said it was "love at first sight".

He was educated at a public school in Buckingham, Stowe School and worked in bars and pubs for several years and once said his dream was to start a chain of pubs.

### royal approval

The Queen reportedly gave her blessing for the marriage when the couple went to Balmoral for Prince Harry's 32nd birthday. Jack proposed in January year in front of a volcano in Nicaragua, looking out over a lake, as the sun was setting. And he has won the approval of his future mother-in-law, who said she "loved Jack" in a series of social media posts celebrating the announcement.

His future father-in-law Prince Andrew described him as an

"outstanding young man".

The couple live together in an apartment called Ivy Cottage in the grounds of Kensington Palace.

The couple will wed at 11:00 BST on 12 October at St George's Chapel, Windsor Castle. It's the same venue used by Prince Harry and Meghan.

American viewers will be able to watch the ceremony live on the TLC network, starting at 4.25am.

After the ceremony the newlyweds will take a carriage ride through Windsor, but will not go up the Long Walk like the Duke and Duchess of Sussex did in May.

In the afternoon, the Queen will host a reception for her granddaughter and her new husband and guests, at Windsor Castle.

Evening celebrations will reportedly be staged at Royal Lodge in Windsor Great Park - the property is the family home of Andrew and his ex-wife Sarah.

### Who's paying for the wedding?

As with the first royal wedding of the year, the wedding will be paid for privately except for the security - which will be picked up by the taxpayer.

Just like Meghan and Harry's wedding, 1,200

members of the public have been invited into the castle grounds to see the couple tie the knot. Buckingham Palace said they had received more than 100,000 applications from people wanting to attend.

As for the dress, the designer's identity

remains a mystery but the bride did tell Vogue recently the dress was the one thing she had been "decisive" about.

"As soon as we announced the wedding, I knew the designer, and the look, straight away," she said.

# Thousands stranded abroad after budget airline goes bust

■ Countless Brits scrambling to get home after Primera Air collapse

THOUSANDS of travellers have been stranded abroad by the collapse of budget airline Primera Air.

Others who had booked and paid for travel were left fuming when the Danish-based carrier ceased trading after 14 years. Passengers were told not to turn up for Primera Air flights from the UK and those abroad are now scrambling to find alternative flights home.

The company has been savaged for a lack of communication amid claims that it was still selling tickets on Monday afternoon – after rumours of its imminent collapse started circulating. Nikki Mart, 27, and her partner Geoff Venus, 32, from Newcastle upon Tyne, landed in Jamaica on Monday for the start of a "dream holiday", only to find out the airline had gone bust hours later. They were due to fly home to Stansted from Toronto with Primera Air on October 14. She said: "I'm trying not to let it ruin our trip, especially as it's happened so

early on. The lack of communication, advice or empathy from Primera Air makes it so much more stressful."

Tara Noe and her husband Remy were due to fly to Toronto with Primera Air next week for a two-week trip so she could take part in her first marathon. The 42-year-old, from the Isle of Sheppey, Kent, said she is in "shock". She added: "You can't contact them. They have shut down the phone lines and the website is inaccessible." After spending £750 on return flights, the couple

have had to pay another £368 for her replacement ticket, with her family stepping in to cover £400 for her husband's fare.

Primera began in 2003 and served 97 destinations in more than 20 countries. It operated from Stansted with flights to Washington, Newark, Boston and Toronto. It also had a base at Birmingham airport serving the US. The airline announced last month that it planned to launch routes from Madrid to New York, Boston and Toronto next year at an introductory

price of £130 each way. But the airline's recent rapid expansion raised eyebrows.

Aviation analyst John Strickland said: "It's very hard to get known in a market where there's a lot of competitive choice and a lot of good prices available already. The odds really were stacked against them."

Rory Boland, Which? travel editor, said: "Passengers will quite rightly be outraged that the airline was still selling tickets right up to the moment it went bankrupt."

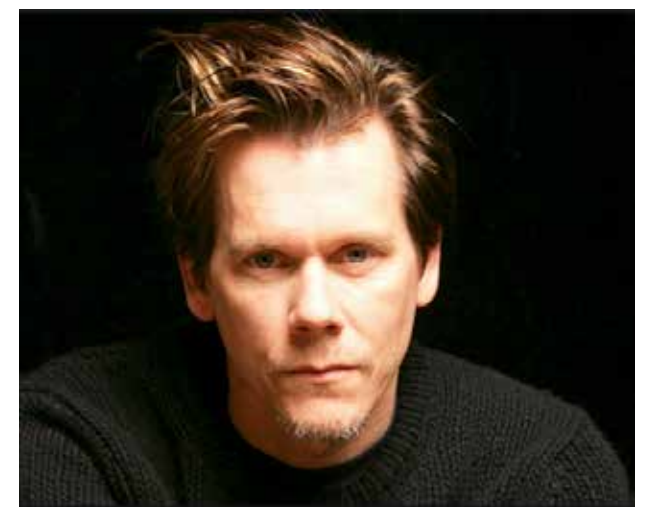

## Modern slavery victim found 'after 40 years in shed'

A potential victim of modern slavery has been rescued after living in a shed for 40 years, according to the Gangmasters and Labour Abuse Authority.

Officers found the 58-year-old British man with just a chair and soiled bedding during a raid at a residential site north of Carlisle on Wednesday.

He was taken away to be assessed by specialist medical staff.

A 79-year-old man has been arrested on suspicion of modern slavery offences.

Martin Plimmer from the GLAA said: "The information that was given to us was that he had been kept in the shed for a period of 40 years.

"When we found him he was like a rabbit in headlights and very confused.

"He was just in the clothes he stood up in and where he was sleeping in the shed there was just a soiled duvet on the floor.

"There was no heating and it was very cold. It was conditions that no human being should live in."

Mr Plimmer said the man appeared to have been made to carry out unpaid work from the age of 16 or 17.

He said it was unclear whether the man had ever tried to leave.

"He has been traumatised for such a length of time that it will be a slow process to win back his trust," Mr Plimmer added.

He said the 79-year-old arrested man would be questioned in due course.

Mr Plimmer added: "In my long career I've never come across anyone who has been held as a slave potentially for 40 years and this, I think, could be the longest period of captivity that we have dealt with."

# Back to the future: Carers build £6m memory lane for dementia sufferers

WITH its cobbled streets, an old-style barber's, a toy shop, post office and vintage cars, visitors might think they had walked on to an early set of Coronation Street.

This "memory lane" is no soap opera but an eye-catching initiative from the latest in dementia-friendly care homes which opened on Sunday. Owners Danny and Damien Holt said: "The purpose of our memory lane is to provide an attractive and interesting destination for the people we care for, offering reminiscence therapy to improve the psychological wellbeing and quality of life for our residents."

The Five Rise Nursing Home in Bingley, West Yorks, which has 67-bedrooms and cost £6million to build – even has its own transport hub.

"Situated in the

entrance of our home is Bingley's bus stop, showcasing maps and popular routes in and around Bingley," the twin brothers added.

"A common effect of dementia is the short-term memory becoming the frailest and the long-term memory being unaffected.

"Often the person will regress back to their 20s and 30s, leaving them with an insatiable desire to organise homes, jobs and to-do lists.

"A need to 'be somewhere' urgently whether that is picking their children up from school or needing to be home to visit their mother.

"The bus stop works by allowing the person to sit and wait for their trip home before quickly forgetting why they were there in the first place.

"Residents can sit freely at the bus stop, feeling a sense

of purpose. Also care staff can use this as a therapeutic tool in distracting the person until their anxieties are eliminated."

Meanwhile residents enjoy a "past" in which everything is authentic – from tins of Colman's mustard on the shelves of the grocer's to its till displaying old-style

currency.

"People with advanced dementia have very complex needs and we know how vital it is to provide plenty of mental stimulation in a safe environment," they added. But such care does not come cheap. Fees start at £700 a week, rising to £950. The Holt twins, who trained

as psychiatric nurses, grew up in a residential care home run by their father Brendan. They already run nearby Glen House Nursing Home in Baildon, West Yorks, which has a sweet shop and walls lined with images of yesteryear. They say their venture has already created nearly 80 jobs.

## UK man killed by sea snake

A British man has died after being bitten by a sea snake on a fishing trawler in Australia, police have said.

The man, 23, had just pulled up a net off the coast of the Northern Territory when he was bitten about 09:00 local time on Thursday (23:00 GMT Wednesday).

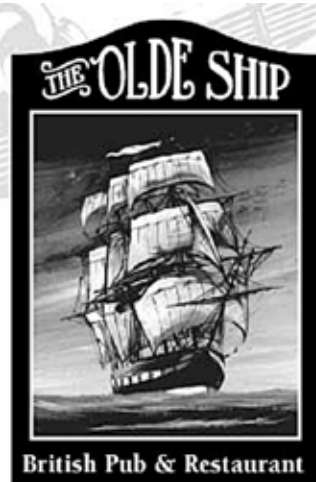
Emergency crews were called to the boat, near island Groote Eylandt, but were unable to save the man.

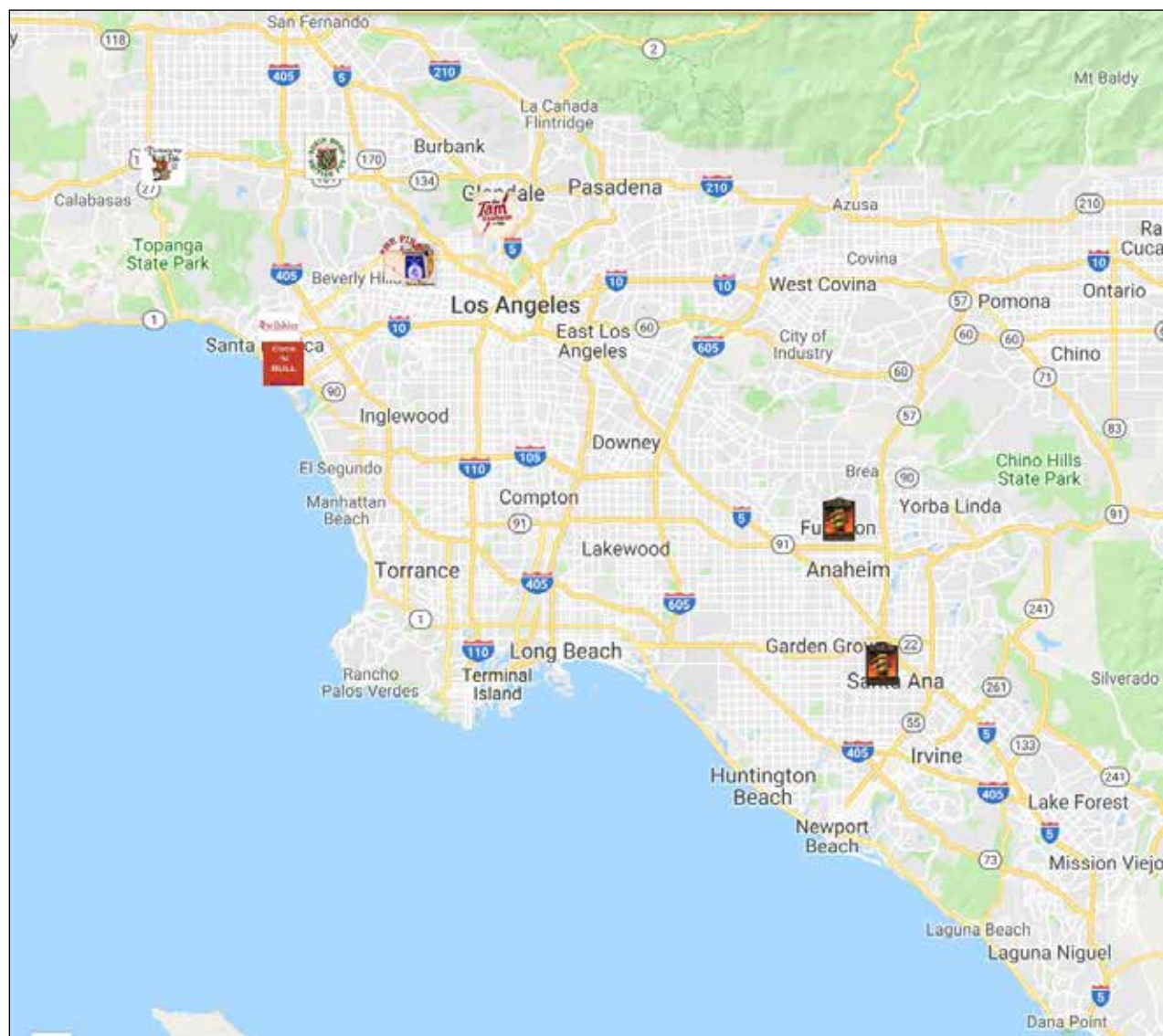
# Craving a Sunday Roast?

# Can 'Hardy' wait to see Tom in Venom!

"Khabib is petrified. I want him to show up for the fight," he added.

McGregor's last

appearance in UFC came in November 2016 when he beat Eddie Alvarez to add the lightweight belt to his featherweight title.

He was later stripped of both titles because of inactivity, with Nurmagomedov being installed as lightweight champion earlier this year - a decision that will never lie well with McGregor.

"My heart is black towards this man" he said.

McGregor confirmed his reputation as a man who does what he wants, when he wants - blamed the "heavy traffic"

for him turning up 26 minutes late for the news conference.

"There must be a McGregor fight going on," he said, taking to the stage alone after Nurmagomedov had walked out 10 minutes earlier, criticising his opponent's "disrespect".

As only McGregor can, he swaggered into the spotlight with his favourite accessory - a bottle of his own whiskey - in his hand.

Nurmagomedov had refused to allow the news conference to be delayed and instead started it at 23:00 BST on the dot, before departing after 15 minutes, leaving UFC president Dana White centre stage, sweating on the star attraction's arrival.

"Khabib knew what he signed up for. I don't know where the little fool is," McGregor added when he finally arrived.

# Pep praises his Silva treasure

**Manchester City manager Pep Guardiola described David Silva as "one of the best players" he has managed after the midfielder scored a dramatic late winner in City's Champions League win over Hoffenheim on Tuesday.**

Silva capitalised on an 87th-minute defensive error by Stefan Posch before finishing into the far corner to give his side their first points in the competition this season.

The Spaniard also played a key role in Sergio Agüero's equaliser in the first half.

"He is one of the best players I have trained in my life," said Guardiola.

"I am a lucky guy to have many of them who are top players at Barcelona and Bayern Munich and he is in that list.

"In terms of mentality, I love the players who in the bad moments step forward and say 'I am

here guys' and he is one of them.

"I am so happy for him. He deserves all of my respect."

City had fallen behind after only 43 seconds when Ishak Belfodil finished through the legs of goalkeeper Ederson for Hoffenheim.

They equalised six minutes later when

Agüero poked home from Leroy Sané's cut-back but had been frustrated from then on, and looked like only taking a point from their trip to Germany before Silva pounced late on.

Manchester United failed to ease the pressure on manager Jose Mourinho with a goalless draw against Valencia in

the Champions League at Old Trafford Tuesday night.

United, enduring their worst start to a league campaign for 29 years, started brightly, thanks mainly to the energy of recalled widemen Marcus Rashford and Alexis Sanchez.

However, as the Spanish side grew into

the contest, the hosts became more ponderous and disjointed.

Indeed, Valencia had the better chances either side of half-time until United rediscovered the impetus and energised not only themselves but also the home crowd.

Rashford clipped the top of the bar with a free-kick, but the visitors hung on for a deserved draw that extended United's winless run to four games.

United are second in Group H on four points, two behind leaders Juventus, who defeated Swiss side Young Boys 3-0 and will travel to Old Trafford on 23 October with Cristiano Ronaldo restored to their ranks.

**Alvaro Morata's goal proved decisive as Chelsea scraped past Hungarian champions Vidi to maintain their 100% start in Group L of the Europa League on Thursday.**

Despite dominating both territory and possession it took the second-half arrival of substitute Eden Hazard to add spark to a Chelsea team frustrated for long periods.

And Morata, who had earlier missed a glorious chance, capitalised on some extra space by sweeping in Willian's flick from a Cesc Fabregas pass.

It ended a miserable run for the 25-year-old, who had managed just one goal from nine previous outings this season.

In Baku, Azerbaijan, Arsenal enjoyed a routine victory as teenager Emile Smith Rowe scored his first goal for the club to help the Gunners beat Quarabag and notch their eighth win in a row.

The 18-year-old academy graduate coolly finished beneath goalkeeper Vagner in the 53rd minute to score Arsenal's second goal.

Sokratis Papastathopoulos and Matteo Guendouzi scored either side of Smith Rowe's strike to also register their first goals for the club.

## Barca ace gives scintillating Wembley display

Lionel Messi produced a Wembley masterpiece to condemn Tottenham to their second successive Champions League defeat as they were beaten 4-2 by Barcelona at Wembley on Wednesday night.

Messi was the magnificent orchestrator behind a superb attacking display from the Catalans that eventually proved too much for spirited Spurs, who also lost their opening Group B game to Inter Milan in Italy.

Spurs keeper Hugo Lloris, back from injury, gifted Philippe Coutinho Barcelona's opener inside two minutes with a reckless dash from goal before Ivan Rakitic put them further in control before half-time with a spectacular 20-yard strike.

Messi hit the post twice before Harry Kane gave Spurs hope with a clever

The results mean Napoli top the group on four points, with Liverpool and PSG both on three points. The Reds host Belgrade on 24 October in a game that they must win to keep on course for last-16 qualification.

"It was an interesting-looking group before we started and it's still interesting now," said Klopp. "We weren't as good as we could be."
