

Tributes flood in for Dame June Whitfield

Comic actor whose career ranged from Take It From Here on the radio to Terry and June and Absolutely Fabulous on TV TRIBUTES HAVE FLOODED in for Dame June Whitfield, one of Britain's best-loved comedic actresses, who has died aged 93.

The London-born actress was a regular fixture on British TV and radio for seven decades, her bestknown roles coming in Terry and June, in which she played half of a middle-aged, middle-class suburban couple, and as Jennifer Saunders's mother in Absolutely Fabulous. She also appeared in Carry On films, Hancock's Half Hour, and even had a part in Friends. Whitfield's agent confirmed her "peaceful" death on Friday. On radio, she was Eth to Dick Bentley's Ron in radio's Take It from Here in the 1950s; partnered Roy Hudd in The News Huddlines on Radio 2 (1984-2000); and was Agatha Christie's Miss Marple for Radio 4 (1993-2001). She partnered Arthur Askey on television for six years and played Terry Scott's wife in Happy Ever After, then in Terry and June, for an astonishing 13 years. And she captivated a new

generation as Jennifer Saunders's vague but sometimes acerbic mother in Absolutely Fabulous.

Shane Allen, controller of BBC Comedy, said: "June Whitfield was the North Star of British comedy. Her spectacular career is unparalleled in its longevity, with seven decades of being a key element in numerous high-profile and successful shows. She was the go-to female comedy performer of her generation and was always in demand from the cream of British comedy."

'a great loss'

Comic actress Miranda Hart tweeted that Whitfield's death was "so very sad". She added: "I once sent a letter to many actors as a budding comedy actor to ask for sponsorship for the Edinburgh Festival. Dame June replied. Fifteen years later, when I met her, she had all my letters and the notes of the show she sponsored. I cried then too."

Television producer Jon Plowman, who worked on episodes of Absolutely Fabulous and the 2016 film version, said: "There was no one with more warmth or a better ability to just 'place' a line, always an act of utter precision. Hit after hit! Take it from Here, Terry and June, Absolutely Fabulous over seven decades. A great loss."

Trained at Rada, Whitfield took her first role in 1944 and went on to become a fixture of stage, screen and radio, appearing in hundreds of productions. Her sense of comic timing kept her in demand from across the entire canon of British comedy.

Whitfield was given a Lifetime Achievement Award at the 1994 British Comedy Awards and inducted into the Royal Television Society's Hall of Fame in 1999. In

1985 she was made an OBE, in 1998 a CBE, and in 2017 a dame. In her autobiography (2000), she

summed up her life: "Not a rags-to-riches story, or one bursting with revelations; there isn't even an unhappy childhood, only a life full of love, affection and laughter, of gigs, gags and a couple of gongs."

EU chief blasted after branding British 'unreasonable'

Get your act together and then tell us what it is you want," says Juncker as Brexit stalemate drags on

CHIEF Eurocrat Jean-Claude Juncker faced furious backlash а this week after branding British voters "unreasonable" over Brexit.

The European president Commission slammed UK voters, saying it was time to "get your act together" over how the country will leave the EU. But Brexiteers said his comments were "ridiculous" and should be a wake-up call to the Government that it was dealing with "impossible people".

"entirely unreasonable"

Iuncker told Mr German Sunday newspaper that it was "entirely unreasonable" to expect Brussels to come up with solutions over Brexit. He said: "It is not us who are leaving the United Kingdom. It is the United Kingdom that is leaving the European Union.

"I find it entirely unreasonable for parts of the British public to believe that it is for the EU alone to propose a solution for all future British problems.

"My appeal is this, Get your act together and then tell us what it is you want. Our proposed solutions have been on the table for months."

Mr Juncker said it was up to the British to decide if the final decision is put back to the people in a second referendum but denied Brussels was trying to stop Brexit. He told the Welt am Sonntag: "It is being insinuated that our aim is to keep the United Kingdom in the EU by all possible means. That is not our intention."

Conservative MP James Gray said he was "certain" Mr Juncker's approach had made the Brexit talks more difficult and attacked the official for criticising British voters. He said: "It's a ridiculous thing to say. It doesn't surprise me because they don't want to lose us.

"elite of the elite"

"He makes these very unhelpful comments and he's a difficult individual.

"We should have boxed them round the ears from the beginning and they might have realised that they were fighting a formidable opponent."

Tory Brexiteer Peter Bone said the EU elite had always been intent on offering the UK a bad deal to deter other countries from trying to leave the bloc. He said: "The European elite has always said they know best. They know best for Europe, they know best for us.

"I hope this is a wakeup call to our Government that we are dealing with impossible people. He is the top of the elite of the elite."

Fellow Brexiteer Andrew Bridgen said: "The EU have been so unreasonable during the negotiations that now the only solution that delivers the Brexit we have promised the British people is to leave with a managed no deal.

"What the EU have forgotten is they sell us twice as much as we sell them.

"That means we are the customer and they have forgotten that the customer is king."

MPs are due to vote on the withdrawal agreement in the week of January 14 after Prime Minister Theresa May ditched the planned vote in December over fears that she would face a humiliating defeat. Former Brexit Secretary David Davis said he expected the deal would be defeated and that would force the UK and EU back to the negotiating table to strike a new deal before March 29.

He said: "They will have to come back and deal again. The deal she's got is no good.

Reject May's deal and Brexit is only 50/50, warns Fox

BREXITEER Liam Fox has warned that Britain has only a 50-50 chance of leaving the EU if MPs reject the Prime Minister's deal.

International The Trade Secretary said backing the withdrawal agreement Theresa May has struck with Brussels was the only way to guarantee the UK quits the bloc on March 29.

MPs are due to vote on the exit plan in the week of January 14 after Mrs May ditched the planned December vote over fears she would face defeat. Dr Fox warned that Parliament would shatter faith in democracy if it took the "incendiary" decision to reject the agreement.

He said: "What you can be sure of is that if

we vote for the Prime Minister's deal then it's 100 per cent certain that we will leave on March 29.

"If we do not vote for that, I'm not sure I would give it much more than 50-50 [chance of success].

"And for me that would induce a sense that we had betrayed the people that voted in thre referendum."

New EU fish quotas blasted


EU rules which came into effect on New Year's Day could have a "devastating" impact on the UK fishing industry, a parliamentary committee has been told.

The "landing obligation" requires boats to bring to shore fish caught in excess of their allocated quota, which they would previously have discarded at sea. After a four-year phasingin period, it came into full effect on Tuesday, with the aim of conserving stocks by encouraging fishermen to be more selective about what they catch. But the House of Lords EU Energy and Environment

sub-committee has heard evidence that the rule could mean fishermen reaching their annual quotas much earlier in the year, with an estimated £165million worth of fish remaining uncaught in 2019 as a result.


Once they have reached their quota for a particular species, fishermen will be forced to choose between halting operations for the rest of the year or breaking the law by continuing to fish for other species and discarding anything over quota. And the committee that raised concern enforcement agencies do not have the capability to police the rule, creating a temptation for fishermen to flout it in the knowledge that their chances of being caught are "slim to none".

Committee memberLord Krebs said: "Maintaining the health of our oceans by fishing at sustainable levels is critically important, and the landing obligation was introduced to help make sure this happens. "So it is deeply concerning that so many people - fishers, environmental groups, even the enforcement agencies themselves - do not think these new rules can be implemented from January."



Army raises eyebrows with millennial recruitment drive

THE British Army is targeting gamers, millennials and even snowflakes with a new recruitment campaign aimed at young people. A series of posters and TV adverts will overturn stereotypes by highlighting the potential qualities 16 to 24-yearolds could offer.



"Phone zombies" are praised for their "focus", "selfie addicts" have "confidence" and "class clowns" bring "spirit", according to the Your Army Needs You campaign. The campaign is inspired by the famous 'Lord Kitchener Wants You' posters from the First World War. Major General Paul Nanson said: "The Army sees people differently. We are proud to look beyond stereotypes and spot the potential in young people, from compassion to selfbelief."

Defence Secretary Gavin Williamson said it was aimed at "those seeking to make a difference as part of an innovative and inclusive team".

We will never give up, vows grandad fighting to gain custody of murdered son's Chinese children

British couple forced to choose one grandchild after bitter custody battle

The British grandparents battling for custody of their murdered son's children have vowed to reunite the family after bringing their granddaughter back to the UK with them.

Ian and Linda Simpson were devastated after having to leave eight-yearold Jack in China with his grandparents while returning to the UK with Alice, six.

Mr Simpson said on Monday: "Our fight continues and we will do all we can to bring Jack as well as Alice back to Britain and to reunite our grandchildren, who love each other dearly."

Their son Michael was stabbed to death by his ex wife and mother of their two children Fu Wei Wei in a jealous rage two years ago.

The Simpsons have since spent more than £100,000 trying to bring their grandchildren back to the UK, and reportedly had to give the children's grandparents more than £9,000 to bring Alice back.

'amazingly brave'

Jack will stay with his relatives in the remote city of Nanzhang in northwest China, 1,100km from Shanghai.

Before leaving China, Mr Simpson, 69, told the Mail on Sunday: "We are overjoyed to bring Alice home but it breaks our hearts to leave Jack behind. Linda cried and asked me, "How can we wrench them apart?"

"But in the end we had to choose between coming home with Alice or walking away without either of our grandchildren. We could have lost them both for ever.

"Alice has never been apart from Jack and it's obvious she misses him badly. She has been amazingly brave but there have been moments when she has been in tears asking for her brother."

The children have reportedly been told by their Chinese family that their parents have deserted them and are alive and working abroad, leaving the Simpsons to tell Alice the truth.

Michael, an executive for Next, was 34 when he was killed in his Shanghai apartment while his children slept.

He had split up with his wife two years earlier and was left to raise their children.

'we had to choose'

He was with his new partner when Wei Wei burst into his flat and stabbed him in the neck, killing him instantly, and injuring his girlfriend.

For more than a year Simpson engaged in a bitter custody dispute with Wei Wei's mother. It is thought they handed over about £9,200 to her parents, to ensure Alice could travel with them. But the Chinese grandparents refused to let Jack go too, even though the siblings have never been separated before.

As Mr Simpson, 69, prepared to show Alice her new home in Hartest, Suffolk. where both children have the offer of a place in the local school, he described the impossible choice they faced in the remote Chinese county of Nanzhang. He said: "We are overjoyed to bring Alice home but it breaks our hearts to leave Jack behind. "Linda cried and asked me, 'How can we wrench them apart?'

"But in the end we had to choose between coming home with Alice or walking away without either of our grandchildren.

The day after Wei Wei's deadly attack, Jack and Alice were spirited 600

miles from Shanghai to live in Nanzhang with their Chinese grandparents. The children were denied contact with their British relatives for a year. While Ian and Linda Simpson fought frantically for custody, the Wei Wei family kept demanding more money, it was claimed.. A breakthrough in the battle came following a high-level diplomatic intervention by Foreign Secretary Jeremy Hunt.

Mr Simpson said: "We feel terribly guilty leaving Jack behind. "The comforting thing is our lawyers are already talking to us about phase two – bringing Jack home. We will never give up."



Coastal patrols increased as migrant tide continues to swell

PATROLS are to be increased as Britain and France scramble to tackle a growing migrant crisis in the English Channel.

Home Secretary Sajid Javid and his French counterpart have also ordered extra surveillance to curtail the growing menace of trafficking gangs. Six Iranian men were found on a Kent beach on Sunday having crossed on a dinghy. The National Crime Agency says migrants pay an average of £7,500 to make the illegal crossing. More than 220 have tried or succeeded in crossing the Channel in the past two months. Mr Javid, who cut short a safari holiday in South Africa, is facing intense criticism over the crisis. He has agreed a tougher course of action by phone with French interior minister Christophe Castaner and they will meet in the New Year. He vowed to step up patrols and pledged further action would be taken to stop traffickers. But he said on Monday night: "Unfortunately there are no easy answers. The reasons behind the increased crossings are complicated and in many cases outside of our control.

"While we have obligations to genuine asylum seekers, we will not stand by and allow reckless criminals to take advantage of some of the

Elphicke said increased cooperation was "a good start" but, "falls short of the kind of joint action and operations needed for the immediate return to France" of such migrants. He added: "We cannot leave it to the French. I want our Border Force cutters cruising the Mediterranean to return to take control of our borders immediately."

Just two Border Force cutters patrol the UK's 7,723-mile coast. France has been accused of turning a blind eye but Mr Castaner insisted it had been tough on gangs. Tory MP for Gillingham and Rainham Rehman Chishti said there was "a lack of leadership" and "the buck stops with the Home Secretary".

Global human trafficking is worth an estimated £6billion annually as millions flee war-torn countries such as Syria. Former Ukip leader Nigel Farage said: "The latest migrant crisis comes as no surprise to me. The recent period of calm weather in the Channel meant it was all too predictable. One of the principal reasons for the influx is the message from the UK to those making the hazardous journey is that if they reach Britain, they will be allowed to stay."

FOR THERESA May, the New Year has begun in much the same fashion as the last one ended, with the Prime Minister being on the end of some withering criticism.

This time the brickbats were prompted by the news that veteran Eurosceptic John Redwood has received a knighthood in the New Year honours list, prompting accusations that May is using the honours system to smooth the way for her Brexit deal.

'desperation'

With the vote on the prime minister's deal due to take place in the week of 14 January, the Conservative backbencher and former Wales secretary is one of three MPs to be knighted.

Redwood, a vehement critic of May's deal, detailed his objections to it in a blogpost published on 27 December titled "Eight things wrong with the withdrawal agreement".

Layla Moran, a Liberal Democrat MP and supporter of the pro-

remain Best for Britain campaign, said the knighthood 'smacked of desperation' as May tries to face down opposition to her deal.

"I cannot see how it is anything but a desperate attempt to blunt criticism of the prime minister's Brexit deal," Moran said.

May also announced three Tory appointments to the privy council, the inner circle of senior MPs and other public functionaries who are referred to as "right honourable", though their role is now largely ceremonial.

Labour's deputy chief whip, Alan Campbell, will also be knighted. The MP for Tynemouth has held the post since 2010, and colleagues said he has been crucial to devising Labour's Brexit strategy in parliament.

In particular, Labour sources said he came up with the idea of using the arcane parliamentary procedure, known as a humble address, to force the government to publish economic assessments of the impact of Brexit, which his colleagues jokingly call the "Campbell papers".

Redwood has been the MP for Wokingham in Berkshire since 1987, and became Wales secretary in 1993, memorably struggling to sing along to the Welsh national anthem at his party's annual conference in Wales.

He clashed with John Major over Europe and stood against him unsuccessfully for the Tory leadership in 1995, when Major urged his critics to "put up or shut up".

Since the EU referendum in 2016, Redwood has consistently urged the government to revert to trading on much less favourable World Trade Organization rules, rather than continue to be bound by EU tariffs and regulations.

The Labour party chairman, Ian Lavery, said: "It is insulting to those who make invaluable contributions to society that the Tories for years have continued to use the honours system to award their own Conservative grandees and party donors."

Let's Get It On: Sheeran copyrigh

Sheeran denies ripping off sections of the 1973 classic for his number one hit Thinking Out Loud.

The action has been brought against Sheeran, Sony/ATV Music Publishing and Atlantic Records by the estate and heirs of the late producer Ed Townsend, who cowrote Let's Get It On with Gaye.

Judge Stanton is also overseeing a separate \$100m lawsuit over the same track launched last June by the company Structured Asset Sales, which owns part of the copyright in Gaye's song. Judge Stanton said the similarities between the two songs included their bass lines and percussion and said listeners might consider the songs' "aesthetic appeal" to be similar. He said there was disagreement over whether the harmonic and rhythmic composition of Gaye's song was too common to merit copyright protection.

Sheeran and the record companies have not yet responded to Judge Stanton's ruling.

Sir Billy Connolly: I'm near the end but I don't fear death

Going dry this January? You'll probably fail...

HALF of the UK is planning a "Dry January".

The bad news is that most will fail by the middle of the month.

The average British adult has not had a boozefree week in almost three months. And according to a study of UK drinking habits, although nearly 45 per cent are attempting to give up liquor for the new year, we are set to give in to temptation just 16 days in.

Giving in because of social occasions like birthdays was the main reason people gave up on last year's Dry January, with 23 per cent citing this excuse. One in six said he or she lapsed because everyone else was drinking while one in eight blamed a terrible day at work. The poll of 2,000 Britons was conducted by non-alcohol gin brand, Ceder's Alt-Gin. It found "generation gap" between drinkers - 54 per cent of 18 to 29-year olds plan to cut booze in January, compared to 42 per cent of the 30 to 44 age group and just 36 per cent of 45 to 50-year olds. The average Briton now thinks about moderating his or her drinking and eating habits four times a week. And 57 per cent are aware of the "two to three days a week off booze" guidance from health experts.

A spokeswoman for Ceder's Alt-Gin said: "It's clear a huge proportion of us think carefully about our alcohol intake. "We're encouraging people to make a permanent move into mindful drinking and keep with it long past Dry January."

But one liver expert has warned that Dry January is not a fix-all solution to heavy drinking. Dr Mark Wright, 49, from Southampton General Hospital, urged people to think about how much they consume all year round.

Sir Billy Connolly has insisted he does not fear death as he revealed how laughter was helping him cope with Parkinson's disease.

The comedian said he viewed old age as an adventure that was preparing him for the "next episode in the spirit world".

But he said there was "still time to go yet, places to go, new friends to make, new songs to write and sing and jokes to tell". The 76-year-old

was diagnosed with Parkinson's in 2012.

Speaking in the Billy Connolly: Made in Scotland documentary shown on BBC2 on Friday evening, Sir Billy said his age and his diagnosis with the degenerative brain condition meant he was now "at the wrong end of the telescope of life"

Reflective mood

The documentary, which was filmed before his 76th birthday, saw the comedy legend in reflective mood as he reminisced about his childhood in Scotland and his subsequent life and career.

He said: "My life is slipping away and I can feel it and I should. I'm 75 and I'm a damn sight nearer the end than I am the beginning.

"But it doesn't frighten me - it's an adventure and it's quite interesting to see myself slipping away, as bits slip off and leave me, talents leave and attributes leave.

"It's as if I'm being prepared for something, some other adventure, which is over the hill. I've got all this stuff to lose first, and then I'll be at the shadowy side of the hill doing the next episode in the spirit world."

Sir Billy recently said his doctor expects him to live until 90 despite his diagnosis with Parkinson's, and has strongly rebuked claims by former TV chat show hostSirMichaelParkinson

that his health was failing to such an extent that he was no longer able to recognise close friends.

He also told BBC Scotland in October that he has some "shoogly days" but is otherwise "perfectly OK".

In the documentary, he said it takes a "certain calm" to deal with the knowledge the condition is never going to go away, and will only get worse in the future.

He added: "Sometimes I don't have it. Sometimes I get angry with it, but that doesn't last long. I just collapse in laughter.

"I'm very lucky in as much as I made a bit of a mark, and you think well I must have done something right.

"And that keeps you company when you're older, the fact that when when you were creative, you created well. It accompanies you. It's a great companion.

"You can volunteer to take life seriously, but it is going to get you. You know they're going to win over you. It's harsh. You can either break down and complain about how



Giving children drugs to treat ADHD? How did we get here?



Cook made a knight

Alastair Cook has been hailed as an exemplary ambassador for cricket after the former England captain received а knighthood in the New Year honours list.

Colin Graves, the chairman of the England and Wales Cricket Board, led the praise for Cook after the 34-yearold became the 11th Englishman to be knighted for services to cricket.

The batsman, who the retired from international game this year, is England's all-time leading run-scorer with 12,472 runs – and the fifthhighest run-scorer in the history of the men's Test game. He scored the last of his 33 Test hundreds in his final Test innings at the Oval in the summer.

"I'm delighted that he has received this honour," Graves said. "It's a fitting tribute to a man who has led with distinction on and off the pitch ever since he made his England debut."

Bill Beaumont, the former England rugby union captain, received a knighthood. The 66-yearold led England to a Five Nations Grand Slam in 1980 and also captained the British and Irish Lions. He is a former Rugby Football Union chairman and was elected chairman of World Rugby in 2016. "I have always viewed my work in the sport as

an administrator as that of a guardian, driven by a passion to do the very best I can for rugby," Beaumont said.

England's football manager, Gareth Southgate, received an OBE after his team's run to last summer's World Cup semi-finals. Harry Kane, who won the tournament's golden boot for top scorer, earned an MBE

United ground tame **Magpies as Solskjaer** makes it four from four

OLE Gunnar Solskjaer racked up his fourth consecutive win as boss and matched United legend Sir Matt Busby with victory over Newcastle on Wednesday.

Busby was the only manager to win his first four games in charge – in 1946 – until the Norwegian's remarkable revival of Jose Mourinho's side continued at St James' Park.

Late strikes from substitute Romelu Lukaku and Marcus Rashford, who was teed up by

another sub, Alexis Sanchez, clinched the points and condemned Newcastle to another nervy relegation

battle.

The Red Devils now have Arsenal, and the top four, in their sights. And soon the debate will start over whether Solskjaer deserves to stay in charge beyond this season.

Fresh from scoring 12 in their previous three games after Mourinho's departure, the visitors were shackled until the 64th minute, but then cut loose. Lukaku smashed home his eighth of the season, reacting quickest to a fumble by Newcastle goalkeeper Martin Dubravka.

The breakthrough was hard won, as United toiled against mass defensive ranks and little space.

But it was Solskjaer's 63rdminute substitutions which shook the game out of its stalemate with Lukaku coming on with

Newcastle manager Rafa Benitez tries to grind out points against sides with vastly superior playing resources to his own current squad, but it rarely works.

This was one of those nights, as Newcastle banked up behind the ball, allowing their opponents possession for long periods - and firing off the occasional warning on the counterattack.

Rashford tested Dubravka with a freekick and Anthony Martial burst into the box in an early warning. Benitez had spotted a chink in the Old Trafford system and his side sprung Christian Atsu

in behind the Manchester United defence three times, forcing saves from David De Gea to lift the home side.

There were signs of the sloppiness Manchester United thought they had eliminated from their game since Mourinho's departure, when Phil Jones's clumsy touch Salomon played in Rondon, but then the defender mopped up with an excellent covering tackle.

But the visitors probed with neat exchanges and Paul Pogba went close from 18 yards. Newcastle were clinging to parity with spirit and aggression. But half-time came and then Solskjaer's substitutions changed the game.

Rashford was a bright spark, worrying the home side with his pace. His cut-back ended in a shot over the bar as United struggled to create clearcut chances. But Lukaku nipped in, Rashford's moment would come, and United finished as comfortable winners.

City reignite title race

Sane strike keeps City within reach as Reds slip to first defeat this term

Manchester City reignited the Premier League title race on Thursday as they ended Liverpool's 20-game unbeaten start to the season, beating the Reds 2-1 to reduce their lead at the top of the table to four points.

Pep Guardiola's hosts knew nothing less than a win at Etihad Stadium would do on a night riddled with tension that produced a game that was frenetic if not a classic.

Leroy Sane produced the decisive moment 18 minutes from time as he collected Raheem Sterling's pass to fire across Liverpool goalkeeper Alisson, after it seemed like Roberto Firmino's stooping header would maintain the visitors' unbeaten sequence.

Sergio Aguero had earlier given City the lead with a rising nearpost drive just before the interval.

That came after a moment of drama when Liverpool forward Sadio Mane hit the City post and John Stones scrambled the ball off the line after his attempted clearance struck goalkeeper Ederson with data subsequently showing the ball had failed to cross by just 1.12cm.

Both sides had chances in a frantic finale but it was City who claimed a crucial win.

Guardiola was blunt before the biggest Premier League game of the season: anything other than victory was not an option.

And while City did not produce the purist style

that is their trademark, they dug deep to get the job done despite some late moments of panic in their penalty box and wayward finishing in the other.

City were in danger of falling off the pace following three recent losses that allowed Liverpool to open up an imposing advantage - and that was why the stakes were so high amid a crackling atmosphere.

It was master marksman Aguero who made the crucial breakthrough with a brilliant near-post finish, thinking and moving quicker then Dejan Lovren to beat Alisson.

City also showed real strength of character to respond just as the momentum Liverpool were generating from Firmino's leveller threatened to take the game away from them.

And at the heart of it all was the magnificent Fernandinho - a man seemingly irreplaceable among City's stellar cast - as he delivered a masterclass of controlled midfield play to steady his side when required.

This was a huge night for City and Guardiola and they emphatically answered the questions that have been levelled at them.

They will now look upon a reduced Liverpool lead and believe they have very much kept alive their hopes of retaining the title.

L i v e r p o o l ' s disappointment was clear as manager Jurgen Klopp and his players

trudged off at the end of their first league defeat of the season - a result that backed up Klopp's insistence that this title race has a long way to run.

The Reds were not at their intense best although they will look back at Mane hitting the post and several other scrambles as key moments that went against them.

They will be disappointed at the manner of City's opener as Aguero, with a brilliant finish, preyed on the fatal hesitation of Lovren, who had a thoroughly forgettable night.

Yet once the frustration subsides, Liverpool can reflect on a superb **cont on page 19, col 6**
