# MORE SHAME FOR FADING ROONEY

Former England star blames 'disorientation' due to sleeping tablets for airport arrest

**FORMER** England football captain Wayne Rooney faced humiliation this week after it emerged he was arrested in the United States for being drunk and swearing in public.

Former Manchester United star Rooney, 33, who now plays for MLS outfit DC United, was detained near Washington's main international airport for "public intoxication" on December 16, it was revealed. The footballer was released before later being ordered to pay a \$25 fine and \$91 in costs. And this week embarrassing pictures were released of Rooney in a police mugshot, wearing what is believed to be a police issue T-shirt. However, his spokesman yesterday claimed the arrest came after Rooney was left "disorientated" by prescribed sleeping tablets he had taken on a flight from Saudi Arabia while drinking.

The spokesman said: "During the flight Wayne took a prescribed amount of sleeping

tablets mixed with some alcohol consumption and consequently was disorientated on arrival. He was approached by police who arrested him on a minor misdemeanour charge.

"He received a statutory automatic fine and was released shortly afterwards at the airport. The matter is now at an end.

#### private jet

"Wayne would like to put on record his appreciation for the manner he was treated by all involved."

Rooney had been returning on a private jet from a trip to Saudi Arabian capital Riyadh, where he had been a guest at a grand prix. The star had posted a picture of himself on a private jet on social media on December 15, writing that he was

having "an unbelievable day at Riyadh Formula E Saudi Arabia Grand".

He was held at Washington Dulles Airport during the incident, which is deemed a Class 4 misdemeanor under US law. A spokesman for Loudoun County Sheriff's Office confirmed Rooney was taken into custody "on a charge of public intoxication stemming from an arrest by the Metropolitan Washington Airports Authority Police".

The spokesman added: "He was later released on a personal recognisance bond."

A spokesman for DC United said: "We are aware of the news reports indicating that Wayne Rooney was arrested in December.

"We understand the media's interest in this

matter but we believe this is a private matter for Wayne that DC United will handle internally. We have no further comment."

Rooney is currently 15 months into a drink-driving ban and had carried out 100 hours of community service as part

of his punishment.

He was given a driving ban of two years after being caught nearly three times over the drink-drive limit by Cheshire Police in September 2017 at 2.10am.

Rooney joined MLS club DC United after signing a three-and-a half year deal with the Washington

team in June 2018. He is being paid a reported £46million for his US deal, making him one of the highest-paid players in the league's history.

Given the minor nature of Rooney's incident, MLS, which owns all player contracts, likely won't take any disciplinary action.

# Suspect was 'paranoid' when he murdered man in front of son

A man accused of stabbing a train passenger to death in front of his 14 year old son sat on the floor of the dock and claimed he was hearing voices when he appeared in court on Wednesday.

Darren Pencille, 35, claimed he felt "paranoid" when he appeared at Staines magistrates' court, charged with stabbing Lee Pomeroy, an IT consultant, nine times.

Wearing a grey tracksuit and black thick-rimmed glasses, Mr Pencille initially stood, flanked by two guards in the dock.

He spoke to give his date of birth and nationality and told the court he had no fixed address.

But then he dropped to the floor of the dock, telling the magistrates: "People are making me paranoid. Can I just talk to you like this?"

Turning to the public gallery, which was packed with journalists, he said: "The people are making me paranoid. They look like they are filming, recording me for no reason." He added: "I'm paranoid. I'm hearing voices."

He did not enter pleas and Helen Matthey, the chairman of the bench,

remanded him in custody.

Mr Pencille is accused of attacking Mr Pomeroy at lunchtime on Friday. The pair allegedly got into a row as they boarded a train at Guildford's London Road station.

Mr Pomeroy is thought to have followed Mr Pencille from one carriage into another one before being stabbed.

## 'quality time'

Mr Pomeroy, who would have celebrated his 52nd birthday the day after the attack, had been heading to London to spend some "quality time" with his son, who cradled him as he lay dying.

He was described by his family as "an honourable man and would always help somebody who was in trouble".

In a statement, the family said he was a cultured man, who loved his wife Svetlana Pomeroy (50). "He was a devoted family man and did everything for his family," they said.

Chelsea Mitchell, Mr Pencille's girlfriend, also appeared in court charged with assisting him following the incident by picking him up in her car and helping him change his appearance.

Miss Mitchell denied the charge, with the court told she would claim she did not know what Mr Pencille had allegedly done.

The couple were arrested at an address in Farnham on Saturday morning, around 16 hours after the attack on the train.

Following their appearance at magistrates' court, the pair were taken separately to Guildford Crown Court where they both made a brief appearance.

## UK 'safer'

Mr Pencille spoke to confirm his name and was remanded in custody until Feb 7. Miss Mitchell appeared in the same court, around five minutes later. She smiled at friends in the public gallery before again only speaking to confirm her name.

There was no application for bail and she was remanded in custody to appear before Guildford Crown Court on the same date.

In an online message before her husband's death, Mrs. Pomeroy said she was impressed with the British public and had moved to the UK because it was safer.

## Hardy Amies goes into administration

Men's tailor Hardy Amies has gone into administration for the second time in its 73-year history.

Founded by the former dressmaker to the Queen, it was previously rescued from collapse in 2008.

Administrators at leading accountancy firm Menzies said it had been trading at a loss for "some time". Founded by the late Sir Hardy Amies, it has one shop on London's Savile Row.

Menzies is seeking buyers for its brand's UK operations and intellectual property

rights.

Sir Hardy, who died in 2003, founded the firm initially as a men's shop at 14 Savile Row in 1946, central London, which is still the group's base.

The former wartime intelligence officer began dressing Princess Elizabeth in 1952 and was granted a royal warrant three years later. He was knighted in 1989.

In the 1960s and 1970s, Hardy Amies designed outfits for a number of high-profile clients including the 1966 England World Cup team and the 1972 British

Olympic squad.

He also designed the costumes for Stanley Kubrik's 1968 sci-fi epic 2001: A Space Odyssey.

Freddy Khalastchi, business recovery partner at Menzies, said: "Despite trading at a loss in the UK for some time, the Hardy Amies brand has a unique heritage, which is much-revered in the world of haute couture, and it very much deserves to live on.

"We are looking forward to talking with potential buyers in the coming days and weeks to find a way to make this happen."

# I'm worried to bits, Gazza tells judge as he denies sex assault

**FORMER England football ace Paul Gascoigne this week told a judge: "I'm scared" when told he faces trial later this year accused of sexually assaulting a woman on a train.**

The dishevelled star, who wept during the Italia 90 World Cup

semi-final loss, appeared on the brink of tears again at the end of the 20-minute hearing on Tuesday before insisting: "I cannot wait, I've done nothing wrong."

Gascoigne, 51, arrived at Teesside Crown Court in Middlesbrough wearing a blue suit, open-necked patterned

shirt and sunglasses. He then donned a barrister's wig outside courtroom number two for a selfie with barrister Robert Mochrie. The snap was posted on the barrister's Facebook page, with Mr Mochrie writing: "Standing in court. Next minute I'm hugged and kissed by this legend. He

## Welsh town aims for steep record

A street in north Wales could soon be recognised as the steepest in the world, with official measurements set to be taken.

The title is currently held by Baldwin Street in Dunedin, New Zealand, which has a gradient of 35% at its steepest.

But residents of Harlech in Gwynedd, believe Ffordd Pen Llech, near the town's famous castle in Snowdonia, is steeper at 36%.

Measurements will be taken on Wednesday and sent to Guinness World Records.

But confirmation on whether a new record has been set will not be given until later in the month.

However, Gwyn Headley, who is behind the attempt, is confident.

"I was driving down it in the summer when it struck me how steep it could be," he told BBC Radio Wales' Good Morning Wales programme.

He started researching and found it was the steepest street in Great Britain, but different methodology was used to calculate the world's best in New Zealand.

In a submission to Guinness World Records last September, the residents claimed Ffordd Pen Llech has a

one in 2.73 gradient at its steepest part, compared with the current record holder's 2.86.

Mr Headley joked news of attempts to take the title had not gone down well in New Zealand, where the rivalry had been receiving media attention.

He added: "We suspect they are steepening the street. It may not be the only record they lose this year (referring to the Rugby World Cup in September)."

Most of the houses are at the bottom of Ffordd Pen Llech, with shops at the top, meaning locals can keep fit collecting their groceries each morning.

The record attempt was organised after Mr Headley got in touch with surveyor Myrddyn Phillips.

His work usually

involves carrying out similar work on mountains and hills to see if they are as high as map data suggests and if they need to be reclassified.

He will use GPS equipment, similar to a Sat Nav, to measure points on the steepest ten metre section.

"And get very tired walking up and down the street," he joked.

Guinness World Records sets out a definition for the steepest street.

It is based on its maximum gradient over a ten metre span, comparing the vertical rise to the horizontal distance.

The street or road is also defined as a public thoroughfare that is commonly used by the public, who are able to drive vehicles across it.

tried to buy my wig and then asked if I could deal with his case?... what an utterly bizarre start to the day."

It is contempt of court to take and publish photos within the precinct of a court and the snap was later removed. Mr Mochrie's legal chambers later declined to comment. As Gascoigne waited for Judge Simon Bourne-Arton QC to begin proceedings, he asked the packed courtroom, "Can we have some music?"

He also tried to take a glass of water from the female security guard sitting alongside him in the dock before she pulled her hand away and pointed to him to get his own.

Michelle Colborne QC, prosecuting, said Gascoigne is charged with sexually assaulting a woman over the age of 16 by kissing her on

a train at Darlington. He was arrested while travelling from York to Newcastle on August 20 and later charged with sexual assault by touching, British Transport Police said. Gascoigne, of Leicester, pleaded not guilty and Michelle Heeley QC, defending, told the court his denials will include claims he has a propensity to kiss people "in a non-sexual manner".

### 'I'm skint'

After hearing his trial could not be accommodated until October 14, Gascoigne called out: "Sir, Your Honour. I'm worried to bits. I'm scared."

Gascoigne, who earned millions during his playing career, exclaimed "I'm skint" as he was told by the judge: "Be quiet." He then apologised to the judge before adding:

"Yesterday I had 20 photographs taken. I'm tired."

After again being told to be quiet Gascoigne held both his hands above his head and said: "I'm sorry, I apologise, my lord" before vowing to "whisper".

The judge said: "You have a solicitor and you have a QC, they will look after your interests."

Gascoigne, who played for clubs including Newcastle, Spurs, Lazio, Rangers, Middlesbrough and Everton, was granted unconditional bail. The court was also told he will be applying for legal aid to be represented by a QC, as the case is being prosecuted by a barrister of the same seniority. The judge warned him he must turn up for the trial.

Gascoigne replied: "I will do, your lord. I cannot wait. I have done nothing wrong."

## 14 year old boy murdered after moped crash

LONDON'S knife crime epidemic claimed a new victim this week with the death of a 14-year-old boy who was stabbed by three men after they deliberately rammed his moped on Tuesday.

Jayden Moodie was stabbed up to seven times by attackers armed with 12-inch kitchen knives and was pronounced dead at the scene.

Jayden's heartbroken uncle Josh Grant said the teenager had moved to the capital from Nottinghamshire with his mother Jada last summer. He said: "I'm in bits. He was a good kid. When he was young he looked up to me and I always gave him advice and tried to show him the right way in life.

"It's hard. I told him before they moved down to London six months ago he had to behave down there. He didn't listen."

The painter and decorator said his nephew – a keen footballer and boxer – had been enjoying his new life and hoped to work for him when he finished school. The youngster's godmother Zoe Grant said the level of violence in London was "out of hand". She said: "He was a beautiful boy, so intelligent and had everything to live for.

"He went to London and then this happens, it's just so unfair. He was very dearly loved by everybody."

"The violence is out of hand, it's not right."

Jayden was ambushed as he rode his moped along a residential street in Leyton, east London. One resident, who asked not to be named, said he had seen the attackers run over to Jayden. "Each took it in turns to stab him in the back. He couldn't

do anything. He was just lying there on the ground and they kept plunging their knives into his back. It was horrific," the witness said. "They were large kitchen knives. "There was no shouting. Nothing – just silence. It was truly chilling.

"I tried to revive him. I came out. There was a police officer. He was cutting his jacket with his scissors. We did everything we could. I tried to do my best but I could not save him."

On Wednesday night police in Leyton recovered a black Mercedes B Class car, which they believe was used by the killers. Jayden's grandfather, who gave his name only as Solomon, said: "Jayden was a good child. The system is letting down the youths. "They don't come on the streets because they want to – they don't have a choice."

Residents told of a turf war between rival gangs based in nearby housing estates. Detective Chief Inspector Larry Smith, of Scotland Yard's murder squad, said: "Everything that we have learned about this attack so far indicates it was targeted."

A man narrowly escaped death just hours after the killing when he was slashed in the throat yards away from Jayden's murder. Detectives said it was too early to establish if the attacks were related.

The teenager is the youngest murder victim in London since 14-year-old Corey Junior Davis was shot dead in a playground in Forest Gate, east London, last September. The number of murders in the capital reached 132 last year, topping the previous highest total of 131 in 2009.

## The Hollies' Eric Haydock dead at 75

ERIC Haydock, a founder member of hit-makers The Hollies, has died at 75.

Bandmates paid tributes to him as "one of the finest bass players on the planet".

Haydock, born in Stockport, Greater Manchester, is survived by the four other original group members – Graham Nash, Allan Clarke, Tony Hicks and Bobby Elliott. Drummer Elliott said he would "listen enthralled" to the "masterful" Haydock playing his six-string electric bass during their BBC and Abbey Road recording sessions."

Haydock was one of the first musicians to play the instrument also known as a Fender Bass VI. Elliott said they created the distinctive three-part Hollies harmony behind hits including He Ain't Heavy, He's My Brother, The Air That I Breathe, Just One Look and Bus

Stop. He added: "On the early package tours, Dave Clark, the Kinks and artists of the period would watch from the wings as we effortlessly rocked the screaming theatre audiences into a frenzy."

The band formed in Manchester in 1962 and had more than 30 singles in the British charts.

Haydock left the group in July 1966 after a dispute between the band and their manager over what was seen as excessive management fees. He was replaced by Bernie Calvert. Haydock went on to live in Padfield, Derbyshire, where locals followed his death on Saturday.

One said: "I have very fond memories of our long chats and dog walks." Another wrote: "Very sad to hear the news of the passing of former Padfield resident and former bass guitarist... Eric Haydock.

"Eric kept us entertained on numerous occasions and he always had a tale to tell."

## Moody Blues vocalist Ray Thomas passes away

Ray Thomas, flautist, vocalist and founding member of the Moody Blues, died Thursday at the age of 76.

Thomas' label Esoteric Recordings/Cherry Red Records confirmed the multi-instrumentalist's death on Facebook, adding that Thomas died suddenly at his home in Surrey, England. No cause of death was announced.

"We are deeply shocked by his passing and will miss his warmth, humour and kindness," the label wrote. "It was a privilege to have known and worked with him and our thoughts are with his family and his wife Lee at this sad time."

MoodyBluesbassist John Lodge tweeted Sunday, "Ray and I have been on this magical journey through life together since we were 14... two young

kids from Birmingham who reached for the stars... and we made it together. El Riot you will always be by my side." Thomas and Lodge played together in their band El Riot and the Rebels in the early Sixties.

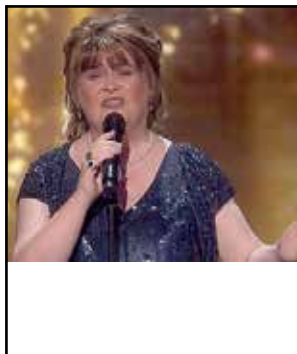
In 1964, after El Riot split, Thomas and keyboardist Mike Pinder formed the Moody Blues alongside drummer Graeme Edge, bassist Clint Warwick and

guitarist Denny Laine. That lineup would release the hit "Go Now" and the 1965 LP The Magnificent Moodies, which featured Thomas on lead vocals for the Gershwin cover "It Ain't Necessarily So."

The Moody Blues would soon replace Laine with Justin Hayward and Warwick with Thomas' El Riot band mate Lodge to form the band's classic

lineup. As flautist, multi-instrumentalist and singer in the Moody Blues, Thomas appeared on all of the prog rock band's albums – including their classic LPs like Days of Future Passed, In Search of the Lost Chord, A Question of Balance and Every Good Boy Deserves Favour – until his retirement in 2002.

## SuBo launches comeback on US TV

SUSAN Boyle launched her career comeback in style when Mel B put her through to the final of Simon Cowell's new US talent show this week.

The Scottish singer, nicknamed SuBo, showed she is still on song as the Spice Girl chose her as her "golden buzzer" act, sending her straight to the semi-finals in the opening episode of America's Got Talent: The Champions. The show brings together the top 50 performers from Got Talents around the world. Susan received a standing ovation on Monday night's show when she sang a pitch-perfect version of the Rolling Stones' Wild Horses. It was her first appearance in a TV competition since she finished runner-up on Britain's Got Talent 10 years ago after stunning judges with her rendition of I Dreamed A Dream.

The 57-year-old said: "I am a champion for those who maybe don't have the confidence to do things, for those who don't have a voice, the ones who people tend to ignore."

"So I could not walk away from a second chance. I had an unfulfilled promise. This time I have something to prove and would love to win."

Mel B, 43, told Susan: "I want to be the woman who gives you something that you deserve."

IT WAS ANOTHER good night for the Brits at the Golden Globes on Sunday, with Christian Bale, Olivia Colman, Richard Madden and Ben Whishaw among the winners for the gongs, which are handed out by the Hollywood Foreign Press Association.

Bale won for his startling transformation into ex-US Vice-President Dick Cheney in *Vice*, while Colman got the nod for her role as Queen Anne in the film *The Favourite*. Madden and Whishaw picked up Globes for TV roles, Madden for his role in the BBC drama *Bodyguard*, and Whishaw for portraying Jeremy Thorpe's lover Norman Scott in *A Very English Scandal*. *Bohemian Rhapsody*, the biopic of Queen frontman Freddie Mercury, won two big awards, including one for its star, American actor Rami Malek.

The Golden Globes have long been scorned as awards because of the small and secretive membership of the HFPA, but they usually provide a vital early guide to the Oscar favorites.

Colman cemented her place as one of the British acting's hottest talents and a crowd favorite, giving an excited acceptance speech that ended with her holding up her trophy and sending a message to her family: "Ed and the kids

- look! Yay!"

And although the ceremony was less political than in years past, Christian Bale did provide one acid moment when he thanked "Satan" for inspiration for his role in *Vice*.

Richard Madden is best known on these shores for his role as Rob Stark in HBO's *Game of Thrones*, but that might change after picking up the Globe for best TV drama actor playing Sergeant David Budd in BBC One's *Bodyguard*. The final episode was watched by more than 17 million people in the UK - making it the UK's most watched episode of a TV drama since current records began in 2002. Madden said of the nod: "I didn't see this coming at all."

He used his speech to pay tribute to co-star Keeley Hawes, "the best actress I could ever work with", series creator Jed Mercurio, and his mother and father, who had flown from Scotland for the ceremony.

### 'A true queer hero'

Whishaw, meanwhile, dedicated his best actor in a TV limited series trophy to Norman Scott, the man he portrayed in *A Very English Scandal*. Scott was targeted in a failed murder plot allegedly hatched by Liberal politician Jeremy Thorpe, played in the drama by Hugh Grant.

Whishaw said Scott "took on the

establishment with a courage and defiance that I find completely inspiring", adding: "He's a true queer hero, an icon, and Norman, this is for you."

And another British win was to be found in the Globe going to Sandra Oh for her role in *Killing Eve*, the unconventional British spy drama written by English writer Phoebe Waller-Bridge.

Musician Mark Ronson was another

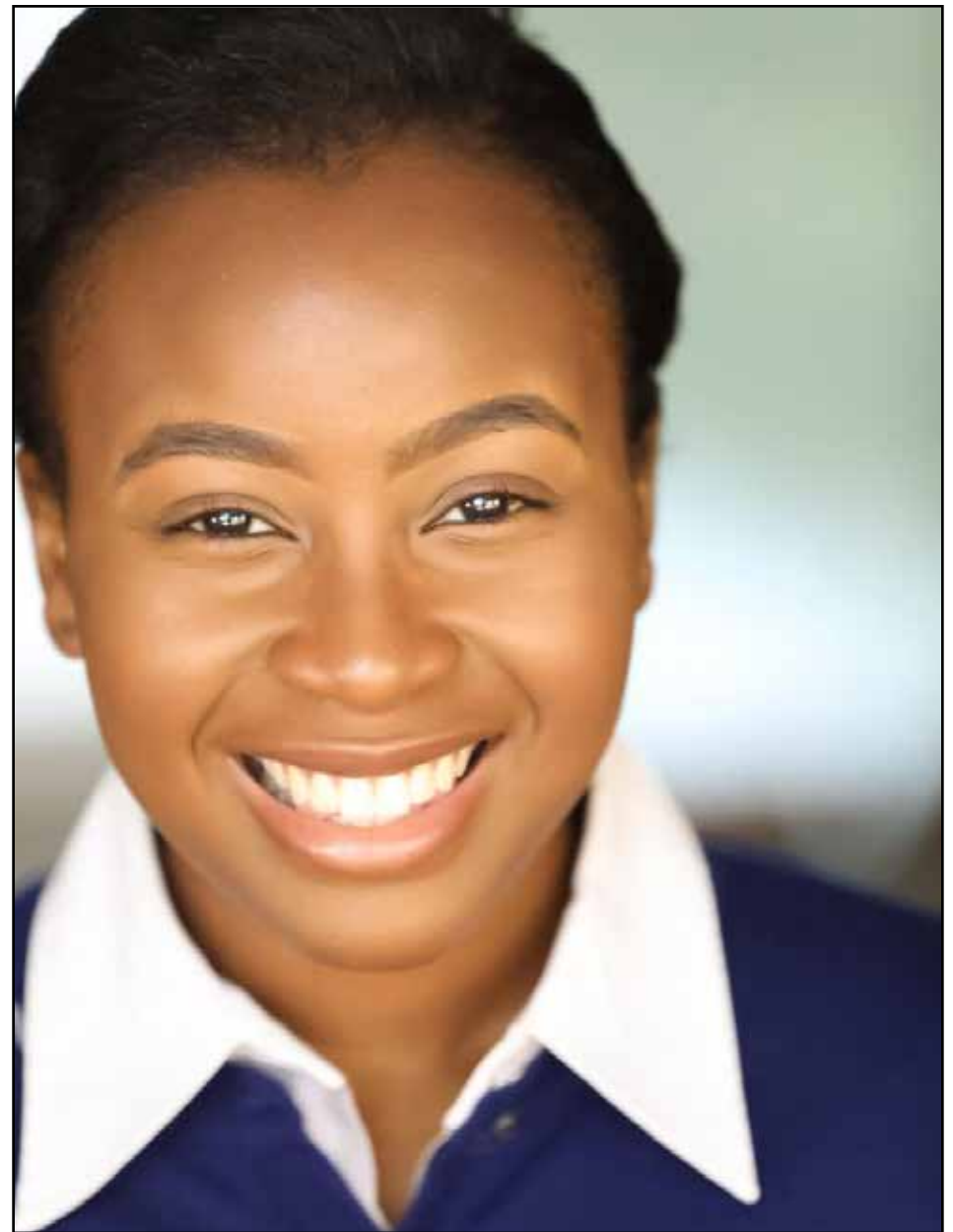
**What was your first impression of LA and has it changed since?**

**What do you find the biggest difference is living here versus Dagenham?**

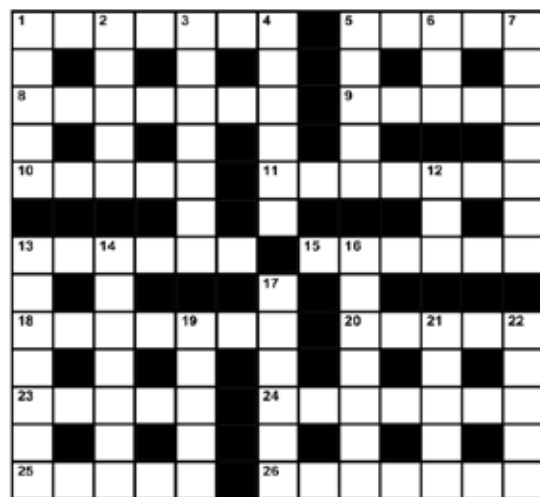

how it will affect your visa applications. The good news is that at the time of writing the US embassy in the UK is still functioning as normal. You can check for real time updates on their Facebook page: [facebook.com/ukusembassy](https://facebook.com/ukusembassy). They are also on Twitter @USAinUK but they don't seem to update that as frequently.

The current state of affairs in politics seems unfathomable. I really feel for the over 800,000 federal workers, of which 320,000 have been given a leave of absence with no pay and are basically stuck in limbo. Many of them have had to take temporary jobs or borrow money, trying to make ends meet. It's even worse for over 400,000 employees that are exempt from the furlough, as they still have to work but don't get paid, and therefore have no opportunity to earn cash on the side. This includes the staff at Homeland Security and the TSA, so if you are traveling anytime during this chaos make sure to be nice and thank them for their service.

For those of you who are really furious about this mess and think you could do a better job, why not consider running for your local council? Contrary to popular belief you don't need to be a citizen to be eligible. According to [empowerla.org](http://empowerla.org) you don't actually even need to be a resident.

"Neighborhood Council elections are inclusive. They are open not just to residents who are US citizens, but also to those who work, own property or a business, go to school or church, or have some other substantial, ongoing participation within the community served by a particular

Neighborhood Council. You do not need to be a US citizen or legal US resident to run for a seat, even if you are undocumented or were formerly incarcerated. However, candidates must meet the minimum age to qualify for the seat they are running for. You'll see details about minimum age requirements for specific seats during the candidate registration process."

If you are curious to see what board seats are available in your area visit [EmpowerLA.org](http://EmpowerLA.org) as they have a great website that can help guide you.

## Old Lady’s buying power likely to entice Ramsey

**Juventus are leading the race to sign Arsenal midfielder Aaron Ramsey when his contract expires at the end of the season.**

The 28-year-old’s current preference is to join the Italian champions but, contrary to some reports, he has yet to make a final decision and will continue to consider offers from a number of Europe’s leading clubs.

The likelihood is Ramsey’s next club, with no transfer fee to pay, will make him the best-paid British player of all time.

It is understood his boyhood dream was to play for Barcelona but despite preliminary talks that option will not be pursued.

An offer from Paris St-Germain is thought to carry great appeal, while there is also interest from Real Madrid, Bayern Munich and Inter Milan.

Madrid forward Gareth Bale is understood to have encouraged his Wales team-mate to link up with him in Spain.

There have been enquiries from English sides and if Ramsey was to remain in the Premier League he would favour a move to Liverpool.

However, although

there is still a possibility the situation might change, it is almost certain the former Cardiff player will go abroad.

Once Ramsey’s choice is made, he is expected to sign a pre-contract agreement and undergo a medical this month.

He will complete the campaign with Arsenal prior to leaving as a free agent in the summer.

He will not be signing a new deal with Arsenal after the Gunners withdrew a fresh four-year offer in September for football and financial reasons.

The two parties were close to finalising an agreement but no physical contract was on the table when the club decided to pull out.

Ramsey was said to be keen to stay yet grew frustrated with the protracted process and, by the end, there were doubts over whether he would have put pen to paper.

Ultimately Arsenal were not prepared to meet his salary demands, with some among the hierarchy regretting the new deal given to Mesut Ozil a year ago, worth £350,000 per week, and determined to avoid a repeat.

Meanwhile, head coach Unai Emery had reservations about Ramsey’s role in his squad.

Soon after Emery was appointed last summer, it was reported he wanted to build the team around Arsenal’s longest-serving player, who was named as one of five captains for this season.

But it became clear that Ramsey’s desire to play as a number eight, running on to the ball from an advanced central midfield position, clashed with Emery’s vision.

Emery does not usually deploy a number eight, meaning the Welshman has mainly been used in a strict deeper role without license to roam or in the number 10 position with his back to goal.

That partly explains why Ramsey’s game time has been limited and is among the factors attracting him to Juventus, where manager Massimiliano Allegri tends to operate with a three-man midfield.

Arsenal boss Emery praised the midfielder’s attitude on Thursday, saying: “Every day he’s here with us, he’s working very well.”

## City with one foot in the final as Jesus fills his boots

Gabriel Jesus grabbed four goals as Manchester City all but secured their place in the EFL Cup final with a crushing 9-0 first-leg victory over Burton Albion on Wednesday.

The Premier League champions have now put 16 goals past lower-league opposition in the past four days, Pep Guardiola's men having thrashed Rotherham United 7-0 in the FA Cup on Sunday.

Kevin De Bruyne's first headed goal in English football set the hosts on their way, with Jesus adding a quickfire double before Oleksandr Zinchenko fortuitously opened his City account.

Jesus took his tally to four either side of Phil Foden's tap-in, before Kyle Walker and Riyad Mahrez completed a miserable night for Burton's cup heroes.

It took City five minutes to unlock the Burton defence, David Silva's pinpoint pass picking out De Bruyne's run and the Belgium international made no mistake with his header.

Despite falling behind Burton rallied and Marcus Harness should have equalised in the 12th minute, but he blazed Lucas Akins' cross over the

bar.

City's control of proceedings was never under threat, though, and in the space of seven minutes the hosts were four goals ahead as Jesus and Zinchenko struck.

Having pounced on a loose ball after Leroy Sané's shot was saved by Bradley Collins, Jesus doubled his tally from Silva's pass – the striker taking his time before slotting it in off the post.

City's fourth was harsh on the visitors as Zinchenko's attempted cross looped over Collins, but there was no doubting the quality of Jesus' hat-trick goal as he converted Mahrez's cross to the back post.

Four minutes after replacing the impressive De Bruyne, Foden had his second Etihad goal in as many games, the youngster profiting after Jesus had been held up by Burton's defenders.

Jesus would not be denied a fourth moments later, though, as Sané beautifully controlled Mahrez's pass on his chest before finding the striker, who applied the finishing touch.

After setting up Walker for City's eighth, Mahrez completed Burton's misery

with a goal of his own, the Algeria international poking the ball past Collins to round out a one-sided semi-final encounter.

The second leg, merely a formality, takes place on Wednesday, 23 January.

"The result was good and of course we are already in the final but we have to play the second leg," said Guardiola.

The win at Etihad Stadium was the largest winning margin in the semi-final of the competition, and the widest victory in the tournament in more than 32 years - since Liverpool beat Fulham 10-0 in a second-round first-leg tie in September 1986.

It was also the first time in more than 31 years City had scored nine goals in a single match - they beat Huddersfield Town 10-1 in a second-tier league encounter in November 1987, and it matched Guardiola's biggest win as a manager - equalling Barcelona's 9-0 thrashing of L'Hospitalet in the Copa del Rey in December 2011.

"It is not easy to play this type of game against a lower team," added Guardiola, whose side are set to face either Tottenham or Chelsea in February's final.

## Klopp: I would never disrespect the FA Cup

JURGEN KLOPP said he would never disrespect the FA Cup after his Liverpool side crashed out at Wolves on Monday.
