



UK KNIFE CRIME 'OUT OF CONTROL'

[Demands for action grow as new figures reveal number of children stabbed to death has almost doubled](#)

MINISTERS are facing urgent demands to put 20,000 more police officers on Britain's streets as the country's knife crime epidemic neared crisis point.

The call came after two teenagers lost their lives in a weekend of bloodshed with stabbings claiming the lives of promising 17-year-old victims in London and Manchester.

On Monday ex-Met Police Commander Lord Hogan-Howe demanded an immediate increase to the nation's depleted number of bobbies on the beat. Figures released on Monday showed the number of children stabbed almost doubled in England over the past five years as police numbers have been decimated.

Lord Hogan-Howe urged the Government to recruit a "knife tsar" to oversee a radical new approach to tackling the epidemic.

He said: "It's important to focus attention on the exploitation of children in socially deprived areas.

"We need to increase police numbers in these areas and reduce the drug supply into the UK and its distribution including by county lines. The number of police officers needs to be increased by 20,000 as quickly as possible and ensure that they are targeted into deprived areas where they're most needed.

"Technology is in the Dark Ages. At the moment we're relying on cops to use their common sense and intuition to find people with knives. What we need is great facial recognition and behavioural science software that helps them to find who and when to

search."

On Saturday an A level pupil at Manchester Grammar School became the latest child to die after violence exploded in a leafy suburb that is home to football stars and business magnates.

A teenager has been charged with the murder of Yousef Makki after police were called to reports of a stabbing in Hale Barns, near Altrincham, at 6.40pm. Yousef, who dreamed of being a heart surgeon,

was rushed to hospital but could not be saved. His death came less than 24 hours after the horrific murder of Girl Scout Jodie Chesney who died in her boyfriend's arms in an east London park. Eddie Coyle, 18, pleaded

with Jodie to stay awake as she lay dying from stab wounds to her back after being attacked by "men in balaclavas" as she sat with Mr Coyle and a friend on a bench in Harold Hill, Romford, at 9.25pm.

Bereaved family demand swift action on knife crime

"Enough is enough. The problem with knives has got out of control. This can't go on."

THE family of murdered teenager Jodie Chesney have backed demands for longer prison terms for knife crime.

Jodie, 17, was stabbed in the back while listening to music with friends in an east London

park on Friday.

Her relatives have now urged the public to support a petition calling for people to face 10-year jail sentences for carrying knives and 25-year terms for using a blade.

More than 34,000

people have already backed the petition.

Currently, about two-thirds of criminals caught with knives avoid jail.

The current maximum jail term for an adult caught carrying a knife is four years in prison and an unlimited fine.

'tougher sentences'

Jodie's grandmother Debbie Chesney, 73, issued a direct plea to the killer, his family and friends to come forward. In a message on Facebook she wrote: "Please if anyone knows anything about this, tell the police. "We are having a hard time believing it. I hope they find whoever did this. We are still in shock at the moment. We just hope the police can find the culprit. Please just share the post in the hopes that the boy who did this or his friends or family have the decency to tell the police who he is."

Jodie's distraught cousin Mark Lotter, 20, said: "Enough is enough. The problem with knives has got out of control. This can't go on. It's just going to get worse. How many more families need to lose a loved one?"

"The Government has to do something. We need more police and tougher sentences."

Jodie, from Dagenham, died from a single knife wound to the back after she had gone to the local park to with her boyfriend Eddie Coyle, 18, and four other friends. One theory is that Jodie was the random victim of a gang initiation attack.

John Apter, chairman of the Police Federation of England and Wales, criticised the Government for failing to call an emergency crisis meeting to address knife crime.

Some officials have suggested the knife crime problem should be treated in a similar way to

terrorism. Mr Apter said: "Despite the rhetoric you hear from politicians about being tough on those who carry knives, two-thirds of those who are convicted don't face prison."

"We have a Justice Secretary who is saying we need to scrap shorter sentences because the prisons are full."

"My argument is build more prisons. We need to have a consequence."

Former Home Office minister Vernon Coaker yesterday suggested knife crime should be treated like terrorism. He said: "We're seeing the murder of young people on our streets – families wrecked, communities almost under attack. "If a terrorist incident occurs,

of course we should deal with that really seriously, but this is also something which is a national crisis and a national emergency."

Victims' Commissioner Baroness Newlove said knife crime is "like a cancer – if you don't get it, it will spread".

The Government has come under fire for its handling of violent crime, with Prime Minister Theresa May even suggesting there was no link between street violence and police cuts. There are 21,000 fewer police officers in England and Wales than there were in 2010, according to official statistics. Experts fear police are missing out on crucial intelligence about those carrying knives and gang members.

THE HEARTBROKEN family of murdered Yousef Makki described their son as incredibly bright", a "double A-star student" who had dreamed of becoming a heart surgeon.

Yousef grew up in a mid-terrace council house with his father Ghaleb, a chef from Lebanon, and saleswoman mother Deborah, and was visiting a friend on the night of the attack.

"He was a wonderful boy with no enemies and always had a smile on his face," said a neighbor of the dead boy, adding 'the whole street is heartbroken."

Terror as family of Leicester boss hide from home raiders

THE wife and six-year-old stepdaughter of Premier league boss Brendan Rodgers barricaded themselves in a bathroom during a raid at their luxury home, it has emerged.

It happened just over a week after the Irishman quit Glasgow giants Celtic to head south to Leicester City. Charlotte Rodgers and daughter, Lola, were asleep in the early hours Sunday when two thieves broke into the family's ranch-like home in the Bearsden suburb of Glasgow. They were awoken when two thugs burst into the master bedroom

– shining a torch as they swept through the house. A source said: "Since Brendan left, Lola has been sleeping with her mum so they were in bed together when the men came into the bedroom.

"Charlotte was still half asleep... but when she realised there were two men in the room holding a torch she screamed and then ran with Lola to the bathroom and locked the door.

"It was a horrifying experience for them both."

The source added: "Charlotte had been

with Brendan for a few days after he moved to Leicester and it seems likely that the house was being cased out.

"She had been worried about staying in the house alone but Brendan assured her everything would be OK."

He added: "They took some stuff from downstairs and a lot of Celtic memorabilia.

"The plan had been for Lola to stay in school in Scotland. But it looks as if that is going to have to change now as Brendan is obviously pretty distressed."

During a trophy-laden two-and-a-half years in

charge of Celtic, Rodgers became the first manager in Scottish football history to win back-to-back domestic trebles. But he faced a furious

backlash from the club's supporters after making the shock decision to leave for The Foxes. Less than 24 hours after he quit, video footage was

posted online of a group of Celtic fans chanting for Rodgers to be shot dead in his sleep. Police are investigating both incidents.

£30,000 a dram! 1926 whisky fetches £615,000 at auction

A BOTTLE of whisky with a label designed by acclaimed pop artist Sir Peter Blake was bought at auction this week for £615,000.

The 1926 Macallan is one of just 12 that features the distinctive label by Sir Peter, who is best known for co-creating The Beatles' psychedelic 1967 Sgt Pepper's album cover. The whisky attracted interest from collectors around the world and was eventually sold to an anonymous overseas telephone bidder.

Auctioneer Charles Graham Campbell opened the bidding at Bonhams in Edinburgh at £360,000. Following a flurry of activity the hammer came down at £500,000 – although the buyer must pay £615,063 with commission – making it £30,750 per dram. The price is the sixth highest paid for a scotch at auction and the third highest for a bottle with the Blake label. It is not known how many of the original 12 still exist.

The whisky lay at Macallan's distillery in Scotland for more than

60 years in an oaken cask brought from Jerez in Spain before it was bottled in 1986. Ahead of the sale, the whisky was described as "dark honey-gold in colour, and almost inconceivably smooth, with a luscious hint of dry-sweetness in the malt".

Bonhams whisky specialist, Martin Green, said: "It's very exciting to have sold one of these

incredibly rare bottles here in Scotland at such a very high price."

The world record for selling a bottle of whisky at auction was set in November last year when a Macallan 1926, hand-painted by Irish artist Michael Dillon, was sold at Christie's in London for £1.2million – breaking the £1million barrier for the first time.

Man jailed for acid attack on three-year-old son

AN "arrogant and selfish" father who organized an acid attack on his three-year-old son has been jailed for 16 years.

The man, 40, had enlisted others to burn the boy in an effort to discredit his estranged wife during a custody battle. The child suffered burns to his arm and forehead when sulphuric acid was squirted at him as he shopped with his mother. At the end of a six-week trial, the parent and five other defendants

were convicted by a jury of conspiring to throw sulphuric acid with intent to "burn, maim or disfigure" the little boy in July last year.

Adam Cech, 27, of Birmingham, who threw the acid, was jailed for 12 years. Jan Dudi, 25, of Birmingham, Norbert Pulko, 22, of London and Jabar Paktia, 42, of Wolverhampton, were also sentenced to 12 years. Said Hussini, 41, of London, was caged for 14 years. Martina

Badiova, 23, was cleared by majority verdict at Worcester Crown Court of the same charges. Sentencing, Judge Robert Jukes QC told the father, who cannot be named in order to protect the boy's identity: "You felt you had been humiliated by your wife when she left you [in 2016]. She went into hiding with the three children. You tracked them down. With this knowledge you went to your friend, Paktia, and told him what you wanted."

Beckham cements his place in LA soccer history

David Beckham wiped away a tear this week as his place in Los Angeles Galaxy history was set in stone.

The former England captain was clearly emotional as a statue of his likeness striking a soccer ball was unveiled at the newly-named Dignity Health Sports Park in Carson,

"It wasn't always easy, I know," he told the fans at the unveiling, which took place before the Galaxy's season opener against the Chicago Fire. "For that, I apologize, but it was one of those relationships between us. ...When I first arrived, the support that you showed me, the love that you showed me, the passion, the loyalty that you showed this club and this team, can never be questioned.

"For you guys, in the end, I hope that I won you over. My commitment to this club, to this league, to this country, was always a lot more than just on the field. I wanted to grow this league, I wanted to play a small part in growing this league and bringing players

and bringing Cups and making this league more successful and bigger than it already was."

At halftime, Beckham was inducted into the Galaxy's Ring of Honor.

Beckham won championships with LA Galaxy in 2011 and 2012 during his six years and 98 appearances.

Beckham described Los Angeles as "our city, our home," as he was joined by his fashion designer wife Victoria, 44, at the unveiling.

The father-of-four added: "From day one when my family arrived in this city, we felt at home and for that we will be forever grateful. When I talk about LA Galaxy and when I talk about LA, I talk about it as family because it is a big family."

Tributes flowed from several sports greats, including former Galaxy team-mate Robbie Keane, who described the 43-year-old as a loyal friend and family man.

"The David Beckham the public know is a global superstar and icon throughout the world,"

said Keane. "But the one I know is even better."

Retired national basketball star Kobe Bryant also gave a videotaped tribute to the ex-Manchester United and Real Madrid midfielder.

"He was the first truly big name to come to the States and really draw attention to the sport," said the former Los Angeles Lakers forward.

The statue unveiling came a day after Beckham, who is owner of football club Inter Miami which will join the MLS in 2020, helped open a refurbished football

field with facilities for underprivileged children in LA.

"Taking care of the

next generation of soccer stars in this country is really important and we did it in a community that

really needed support and a safe environment for children," said Beckham.

Idris Elba's directorial debut to screen in Hollywood

YARDIE, Idris Elba's debut as a feature director, is coming to Los Angeles for a limited engagement at the Arena Cinelounge in Hollywood March 15-21st.

Was there a particular reason you chose LA?


join our group Brits in LA seeking out words of wisdom - what is the best piece of advice you've been given?

I'm always working, and appreciate any follows or DMs re: collaboration.



extended this period, but I completely appreciate how easy it is to miss or forget. I've been here over 20 years now and the American healthcare system is probably the only thing that still makes me feel like a 'foreigner'. Every time I think I have got to grips with it, the rules change. There aren't a lot of options if you don't currently have coverage. If you have had a life changing event such as having a baby, getting married or losing health coverage you should qualify for a 'Special Enrollment Period', you can check your eligibility on CoveredCa.com. Native Americans and people eligible for

Medicaid/CHIP can enroll year-round.

Many states offer short term limited coverage. Unfortunately, California has banned these plans as they destabilize the health marketplace. But don't despair if you are uninsured as there are quite a few free or low cost clinics and hospitals scattered around Los Angeles. Go to their website Los Angeles Department of Health at <http://dhs.lacounty.gov/>

Also, the Centers for Disease Control offer some free or low cost services, including mammograms and Pap smears. Visit www.cdc.gov

Planned Parenthood is another fantastic resource.

Contrary to popular belief they are not 'just an abortion clinic'. They offer a wide range of medical services, including general health care for both men and women and everyone in between. The cost is based on your income so the less you earn the less you pay. Go to www.plannedparenthood.org to learn more



City under investigation by UEFA

Manchester City are being investigated by Uefa for alleged financial fair play violations.

Uefa said the investigation "will focus on several alleged violations of FFP that were recently made public in various media outlets".

German news magazine Der Spiegel has published a series of claims, based on leaked documents, that Premier League champions City have violated FFP rules.

City said: "The accusation of financial irregularities is entirely false."

The club added: "Manchester City welcomes the opening of a formal Uefa investigation as an opportunity to bring to an end the speculation resulting from the illegal hacking and out of context publication of City emails."

"The club's published accounts are full and complete and a matter of legal and regulatory

record." Uefa previously found City had breached FFP rules in 2014.

The two parties reached a settlement, with City paying a £49m fine - £32m of which was suspended - while their Champions League squad was reduced for the 2014-15 season.

The Football Association is looking into claims City made a banned £200,000 payment to Jadon Sancho's agent when the England winger was 14

years old.

That allegation was also made in documents published by Der Spiegel last month.

Uefa says it will make no further comment while the investigation is ongoing.

FFP rules are designed to ensure that the amount clubs spend on their players and wages is approximately equal to what they earn in commercial revenue and prize money.

Chelsea ease to Europa win

Callum Hudson-Odoi scored his third Europa League goal of the season as Chelsea beat Dynamo Kiev in their last-16 first-leg match on Thursday night to put one foot in the quarter-finals.

The lively Pedro opened the scoring from close range as he ran on to Olivier Giroud's backheel.

Willian struck the second goal Chelsea's dominance deserved as he curled home from 25 yards.

Teenager Hudson-Odoi added a late third to put Chelsea in control of the tie.

Dynamo Kiev - who have never won in their 15 visits to England - did not manage a shot on target.

The second leg is at Kiev's Olympic Stadium next Thursday at 17:55 GMT.

The Blues, who won the Europa League in 2013, may need to win the tournament to

qualify for next season's Champions League as they are sixth in the Premier League.

Maurizio Sarri made six changes but still named a relatively strong team, with Eden Hazard, N'Golo Kante and Gonzalo Higuain on the bench in case of emergency.

Pedro scored the opener when he moved in from the left and played a one-two with Giroud before placing the ball through the legs of goalkeeper Boyko.

He then missed a glorious chance to double the lead as he fired straight at the keeper from six yards from Davide Zappacosta's cross.

Ross Barkley had a shot stopped by the goalkeeper's legs, before Pedro had a volley and 18-yard effort saved.

After the break, the ex-Barcelona winger again tested Boyko as he cut in from the right but his low effort was stopped.

It looked at that stage like Chelsea might be going to Ukraine with only a one-goal lead, but then Willian stepped up with a free-kick which left Boyko rooted to the spot.

Hudson-Odoi scored after a pass from fellow substitute Ruben Loftus-Cheek late on to put Chelsea on the brink of the last eight.

Kepa Arrizabalaga, who kept his place in goal, was not needed to make a save, although he flapped at a cross late on.

Hudson-Odoi has enjoyed the Europa League this season, netting against PAOK Salonika in the group stage and at home to Malmo in the last round.

Sarri's refusal to give the winger more game time has frustrated Chelsea fans - especially with their recent struggles - and he came on to a great ovation when he replaced Willian with 12 minutes left.

Harry strikes again as Spurs bounce back from bad run

Tottenham eased past Borussia Dortmund on Tuesday night to reach the Champions League quarter-finals for the first time since 2011 as Harry Kane became the club's top scorer in European competition.

Leading 3-0 from the first leg, Spurs were forced to survive a first-half barrage from the Bundesliga leaders in the crackling atmosphere of the Westfalenstadion.

But Kane's intervention just after half-time ensured a comfortable second period in which the hosts failed to register a shot on target.

Latching on to Moussa Sissoko's pass, the England captain clinically lifted the ball past home goalkeeper Roman Burki into the right corner.

It was Kane's first effort

on goal and confirmed a 4-0 aggregate win for a Tottenham side that defended resolutely throughout.

Kane's 24th European goal moves him one clear of the club record he previously shared with Jermain Defoe.

The draw for the quarter-finals takes place on Friday, 15 March.

Mauricio Pochettino's Spurs side have kept just one clean sheet in the Premier League in 2019, but they looked solid in Germany after deploying the same three-man defence that helped them to a commanding first-leg lead.

Jan Vertonghen's 10th-minute tackle on Marco Reus exemplified their early resolve. Timing his challenge to perfection, the Belgian nipped the ball away from the

Dortmund attacker who had broken clear inside the area.

When Dortmund did break through, Spurs goalkeeper Hugo Lloris made brilliant saves from Reus, Julian Weigl, Mario Gotze and Jadon Sancho, while Weigl was denied a second time by a superb Ben Davies block.

Dortmund bombarded Lloris' goal with five shots on target in the latter stages of the opening half, but Tottenham carried a threat on the break with the pace and movement of Son Heung-min and Kane.

Son clipped an effort just wide of the left post before Kane's clinical finish inflicted a first home defeat on Dortmund under manager Lucien Favre.

United legends revel in the moment



If you were in any doubt as to how much Manchester United's Champions League victory over Paris-St Germain meant to the club, the image of three legends celebrating in the dressing room tells you all you need to know.

Eric Cantona, Sir Alex Ferguson and Ole Gunnar Solskjaer, three men who have earned their place in the United history books, toasted a memorable night at Parc des Princes.

It was a victory that

echoed of a night in Barcelona 20 years ago, when, with Ferguson at the United helm, Solskjaer scored one of the club's most famous goals in injury time to beat Bayern Munich in the final.

Almost two decades later, Solskjaer is caretaker manager at Old Trafford and his charges rolled back the years as Marcus Rashford's injury-time penalty capped a remarkable turnaround as United reached the quarter-finals at the expense of shell-shocked PSG.

"That's the Champions League, it's what it does," said Solskjaer. "It's this club, it's what we do, that's Manchester United."

Frenchman Cantona who helped United win four league titles and two FA Cups during the 1990s, added: "I love it. I'm so happy."

Two Romelu Lukaku goals and Rashford's 94th-minute spot-kick meant United became the first club in the competition's history to overturn a 2-0 or greater first-leg home deficit.

It also ensured only Tottenham's third appearance in the last eight of the competition.

Tottenham manager Mauricio Pochettino, speaking to BT Sport: "We

are in the quarter-finals. I'm so happy for the players and the fans. It's an important victory. Of course we suffered a bit but it's OK and we fully deserve to be in the

quarter-finals.

"Hugo Lloris was great. We conceded more chances than we expected but that's football. After losing in the first leg they had nothing to lose."

'This is what we do'

Solskjaer in dreamland as United pull off dramatic victory in Paris

Manchester United caretaker boss Ole Gunnar Solskjaer led the club into the Champions League quarter-finals on a dramatic night in Paris and then declared: "This is what we do."

Romelu Lukaku scored twice before Marcus Rashford's VAR-awarded penalty saw United progress on away goals at the expense of Paris St-Germain.

"It's this club. It's what we do, that's Man Utd," said Solskjaer, who famously scored a late winner for United in the 1999 final. "That's the Champions League, it's what it does."

This is the first time since 2014 that United have reached the last eight. The last four quarter-finalists will be decided on 12 and 13 March, with the draw on 15 March.

"We can go all the way," said Solskjaer. "Of course we fancy ourselves, but we just have to wait for the draw and then take

the game as it comes."

The Norwegian added: "It's a typical Manchester United night. We had a gameplan and the belief in the boys was what we hoped for. Everyone shares a huge pride."

"The players were really great. They were focused, they listened to all the instructions like in training, and on the pitch they knew that we had to defend well. There was a lot of quality."

Lukaku's early opener gave United hope and although Juan Bernat equalised, Lukaku struck again in the first half before Rashford sent the Red Devils through.

"It was a great start - we planned to get the first goal but we didn't expect it after two minutes," Solskjaer said. "That made it open, we wanted a lot of goals."

"We knew that we would have to suffer, defending against Kylian Mbappe and Angel di Maria. It is known that

if we leave spaces, it is certain death.

"We saw yesterday with the match between Real Madrid and Ajax, Barcelona against PSG [in 2017] - they are scenarios that are similar and it shows that the mind in football is important."

"Our boys are young and fresh, which gave us more energy when we needed that goal."

Defensive woes cost Gunners

Arsenal manager Unai Emery says he has "confidence" his side can overturn Rennes' 3-1 lead at Emirates Stadium in the second leg of their Europa League last-16 tie.

Alex Iwobi's early cross-shot had put Arsenal in front but they lost control of the game after Sokratis Papastathopoulos' dismissal for a second booking Thursday night in France.

Benjamin Bourigeaud immediately drew the hosts level with a stunning strike into the top right corner, with Nacho Monreal's own goal and Ismaila Sarr's late header compounding a miserable evening for Arsenal.

"The red card changed the game more than we wanted," Emery said.

"The first 40 minutes we controlled, we scored, we didn't concede good chances. I think we can do better and I have confidence with our players and our supporters helping us."

Arsenal go into the second leg having overturned a 1-0 deficit in the last-32 stage.

On that occasion, they progressed with a 3-0 home victory over Belarus side Bate Borisov.

Arsenal arrived at Roazhon Park having never lost an away game against French opposition. For large parts of the first

half, that record looked like remaining intact as they gathered an early lead courtesy of Iwobi and controlled possession.

But while Lucas Torreira's effort was superbly saved by Rennes goalkeeper Tomas Koubek and Pierre-Emerick Aubameyang also tested the Czech keeper they proved architects of their own downfall in an 86-second spell.

Having already been booked for a foul on Hatem Ben Arfa, Greece defender Papastathopoulos pulled Sarr's shirt to earn his second yellow card, shifting the momentum of the game in the hosts' favour.
