BREXIT DELAYED!

■ May given until end of October to make a workable deal
■ But PM repeats she opposes a second referendum

EU leaders have granted Theresa May a six-month Brexit extension - coupled with a stark warning not to "waste this time".

After more than six hours of late-night talks in Brussels in which France clashed with Germany over the length and terms of the extension, the European Council on Wednesday agreed that Britain's membership of the bloc could continue until October 31.

In a press conference in the early hours of Thursday Mrs May claimed that the new extension still meant that the UK could leave the bloc earlier as long as the withdrawal agreement was ratified.

"What we have agreed tonight means that we can leave the European Union before June 30. What we need is to ensure that we have an agreement in parliament, that we can get through the necessary legislation to enable us to leave. This decision enables us to do that."

Meanwhile, the Independent Group of Members of Parliament, - 11 MPS who all quit their respective parties in February largely over Brexit, are in the process

of setting up official party structures and plan to be called "Change U.K. - The Independent Group." They've named former Tory Heidi Allen as their leader, with former Labour MP Chuka Umunna their spokesman and plan to stand candidates in forthcoming EU elections.

"All of our candidates will be making the case for a People's Vote," Umunna said in a statement. "Brexit is proving to be undeliverable, we believe the people should have the final say on this matter, and the best option is for the U.K. to remain a full member of the European Union."

'everything is possible'

The development of a cross-party consensus towards a second referendum was expected to increase pressure on May to agree to a new vote, but when questioned by the leader of the Scottish National Party Ian Blackford on Thursday whether the Conservatives and Labour have discussed a

second referendum, May replied: "The government has not offered a second referendum."

She said the Withdrawal Agreement Bill would allow MPs an opportunity to put down amendments to allow for a public vote, although she doesn't support the idea. "I believe it is important to deliver on the result of the first referendum," she said.

Donald Tusk, 61, president of the European Council, did not rule out a further extension

if the political deadlock in London continued. "I am too old to exclude another scenario," he said. "I think still everything is possible."

In reference to the divisions among the 27 leaders he added: "This extension is as flexible as I expected, and a little bit shorter than I expected, but it's still enough to find the best possible solution. Please do not waste this time."

It is understood that during the talks President Macron of France argued

for a shorter extension that would have been subject to a review in June, potentially meaning that the UK could have crashed out if sufficient progress had not been made towards a deal.

Germany and more than a dozen other member states had called for the Brexit deadline to be pushed back until the end of the year to give the UK time to hold a second referendum or a general election.

In the end a compromise was reached for a

Hallowe'en extension and only a formal update on progress at the EU's June summit, with no ability bring forward the cut-off date.

The move will pile pressure on Mrs May to step down so that a new leader can be chosen before the Conservative Party conference, which takes place less than a month before the new deadline. Senior government sources said, however, that Mrs May intended to stay on

Government fires adviser over George Soros and Islamophobia remarks

LEADING BRITISH philosopher Sir Roger Scruton should be stripped of his knighthood, The Labour Party said this week, after he was sacked as a government adviser for claiming that there was a "Soros empire" and that Islamophobia was an invented term.

The 75-year-old writer was appointed as a housing adviser less than six months ago. He was fired after giving a magazine interview.

Sir Roger said that the word Islamophobia was invented by the Muslim Brotherhood, an extremist Sunni Islam organisation, "to stop

discussion of a major issue". He also said that it was "nonsense" to accuse Viktor Orban, the Hungarian prime minister, of antisemitism or Islamophobia. "The Hungarians were extremely alarmed by the sudden invasion of huge tribes of Muslims from the Middle East," he said.

Referring to George Soros, the Jewish philanthropist, Sir Roger told *The New Statesman*: "Anybody who doesn't think that there's a Soros empire in Hungary has not observed the facts."

On China he said: "They're creating robots out of their own people

... each Chinese person is a kind of replica of the next one and that is a very frightening thing."

Ministers had rejected calls to fire Sir Roger in November after it emerged that he had described Islamophobia as a "propaganda word" and homosexuality as "not normal".

He was sacked Wednesday as chairman of the Building Better, Building Beautiful commission to advise on new homes after calls from Tory MPs.

Calling for Sir Roger to be stripped of his knighthood, Dawn Butler, 49, the shadow women and equalities

minister, said that his comments had invoked "the language of white supremacists".

"His claim that Islamophobia does not exist, a few weeks after the devastating attack in Christchurch, is extremely dangerous," she said. "His defence of the prejudice stoked by Viktor

Orban's government is appalling."

A government spokesman said that Sir Roger's comments were "unacceptable" and he had been "dismissed".

A spokesman for the Department of Housing, Communities and Local Government said that Sir Roger had been sacked after "his unacceptable

comments".

The row comes at an awkward time for the Conservative Party, which is battling accusations that it does not take Islamophobia seriously. The party suspended 14 members last month for Islamophobia over a string of abusive posts on social media.

Assange arrested at Ecuadorian Embassy

Wikileaks co-founder Julian Assange has been arrested at the Ecuadorian embassy in London.

Assange took refuge in the embassy in 2012 to avoid extradition to Sweden over a sexual assault case that has since been dropped.

At Westminster Magistrates' Court on Thursday he was found guilty of failing to

surrender to the court.

He now faces US federal conspiracy charges related to one of the largest ever leaks of government secrets.

The UK will decide whether to extradite Assange, in response to allegations by the Department for Justice that he conspired with former US intelligence analyst Chelsea Manning to download classified

databases.

He faces up to five years in US prison if convicted on the charges of conspiracy to commit computer intrusion.

Assange's lawyer Jennifer Robinson said they would be fighting the extradition request. She said it set a "dangerous precedent" where any journalist could face US charges for "publishing truthful information

about the United States".

She said she had visited Assange in the police cells where he thanked supporters and said: "I told you so."

Assange had predicted that he would face extradition to the US if he left the embassy.

After his arrest, the 47-year-old Australian national was initially taken to a central London police station before appearing in court.

Dressed in a black suit and black polo shirt, he waved to the public gallery and gave a thumbs up. He pleaded not guilty to the 2012 charge of failing to surrender to the

court.

Finding him guilty of that charge, District Judge Michael Snow said Assange's behaviour was "the behaviour of a narcissist who cannot get beyond his own selfish interest".

He sent him to

Southwark Crown Court for sentencing, where he faces up to 12 months in prison.

The court also heard that during his arrest at the embassy he had to be restrained and shouted: "This is unlawful, I am not leaving."

as prime minister until parliament voted for a Brexit deal, however long this took.

In a move that will infuriate Tory Brexiteers, Downing Street made clear that Mrs May's pledge to step down

was conditional on the withdrawal agreement being approved by MPs. Tory Brexiteers had seized on Mrs May's comments last month that she was "not prepared to delay Brexit any further than June 30" as evidence that she would step down in favour of a new leader if that deadline were

missed.

In Brussels, Mrs May repeatedly side-stepped questions about her departure date. "We have a duty as politicians to find a way to fulfil the democratic decision of the referendum, deliver Brexit and move our country forward," she said. "Nothing is more pressing or more vital."

Fawlty Towers named best British sitcom

Fawlty Towers has been named as the best British sitcom of all time.

The BBC series topped the Radio Times magazine's list, compiled by a panel of television experts, beating Father Ted, Blackadder, I'm Alan Partridge and Only Fools and Horses.

The judges called John Cleese a "six-foot-five comic genius" who made the show a hit playing the highly-strung Basil Fawlty, proprietor of a sub-par Torquay hotel.

Fawlty Towers ran for just two series of six episodes each in the 1970s.

Co-writer and co-star of Connie Booth told the publication: "Fawlty Towers succeeds, I think, because it allows infantile rage and aggression a field day in a buttoned down, well-mannered English society.

"It's unique in being a farce, with all the plot surprises and precision that the style requires. And it doesn't hurt that the star of the show is a six-foot-five comic genius. If he was shorter I can't imagine how it would have worked."

Cleese added: "I was very lucky to be working at the BBC when decisions were taken by people who had actually made programmes.

"What a cast. I'm proud we are up there with Porridge and Only Fools and Ab Fab and Blackadder and The Office and Reggie Perrin and The Thick of It."

Channel 4 sitcom Father Ted, penned by Arthur Mathews and Graham Linehan, came second in the list, with I'm Alan Partridge coming third, and Blackadder fourth.

The list was voted for by 42 comedy experts, including lauded writers Mathews, Linehan and Richard Curtis, as well Barry Cryer.

Mum Doria gets ready to fly in for birth as Meghan 'snubs' royal baby doctors

THE DUCHESS of Sussex's mother is expected to fly to London to be with her daughter when she gives birth.

Doria Ragland, 62, is planning to arrive in the coming weeks as Meghan Markle's due date approaches, it was reported this week. The American yoga instructor will stay at Windsor Castle to help Meghan, 37, and Prince Harry, 34, settle into life as parents, before returning home to Los Angeles.

A source said: "Doria should be here for the birth and will be staying. But then she has to get back to her dogs and work."

Meghan and Harry have officially moved out of Kensington Palace and into the newly renovated Frogmore Cottage in the grounds of Windsor Castle. The insider added that the couple want to make their new pad "as

homely as possible", with Meghan putting up posters from her Toronto home. It has also been claimed that the Duchess has snubbed some of the best doctors in the world.

An insider said she does not want "men in suits" at the birth and has told the Queen she will not allow the traditional royal doctors and gynaecologists to attend her.

Alan Farthing and Guy Thorpe-Beeston, who were present for the Duchess of Cambridge's three births, have been told their services will not be required.

It is believed the couple have chosen their own team led by a female doctor.

A royal source said: "Meghan said she doesn't want the men in suits.

"She was adamant that she wanted her own people. It did leave a few of us a little baffled.

"Working for the Royal Household is seen as an honour and attracts other highprofile fee-paying patients."

Another aide said the decision was "surprising", adding: "These people [the royal doctors] are the best of the best and when it comes down to it, their role would actually be very limited in the birth itself, assuming all goes to plan."

The doctors never charge the Royal Family but a new team could cost thousands. Princess Anne is among royals who previously opted for the royal gynaecologists to be present during their births.

It emerged last week that the Duchess will not give birth on the private Lindo Wing of St Mary's Hospital in

Paddington, London. The £6,000-a-night ward offers a "five-star" birthing experience with expectant mothers accommodated in spacious private rooms with en-suite bathrooms. The Duchess of Cambridge had her three children there, following her husband Prince William's mother, Princess Diana. However, it is thought the NHS Frimley Park Hospital in Surrey has been selected by Meghan and Harry instead. It does not have

private rooms but was one of only three hospitals rated "outstanding" by the Care Quality Commission in 2015. The general ward's 14 labour rooms handle thousands of births each year. High-profile births include the Earl and Countess of Wessex's two children in 2003 and 2007, and Chris Evans and wife Natasha Shishmanian's twins last year. Meghan's due date is thought to fall at the end of this month or at the beginning of May.

Trendy pushchairs fuel black market crimewave

A BLACK market in posh buggies is fuelling a multi-million pound theft racket, figures revealed this week.

As many as 1.5 million parents have had trendy pushchairs worth as much as £3,000 stolen – often outside their front door. Although nearly 3,000 thefts have been reported to police in the last four years this is just a fraction, experts warn, as many cases go unreported. And parents' willingness to buy cheaper second-hand ones may fuel the buggy black market. Almost one in five parents admit they would consider buying a stolen pram or pushchair. Some buggies are a status symbol, with the average cost of a stolen one now £487, according to price comparison site Confused.com, which sent a Freedom of Information request to police forces.

The sought-after iCandy range sells buggies for between £550 and £1,500. Silver Cross, used by the Royal Family, sells a pram developed with luxury carmaker Aston Martin for £3,000.

Parents in Greater Manchester, West Yorkshire and Essex should be particularly wary, according to the FOI data. The most common locations for thefts are cafes, public car parks, outside supermarkets and from the owner's home. The most popular brands targeted are Mothercare (13 per cent), Silver Cross (12 per cent) and Mamas and Papas (11 per cent).

Tom Vaughan, of Confused.com, said: "We want parents to protect their prams by investing in security locks and ensuring they're covered by insurance."

It features the Apollo 11 moon landing, the emergence of African and Caribbean nations and introduces Camilla Parker-Bowles.

Hen party mum jailed over £2.5m NHS fraud

Five months sentence for 'incapacitated' mother captured on social media partying in Ibiza

A MOTHER was has been jailed after her "fraudulent" £2.5million damages claim against the NHS was unmasked by photographs of her at her daughter's hen party.

Lesley Elder, 50, said an operation had left her reclusive and in such pain that she could not work or travel. But images posted on social media showed her "partying after midnight" at a nightclub in Ibiza with her daughter and other women wearing straw hats, sashes and T-shirts.

Elder had suffered "genuine injury" from an "unnecessary" procedure, but a court previously ruled that her claim was "grossly exaggerated". The mother of two of Poole, Dorset, was awarded the reduced sum of £120,000. But health chiefs disputed the payout in the High Court in London, producing

Facebook photos from the Spanish resort.

Elder was jailed for five months for contempt of court in what Judge Karen Walden Smith called an "attempt to effectively defraud the NHS". Elder was sentenced in her absence after she was taken to hospital when she appeared to swallow a handful of pills in court. She had sued the NHS after having a vaginal mesh implant at the George Eliot Hospital in Nuneaton, Warwicks, in 2010 after being wrongly diagnosed. The foster parent said she was left severely disabled with serious and constant pain in her groin and leg. She had to use a walking stick and was unable to do many normal activities. The NHS Trust admitted liability for putting her through the "contraindicated" surgery. Elder had claimed she was

particularly upset about being unable to attend daughter Tania Bunston's hen do.

But surveillance by private investigators and searches of social media showed that she had "fully participated". Elder insisted the trip was simply a holiday. She had previously attended court in a wheelchair but evidence also showed she was able to walk unaided, do her shopping and exercise her dog. The NHS told the court that Elder had told "lies from top to bottom". Judge Walden-Smith said her conduct included "extensive and widespread exaggeration and lies" and was an "outright attempt to mislead". She added: "This was deliberate and persistent making of false statements for the purpose of falsely recovering significant monies from a publicly funded body."

the THC in the plant is the part that does make you high, and that is taken out!



As the psychopathic killer Villanelle in BBC America's darkly comic espionage thriller Killing Eve, British actress Jodie Comer has amassed a huge cult following of fans who love her for her character's lethal smile and diabolical assassinations.

But 26-year-old Jodie could not be more different from her on-screen character.

A sweet and lovely Liverpoolian, she still lives at home with her mum and dad and gets homesick when she is away on location filming.

"I am away for a good majority of the year and there's no place I would rather be than at home in my pajamas with my brother Charlie watching the telly - that is my complete happy space," she says.

"I just want to come home and do normal stuff and get back to reality. It definitely keeps me grounded. I am a home bird and a lot of people from Liverpool are that

way - they have a very big sense of pride about where they are from and family is extremely important to them."

An Everton supporter, she was a regular at home games at Goodison Park although, she says, she has not been there lately.

She enjoys her home life in Liverpool with her group of girlfriends and she relates to the city's musical heritage." I've researched it and I love The Beatles, particularly George Harrison, who was my favorite Beatle.

"There are so many Beatles tours in Liverpool that I'd like to do and in the Cavern Club they have a Beatles tribute that I am still trying to get the girls to go with me on a Saturday when I can manage to get us all together. But God, Liverpool has changed so much since the days of the Beatles. But it is wonderful and it's really coming into its own in a sense of culture and independent restaurants and bars. But I am envious that I wasn't

born in the swinging 60s. That would have been fun."

Despite the attention she gets from men in pubs and on the streets, particularly when she goes back to her hometown, 25-year-old Jodie doesn't have a man in her life.

"I am very much work focused at the minute and it's funny, because I feel like if I meet someone at the right time that would be great, but at the moment I think I am cool with just being by myself. It's just nice," she says.

We are talking in a hotel in Beverly Hills, where Jodie is on a flying visit with the second series of Killing Eve about to air.

She is colourfully dressed in a pink top and bright yellow flared trousers and is cheerful and friendly, talking happily about how her life has changed since she landed the role of the ruthless assassin Villanelle.

"What I love about Villanelle is she is many characters within one and she has enabled me to hopefully show some versatility that people may not have expected from me beforehand," she says.

"And there has been such an overwhelming response to Killing Eve that when I meet people, they are enthusiastic about talking about it and they enjoy it so much. So it's

to challenge me with. So I think I have really been able to grow and learn more about myself."

Ozzy Osbourne has postponed all of his 2019 tour dates after aggravating an old injury while falling at his Los Angeles home.

Osbourne, (pictured, right), will remain under doctor's care in L.A as he "recovers from an injury sustained while dealing with pneumonia."

The illness forced the metal legend to axe large parts of his No More Tours 2 tour earlier this year.

The remaining US

dates will be now be re-arranged for 2020.

It's the latest in a serious of health issues for the rocker, who - according to his wife Sharon - stopped breathing and his heart stopped beating after a quad bike accident in 2003.

In a statement on Facebook, Osbourne said: "I can't believe I have to reschedule more tour dates.

"Words cannot express how frustrated, angry and

depressed I am not to be able to tour right now."

He added: "I'm grateful for the love and support I'm getting from my family, my band, friends and fans, it's really what's keeping me going.

"Just know that I am getting better every day... I will fully recover... I will finish my tour... I will be back!"

The former Black Sabbath frontman has no scheduled UK dates this year, but was due to



resume his rock 'n' roll duties next month at the Rocklahoma festival in Oklahoma.

His last gig was a set at his own Ozzfest in California on New Year's Eve 2018.

Dead-eyed Luka shrugs off spot kick record

LUKA MILIVOJEVIC is one penalty away from equalling a top-flight record, but the Crystal Palace skipper would rather be known as a free-kick specialist.

His second-half spot-kick, which ended Newcastle's five-game winning run at home, takes him to within one of former Eagles striker Andy Johnson's 11-penalty haul in a season. But Milivojevic is more concerned about the goals that got away.

"I've scored just one goal from open play this season," he said.

"Three times I've hit the post from free-kicks – maybe I should have scored a few more."

Given the choice between joining Johnson in the history books or bursting the net with a set-piece, it is an easy decision.

"The free-kick, of course," he said. "I can't say I don't want the record but it's not really in my power."

Milivojevic's ice-cool temperament is one of the reasons Palace have all but secured survival.

While their dogged defence frustrated the

Magpies, it was their captain who clinched it after DeAndre Yedlin fouled Wilfried Zaha.

Milivojevic puts his success rate down to winning the mental battle. He said: "It does feel like mind games. Sometimes I make up my mind which way to shoot the day before."

Defeat means Newcastle are not safe and Rafa Benitez will use a game like this to remind owner Mike Ashley how much investment is needed. He said: "When something goes wrong, we have to have more experience."

More injury misery for Kane

Tottenham have confirmed England captain Harry Kane has sustained a "significant lateral ligament injury to his left ankle".

The 25-year-old striker suffered the injury in the 1-0 win over Manchester City in the Champions League quarter-final first leg on Tuesday.

Kane's injury could rule him out for the rest of the 2018-19 season.

Spurs have also said England midfielder Dele Alli, 23, fractured his left hand during the same match.

A club statement said Alli will be assessed before Saturday's home Premier League match against Huddersfield Town.

Kane, who has scored 24 goals for Tottenham this season, had slipped as he tried to block City full-back Fabian Delph's clearance on the right touchline in the second half and was substituted immediately.

After Tuesday's match, Spurs manager Mauricio Pochettino said: "It's a worry for us.

"We are going to miss him - maybe for the rest of the season."

“We knew before the game Gerard would be important but what I didn’t know was when we started to play we were losing 2-0. All the players show they deserve to play. It’s not easy to choose the moments for them.”

Shining Son eclipses City

■ Spurs eke out narrow Champions league advantage

Son Heung-min's late goal gave Tottenham a crucial and well-deserved advantage over Manchester City in a thunderous Champions League quarter-final first leg on Tuesday night.

In a searing atmosphere in their vast new stadium, Spurs overcame the loss of Harry Kane to a serious looking ankle injury - sustained when he challenged Fabian Delph in the second half.

And they made the breakthrough with 12 minutes left as Son twisted and turned on the byeline before shooting low past Ederson.

Spurs had survived the concession of an early penalty, awarded on a pitchside video review by the referee after Danny Rose was judged to have handled Raheem Sterling's shot. Sergio Aguero stepped up, but keeper Hugo Lloris saved.

Manchester City were

never at their best and must now overturn this narrow deficit at Etihad Stadium on 17 April to keep alive their hopes of a historic quadruple of Champions League, Premier League, FA Cup and League Cup.

This was the sort of night Spurs' new stadium was built for - and how Mauricio Pochettino's side delivered in front of their exultant supporters.

Spurs rode out Aguero's penalty miss and another Kane injury setback to knock an off-colour Manchester City out of their usual stride. No-one can dispute that this was a first-leg advantage the home team totally merited.

The much-maligned Lloris, understandably criticised after his late error at Liverpool recently, was a hero here but Spurs had them all over the pitch.

Harry Winks gave a performance of real

maturity in midfield and when Kane went off it was the talismanic figure of Son who again showed his liking for his new surroundings with the winner - after scoring the first Premier League goal here against Crystal Palace.

The South Korean is the ideal modern attacker: tireless, unselfish but with an eye for goal and a willingness to take responsibility, which he did here as he led the charge after Kane's departure, culminating in the turn back from the byeline and shot underneath Ederson to give Spurs a precious lead to protect at Etihad Stadium.

Spurs look certain to have to overcome the absence of Kane in the second leg but a lead - and of great significance, a clean sheet - will see them travel north with justified optimism.

Pep Guardiola's team selection raised plenty of eyebrows and the selection of Delph at left-back left City with a huge flaw. He struggled to cope with Son all night, switching off to great cost as the South Korean chased a ball to the byeline unchallenged.

Riyad Mahrez looks poor value at £60m and the introductions of Leroy Sane and Kevin de Bruyne smacked of too little too late.

City must show more urgency for the second leg and more of their trademark attacking brilliance to succeed.

Spurs will almost certainly be missing Kane but they also have a clean sheet so City must attack while also being aware they must not slip up at the back and risk falling foul of the away goals rule. The stage is set for a dramatic second leg.

Reds ease to Porto win

LIVERPOOL produced a measured and mature performance Tuesday night to establish a 2-0 first leg lead over Porto in their bid to reach the Champions League semi final.

But there was several moments when Porto threatened, suggesting there is still a lot of work to be done before the Premier League leaders can be sure of progressing.

First half goals from Naby Keita and Roberto Firmino, coupled with a crucial clean sheet, have put the Reds in a strong position ahead of next week's quarter-final, return leg in Portugal, but it was less than the convincing show Klopp's men put on last season, when they beat the same opponents far

more comfortably.

Moussa Marega saw three efforts well saved by Alisson, but the Reds dominated from start to finish without getting the third goal that would have left the visitors dead and buried.

Keita had waited all season before notching his first goal for the club in last week's win at Southampton.

Now the Guinea international has two in five days after firing the Reds ahead inside the opening five minutes.

The Reds hammered Porto 5-0 on aggregate in the knockout stages last season - and looked bang on course to do the same again after charging into a 2-0 lead inside the opening 30 minutes.
