LANDSLIDE FOR BORIS!

- Tories secure biggest election victory since 1987
- Corbyn to resign as leader after Labour's worst loss since 1935
 - Swinson loses her seat as Lib Dems fail to gain ground
 - SNP victories likely to bring independence headache for Boris

Boris Johnson won a huge victory in Thursday's general election – and immediately called on Remainers to “let the healing begin” promising he would never ignore their “positive feelings of warmth and sympathy towards the other nations of Europe”.

After securing 365 seats and with it a commanding majority of 80, the prime minister said that it was time for “closure” on the three-year Brexit struggle as he addressed the nation for the first time as head of a new Conservative government.

With the last result now declared, the prime minister has secured the largest for a Conservative leader since Margaret Thatcher's 1987 victory.

He acknowledged that many voters had struggled against family tradition to vote Tory for the first time in their lives and deliver a triumph largely secured by taking seats in Labour's former heartlands.

“I want to thank you for the trust you have

placed in us and in me and we will work round the clock to repay your trust and deliver on your priorities,” he said in Downing Street, adding that voters wanted the new government to focus above all on the NHS.

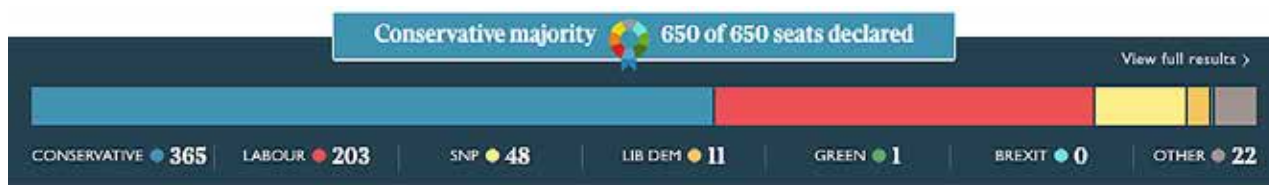
The win had delivered an “overwhelming mandate” to deliver Brexit, he said, but said also that he would not ignore those who had not voted Tory and did not want to leave the EU.

“I frankly urge everyone on either side of what are, after three and a half years, a frequently arid argument, I urge everyone to find closure and to let the healing begin,” he said.

Jeremy Corbyn conceded defeat at 3.20am

but resisted pressure to quit immediately. He said that he would stand down after leading the

party through “a period of reflection”.

Speaking later about the timetable for him to leave,

Mr Corbyn said: “The national executive will have to meet, of course, in the very near future and

it is up to them. It will be in the early part of next year.”

And it's goodbye from him....

■ Corbyn to step down as Labour leader after another dismal election performance

Jeremy Corbyn announced on Friday that he would quit as leader of the Labour Party after a "process of reflection" on a dismal election result.

Speaking at his London constituency of Islington North, Mr Corbyn said: "I want to make it clear that I will not lead the Labour Party in any future election campaign." But he said that he would "lead the party to ensure that discussion takes place".

He added: "This is obviously a very disappointing night for the Labour Party with the result we have got. But I want to say this: in the election campaign we put forward a manifesto for hope, a manifesto of unity and a manifesto that would help to right the wrongs of injustice and equality that exist in this country.

"All of those policies were extremely popular during the election campaign and remain policies that have huge support across the country. However, Brexit has so polarized and divided debate in this country it has overridden

so much of normal debate. I recognise that that has contributed to the result the Labour Party has received this evening."

Joe Biden, the US presidential candidate, spoke out at a fundraiser in San Francisco following the result, he said: "Look what happens when the Labour Party moves so, so far to the left. It comes up with ideas that are not able to be contained within a rational basis quickly."

He added: "You're also going to see people saying, my god, Boris Johnson, who is kind of a physical and emotional clone of the president, is able to win."

'the nasty party'

Mr Corbyn had faced a clamour to stand down from a host of defeated and re-elected MPs. After the exit poll was published at 10pm John McDonnell, his closest political ally, was ashen faced as he refused to rule out Mr Corbyn's resignation.

But Jess Phillips, a potential candidate for leader, said it was "impossible to say anything other than" that Mr Corbyn should quit. "The country is making a

clear statement about how it feels about the Labour Party," she told Sky News.

Ruth Smeeth, parliamentary chairwoman of the Jewish Labour Movement, blamed the leader personally for her loss in Stoke-on-Trent North. "Jeremy Corbyn's actions on antisemitism have made us the nasty party. We are the racist party," she said.

Phil Wilson, who lost Tony Blair's former seat of Sedgfield, said: "For the leadership to blame Brexit for the result is mendacious nonsense."

Mr McDonnell had argued that Mr Corbyn was not the reason the exit poll forecast Labour at its lowest ebb since 1935. The "extremely disappointing" prediction was because "Brexit has dominated this election", the shadow chancellor said. Despite recent rumours that he would become acting leader if Labour lost, he ruled this out.

Jon Lansman, the founder of the pro-Corbyn activist group Momentum, had appeared to accept that Mr Corbyn would stand

down. "Jeremy has always been a reluctant leader," he said. "He won't overstay his welcome." Mr Lansman said Mr Corbyn had "achieved a great deal" on issues such as austerity, and that the election was "incredibly polarised because of Brexit".

He told ITV: "Maybe the manifesto was too long and too detailed - it's a programme actually not

for a government, but for ten years."

When the 10pm exit poll showed Labour on 191 seats, 71 fewer than in 2017, there was almost ten minutes of silence at Labour HQ, a source said. At about midnight one official said: "Atmosphere is beyond grim and nobody senior has seen fit to even say anything to the staff who gave so much."

The former Labour home secretary, Alan Johnson, told ITV: "The Corbynistas will make an argument that victory is a bourgeois concept and the only goal for true socialists is glorious bloody defeat and now we just had another one of them . . . but it's Corbyn. We knew that in parliament. We knew he was incapable of leading. We knew he was worse than useless."

Labour's 'Red Wall' swept away

IN THE END Labour's much-vaunted 'Red Wall' wasn't so much breached as demolished.

Thursday's election saw constituencies with deep Labour roots defecting to the Conservatives.

Workington, Stoke-on-Trent, Dudley, Blyth Valley and Bolsover: places in the north and Midlands that returned Labour MPs for generations have gone. A combination of lackluster leadership from Jeremy Corbyn and strong Leave sentiment among working class voters combined to produce Labour's worst election result since 1935 and the Conservative's largest majority since Margaret Thatcher's

landslide in 1987.

The result was worse than Labour had feared or the pollsters predicted. Its vote share fell not just in strong Leave areas (by 10.9 per cent) but also down by 6.3 per cent in those parts of the country that voted strongly to Remain as well.

In contrast the Tories picked up not only target seats in parts of the country that they have never represented before but also won in metropolitan areas such as Kensington, on which they had all but given up at the start of the campaign.

Elsewhere in the country the results are no less remarkable. In Scotland the SNP took 47 of the country's 59 seats.

While not in a position of power in Westminster the overwhelming support for the pro-independence party will ensure that a second Scottish referendum after Brexit loses none of its potency as an issue in the next few years.

The Liberal Democrats, leaderless after the quick demise of Jo Swinson, face an existential question about their future, having failed to win the Remain voters they hoped would give them the base to rebuild as a political force.

When the dust has settled what are the implications for Britain's political system? What does the result mean for Labour, the new victorious Conservative

Scottish independence back on agenda?

■ SNP landslide heralds battle with Westminster after Johnson's 'return to sender' pledge

Nicola Sturgeon has set the stage for a constitutional showdown with Boris Johnson after the Scottish National Party secured an election landslide in Scotland.

The nationalists gained a dozen seats as the Tories, Labour and the Liberal Democrats collapsed north of the border.

With all results declared the SNP won 47 of the country's 59 seats, up from the 35 it won in 2017. Ms Sturgeon's party secured 45 per cent of the vote, up eight points. The Conservatives won six seats, the Liberal Democrats four, and Labour now have a single

MP north of the border. As a Conservative majority was confirmed in the rest of Britain Ms Sturgeon said that the result showed "the divergent paths Scotland and the rest of the UK is on." She vowed to formally request the powers to hold a second independence referendum before the end of the year and refused to discuss the prospect of Mr Johnson rejecting her approach.

'I have a mandate'

The constitution is a reserved power under the Scotland Act, which means that Edinburgh has to secure permission

from London to hold a vote. Mr Johnson has repeatedly promised to reject any demand for another ballot and has strengthened his position with a comfortable majority. He said last month that if there is any formal demand "we will mark that letter return to sender and be done with it".

Ms Sturgeon told the BBC: "The results across the rest of the UK are grim but underlines the importance of Scotland having a choice. Boris Johnson has a mandate to take England out of the EU but he must accept that I have a mandate to give Scotland a choice for

an alternative future." The SNP campaign had focused on the themes of stopping Brexit and preventing Mr Johnson from winning a majority, as well as making the case for a second independence referendum.

The biggest scalp claimed by the SNP was Jo Swinson, the Liberal Democrat leader, who lost by 149 votes in East Dunbartonshire.

'this party must listen'

Colin Clark, the Scotland Office minister, was defeated by a margin of 819 votes in Gordon. He had declared himself the "Salmond slayer" after winning the seat from Alex Salmond, the former first minister, in 2017.

Lesley Laird, the shadow Scottish secretary and Scottish Labour's

deputy leader, was defeated in Kirkcaldy & Cowdenbeath by Neale Hanvey. The SNP withdrew support from Mr Hanvey after he shared antisemitic material on social media.

Ian Murray, Labour's sole Scottish MP, said after retaining Edinburgh South that Jeremy Corbyn must quit as party leader and that "the policy and the ideology has to go as well".

"This party must listen, this party must respond, or this party will die," he said.

The SNP also ousted the Conservatives Kirstene Hair in Angus and Paul Masterton in East Renfrewshire, as well as defeating Labour's Danielle Rowley in Midlothian and Ged Killen in Rutherglen &

Hamilton West.

Kenny MacAskill, the former SNP justice secretary, returned to frontline politics by winning East Lothian from Labour. Pete Wishart became the SNP's longest serving MP after retaining his Perth and North Perthshire seat with a significantly increased majority.

Despite their overall victory the SNP lost its Europe spokesman as Stephen Gethins was defeated in North East Fife by Wendy Chamberlain of the Lib Dems. Mr Gethins, 43, had won the constituency by just two votes in 2017, when it was the tightest majority in Britain. The Lib Dems also retained Edinburgh West as well as Caithness, Sutherland & Easter Ross.

Swinson departs, unapologetic

■ Lib-Dem leader adamant Remain stance was correct

Jo Swinson has refused to apologise for the Liberal Democrats' stance on Brexit after she became the first serving leader of a major party to lose their seat since 1945.

The Lib Dems had their number of MPs nearly halved to 11. Ms Swinson will be replaced after five months in charge, making her one of the shortest-serving leaders of a major party in recent times.

In her last speech as leader Ms Swinson, 39, said she was proud that the Lib Dems had been the unapologetic voice of Remain at the election, "giving people the chance to choose to stop Brexit".

She added: "Obviously it hasn't worked. And I... am devastated about that. But I don't regret trying... because the prize was to save our future, our children's future."

The first female leader of the Lib Dems also appeared to blame sexism for some of the party's woes, saying: "One of the realities of smashing glass

ceilings is that a lot of broken glass comes down on your head."

Sir Ed Davey, who held his seat of Kingston & Surbiton, and Baroness Brinton, the Lib Dem president, will become acting leaders.

Ms Swinson lost in East Dunbartonshire to Amy Callaghan, 27, who reclaimed the constituency for the SNP by 149 votes. The defeat crystallised a poor result for the Lib Dems, who had hoped to make substantial gains on their 2017 tally of 12 seats. At the start of the campaign Ms Swinson declared that she was a genuine

candidate for prime minister.

Senior Lib Dems laid blame for the election defeat at the Ms Swinson's door. Sir Simon Hughes, who was a justice minister in the coalition government, said: "Every single decision taken since Jo became the leader was the wrong decision...the whole thing has been a disaster."

Sir Simon criticised Ms Swinson's decision to run a presidential-style campaign, saying: "Jo led the campaign on the basis that she could be prime minister. Incredible. Nobody believed it. She was almost unknown."

In a dramatic night that redrew Britain's electoral map, Jo Swinson, the Liberal Democrat leader, lost her seat in East Dunbartonshire to the Scottish National Party. The SNP gained a dozen seats to win 47, making it the party's second best Westminster result ever. A candidate who is suspended from the party also took his seat. There are now six Tory MPs in Scotland, down from 13 in 2017, with Labour again left with only one MP north of the border.

Mr Johnson said the results showed that the "irrefutable" decision of the British people was to get Brexit done and end the "miserable threats" of a second referendum. In a message to former Labour voters who backed the Conservatives for the first time Mr Johnson said they may only have lent him their vote but that it would be his mission to earn their support for good.

challenges

Before his Downing Street address he spoke to Tory activists under a new banner of "the people's government". He told them: "In winning this election we have won the trust of people who have never voted Conservative. Those people want change and we must not let them down. We must change too."

However, demonstrating the challenges that will quickly face Mr Johnson, the new president of the European Council, Charles Michel, warned that Brussels would not agree a free trade deal that did not include the UK signing up to EU rules and regulations. "The EU is ready for the next phase," he said. "We will negotiate a future trade deal which ensures a true level playing field."

Farage undaunted after epic Brexit Party fail

The Brexit party suffered a total wipeout with none of its 273 candidates winning a seat in Thursday's general election.

Nigel Farage's party failed its first test in Peter Mandelson's former constituency of Hartlepool in north-east England, where its chairman and most senior candidate, the property millionaire Richard Tice, was hoping to end 55 years of red rule.

Labour's Mike Hill held on to the seat with 15,464 votes – a majority of 3,595 – seeing off Tice, who got just over 10,000 votes. But the Brexit party got 25.8% of the vote, just behind the Tories at 28.5%, suggesting the Conservative landslide would have been even greater had Farage given Boris Johnson a clear run in all seats.

Its hopes of taking another key Labour

marginal, Tony's Blair's former seat of Sedgefield, also failed but Jeremy Corbyn's party was left reeling nonetheless, down 17 percentage points on 2017.

Labour's Phil Wilson, who was defending a majority of more than 6,000 votes in the seat, hit out on social media at his party's "delusional" leadership.

'giving people a choice'

Ann Widdecombe, the former Tory MP, also failed in her bid in Plymouth Sutton and Devonport.

Farage said his political life was not over, claiming a new party would rise from the ashes. "It will become the reform party, it will campaign, one of the reforms being getting rid of the first past the post system and giving people a choice," he told the BBC.

The Brexit party appeared to scupper its

own electoral chances in early November, announcing it would not contest the 317 seats won by the Conservatives at the 2017 general election.

Its support subsequently crashed in the polls and a further blow came when four MEPs, including Annunziata Rees-Mogg, Jacob Rees Mogg's sister, quit the party urging voters to support the Conservatives instead, arguing it was splitting the leave vote and giving remain alliances a boost.

Their fears proved correct on the night, suggesting the Tory landslide would have been bigger had Farage stood down in all seats. In Barnsley, it took 29.2% of the vote, two points ahead of the Tories. In Gower, it was neck and neck with the Conservatives, with both parties taking 29.9%.

In Blyth Valley, a

tight marginal snatched from Labour by the Conservatives, the Brexit party took 8.3% of the vote.

Following the election, Farage is expected to focus his efforts on supporting Donald Trump's presidential campaign. "If I am asked to help I will," he told the BBC. But he said he would stay in Britain to fight for what he believed was a proper Brexit.

Farage said: "The truth of it is, half the cabinet voted remain. Michael

Gove – I was with him earlier – clearly wants the softest of all Brexits.

"Boris, whilst he is committed to leave, has never really, I don't think, been keen on leaving on WTO terms.

"My view is a big majority means that the influence of the ERG [European Research Group], the influence of those who are committed Eurosceptics, becomes a lot weaker and I would expect, I'll predict, by 1 July we will be extending the transition period out until 2022."

Labour luvvie Coogan brands Tory voters 'ignorant'

LEFT-leaning actor Steve Coogan sparked fury after branding Conservative voters "ignorant" in an unchallenged pre-election TV rant. The star, who has previously backed Labour but claimed he voted tactically by backing the Liberal Democrats, said Boris Johnson and the Tories "depend on a certain level of ignorance from their supporters". In a diatribe on Channel 4 News the night before the polls opened he said his comedy alter-ego Alan Partridge was "ill-informed and ignorant and therefore he's a Conservative and a Brexiteer", a remark that prompted host Cathy Newman to laugh. Divorced Coogan, 54, went on to claim the Tories "don't invest as much money in education because they depend on a certain

level of ignorance from their supporters". The comment again caused Ms Newman to laugh. Coogan, a crusader for tighter press regulation alongside fellow Left-wing actor Hugh Grant, was given free reign to make his anti-Tory comments by the broadcaster despite the imminent election. But James Johnson, former Prime Minister Theresa May's special adviser, eventually intervened to tell him his attitude was actually angering long-term Labour voters. He said: "I don't want to cause a fight with Steve Coogan, but this is exactly the attitude that means that these long-term Labour voters who are good people are leaving the Labour party and going to the Conservatives. People like Steve and those in the London bubble are telling them they are



stupid." One viewer sarcastically wrote: "I was going to vote Conservative but now that Coogan has told me what he thinks I've changed my mind. "If only more Leftie luvvies got involved to impart their wisdom to us

lesser mortals the world would be a better place." Another added: "Let's face it not many are as ignorant and talentless as Steve Coogan. Another champagne socialist trying to get people to vote for the Marxist Jeremy Corbyn."

government and for Brexit?

Labour will enter the new House of Commons a denuded electoral force. Jeremy Corbyn is set to go as leader and there will be a battle for the soul of the party between younger Corbynistas hoping to pick up the flame and those who wish to move the party back to the centre.

Labour will also have to judge whether its traditional electoral coalition between older working-class voters in the north and Midlands and affluent younger voters in cities is viable. Do they fight the Tories to win back what they've lost and tailor their policies accordingly, or do they look to create a new electoral coalition with a less defined base?

TV naturalist David Bellamy dead at 86

■ Presenter's eccentric style beloved by millions

TV naturalist Professor David Bellamy, who brought the world of wildlife into the nation's living rooms for nearly 30 years, died this week aged 86.

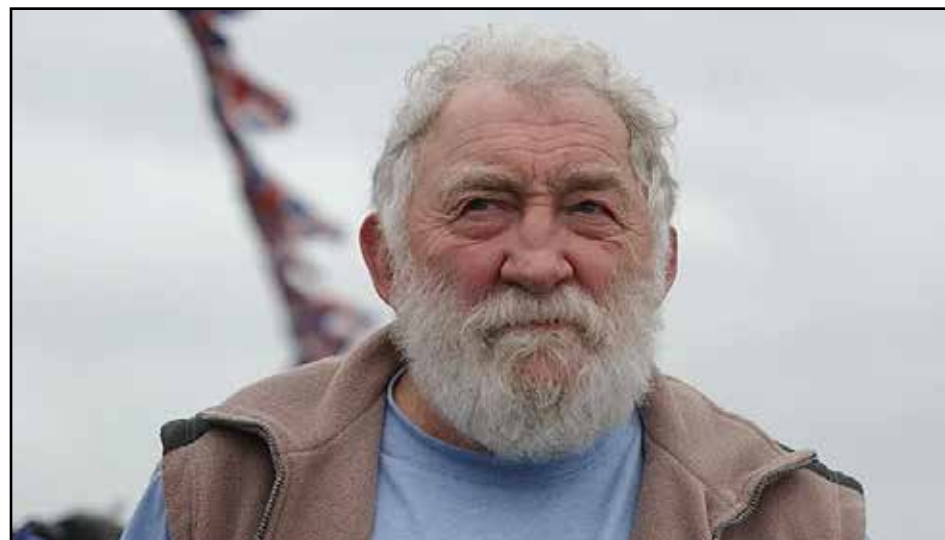
Famous for his

enthusiastic and eccentric style, he was widely parodied by comedians including Sir Lenny Henry. He was also a committed environmental activist, with his successes

including helping to save an ancient Tasmanian forest from being flooded to make a dam. But the Durham University botany lecturer fell foul of the green movement for his scepticism about man-made climate change, leading some to brand him a "climate denier". The London-born presenter later claimed that his questioning approach to climate issues damaged his broadcasting career, leading to programme ideas being rejected.

'larger than life'

Bellamy broke on to TV by commenting on the 1967 Torrey Canyon oil tanker disaster and for nearly 30 years his bearded, tousled appearance and exuberant style made him one of Britain's most recognisable eco-experts. The Conservation Foundation, which Bellamy founded, tweeted: "The

Conservation Foundation is greatly saddened to announce the death of Professor David Bellamy, our co-founder and president. The Foundation was very special to David and he was very special to us."

David Shreeve, the Conservation Foundation director, said: "He was a larger-than-life character who became a very special friend and teacher. "He inspired a whole generation with his wide range of interests and

enthusiasm which knew no bounds.

"The Conservation Foundation was very special to him and so today is very sad for all of us."

Comedy writer and radio presenter Danny Baker has paid tribute to Bellamy, calling him a "truly brilliant and canny broadcaster". Referencing Sir Lenny's "grapple me grapenuts" catchphrase that Bellamy inspired, Baker added: "Thoughts with @LennyHenry at this time."

Piers Morgan said: "RIP David Bellamy, 86. A brilliant naturalist, broadcaster & character."

Bellamy, who lived in County Durham, fronted TV shows, including Bellamy On Botany, Bellamy's Britain, Bellamy's Europe and Bellamy's Backyard Safari. He worked in a factory and as a plumber before marrying wife Rosemary, who died last year, and becoming an academic. The couple had five children, including four they adopted.

British talent in pole position for upcoming Golden Globes?

BRITISH stars could win a clutch of Golden Globes awards next month.

Comedian Ricky Gervais, 58, will host the ceremony for a record fifth time on January 5 at the Beverly Hilton hotel in Los Angeles.

Oscar winner Olivia Colman, 45, has been nominated for her portrayal of the Queen in Netflix's regal drama The Crown, while her co-star Helena Bonham Carter, 53, received a nod in the supporting category.

Fleabag creator and star Phoebe Waller-Bridge is up for best performance, while the hit BBC show is in the best comedy category. Phoebe, 34, picked up six Emmys in September.

And Jodie Comer, 26, (pictured, above, right) star of BBC One's Killing Eve, finds herself up against Colman for best actress.

Other British actresses to be nominated are Dame Emma Thompson, 60, Dame Helen Mirren, 74, Emily Watson, 52, and Cynthia Erivo, 32.

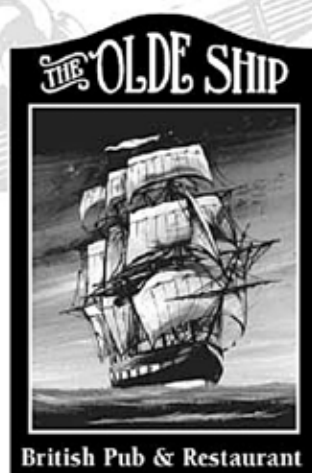

When I do visit home, I love going to my favorite haunts, and of course catching up with my favorite people.

What was your first impression of LA and has it changed since?

LA (as an adult) was at the end of a month of traveling around New Mexico, Arizona and Texas, and LA was a bit of a smash in the face after being in the desert and so remote for so long. That has changed since moving here, as I spend my down time often in Griffith Park with my dog, and that can feel like a total escape from the city, and it's right there!

What do you find the biggest difference is living here versus Sydney?

LA reminds me a lot of Sydney in a lot of ways, particularly the weather and the aesthetic obsession of people, but LA is far more interesting and diverse. Sydney is cleaner. Much, much cleaner. As far as differences between LA and Dundee, well, literally everything! Both cities are super cultural and art-focused though, unlike Sydney which is quite devoid of artistic culture to be honest... Sydney is the capital of the film industry in Australia however, so it is

Recrowned Joshua pledges to fight either Fury or Wilder in 2020

Unified world heavyweight champion Anthony Joshua says a fight with Tyson Fury or Deontay Wilder "has to happen in 2020".

Britain's Joshua reclaimed his IBF, WBA and WBO titles from Andy Ruiz Jr in Saudi Arabia on Saturday.

WBC champion Deontay Wilder is scheduled for a rematch with Britain's Tyson Fury

on 22 February.

"I feel like it's 'Lord of the Rings', the last ring, let's get it on, let's make history," said Joshua, 30.

Speaking on the Zoe Ball Breakfast Show on BBC Radio 2, he added: "It has to happen in 2020, we're in the same division, same era, if these guys want to make history, especially Wilder because he has the last belt.

"We created history by becoming a two-time champion of the world and I feel like we can add to that legacy in 2020."

By defeating Ruiz, Joshua joined a small cluster of men including Muhammad Ali, Lennox Lewis, Evander Holyfield, Mike Tyson and Floyd Patterson to have reclaimed the world heavyweight title.

Joshua says he will

fight either the WBO's mandatory challenger - currently Ukraine's Oleksandr Usyk - or the

man in the same position with the IBF, Bulgarian Kubrat Pulev next.

"If I don't fight those

guys I'll have to give up my belt and I'd rather fight to defend them," he added.

Klopp extends Reds deal

Liverpool manager Jurgen Klopp has signed a new deal with the club that will run until 2024.

Klopp, who joined the Reds in October 2015, signed a new six-year contract in July 2016 and that has now been extended further.

Liverpool won the Champions League under the German last season and finished second in the Premier League.

They lead the top flight this season and have an

eight-point lead in pursuit of a first league title since 1990.

"This club is in such a good place, I couldn't contemplate leaving," Klopp, 52, told Liverpool's website.

"For me personally this is a statement of intent, one which is built on my knowledge of what we as a partnership have achieved so far and what is still there for us to achieve.

"When I see the development of the club and the collaborative work that continues to take place,

I feel my contribution can only grow.

"People see what happens on the pitch as a measure of our progress and although it is the best measure, it's not the only measure. I have seen the commitment from ownership through to every aspect and function of the club you can think of.

"When the call came in autumn 2015, I felt we were perfect for each other; if anything, now I feel I underestimated that."

King added: "From the

The last-16 ties begin on 18-19 February and 25-26 February, with the second legs scheduled to take place on 10-11 March and 17-18 March.

having left DC United in October.

Derby are currently 16th in the Championship under manager Phillip Cocu, nine points adrift of the play-off places.

On the challenge facing him in the Championship, Rooney added: "The difference here is it is a very tight league. We're not where we want to be but we're not too far off the play-off spots.

"This league is about being consistent. Without a doubt [the play-offs are still achievable]. I've lost the Premier League title with about four minutes to play, it's not even Christmas yet so there's a long way to go.

"In all three games I've been to, in parts of games there's been a lack of urgency, a lack of composure, and not enough chances created. It's something we're working on and trying to put right."

EUROPE BOUND: Clean sweep for British clubs

■ Good week in Europe as British teams go nine-for-nine in Champions and Europa League

Arsenal, Celtic, Manchester United, Rangers and Wolves completed a clean sweep for British clubs as they advanced into the last 32 of the Europa League this week.

They follow Liverpool, Manchester City, Chelsea and Tottenham all qualifying for the last 16 of the Champions League, meaning all nine British clubs progress.

Arsenal, Celtic and United will all enter Monday's draw as seeded teams after winning their groups.

The Gunners came back from two goals down to draw 2-2 at Standard Liege in Group F, while Ole Gunnar Solskjaer's side thrashed AZ Alkmaar 4-0 to finish top of Group L.

Earlier on Thursday Celtic finished on top of Group E despite losing 2-0 to runners-up Cluj in Romania.

Wolves finished second in Group K with a thumping 4-0 win over Besiktas, while Rangers' 1-1 draw with Young Boys saw them finish as Group G runners-up.

However, the likes of

Ajax, Benfica, Inter Milan and Red Bull Salzburg could all now lie in wait for Rangers and Wolves, with all four seeded after dropping down into the competition from the Champions League.

How the draw works

The teams will be divided into two pots, with the first consisting of all 12 of the Europa League group-stage winners and the four best third-placed teams, dropping down from the Champions League.

The second pot will contain the group runners-up plus four more teams dropping down from the Champions League.
