MARKLE VS MEGHAN: ROYAL COURTROOM DRAMA AHOY?

■ As court case showdown looms between Duchess and Mail on Sunday, sister tells reporters, "If he is called, he will come."

The Duchess of Sussex's father, Thomas Markle, will testify if asked to in the court case against Meghan, the duchess' half sister has said.

Samantha Markle - Mr Markle's daughter from his first marriage - told the BBC: "If he is called, he will come."

New court documents in the case between Meghan and the Mail on Sunday show the paper will use evidence from Mr Markle.

No date has been set for a hearing in the case, which centres on a private letter Meghan wrote to him.

Meghan accuses the paper of misusing her private information, breaching copyright and selective editing.

The Mail on Sunday rejects the claims and says there was "huge and legitimate" public interest in publishing the note.

Documents submitted to the High Court by the paper laying out its defence show much of the evidence it could rely upon comes from Mr Markle.

He was at the centre of

controversy in the lead up to Meghan's marriage to Prince Harry in May 2018.

The documents include text messages sent from Mr Markle to his daughter before the wedding.

"The fact that so much of the evidence appears to come directly from him and that he appears to be co-operating with the paper presents at least the possibility of him being called to testify in court against his own daughter," a leading royal reporter said on Wednesday.

The Daily Mail, the Mail on Sunday's sister paper, reported on Wednesday that Mr Markle was "expected to be called as a key witness" in the case.

The newspaper has given what BBC royal correspondent Jonny Dymond describes as a "very robust" response to Meghan's claims.

The paper argues in

legal documents that members of the Royal Family, including the duchess, "rely on publicity about themselves and their lives in order to maintain the privileged positions they hold and promote themselves".

It said the duchess "did not have a reasonable expectation of privacy that the contents of the letter were private and would remain so".

"There is a huge and legitimate public interest in the Royal Family and the activities, conduct and standards of behaviour of its members," it said.

"This extends not merely to their public conduct, but to their personal and family relationships because those are integral to the proper functioning of the monarchy."

As evidence that it did not infringe her privacy, the paper says the letter was "immaculately copied" in Meghan's "elaborate handwriting", arguing that this care in its presentation meant she anticipated it would be seen and read by a wider audience.

The 44-page legal filing by the Mail on Sunday aims to tackle

the duchess' claims one by one.

Meghan claimed she had not courted publicity for her relationship with her father - but the paper says she has not denied authorising her friends to speak about it for an article in a US magazine.

The duchess also said publishing the letter breached her copyright - but the Mail on Sunday says it was not a protected "original literary work" but a recounting of existing facts.

Meghan said it infringed her data rights - but the newspaper says the data was not

sensitive and concerned topics she herself had put in the public domain.

Accused of selective editing - the Mail on Sunday says the extracts it released accurately conveyed the tone, content and meaning of the letter.

In October, law firm Schillings, acting for the duchess, filed a High Court claim against the Mail on Sunday and its parent company Associated Newspapers over the alleged misuse of private information, infringement of copyright and breach of the Data Protection Act 2018.

IndyRef2: Sturgeon fumes as BoJo says No Go

■ Scottish leader vows to fight on after PM officially rules out new independence referendum

BORIS JOHNSON has officially rejected Nicola Sturgeon's demand to call further Scottish independence referendums.

In a brief response to the Scottish First Minister's request, Mr Johnson said she should respect the promise she and Alex Salmond made before the 2014 vote, that it was a "once in a generation event".

The Prime Minister pledged to "uphold the democratic decision" of the Scottish people and refused Ms Sturgeon's demand that the power to call constitutional referendums be transferred to Holyrood, which would allow the Scottish Parliament to stage separation votes whenever it wanted.

public services

An angry Ms Sturgeon accused him of being terrified of another vote, insisting the "overwhelming likelihood" was that Scots would back separation if they had another chance.

But Mr Johnson said she should focus on improving Scotland's public services. He said the education and health systems had been "left

behind because of a campaign to separate the UK."

He was responding to a letter Ms Sturgeon sent before Christmas arguing he had a "democratic duty" to transfer the power to stage independence votes after the SNP won 48 of 59 Scottish seats in the general election.

popular vote

Alister Jack, the Scottish Secretary, warned the Prime Minister at the weekend this would lead to a "neverendum", with the SNP staging votes until it won.

He also pointed out that the popular vote in December's election, with 55 per cent backing Unionist parties and 45 per cent the SNP, was almost identical to the 2014 referendum result.

In his reply, Mr Johnson told Ms Sturgeon he had "carefully considered" her arguments but she and Mr Salmond had pledged that the 2014 referendum would not be repeated for a generation, and they had both "committed to respect" the result.

'political stagnation'

Mr Johnson added:

"Another referendum would continue the political stagnation that Scotland has seen for the last decade, with Scottish schools, hospitals and jobs again left behind because of a campaign to separate the UK."

'terrified'

Ms Sturgeon said: "The Tories are terrified of Scotland having the right to choose our own future. They know that given the choice the overwhelming likelihood is that people will choose the positive option of independence."

"It is not politically sustainable for any Westminster government to stand in the way of the right of the people of Scotland to decide their own future and to seek to block the democratic mandate for an independence referendum."

Sturgeon later added that the Scottish Government would respond later this month and ask Holyrood, which has a separatist majority, to stage a symbolic vote.

Adam Tomkins, the Scottish Tories' shadow constitution minister, said Mr Johnson's letter should "draw a line" under the saga.

Starmer faces tough fight for Labour top job from far left fave

THE PROSPECT of another far-left leader succeeding Jeremy Corbyn grew closer this week as a new poll revealed that Rebecca Long Bailey is on course to become the next Labour leader.

Despite Sir Keir Starmer, the shadow Brexit secretary, emerging from the first stage of the contest with a commanding lead among MPs, Ms Long-Bailey has come out on top in a survey of 3,835 party members.

The poll, conducted by Survation on behalf of the LabourList website, found that the shadow business secretary received 42 per cent of votes, compared with 37 per cent for Sir Keir.

Based on Labour's leadership rules, which include an alternative vote system, Ms Long-Bailey remains ahead on second preference votes with 51 per cent, two points ahead of Sir Keir.

The findings will trigger alarm bells among Sir Keir's allies, who have appeared bullish about his

prospects.

It comes two weeks after a smaller poll by YouGov put Sir Keir ahead with nearly two thirds of the vote share.

Late this week friends remained quietly confident he could triumph, pointing out that he had taken a step closer to reaching the last stage of the race after receiving an endorsement from the environmental group SERA, which is affiliated to Labour.

The 57-year-old now only needs to secure the backing of a second trade union, having received Unison's support, to become the first candidate to progress to the final ballot.

Trailing in the poll were Jess Phillips on 9 per cent, Lisa Nandy on 7 per cent and Emily Thornberry is on 1 per cent.

Ms Nandy made a push this week to win over moderates, as she claimed that Mr Corbyn had sided with Vladimir Putin and "failed the test" in the wake of the Salisbury attack.

The Wigan MP said that if elected she would never again allow the party to stand in "solidarity" with Russia's "authoritarian regime", adding: "The Labour leadership failed on Russia. We must put this right."

The 40-year-old also claimed the party had committed a "serious failure" on Brexit. "We've allowed the Right to frame the debate," she said.

"The trap was set. You can either be for your country or for the world. And senior Labour politicians rushed headlong into it."

Ms Nandy later discussed her domestic policy plans, which include scrapping tuition fees, renationalising Royal Mail and renewing Trident if "coupled with a strong commitment to multilateral disarmament".

In an interview on The Andrew Neil Show on BBC Two, she said Labour's election manifesto pledges had been "reasonably popular".

Meghan: the sniping goes on

With the British establishment closing ranks behind the Queen against Meghan and Harry in recent weeks it came as no surprise that the royal couple came in for some harsh criticism from the more hidebound English press. This comment from the *Telegraph* was typical:

"Freedom, as you're about to find out, does not come free of charge; it's an expensive, hard, tarnished business. And please, whatever you do, don't claim that you were 'driven out' or that the British people were racist towards Meghan, because that is the most insulting, disingenuous, face-saving falsehood. While North America may be shamefully short of mixed-race couples, a tolerant UK leads the world. We only ever wished you the best.

'one-sided'

"All families have to absorb the quirks and ambitions of new members who, in turn, must adapt to their peculiar new relations. In this case, the accommodating seems to have been decidedly one-sided. The Duchess felt "it wasn't working" for her. All Granny can do is humour the tricky granddaughter-in-law, make her feel she's got what she wanted, while keeping the indignant British taxpayer on board. If they get the money side of the Sussex deal wrong, it will not only be utterly toxic, it could hasten the end of the monarchy."

Queen grants Harry his wish

Her Majesty regrettably agrees Harry and Meghan can quit as senior royals

THE Queen has agreed to let the Duke and Duchess of Sussex quit for a new independent life, but expressed her sadness at losing them as full-time working royals.

In an unusually personal statement after a 90-minute family meeting at Sandringham House in Norfolk on Sunday, the 93-year-old monarch said she and her family respected Harry and Meghan's desire to create a new life, in which they will divide their time between Britain and Canada in a transition period.

After the couple were presented with a paper outlining several options for varying degrees of autonomy, the decision was taken in principle for them to stand down from their senior roles in the Firm. But there are still many complex details to be worked out and the Queen said more decisions would be made in the coming days.

charitable foundation

The Queen's statement was reminiscent of the informal style she used to address the nation after Princess Diana's death. The Queen, Prince Charles, Prince William

and Harry took part in the meeting. Aides declined to say whether Meghan joined the conversation by phone from Canada as expected. The precise details of what had been agreed in principle remained a closely guarded secret. Staff from the four households said they had been asked not to share any further information. It is clear, however, that the Sussexes are free to go off and "earn a professional income", while creating a transatlantic charitable foundation modelled on similar ones set up by two former US presidents and their families, the Obamas and the Clintons, and by Microsoft founder Bill Gates.

Critics have warned that their intention to trade on their royal connections and strike commercial deals while working as a liberal, progressive force – highlighting causes such as climate change and women's empowerment – risks tarnishing the reputation of the monarchy if they choose the wrong business partners or causes.

But the feeling inside

the family was that it was better to keep them in the fold as much as possible, amid fears over the damage they could do if they went rogue.

One of the couple's closest friends, ITV news anchor Tom Bradby, has suggested they were ready to walk away and give a no-holds-barred interview, perhaps like Diana's 1995 Panorama bombshell when she questioned whether Charles would ever become King. Some royal commentators noted that the Queen did not refer to the couple as the Duke and Duchess of Sussex in her statement, speculating that they might be stripped of their

titles.

The paper presented on Monday set out several options with the likely costs in the light of the couple's decision to give up taxpayer-funding from the Sovereign Grant.

This pays for the running of their office, key staff and their overseas travels on official duties.

The family has yet to reach a clear view on how much money the couple will get from Charles's annual £21million income from the Duchy of Cornwall estate.

There will also be a hefty tax bill for the couple if they live in two countries. Some have

also predicted they may have to pay for some of their £1million-a-year police protection. Although senior security sources and politicians suggested taxpayers in Britain should still pay, because the couple will always be targets for fixated individuals, far-Right extremists and Islamist terrorists due to Harry's military service in Afghanistan. If they spend half the year in Canada, it is likely Canadian taxpayers will end up paying for their protection too. Reports this week suggested Canadian Prime Minister Justin Trudeau had agreed his country would cover the cost.

Pastor: Devil made me a serial rapist

Michael Oluronbi was convicted of 15 counts of rape, seven counts of indecent assault and two counts of sexual assault on Friday after a trial at Birmingham Crown

Court.

A jury heard that some of Oluronbi's female victims became pregnant, but were given drugs for a termination by the qualified pharmacist.

The pastor claimed the devil made him carry out the abuse. In a video he says: "Everything was just my fault ... I was an animal." He will be sentenced at a later date.

Parents late to pick up the children face fines from school

A PRIMARY school has sparked anger after introducing a policy of fining parents if they are late to pick up their children.

New rules at Holy Trinity School in Gravesend, Kent, state that parents and carers who fail to arrive at the gates on time will be fined £1 every five minutes per child.

Under the policy, the school states it will contact social services if a child is not collected by 4pm – half an hour after classes finish – and if parents cannot be contacted, the child will be admitted into the care of the local authority.

However, the penalty will only come into force after parents have been late on three occasions.

Schools have argued that stretched budgets cannot cover paying overtime because parents are not keeping to the timetable.

However, some critics fear the penalties will punish less well-off families.

One parent at the school told Kent Online: "Lots of schools finish around the same time and this means that it is a struggle to get kids on time.

"The letter says that if kids aren't picked up by 4pm the school will ring social services. We think the fact that the governors have agreed to impose this is disgraceful.

Denise Gibbs-Naguar, the head teacher, said: "It is...an increasingly regular occurrence to have a significant number of uncollected children still on site at 4pm".

"When this occurs a member of staff has to be paid overtime... the school is not able to sustain this ongoing cost."

Back in black? Next James Bond could be person of color, producers suggest

PRODUCERS of the James Bond film franchise have given their strongest hint yet that the next 007 will not be a white man.

Barbara Broccoli and Michael G Wilson, who have overseen the spy series throughout its Daniel Craig era, believe that British diversity allows for a black or Asian Bond.

Mrs Broccoli has, however, ruled out a female Bond, saying that although the MI6 agent can be "any colour", the character, nevertheless, "is male".

Speaking about Bond's ethnicity, fellow producer Mr Wilson suggested that the spy's Commonwealth connections could allow for a broader range of casting options.

Idris Elba has often been mentioned as a successor to Craig, and bookmakers believe Last Christmas star Henry Golding, or Bafta-winner Daniel Kaluuya could have a chance of becoming the new 007. Craig himself was something of a surprise when he took the role.

Created in 1953 by

Ian Fleming, the hero's looks were in part based on those of white American performer Hoagy Carmichael, and screen portrayals of the spy from Sean Connery to Craig have all been by white actors.

Mrs Broccoli and Mr Wilson, her half-brother, have strongly suggested that there is no need for this convention to continue, nor for the character to resist evolving his views to match the more politically aware era of the 21st century.

Speaking to Variety, Mr Wilson said: "You think of him as being from Britain or the Commonwealth, but Britain is a very diverse place."

There have been calls from some quarters for the spy franchise to diversify its leads with talent from different ethnic backgrounds, and for there to be a female Bond.

While the first may soon happen, the second will not. "He can be of any colour, but he is male," said Mrs Broccoli.

"I believe we should be creating new

characters for women – strong female characters. I'm not particularly interested in taking a male character, and having a woman play it. I think women are far more interesting than that."

Resisting a change in gender, the character of Bond may be powerless to resist the changing political landscape around him, and could find his macho image more malleable in a post-MeToo world. Mrs Broccoli said: "Bond's been evolving along

with all the other men in the world. Some have just gotten there more quickly than others."

Comfortable with adapting the character to match the era, the producer is not as at ease with the departure of Craig, remarking that she is "in denial" over the "traumatic" idea that the actor will not reprise the role.

Mrs Broccoli has suggested that it is not only the character that could evolve in future, but that the cinematic franchise itself could be

brought up to date with 21st century trends.

She said that with the largest audience possible in mind, there was a logic to bringing Bond from the big screen to the small, and would not rule out the involvement of other platforms such as Amazon and Netflix.

Craig's next outing will be in No Time To Die, and it was announced this week that teenage American singer Billie Eilish would provide the theme tune for the film, set to be released in April.

Pasty baker flakes on Cornwall

BRITAIN'S leading bakery chain Greggs has been forced to close its only branch in Cornwall after a backlash from Cornish residents over the selling of pasties.

The bakery chain opened its first store in the county in September 2018 with an outlet at a service station in Saltash but said it has shut following a "thorough review". It means Greggs has returned to no longer having a presence in Cornwall despite having more than 1,700 branches across the country.

The announcement was celebrated by residents who claimed the decision marked a vindication for the traditional Cornish pasty.

Some opponents had branded Greggs as "junk" and warned the chain was never likely to survive long-term in the county.

Ann Muller, owner of Ann's Pasties, said: "People love a pasty in Cornwall. There isn't a Cornish person around who doesn't have a pasty at least once a week – and people like them traditional."

Rutland to get its first taste of McDonald's despite 50 objections

Plans for a McDonald's drive-through in Rutland – the last county in England without a branch of the fast food chain – have been approved.

Despite more than 50 objections, including claims that the "unsightly" development

would increase litter, councillors passed the application for the restaurant north of Oakham.

The planning application was recommended for approval in a report presented to Rutland County Council's planning committee

yesterday evening, with councillors giving it the go-ahead after an hour's debate.

Martin Cuthbert, who will be the manager of the franchise, said he was expecting it to attract customers from "both Oakham and passing traffic".

UK pothole problem is 17 miles deep, says new report

Potholes on Britain's roads would be 15 times as deep as the Grand Canyon if they were stacked up, it has been claimed, as small businesses urged the Government to end the blight on motorists.

More than 700,000

potholes were reported to local authorities last year, with a total depth of 17 miles.

The Federation of Small Businesses (FSB) called on Boris Johnson to honour his manifesto pledge to spend £2billion repairing potholes.

Mike Cherry, the FSB's national chairman, said that "poorly maintained" roads "seriously hamper small firms from going about their business" as vehicles were damaged, leading to repairs that businesses sometimes could not afford.

Hopkins and Pryce lead British Oscar charge

THERE is a sizeable contingent of British talent vying for Oscars following the release of this year's nominations.

Welsh actors Anthony Hopkins and Jonathan Pryce (pictured, right) are both in the running for their roles in in Netflix's *The Two Popes*. Hopkins, 82, won a nod for Best Supporting Actor playing conservative Pope Benedict, while Pryce, 72, plays the liberal future Pope Francis and is nominated

for best leading actor.

Other UK talent to be shortlisted includes actresses Cynthia Erivo, Florence Pugh and director Sir Sam Mendes. Erivo, 33, is up for Best Actress as abolitionist Harriet Tubman in *Harriet*. Pugh, up for best-supporting actress as Amy March in *Little Women*, put her first nomination down to "hard work". The 24-year-old said: "You've got to keep on going, and hopefully you'll see

something at the end of the tunnel."

Mendes, who helmed the WWI pic *1917*, faces tough competition from Martin Scorsese (*The Irishman*), Todd Phillips (*Joker*), South Korean Bong Joon-ho (*Parasite*) and Quentin Tarantino (*Once Upon A Time... In Hollywood*). Sir Sam said he "couldn't be more thrilled" by the nominations for his First World War epic, which he called "a labour of love for many people".



Tuna in, cod out as climate change brings drastic changes to British waters

CLIMATE change could fill Britain's seas with anchovies and tuna as species such as cod are wiped out, a government study has predicted.

The country's increasingly warm and acidic seas are becoming less hospitable to cold-water fish and shellfish on which the fishing industry relies.

The Department for Environment, Food and Rural Affairs scientists forecast that by 2050 this will cause big changes in commercial species' distributions in the North Sea. Already, fish from warmer climes are populating Britain's seas, the Marine Climate Change Impacts Partnership found.

Increasing numbers of Atlantic bluefin tuna have been reported in home waters by commercial and recreational fishermen. At present, there is no quota for this species for British vessels.

Mackerel has become dominant off the west of Scotland in the last 30 years, and northern hake has recolonised the northern North Sea after being largely absent for more than 50 years.

Scientists also noted

the appearance of warm-water species, such as the European anchovy, and local declines of some cold-water species, including the viviparous eelpout.

Welsh fisheries will be particularly at risk from climate change, the report predicted, as cockles and whelks do not cope well with ocean acidification, which is caused primarily by uptake of carbon dioxide from the atmosphere.

Species such as European seabass and herring are expected to

become more prevalent in UK waters, as their larvae are more resilient to ocean acidification than other competing species.

Fish are likely to become smaller as they have to travel further for their prey in warming waters, expending more energy, the report predicted.

This all spells trouble for the British fishing industry, which does not have the correct quotas for the newly arriving fish, and will have to cope with catching smaller fish. The study's authors said: "Declines in shellfish

resulting from ocean acidification may result in significant economic losses."

Tony Juniper, the chairman of Natural England, said: "This report underlines the profound impacts already being caused to our marine environment by climate change. The UK

is taking strong steps to safeguard the health of the ocean environment so vital for our well-being, both around our own shores and further away. More is needed, however, including the vigorous pursuit of the UK's net zero emissions goal, which hopefully more countries will soon adopt as well."

However, the arrival of warm-water species presents an "opportunity" for tourism by anglers, the report said, adding that "warm-water fish have been detected in the Channel Islands, including species such as the Atlantic bonito, which is popular for sea angling".

Let's roll up county lines drug gangs, says Johnson

Boris Johnson has ordered all Whitehall departments to take action to tackle crime as he declared that he wanted to "roll up" county lines drugs gangs.

At yesterday's Cabinet meeting, he told ministers that "every department in Whitehall should consider itself a criminal justice department" in a drive to tackle "complex causes of crime".

The move will involve long-term reforms to improve health, social care, youth services and education, Downing Street said.

Earlier, Mr Johnson warned that county lines gangs, which run drugs from cities into villages across Britain, were "killing young kids".

He said: "I want to see crime come down. I want to see the county lines drugs gangs wound up, rolled up."

Jury Summons? Don't panic!

Have you received a jury summons recently? A lot of our members in the Brits in LA Facebook group have too and it has caused a lot of concern.

Many of our members are here on visas so don't actually qualify to do jury service and are understandably confused when they receive the notice. It can be quite scary when such an official document arrives in the post, especially when you are here on a temporary basis. Having gone through the visa process myself I know how carefully you all tread, afraid you are going to put a foot wrong. I don't think I jaywalked once before I got my citizenship!

I received my first summons about 15 years ago. I was a green card holder. I don't know why but I panicked when I opened it. I naturally ignored it for a few days

but then finally plucked up the courage to call the number on the card. The customer service representative on the other end of the phone was surprisingly nice; and reassured me that I wasn't going to get in to any trouble for not being able to serve. She explained that the process is random and notices were sent to people who have either registered to vote or are in the DMV database. So my name got picked purely because I had a California driving license.

So whatever your status, if you get a notice make sure to respond as by not doing so CAN get you into trouble.

To serve on a jury you need to be a US citizen so if you are not a U.S. Citizen, you must complete SECTION A of the summons and register by calling 1-800-778-5879. Although you are not

qualified for service, you are required to complete the registration process.

I recently got summoned again. I received a postcard in the mail with "FAILED TO RESPOND" highlighted in bright red, and that I may be subject to a fine of up to \$1500! This time I felt understandably terrified as I am now eligible as a citizen. Obviously, somehow my original summons had got lost in the mail, but miraculously the little scary postcard had made it to me. So again I put it off for a bit then realized the stress was actually worse than a \$1500 penalty. I picked up the phone and to my relief I got another friendly customer service rep who told me not to worry and they would just reschedule my court date. My fears of being hauled off to jail or having my citizenship revoked disappeared immediately. That feeling of relief taught me a very good lesson too... never avoid or ignore problems as the fear they create is often far worse than the actual outcome.

I did experience another hiccup, my new date was set but it just wasn't feasible to take that period off at my work place. This time I visited www.LACourt.org to access 'My Jury Portal' and to my delight there was an option to postpone. And with a simple click, and no threat of fines, that's exactly what I did. I am now due in towards the end of February and to be honest I am actually quite excited to experience the full process. 

What do you find the biggest difference is living here versus Michigan?


The biggest difference between here and Michigan - the densely populated cityscape to land area ratio - if that makes sense: i.e. no place to park!!!!

Stokes named World Player of the Year

Ben Stokes joined an exclusive club this week, becoming just the second English player, after Jonathan Trott, to be named the International Cricket Council's world player of the year.

Stokes has enjoyed a remarkable year. The all-action all-rounder proved a hero with bat and ball, and a brilliant fielder. But beyond his feats in the World Cup and at Headingley, Stokes has emulated Trott by becoming England's most

dependable batsman. His average since the start of 2019 is 47, 10 more than Joe Root and 12 ahead of Rory Burns, the next-best to have played more than four Tests.

Stokes has always been technically sound. Good on front or back foot, driving or hooking and pulling, he can play every shot in the manual plus be unorthodox when necessary. His match-winning innings at Headingley against Australia combined the savage with the sublime.

The switch hit for six off Nathan Lyon followed steady accumulation and robust defence early in his innings when the team were in trouble.

Stokes, aged 28, can now build an innings and that is the crucial difference to how he was at 24. The Headingley century and dragging his team through the World Cup final have

imbued him with a sense of invincibility. Stokes, in his own mind, is simply never beaten. Sports psychologists call it being in the "flow state", which is essentially a calmness and ability to block out the external pressure.

"I think more than anything, it's his mental approach to the game," England captain Root said when asked about

Stokes' improvement this week. "I think after he had a time out of the team, he's grown as a senior player, as a mentor to the young guys within. That's testament to his character and how much he cares about playing for England and how much he cares about the group that surround him. And his desire to want to get better all the time."

Guardiola has not given up hope that the striker, who joined from Atletico Madrid in July 2011 for £40m, will sign a new deal.

"It depends on him, it is his decision," said Guardiola.

City's defence has been a problem this season, but Guardiola retains faith in John Stones, who has suffered a stop-start two seasons due to injury and loss of confidence.

There is relief from Guardiola that City's results and performance have improved, with nine wins in their last 10 games since losing at home to Manchester United in December. Guardiola still feels under pressure to deliver at City and knows, in particular, the importance

of the Champions League. He remains hopeful of reducing the 14-point lead that Liverpool have (with a game in hand) in the Premier League.

Jurgen Klopp recently extended his contract at Liverpool to 2024, which

led to questions as to whether Guardiola will also renew his deal at City beyond a fifth season at the club which, already, would be the longest stay in his managerial career.

Guardiola, who is 49 on Saturday, when City host

Crystal Palace, has already indicated that he is open to extending his deal and explained at the time that it was not just about him, but what the club and players wanted, and whether they still wanted to work with him.

Everton seal £30m sponsorship deal for new stadium

Everton have agreed a £30million naming rights option for their proposed new stadium, with the company owned by former Arsenal shareholder Alisher Usmanov, the club have announced.

Usmanov's USM Holdings has paid the fee and already agreed terms on the annual value of stadium sponsorship when the arena on Liverpool's docklands is

built, scheduled for 2023.

The arrangement further extends Usmanov's Everton interest, as USM is already a major commercial partner and sponsors the club's training ground, Finch Farm.

There is no guarantee the stadium will be called the USM Arena under the deal, but Usmanov is in prime position to push ahead with the exclusive agreement ahead of any

rival interest. Everton have not said how much naming rights will be worth per season, but it is thought to be below the £25million a year Tottenham Hotspur are believed to be seeking for their stadium naming rights.

Usmanov – a close friend of majority shareholder Farhad Moshiri, who is also part owner of USM – has not disguised his growing influence at the club,

having sold his Arsenal shares in August 2018. His significant financial support is proving crucial to Moshiri after the board confirmed record losses of £111.9million in its most recent accounting period, covering 13 months from May 31, 2018, to June 30, 2019.

Speaking last week, Usmanov hinted at the next stage of his involvement. "They are going to build a new

stadium. Why not the USM Arena?" he said in an interview in the Financial Times. "I am thinking about my investment in this club."

Moshiri's investment in Everton has risen to £350million – aside from his initial purchase in 2016 – but he is yet to see a meaningful return, as signings have failed to impress and a succession of managers have been sacked.

Spurs eye Ze Luis as Eriksen exit looms closer

Tottenham Hotspur have been offered the chance to sign striker Ze Luis from Porto but are also looking at other options as Jose Mourinho pushes to strengthen his squad.

At the same time, Piero Ausilio, the Inter Milan sporting director, is in London to try to conclude a deal for Christian Eriksen. The midfielder wants to join Inter now, rather than at the end of the season when his contract expires at Spurs, and has agreed personal terms, but the clubs

remain apart on their valuation. Spurs want £17.1m, while Inter have offered a little over half that with add-ons.

The priority, with Harry Kane out until the middle of April having suffered a serious hamstring injury, is a centre-forward and Ze Luis has been offered on loan until the end of the season by Jorge Mendes, the agent.

Mendes has a long association with Mourinho, having done the deal to take him to Chelsea in 2004, and has

already taken another Portugal-based player, Gedson Fernandes, to Spurs from Benfica. The 21-year-old's move was announced on Monday on an initial 18-month loan spell, for €4.5million, with an option to buy for fifty million euros.

A complication for Ze Luis is that he is a Cape Verdean and does not hold a Portuguese passport, so will struggle to secure a work permit. Spurs would have to apply under the Home Office points system and

it is unclear, given that he is 28, whether he would fulfil the criteria. He signed for Porto last year from the Russian club Spartak Moscow, but has not been a regular starter.

Talks have also taken place between Spurs and AC Milan over striker Krzysztof Piatek, but the costs are too high. Spurs are aware that Napoli have made their former striker Fernando Llorente available on loan and, like Chelsea, hold an interest in Atletico Madrid winger Thomas Lemar.

Fernandes said he would settle in London, where his parents already live. "It's a hard story. My family, they came to London because in Portugal, work is very hard and it's very difficult to find work," he said.

"They did not have a brilliant life, but they have a good life here and this is one more motivation for me to be here. They will help me settle.

"It's one big dream to come to this big club. This is a fantastic challenge."

■ Spanish veteran makes the difference as United edge past Wolves in FA Cup

Juan Mata brushed aside his recent role as a bit part player at Manchester United Wednesday night to score the vital goal which earned them an FA Cup third-round replay victory over Wolverhampton Wanderers.

Mata has given the impression of reaching veteran status, despite being just 31, and when he collected Anthony Martial's clever pass there was an awful lot of the Old Trafford pitch to cover. But the midfielder did just that and showed a surprising turn of pace as he held off defenders before deftly lifting the ball over goalkeeper John Ruddy.

It lifted the atmosphere around Old Trafford, far from full once more for a cup game, although there was the damper of an injury to Marcus Rashford, who had come on as a second-half substitute but lasted just 16 minutes before aggravating a back injury following a

robust challenge by Matt Doherty.

Ole Gunnar Solskjaer later admitted that playing Rashford had been a risk, but it was one he felt he had to take, with the striker coming on as the game remained goalless. It showed the importance of getting through this tie, setting up a meeting with either Watford or League One strugglers Tranmere Rovers, and of staying in the Cup.

Rashford was not involved in the goal but his arrival gave United more of an edge and the concern will be whether he will be fit to face Liverpool away on Sunday. United cannot afford to be without him.

Wolves, who knocked United out last season, departed with a sense of grievance after appearing to open the scoring in the first half only to have the goal disallowed after a video assistant referee check.

This replay had come after a goalless, tepid first

encounter at Molineux and, after a bright start, the game went the same way. Chances were missed and not least by United's Daniel James, who has the speed and the directness but does not yet have the finishing.

The winger spurned three good chances. For the first he tried to go around Ruddy, only for the goalkeeper to thrust out a hand, then he tried to lift the ball over the former England international only for him to block with his shoulder, before James did well in the second half to create the space but shot low across goal and just beyond the far post.

Wolves also had chances and were unfortunate from a short corner as Ruben Neves swung in a cross that was met by Doherty, whose header beat Romero but rebounded back off the far post.

Finally it was United who broke the deadlock. Maguire was heavily involved as he

dispossessed Doherty inside the United penalty area and cleared, with Conor Coady misjudging the ball as he let it bounce and allowed Martial to

seize on it. Wolves' high defensive line was undone but no one was sure Mata could stay ahead of the chasing pack, which he did to finish with aplomb.

Having come back into the team for the 4-0 win at Norwich City, with two assists, it was an even more key contribution from Mata.

Aguero 'will die scoring goals'

■ Pep hails record-breaking Aguero

Manchester City's record-breaking forward Sergio Aguero will "die scoring goals", says his boss Pep Guardiola.

The Argentina striker scored a hat-trick to become the highest overseas goalscorer in Premier League history as City thrashed Aston Villa 6-1.

Aguero, 31, moved past Thierry Henry and joined Frank Lampard on 177 goals scored in England's top flight.

"He's a legend," added Guardiola. "It was an honour to be here on the day he achieved
