Tributes flow for Terry Jones

Python founder, writer and director dies peacefully at 77

Sir Michael Palin has paid tribute to “one of my closest, most valued friends” following the death of fellow Monty Python star Terry Jones.

The actor and comedian, who directed some of the comedy troupe's best-loved works, “gently slipped away” at the age of 77, a statement to the PA news agency on behalf of his family said.

Sir Michael said Jones, who had dementia and died on Tuesday evening, was “kind, generous, supportive and passionate about living life to the full”.

He was far more than one of the funniest writer-performers of his generation, he was the complete Renaissance comedian – writer, director, presenter, historian, brilliant children's author, and the warmest, most wonderful company you could wish to have,” he said.

'many talents'

He added in a statement to PA: “I feel very fortunate to have shared so much of my life with him.”

Fellow Python stars John Cleese and Eric Idle also paid tribute to Jones, with Cleese tweeting: “It feels strange that a man of so many talents and such endless enthusiasm, should have faded so gently away...”

Referring also to sixth Python member Graham

Chapman, who died in 1989, he added: “Two down, four to go.”

Idle tweeted that Jones's death “is a cruel and sad thing”, adding: “But let's remember just what joy he brought to all of us.”

Idle said he loved Jones “the moment I saw him on stage at the Edinburgh Festival in 1963.

'truly authentic'

“So many laughs, moments of total hilarity onstage and off we have all shared with him. It's too sad if you knew him, but if you didn't you will always smile at the many wonderfully funny moments he gave us.”

Jones appeared in the Monty Python's Flying Circus TV series in a variety of characters, and was known for his performances in drag.

A statement on behalf of his family said they were “deeply saddened” to announce the death of a “beloved husband and father”, who had “given pleasure to countless millions across six decades”.

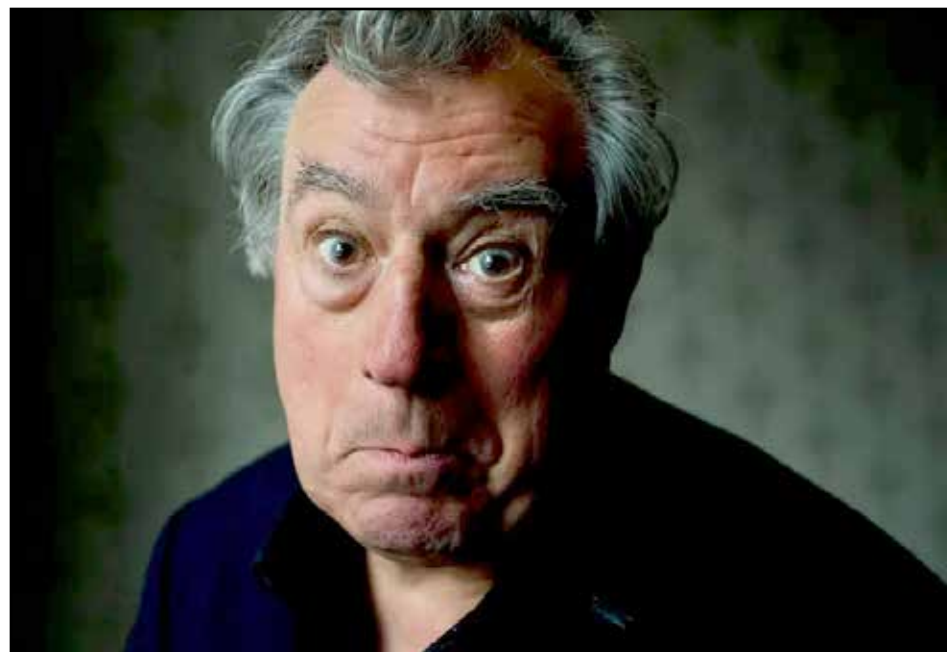
They hailed an “extraordinarily talented, playful and happy man living a truly authentic life, in his words 'Lovingly frosted with glucose'.”

Jones first got the acting

bug while studying at Oxford. He founded the Experimental Theatre Company with his friend and contemporary Michael Rudman, performing everything from Brecht to cabaret. He also met Palin and the historian Robert Hewson, and collaborated with them on a satire on the death penalty called Hang Down Your Head and Die. It was set in a circus ring, with Jones playing the condemned man. He and Palin then worked together on the Oxford Revue, a satirical sketch show they performed at the 1964 Edinburgh festival, where he met David Frost as well as Chapman, Idle and Cleese.

After graduation, he was hired as a copywriter for Anglia Television, and was then taken on as a script editor at the BBC, where he worked as joke writer for BBC2's Late Night Line-Up (1964-72). Jones and Palin became fixtures on the booming TV satire scene, writing for, among other BBC shows, The Frost Report (1966-67) and The Kathy Kirby Show (1964), as well as the ITV comedy sketch series Do Not Adjust Your Set (1967-69).

In 1967, he and Palin

were invited to write and perform for Twice a Fortnight, a BBC sketch show that provided a training ground not only for a third of the Pythons (Jones and Palin), but two-thirds of The Goodies (Graeme Garden and Bill Oddie) and the co-creator of the 1980s political sitcom Yes, Minister, Jonathan Lynn.

In 1969 Jones became one of the six founders of Monty Python's Flying Circus. They expected the show to be quickly decommissioned by BBC bosses. “Every episode we'd be there biting our nails hoping someone might find it funny. Right up until the middle of the second series John Cleese's mum was still sending him job

adverts for supermarket managers cut out from her local newspaper,” Jones recalled. “It was only when they started receiving sackfuls of correspondence from school kids saying they loved it that we knew we were saved.”

children's books

After Python finished its run on TV, Jones went on to direct several films with the troupe. The first, Monty Python and the Holy Grail, was, he recalled, “a disaster when we first showed it. The audiences would laugh for the first five minutes and then silence, nothing. So we re-cut it. Then we'd show it in different cities, saying, ‘We're worried about our film, would

you come and look at it? And as a result people would come and they'd all be terribly worried about it too, so it was a nightmare.”

Jones directed and starred in Monty Python's Life of Brian, which some religious groups denounced for supposedly mocking Christianity. Jones defended the film: “It wasn't about what Christ was saying, but about the people who followed him – the ones who for the next 2,000 years would torture and kill each other because they couldn't agree on what he was saying about peace and love.”

He also wrote children's books, starting with The cont. on page 4, col. 6

UK jobless total lowest in 46 years

THE jobless total in the UK has dropped to below 1.31 million – the lowest level since 1974.

The number of people claiming unemployment benefit fell by 7,000 in the three months to November, official figures revealed this week.

Female unemployment fell by 9,000 while the number of jobless men rose by 2,000.

Meanwhile, the employment rate grew to its highest point on record, at 76.3 per cent – 0.6 points higher than a year earlier.

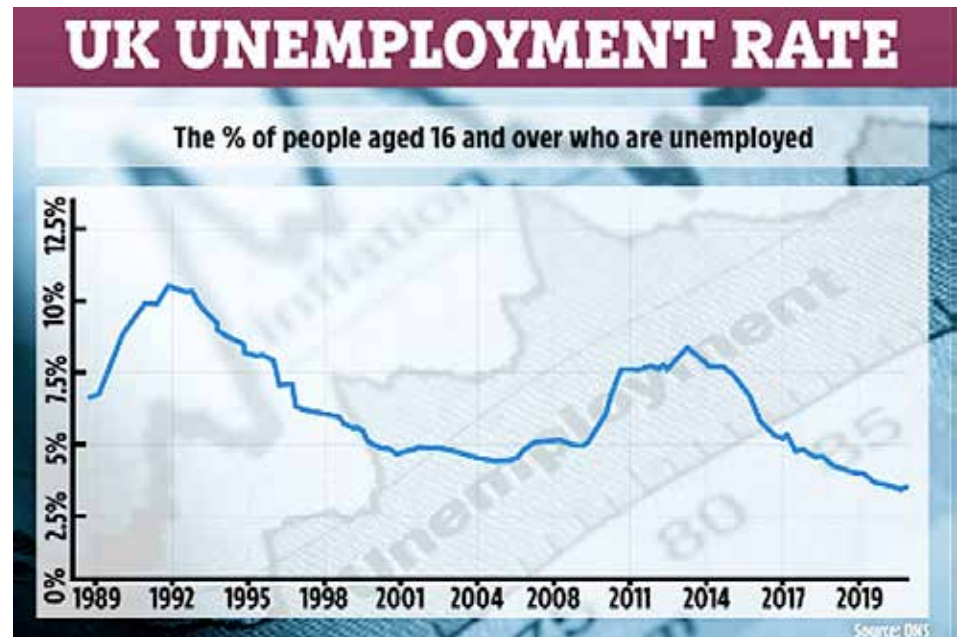
David Freeman of the Office for National Statistics, said: “The

employment rate is at a record high, with over two-thirds of the growth in people in work in the last year coming from women working full-time.

“Self-employment has also been growing strongly, and the number of people working for themselves has now passed five million for the first time.”

It means that just 3.8 per cent of people who are looking for work do not have a job – although earnings are still lower than in the run-up to the financial crisis, the ONS said. The growth in average weekly earnings, including bonuses,

remained unchanged at 3.2 per cent. Mr Freeman added: “While pay growth has eased since last summer, with inflation remaining subdued, earnings are continuing to increase in real terms.” Currently the average weekly wage is £472, which is £1, or 0.2 per cent less than in March 2008. The number of vacant jobs fell by 11,000 to 805,000 – 49,000 fewer than the same period a year earlier, statistics showed. Mims Davies, Minister for Employment, said: “With unemployment at its lowest since the Seventies, our jobcentres go beyond getting people



into work – they are about progression. “Reaching supporting those in work about community and out to more people, and to get ahead.”

Sinn Fein demands vote on Irish unity within five years

SINN FEIN has made a border poll on Irish unity within five years a precondition for joining a coalition government in Dublin.

Speaking at the launch of the party’s manifesto on Monday, Mary Lou McDonald, the president of Sinn Fein, said it wanted a border plebiscite by 2025 and an all-party forum on unification to convene in the next parliament.

The Irish general election takes place on Feb 8. The latest

opinion poll, released on Monday by The Irish Times, showed a surge in support for Sinn Fein. The party had a popularity rating of 21 per cent, up 7 per cent since the last poll three months ago, and marginally behind the ruling Fine Gael party on 23 per cent and the biggest opposition party Fianna Fail on 25 per cent.

The campaign has been dominated by domestic issues such as a chronic shortage of housing and chaos in the health sector.

Sinn Fein’s claims that these crises have been caused by decades of mismanagement by the two establishment parties have resonated with voters.

If these levels were replicated in the general election, then Fine Gael and Fianna Fail would find it hard to form a stable government without Sinn Fein MPs. However, both parties have ruled out a coalition with the former political wing of the Provisional IRA.

‘Stable’ UK to outperform the sluggish eurozone

■ Global bosses poised to invest as they see Britain as beacon of stability after Brexit, says PwC report

CHIEF executives from around the world are poised to unleash a wave of investment in Britain, as forecasts show the UK’s economy will outperform the eurozone in the two years after Brexit.

The UK is the fourth most important nation for business growth plans behind only the US, China and Germany, according to a PwC report launched at the World Economic Forum’s annual conference in Davos this week.

It suggests Britain is seen as an increasingly stable place to do business in a world beset by political and economic turmoil, despite previous claims that its international standing would be undermined by Brexit.

Britain is now as attractive as it was in 2015 before the decision was reached to hold an EU referendum, PwC found.

Separately, the international Monetary

Fund (IMF) said that UK economic growth will rise to 1.4pc and 1.5pc in 2020 and 2021 respectively as Brexit uncertainty comes to an end at last and business investment picks up.

Meanwhile sluggish growth in Germany and Italy will hold the eurozone back, with the bloc expected to expand by 1.3pc this year and 1.4pc next year.

Britain also outperformed the eurozone in 2019, meaning growth is set to be higher in the UK than the monetary union for three years running.

The IMF also said that global growth will be 3.3pc this year and 3.4pc in 2021. This is down 0.1 and 0.2 percentage points respectively from its last forecast in October.

The IMF attacked Brexit during the 2016 referendum campaign, with then-managing director Christine Lagarde saying that the

consequences of Brexit would range from “pretty bad, to very, very bad”. But with Brexit days away, hope for the economy is picking up.

PwC’s survey of directors ranked Britain joint fourth alongside India and Australia as a growth target.

The UK came ahead of France and Japan, indicating the economy is once more punching above its weight after a spell of nervousness.

Kevin Ellis, chairman of PwC UK, said: “The findings provide timely perspective on the UK’s standing as a place to invest and do business. Viewed against the turbulent global backdrop, the UK is a beacon of relative stability.”

“You can’t replicate natural advantages like our timezone and location between the US, Asia and the rest of Europe, but more than that the UK is a fair and trusted place to do business.”

America rules out returning Harry Dunn suspect

The US has turned down an extradition request for one of its citizens to be charged over the death of motorcyclist Harry Dunn.

Mr Dunn, 19, died after a crash in Northamptonshire in August which led to the suspect, Anne Sacoolas, leaving for the US under diplomatic immunity.

The Home Office started extradition proceedings on charges of causing the death by dangerous driving.

'denial of justice'

A spokeswoman said the decision by the US "appears to be a denial of justice".

The US Secretary of State Mike Pompeo turned down the extradition request in an email to the UK Government, family spokesman Radd Seiger said.

He said the family would react fully to the news on Friday morning, adding "the fight goes on" for justice for their son.

The family's constituency MP Andrea Leadsom is due to meet the US ambassador Woody Johnson in London on Friday to discuss the case.

When the Home Office started extradition proceedings the US State Department said the request would be "highly inappropriate".

It insisted Ms Sacoolas' status at the time of the crash meant she had diplomatic immunity.

Prime minister Boris Johnson previously said the chance of the suspect ever returning to the UK was very low.

■ Duke reveals decision to quit royal life came after 'months of talks ... years of challenges'

THE Duke of Sussex has described his "great sadness" over his split from the Royal family, but said he had "no other option".

In his first personal comments about his decision to step back from public life, the Duke expressed disappointment with the conclusions reached about his future.

He revealed he had hoped to continue serving the Queen, the Commonwealth, and his military associations without public funding but added: "Unfortunately, that wasn't possible."

The heartfelt speech was delivered at a private dinner for Sentebale, the charity Prince Harry co-founded in 2006, in London, barely 24 hours after Buckingham Palace announced that the Duke and Duchess of Sussex were to give up their HRH titles and would no longer formally represent the 93-year-old monarch.

'no other option'

He said: "The decision that I have made for my wife and I to step back is not one I made lightly."

"It was so many months of talks after so many years of challenges. And I know I haven't always gotten it right, but as far as this goes, there really was no other option."

He added: "The UK is my home and a place that I love. That will never change. What I want to make clear is that we're not walking away, and we certainly aren't walking away from you."

The Duke, 35, insisted that his 38-year-old wife upheld the same values as he did and was the same woman with whom he had fallen in love.

"We both do everything we can to fly the flag and

carry out our roles for this country with pride," he said.

The Duke blamed the media for the seismic schism in the Royal family, describing it as a "powerful force".

He said he wanted to share "the truth" about the revelations of the last few weeks, insisting that he was still the same Harry of old "but with a clearer perspective".

"That will never change," he said. "I have grown up feeling support from so many of you, and I watched as you welcomed Meghan with open arms, as you saw me find the love and happiness that I had hoped for all my life. Finally, the second son of Diana got hitched. Hurray!"

The Duke said he had accepted the outcome of the negotiations that had prevailed since he and his wife announced their intention to "step back" from public life earlier this month, but insisted that it did not change who he was nor how committed he was.

'great honour'

"I hope that helps you understand what it had to come to, that I would step my family back from all I have ever known, to take a step forward into what I hope can be a more peaceful life," he added.

"I was born into this life, and it is a great honour to serve my country and the Queen ... It has been our privilege to serve you, and we will continue to lead a life of service."

The Duke said he will always have "the utmost respect" for his grandmother, the Queen, who is understood to have made it clear from the outset that the Sussexes were not going to get their

"cake and eat it" wish by keeping one foot in the royal fold.

"I am incredibly grateful to her and the rest of my family, for the support they have shown Meghan and me over the last few months," he said.

"Together, you have given me an education about living. And this role has taught me more about what is right and just than I could have ever imagined. We are taking a leap of faith - thank you for giving me the courage to take this next step."

Separately, it emerged that the Prince of Wales plans to review the Duke and Duchess of Sussex's "abdication" deal within a year, amid fears over the mounting costs of their

proposed lifestyle.

While the couple have severed all official ties with the Royal family, Prince Charles is to continue to offer "private financial support" to his son and daughter-in-law as they embark on a new life in Canada.

The substantial cash injection is expected to come from the Prince's own private investment income rather than revenue generated by the Duchy of Cornwall estate, which has traditionally funded the heir to the throne and his two sons.

However, a source close to the Prince of Wales suggested that this was not an inexhaustible source of funds.

The warning was

sounded as grave concerns were expressed over the couple's security arrangements, which one well-placed source described as a "mess" which could cost millions. A security source told reporters: "You can't expect the Met Police to provide the security. They don't have the powers to operate in Canada. They would not be allowed to be armed."

"Security will have to be locally provided. The Canadians will have to pay and then bill it back to the UK Government."

Staffing costs have been estimated at a minimum of £500,000 per individual but that does not include travel, reconnaissance and home security.

Parkinson's diagnosis for Ozzy Osbourne

Ozzy Osbourne has revealed he has been diagnosed with Parkinson's disease.

The Black Sabbath frontman and reality TV star, 71, told the Good Morning America TV show that medics discovered he had the neurodegenerative disorder during treatment for a fall.

He said: "I did my last show [on] New Year's Eve at The Forum. Then I had a bad fall. I had to have surgery on my neck, which screwed all my nerves and I found out that I have a mild form."

'host of medications'

His wife and manager, Sharon Osbourne, added: "There's so many different types of Parkinson's, it's not a death sentence by any stretch of the imagination, but it does affect certain nerves in your body. And it's like you have a good day, a good day, and then a really bad day."

Ozzy said: "I'm on a host of medications, mainly for the surgery. I got a numbness down this arm for the surgery, my legs keep going cold."

Sharon said the couple planned to go abroad: "We have got all the answers we can get here [in this country], so in April we are going to a professor in Switzerland who deals with getting your immune system at its peak."

"We are going to go wherever we can go to seek answers."

Titanic wreck salvage plan is condemned as 'modern piracy'

AN AUDACIOUS plan to seize treasures hidden inside RMS Titanic sparked a furious row this week amid accusations of modern-day piracy.

Politicians accused a US salvage firm of attempting to "pilfer and pillage" the sunken wreck to make money, and the Government has said it would lobby the US and other Atlantic nations to "ensure the wreck of the Titanic is treated with the sensitivity it deserves".

However, descendants of the passengers and crew who died in the tragedy gave the project their blessing, and said it was time to retrieve Titanic's artefacts before they were lost forever.

The firm RMS Titanic Inc (RMST) had said it aims to cut open the wreck and remove its Marconi wireless system, described as the "voice of Titanic".

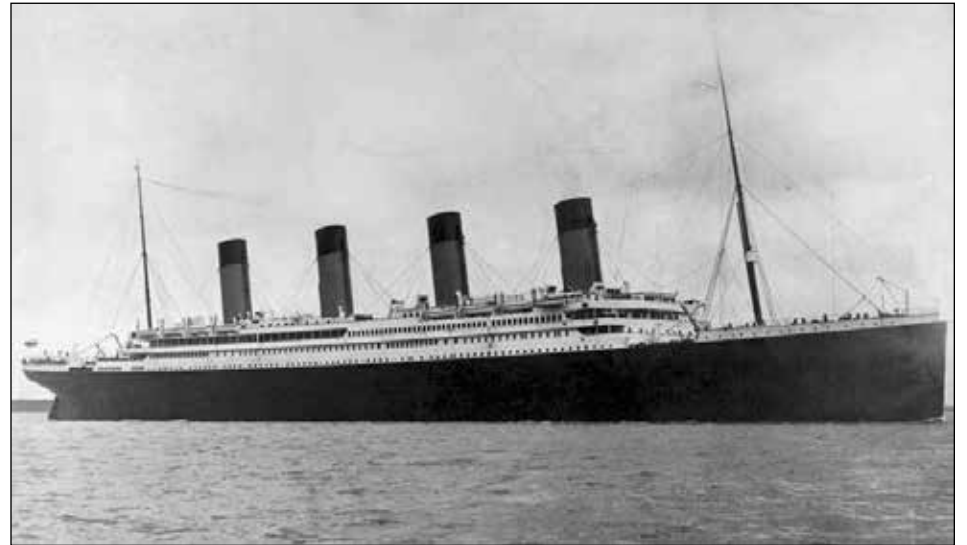
In legal papers revealed this week, it said it would

"surgically" remove a deckhouse roof, and use underwater robots to recover the radio which broadcast Titanic's final distress signals as it sank on April 15 1912.

The firm was awarded sole salvage rights to the Titanic nearly 30 years ago, and remains the only entity permitted to recover items from the wreck site. It has vowed to "ignore" a new treaty between the US and UK designed to protect the wreck from scavengers.

But Gavin Robinson, DUP MP for Belfast East, where the Harland and Woolf shipyard built the ship, likened the expedition to "piracy" and urged the Government to intervene.

"It's important we get behind the Government, and make sure that there are robust efforts in place that would frustrate the efforts of those who want to profiteer," he said. "The idea that

a vested connection would warrant pilfering and pillaging what is essentially a tomb, I think it's entirely misguided.

"If the detail of this agreement is not sufficiently robust to frustrate their efforts, that's where we need to place our attention now." Once recovered, the wireless and other artefacts would be put on display at the Luxor casino in Las Vegas, then

taken on tour around the world.

The company has recovered thousands of items from the vast debris field surrounding the Titanic since it was discovered in 1985, but the Marconi would be the first artefact taken from inside the wreck itself. RMST has insisted that it wants to preserve the wreck's treasures for future generations, and has sought approval for

the project from relatives of the dead.

Vanessa Beecham, 59, whose great-uncle, Edward Biggs, died in the sinking aged 21, told The Daily Telegraph: "I don't see this as a problem."

"They raised the Mary Rose in the Eighties. The people who died, including my great-uncle, are long gone...if the wireless can be retrieved in a sensitive way, then they have my blessing."

Ibiza club run by Lineker's brother sued after man paralysed

A FORMER Premier League footballer is suing Gary Lineker's family's Ibiza beach club for £8.5 million after he was left paralysed when he dived into its pool.

Jonathan Hutchinson, a former Birmingham City defender, broke his neck while partying with his friend in the "day club" section of the Ocean Beach Club in June 2016.

The friends had been drinking and "milling around" the bar area when they arrived at the resort – set up by Gary Lineker's brother Wayne – in the early evening, his lawyers said. But only hours later, emergency services were called to

haul Mr Hutchinson, 37, out of the pool after guests found him "floating" in the water.

Mr Hutchinson, who works as a welding inspector, now has to use a wheelchair, as his motor functions were significantly impaired by the accident.

'irregular size'

The father-of-two is suing the company which owns the club, Ice Mountain Ibiza SL, and its Spanish insurers, for £8.5 million of damages. Both companies deny liability.

Sarah Crowther QC, representing Mr Hutchinson, argued that the pool, which was of "irregular size", lacked sufficient warning

signs restricting diving and was inadequately supervised. She claimed that her client could not remember the specifics of the incident due to his injuries.

Mr Hutchinson, originally from Middlesbrough, was forced to retire from football in 2008 due to a series of injuries. He

played as a centre-back for Birmingham City in the Premier League in 2002, before moving to Darlington three years later.

His case reached the High Court this week, as lawyers contested whether it should be heard in England or Spain. The judge reserved her decision.

Saga of Erik the Viking and in 1987 he directed Personal Services, a film about the madam of a suburban brothel catering for older men.

Jones died "with his wife Anna Soderstrom by his side after a long, extremely brave but always good-humoured battle with a rare form of dementia, FTD", the statement said.

"Over the past few days, his wife, children, extended family and many close friends have been constantly with Terry as he gently slipped away at his home in north London.

"We have all lost a kind, funny, warm, creative and truly loving man."

BBC could be a Netflix-style service, says former chief

A FORMER director-general of the BBC has suggested that it could be turned into a "successful" Netflix-style subscription service.

Mark Thompson, now the chief executive officer of The New York Times, said it would be "possible" to remodel the broadcaster on streaming platforms.

However, he claimed the result "wouldn't be the BBC" and it would no longer be "a universal service paid for by everyone and used by everyone".

He also warned against decriminalising the licence fee, saying the result would be "negative" for the service.

Boris Johnson is looking into reviewing whether people who do not pay the £154.50 fee for watching television or BBC iPlayer should be prosecuted.

Mr Thompson warned that the corporation could lose around £200million by such a move, saying: "Once you decriminalise, you delegitimise a given service or a given tax. Because all the people who still pay it feel they can see other people enjoying the service for

nothing.

"I worry that decriminalisation is a de facto abolition of the licence fee but without the courage to say that."

His remarks came as it was revealed that the BBC could face a Commons inquiry into the future of its "out-of-touch" licence fee and role in national life. Julian Knight, the Solihull MP, has made the proposal the centrepiece of his bid to be elected chairman of the digital, culture, media and sport select committee.

The former BBC journalist said: "It's time for a root-and-branch, no-holds-barred review into the future of the BBC – how it is funded and what its role should be in our national life."

He said that the "main option" was to move to a subscription service or allow people to opt out from the BBC.

Mr Knight added: "The technology is there already. The iPlayer, for instance, requires registration, it was designed for subscription charges to be introduced in the future; so the BBC has designed a system for an eventuality they say would be a disaster."

Downton creator hints at movie sequel

DOWNTON Abbey creator Julian Fellowes has hinted a sequel to the film is in the works – but first he has to find the time to write it.

The 70-year-old writer promised he would get cracking on a follow-up to the 2019 hit once he has finished other work he has in the pipeline. He is currently working on The Gilded Age – a 10-part HBO series set in 19th century New York starring Sex And The City's Cynthia Nixon and Mamma Mia's Christine Baranski.

Julian is also busy promoting the upcoming

ITV drama Belgravia in the US, what he was doing when he was asked about a second film featuring the Crawley family. "Give us a break, guv," he said. "Not until I've finished the scripts for The Gilded Age."

The first Downton movie made £136 million worldwide when it was released last September so studio bosses are likely to be keen to replicate its success.

However, plans for a sequel could be a long time in the making as producers had a big task getting the cast back together for the first film.

73m viewers for The Crown, Netflix reveals

NETFLIX has lifted its veil of secrecy over viewing figures for The Crown, revealing that 73 million people watched the show.

That amounts to nearly half of the streaming service's 158million subscriber households.

The third series, starring Olivia Colman as the Queen, was watched by 21 million households in its first four weeks – 40 per cent up on series two over the same period – despite some claiming Colman paled in comparison to Claire Foy, her predecessor.

Netflix hailed the figures as a major success. Ted Sarandos, the tech firm's chief content officer, said: "Seventy-three million households around the world have made The Crown part of the global cultural zeitgeist. Thanks to creator and writer Peter Morgan and a phenomenal cast and crew, the show's popularity grows with each new season and, as the recent SAG and

Golden Globe Awards demonstrate, its quality remains unsurpassed."

The show won best actress for Olivia Colman at the Golden Globes, and outstanding performance by an ensemble cast at the Screen Actors Guild awards.

The Crown is the jewel in Netflix's schedule, but it was less popular than Sex Education (watched by 40million accounts in its first four weeks) and Stranger Things (64million).

Viewing figures for the UK were not released, but last year Lord Hall of Birkenhead, the BBC director-general, suggested he had seen data showing it had a fraction of the audience for the BBC One drama Bodyguard.

The fourth series of The Crown will cover the early years of the Prince and Princess of Wales's marriage. Imelda Staunton is said to have signed on to play the Queen for the fifth and sixth seasons.

Sturtevant Falls (Sturtevant Falls Hiking Trailhead, Forest Rte 2N40, Arcadia)

The first time I came here, I found it difficult to find the start of the trail - so be ready for that. The signs are honestly not very good - the trail starts on the other side of the roads than you'd expect (hopefully that'll make sense when you're there!). This trail is pretty cool. It starts on a tarmac road then you'll cross a river and it's onto shaded path with trees and cabins. Not a super hard hike, I'd say about 40 minutes to get to the falls which is really lovely.

Hermit Falls. (Hermit Falls Trail, Forest Rte 2N40, Arcadia)

This one actually starts at the same spot as Sturtevant. It's pretty flat for the majority of the walk with the incline increasing only for the last bit. The falls are gorgeous with a decent sized pool. About 2.5 miles total and not too hard.

Verdugos (Brand Park, 1601 W Mountain St, Glendale)

Not for the faint hearted! This is a three mile STRAIGHT UP hike, winding around the Verdugo Mountains. It's home of the Verdugo 10k run (yes, people actually run it). You get shade when the trail wraps behind a hill and the views of the city at the top are gorgeous. I won't tell you how quick people run this trail, but depending on how fast you hike, I would allow up to 2.5 hours.

Solstice Canyon. (Solstice Canyon Hiking Trail Parking, Malibu)

Unlike all of the other hikes, you can actually loop back round on this one, but this takes you up a pretty steep hill before descending to a small river, following the road back to the car park. The trail is mostly tarmaced but you're pretty exposed to the sun. When you get to

the Robert's Ranch you're at the end - the house was designed by architect Paul Revere Williams, African American member of the American Institute of Architects, in 1952.

Nicholas Flat

(Leo Carillo State Park) This is a very cool (and pretty easy) hike! The trail takes you through some kind-of fields then past a pretty lake before ascending through a shady path. The view of the ocean you get at the end of this hike is completely spectacular.

Wisdom Tree (Hollywood)

This Hollywood staple is short and sweet, providing panoramic views at a calm spot underneath a beautiful tree. To start the trail you need to walk

through a residential street but keep going up and you'll get there! It's very steep up and pretty rocky but you can do the whole hike in around 40 minutes.

Franklin Canyon Reservoir (Hollywood)

This is a hidden treasure very close to Hollywood. You'll often find people picnicking on the side of the reservoir, chilling in the sun. The trails go all over the place so you can really make your own path. Some of the trails take you through overgrown patches but they all meet up as far as I can tell so you can make it as long or short, easy or strenuous as you like.

Wildwood Canyon (Burbank)

This one is pretty similar to Verdugos... but with

less shade - almost zero shade. About five miles up and down, and you'll hit a missile tower at the top. This one is intense and only gets steeper as you go up... be warned!

Switzer Falls (Switzer Truck Trail, Altadena)

I love this hike! You're looking at a 40 minute drive from LA (out of traffic) but it's worth it. Switzer Falls has become my favorite hike around LA but if you're very afraid of heights it's not quite as fun. You'll need a parking ticket for this one (you can buy them in places like Big 5) which are very cheap for a year pass and work in multiple places. I'd leave approximately two hours for hiking, but you could explore all day if you want to.

England roar to victory in Third Test

ENGLAND roared back to form in fine fashion in Port Elizabeth this week, comprehensively outplaying South Africa to win the third Test by an innings and 53 runs.

Joe Root's men go 2-1 up with one match to play after delivering a classical Test performance.

They laid a solid foundation with the bat on the first day, then accelerated towards 500 on the second. After that, it was all about pressure with the ball.

It's a far cry from the start of the series, the first-Test defeat at Centurion, when everything was looking shambolic.

Since then, the victories in Cape Town and Port Elizabeth have been much more like it.

England were aided by the disarray of their hosts – this defeat was their seventh in eight Tests – but nonetheless England's top-to-bottom improvement will surely fill them with optimism for the year ahead.

The undoubted star of the show was England's young batting star, Ollie Pope, who hammered a peerless 135 and took six

catches in the field.

And after Pope's innings came the five-wicket haul of his fellow 22-year-old Dom Bess. For an off-spinner to have that sort of success against a team filled with right-handers is an excellent achievement.

England will move up to fourth in rankings, behind New Zealand, Australia and the top-placed India, with victory in the final Test that

starts at the Wanderers on Friday. Yet they are third in the newly formed World Test Championship and convincing wins in their next three series – in Sri Lanka in March and at home against West Indies and Pakistan next summer – will close the gap on the top two in that table – again India and Australia. If they do finish in the top two by the summer of 2021 they will play in the inaugural

Test Championship final which is expected to be at Lord's.

Asked about getting to the top of the Test rankings, England captain Root said: "That's the journey we're on. That's what we're planning to

think we're going to win that Test. Everyone put in a shift, everyone was diving around in the field, making sure when those chances came we were ready.

"That's the sort of attitude you need consistently if you want to keep improving and want to get to No 1 in the world. If we can harness that like we did this week, then we'll start to be more consistent."

We've got a really clear way of how we're trying to play the game," Root said. "There are a number of things we've looked

to address and improve on, and we're starting to see signs of that now. If that can continue then we'll continue to see good results, I'm sure."

Root was also pleased with the contribution of Mark Wood, the injury-plagued fast bowler who took three wickets in his first Test appearance in 11 months. "You look at his statistics and they don't necessarily make you turn your head," he said. "But watch when he bowls – the amount of wickets that fall at the other end, he's a brilliant partnership bowler."

'Toxic' United lose again

Manchester United's latest defeat has seen the atmosphere turn "toxic" at Old Trafford, says former midfielder Darren Fletcher.

Solskjaer's team were booed off the pitch after a 2-0 home defeat by Burnley left them six points off a Champions League spot.

"The scenes in the stadium weren't good," said Fletcher, a five-time Premier League winner with United.

"The chanting, the atmosphere really turned toxic for the first time."

On a bitterly disappointing night for United, goals by Chris Wood and Jay Rodriguez earned Burnley a first ever Premier League win

at Old Trafford.

Since Solskjaer was made permanent manager in March, United have lost more Premier League games (12) than they have won (11).

They are fifth in the table - a massive 30 points behind leaders Liverpool, who have two games in hand.

By the time Jonathan Moss blew the final whistle on Wednesday, thousands of United fans had already left Old Trafford.

Fletcher fears the atmosphere at Old Trafford could hurt United's younger players if it does not improve.

"At the minute you can see with every setback these youngsters are just sinking," he added on BBC Radio 5 Live.

"The scrutiny and the pressure that these kids are under - it was difficult for me coming into the team and I was surrounded by world-class players left, right and centre.

"These lads don't have that support network around them and they are really finding it difficult.

"It might make a few of them, but at the same time it will probably break a few of them as well, which is really disappointing."

During the game, fans vented their frustration with vitriolic chants against United's executive vice-chairman Ed Woodward and the club's owners the Glazer family.

Former United defender Rio Ferdinand labelled the night an "embarrassment" and urged those in charge of the club to take action.

"I can't defend this. What has been invested?" Ferdinand, who won six Premier League titles and one Champions League at United between 2002-2014, told BT Sport.

"These young kids now in schools around the country, they are not going to be wearing Manchester United shirts."

No negativity at Spurs, insists Dier

Tottenham midfielder Eric Dier has denied there is a negative atmosphere at the club under Jose Mourinho.

Spurs went three league games without a goal before beating Norwich in midweek and players are said to be unhappy with Mourinho's training methods.

"The spirit has always been one of this team's greatest strengths and I still think it is," Dier said.

"I think everybody has been training very well, training hard, enjoying themselves in the same way as always."

Mourinho replaced Mauricio Pochettino, who guided Spurs to the Champions League final and four successive top-four finishes, in November, with the club struggling in 14th place.

The former Chelsea

and Manchester United coach began his reign impressively with four wins in his first five matches and the team scored 16 goals in the process.

But after beating Brighton 2-1 on Boxing Day, they went four league matches without a win and in that period, top-scorer Harry Kane suffered a serious hamstring injury that required surgery and is likely to sideline him until April.

In addition, unsettled defender Danny Rose is said to have clashed with Mourinho after being left out of the matchday squad.

Dier, who joined Spurs from Sporting Lisbon in 2014, said: "Any club, when results aren't going well, is not a happy atmosphere. But it

definitely isn't a negative atmosphere."

One newspaper article claimed Mourinho's training resembled 'lower-league sessions', but England international Dier said: "Who is saying that? Maybe you lads know - I don't. Personally I have enjoyed it. I enjoy doing new things."

Club captain Hugo Lloris, who returned to action in the victory over Norwich after being out with an elbow injury since October, was also quick to dispel rumours of unrest.

"The atmosphere is great, we can feel all the players involved and ready to fight for the club, the new manager and his staff," he said.

"We cannot control everything you say outside but I can confirm the atmosphere is very positive."

Reds go marching on!

■ Late Firmino winner sees off spirited Wolves and leaves Liverpool 16 points clear

Liverpool's march to the Premier League title continued on Thursday as Roberto Firmino's late winner at Wolverhampton Wanderers gave them the victory that extends their lead at the top to 16 points with a game in hand.

Wolves can consider themselves unfortunate to be the victims of Liverpool's 22nd win in 23 league games after making life as uncomfortable as anyone has for Jurgen Klopp's side this season before Firmino ensured Liverpool took another significant step towards their first title in 30 years.

Reds captain Jordan Henderson headed them in front from Trent Alexander-Arnold's corner after eight minutes but Wolves drew level six minutes after the break when Raul Jimenez glanced in Adama Traore's cross.

It was the first goal Liverpool - who lost Sadio Mane to a muscle injury in the first half - had conceded in the league for more than 12 hours and it required

important saves from goalkeeper Alisson to keep out Traore and Jimenez as Wolves pressed.

Liverpool, as ever, carried a huge threat and Firmino drilled home the winner with six minutes left - although substitute Diogo Jota then wasted a glorious chance to give Wolves a point in stoppage time.

The Reds, who have won their past 14 league games, are the third team to go 40 games unbeaten in the Premier League.

Liverpool were arguably put under more pressure at a vibrant Molineux than at any

time in the Premier League this season - but the champions-elect did what champions do and found a way to get the job done.

After Wolves equalised, and with the dangerous Traore moving through the gears, there was the possibility that Liverpool could lose their first league game in more than a year.

This, however, is a team that has forgotten how to draw never mind lose and even though it came against the run of play, it was no great surprise when Firmino made the decisive late contribution.

Wolves manager Nuno Espirito Santo and his players understandably cut dejected figures at the final whistle, denied so late on as they pushed to become only the second team after Manchester United to take points off Liverpool this season.

When that disappointmentsubsides, they can look back with pride on a performance that produced further evidence of what has been rebuilt at this famous old club.

Substitute striker

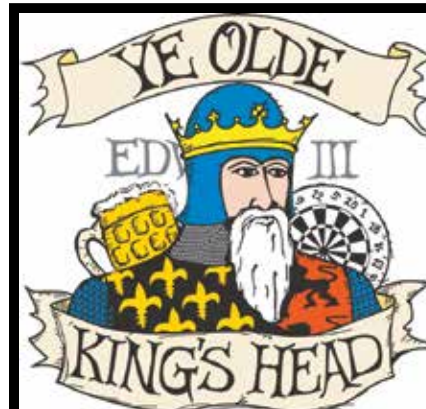
