■ Sajid Javid shocks Westminster with sudden departure
■ Exit follows rumors of tensions with key Boris aide

Sajid Javid has shocked Westminster by quitting as chancellor in the middle of Boris Johnson's cabinet reshuffle.

Mr Javid rejected the prime minister's order to fire his team of aides, saying "no self-respecting minister" could accept such a condition.

He has been replaced as chancellor by Chief Secretary to the Treasury Rishi Sunak - who just seven months ago was a junior housing minister.

Mr Javid had been due to deliver his first Budget in four weeks' time.

The former home secretary was appointed chancellor by Mr Johnson when he became prime minister in July.

His resignation follows rumours of tensions between Mr Javid and the prime minister's senior adviser Dominic Cummings.

Mr Javid said his advisers had worked "incredibly hard" and he could not agree to them being replaced.

"I felt I was left with no option but to resign," he said, adding that Mr Sunak and the rest of the government retained his "full support".

In his resignation letter, Mr Javid explained that he could not accept the PM's conditions saying: "I believe it is important

as leaders to have trusted teams that reflect the character and integrity that you would wish to be associated with."

Downing Street said there would now be a joint team of economic advisers for both the chancellor and prime minister.

Business Secretary Andrea Leadsom and Housing Minister Esther McVey are out of government

Environment Secretary Theresa Villiers is sacked and replaced by George Eustice, who resigned as a minister last year over Theresa May's Brexit plans
Attorney General

Geoffrey Cox was asked to resign by the PM. He is replaced by former Brexit Minister Suella Braverman

International Development Secretary Alok Sharma has been appointed business secretary and minister for the upcoming climate conference COP26, in Glasgow.

He is being replaced at the international development department by Armed Forces minister Anne-Marie Trevelyan.

There is a return to government for former Defence Secretary Penny Mordaunt, who becomes paymaster general.

Meanwhile, Mr Cleverly is made a joint minister in the Foreign Office and Department for International Development.

Cabinet members remaining in place include Home Secretary Priti Patel; Foreign Secretary Dominic Raab; Cabinet Office minister Michael Gove; Health Secretary Matt Hancock; International Trade Secretary Liz Truss; Transport Secretary Grant Shapps; Defence Secretary Ben Wallace and Leader of the House Jacob Rees-Mogg.

Boris gives greenlight to 10 freeports and HS2

IN A DRAMATIC move aimed at revitalizing Britain's struggling industrial towns, Boris Johnson has given the go-ahead for both the High Speed Rail Link (HS2) and ten 'freeports'.

The Prime Minister, who has vowed to repay the trust of the blue-collar voters who backed him at the general election, will introduce the special trading zones with the potential to create thousands of jobs and generate billions of pounds. The reforms will slash red tape and taxes, allowing goods to be imported, stored and exported without tariffs being imposed or the need for time-consuming paperwork to be filled out. Charges are imposed only if the goods are put into the domestic market. Component parts can be processed into goods in the free trading zones with duties paid only on the final product, which supporters say would boost manufacturing jobs and other types of employment locally.

Mr Johnson has also backed the high speed rail link - HS2 - between

London and the North.

Around £40million will additionally be pumped into pilots for new 5G mobile phone networks in rural areas as part of the investment to overhaul the UK's infrastructure.

Mr Johnson has held talks with Tory MPs who won seats in Labour's heartlands. One said the PM is giving "very positive responses" to their ideas and it is like "pushing at an open door" because he is keen to find ways to repay the support of voters in their areas.

'free trade zone'

Ministers have launched a consultation on plans to establish the freeports, which will be open for business once the Brexit transition period is over at the end of the year.

Though Brussels does not completely outlaw the free trade zones, its state aid and customs rules make it difficult to introduce. A number of port areas have been pushing for such "free trade zone" status following Brexit, including Tees Valley - a combined authority in the North-east that consists of Darlington, Hartlepool,

Middlesbrough, Redcar and Cleveland, plus Stockton-on-Tees.

The freeport concept will also be open to areas with airports.

Treasury minister Rishi Sunak said: "Freeports will unleash the potential in our proud historic ports, boosting and regenerating communities across the

UK as we level up.

"They will attract new businesses, spreading jobs, investment and opportunity to towns and cities up and down the country.

'ashamed'

"This is all part of our mission as an open, outward-looking country, championing global free trade with vibrant freeports that work for all of the UK."

Mr Johnson decided

to press ahead with HS2 despite fierce opposition by a significant number of his MPs. The high-speed link from London to Birmingham is believed to be safe, but other stretches can be reviewed.

Former leadership rival Jeremy Hunt urged him to "go full-speed ahead" on the complete route to and Leeds. The ex-Cabinet minister said he was "ashamed" of UK's rail network and it needs to be "sorted out".

Mr Hunt added: "I am a strong supporter of HS2 - I would go for HS3, HS4. As someone who lived in Japan, I have always been ashamed at the state of our railways.

"Nearly anywhere else you go in the world, they have decent railways, which have had proper investment.

"If we want to be a modern 21st-century country, it's time we sorted that out."

England set to introduce the T-level

■ Move aims to fill vocational job gap

A new vocational qualification, the T-level, is to be introduced in England in September 2020.

The move comes amid growing concern that too many young Britons are graduating with academic qualifications but are unable to find high paying jobs in the

private sector, amid a serious shortage of technical and trade workers - a gap in the market which has been filled by immigrants from poorer countries in recent years.

Aimed at 16 to 19-year-olds, T-levels will focus on practical, rather than academic subjects.

Courses will be introduced from September 2020 and last two years. They will include a mixture of classroom learning and on-the-job experience, with a work placement of at least 315 hours - about nine weeks.

Boris threat to US over Harry Dunn controversy

BORIS Johnson threatened to ignite a new row with the US this week by hinting at a bid to renegotiate our extradition treaty.

During a Commons clash with Labour leader Jeremy Corbyn, the PM conceded the rules on transferring suspects between the two countries were "unbalanced" against Britain. He spoke out over the continuing refusal of the US to extradite Anne Sacoolas, the intelligence officer's wife alleged to have killed motorcyclist Harry Dunn, 19, in a road smash.

Mr Corbyn claimed she was able to avoid facing a UK court over the allegation because of "lopsided" extradition arrangements. Mr Johnson replied:

"He has a point in his characterisation of our extradition arrangements with the United States. I do think that elements of that relationship are unbalanced, and it is certainly worth looking at.

"But that is totally different from the case of Harry Dunn and Anne Sacoolas. We continue to seek the extradition of Anne Sacoolas."

Mr Corbyn also pressed the PM over reports that the US was resisting extradition because Sacoolas, 42, was a CIA spy. She is charged with causing death by dangerous driving. Mr Dunn died in a crash with a car outside a US base in Northamptonshire in August. The Foreign Office has rejected Mr Dunn's family's calls for a public inquiry into the case.

Brighton cub scout leader named as Coronavirus 'super-spreader'

THE "super-spreader" at the centre of Britain's coronavirus outbreak broke his silence this week as friends claimed he feared being made a national scapegoat.

From his quarantine hospital bed Cub Scouts leader Steve Walsh, 53, who is thought to have infected at least 11 people in a fortnight, said he acted immediately once he thought he had the killer virus.

The father of two, who has made a full recovery, said: "As soon as I knew I had been exposed to a confirmed case of coronavirus, I contacted my GP, NHS 111 and Public Health England.

"I was advised to attend an isolated room at hospital, despite showing no symptoms, and subsequently self-isolated at home.

"When the diagnosis

was confirmed, I was sent to an isolation unit in hospital where I remain, and, as a precaution, my family was also asked to isolate themselves."

Gas sales executive Steve caught the virus at a Singapore conference last month before going skiing in the Alps and returning home.

He said: "I would like to thank the NHS for their help and care.

"Whilst I have fully recovered, my thoughts are with others who have contracted coronavirus.

"I also thank friends, family and colleagues for their support during recent weeks."

Steve, who lives in Hove, East Sussex, with wife Catherine and two children, is known as Shere Khan at the local Cub Scout group where he

is assistant leader.

This week the family's £350,000 semi-detached home was being guarded by private security staff.

Neighbours said Steve had broken his silence because he feared he and his family would be blamed for the crisis.

One, author Ian Henshall, 59, said: "I've spoken to his wife Cathy directly and to Steve by email and they are absolutely terrified of being made scapegoats, which would be totally unfair.

"They are a lovely family and Cathy is hoping he will be able to leave isolation and come

home soon."

Steve caught the virus at Singapore's Grand Hyatt hotel, then went to Les Contamines-Montjoie, in south-east France, for a ski break with friends Bob and Catriona Saynor, who own the chalet where 11 people were exposed to the virus.

The Saynors and their son, nine, are now believed to have the virus.

Steve then flew from Geneva to London with easyJet along with 100-plus passengers and crew before going to his local pub The Brigadier, in Hove, and a group yoga session in a church hall.

After he heard he had been in contact with someone with coronavirus, he drove to the Royal Sussex Hospital, Brighton. After the virus was diagnosed, he was taken to London's Guys and St Thomas' Hospital, where he is in quarantine.

A spokesman for his employer, Servomex, of Crowborough, East Sussex, said: "We are very pleased that Steve Walsh has made a full recovery. "We are working with public health authorities to ensure the welfare of our staff and communities and wish anyone with the virus a quick and full recovery."

can currently choose between thousands of different courses and qualifications. The government says T-levels will make things less confusing for students and employers.

T-level students will have a range of subjects to choose from, including accountancy, catering, finance, hair and beauty and manufacturing.

Those who successfully complete their course will be awarded one of four overall grades, ranging from a distinction* to a pass. They will receive a nationally recognised certificate showing their overall grade and listing what they have achieved.

T-levels are being introduced in England

only. For the rest of the UK, Btecs (available across the UK), NVQs (available in England, Wales and Northern Ireland) and other vocational courses like Scottish Vocational Qualifications (SVQs) will continue to apply.

T-levels are aimed at students seeking an alternative to A-levels.

They are also targeted at those who do not wish to take an apprenticeship, which usually requires 80% of a student's time to be spent with an employer.

Instead, T-levels will offer a mix of classroom study and technical training, and subjects, such as maths, English and digital skills.

At present, about half of qualifications awarded to 16 to 18-year-olds in England are for vocational courses, like Btecs and City & Guilds.

Britain battered by 'Storm of the Century'

■ Storm Ciara causes misery across the UK - with five more 'weather bombs' on the way

EVERY part of Britain was battered this week by its most devastating storm in years. And worse is to come with five more "weather bombs" set to hit British shores by next month.

Storm Ciara blasted the coast with near-100mph gales, while inland 70mph gusts tore down cranes, trees, rooftops and even football stadium stands. A "risk to life" warning was issued on Monday Ciara brought more gale-force winds, snow and heavy downpours.

The Met Office's Helen Roberts said Storm Ciara could be the worst this century. She said: "It's definitely the biggest storm in seven years and in terms of area affected it's probably the biggest this century." Storms Dennis, Ellen and Francis will hit in the next two weeks and two more will arrive by March.

Meteorologist John Hammond said: "Ciara is a violent start to a very wild spell."

Monday's highest wind speed was 97mph on the Isle of Wight. Gusts of 93mph hit Aberdaron, North Wales.

Dennis was set to hit on Valentine's Day after press time, with extreme North Atlantic weather ravaging the west coast before Ellen strikes on Sunday. The Met Office said the February storms come from a "super-charged, high-altitude Atlantic jet-stream wind firing tempests at Britain".

It said: "Unsettled conditions are expected to dominate to February 21.

"It stays windy early next week and turns colder. The strongest winds are expected in the West. Snow is likely in the North.

"February 21 to March 6 can expect rain and strong winds at first, perhaps becoming more settled through late February and early March."

The weekend storms disrupted Sunday sport. Horse racing, rugby and football fixtures, including the Premier League clash between Manchester City and West Ham, were postponed. Three people were injured after part of a pub roof collapsed in Perth and a tree fell on to a car in Flitwick, Beds. Flights were cancelled and some rail companies urged people not to travel.

In a dramatic rescue, firefighters in Blackpool pulled out a motorist whose car got stuck in deep floodwater. Cumbria saw six inches of rain in 24 hours. The town of Appleby-in-

Westmorland was hit by severe flooding as the River Eden burst its banks. People waded

through thigh-deep water in Hebden Bridge, West Yorks, the town of Mytholmroyd was largely under water and the Humber Bridge was closed for only the second time in its history.

'Idiots' saved from ice hell on Ben Nevis ...in trainers

HEROIC mountain rescuers have blasted four students who tried to walk up Ben Nevis in a snow and lightning storm wearing trainers as "absolute idiots".

More than 20 volunteers and a helicopter crew put themselves at risk saving the group after they got trapped in temperatures of -20C (4F) at the height of Storm Ciara.

The four had set out to tackle Britain's highest peak in atrocious weather with no proper clothing, no climbing gear such as ice axes or crampons and no maps - possibly in a quest to take selfies.

They became separated and stranded and would certainly have died had they not been located by selfless rescuers - who said the foursome's

actions were "up there" with the stupidest ever seen. It is believed the four managed to get a phone signal and used an app to raise the alarm, which brought 22 members of the Lochaber Mountain Team out to look for them.

Rescue members used the app What3Words - which works as a user friendly GPS - layering three simple words over just about any location on the planet, to find the group on Monday night.

The team found all the lost walkers - believed to be foreign students living in Glasgow - huddled on a ridge of steep ice and brought them halfway down the 4,413ft mountain. There they were loaded aboard a Coastguard helicopter

and airlifted to hospital in the nearby town of Fort William, which is used as a base by many climbers. Later rescue team leader John Stevenson blasted the four, who had taken a taxi to the mountain from Fort William and may have set off up a summer tourist path oblivious to the danger.

John said: "They were absolute idiots. They were all wearing trainers and decided to walk up Ben Nevis in those conditions. They were just plain stupid."

"As far as stupidity goes this is right up there for the rescues we have ever carried out.

"They weren't climbing, just walking, but I don't think they even made the summit. They were poorly equipped for

any weather.

"We don't know why these four were up there but if it was to get a selfie it would have been a foolhardy thing to do - and could have been extremely costly."

John said the weather was so bad that after the airlift the helicopter was unable to return to its base in Inverness 70 miles away.

He added: "These guys didn't have a scooby. It really is maddening. Two of them are particularly bad from the cold. All four would have never survived the night up there. They are lucky to be alive and that we found them."

All four were being treated for the effects of the cold in Fort William's Belford Hospital.

Woman who tried to open Jet2 aircraft door in mid-flight is jailed

■ Court told Chloe Haines “blacked out and didn’t really remember what happened” during budget flight to Turkey

A woman who tried to open a plane’s emergency door in mid-air while yelling: “I’m going to kill you all” has been jailed for two years.

Passengers on the Jet2 flight to Dalaman in Turkey said they feared they were going to die as Chloe Haines lunged at a door handle.

Cabin crew and passengers tried to restrain her as she kicked and shouted. Two fighter jets were scrambled to

through the hearing and as she was led to the cells.

Judge Charles Gratwicke said: “Those that are trapped in the confined space of the aircraft will inevitably be distressed, frightened and petrified by the actions of those who in a drunken state endanger their lives.”

‘I want to die’

The court was told that Haines said she “blacked out and didn’t

cope with any further emergency.

Haines had been convicted of drink-driving and assaulting an emergency worker last April.

Oliver Saxby, QC, said in mitigation that Haines had had a mental illness diagnosed and had not touched alcohol since the incident. “She wasn’t just drunk,” he said. “She was unwell. She’s appalled, she’s ashamed, she’s deeply embarrassed by what

escort the aircraft back to Stansted airport last June. Chelmsford crown court was told that it had cost the airline £86,000.

‘drunken state’

Prosecutors said that passengers did not know that it was impossible to open the door in mid-flight and one had said: “I thought I was going to die.” Haines, 26, from High Wycombe, Buckinghamshire, pleaded guilty at a hearing in December to endangering the safety of an aircraft and assaulting a member of the cabin crew. She wept

really remember what happened” after mixing alcohol with medication.

Michael Crimp, for the prosecution, said that she had been drinking before the flight. A passenger claimed that Haines was drinking from a bottle she had stored in the overhead locker. A partly drunk bottle of gin was found in a duty-free bag.

She shouted: “I want to die,” as she was restrained.

Mr Crimp said the risk arose from all the cabin crew having to deal with the incident, leaving them unable to

Mr Saxby said that Haines was unemployed with no savings.

Steve Heapy, the chief executive of Jet2.com and Jet2holidays, said: “[This] was one of the most serious cases of disruptive passenger behaviour that we have experienced, and we have banned her from flying with us for life.”

He added that the airline had been trying to tackle excess drinking in the airport before flying and the illegal consumption of duty-free alcohol on board flights.

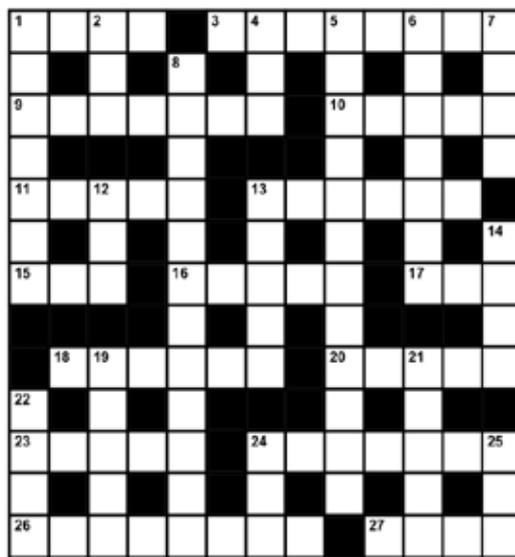

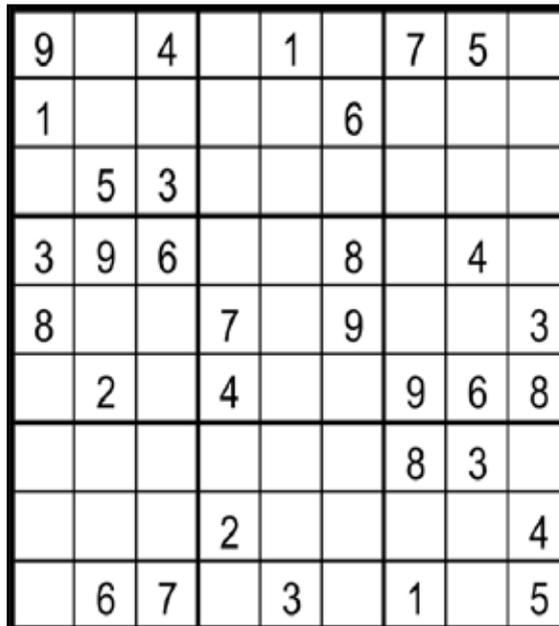

England in South Africa: Eoin Morgan says his team have 'lessons to learn'

England have plenty to learn in the run-up to the Twenty20 World Cup after their one-run defeat by South Africa, according to captain Eoin Morgan.

The tourists failed to chase 178 in the first of a three-match series in East London.

"We should be winning that 10 times out of 10," Morgan told the Test Match Special podcast.

"It's about learning, going through a process we've gone through over a number of years to try to get better."

After winning the 50-over World Cup last July, England will look to become the first men's side to hold both global limited-overs trophies simultaneously at the T20 World Cup in Australia in October and November.

On Wednesday they

recovered from a poor start with the ball and in the field to limit the home side to 177-8.

They were coasting the chase when Jason Roy was making 70 from 38 balls, only to lose three wickets in four overs.

Even then, Morgan's 52 took them to needing seven from seven balls, before the captain was caught at long-on from the final delivery of the 19th over.

"Getting out off the last ball of the 19th over was horrifically bad for me, given my experience and how many games I've played," said the Irishman.

from the only ball he faced, the last ball of the match.

He was run out coming back for a second that would have forced a super over, leaving England with their first one-run defeat in a T20 international.

"I know recently we've played in a lot of tight games, but we want to play in as many of these as we can because we want guys exposed to as much pressure as they can be," Morgan added.

"You cannot replicate the pressure you'd have in the World Cup, but in situations like that we have to find a way to get over the line."

Morgan also defended the omission of batsman Dawid Malan, who made a century in his last T20 international in New Zealand in November, likening it to the time Jonny Bairstow spent time out of the one-day team before forcing his way into the World Cup-winning side.

"Malan is an exceptional player and given the success of the white-ball team over a short period of time, he's a bit of a victim of that," said Morgan.

"Dawid has done absolutely everything he needs to do to be in the squad. He just needs to wait for an opportunity and hopefully take that."

"There is extreme competition for places and for captain, coach, the whole team, it's a very healthy sign."

Nuno Espirito Santo says Wolverhampton Wanderers "is my life" but revealed he has had no talks about a new contract.

The Portuguese coach, appointed in May 2017, signed a new deal last July, committing him to the Premier League club until 2021.

Wolves are ninth in the Premier League under Nuno, who took them to promotion from the Championship in 2018.

"I have not had a proposal. I have one year more of my contract and I don't think about that," he said.

"When you sign something, you stick to it or you don't."

Not only are Wolves competing in the top half of the table this season but they are also into the knockout rounds of the Europa League - they take on Espanyol in the last 32 later this month. Nuno, 46, was linked

with Arsenal following Unai Emery's sacking in November, but he has moved to allay fan concerns that he could move on in the near future.

"I am happy with the group of players we have and the way we work," he added.

"They [the fans] can be assured that every day, this is my obsession. Wolves is my obsession. It is my life. I don't think about anything else."

■ **£100m-rated Dortmund star expected to move to England's top flight next season**

Manchester United and Chelsea are in a fierce battle to bring Jadon Sancho to the English Premier League.

The Borussia Dortmund star will command a £100 million price tag and United are thought to be in the box seat for the English international, who has enjoyed a stellar season for both club and country.

Sancho took a huge gamble to call it quits at Manchester City aged just 17, choosing to leave the shores of England to join the German giants. Nearly three years on, and the decision has paid off handsomely, with the teenage sensation paving the way for several other English youngsters to pursue their careers overseas.

The 19-year-old has been in stunning form

wide areas last summer by signing Daniel James from Swansea City. However, the Red Devils still lack a consistent option for the right wing slot, someone who could provide a genuine creative and goalscoring threat from the right side of the attack.

This is where Sancho comes in. The English international has proved himself in both the demanding world of the Bundesliga and in a series of eye-catching performances for the Three Lions.

by Lampard following Chelsea's transfer ban.

The Premier League side were linked with a number of signings in January, including Paris St-Germain forward Edinson Cavani and Napoli striker Dries Mertens.

Lampard's apparent frustration with a lack of new arrivals is understood to have stemmed from clubs refusing to sell rather than any problems with Chelsea's recruitment strategy.

Ziyech contributed to three Ajax goals in a 4-4 draw against Chelsea during their Champions League group game in November.

The most memorable came when the winger's free-kick from near the corner flag curled over Kepa Arrizabalaga's head and hit the far post before rebounding in off
