# FEARS RISE AS BRITISH COVID-19 CASES DOUBLE

**PM unveils nationwide battle plan as country sees first fatality**  
**Elderly care a priority • Army on standby • New powers to control borders**

**BRITAIN** was on full alert this week after the number of recorded coronavirus cases soared to 116 and the nation saw its first fatality from the disease.

Boris Johnson unveiled a national epidemic battle plan, acknowledging a looming "national challenge", the Prime Minister promised he would prioritize care for the elderly and vulnerable. The NHS has declared the outbreak a level four emergency which is the highest warning that can be issued, while Government medics warned the chances of dying from the flu-like disease "ramps up" for the over-80s.

At the height of an epidemic, up to one in five workers could be off sick, Mr Johnson's plan says.

Intensive care units have been ordered to make urgent checks for Covid-19 cases among patients amid fears the virus could be already present and spreading among the most vulnerable.

NHS trusts warned that if the outbreak grows they may have to use all wards to treat victims, who are currently in isolation.

The 28-page battle plan also puts the Armed Forces on standby "to provide support to civil authorities if requested".

### 'national challenge'

Police could be forced to focus only on serious crimes and maintaining public order if force numbers are squeezed by illness. Sweeping new powers will also allow border guards at UK ports and airports to force arriving travellers to test for Covid-19 and detain and isolate any who refuse.

A TV and social media blitz urging people to wash hands regularly was launched on Tuesday.

Flanked by his scientific and medical advisers, the Prime Minister said at Downing

Street: "I do think this is a national challenge. "The potential is there for this to be something that our country has to get through. But I've got absolutely no doubt that we have the resources or the health service - we've got the expertise to do it.

"I'm very confident that the British public can see exactly what the balance of risk is. I think they are getting a very clear picture of how we need to behave and I think we will get through it."

Mr Johnson said the Government would be "prioritising the needs of the vulnerable and the elderly" because data shows they are most at risk of dying from the virus. England's chief medical officer Professor Chris Whitty said: "There is a significant ramp up in the risk of people dying of this infection once they get over 80.

"The exact percentages will depend on a lot of

factors including the health care system you have in place." But, Prof Whitty stressed, the Covid-19 mortality rate was still low, even in high-risk groups. He said: "If you look at the Chinese data, if you take the very oldest people, the great majority survive."

### "bedside test"

Government medics are confident a UK worst-case scenario prediction of 500,000 dying from coronavirus is far too high and an "unhelpful" estimate. Five hundred more NHS 111 helpline

handlers have been recruited to deal with questions.

Health Secretary Matt Hancock told MPs on Tuesday: "Our approach is to plan for the worst and work for the best."

The latests cases include residents of London, Hampshire, Northants, Bury, Wirral, Greater Manchester, Humberside and Kent. Prof Whitty said eight of those patients had recently travelled from Italy, one from Germany, one from Singapore, one from Japan and one from Iran. Mr Hancock

said the Government was "currently engaged with more than a dozen companies to try to come up with a bedside test" for Covid-19.

A Whitehall source said the military would be deployed only to cover security at nuclear plants and other key sites.

Meanwhile Mr Johnson insisted he had not given up shaking hands with visitors.

He said: "I visited a hospital the other night where there were a few coronavirus patients. I shook hands with everybody."

# She's Priti fantastic!

■ Boris gets behind embattled home secretary as top aide quits over her 'vicious' behaviour

THE Prime Minister this week confirmed he "absolutely" trusts Priti Patel following allegations that the Home Secretary led a campaign to oust her chief civil servant.

Boris Johnson and other senior Tories rallied to defend Ms Patel after Sir Philip Rutnam quit the Home Office accusing her of "vicious" behaviour.

Party figures insisted Ms Patel was "determined" to shake up the Whitehall department but rejected claims of bullying against her.

Mr Johnson said: "I absolutely do have confidence in Priti Patel. I think she is a fantastic Home Secretary.

"It is never an easy job, as anyone who has been Home Secretary will testify. It is one of the toughest jobs in Government.

"There is a big, big task ahead of us now. We are delivering, at last, a new immigration system. That will take a lot of work by the Home Office, a fantastic department."

Ms Patel has been under fire since Sir Philip resigned on Saturday.

He claimed a "vicious and orchestrated briefing campaign" had been run against him by ministers and threatened to launch a legal action for constructive dismissal. The outgoing permanent secretary also claimed to have received reports of her "shouting and swearing, belittling people, making unreasonable and repeated demands".

Health Secretary Matt Hancock defended her on Monday, saying: "Priti is a very determined Home Secretary. In every dealing I've had with

her she has been very courteous."

Former Tory transport minister Nusrat Ghani suggested she may have ruffled male mandarins. She said: "I do think it's

curious that if you're providing leadership, if you're determined, working at a fantastic pace, that in men that is seen as a fantastic skill and for women sometimes it's

seen as challenging." Labour leadership candidate Sir Keir Starmer said: "The Home Secretary has a duty to come to Parliament to explain the allegations."

## NHS a red line in US negotiations, insists Truss

BRITAIN is willing to walk away from trade talks with the US if that is what it takes to protect the NHS, International Trade Secretary Liz Truss said on Monday.

The health service will "not be on the table" during talks, due to start this month, a document published by the Department for International Trade confirmed. And the Government will not be compromising on environmental protection, animal welfare and food

standards.

Ms Truss told Sky News: "We want a deal with the EU on Canada-style terms. If we have to trade with the EU on Australia-style terms, we will. Likewise with the US - we want to get a deal as soon as possible, but we're certainly not going to sell out the NHS.

"That's a very clear red line. We're not going to allow drugs to cost more on the NHS and we're not going to sell out our food safety and animal welfare standards.

"We'll walk away if it is not a deal that suits the UK because one of the key reasons people voted to leave the EU was to have control over their own rules and regulations."

The paper acknowledged concerns about US chlorine-washed chicken and hormone-fed beef. It said: "Ensure high standards and protections for UK consumers and workers and build on our existing international obligations.

"This will include not compromising on our

high environmental protection, animal welfare and food standards."

The Government has

estimated a US trade deal would boost Britain's economy by £3.4 billion over the next 15 years.

US ambassador to the

UK Woody Johnson welcomed the 184-page document, adding: "Lots of work to do - let's get started."

## Berkshire woman named as first British coronavirus fatality

A woman with underlying health conditions has become the first person in the UK to die after testing positive for coronavirus.

The Royal Berkshire NHS Trust said the patient, understood to be in her 70s, had been "in and out of hospital for non-coronavirus reasons".

She was admitted and tested positive for coronavirus on Wednesday.

**'highly likely'**

It comes as the number of UK people diagnosed with the virus reached 116, a rise of more than 30 in 24 hours.

Meanwhile, the prime minister's official spokesman said it was "highly likely the virus

is going to spread in a significant way".

The woman, who was being treated at the Royal Berkshire Hospital in Reading, is believed to have caught the virus in the UK, said the country's chief medical adviser Prof Chris Whitty.

**'sympathies'**

She is not thought to have been abroad recently. Officials are now trying to trace the people she was in contact with.

Prof Whitty offered his sincere condolences to her family and friends and asked that their request for privacy is respected.

Prime Minister Boris Johnson also said "his sympathies are with the victim and their family".

Mr Johnson reiterated that the UK was "still in the contain phase" - the first stage of the government's response to the outbreak.

He said scientists and medical staff are making preparations for the next phase - the "delay" phase.

According to the latest government figures, as of 9:00 GMT on Thursday there were 115 cases across the UK. Another case was later confirmed in Wales.

The UK cases include 105 patients in England as well as six in Scotland, three in Northern Ireland and two in Wales.

Alder Hey Hospital in Liverpool confirmed a child there had tested positive for coronavirus. It is not known how old the child is.

# Commuters get creative to avoid the lurgy

■ With masks impossible find, Londoners get creative to stay safe in public spaces

**PANICKING** commuters in London have resorted to wearing storage boxes and plastic bags over their heads as they come up with novel ways to avoid contracting coronavirus.

Photos, circulated on social media, show people coming up with creative ways of covering their noses and mouths in a bid to avoid contamination, as medical experts warn surgical face masks are ineffective at keeping the virus at bay.

One train passenger in a heavy-duty gas mask was spotted on the platform at Milton

Keynes station, while a Londoner adopted the

same approach on the Tube. Others adopted more rudimentary protection. A woman was seen on a bus with a plastic storage container over her head while a man was spotted wearing a shopping bag.

## 'little protection'

Dr Stephen Griffin, of the University of Leeds, said: "Standard face masks provide relatively little protection from respiratory aerosols – they can stop larger droplets and some studies have estimated a five-fold protection versus no barrier alone."

Two British men have reportedly been arrested in Morocco trying to

smuggle face masks back to the UK. A lorry driver was caught with 100,000 face masks with an estimated value of £2.6million. In a separate incident another Briton was arrested at Agadir Airport attempting to fly to Britain with 17,000 face masks.

## Panic buying begins as fears grow

**PANIC** buyers have begun to strip supermarket shelves in the UK amid growing fears over the coronavirus outbreak.

Despite government reassurances, supermarkets reported shoppers seemingly starting to stockpile items such as toilet roll, pet food, pasta, rice, nappies – as well as booze. Sales of hand sanitizer in supermarkets have tripled in a month. Some stores have started to run out of the sanitizer – which costs 50p in Lidl but was this week spotted for sale on eBay for £40 – as well as face masks. Some Boots stores have limited hand gels to two per customer. Ocado sold out of it amid bulk buying. The online supermarket warned that people were putting in large orders meaning there could be delivery delays. But the Government's chief scientific adviser Sir Patrick Vallance said: "There is absolutely no reason to be panic buying or keeping large supplies of things."

"There have been a number of competing offers in excess of £1billion. I have no doubt such offers will be considered so that the Ritz is sold at the right time and for a proper price."

# Meghan livened up dull royals and her critics are racist, says Hilary Mantel

AWARD-WINNING author Dame Hilary Mantel sparked controversy this week after suggesting the Duchess of Sussex had been on the receiving end of "abominable racism".

Prince Harry, 35, and Meghan, 38, announced last month that they were quitting royal life and splitting their time between the UK and North America.

Booker Prize-winner Dame Hilary, 67, told April's issue of Harper's Bazaar:

"I'm pleased that it's the marriage that's surviving and the connection with the monarchy that has to go, because I think almost all of us would have bet that if she [Meghan] left, she'd have to leave alone. Though, none of us know the details of how this is going to work out.

"But I think that Meghan was too good to be true.

"She was a smiling face

in a dull institution, she cheered the nation up no end, or at least men and women of good will.

"I do think abominable racism has been involved. People who say that's got nothing to do with it – well, they need to check their privilege!"

The novelist's comments come as *The Mirror* and *The Light*, the final part of her trilogy about the life of Henry VIII's adviser Thomas Cromwell went on sale this week.

And Dame Hilary says the scrutiny Meghan has faced since becoming a royal wife goes back centuries.

She said: "There's an intense concentration on the bodies of royal women.

"If anyone doubts that, we only have to look at what happens when our royal ladies are pregnant and when they give birth.

"They are perceived as public property in the same way that Tudor women were perceived."

In a blistering attack in 2016, months after their relationship became

public, Prince Harry said media coverage of his future wife had "racial undertones". Novelist Sir Philip Pullman claimed Meghan had become a target "because she's

black".

It is not the first time Dame Hilary has courted controversy with comments about the Royal Family. In 2013 she said the Duchess of

Cambridge was forced to present herself publicly as a personality free "shop window mannequin" whose sole purpose is to deliver an heir to the throne.

Dame Helen, who has said she wants to replace the word "beauty" with "character" was promoting L'Oreal Paris' Age Perfect Cosmetics

in Beverly Hills. She has represented the brand for six years. And the star gave a glimpse of her formidable acting technique when she said she likes to experiment and "spend many hours in the mirror finding the best ways to get into character".

The Prime Suspect star sees no problem representing a cosmetics giant but said last year: "I think we should start calling it 'character' instead of beauty, because that's really what it is."

The actress has enjoyed more than a half a century on stage and screen.

Celebrity chef Ainsley Harriott has received his MBE from Prince Charles at Buckingham Palace.

The TV presenter said the honour, for services to broadcasting and to the culinary arts, was "very special".

The 63-year-old has been offering cooking tips on the TV for almost 30 years on show like *Can't Cook, Won't Cook*, and *Ready Steady Cook*.

It came in the week that *Ready Steady Cook*

returned after a decade away, with Rylan Clark-Neal taking over as host.

"As a presenter I like what he does," Harriott said of his successor. "I think he engages with people. He's very warm, he's got a relaxed style, so I'm sure that's going to work."

Harriott said he would continue with a career built on making cookery more accessible to the public.

"I think it's kind of bringing food to people

who perhaps a little bit shied away from it, [were] a little bit embarrassed about it," he said.

Harriott was recognised alongside actress Maureen Beattie OBE and The Priests, a trio of singing clergymen, who were also given MBEs.

England netball captain Serena Guthrie was given the same honour, while trainer Nicky Henderson was made an OBE for services to horse racing.

# Genesis to reunite for UK shows next winter

The British prog rock band Genesis have announced that they will reunite for a series of UK stadium shows in November and December.

"There's a Genesis sound which is still there," said guitarist Mike Rutherford. "I missed it, it's nice to play it again."

The group announced the Last Domino tour on Zoe Ball's BBC Radio 2 breakfast show this week. Rutherford said: "It feels great, it feels the right time, we're looking forward to doing it. A lot of our contemporaries have been playing a lot – we've done two shows in the UK in the last 28

years."

The group said that they would be joined by Phil Collins' 18-year-old son Nicholas on drums for the shows. "He plays like me and he kind of has the same attitude as me," said Collins. "So that was a good starter."

Quizzed on the potential setlist, Collins said: "There are songs you feel you have to play because the audience would feel cheated if you didn't, then it's a question of putting the rest of the stuff together from songs we haven't played for a long time."

Ahead of their appearance on BBC Radio 2, the band posted a clue

to their Instagram page, reading: "And then there were three". The group last played together in 2007, their first tour with drummer Phil Collins in 14 years, and have faced constant speculation about the possibility of a reunion in the intervening years. In January, the trio were spotted at a New York Knicks game at Madison Square Garden, sparking renewed rumours.

Genesis formed at Charterhouse school in Surrey in 1967, and enjoyed cult success until the early 1970s, when their fourth album, *Foxtrot*, became their highest-charting release,

and a theatrical tour stoked their reputation.

They reached a creative peak with the 1974 album *The Lamb Lies Down on Broadway*, which would be their last with Peter Gabriel. He left in 1975, at the end of an even more elaborate tour for the record, and embarked on a highly influential solo career.

Their progressive origins would gradually smooth into a more generic pop sound. Following Gabriel's departure, Phil Collins took over as lead singer,

and Genesis achieved them as the trio of Collins, Rutherford and Banks.

It is estimated that Genesis have sold between 100 and 150m albums worldwide.

# Millions talk like me because of TV's Thomas, says Ringo

SIR Ringo Starr says he inspired a global increase in Scouse accents – after millions of children heard him narrate *Thomas The Tank Engine*.

The Beatles drummer, 79, claims his voice has been mimicked by people all over the world, who grew up listening to him on the beloved TV series. Ringo even said he meets fans of the show, now in their 20s, 30s and 40s, who boast a faux Liverpool accent.

He said: "People have

held all these kids up to me saying that he or she loves Thomas. And my plan was when we first started in England, when I just narrated the stories, I thought all these kids would grow up talking like that, saying, 'Alright, what is for dinner?'

"I thought they would all have a Liverpool accent. And some of them did, according to their parents."

Ringo was the first narrator of the *Thomas And Friends* television programme, from 1984 to 1986 for the British

broadcast, and from 1989 to 1990 in the US. The show remains one of the most successful children's franchises in history, with a huge line of merchandising and worldwide syndication. But Ringo's first love will always be his music, having spent more than six decades as a drummer. He recently recalled: "My mother always said, 'Son, you're always at your happiest when you're playing your drums.' It's a lot of joy, when I play, in my heart."

They try to up each other by competing to see whose kid sat up first, who hit all their milestones and whose kid said their ABC's fresh out of the womb. It is bloomin' exhausting.

To add more pressure on us already weary mums, things like "you must cloth diaper", or "breast feed only" or "make all meals from scratch" are thrown at you. One person even told me I was psychologically scarring my children by letting them watch television. The British in me said "Oh really?" and the British inside me was saying something a lot less PG rated.

### 'chilled out'

In England most of my family and friends are all about "I've got your back" or "just do what you are doing as you know what's best for your family". Therefore even if you feel like you are failing as a parent they bring you back up and go make you a nice cup of tea. Which is why I've found mostly my British mum friends in LA are noncompetitive and chilled out when it

# Cup in hand, Pep hails City's domestic dominance

Manchester City's recent dominance of English competitions is unrivalled, says manager Pep Guardiola after winning a third successive Carabao Cup on Sunday.

Goals from Sergio Aguero and Rodri before Mbwana Samatta's reply saw City beat Aston Villa 2-1 at Wembley.

On top of three League Cups, Guardiola has won two Premier Leagues, an FA Cup and two Community Shields with City.

"Since we started to win, the last nine [domestic] competitions we played, we won eight," he told BBC Radio 5 Live.

"That is awesome. No club before in the history of domestic trophies, not counting Europe, won the amount of titles in a row we have won.

"Not even the biggest Liverpool in the 80s, the biggest Manchester

United with Sir Alex Ferguson or Jose Mourinho, or Arsene Wenger [with Arsenal].

"These clubs were amazing but were never able to win in the last nine titles, domestic eight."

Liverpool won six league titles, two FA Cups and four successive League Cups in the 1980s, while United accumulated 13 Premier League titles including three in a row on two occasions under Ferguson, with Wenger guiding Arsenal to an unbeaten league season.

Guardiola, who joined Manchester City in 2016, led his side to the domestic treble of Premier League, FA Cup and League Cup last season, having also won the season-opening Community Shield.

The Spaniard says his side cannot compete for the title this year because Liverpool are "exceptional". but believes his players' desire to keep winning

trophies has made City a "big, big club".

"Never before we could go to Madrid, and Europe, and bigger stages and win the way we did,"

Guardiola said about his side's 2-1 victory

against Real Madrid in the Champions League last-16 first leg in the week.

"That doesn't mean we're going to qualify, but this is the first step. To believe we can go there and play, face-to-face, and

win it.

"This is more important than come the end of the season we won one title or two titles."

## "Dream" to score against Reds, says Barkley as Klopp's boys exit FA Cup

Ross Barkley said it was "a dream" to score against Liverpool as the midfielder helped Chelsea reach the quarter-finals of the FA Cup.

The 2-0 result on Tuesday meant Liverpool suffered their second successive defeat of this stellar season in a highly competitive encounter at Stamford Bridge.

Liverpool made seven changes to the side that lost surprisingly at Watford on Saturday - the first reverse of their league campaign after 18 successive victories left them on the brink of a first title for 30 years.

Chelsea, however, still had to overcome a Liverpool team containing the likes of Virgil van Dijk, Sadio Mane, Andy Robertson and Joe Gomez in a hard-fought fifth-round tie.

Liverpool goalkeeper Adrian gifted Willian Chelsea's opener after 13 minutes when he hopelessly fumbled his 20-yard shot, but the European champions had chances of their own only to see recalled keeper Kepa Arrizabalaga present a formidable barrier with a string of saves.

The game was effectively settled after 64 minutes when former Everton midfielder and Toffees fan Barkley surged from inside his own half on a solo run before beating Adrian with an emphatic strike.

"It was brilliant, a massive result for the lads," Barkley told BBC One. "We needed a top performance tonight at home after two disappointing results.

"Scoring against Liverpool is massive for me. As an Everton fan, it's always a dream to score

against them."

The hosts could have had more but Mason Mount rattled the crossbar with a 25-yard free-kick, before striker Olivier Giroud saw an effort brilliantly tipped on to the woodwork by Adrian.

Chelsea boss Frank Lampard will now have Wembley in his sights while Liverpool counterpart Jurgen Klopp returns to the task of wrapping up the Premier League title and overcoming a 1-0 deficit from the Champions League last-16 first leg against Atletico Madrid.

The tiny figure of Billy Gilmour looked like a boy among men at the heart of this FA Cup tie between two Premier League superpowers - but the 18-year-old Scot gave a performance that was huge in stature.

Gilmour, who has only

played six games with three starts and a total of 281 minutes, may be short on experience but he looked big on talent as his controlled, creative display deservedly won him the man-of-the-match award.

He glided around midfield, happy to take the ball in deep positions but also willing to make an impact further forward in the face of experienced opposition such as Fabinho.

This was a big victory for Chelsea and Frank Lampard.

Their Champions League hopes look all but over after a 3-0 home defeat in the home leg of the last-16 tie against Bayern Munich and they face a fight to finish in the top four - but they are at the heart of that battle and are now in the later stages of the FA Cup.

# Ighalo revels in United vindication

## FA CUP: Red Devils cruise to book sixth round berth

Manchester United striker Odion Ighalo says he "doesn't care what anybody says" about his surprise move to Old Trafford after his two goals ensured an all-Premier League FA Cup quarter-final line-up and comfortable 3-0 win at Derby County.

January signing Ighalo again showed why his shock acquisition in January may yet prove to be shrewd business with two smart finishes on Thursday to book a tie with Norwich at Carrow Road later this month.

The 30-year-old now has three goals from just two starts and he overshadowed a reunion with United's all-time leading goalscorer Wayne Rooney at Pride Park.

"As long as my teammates believe in me, the boss believes in me and the fans believe in me, I just have to keep going," Ighalo said.

"I don't care what anyone says. We want to keep the momentum going and make sure we do great this season."

Rooney had his name chanted throughout by the thousands of away

fans and came close with two fine free-kicks.

But from the moment left-back Luke Shaw's deflected opener flew in the Premier League side were able to cruise into the last eight.

Rooney scored 253 goals for Manchester United before leaving in 2017 and has still never scored against them throughout his career.

The 34-year-old twice went close from free-kicks though, twice denied by excellent saves from Sergio Romero.

Rooney, who led his new side in a pre-match huddle, has moved from the rampaging teenage striker who was compared to Pele at his 2004 peak to a deep-lying midfielder who started the last time United won this trophy in 2016.

For Derby he was in a similar midfield role, shielded from too much

running duties by the youth of Max Bird and Louie Sibley alongside him. The duo have a combined age of just 37 and were toddlers when Rooney was announcing himself on the world stage.

Despite a lack of mobility Rooney still remains an influence. Not only were his two free-kicks a threat, he was at the heart of their two other best second-half chances.

First, a sweeping 50-yard crossfield pass found Jayden Bogle, and his cross was headed wide by Martyn Waghorn. And then an even better ball from inside his own half released Rams sub Jack Marriott, but Romero was once again equal to the effort.

"Everyone loves Wayne, all the supporters at Manchester United appreciate what he did," said United boss Ole Gunnar Solskjaer.

## Premier League orders: no more handshakes

The Premier League has announced that the pre-match handshakes between both teams and officials will not take place until further notice because of fears over the spread of coronavirus.

The measure comes the day after the government asked the league "to step up its contingency planning".

The teams will still line up as usual but the home team will walk past the away side without shaking hands.

There have been more than 90,000 cases of the virus in 87 countries.

A statement on the Premier League's website said: "The

Premier League fair-play handshake will not take place between players and match officials from this weekend until further notice based on medical advice.

"Coronavirus is spread via droplets from the nose and mouth and can be transmitted on to the hands and passed on via a handshake."

Premier League leaders Liverpool announced on Thursday that they would not be having mascots at Anfield.

They have also cancelled staff travelling to any high-risk countries and "reminded everyone of good hygiene practices".

The club also said there

will be "hand sanitisers and/or antibacterial handwash in all the washrooms at Anfield" as well as hygiene information posters.

Last week Newcastle manager Steve Bruce said the club had stopped their morning handshake ritual while West Ham boss David Moyes said the players would be fist bumping instead of shaking hands.

Southampton also banned players from signing autographs or taking selfies with fans.

League One club Sunderland have also told their players to not go abroad during their upcoming break.
