



NHS: WE ARE READY FOR CORONAVIRUS THREAT

- Tenth Briton dies as confirmed cases approach 600
- Chancellor announces £5bn emergency NHS funding

NHS chiefs insist they are ready to face down the Covid-19 threat with checks being ramped up to allow as many as 10,000 people to be tested daily.

Labs across the country have been processing around 1,500 tests every day – but officials anticipate thousands more will soon need to be swabbed. The death toll in Britain rose to ten at press time on Thursday, with 596 confirmed cases. Deputy Chief Medical Officer for England Jenny Harries said “many thousands” more will be struck down within days. Cases in the UK are set to peak within a fortnight at which point the Government will order people to place themselves in quarantine.

Dr Harries said: “We will have significant numbers in a way which I think the country is not used to, so large numbers of the population will become infected.

“Within 10 to 14 days we will be likely to advise people with symptoms to self-isolate and we are expecting the start of the peak to come during that period.”

NHS hospital laboratories are now being drafted in to increase capacity in anticipation of soaring demand for testing. Ten NHS microbiology services have already made preparations to run more tests than usual and NHS pathology services will do so in the coming weeks.

‘good hygiene’

Seven regional co-ordination centres are also being set up to get results back to people as quickly as possible.

The vast majority of tests will continue to be turned around within 24 hours and people who test positive will be prioritised.

Professor Dame Sue Hill, NHS Chief Scientific Officer for England, said: “The NHS is ramping up the number of testing centres across the country, to help people get care quickly, or have their mind put at ease.

“The public can help

us to help the country to stay safe by practising good hygiene and washing their hands more often, for at least 20 seconds.”

Samples are being collected from people in their homes, in coronavirus pods, at GP surgeries, on hospital wards and at drive-thru centres.

Swabs are taken from the patient’s nose, throat or lungs. In some cases blood or stool samples are needed.

Professor Sharon Peacock, director of the National Infection Service, Public Health England, said: “Wider testing is important as it will help to manage demand as the number of people being tested increases in the coming weeks.

“This will ensure that PHE and the NHS have the most robust system possible to understand what is

happening with the virus.”

And in another sign of the seriousness of the situation, the NHS said student nurses will be called to the front line in the Covid-19 battle.

There is growing concern the epidemic crippling Italy could be seen in Britain. The country is now on lockdown with the death toll surging past 1,000 on Thursday.

Professor Giacomo Grasselli, who is leading the intensive care response in the worst hit Lombardy region, said: “The only way to win this battle is to

change the behavior of people.

“They have to stay at home, they have to avoid crowded places, they have to wash their hands.”

British Airways has cancelled all flights to and from Italy until April 4.

The Department for the Environment, Food and Rural Affairs said deliveries to supermarkets and retailers could now be made around-the-clock to prevent shortages sparked by panic buying.

And Downing Street said that authorities

had the power to order people to self-isolate if they refused to follow “sensible” advice to maintain public health.

And the NHS has been given a £5billion boost to give patients more time with their GPs and increase the nursing workforce.

Chancellor Rishi Sunak, announcing the funds in his first Budget, said the money will fund 50,000 more nurses, 50 million more GP appointments and start work on 40 new hospitals.

He said: “We promised to back the NHS and this budget gets it done.”

FTSE suffers largest fall since Black Monday as world markets tumble

Britain's benchmark share index has endured its worst day in more than three decades after panic over the coronavirus crisis increased the sell-off on global markets.

Apprehension over the Covid-19 pandemic on Thursday prompted the FTSE 100's largest daily fall since the aftermath of Black Monday in October 1987 and halted trading on Wall Street. "Everyone is selling everything," one London-based trader said.

While President Trump has promised "very major" stimulus, he heightened market concerns by implementing a ban on European travel to the United States and disappointed those who have been calling for broader measures to shore up the economy.

As global stocks tumbled into bear market territory, in London the FTSE 100 slumped to its lowest levels in almost eight years. The index closed down 639.04 points, or 10.9 per cent, at 5,237.48; its largest single-day fall since October 20, 1987, when it dropped 12.2 per cent.

Since February 19, where the outbreak first triggered an international market rout, the FTSE 100 has lost 2,200 points, or 30 per cent.

In New York the S&P 500 declined by 7 per cent within minutes of opening, triggering an automatic break across the New York Stock Exchange for the second time in a week.

This was the first of the exchange's three "circuit breakers" which kick in when the index falls sharply. The first level, a 7 per cent drop, triggers a 15-minute break in trading; the second, a 13 per cent slump, leads to another 15-minute halt; the third, a 20 per cent collapse, ends trading for the day.

America's three main indices remained deep in the red when trading resumed. The S&P was down 8.2 per cent at 2,515.83, the Dow Jones industrial average down 9.1 per cent at 21,418.60 and the technology-dominated Nasdaq Composite down 8.3 per cent at 7,293.74.

Mr Trump, who has repeatedly pointed to Wall Street's record

highs as evidence of his administration's economic success, said the market "has taken a big hit, but it's going to all bounce back and it's going to bounce back very big at the right time".

Leading indices across Europe also struggled, with the Cac 40 down 11.4 per cent in Paris and the Dax down 11.4 per cent in Frankfurt. Across Asia the Nikkei 225 dropped 4.4 per cent in Tokyo and the CSI 300 fell 1.9 per cent in Shanghai and Shenzhen.

There was little sign of relief in the commodity and currency markets, with an intensifying price war between Saudi Arabia and Russia pushing crude oil prices down by a further 6 per cent to \$33.50 per barrel.

High levels of volatility swept through cryptocurrency markets, with bitcoin dropping as much as 25 per cent. Even gold, which is often deemed a safe haven for investors during times of uncertainty, slipped 3 per cent to \$1,582.31 per ounce.

The latest falls pushed the MSCI All-Country World Index, which tracks stocks across 49 countries,

into bear market territory, down 20 per cent from its 52-week peak.

President Trump's plan to ban travel from Europe in a bid to stem the spread of Covid-19, announced overnight, raised fears of more disruption. The White House is facing calls to do more to shore

up economic activity.

"We are going into a global recession," Mohamed El-Erian, the influential chief economic adviser at Allianz, told CNBC. "After what's been happening in the last two days, we are going to see a spread of economic sudden stops."

The issue with such economic shocks is that it's "not easy to restart an economy", he said. "You've got to get people to re-engage, you've got to co-ordinate the restart. So the economic damage is going to last. That's why I believe we're going to get a global recession."

Rationing begins as frantic shoppers empty shelves

SUPERMARKETS have been forced to bring in rationing as "selfish" shoppers panic buy over coronavirus fears.

Shelves across the country were stripped bare of necessities like toilet rolls, anti-bacterial wipes, longlife milk and children's medicine this week. Despite calls for shoppers to remain calm, pictures posted on social media showed many empty food displays in supermarket aisles. In at least one London store eggs, milk

and water were in short supply. Delivery slots for online grocery stores were also hit, with one customer describing it as "worse than Christmas" for delays. There was widespread anger online, with many citing "appalling selfishness".

But Prime Minister Boris Johnson urged calm, saying: "We have had no advice from scientific advisers or medical officers that there's any need for people to buy stuff in.

"If you think you have

symptoms the best thing to do, as you know, is to stay at home and contact the NHS. We will make sure we give the NHS the investment it needs to cope with this crisis."

Tesco has almost sold out of dried pasta online, but at press time was the only one of the so-called Big Four supermarkets to limit sales on food. It is rationing anti-bacterial products, dried pasta, UHT milk, children's medicines, water and tinned vegetables to five items per person.

Trump has blood on his hands, Harry tells Greta impersonators

- Duke left red-faced after Russian hoaxers fool him - twice - over climate change and 'North Pole' penguins
- "If they were at Buckingham Palace, it wouldn't have happened," says former Palace spokesman

The Duke of Sussex has fallen victim to Russian hoaxers posing as Greta Thunberg, who fooled him into talking about his decision to leave the royal family.

He was also tricked into offering to help move penguins to the North Pole, and discussing the climate change crisis faced by an island that does not exist.

Under the impression that he was talking to Miss Thunberg, 17, and her father, Svante, the duke said that President Trump had "blood on his hands". He also spoke about the tension surrounding his decision to quit royal duties and said he was "completely separate" from most of the royal family.

children's song

The conversations, said to have been made by Vladimir Kuznetsov and Alexey Stolyarov took place on New Year's Eve and January 22. The pair spoke about 50 penguins that were supposedly stuck in customs and needed to be taken to the North Pole, prompting Harry to offer the services of a guide he knows there. Penguins are native to the southern hemisphere.

In an excerpt posted by The Sun, the hoaxers talked about the help needed by the island of Chunga-Changa, which is in fact a Russian children's song.

On his decision to step down as a senior royal, the duke said: "Sometimes the right decision isn't always the easy one. And this decision certainly wasn't

the easy one but it was the right decision for our family, the right decision to be able to protect my son."

Dickie Arbiter, a former palace spokesman, said the prank was one of the pitfalls of being outside the royal fold. He said: "As long as Harry and Meghan are over there, they're out of the protection of the system — and for all its faults, the system does protect. If they were at Buckingham Palace, it wouldn't have happened. They're pretty vigilant."

'blood on his hands'

The duke also told the hoaxers that the world was being led by "some very sick people". He said: "The fossil fuel industry and certain presidents are driving completely the wrong agenda.

"I think the mere fact that Donald Trump is pushing the coal industry so big, he has blood on his hands. Because the effect that that has on the climate and the island nations far, far away —

again out of sight, out of mind."

The duke said that Miss Thunberg was "one of the few people" who could reach into Boris Johnson's "soul" and get him to believe in her cause. "But because he has been around for so long, like all of these other people, they are already set in their ways." He also said that the royal family was "scared of the tabloid media". Because he and Meghan were standing up for what they believed in, the tabloids had "come out fighting" and would try to destroy their reputation.

The other member of the royal family to step down from official duties, the Duke of York, has hired a new PR adviser. Mark Gallagher, a crisis management specialist, has been brought in because the duke faces growing pressure from the US authorities to answer questions about the Jeffrey Epstein scandal. He has also hired a leading extradition barrister, Clare Montgomery, QC, who

previously represented the Chilean dictator Augusto Pinochet.

The duke has denied all knowledge of Epstein's crimes. He has also denied

claims by Virginia Roberts Giuffre that they had sex when she was a teenager.

'We will get through this together'

■ Chancellor unveils £30bn emergency funding to beat back epidemic

RISHI Sunak unveiled an emergency £30billion blitz to defend Britain against the coronavirus on Monday, vowing: "We will get through this together."

On the day the outbreak was declared a global pandemic, the Chancellor held his nerve and used his first Budget to hike spending on the NHS and boost growth to minimise the economic disruption from the health crisis.

He poured billions into guaranteeing sick pay and benefit payments to protect workers while slashing business rates and taxes to keep firms going.

But the package of measures is set to send Government borrowing soaring.

While warning the country to brace for a "significant" hit, he insisted the impact would be temporary and the economy will bounce back in the medium term.

Mr Sunak said: "For

a period, it's going to be tough, but I'm confident that our economic performance will recover.

"The British people may be worried, but they are not daunted.

"We will protect our country and our people. We will rise to this challenge."

Mr Sunak announced a £12billion package of immediate measures to prepare public services and businesses at the peak of the outbreak.

It included an extra £5billion for the NHS and other public services in an emergency response fund. There is also £7billion for helping firms and supporting employees in the face of an outbreak that could leave a fifth of the UK workforce too ill to work.

With almost 600 coronavirus cases and ten deaths in the UK confirmed, Boris Johnson this week switched the Government's response from attempting to

contain the outbreak to a focus on delaying the spread.

The Prime Minister is now implementing the second phase of his action plan, which could lead to major public gatherings being shut down and millions of people being advised to work from home.

instant tax cut

As the Government prepares to ramp up preparations, Mr Sunak announced further measures costing £18billion this year, including road and rail projects, to boost the economy.

Around 30 million people are set to get a tax cut, with a raise in the National Insurance threshold.

The instant tax cut will put an average of £100 a year in workers' pockets from next month.

Officials insisted the package will help buoy the economy through the health crisis, even though the measures were planned before the full extent of the emergency was clear.

Under Mr Sunak's emergency measures, the Treasury will foot the bill for sick pay for up to two million small and medium-sized businesses to cover the cost of 14-day isolation periods for staff with coronavirus symptoms.

Half of the country's firms will also be spared business rates for the next year while many small traders will be entitled to £3,000 grants to help them cope with the suspected drop in demand as consumers are forced to stay at home.

To protect the under-pressure hospitality trade, alcohol duty was frozen and pubs were given a £5,000 business

rate discount. The Budget also poured £1billion into bolstering the benefits system and setting up a hardship fund to be administered by local authorities.

This will protect the most vulnerable from the financial impact of the outbreak.

Changes to pensions tax rules were also announced to stop high-earning doctors being hit by big bills for taking extra work.

Mr Sunak told MPs the £2billion move would help "support our hard-working doctors". He added: "I've listened to

concerns from all sides of this house that the pensions tax system is preventing doctors from taking on more hours.

"To significantly reduce the number of people that the tapered annual allowance affects, I'm increasing both taper thresholds by £90,000."

Building will boom with £640bn cash boost

RISHI Sunak turned on the spending taps with £640billion to fund Britain's biggest building programme.

Cash will be shoveled into roads, rail, housing and broadband over the next five years in a giveaway Budget that will "lay the foundations for a decade of growth".

Investment will reach levels not seen since 1955 as the Government charges ahead with plans to boost economic growth outside London and the South-east.

Mr Sunak said: "If the country needs it we will build it."

The Chancellor had been tipped to drop fiscal rules that set limits on day-to-day spending but told MPs they remain in place and his plans meet the terms.

By 2024 day-to-day spending on public services will be £100 billion higher in cash terms than it is today.

And the splurge on capital spending – cash for major infrastructure

projects – is triple the average amount invested in the last 40 years.

In his first budget – just four weeks after taking over the job from Sajid Javid – Mr Sunak hailed the "biggest programme of public investment ever". It included £27billion for roads, £2.5billion for potholes, new railways and stations and £5billion for broadband.

He said: "We promised to get Britain building – this Budget is getting it done. I'm announcing the biggest ever investment in strategic roads and motorway – over £27billion of tarmac. That will pay for work on over 20 connections to ports and airports, over 100 junctions, 4,000 miles of road.

"I'm announcing new investment in local roads, alongside a new £2.5billion pothole fund – that's £500 million every single year; enough to fill, by the end of the Parliament, 50 million potholes.

"Our ambition is truly

national."

The projects include a long-promised road tunnel beneath Stonehenge on the A303, upgrades to the A417 in the South-west, the A428 in the East and the A46 in the Midlands.

Work will also take place to unclog Manchester's arteries and free traffic north of Newcastle.

A Pant-Llanymynech bypass will also be built to protect Welsh Borders beauty spots.

Mr Sunak pledged to change the whole mindset of Government to boost the UK's nations and regions.

A new devolution deal will give West Yorkshire a directly elected mayor who, along with seven other metro mayors, will get Londonstyle transport funding settlements worth £4.2billion. An extra £640million was announced for the Scottish government, £360million for the Welsh government and £210million for the Northern Ireland executive.

Bill Nighy: I owe it all to Billy Mack

■ The veteran British actor tells John Hiscock how Love Actually transformed his career

Bill Nighy has made almost 150 movies and television shows, ranging from little British productions to huge-budget Hollywood blockbusters.

But the one that continues to come back into his life and resonate with him is Love Actually, the Christmas romantic comedy from 2003 in which he plays ageing rock star Billy Mack.

He credits it with making him an internationally known actor and, he tells me when we talk in Los Angeles: "It's almost certainly the reason I'm sitting here. It's possible it would have happened anyway but Love Actually certainly accelerated it.

"And - who knew? - it's become kind of beloved and it's entered people's lives in all kinds of ways. From people coming up and saying, 'You helped me through my chemotherapy' to people saying that they dress up as the characters every Christmas and actually have Love Actually parties," he laughs.

"And now it's like every Christmas you get the Queen's Speech and then you get Love Actually."

One line from Billy Mack is part of cinema legend. "The line that

follows me around everywhere is: 'Hey kids, don't buy drugs. Become a rock star and people give you them for free,'" he says.

"When the movie first came out all the kids in my district used to follow me down the street shouting it and they all knew it by heart," he says.

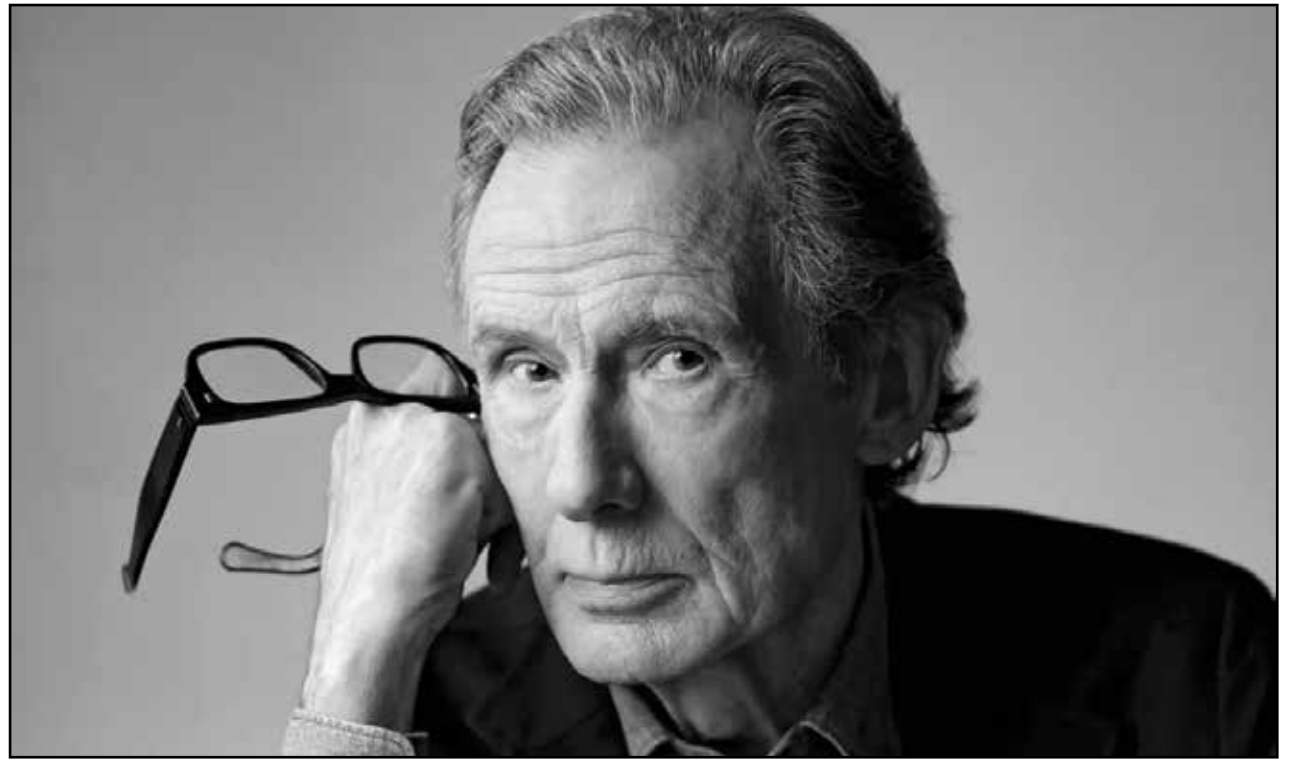
"I once came through Immigration from Canada to the US at about 4am. I was the only person there, and this very scary Immigration guy with a huge black moustache beckoned me over and I thought, 'Oh my God.' and he said: 'Hey kids, don't buy drugs, become a rock star, people give you them for free, right? Am I right?'"

"And I thought, 'Drugs, no I don't have any drugs!'"

"When I die the words, 'Hey kids, don't buy drugs' will be on my tombstone."

A talk with 70-year-old Bill Nighy is always entertaining. Drily amusing and self-deprecating, he has had some dark moment and bouts with depression in the past but now clearly enjoys life without taking much of it too seriously.

Because of his long career and appearances in so many movies and TV productions he is often

recognised in the street - and frequently mistaken for somebody else.

"This morning in the elevator, a woman said, 'you look really familiar,'" he recalls. "I just went, 'Well my name's Bill' and she went, 'Do I know you from somewhere?'"

"I was in Melbourne in Australia and a woman came up and said 'Mr. Stamp, it's lovely to have you here.' And lately I've been Paul Smith, the designer. A man came out of a diner the other day holding his shirt, he said 'you designed this! I

said 'No, I didn't.' He said 'yeah you did,' and there was a guy behind him eating a sandwich, he said 'that's Paul Smith, isn't it?' And the guy went, 'yeah.'

And if I have glasses on I'm mistaken for Gary Oldman. I have been congratulated on Tinker, Tailor, Soldier, Spy half a dozen times. I just say, 'thank you, we had a lovely time making it.' What are you going to say?"

He has lived alone since his 27-year relationship with the actress Diana Quick ended in 2008. And

he is horrified at the idea of anyone trying to "fix him up" with someone.

"People have occasionally tried and I go to a dinner party and there's a woman on her own sitting opposite me and I think, 'Oh, I see.'

"But if anybody ever proposes that I should

meet someone for the specific purpose of being intimate with them or spending the rest of my life with them, that's the end of it," he says with a laugh. "I go missing. I'm gone because I can't deal with that situation. I'd just can't bear it and I'd go to pieces."

Craig scotches more Bondage talk

DANIEL Craig has insisted that No Time To Die really will be his final outing as James Bond.

It had been widely believed a new actor would take over. However, recent reports suggested Daniel was contemplating staying on.

But Daniel, 52, used a hosting gig on Saturday Night Live to insist it would be his last 007 film. He also joked about the influence of Phoebe Waller-Bridge, after the Fleabag creator

was drafted in to help on the script. He said: "This next James Bond film is going to be my last, but it's going to be one of the best because we got Phoebe to come to help with some of the dialogue."

In a nod to Fleabag's habit of talking to the viewer, he quipped: "It's not going to be that different. Every so often I will turn to the camera and I will say, 'The name's Bond, James Bond. Is it bad that I fancy the Pope?'"

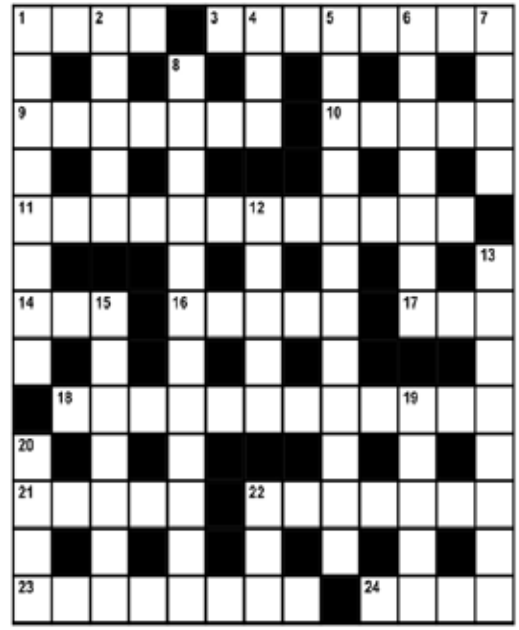

Forgive me for being cheeky and sneaking the name of my new single, "Toxic World" in the banner for this little article but self-promotion is important. I learned that many years ago when I quit film school in Toronto and landed head first in the music business.

I had been writing songs and playing in cover bands when a small indie label heard one of my tunes and quickly signed me to a record deal. In my mind it was like winning the lottery, and in a sense it was because within a few months I had a number one Canadian hit called "Bondi Junction." The tune also penetrated the

Billboard and Cashbox charts in the US and basically changed my life forever.

I eventually scored a contract on Capitol/EMI Canada where I enjoyed several other Top 10 hits before moving to L.A. in the early 80s after landing on a well funded label called Free Flight, distributed by RCA. They got me my Green Card and I really thought this was it. I was finally in the big leagues - but then suddenly it was over. Free Flight abruptly shut its doors and before long I had to figure out how to pay the rent.

Chocolate mints was the answer. Selling them over the phone for four hours a day. It was

painful. Former pop star now waking up at 6:00 am to make calls in a room full of struggling actors and musicians. In the afternoons I did what everyone else does in L.A. I started writing a screenplay.

They say when one door closes another one opens.

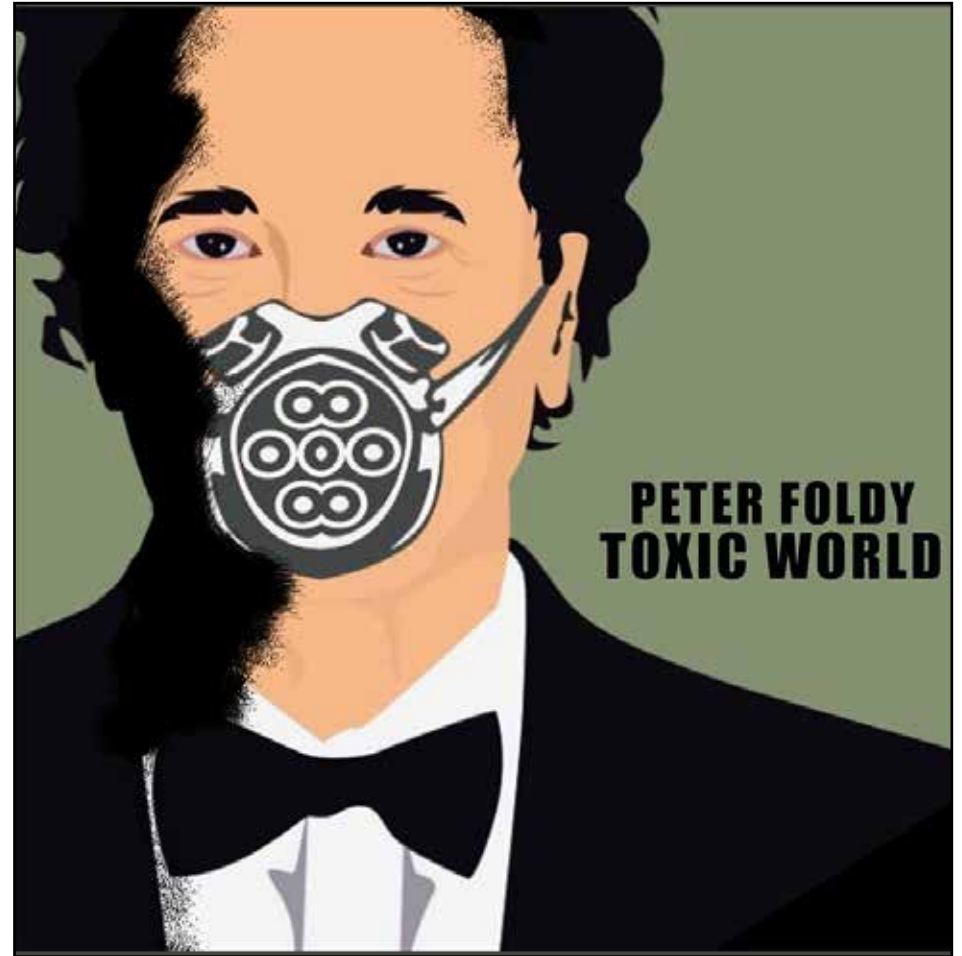
Turns out one of my co-workers at the chocolate mint boiler room, (also a Canadian) recognized me from the music biz. We became friends and he told me that a producer he knew was looking for a teen comedy. I said I had just finished one. My new buddy read it, liked it and helped me sell it to the producer. The film, called "Hot Moves" got made and did extremely well, playing in theaters all across the US and Canada especially cleaning up on a new format called home video.

I quit the chocolate mint business and became the Associate Producer of "Hot Moves," learning more in three days than I did in three years attending film school. The success of that film led to more writing and producing gigs, and eventually to directing features with actors such as Beverly D'Angelo, Eugene Levy, Academy Award winner Louise Fletcher and even a young Paul Rudd.

But this little story is about my time in the music business. Things often come full circle because I'm back in it--and I've got Facebook to thank.

When social media became a thing I started getting messages from former fans telling me how much my past recordings had touched them. What some of those songs meant to them. I was both flattered and flabbergasted- but also encouraged. For the first time in ages I went back to writing and recording new music. It took over five years but in 2016 my

10 track CD, "Nine Lives" was born and started receiving radio airplay as well as some really kind reviews. It felt rewarding - which brings us back to my current single, "Toxic World."

I wrote the tune last year because I wanted to say something socially conscious but incorporate it in a love song. I hired a bunch of great musicians like Imre Czomba and Jamie Ward of the band Balcony to help me find just the right tone for it - but it was Miklos Malek, a producer who had worked with Jennifer

Lopez and Arianna Grande, who finally brought it all together.

"Toxic World" became a new, modern direction for me musically and I was really excited. I guess some other folks were too because the track recently hit #1 at a station in Canada and is currently sitting at #27 on a Canadian Anglo Top 100 chart in Quebec. It's getting some decent radio play at a time when that privilege is mostly reserved for the top music stars. But that's not slowing me down. I'm pushing on with it because, if you listen,

you'll hear that is not only a fun tune, but also very timely.

So if you've managed to read this far, those are the broad strokes to my musical journey. They say luck is when opportunity meets preparation, so my advice is be prepared, do what you love and opportunities will come. As corny as it sounds, follow your dreams. That's why we all came to L.A. in the first place, right?

Meet Jared Morrison (aka J-Moz) from Peterborough who moved to LA two years ago, originally as a PE teacher but ultimately to pursue a career in music.

Was there a particular reason you chose LA?

Strangely it was LA that chose us. My partner and I always had a desire to work abroad as teachers due to England's work-life balance, as well as us both needing more sunshine in our life. We had applied for jobs in various overseas destinations after we had returned from an around the world trip and the first school that offered us an interview was a Charter school in the Valley area. Arteta tests positive for Coronavirus

Arsenal manager Mikel Arteta has tested positive for coronavirus and the club's game against Brighton on Saturday has been postponed.

The Gunners have closed their training ground and club staff who had recent contact with Arteta will now self-isolate.

The Premier League will hold "an emergency club meeting" on Friday to discuss future fixtures.

"This is really disappointing," said Spaniard Arteta, 37.

"I took the test after feeling poorly. I will be at work as soon as I'm allowed."

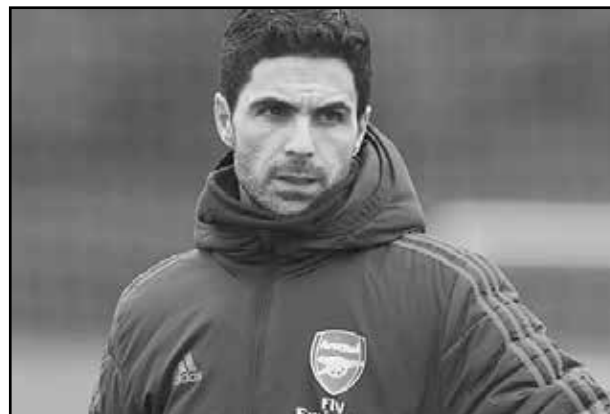
Arsenal expects a

"significant number of people" will self-isolate, including the "full first-team squad".

The club were due to face Brighton in the Premier League at Amex Stadium on Saturday (15:00 GMT) but Brighton released a statement, shortly after confirmation of Arteta's positive test, announcing that the game had been called off.

"The health of our people and the wider public is our priority and that is where our focus is," said Arsenal managing director Vinai Venkatesham.

"We are in active dialogue with all the relevant people to

Arsenal's Premier League match with Manchester City

No rebuilding ahead, claims Mou

Tottenham manager Jose Mourinho says he is not planning an overhaul of his squad despite their Champions League last-16 exit to RB Leipzig.

Spurs are facing a first season outside Europe's top competition in five years unless they can overturn a seven-point gap on fourth-placed Chelsea.

Mourinho's side, who have been affected by injuries all season, have gone six games without a win.

"I don't think so," he said when asked if Spurs need a massive summer rebuild.

The Premier League side were well beaten in Germany as Leipzig won 3-0 to secure a 4-0 aggregate victory.

Spurs captain Harry Kane and midfielder Moussa Sissoko have not played since 1 January, while Son Heung-min is also sidelined and Steven Bergwijn could miss the rest of the season.

"This summer, unless something happens during the holidays or the Euros, when we start we will have Sissoko, Kane, Son, Bergwijn and Ben Davies so that is massive," Mourinho told BT Sport.

He was annoyed in the post-match news conference when asked if their problems ran deeper than injuries,

"You want me to speak about other things, when the obvious thing is the problems accumulate through injuries," he said.

"We can do a mental exercise. Imagine Leipzig without Sabitzer, Schick, Werner. You want to imagine Liverpool without Salah, Mane, Henderson, Firmino? Barcelona without Griezmann, Messi, Suarez, Pique?"

"Do you want to make this exercise with every team in the world? I think any team would struggle, it's simple.

"We can cope for three or four matches, we cannot cope for three or four months.

"All the players on Leipzig's bench, in my team they would play at this moment."

Spurs became Champions League regulars under Mauricio Pochettino and reached

last season's final - in which they lost to Liverpool. Pochettino was sacked and replaced by Mourinho in November.

The London club are four points behind fifth-placed Manchester United - who they play this Sunday. Fifth place could qualify for the Champions League if Manchester City fail in an appeal to get their European ban overturned.

But Mourinho thinks this season's Champions League exit could be "good" for the club.

"Difficult moments can prepare the future in a better way," he said.

Mourinho added: "With the squad we have at the moment it will be very difficult [to qualify for the Champions League] because the problems won't go tomorrow. We will fight until the end."

United romp to five-star victory in Austria

Manchester United took control of their Europa League last-16 tie with a resounding 5-0 first-leg win at LASK on Thursday in front of a crowd of just 500 people.

Odion Ighalo's superb goal set United on their way inside a largely

empty Linzer Stadion after the Austrian government had restricted the attendance in response to the coronavirus outbreak.

The 30-year-old Nigeria striker has now scored four goals in three starts United, who are now unbeaten in

their last 11 games in all competitions.

However, he will have scored few better, or in a more surreal atmosphere than the opening goal, with the forward collecting Bruno Fernandes' pass and juggling the ball from right foot to left,

before dispatching it into the top left corner, off the underside of the crossbar.

Juan Mata, Daniel James and Harry Maguire all had chances to add to their tally, while Ighalo hit the post before supplying James for United's second -

with the winger cutting inside and driving a right-foot effort into the bottom left corner.

Fred's incisive pass allowed Mata to roll in a third, while substitutes Mason Greenwood and Andreas Pereira, added a fourth and fifth in injury time.

RED AND BURIED!

■ Atleti stun Klopp's boys as Adrian blunder helps dethrone European champs

Holders Liverpool were knocked out of the Champions League with a dramatic extra-time defeat by Atletico Madrid in the last 16 on Wednesday.

A finely balanced second leg turned on a catastrophic blunder by goalkeeper Adrian.

Jurgen Klopp's side - seeking to win the trophy for a seventh time - thought they had overturned Atletico's 1-0 advantage from the first leg when Roberto Firmino's first goal at Anfield this season at the start of the added 30 minutes gave them the lead in the tie.

Georginio Wijnaldum's first-half header was full reward for Liverpool laying siege to the Atletico goal for much of the first 90 minutes.

In the second half, Andrew Robertson was then inches away from a winner only for his header to crash against the woodwork.

And yet, as the Kop sensed another memorable Champions

League victory, Adrian - deputising for the injured Alisson - paid the price for a dreadful clearance as substitute Marcos Llorente pounced with a low finish to secure Atletico's crucial away goal.

Llorente struck again with another composed finish in the 105th minute and with the spirit draining out of Liverpool and their supporters, former Chelsea striker Alvaro Morata adding insult to injury with a third in the dying seconds to send Atletico through to the last eight.

This game was, in many respects, a tale of two goalkeepers.

The magnificent Jan Oblak formed a formidable barrier for Atletico Madrid, his yellow shirt a colossal presence in his penalty area as he made nine saves and claimed countless crosses.

In contrast, Liverpool's mammoth effort was fatally undermined by the hapless Adrian, who also made an error that contributed to their FA

Cup fifth-round defeat by Chelsea.

The Reds had finally established a measure of control through Firmino's goal, but once Adrian had hacked out a hopeless clearance and Llorente's shot beyond him into the net at the Kop end, Atletico were ruthless.

Klopp looked and sounded suitably downcast last week when he announced his world-class Brazilian goalkeeper Alisson had suffered a hip injury, knowing he could make the difference to a Champions League tie that was always going to be decided on the finest of margins.

And so it proved, Liverpool's morale and fighting spirit disappearing visibly after Adrian's mistake.

Liverpool will still complete the formalities of their first Premier League title but they pride themselves on their status as European champions and this was a painful night.

It doesn't feel right - Klopp

Liverpool manager Jurgen Klopp says their Champions League last-16 defeat by Atletico Madrid "doesn't feel right" and criticised the La Liga side's style of play.

The European champions' hopes of defending their title were ended by a 3-2 loss at Anfield on Wednesday, with Atletico winning 4-2 on aggregate.

The Reds had reached the final in the previous two seasons under the German.

Klopp suggested Diego Simeone's Atletico

do not play "proper football".

"I am completely happy with the performance. It's so difficult to play a side like this," Klopp told BT Sport, adding he was "searching for the right words".

"I don't understand with the quality they have the football they play. They could play proper football but they stand deep and have counter-attacks.

"We accept it, of course, but it doesn't feel right tonight. I realise I am a really bad loser,

especially when the boys put such an effort in against world-class players on the other side who defend with two rows of four.

"We know in the past two years we had some lucky moments in the Champions League - you have to reach two finals - but today everything was against us in the decisive moments."

Defeat was Liverpool's fourth loss in six matches in all competitions, but they remain 25 points clear at the top of the Premier League.
