## Queen sends message to nation as coronavirus crisis deepens

The Queen has issued a message to the nation on the coronavirus outbreak, saying the UK is "entering a period of great concern and uncertainty".

The 93-year-old praised the work of scientists, medics and emergency staff, but added that everyone has a "vitally important part to play".

Her message came just ahead of the PM's daily briefing, in which he said the UK could "turn the tide" in 12 weeks.

The monarch said she

and her family "stand ready to play our part."

The Queen had already cut short her official duties because of the crisis, and is now at Windsor Castle with the Duke of Edinburgh.

He was flown there by helicopter from the Sandringham estate where he has been staying.

The virus has now seen 144 people who tested positive die in the UK.

In her statement, the Queen said: "Our nation's history has been forged by people and communities coming together to work as one."

"We are all being advised to change our normal routines and regular patterns of life

the UK, particularly the over-70s, to avoid all non-essential contact.

The advanced age of both the Queen, who is the world's longest reigning monarch, and Philip, who is 98, means they are more at risk of complications if they catch the Covid-19 illness.

They are expected to remain at Windsor beyond Easter with fewer staff, as a precaution.

In his news briefing, Boris Johnson said he did not know how long the crisis would affect the UK, but said he hoped to "get on top of it" within the next three months.

He said trials of a vaccine were expected to begin within a month and warned he would "enforce" Londoners to be kept apart "if necessary".

He also urged businesses to "stand by their employees", adding that the chancellor would be making further announcements on Friday.

From Friday, all schools in the UK will close their doors to nearly all pupils, except vulnerable ones and the children of key workers.

A full list of key workers, likely to include NHS workers, school staff and delivery drivers, was not available at press time.

She added: "Many of us will need to find new ways of staying in touch with each other and making sure that

The Queen's message came after Buckingham Palace announced last week that changes were being made to her diary commitments "as a sensible precaution".

She has cancelled her annual garden parties, along with visits to several UK towns.

# Boris Johnson announces complete closure of schools

## Emergency grades to replace tests under first nationwide closure in history

Boris Johnson has ordered the first nationwide shutdown of schools in British history to try to stem the spread of the coronavirus.

Exams were cancelled as schools and nurseries prepared to shut their gates indefinitely from Friday with only the children of key workers and vulnerable pupils able to attend basic facilities.

Pupils were left in limbo as Mr Johnson took the unprecedented step and indicated that grades would be awarded through an alternative system, but failed to set out details.

Gavin Williamson, the education secretary, said schools would close "until further notice" because keeping them open was no longer in the best interests of children and teachers. He acknowledged an "increasingly challenging" situation as staff shortages and falling attendance followed official advice to minimise contact with others.

He said this morning

that the Cabinet Office would release a full list of key workers on Thursday, emphasizing it would apply not only to medical staff but all of those who keep hospitals running.

He told BBC Breakfast that head teachers should identify children about whom "there are particular concerns" because "we took the move to include vulnerable children — we'll be wanting to make sure they're in a safe and proper environment".

Mr Williamson estimated that 10 per cent of children would need to stay in an educational setting, but said that schools would work together to ensure staff get some time off over Easter. "Certainly this is something as an education secretary I would never have wanted or been in a position to make this decision," he added.

Mr Johnson said that NHS and care staff, police and delivery drivers were among key workers whose children would be offered places at "skeleton schools".

The prime minister had played down the option of shutting schools because Sir Patrick Vallance, the chief scientific adviser, said it offered little marginal benefit relative to disruption. Sir Patrick said last week that schools would have to close for at least 13 weeks and the chances of keeping children apart for that time was "zero".

The measure is in response to a worsening forecast of the severity of the outbreak as the number of fatalities in Britain leapt to 104, up 32 in a day. At press time the number of cases was 2,626, up 676.

Matt Hancock, the health secretary, outlined emergency legislation in parliament on Thursday detailing measures the government plans to take in order to slow the spread of the virus and to protect NHS workers. The legislation will include plans to hand police powers to arrest and isolate people.

Labour was not expected to demand a vote on the bill, allowing

it to pass through parliament swiftly, but Jeremy Corbyn wrote a list of conditions to the prime minister which he said would need to be honoured to gain public support. Mr Corbyn noted that the legislation would have to be voted on every six months to prevent handing the government too much power.

Schools, pupils, parents and experts called for urgent clarity on how A levels and

GCSEs would be graded without exams. Mr Williamson said there would be a "means of redress" for pupils who thought their assessments unfair.

More than 4.5 million pupils are preparing to take GCSEs, and a quarter of a million to take A levels. They were plunged into confusion by the sudden announcement.

Alistair Jarvis, head of Universities UK which represents

vice-chancellors, said universities should honour the offers made regardless of grades awarded in place of A level exams.

He said: "There is another option, and that's the universities honour the offers that have already been made. Universities are people who are very experienced about making admissions judgments and the offers have already been given."

## Interest rates cut to lowest on record to fight virus

The Bank of England has cut interest rates to their lowest level on record and launched £200 billion more quantitative easing to rescue the economy as the coronavirus crisis continues to rock financial markets.

In its second emergency intervention in little over a week, the Bank cut rates from 0.25 per cent to 0.1 per cent and pledged to buy £200 billion more gilts and corporate bonds to prop up growth, taking its total QE programme to

£645 billion.

The action was taken after a serious deterioration in the gilt market as investors have sold out of UK government debt to switch into short-term cash holdings, largely

# Ghost town Britain as public stay home

■ Nation moves on to war footing as cases of the deadly virus continue to surge

## THE devastating impact of the coronavirus crisis is laid bare in these haunting images of ghost town Britain.

City centres lay deserted this week as millions ditched the commute at the start of the working week to stay at home instead.

It came as the nation moved on to a war footing as cases of the deadly virus continued to surge. Mainline stations looked abandoned after the traditional morning rush hour was replaced by the arrival of near-empty trains. In London, Euston and Waterloo stations were among those that saw a dramatic fall in passengers. Some Underground train carriages, where workers are normally packed in like sardines, were completely empty.

Many employees who headed to work wore masks and took other protective measures.

City centres in Birmingham, Nottingham, Bristol, Edinburgh and Cambridge were all eerily quiet, while major airports including Heathrow looked deserted.

Major roads and motorways usually clogged up with traffic were also empty.

The chilling scenes came as travel and workplace restrictions

were put in place.

Popular landmarks and tourist attractions in London and elsewhere were also abandoned as visitors stayed away from large gatherings.

Businesses were also operating with skeleton staff.

Experts estimate nearly a third of the UK's 32 million workforce has been affected, with working from home plans impacting up to 12 million families across the UK.

One commuter, Becky McElroy, 24, travelled from her home in Dartford, Kent, to London Bridge station.

The sales negotiator at an estate agent in east London said: "I'm one of nine people in my team and as far as I know everyone is due in this morning."

"They have provisions for us to work from home should we get to that situation."

"We now have antibacterial hand wipes in the office and posters have been put up warning us to wash our hands for 20 seconds. I think the bosses are monitoring the situation all the time."

Major companies, including Deloitte and JP Morgan, have implemented contingency plans for staff, while many others are expected to follow the

Government's updated advice.

A number of major stores have also closed their doors, including Apple, Nike and fashion outlet Urban Outfitters. As train services were decimated and the Government called for a stop to non-essential journeys ministers warned there was no point running "ghost trains" with no commuters, with some services facing the axe.

Last week, there were nearly two million fewer passenger journeys on Britain's railways and the London Underground. Millions more workers are expected to stay at home, with the crisis expected to worsen over the coming weeks. Transport Secretary Grant Shapps said the number of train passengers had fallen by up to 20 per cent last week.

In London, where five million people travel on the Tube each day, journeys were also down by 19 per cent.

Mr Shapps said he would be meeting rail bosses this week to determine how to "sustain" services amid the growing crisis. It is understood firms are in talks to renegotiate contracts while union leaders have also held talks with bosses over how to keep public

transport operating.

Mr Shapps said: "People still need to be able to travel to an extent, and some of that is actually about how many trains are put on a line at any one time and the rest of it."

Asked whether train companies could be freed from their franchise

obligations, Mr Shapps said: "It's quite clearly an exceptional international moment in time."

"We need to be flexible as a country to react to that, and I'll be driven by, among other things, the demand. "There's no point running ghost trains any more than in running ghost planes, but

those are conversations which are ongoing."

Transport for London, which has also seen a 10 per cent drop in bus passengers, said it will need financial support from the Government, and that its best case scenario is that the coronavirus outbreak will cost it £500million.

## Comic veteran Roy Hudd dead at 83

Roy Hudd, who hosted BBC Radio 2's *The News Huddlines* for 26 years and also starred in *Coronation Street*, has died at the age of 83.

In a statement, his agent said: "We are sad to announce the passing of the much-loved and amazingly talented Roy Hudd OBE."

"After a short illness, Roy passed away peacefully on Sunday 15 March, with his wife Debbie at his side."

The all-round entertainer also starred in *Coronation Street*.

His agent added: "The family would ask you to respect their privacy at this very sad time."

Rory Bremner described Hudd's death as a "great loss".

The team at *Have I Got News For You* also tweeted a tribute.

"Hopefully Roy Hudd's death will not go unnoticed in the current crisis," the tweet read.

"Roy was a very generous comic who went out of his way to encourage young gag writers. Many producers and writers working in comedy today owe him a great deal."

Comedy writer Simon Blackwell, who is best known for his work on *The Thick of It*, *In The Loop* and *Veep*, said he got his start thanks to Hudd.

"Very sad indeed to hear that Roy Hudd has died," Blackwell tweeted. "A really lovely

bloke, a great comedian, excellent straight actor. And a comedy historian too."

"I got my start in comedy writing via his Radio 2 show *The News Huddlines*. He was a total joy to write for. All good wishes to his family."

Actor and writer Mark Gatiss tweeted: "Farewell to the wonderful Roy Hudd. A great comic and actor. One of those joyous people who feel like they've been with us forever."

# NHS: Virus could put 8m in hospital

- Pandemic to last a year says leaked NHS alert
- 80% of nation expected to become infected
- Over 70s to be quarantined

UP to eight million Britons could be hospitalised with coronavirus as the crisis is expected to last a year, according to a leaked document.

Eighty per cent of the population is likely to be infected, health experts fear.

The crisis is now expected to last until spring 2021, according to a leaked document from Public Health England. The shock figures come as Britain is on the brink of shutdown with the Government ready to close pubs, restaurants and shops to fight coronavirus.


## lockdown

Pensioners aged over 70 will be asked not to go out for up to four months for their own "self-protection". Health Secretary Matt Hancock pledged to "stop at nothing" to limit the disease's impact and said everyone's life will be affected.

Millions of Europeans are in lockdown, only able to leave their homes under limited circumstances. The US Federal Reserve has cut interest rates to zero due to the virus. Ireland's government has ordered all bars in the Republic to close for two weeks and urged residents not to hold private parties. Millions of Europeans now face draconian clampdowns shutting many shops and eateries and stopping residents from leaving homes. Emergency plans in the UK are being ramped up as the death toll continued to rise.

Police are expected to be given powers to arrest people with the virus who refuse to self-isolate.

Public Health England emergency preparedness



and response team's document warns that one in ten people could have symptoms at the peak of the outbreak.

It is the first time health chiefs tackling the virus have admitted that they expect it to circulate for another 12 months and lead to huge extra strain on

an already overstretched NHS.

An estimated 500,000 of the five million vital workers in "essential services and infrastructure", such as the NHS and social care, could be off sick at any one time.

The document added that: "As many as 80 per

cent of the population are expected to be infected with Covid-19 in the next 12 months, and up to 15 per cent (7.9 million people) may require hospitalisation."

## 'dip in the summer'

The report was drawn up late last week and approved as accurate by Dr Susan Hopkins, lead official dealing with the outbreak. It is not believed to have detailed how

many deaths are expected. But if the 80 per cent figure proved correct, the one per cent death rate suggested by many experts could lead to more than 531,000 deaths.

If Chief Medical Officer Prof Chris Whitty's suggestion that the death rate may be closer to 0.6 per cent is right, some 318,000 deaths could occur.

Paul Hunter, a professor of medicine at the

University of East Anglia, said: "For the public to hear that it could last for 12 months, people are going to be really upset about that and pretty worried about that."

"A year is entirely plausible. But that figure isn't well appreciated or understood."

"I think it will dip in the summer, towards the end of June, and come back in November, in the way that usual seasonal flu does."

## PM orders industry: build ventilators asap

**THE Prime Minister has called on British manufacturers to rapidly retool their production to help build ventilators for coronavirus patients.**

The UK currently has only about 5,000 ventilators but Health Secretary Matt Hancock said the country is expected to need "many times more than that" due to the disease causing respiratory problems. Car manufacturers and military engineers are among those in talks to join the national effort. Ventilators supply higher levels of oxygen and push air into the lungs.

Mr Hancock told Sky News's Sophy Ridge on Sunday: "We start with around 5,000, we think we need many times more than that, and we are saying if you produce a ventilator then we will

buy it. No number is too high.

"They are relatively complicated pieces of kit but they're not so complicated that the advanced manufacturing that this country is so good at now can't be able to turn its production lines over to.

"Frankly, right across the world, the demand for them is incredibly high, so it is not possible to produce too many. Anybody who can should turn production and engineering over to ventilators.

"The thing the NHS needs now more than anything else is more ventilators. We've been buying as many as we can but we need to produce more too."

British Medical Association chairman Dr Chaand Nagpaul

said the UK's starting position when it comes to equipment was "unfortunately far worse than many other of our European nations". He added: "We have about a quarter of the critical care beds that Germany has, as an example, so it's really important that we see what plans the government has to expand that capacity.

"We need to be really decisive on how that limited resource is used in the best possible way for those who will need it."

Later this week Public Health England warned that some retailers are selling unreliable products claiming to diagnose coronavirus. A statement said: "There is little information on the accuracy of the tests, or

published evidence about the suitability of these tests for diagnosing Covid-19."

Most of the official tests are being given to hospital patients in critical care with pneumonia or other respiratory and flu-like illnesses. People who self-isolate with a fever or cough but do not require medical attention do not usually need testing, PHE said.

in dollars. With the economy effectively in suspended animation, investors are liquidating their positions and scrambling for the safest asset they can find, which at the moment is the US currency.

Economists are now warning of a collapse in growth that the UK has not seen before. The decision to close down much of the economy may cause it to shrink 15 per cent or more in just three months, Capital Economics and Jefferies have both warned.

Widespread business failure and mass staff lay-offs are anticipated that could cause permanent damage. Andrew Bailey, the Bank of England governor, has said it is the authorities' job to prevent temporary "dislocation" becoming permanent economic "destruction".

The rush by investors into dollars has been behind the swiftest stock market collapse since the 1929 Great Depression and has driven up UK government borrowing costs from 0.15 per cent to around 0.8 per cent in just ten days, despite a cut in rates over the same period from 0.75 per cent to 0.15 per cent.

Last Wednesday, the Bank cut rates from 0.75 per cent to 0.25 per cent and launched a cheap funding package for high street banks to ensure the cut was passed on to borrowers. It was the Bank's first unscheduled cut since October 2008 and the largest single move since early 2009.

The Bank has today increased the size of the cheap funding scheme alongside the rate cut and QE. Last week, Mr Bailey said the Bank had used up almost half its policy ammunition to support growth. It now appears to have used all that remained.

On Tuesday, it unveiled a separate

commercial paper facility to help large businesses raise essential working capital funds that they can no longer raise in the markets, which are largely frozen.

In a statement after Thursday's surprise announcement, the Bank said: "In light of actions to tackle the spread of the virus, and evidence relating to the global and domestic economy and financial markets, the MPC held an additional special meeting on March 19.

"Over recent days, and in common with a number of other advanced economy bond markets, conditions in the UK gilt market have deteriorated as investors have sought shorter-dated instruments that are closer substitutes for highly liquid central bank reserves.

"As a consequence, UK and global financial conditions have tightened. At its special meeting on March 19, the MPC judged that a further package of measures was warranted to meet its statutory objectives.

"The majority of additional asset purchases will comprise UK government bonds."

## Some UK seniors invoke spirit of Blitz vowing to 'keep calm and carry on'

**Despite being one of the most at-risk segments of the population, not all older Britons plan to follow government recommendations for social isolating.**

A report in the Daily Express this week quoted several pensioners who have vowed to not let the pandemic affect their lives.

Defiant Kathleen Hall, 77, from Manchester, said she and her husband Robert, 79, plan to refuse to self-isolate.

She said: "I won't be staying in. I only go out three times a week to the hairdresser's, the club and the shops and I'm not giving that up.

"I'm not staying in for four months, that's ridiculous.

"I'm lucky because I'm 77 but I'm healthy enough. There's a woman who's 100 who lives down the road and I'm more worried about her."

Widower Bernard Bibby, 76, from Rochester, Kent, was working as a TV extra in shows including Killing Eve

and The Crown, but has temporarily given it up out of fear of catching the virus travelling into London.

He said: "I've always got one month's worth of food in the house, whether it's tinned or frozen. It's a wartime spirit. We've been here before, you just cope and work together to protect each other. It's going to upset business but it's better to be disturbed than dead."

Sprightly Eric Castle is "keeping calm and carrying on". The 100-year-old, from Leeds,

said: "I have no plans to change the way I live my life just because of this virus. I've made it this long so I think I'll be all right. I'm very independent but I don't know what people like me are expected to do if the Government says the over-70s have to stay at home. I have no family, I am on my own."

Barbara Peters, an 81-year-old ballet teacher from Halifax, West Yorks, insists she will "keep dancing" in the face of the worsening coronavirus outbreak. She said: "I've just had a lovely lunch

out with friends and a nice glass of wine, so clearly I'm not self-isolating. There are some incredibly fit people in their 80s and some really unfit people in their 50s, so I don't think we can base everything on age."

Ruth Deakin, 84, from Leeds, said: "I don't really see the point in being in good health at the age of 84 if you can't go out and enjoy yourself, so I don't plan on holing myself away at home. I'm certainly not going to panic like some people, that doesn't help anyone."





# The End is Nigh..?

■ On the one hand our human-centric sense of self-importance knows few bounds and, on the other, we're aware of how vulnerable we are, says Marius Brill

**Good news! If you're reading this, the world hasn't ended.**

Yet.

But it certainly feels like it might at any moment. This year has seen Australia on fire, the UK flooding, New Zealand erupting, The West Indies quaking, locusts plaguing East Africa, land-slides in Myanmar, Ciara, Dennis and Jorge etc. batter Europe and now corona-pestilence is spreading around the world as democracies crumble to madmen and demagogues. Surely we haven't got long to go? The end is nigh or near or now.

It's all pretty biblical.

But maybe that's the point. In the back of our minds, this is how the world's supposed to end, not with a bang or a whimper, but presaged with augurs, omens and portent. So even if we might think of ourselves as well beyond scripture, it's hard to witness the earth shrugging like this without a sense of dread. It didn't take a bible scholar to note that the four coaches carrying 'corona virus' evacuees from Wuhan, were called "Horseman": like the prophesied Horsemen of the Apocalypse.

Even if few have read it, Revelations the

last book of the New Testament, is embedded in the western psyche. It predicts a host of natural disasters before God eventually kills everyone and ushers in his new kingdom of righteous bores: "and, lo, there was a great earthquake; and the sun became black as sackcloth of hair, and the moon became as blood;" (Rev 6.12) sort of thing. Mind you, it also goes on about, "A measure of wheat for a penny, and three measures of barley for a penny;" (Rev 6. 6) which are way out at present crop values, so you take your pick as far as accuracy goes.

Judaism hand-wrings about "the Day of the Lord" in which God causes death, destruction, and a war between Gog and Magog; which is only settled when Gog and his Ma go for family counselling.

If you believe in such things, the omens don't look good. But to believe there is meaning in the world's current chaos takes something deeply human: a massive ego. Even in our world creation stories we stick ourselves slap bang in the middle; created in God's image, our planet the centre of the solar system, and so forth. Which may be why we find it harder

to conceive that the world might just as easily end in a millisecond of senseless whimsy from a disinterested universe. Somehow, we're so important we're owed warnings, we're so significant we're worthy of messages from a higher power telling us of our coming doom; despite the fact that we'll be able to do sweet far call about it.

On the one hand our human-centric sense of self-importance knows few bounds and, on the other, we're aware of how vulnerable we are. Extinction Rebellion (XR) is the most recent movement to swell its numbers by tapping directly into the fear of an Apocalypse and the role of man in both creating and preventing it. At the end of February their young prophet, unafraid of a bit of hell and damnation rhetoric, told a crowd in Bristol that, "the world is on fire" while a fug of spliff smoke rose above the student activists. XR follows the CND (Campaign for Nuclear Disarmament) "Action or Armageddon" principle in the 70s and, earlier C20th campaigns, driven by a fear of overpopulation and faith in genetics: the Eugenics and Nazi movements. And before that, for millennia, the church had the last word on the "End of Days" and man's role in it. Repent repent!

## parasites

When you stop to listen to so called "Climate Change deniers" you find that a fair number are, in fact, "the-responsibility-of-man-in-creating-climate-change deniers", which may be equally wrong but a little harder to provide conclusive evidence to challenge. And not nearly as pithy. The fact that they are lumped in with the swivel-eyed who struggle to read their own thermometers, and the corporate interest in continuing pollution

and deforestation, is, I suspect, because their point is a harder one to bear. Because if, say, we didn't cause this mess, or all we did was perhaps accelerate it, what hope have we of clearing it up? Would changing human behaviour really change anything in any significant way? Even if we all became net-zero, bovine-free, vegan, cyclists would that really be enough to halt the coming reckoning? Or, are we just inconsequential parasites tickling the surface of the planet?

Douglas Adams, in *The Restaurant at the End of the Universe*, speculated on the effects of a "Total Perspective Vortex" machine in which 'you are given just one momentary glimpse of the entire unimaginable infinity of creation, and somewhere in it a tiny little marker, a microscopic dot on a microscopic dot, which says "You are here."' This would, Adams suggested, immediately destroy the human brain. Our significance, in the big scheme of things, is so minimal we wouldn't even be able to comprehend a big scheme of things even if there were one.

But if we're not important, and our actions have little or no consequence, why should we feel guilty about them? And if we don't feel shame, if we don't feel bad about stuff, how can we be inspired to act well? The Judeo-Christian solution was simple: we're all guilty. We're all tainted by Adam and Eve's original sin; "Of man's first disobedience, and the fruit Of that forbidden tree, whose mortal taste Brought death into the world, and all our woe" as Milton put it. Buddhism is more direct, its first two truths are that life consists of suffering, pain, and misery and that this suffering is caused by selfish craving and personal desire.

So here's the paradox.



**RED ALERT:** Coronavirus has tapped into our universal dread perfectly.

If we are important, then we're responsible, and guilty, and that makes us unhappy. If we're inconsequential, there's no meaning to anything we do, and our pointlessness also makes us unhappy. Unhappiness, despair, anxiety, stress, fear, morbidity and self-absorption... or as a doctor would diagnose it: depression.

Maybe the old religions were on to something. Roughly 20% of people in the UK are diagnosed with depression, if we double that number for those too depressed to see their doctors and add some more for those who just try to pretend they're ok; we might start to think Buddha got it right, the natural state of man is pain. The abnormal ones, the people who really have mental health issues, the people we perhaps should be trying to cure, are the deluded few who are happy in life, who fail to see their black dogs or take them for walkies.

Coronavirus has tapped into our universal dread perfectly. Every action the Government fails to make to prevent it fulfils our tendency for despair. At once we are fulfilled because we are right and crushed by the horror of it. At the time of writing, South Korea is testing thousands every day, they have drive-thru testing centres which

provide results in 10 minutes. In the UK, the tiny few that are getting tested currently have to wait 72 hours for results. Think how many people you can infect in 72 hours.

But consider this, the fact that we are doing so little may have less to do with Government incompetence and more to do with the fact that a proudly "out-of-box" thinker like Dominic Cummings is in 10 Downing Street. For a chap who likes to think the unthinkable, a disease that disproportionately kills Boomers and spares the young, annihilates the generation that are blocking up the job market with their damned experience and health and not retiring and sitting on all those properties – it is a disease made in heaven. "Thanks for voting Brexit now just die."

Apocalypse now? It may not be the end of the world, but it will be for many. There are mad, surreal, prophesies in Revelations, but the world ending because someone in China fancied a bit of bat in their soup? Not even the Nostradamus went there.

the good of European football as a whole".

Elsewhere, the South American Football Confederation (Conmebol) says this year's Copa America, due to take place from 12 June to 12 July, has been postponed until 2021.

World governing body Fifa says the newly-expanded Club World Cup, originally scheduled to take place in China in June 2021, will be postponed and a new date announced when "there is more clarity on the situation".

The organisation is also going to donate \$10m (£8.3m) to the World Health Organisation (WHO) Covid-19 Solidarity Response Fund.

Many of Europe's domestic leagues - as well as the Champions League and Europa League - have been suspended following an increasing number of coronavirus cases around the continent.

Players and coaches have also been affected by the virus or been told to go into self-isolation, meaning leagues have had to shut down.

### How Europe's top leagues have reacted:

**Premier League:** All elite football in Britain cancelled until 30 April at the earliest subject to "conditions at the time".

**La Liga:** Spain's top flight suspended until 4 April at the earliest when it will "revaluate" the situation.

**Serie A:** Italy has the highest number of cases in Europe and the country is in lockdown.

**Bundesliga:** Suspended until at least 2 April in Germany.

**Ligue 1:** Games initially played behind closed doors in France but now suspended "until further notice".

# Football suspension extended to April 30

English football will be suspended until at least 30 April because of the continued spread of coronavirus.

All games in England's Premier League, EFL, Women's Super League and Women's Championship, and all fixtures in Scotland, Wales and Northern Ireland, are currently postponed.

The Football Association has also agreed that the current season can be "extended indefinitely".

Under current rules the season had been scheduled to end on 1 June.

A joint statement issued by the FA, Premier League and EFL expressed "a commitment to finding ways of resuming the 2019-20 season" and completing all domestic and European matches "as soon as it is safe and possible to do so".

The postponement of Euro 2020 has opened up a window for domestic league fixtures to take place in June.

However, the UK government has effectively banned sports events for the time being by advising against mass gatherings.

Last week, West Ham vice-chair Karren Brady said the current season should be declared null and void.

FA chairman Greg

Clarke also expressed his concern that it might prove impossible for the season to be concluded.

However Brighton chief executive Paul Barber told the BBC that it would be "unjust" if runaway leaders Liverpool were denied the title, and suggested increasing the league to 22 teams for 2020-21.

Fifa has also established a working group to tackle the issues facing football as a result of the pandemic. The group will look at the international fixture calendar, and issues around player contracts.

Player contracts typically expire on 30 June but many leagues, if resumed, look likely to continue beyond that date.

It was also announced that the Football League is to release a £50m short-term relief fund to help clubs with cash-flow issues because of the outbreak.

The fund includes the early release of award payments, and an interest-free loan facility.

The announcement was made after an EFL board meeting called to discuss the impact of the outbreak on clubs.

The Leasing.com Trophy final between Portsmouth and Salford City, scheduled for 5 April, has also been postponed.

Under the terms of the relief fund, Championship clubs will receive their remaining £800,000 award payment from the Premier League on Thursday. In addition, they will be able to apply for a £584,000 interest-free loan.

For League One clubs the figures are £250,000 and £183,000, and for League Two sides they are £164,000 and £120,000.

An additional £1m from the EFL Futures pot, a scheme which rewards clubs for giving opportunities to home-grown young players, will be allocated now on a pro-rata basis.

The 47 League One and League Two clubs told the EFL on Tuesday that they face an estimated combined loss of £50m

if the campaign cannot restart before the summer. Championship clubs are also unanimously behind trying to complete the season after all 24 second-tier sides held a video conference on Tuesday.

"As part of the League's continued contingency planning, the board heard the comments and observations from EFL clubs, before discussing a number of issues including the current financial position and implications, insurance, regulatory matters and broadcasting arrangements," an EFL statement read.

"Discussions centred on financial relief for clubs in the short term and while there is no one single solution, measures are to be put in place to

immediately assist with cash flow via a £50m short-term relief package."

Kelvin Thomas, chairman of League Two side Northampton Town, told the BBC: "The EFL decisions today are very useful short-term measures for clubs and it seems like there are more conversations being had, and to be had, in the background with other stakeholders."

"I think when the EFL and clubs have a better idea of what the future holds, we will be able to make more informed decisions."

The EFL has set up a dedicated task force that will continue to review the threat posed by the coronavirus pandemic and the impact on its clubs and competitions.

## CRICKET: switching Tests to Caribbean 'unrealistic'

■ Following cancellation of Sri Lanka tour, West Indies series also in doubt

Switching this summer's Test series from England to the Caribbean is "an unrealistic option", says Cricket West Indies chief Johnny Grave.

The three-Test series, set to start at The Oval on 4 June, is in doubt because of the coronavirus pandemic.

Grave is reported as saying a switch was a possibility but he told BBC Sport: "I have not had any discussions with

England over whether we can host.

"It would be strange that England can't have cricket but the Caribbean can."

He added: "Realistically, without knowing anything about pandemics, if England can't hold cricket then it almost certainly means the rest of the world can't hold cricket either. I think it is an unrealistic option."

Grave did say the

West Indies are being as "flexible as possible" to get the series played.

England's Test tour of Sri Lanka was called off last week with captain Joe Root saying the decision was a "relief" because players were distracted, thinking about families in the UK.

The sporting calendar has been decimated by the pandemic with football's European Championship one of many events

already called off.

The first Test in London is set to be followed by matches at Edgbaston and Lord's starting on 12 and 25 June respectively.

"I have been in contact with [England and Wales Cricket board chief executive] Tom Harrison a few times over the last week," Grave said.

"The only discussions we have had are, in principle, having flexibility over warm-up

games, when the series would start and how many rest days [there would be].

"We have given the ECB assurances that we will be as flexible as we can. We have not had any discussion about not playing them in June."

"We have not had any discussion about playing them later in the English summer. We have not had any discussion about hosting the matches here."

# Euro 2020 postponed

**Euro 2020 has been postponed by one year until 2021 because of the coronavirus pandemic.**

European football's governing body made the decision during an emergency video conference involving major stakeholders on Tuesday.

The tournament, due to take place from 12 June-12 July this summer, will now run from 11 June to 11 July next year.

The postponement provides a chance for European leagues that have been suspended to now be completed.

By moving the European Championship, Uefa now has a clash with the Women's European Championship, which is due to be held in England in 2021, beginning on 7 July.

The Nations League and the European Under-21 Championships are also scheduled to take place next summer.

Uefa said all three events will be "rescheduled accordingly", but it is currently unclear if that involves minor tweaks to dates, or large-scale postponements.

## 'solidarity'

In delaying Euro 2020, Uefa said it wanted to avoid "placing any unnecessary pressure on national public services" of its 12 host countries, as well as helping allow domestic competitions to be finished.

"We are at the helm of a sport that vast numbers of people live and breathe that has been laid low by this invisible and fast-moving opponent," said Uefa president Aleksander Ceferin.

"It is at times like these, that the football community needs to show responsibility, unity, solidarity and altruism.

"The health of fans, staff and players has


to be our number one priority and in that spirit, Uefa tabled a range of options so that competitions can finish this season safely and I am proud of the response of my colleagues across European football.

"There was a real spirit of co-operation, with everyone recognising that they had to sacrifice something in order to achieve the best result."

Ceferin said it was important Uefa "led the process and made the biggest sacrifice", adding it comes "at a huge cost" but "purpose over profit has been our guiding principle in taking this decision for the good of European football as a whole".
