# No quick end in sight as coronavirus deaths surge

- UK death toll zooms past 2,300
- 13-year-old is youngest victim

A SURGE in coronavirus deaths brought the UK toll to 2,352 on Thursday – the first daily rise of more than 500.

It marked the bleakest day since the outbreak. The latest victims included the youngest Briton killed, a 13-year-old boy with no health issues. The teenager, who died on Monday, is believed to be Ismail Mohamed Abdulwahab. New deaths reported were up almost 50 per cent on the previous day, from 381 to 563. But the true total will be higher as the figures cover only people tested positive for the virus who died in hospital.

The number of confirmed UK cases rose by more than 4,000 for the first time this week, bringing the total who tested positive to almost 30,000. Mr Sharma said 10,767 had been admitted to hospital with coronavirus, including 3,915 in London and 1,918 in the Midlands. Despite hopeful early signs that Britain’s lockdown appeared to be slowing the spread of Covid-19, the number of deaths are likely to rise for some days. vehicle traffic, saying: “The message here is people do need to stay at home.”

Professor Doyle said the record number of new cases was “slightly concerning” and it was too early to say whether a welcome plateau of hospital admissions at the start of the week had ended.

London is bearing the brunt but rising UK hospital admissions showed “the threat is

everywhere”, Prof Doyle said.

Figures show 1.7 million NHS 111 assessments over the last 15 days have resulted in people told they may have the virus. Assessments include 1.5 million symptom checks completed online and 243,500 over the phone.

They do not necessarily relate to individuals – some users may have sought help more than once.

The data, published by NHS Digital, comes after GP practices in England were told to open over Easter to help the NHS cope. The British Medical Association said emergency changes to contract regulations were likely to mean practices having to open on Good Friday and Easter Monday.

New guidelines could also mean delays to bone marrow transplants and radiotherapy treatments.

Most non-urgent cases of allogeneic transplants, which use stem cells from a donor, should be deferred until the risks associated with the outbreak have passed, the National Institute for Health and Care Excellence (Nice) said.

New radiotherapy guidelines advise doctors to weigh the risk of “cancer not being treated optimally” with the risk of patients become ill with Covid-19.

# £75m plan to bring stranded Brits home

**DOMINIC Raab has announced a £75million rescue package to bring home Britons stranded abroad by the coronavirus crisis.**

The Foreign Secretary said the cash would be used to fund repatriation flights after planes were grounded and international travel stopped by Covid-19.

The plan was announced after talks between ministers and airlines British Airways, Virgin, Easyjet, Jet2 and Titan Airways.

BA has already been working on repatriation flights, while the other companies signed a "memorandum of understanding" with Mr Raab.

The deal was announced as officials faced criticism from Britons flown back to Heathrow after being stranded in Peru. They claimed holidaymakers had missed planes because they were only notified of their flights out of Lima by email at short notice.

Mr Raab said the new mission would focus on destinations where

commercial flights have been halted, and would prioritise the sick and elderly.

He said: "This is a worrying time for many British citizens travelling abroad.

"We've already worked with airlines and governments to enable hundreds of thousands to return home on commercial flights.

## 'very difficult time'

"We will keep as many of those options open as possible.

"Where commercial flights aren't possible, we will build on the earlier charter flights we organised back from China, Japan, Cuba, Ghana and Peru.

"The arrangements agreed today will provide a clearer basis to organise special charter flights where Britons find themselves stranded.

"Our priority will always be the most vulnerable."

Foreign Office sources say about 300,000 Britons are stranded. It is aiming to bring most home via

the commercial flights still running.

However, about 60,000 should benefit from the new scheme to use charter flights, costing about £250,000 each.

Transport Secretary Grant Shapps said: "This is a very difficult time for British citizens travelling overseas, or those with families and loved ones abroad.

"We are doing everything we can to ensure airlines can operate and bring people back home safely."

Since the Covid-19 outbreak, the Foreign Office has helped return nearly 1,400 people on specially chartered flights from China and Peru, and 1,900 people from cruises. In the past week, the department has helped more than 4,000 people to get back from Jamaica and more than 8,500 from Morocco.

Another 5,000 Britons successfully left Bali after the British consular team in Indonesia worked to unblock a visa problem.

Under the scheme announced Monday

night, airlines would honour pre-booked tickets to enable passengers to get home.

They would offer alternative flights if routes were cancelled and organise replacement tickets, through other carriers if necessary.

Officials have already organised charter flights to Ghana and Tunisia, and more countries will be added this week.

Mr Raab added: "We are negotiating intensely with countries around the world to secure permission for return flights where airspace has

been closed."

But Britons who were flown home from Peru accused the Foreign Office of bungling their rescue mission. They claimed repatriation flights using British Airways planes were dogged by communication problems. The relieved holidaymakers said some of those stranded missed flights out because officials contacted them just hours before the early morning flight.

Shona McKenna, 33, from Luton, said: "We didn't get the email until midnight and we had to

be at the airport at 7am, so a lot of people were asleep and never got it.

"The first flight, a lot of people missed it because they didn't get the email in time. We had 50 people on standby but only 12 turned up to the airport."

A Foreign Office spokesman said: "We recognise British tourists abroad are finding it difficult to return to the UK because of the unprecedented international travel and domestic restriction.

"The office is working around the clock to support British travellers."

## Minister hints at easing of lockdown

**THE nationwide lockdown to slow the spread of coronavirus could be relaxed within weeks if the rate of infections flattens, a Cabinet Minister said this week.**

Robert Jenrick said if people stick to government advice, the numbers of infected people would fall and relieve pressure on the NHS. The Housing Secretary, offering hope to worried families, said: "If we all adhere to the measures, there is reason to believe they will begin to flatten the curve.

"And we could see the evidence coming through that the NHS is being able to cope with the situation as best as possible.

"If that is the case, there may be the potential to relax measures in a

sensible way in accordance with medical advice in the weeks and months that would follow that."

But he warned that the next two weeks will be critical as Britain surges towards the peak of the virus outbreak.

Mr Jenrick added: "It's likely the numbers will get worse in the coming days before they get better."

Some experts have indicated the worst period of the Covid19 epidemic could strike between April 6 and April 20, when most fatalities are likely to occur. Mr Jenrick said the deaths of a 13-year-old and a 19-year-old with coronavirus is a reminder that the disease affects everyone.

He said: "Every death is a tragedy but two young people dying is even more

sobering. It does remind us all that this is a virus that's indiscriminate.

"It doesn't just affect the elderly, or those who are extremely vulnerable because of their pre-existing conditions, although those people do need to take particular care. It can affect all of us.

"Some young people have felt almost invincible, and you saw that a couple of weeks ago with young people out enjoying themselves when we first started to implement social distancing measures.

"Now everybody understands and appreciates the seriousness of the situation, and is following the medical advice, which is to stay at home. By doing so, you protect the NHS and help to save lives."

## TV sales soaring

TV sales have soared by 60 per cent compared with last year. But shoppers are opting for basic models over more expensive sets, data suggests, with smaller screen sizes of 42in or less selling particularly well.

Kelly Whitwick, market insights expert at GfK, said: "People are facing having their entire household at home every day, possibly with the need to keep distance from each other, and almost certainly with very different views on what they want to watch – so they are quickly buying an extra TV to spread out around the house."

### Balson keeps rolling

BRITAIN'S oldest family business says its "very loyal" customers will help it beat the pandemic. Master butchers R J Balson and Son of Bridport, Dorset, started trading in 1515 and has survived floods, fire, plague and two World Wars. Proprietor Richard Balson said orders from pubs, restaurants and B&Bs closed in the lockdown "just finished overnight". But he added: "People are coming in and buying extra meat, especially things they can freeze

"We're being sensible and obeying the social distancing rules. But we still have time to stop and chat to our customers like we have always done – just at a safer distance."

ANGELA Rippon is offering free ballet lessons online to over-55s. Classes began this week at 1pm GMT for nine weeks via the academy's website and social media channels. Between sessions, bite-size videos will help viewers hone their skills.

# Harry and Meghan facing huge personal security bill

**THE Duke and Duchess of Sussex are facing a multi-million dollar security bill after losing their free personal protection squad following their move from Canada to the US.**

Harry and Meghan will need to pay top security specialists about £800 (\$1,000) a day and a team of guards will be required to patrol the perimeter of their property, according to Dai Davies, a former head of Scotland Yard's royalty protection unit.

They or their family, through the Queen or Prince Charles, have become liable for the costs because the Sussexes are no longer be working royals able to ask for assistance from host countries.

Harry, 35, and Meghan, 38, will lose their status as internationally protected persons under a 1973 United Nations treaty.

Buckingham Palace confirmed that the Sussexes will now pay

privately for their security after moving to Los Angeles earlier this month. It came after US President, Donald Trump, publicly stated that American taxpayers would not be footing the bill.

A spokeswoman for the couple, who are house-hunting for a place to settle with their 10-month-old son, Archie, said: "The Duke and Duchess of Sussex have no plans to ask the US government for security resources. Privately funded security arrangements have been made."

According to reports from Westminster, Home Secretary Priti Patel, has still not officially decided whether the Sussexes should receive some form of protection at the Treasury's expense. A source at the Treasury said: "If you look at the cost over their lifetimes it's got to be £100 million plus.

£90,000 to £110,000 per year and then you've got their travel and accommodation. They fly business class everywhere.

"If you are paying for a top personal protection officer privately that's going to cost \$1,000-a-day at least for top end people, which is what they will need. You'll need several of them plus a few to man the gates and do other things."

In a final update before quitting their royal roles, the couple this week confirmed they had dropped plans to create a charitable foundation.

Their only outlet will be Travalyst, a not-for profit organisation created by Harry to promote ethical tourism. They plan to spend the next few months "focusing on their family and continuing to do what they can, safely

and privately, to support and work with their pre-existing charitable commitments while developing their future non-profit organisation".

The couple are also mothballing their Sussex Royal Instagram account and website and will no longer use the royal title. Their new chief of staff is Catherine St Laurent, who previously worked for Bill Gates's wife Melinda.

## Coronavirus briefs...

**COSTUME designers from some of Britain's top TV dramas have come together to make hospital scrubs for NHS staff fighting coronavirus.** The team – including some from His Dark Materials and Downton Abbey – have used industry contacts to buy around 2,000 feet of fabric to run up uniforms from their homes. The project has the acronym HDM, first used for the BBC's Philip Pullman fantasy hit but which now means Helping Dress Medics. More than 170 people have donated money to buy material since the group's GoFundMe page launched at the weekend.

**TV WILDLIFE presenter Kate Humble** reckons the pandemic will help people rediscover practical skills as everyday conveniences are more difficult to access. The 51-year-old former Londoner, who is isolating at her Monmouthshire smallholding, also predicts an exodus of city dwellers moving to the countryside as they get a taste for a slower-paced life. She told *Radio Times* magazine: "What convenience does is rob us of all the things that make us happy. We don't grow things any more, we don't fix things any more. I think there'll be a lot of rebalancing."

# Frieze Los Angeles 2020

I was very excited to attend Frieze LA for the first time in February.

I've been lucky enough to have attended Frieze New York and Frieze London for several years, and LA's second Frieze edition was just as insightful and rewarding. Launched in 2019, Frieze LA celebrated its sold-out second edition last month, shining a spotlight on LA's artistic communities, and bringing together over 75 local and international galleries, as well as artists, institutions and collectors. The 2020 edition attracted over 35,000 visitors during its 4 days at Paramount Pictures Studios.

Within the gallery tent, world-renowned art-houses such as Gagosian, Pace, Hauser & Wirth, David Zwirner, Blum & Poe and Spruth Magers all had booths, as well as local galleries like The Box, Kayne Griffin Corcoran and David Kordansky Gallery (to name a few). Of the many incredible artists presented at Frieze, the below captures just a handful of the key stand-outs.

West-coast based, James Turrell's LED installations (above, right), co-presented by Pace Gallery and Kayne Griffin Corcoran, seduce you in their immersive light and bright colours.

As Turrell notes, "I want the light itself to be the revelation." Associated with the Light and Space movement of the 1960s, Turrell investigates 'perceptual art', exploring the materiality of light and sensation, and interrogates the connection between constructed light and painting with light. Also showcased was Turrell's first ceiling-mounted artwork, part of his Glass series, which progresses through a two-and-a-half hour colour sequence, creating a riveting and hypnotic narrative of light and colour. Turrell builds on the emotional experience of space, colour and perception. The installation also sought to raise awareness of his Roden Crater – an open-air observatory built inside a collapsed volcano in the Arizona desert.

An incredibly striking artwork, (and one of my favourites) is Sterling Ruby's WIDW.TERROR TEARS (2020) (far right), presented by Brussels-based gallery Xavier Hufkens, which sold early-on for \$350,000. Ruby, who lives and works in LA, is known for his material experimentation, and his WIDW (window) series (2016-) is no exception. His use of cheap recycled scraps, as well as polished materials,

highlights his perception around archeology in the production of art, in that all materials existed previously, were laid to rest, and through the creation of art, were dug up and brought back to life.

At the Maureen Paley booth (and the esteemed Maureen Paley herself was in attendance) was Peter Hujar's David Lighting Up, Manhattan-Night (I) (1985), (below) printed posthumously in 2018 (fig.4). Hujar,

related pneumonia, David became an AIDS activist. His work unapologetically and loudly confronted the AIDS crisis and persecution of sexual minorities in Ronald Reagan's America. Hujar's death greatly impacted Wojnarowicz, and he later said "Everything I made...I made for Peter." David died from complications related to AIDS in 1992, at the age of 37.

One couldn't miss (even if one wanted to!) Richard Prince's all-American, macho and aggressive, souped-up muscle car, the Ford Mustang, presented by Gagosian with a price tag of \$5 million

(below). Considered both a sculpture and a painting, Untitled (2008) reflects the artist's incessant fascination with American subcultures and its reverence of celebrities, fast cars, bikes and cowboys.

New for 2020, Frieze presented its "Focus LA" section, promoting local artists and providing a stage for emerging LA art spaces that have been open for 15 years or less. The backlot also hosted multiple pop-ups, including Roberta's pizza and multiple Ruinart champagne stands.

**Aston Villa captain Jack Grealish says he is "deeply embarrassed" after he was pictured at the scene of a car accident on Sunday.**

Various newspapers reported Grealish drove his £80,000 Range Rover into a number of parked vehicles outside the party in Solihull.

The alleged incident came just hours after Grealish, 24, had posted on social media asking fans to "stay home" during the country's coronavirus lockdown.

He has been fined and disciplined by the club with the proceeds donated to The University Hospitals Charity in Birmingham.

In a video message Grealish said: "I got a call off a friend asking to go round and I

stupidly agreed.

"I don't want anyone to make the same mistake I did.

"I know it's a tough time for everyone at the moment being locked indoors for so long," he added.

"But I urge everyone to stay indoors and follow the guidelines and I know I'll be doing that in the near future now."

Grealish then added that he "hopes everyone can accept my apology" and that everyone can "move on" and be out "enjoying themselves once this has all boiled over".

West Midlands Police said they were called just before 10am on Sunday to the Dickens Heath area of Solihull to reports that a Range Rover had crashed into two parked cars in

the street, causing them minor damage.

The force said the driver had left his details with a member of the public before leaving on foot and would be spoken to by police in due course.

Images surfaced online on Sunday of a damaged white Range Rover, as well as a picture that appeared to show the Villa midfielder in slippers and a bright blue hoodie.

Villa said in a statement: "Aston Villa is deeply disappointed that one of our players ignored the Government's guidance on staying at home during the coronavirus crisis.

"Club captain Jack Grealish has accepted that his decision to leave his house was wrong and entirely unnecessary."

## Premier League restart pushed back

**The restart date for the Premier League was due to be pushed back on Friday after a meeting of all 20 Premier League clubs, who convened via video.**

The meeting took place after the British Weekly went to press but it was clear that there is no hope of professional games being played immediately after the current 30 April deadline.

The Premier League could shift the date back

into May or opt to follow Spain and France, who have shut down their leagues for an indefinite period.

Italy have talked of Serie A returning in late May, but that seems optimistic.

Pushing the date back would allow Premier League clubs the chance to offer their stadiums and medical staff to the National Health Service, knowing they would not be required in the short

term.

That would at least correct some of the negative publicity that has accompanied news that four clubs, including Tottenham, are already using the government's furlough scheme to compensate laid-off workers by up to £2,500-a-month, despite their players and manager Jose Mourinho, some of whom earn in excess of £100,000-a-week, remaining on full pay.
