# BORIS ON THE MEND!

■ PM out of intensive care and 'continues to improve'

■ Johnson thanks NHS for 'brilliant care'

**Prime Minister Boris Johnson has been moved out of intensive care but remains in hospital, Downing Street has said.**

Mr Johnson has been receiving treatment for coronavirus at St Thomas' Hospital in London since Sunday.

No 10 said he "has been moved this evening from intensive care back to the ward, where he will receive close monitoring during the early phase of his recovery".

A spokesman added: "He is in extremely good spirits."

He was taken to hospital on Sunday -

10 days after testing positive - and was moved to intensive care on Monday.

The prime minister was receiving "standard oxygen treatment" in intensive care and had not been on a ventilator, Downing Street said earlier.

He "continues to improve" after a "good night" and thanked the NHS for the "brilliant care" he has received, the spokesman added.

Meanwhile, applause

rang out across the UK in the third "Clap for Carers" event, where people in lockdown show their appreciation for NHS staff and other workers on the front line of the pandemic.

A total of 7,978 people have now died in hospital after testing positive for coronavirus, up by 881 on Wednesday.

Foreign Secretary Dominic Raab has urged the public to stay indoors over this Easter weekend, saying

that after almost three weeks of lockdown "we are starting to see the

impact of the sacrifices we've all made".

"Let's not ruin it now," he added.

Mr Raab, who is deputising for the PM, said a decision on whether to ease the lockdown measures would not come until "the end of next week".

## 'World-class care'

Giving his reaction to the latest development, US President Donald Trump tweeted: "Great News: Prime Minister Boris Johnson has just been moved out of Intensive Care. Get well Boris!!!"

Health Secretary Matt Hancock tweeted: "So good that the prime

minister is out of intensive care and on the road to recovery. The NHS is there for us all and I know our amazing NHS staff have given him their characteristic world-class care."

Speaking earlier at the Downing Street daily briefing, Mr Raab said he had not spoken to Mr Johnson since his admission to hospital.

"I think it is important to let him focus on the recovery - we in the government have got this covered," said Mr Raab.

Mr Raab added that he has "got all the authority I need" to take decisions along with his cabinet colleagues.

## Trump is 'terrifying campaigner', says former DC ambassador

Britain's former ambassador to the US has described President Trump as a "terrifying" and "lethal" campaigner, in his first interview since he was forced out of the job.

Lord Darroch of Kew, 65, resigned last July when he came under sustained attack in a series of tweets from Mr Trump after condemning the administration as "inept" in leaked diplomatic cables. He failed to secure

explicit support from Boris Johnson, who at the time was frontrunner to be the new prime minister.

The furore surrounding the leak of sensitive cables written by the ambassador marked a low point in transatlantic relations, with Mr Trump criticising him as "wacky", "stupid", "pompous" and "not liked or well thought of within the US". He added that "we will no longer deal with him".

Lord Darroch, who was appointed a life peer in Theresa May's resignation honours list, intends to publish a book called Collateral Damage in September. In a preview of his memoir, he said that "we called Trump as a likely election winner back in February 2015" — suggesting he would use the book to answer criticism that the Foreign Office did not build strong enough links with the Trump campaign because it was

too focused on Hillary Clinton.

"I've always thought that he is an extraordinary campaigner and in a way, he's a terrifying politician to try and take on," Lord Darroch said. "Whoever wins the Democratic nomination has got to stand up against one of the most lethal politicians in the modern era. As a campaigner and as a competitor, he is kind of terrifying."

# New Labour leader unveils shadow team

**NEW Labour leader Sir Keir Starmer has unveiled his shadow ministerial team following his victory in the race for the party's top at the weekend.**

They include prominent critics of his predecessor Jeremy Corbyn, including Jess Phillips, who was briefly a leadership contender.

Ms Phillips will be part of the shadow home affairs team, focusing on tackling domestic violence.

Liz Kendall, who came last in the 2015 Labour leadership election, has been made a shadow health minister.

Sir Keir has appointed Angela Rayner, who won the contest to be Labour's deputy leader, as shadow first secretary of state. She will also deputise for him at Prime Minister's Questions and in other key functions.

## 'Next election'

Dr Rosena Allin-Khan, a defeated contender in the 2020 deputy leadership race, also joins the shadow health team, under Jonathan Ashworth, who continues as shadow health secretary.

Sir Keir said: "This is a new team that will take the Labour Party forward in a new era."

"Under my leadership, the Labour Party will be utterly focused on working in the national interest, rebuilding people's trust in our party and winning the next election."

Earlier this week, Sir Keir appointed former Labour leader Ed Miliband to his new shadow cabinet and named leadership rival Lisa Nandy as his shadow foreign secretary.

Sir Keir won the Labour leadership contest last Saturday, beating Ms Nandy and Rebecca Long-Bailey to the role by a convincing margin.

He has appointed Ms Long-Bailey - a leading figure on the left of the party and a key ally of Mr Corbyn - as shadow education secretary.

Nick Thomas-Symonds - the shadow solicitor general - was promoted to the role of shadow home secretary.

## 'Business support'

Anneliese Dodds was promoted to shadow chancellor, after serving

in a junior role under John McDonnell, who has quit the frontbench.

Pat McFadden - a minister under Gordon Brown, sacked by Mr Corbyn from his shadow team - has been made shadow economic secretary.

Wes Streeting, one of Mr Corbyn's most vocal critics, has been promoted to shadow exchequer secretary, a junior role on the shadow Treasury team.

Ms Dodds has, meanwhile, written to Chancellor Rishi Sunak, following a meeting with him, to offer to work constructively to "prevent further damage to jobs and incomes" and "provide the public and businesses with the support they need".

In her letter, she highlighted concerns about some employers failing to furlough employees, and the apparently low take-up of the Coronavirus Business Interruption Loan Scheme.

She also called on the government to increase international coordination to prevent widespread bankruptcies and barriers to trade.

## NHS labs will help boost antibody tests to 90,000/day

**NHS laboratories are planning to carry out tens of thousands of antibody tests every day to tell staff and patients whether they have recovered from coronavirus.**

Britain's top laboratory doctor is co-ordinating efforts to use existing machines to run highly accurate tests checking whether people have had the virus with the hope of reaching 90,000 a day in the next couple of months.

The use of NHS labs could help to plug the gap caused by the failure of home testing kits and discussions are now under way to decide who will have priority for checks. NHS staff and patients needing treatment for other conditions are likely to be the first.

Antibody tests that tell people whether they have recovered from coronavirus are seen as vital to charting a course out of lockdown and allowing those who have developed immunity to return to normal life.

However, home testing kits assessed by the government all proved too inaccurate for use and the Department of Health said on Wednesday it would be asking for its money back after buying three million unusable home tests from China.

Antibody tests have, however, proved accurate using a standard laboratory diagnostic tool and are being used in a research programme with a sample of the population to discover how widely the virus is spreading.

Jo Martin, president of the Royal College of Pathologists, said she had been asked to work with NHS labs to see whether similar tests — known as enzyme-linked immunosorbent assays (Elisa) — ordered from commercial suppliers could be used in local hospitals. "In labs around the country there is capacity to do tens of thousands of a day, probably 90,000 a day if we really went for it," she said. "We've got

the staff and we've got the equipment."

She added: "It is not being done very widely at all but that's why I've been asked to roll it out... We know that some labs have ordered the Elisa kit and are waiting for this to be delivered. This will have to be checked and validated and then if they are effective they will start over the next couple of months."

Doctors and nurses would be among the first tested. "If I had a cough, cold or headache a month ago and then present again with a cough, cold or fever but have antibodies to Covid-19 it is not likely to be Covid-19," she said. "We know that staff will find that reassuring."

Patients scheduled for urgent surgery or chemotherapy could also be checked to see if it was safe for them to go ahead with procedures. "If you as a patient are immune to Covid then you reduce your risk of becoming ill if you come into hospital for other treatments," Professor Martin said.

## Fergie praises NHS

Sir Alex Ferguson has praised the NHS for "saving my life" two years ago, and for its "magnificent" response to the coronavirus pandemic.

Ferguson's comments came as Manchester United announced a package of additional measures to support the NHS, including medical and protective equipment, and use of the club's vehicle fleet.

"I'm delighted we are now recognising the importance of our NHS, as I experienced two years ago after they saved my life," Ferguson said. "The response to this pandemic has been magnificent and has made me proud of the way the club and the British people have rallied round to help. Well done."

The former United manager was treated at Salford Royal hospital in May 2018 after a brain haemorrhage, spending four days in intensive care.

United are already part of the Premier League's commitment to supporting the NHS, and the club's players are involved in the #PlayersTogether charity initiative. The club have now put their 16-vehicle fleet on standby, with volunteer drivers available to support their courier operations.

The club's foundation has delivered gifts to 3,500 NHS workers and is continuing to support the children of key workers. United have also donated medical equipment and consumables to the Salford Royal, including protective equipment, dressings and other club medical supplies.

# Expected peak still some weeks away

The UK coronavirus death toll is expected to continue to rise for at least two weeks, the government's chief scientific adviser has said, despite encouraging signs about the rate of infections and hospital admissions.

Sir Patrick Vallance told Thursday's daily Downing Street briefing that the number of people to have died from coronavirus in UK hospitals had reached 7,978, after the deaths of a further 881 people. It is the second-highest daily total after Wednesday's record 938 deaths.

Despite the slightly lower figure, Vallance said the peak of the outbreak could still be weeks away. "I would expect the deaths to continue to keep going up for about two weeks after the intensive care picture improves. We're not there yet, but that's the sort of timeframe I would expect."

The chief medical officer for England, Prof Chris Whitty, pointed out that two weeks ago admissions to intensive care were doubling every

three days. He said: "It's now becoming not quite flat, but doubling time is now six or more days in almost every area in the country. That has only happened because of what everybody has done in terms of staying at home."

The official UK figure of 881 new deaths differs from the 891 total from figures released separately by agencies in

the UK's four countries, which gather their data differently. NHS England said a further 765 people had died, ranging in age from 24 to 103. Only 43 of those patients had no known underlying health condition.

Scotland recorded 81 deaths, taking its total to 447. Unlike the rest of the UK, Scotland's total includes some deaths

outside hospitals because it counts all fatalities where Covid-19 is recorded as a cause on a death certificate.

Wales recorded 41 deaths, taking its total to 286; and in Northern Ireland there were four more deaths, taking its total to 82.

Last week the health secretary, Matt Hancock, said the NHS was preparing for at least 1,000

deaths a day, at a time when scientific advisers were forecasting the outbreak to peak at Easter.

The peak is now expected to come in four weeks, after signs that the transmission rate was beginning to fall. New infections continue to fluctuate. On Thursday, 4,344 new cases were recorded, compared with 5,492 on Wednesday.

The crossbench peer was interviewed by the Harvard Political Review after becoming a fellow at the university for its spring term. His successor, Dame Karen Pierce, 60, arrived in Washington on the last flight before Mr Trump banned arrivals from Britain and spent her first two weeks quarantined at the embassy residence.

Lord Darroch attributed Trump's success to the perceived 'authenticity' of his message. He said: "People are no longer trusting mainstream politicians to have the answers to the problems that they see every day.

So it's not that populism has just risen from nowhere. It has risen because of the failure of the established political process."

He said that his two stints as a press spokesman showed how mainstream politicians were careful to make "safe" statements while populists were not afraid to give "straight answers", even if they were controversial.

"It gives them a stamp of authenticity," he said. "People listen to mainstream politicians and hear code and evasion, and they listen to populists and hear clarity and simplicity. It may be in some cases that it's fantasy, because these simple, straightforward answers just simply don't work."

# Saints lead the way in wage deferrals

Southampton first to announce measures to aid non-playing staff; City's Guardiola will also take pay cut

Southampton have become the first Premier League team to announce an agreement with their players over wage deferral during the coronavirus crisis.

They have announced measures to help the club and non-playing staff through the Covid-19 pandemic. Southampton's players, the manager Ralph Hasenhüttl and his coaching staff have agreed to defer part of their salaries for the months of April, May and June "to help protect the future of the club, the staff that work within it and the community we serve".

In addition, the club have confirmed that they will not use the government's job retention scheme to furlough non-playing staff during that three-month period.

It comes after it emerged that Manchester City are in advanced talks with their players about wage deferrals. City are

understood to be making good progress, even though sources are urging caution on how those discussions will conclude.

There is an expectation that the sheer wealth of City's Abu Dhabi owners will enable the English champions to emerge from the crisis without it having an impact on staff.

It was revealed this week that Pep Guardiola, the City manager, had agreed to take a cut to his £20 million salary — along with senior executives — and it is understood that Ferran Soriano, the chief executive, wants the players to follow suit.

City were the first club to announce that they would not be placing any staff on furlough and have agreed to hand over the Etihad Stadium to the NHS. The desire for players to accept some kind of deferral is in line with the need to run the club like a proper business, particularly after the recent financial fair play

breaches that resulted in them being banned from the Champions League for two seasons.

City stand to lose more than £100 million if the season is not completed and financial decisions have to be made in the interests of their Chinese and American investors as well as the major stakeholders from Abu Dhabi. Discussions between the Premier League, players and the Professional Footballers' Association (PFA) on Saturday ended with proposals that included possible deferrals of up to 30 per cent of pay.

Bobby Barnes, the deputy chief executive of the PFA, believes that players fear clubs could use a temporary pay cut to reduce their wage bills permanently. He said: "There is an underlying suspicion of the players that this is a reset from the clubs, who have long felt that player wages are the biggest expenditure."
