Coronavirus vaccine trial begins in Oxford

"It's not just for this country, we need to make a vaccine for the world."

The first human trial in Europe of a coronavirus vaccine has begun in Oxford.

Two volunteers were injected on Thursday, the first of more than 800 people recruited for the study.

Half will receive the Covid-19 vaccine, and half a control vaccine which protects against meningitis but not coronavirus.

The design of the trial means volunteers will not know which vaccine they are getting, though doctors will.

Elisa Granato, one of the two who received the jab, said: "I'm a scientist, so I wanted to try to support the scientific process wherever I can."

The vaccine was developed in under three months by a team at Oxford University. Sarah Gilbert, professor of vaccinology at the Jenner Institute, led the preclinical research.

"Personally I have a high degree of confidence in this vaccine," she said.

"Of course, we have to test it and get data from humans. We have to demonstrate it actually works and stops people getting infected with coronavirus before using the vaccine in the wider population."

Prof Gilbert previously said she was "80% confident" the vaccine would work, but now prefers not to put a figure on it, saying simply she is "very optimistic" about its chances.

The vaccine is made from a weakened version of a common cold virus (known as an adenovirus) from chimpanzees that has been modified so it cannot grow in humans.

trials come larger efficacy tests, in which the drug is given to thousands of people to see if they are protected from infection. Whether a vaccine can be developed before the end of the year will depend on the speed of the trials and whether it can be made at scale.

Ordinarily, manufacturers wait for a vaccine to be proved successful before producing it. With the doses required for any coronavirus vaccine, that could mean months lost.

Speaking at a press conference, Mr Hancock confirmed that manufacturing investment would be running in parallel. "If either of these vaccines safely works, then we can

make it available as soon as humanly possible," he said. "After all, the upside of being the first country in the world to develop a successful vaccine is so huge that I am throwing everything at it."

Gilbert, an Oxford University professor of vaccinology, said that to get to this stage her team had compressed five years of work into four months. She added: "It's not just for this country, we need to make a vaccine for the world."

The vaccine that she

and her colleagues at the Jenner Institute have developed uses a harmless virus to carry part of the coronavirus's genetic material. In the body this induces cells to produce proteins identical to those on the surface of the coronavirus so training the immune system to spot them.

Oxford hopes to have the drug ready by autumn if the trials are a success. "The prospects are very good," Professor Gilbert said, "but it's not certain."

NHS soon to reopen for routine care as virus passes peak

The NHS will reopen "within very short order" for routine care, the health secretary said on Wednesday amid warnings that 60,000 cancer patients could die through lack of treatment or diagnosis.

Matt Hancock told the Commons that the coronavirus peak had been reached and that hospitals again had the capacity to attend to victims of cancer, heart attacks and strokes. Routine surgery would resume shortly, with the NHS having 10,000 free beds and with the outbreak no longer worsening, he said.

On Wednesday 759 further coronavirus deaths were reported in hospitals, taking the total to 18,100.

Mr Hancock declared victory in the battle to stop the health service being overwhelmed. He said there were 3,000 intensive care beds available, three times more than at the start of the outbreak even before counting the temporary Nightingale hospitals. "Within very short order we will start to restart the NHS," he said.

Senior doctors are increasingly worried about the potentially

deadly fallout from the lockdown and efforts to free up NHS beds to treat coronavirus patients. Cancer Research UK has estimated that more than 2,000 cancer cases a week are being missed because GP referrals are down by three quarters.

Karol Sikora, chief medical officer of Rutherford Cancer Centres, told ITV that up to 60,000 cancer patients could die because of lack of treatment or diagnosis.

"It's absolutly right to stop the treatment for some cancers in the face of coronavirus. But for others, a delay of more than a month would have a negative impact on the future prognosis," he said.

Mr Hancock said he wanted to "emphasise that people with non-coronavirus symptoms must still contact their GP. If you are told to go to hospital, the place you need to be is in hospital."

Pregnant women and parents of young children must also seek help because "non-Covid NHS services are open for patients. The NHS is there for you if you need advice and treatment."

Hospitals have been told to cancel all non-

urgent operations but Mr Hancock said that with demand for coronavirus care no longer rising, "we will gradually reopen the rest of the NHS to non-life-threatening elective surgery as soon it is safe to do so".

He cautioned that he could not "give the guarantee that all cancer treatment can go ahead"; in some instances, it would be "clinically inadvisable".

Derek Alderson, president of the Royal College of Surgeons of England, said: "Some cancer operations have been cancelled as a twofold measure: to allow further capacity for Covid-19 patients but to also to keep cancer patients away from hospital, so they are at less risk of catching Covid-19.

"There are, of course, some cancer operations which will need to be prioritised sooner, and the recent guidance from NHS England will help clinicians to ensure that they are. We are working with government to establish Covid-free centres where some cancer treatment can take place with minimal risk of infection."

Army of thousands coming to help trace coronavirus victims

■ Key move for easing social distancing promised within weeks as Britain reaches infection peak

An army of thousands of coronavirus contact tracers is to be trained within weeks to help Britain to exit lockdown.

Council staff and civil servants are among those who will be drafted in as part of a three-tier system to ensure that every infected person is isolated before they pass the virus on to others.

Public Health England aims to have a system running within three weeks so that it can be used if the government wants to ease restrictions.

As he declared on Wednesday that Britain had "reached the peak" of coronavirus cases, Matt Hancock, the health secretary, promised "very large scale" contact tracing would be in place to allow social distancing to be relaxed.

John Newton, the government's testing chief, said today that it would have the capacity to meet Mr Hancock's target of testing 100,000 people a day by the end of next week.

He told ITV's Peston that progress so far was "ahead of target" and that there would "certainly" be the capacity for that number of tests before May. "There will be a lot more access for a lot more people quite soon," he said.

Asian countries such as South Korea and Singapore have kept outbreaks under control and minimized deaths through intensive tracing of the movements of those shown to be infected, with those who have come into close contact ordered to self-isolate.

Britain abandoned mass contact tracing a month ago as testing capacity failed to keep up with the epidemic.

The aim would be to track more than 80 per cent of people with whom an infected person had been in contact within 24 hours of diagnosis. Infected people and those they had contact with would be quarantined until the risk that they could get the illness had

passed

The plan emerged as:

- The chief medical officer warned that some social distancing would last the rest of the year and the World Health Organisation said that "the virus will be with us for a long time".
- A national "antibody census" will test 300,000 people over the next year to build up a picture of how the virus has spread through Britain.
- Hospitals have been admonished for stockpiling supplies as it was revealed that the NHS needs up to 60 million masks a week for frontline workers.
- Parliament hosted the first partly virtual prime minister's questions in a sitting largely free of technical glitches.

Mr Hancock told MPs: "As we bring the number of new cases down so we will introduce contact tracing at large scale . .

. Our goal is to get to a point where we can test, track and trace everybody who needs it."

Borrowing set to soar to record levels

The UK's budget deficit is set to see "an absolutely colossal increase to a level not seen in peacetime", the director of the Institute for Fiscal Studies has said.


The economic impact of coronavirus was likely to push the deficit to as high as £260bn, Paul Johnson told the BBC.

He was speaking on Thursday after latest figures showed that the deficit hit £48.7bn in the 2019-20 financial year.

But Mr Johnson said those figures were "the numbers before the storm".

And, separately, one of the Bank of England's top policymakers has warned that the UK faces its worst economic shock in several hundred years.

Jan Vlieghe, a member of the BoE's interest-rate setting committee, said that "early indicators" suggest the UK was "experiencing an economic contraction



that is faster and deeper than anything we have seen in the past century, or possibly several centuries".

He did, though, say there was "in principle" a good chance that the UK would return to its "previrus trajectory once the pandemic is over".

The UK's deficit last year - the gap between the government's income and its expenditure - was £9.3bn higher than in the 2018-19 financial year and equivalent to 2.2% of CDP

The Office for National

Statistics, which released those figures, said they did not capture the big spending announced by the government to cope with the virus.

"The coronavirus (Covid-19) pandemic is expected to have a significant impact on the UK public sector finances," it added.

"These effects will arise from both the introduction of public health measures and from new government policies to support businesses and individuals."



Tax rises

The ONS said the full effects of coronavirus on the public finances would become clearer in the coming months.

Mr Johnson told the BBC's Today programme that there was still "a huge amount of uncertainty" surrounding the economic impact of the virus.

However, the government had announced tax cuts and spending increases worth £100bn, so the effect was "likely to dwarf the record that we

saw during the financial crisis".

Mr Johnson said the economy was unlikely to recover quickly afterwards and would remain "smaller than it otherwise would have been". He added that tax rises and a growing deficit were the likely outcome.

"I would be astonished if in a couple of years the economy was back where it would have been if it [the virus] had never happened," he said.

Meanwhile, a closely

watched survey of UK businesses has indicated that the economic impact has been even worse than feared.

The IHS Markit/CIPS flash UK composite purchasing managers' index (PMI), which measures activity in the services and manufacturing sectors, fell to a new record low of 12.9 in April, down from 36 in March.

Any reading below 50 indicates contraction. Economists polled by Reuters had expected a figure of 31.4.

Pandemic has brought Britain and China closer, Beijing ambassador Liu Xiaoming claims

The coronavirus pandemic has brought Britain and China closer together, Beijing's ambassador to London claimed on Thursday.

Liu Xiaoming hailed the unprecedented dialogue and "very close work" between the two countries on finding a vaccine.

His comments came amid warnings that Britain should rethink the relationship in the light of issues raised by the pandemic, in particular the reliance on Chinese technology.

"China and the UK are working very closely on a vaccine," Mr Liu claimed in a webinar with the think tank Asia House. "Our two countries are sharing information and experience, conducting

joint scientific research . . . President Xi and Boris Johnson expressed support for the scientists of the two countries to work together on this very important area."

Each country's search for a vaccine is separate but Mr Liu hailed cooperation during the pandemic as the model for a relationship.

"In the matter of one month, President Xi and Boris Johnson have had two telephone conversations," he said.

Dominic Raab, the foreign secretary, was also in close contact with his Chinese counterpart, as was Mark Sedwill, the cabinet secretary and national security adviser. Matt Hancock, the health secretary, held his most

recent discussions with his Chinese counterpart on Wednesday, he said.

"I've been here as ambassador for more than ten years and I've never seen our top leaders have such intensive communications in such a short time," Mr Liu said. "I am confident that China and the UK will emerge from this test with a more mature and robust relationship."

Technology such as the video-conferencing platform Zoom, on which businesses and individuals are increasingly relying, would improve considerably once Huawei's 5G installation in Britain was complete, he said.

"Once you have Huawai participating in

this online technology the speed and quality of these meetings will be even better," he said. "I know Prime Minister Johnson has a very ambitious plan to have full coverage of the UK by 2025 in 5G. Huawei will be a big help in this."

Britain's decision to allow Huawei a role in the network has frayed relations with Washington, which has lobbied for the Chinese telecoms company to be dropped. Since the pandemic, the Trump administration has launched a diplomatic and PR offensive against China, blaming Beijing for the spread of the virus and cutting off funds to the World Health Organisation.

Mr Liu hailed Beijing's decision to give further \$30 million to WHO, the replacing funding shortfall by Washington, the left suggested and Beijing London were natural partners in the strengthening of the multilateral institution that President Trump is abandoning.
