

TOO MUCH, TOO SOONP UK begins to ease lockdown, but social distancing remains impossible on public transport

SAFETY regimes to stop the spread of coronavirus collapsed on Tuesday as commuters crammed on trains for the first day back.

Standing room only on some London underground trains made social distancing rules impossible. Large crowds were pictured on platforms waiting for trains before passengers piled on. As signs of normal life returned with garden centres and civic amenity tips reopening, facemasks were in evidence. But the recommended protection to stop wearers spreading the killer disease was scant among commuters. Meanwhile rush hour traffic rose in the capital as thousands drove to work. On Sunday night Boris Johnson tried to revive the economy by easing restrictions following a drop in the death rate. He said those who can should continue to work from home but if that is not possible they should return to the workplace.

overcrowding

But he added: "We want it to be safe for you to get to work. So you should avoid public transport if at all possible, because we must and will maintain social distancing, and capacity will therefore be limited."

He urged workers to commute by car, walking or bicycle. But the events of this week showed that for many his message is impossible to follow.

Compounding the risk of overcrowding is the fact that the public transport network is running at greatly reduced capacity. London Mayor Sadiq Khan said that if the tube and bus networks were running normally they would still only be able to carry 15 per cent of their normal 10 million passengers a day due to social distancing requirements.

He told BBC Breakfast: "Even if we were to run at 100 per cent on the Tube and buses – and we're running 85-95 per cent of our buses and 60-65 per cent of the Tube in rush hour – it is not possible to adhere to social distancing rules unless there's about 15 per cent of people using public transport.

"So the key message from the Prime Minister and from me today is do not use public transport. Public transport is for essential workers, particularly in rush hour." The worst congestion London on was Underground from where commuters posted pictures of crowded platforms and carriages.

One passenger tweeted: "Tube trains in London absolutely jam-packed. Social distancing is being completely ignored."

'just not possible'

But the problems facing commuters who are more than a bicycle ride from work are not

confined to the capital.

One tweeter said: "When I was working in Bradford people were commuting daily from Manchester, Sheffield, Leeds, Barnsley, Doncaster. Just not possible."

Semi-retired doctor Peter Harrison questioned how guidelines on public transport could be observed. He tweeted: "How is social distancing possible in a plane or train with air conditioning and no way to open windows." Commuters admitted

to being nervous about safety. Gerry Tiernan, 54, who works in the costume department at English National Ballet, said: "I am surprised at the amount of people who aren't wearing masks. "It's going to be pure luck as to whether you get it (Covid-19) or not. There are signs on the Tube saying 'Keep two metres apart' but no-one is doing it."

Doctor James Wilson, 29, who works at West Middlesex Hospital in Isleworth, is very nervous about how his commute will change. He said: "We have only just got past the peak of the virus and we need a longer period of things being sustained at this level. If we stop social distancing, we are going to see it back in three weeks." The Rail Delivery Group

said major national rail stations were quiet this week with the network at about half its normal capacity. Consultancy Teneo said demand for services is nearly double that available and will rise. Spokesman Matt Lovering said: "The Prime Minister has said people should avoid transport if possible.

"However, that is not a plan to reopen the country, it's simply an admission that the Government has not worked out how to make public transport safe."

"recession to end all recessions" is forecast - and it may continue for years

THE Treasury is set to lose up to £130billion in taxes due to the Covid-19 crisis as experts warn of "a recession to end all recessions".

The blow – calculated for this fiscal year after businesses were shuttered and many were left unable to work – is more than the Government is spending on propping up the economy.

As the UK death toll rose above 33,000, Chancellor Rishi Sunak admitted we are "very likely" already in the middle of a "significant recession".

But Paul Johnson, director at the Institute of Fiscal Studies, warned that we are facing major turmoil. He said: "It is a mega-recession. It is a recession to end all recessions, in terms of its scale. It's just a very different kind of one to ones we have had in the past because it resulted from a different thing, a pandemic. It has resulted from a different response, Government closing part of the economy down.

"And it should result in a different route out and we hope a faster route out. But we cannot know that it will be a faster route out."

Carsten Jung, an economist at the IPPR think tank and a former Bank of England official, added: "The lion's share of the cost of dealing with Covid-19 will be the lost tax. The tax loss is more than is spent in additional support to the economy.

"The final amount depends on the economic scenario. It depends on how quickly businesses bounce back and consumers start to spend. Also, how fast demand picks up for products and if people have jobs in coming months."

The expected loss to the Exchequer from income tax, National Insurance, VAT, corporation tax, excise duties and even council tax was estimated by the Office for Budget Responsibility. It makes up the biggest chunk of the overall £327billion potential cost of the pandemic. Statistics showed that the UK economy contracted by two per cent in the first quarter of 2020 - which only includes one week


GDP plunged by 5.8 per cent in March alone - the largest monthly fall since records began in 1997 and experts predict that second quarter figures out later in the year will be even worse. Preliminary numbers from HMRC show income tax receipts for March 2020 down 21.3 per cent on last year's March take. Total tax income in March 2019 was £43.6billion - and this March it was down to £41.3billion, before the pandemic really started to squeeze the economy.

The devastating news sparked fresh demands for major international corporations to pay their fair share of tax in the UK.

Stephen Moss, founder and managing director of Sourced Capital, a leading peer-to-peer lending company, said falling income tax levels highlight the need to hold big operations such as Amazon and Starbucks accountable.

He said this was particularly the case "given the fact that they largely continue to operate throughout the pandemic, with some even seeing an uplift in

BORIS Johnson has urged Britons to use "common sense" to help free the country from the coronavirus lockdown.

On Monday the Prime Minister unveiled a 50page plan for getting employees back to work, children back at school and freedoms restored. Key measures in his blueprint include a recommendation for people to wear face masks in enclosed public spaces, such as shops, and on trains and buses where social distancing is difficult. There are also hopes of a return of televised sport and cultural events to "boost national morale".

It was also suggested people from different households could soon be able to meet in social "bubbles". And dismissing criticism from opposition politicians of the Government's changing message, Mr Johnson insisted he was putting his trust in "good, solid British common sense". Presenting his three-stage plan for easing the lockdown to MPs, the PM said: "We have begun our descent from the peak of the pandemic but our journey has reached the most perilous moment. We will be driven not by hope or economic revival as an end in itself, but by data and science and

He said he was not expecting a surge of people back at work this week but urged employees to begin speaking to their employers about a return to the workplace.

He added: "If you can't work from home, you should now think about going to work, providing your workplace is Covidsecure and providing you can travel safely."

Morgan: I went too far with Meghan

PIERS Morgan has admitted he went over the top when he accused the Duchess of Sussex of splitting her husband Harry from the Royal Family.

The *Good Morning Britain* presenter had also claimed Meghan had ditched her own relatives. He said: "It's probably not wise, if you're a columnist, to make things too personal."

Commenting on his previous stance about the duchess, he said: "Have I taken things a bit too far? Probably. "Do I think that will govern and temper how I talk about them going forward? Absolutely."

He added that he is at his "best as a journalist on stuff that really matters". Recently he has torn strips off Government ministers over the handling of the pandemic. In a newspaper interview he said: "It's the stuff that is substantial, particularly when people's lives are at stake, that seems to galvanise my personality into the best possible place.

"And it's times of relative peace, calm, quiet and, dare I say, boredom that might occasionally bring out the worst in me.

"Having squabbles with people who are never going to change their mind in a million years about stuff – that no longer seems remotely important."

In January, he tweeted: "People say I'm too critical of Meghan Markle – but she ditched her family, ditched her Dad, ditched most of her old friends, split Harry from William and has now split him from the Royal Family. I rest my case."

Last year, he accused her of behaving like a member of the TV family the Kardashians "not somebody who married into the Royal Family".

The lockdown low-down

■ As the UK eases into a return to normal, here are the specifics of the new requirements

Face coverings

PEOPLE should wear face-coverings on public transport or in shops where social distancing is not always possible. A scarf, homemade mask or shopbought mask can be used to cover the nose and mouth, although it is not obligatory. They should not be worn by the under-twos, young children who will find them hard to manage and those with respiratory conditions. People should wash their hands before putting them on and taking them off. The government said surgical grade masks should be reserved for medical workers. The government has published information to make your own face covering at www. gov.uk/government/ publications/ howto-wear-and-make-aclothface-covering

workers

were told to return to their jobs providing they cannot be done at home. Food production, construction, manufacturing, logistics, distribution and scientific research are all allowed to restart under the new lockdown rules. But pubs, restaurants, hairdressers, cinemas and clothes shops were all ordered to remain shut. Office workers and anyone else who can work from home were told to carry on. The government pointed out that everyone in work and paying taxes is helping to fund the NHS. "Covid-19 Detailed

Secure" guidance for businesses on how they can reduce the risk of infection among their workforces will be published this week. Workers in shops that are classed as non-essential will not be back until June 1 at the earliest, while hospitality and beauty businesses are being kept in lockdown until at least July 4.

Public transport

Most people should avoid public transport "where possible" as more begin returning to work. Social distancing guidelines on trains and buses "must be followed rigorously" to prevent the virus spreading. The PM admitted capacity will be limited on trains and buses as a result. Ministers say people should try to cycle, walk or drive instead. Key workers are among those advised to avoid public transport if they can. The Government wants councils to widen pavements, create pop-up cycle lanes and also close the roads to traffic to allow more people to cycle. Transport operations will be given new guidance later this week to ensure they are following social distancing guidelines.

Public spaces

Outdoor exercise can be taken as many times a day as desired under the new changes. Team sports remain banned but tennis and fishing are now allowed. People will also be able to play sports and exercise with a member of their own household

or one person from another home as long as they maintain social distancing. But flouting the guidelines carries tougher penalties, with fines starting at £100.

Families

It is now possible to meet one family member at a location outside the home provided the parties maintain social distancing. Dominic Raab said a person could meet two people at different times in a day,

for example their mother in the morning and father later. He clarified: "Outside, staying two metres apart."

Car trips

MOTORISTS can travel anywhere in England, including beach visits and even mountainhiking, providing distancing social regulations are stuck to. It is great news for families who do not live near parks or open spaces. However, the new measures are only in place for England, so visits to beauty spots in Wales and Scotland are off the agenda.

Shielding the vulnerable THE over-70s, pregnant women people and with pre-existing health conditions should still minimize contact with others. Ministers say "clinically vulnerable people should continue to take particular care to minimise contact with others outside their households".

Policing

FINES for breaking lockdown laws rise from £60 to £100. First offenders will get a £50 discount if they pay up within 14 days. Penalties will double for each repeat offence up to a maximum £3,200.



How coronavirus could break up the UK

■ Leading SNP politicians are pushing to accelerate their campaign for Scottish independence

The British response to the Covid-19 pandemic has given the Scottish National Party a powerful new argument for independence, according to some of its most prominent MPs.

"They are formulating policies with a view to unveiling a prospectus once the coronavirus outbreak has abated," The Times reported this week.

Among the group is Joanna Cherry, considered a front runner to succeed Nicola Sturgeon as SNP leader. "I do think the incompetent handling of Brexit and the Covid crisis by Westminster builds the case for independence," she told the newspaper, adding that "many more would now people" question "the UK as a stable and competent entity" than was the case in 2014, when Scotland voted to remain in the UK. Sturgeon has called

for a second vote on independence - a demand

rejected by Boris Johnson - but some in her party believe she should be making the case more strongly.

Even before the outbreak had reached crisis point, back in February, SNP MP Angus MacNeil "said 'all options' for securing independence should be on the table, including claiming through mandate а victory in next year's Scottish elections", as The Independent reported at the time.

"The post-coronavirus era promises to be a good time for the party, as it does for radicals everywhere," says Chris Deering in the New Statesman. "A world waits to be remade. Sacred cows are for the broth pot. The fusty are at bay. It is a rare chance to try new things."

Sturgeon herself has suggested that Scotland should spend the lockdown contemplating "a new way of doing things" - although she has avoided explicit mention of independence.

"As make we that journey [back to normality], difficult and challenging as it will be, we can also start to talk about our destination."she wrote in The Sunday Herald last month. "We can start to think together, and work together, to decide the kind of Scotland we want to emerge from this crisis."

According to The Times, that process has already begun in earnest. The newspaper says the SNP's policy chief, Alyn Smith, has contacted 30 local party branches "to discuss plans including how a universal basic income would work in an independent Scotland".

Smith denied that he was "politicking or taking advantage" of the health crisis. The party was simply debating policy "as an energising prospect

for how an independent Scotland would look different", he said.

Some nationalist commentators think the SNP should go further. Its leaders "seem embarrassed by the notion of independence", but they should look to the example of Dominic Cummings and his determination to push through Brexit, says Kevin McKenna in The National.

"I wish the SNP had someone like him to preserve the integrity of their own project," McKenna continues. "The party needs an official nasty bastard like him who'll cut to the chase and get to what's real... And don't give me any of that sanctimonious mince

about us all needing to pull together to defeat the virus."

Butthe New Statesman's Deerin argues that while post-coronavirus voters may be open to new and radical ideas, they may also be tired of the ones they've heard before. "In a newborn era of uncertainty and risk, a return to the same old arguments about Scottish independence holds little appeal," he argues.

This is especially true after experiencing such a crisis together, reliant on the same institutions and watching the same TV press conferences, Deerin adds. "The country, in short, is functioning as one, culturally, politically and economically, in a way that was perhaps thought lost for good."

Indeed, says a National reader in a letter to the editor, "if Nicola Sturgeon returned to full-campaign mode for Scottish independence today, the fiercely critical outcry would engulf her to such an extent that her career would be over and Scottish independence would be set back decades".

The strongest argument against independence may be financial, however. "The idea that Scotland would be richer alone, which the SNP pushed in the 2014 referendum, was undermined by the subsequent collapse in the oil price," says The Economist.

Harry Dunn suspect named as Interpol fugitive

INTERPOL has issued a "red notice" for the American woman suspected of killing the British teenager Harry Dunn.

Diplomat's wife Anne Sacoolas, 42, could now be arrested if she leaves the US. Northampton Police, which applied for the order, sent an email to Harry's parents confirming they had been successful and that Sacoolas is now "Wanted Internationally". Thev added: "Should she leave the USA, the wanted circulations should be enacted."

A red notice is not

an international arrest warrant but it can request that law enforcement locate and provisionally detain a suspect "pending extradition, surrender or similar legal action". The US has said it will not comply.

Harry's mother Charlotte Charles said on Monday: "This is important news that has just been passed on to us, and we are in pieces. "It's been a terrible time for us. We are utterly bereft and heartbroken and miss our Harry every minute of every single day.

"I just want to urge Mrs Sacoolas to come back to the UK and do the right thing. Face justice and maybe then our two families can come together after the tragedy and build a bridge."

Family spokesman Radd Seiger said of the notice: "It renders Sacoolas a fugitive on the run and it means that she would be arrested and returned to the UK the minute she attempts to set foot out of the USA.

"More importantly, it means that the British authorities have concluded that she did not have diplomatic immunity at the time of Harry's death. Red notices

would not be served on valid diplomats.

"I would urge the authorities in London and Washington and Mrs Sacoolas' legal team to come together to return her to the UK to face the English justice system, where she will get a fair trial.

"I am sure that both families have suffered for far too long, and it is time for her to do the right thing."

Harry, 19, was killed on August 27 when a

car hit his motorbike near the US military base RAF Croughton in Northamptonshire. Sacoolas was charged with causing death by dangerous driving after it was alleged she was on the wrong side of the road. COUNTY OF LOS



Football set to return next month

The government says it is "opening the door" for the return of professional football in England in June.

Culture Secretary Oliver Dowden said Thursday's meeting with the Football Association, Premier League and English Football League had "progressed plans".

He added that plans for the sport to resume should "include widening access for fans to view live coverage".

Meanwhile, England's deputy chief medical officer said any return would be "slow" and "measured".

The Premier League met on Monday to discuss "Project Restart" and hopes for a return to action on 12 June, with matches played behind closed doors.

"We all agreed that we will only go ahead if it is safe to do so and the health and welfare of players, coaches and staff comes first," said Dowden.

"It is now up to the football authorities to agree and finalise the detail of their plans, and there is combined goodwill to achieve this for their fans, the football community and the nation as a whole.

"The government and our medical experts will continue to offer guidance and support."

He added that plans to return should "ensure finances from the game's resumption supports the wider football family".

The next meeting of Premier League clubs will take place on Monday, when top-flight players may return to initial group training under social distancing protocols.

Footballers have so far been limited to individual training but Premier League bosses hope a first phase of team training, under strict guidelines and restricted to 75 minutes, can begin next week.

England's deputy chief medical officer, Jonathan Van-Tam, said: "There will be small, carefully measured, step-wise approaches to see what can be achieved safely. The first of those is to return safely to training, still observing social distancing.

"We will have to see how that goes before we can even think about moving on to the return of competitive football matches."

Monday's meeting will come after a weekend when the Bundesliga, Germany's top flight, becomes the first major league to restart.

The Premier League has been suspended since 13 March because of the Covid-19 pandemic and most teams have nine fixtures left to play.

Brighton had a third player test positive for coronavirus earlier in May and boss Graham Potter is wary about a return to action.

"We are in uncharted territory. It's a hugely complex situation," he said.

"It's very difficult to call one day to the next. The general will from all the clubs is to play out the season as close to the format as possible. Whatever date that is remains to be seen.

"We are sanitising the environment. The players are not coming in for any length of time.

"It will be as safe as it is made to be. The challenge will be when [we have] contact, larger groups and different teams. We need to see where we are on Monday and then Tuesday."

He added: "There are concerns, of course. We have come out of lockdown. The situation is not totally resolved.

"I have a young family. My wife's family has health issues. We are human beings."

Meanwhile, the Premier League confirmed clubs had decided that shortterm contract extensions could be agreed with players whose deals run out on 30 June, with the season set to go beyond that date.

Club and players will now have until 23 June to agree extensions which run until whenever the campaign is scheduled to finish.
