CORONAVIRUS: Boris vows to fight second wave 'on all fronts'

■ New travel restrictions and renewed lockdowns in the North announced

BORIS Johnson has pledged a twopronged attack to avert a catastrophic second wave of Covid.

He is threatening to remove more foreign holiday destinations from the UK's safe travel list.

And he will take targeted action with local lockdowns to control flare-ups at home.

Sources close to the Prime Minister say he will do whatever it takes on all fronts to protect the country from a second wave.

They said Downing Street has learned the lessons from the early months of the pandemic and is now focused on getting ahead of events.

After navigating the double whammy of a health and economic crisis, the PM will stick to a strategy to contain the disease.

He is on the brink of blacklisting more countries with high infection rates to prevent cases of coronavirus being brought into Britain after delisting Spain as an approved tourism destination on Monday. Top Tories and tourism bosses have warned against tough restrictions

on holidaymakers.

But the PM is said to be "desperate" to avoid a major resurgence of the virus at home.

Ministers held more talks on Thursday to discuss which countries to target next as cases of coronavirus spike across Europe. Belgium and Luxembourg are top of the list and a flare-up of the disease in Croatia is also a key concern.

Around 600,000 Britons were in Spain on Saturday when the Government gave six hours' notice of returning travellers being hit with a 14-day quarantine. It has also advised against all but essential travel to the country.

'real risk'

The changes apply to its popular Balearic and Canary Islands despite them having low rates of Covid-19.

Medical experts have warned the UK is in a race against time to prevent a second wave and nationwide lockdown.

Oliver Dowden insisted testing passengers at airports was not a "silver bullet" that would allow restrictions to be eased.

He said: "We are not at the point where there is a viable alternative to the 14-day quarantine.

"There is a real risk here – the virus is rising rapidly around the world.

"We need to ensure that the measures we've taken in the UK to keep this virus under control do not go to waste because we allow cases to come in from elsewhere."

Prof Jose Vazquez-Boland, chair of infectious

diseases at Edinburgh University, said easing restrictions is leading to a "comeback of community transmission".

He warned: "There will be a resurgence of new cases every time social restriction measures are lifted as long as the virus remains in circulation."

Prof James Naismith, director of the Oxfordbased Rosalind Franklin Institute, said he fears a winter spike "if we fail to check this flare-up".

He added: "There is only a short time to get our systems ready to prevent this." However concerns have been raised about the economic impact of tougher restrictions.

Heathrow Airport called for passenger testing to be introduced swiftly to allow the 14-day quarantine period to be significantly reduced.

Chief executive John Holland-Kaye claimed travellers are being forced to play "quarantine roulette".

He said: "Our European competitors are racing ahead with passenger testing."

Ex-minister Crispin Blunt warned imposing blanket measures "quite regardless" of the presence of the virus undermined public support for the Government's approach.

Former Cabinet minister David Davis said there are better alternatives to widespread quarantine restrictions and backed Heathrow's call for airport testing. He said: "On a 14-day holiday there is an 80 per cent chance someone infected will manifest symptoms at the airport.

"Nothing is perfect. You are as likely to catch the virus on the London Underground as you are on a plane."

Coronavirus: Home visits banned in parts of northern England

■ Failure to social distance prompts tough new measures

Separate households are no longer allowed to meet indoors in Greater Manchester, East Lancashire and parts of West Yorkshire, the government said.

Matt Hancock said those areas had seen an "increasing rate of transmission", which was "largely due" to people not following social distancing.

Labour criticised the government for a lack of clarity over the restrictions and for announcing it "late at night".

Details of the new rules were published two hours after the announcement on Thursday.

Millions of people in Greater Manchester, Blackburn with Darwen, Burnley, Hyndburn, Pendle, Rossendale, Bradford, Calderdale and Kirklees will be affected by the tightening of restrictions.

The new measures mean different households will not be allowed to meet in homes or private gardens, but single households will still be able to go to pubs and restaurants.

The health secretary also

said in Leicester, where a local lockdown has been in place for the last month, the same restrictions would also apply.

But pubs, restaurants and some other facilities will be allowed to reopen from Monday, as some of the stricter measures are lifted.

The new lockdown rules for parts of northern England come nearly four weeks after restrictions were eased across England and people were allowed to meet indoors.

'new low'

Mr Hancock said: "We take this action with a heavy heart but unfortunately it's necessary because we've seen that households meeting up and a lack of social distancing is one of the causes of this rising rate of coronavirus and we'll do whatever is necessary to keep the country safe."

Labour leader Keir Starmer tweeted that announcing measures "affecting potentially millions of people late at night on Twitter is a new low for the government's communications during this crisis".

He added: "When the government ended the daily press conferences, they said they would hold them for 'significant a n n o u n c e m e n t s', including local lockdowns. It's hard to imagine what could be more significant than this."

Andy Burnham, the mayor of Greater Manchester - a city with a population of about 2.8m - said there had been a "marked change in the picture" with regard to the spread of Covid-19 in the area.

"We have gone from a falling rate of cases in nearly all of our boroughs last week to a rising rate in nine out of 10 affecting communities across a much wider geography," he said. "In Rochdale, the one borough where cases have fallen, they are still too high."

He said all residents "young and old alike" should "protect each other" by observing the requirements, which will be reviewed weekly.

This means "the more we stick to them, the

quicker they will be removed", he said.

"This is a place which prides itself on looking out for each other. We now need to be true to that by not acting selfishly and keeping the health of others in mind at all times."

Jonathan Reynolds, shadow secretary for work and pensions and an MP in the Greater Manchester area, said the figures were showing an increase in infections including in Tameside where positive tests per 100,000 population has gone from 4.9 to 16.3.

The restrictions are not as strict as those that were imposed in Leicester, she said, but Thursday's announcement covers a much greater area.

The pair had dinner on Monday in London before holding further "informal" discussions. Officials on both sides are privately confident a deal can still be reached after good progress was made last week.

But a UK Government spokesman said Brussels has not yet decided whether it is ready to accept Prime Minister Boris Johnson's offer of a Canadastyle free-trade deal.

The spokesman said: "We've had constructive discussions and both

sides have shown pragmatism and willingness to move on difficult areas.

"What is needed now is reflection on the EU side on whether what they're asking us is consistent with our status as an independent country. If they come to the correct conclusion, we'll be able to move forward."

The two sides will now take a two-and-a-half-week summer break before returning for the next round of negotiations in Brussels on August 17.

Maddie: Police dig their way into cellar where suspect 'wanted to have dungeon'

THE prime suspect in the Madeleine McCann case wanted to create a "cellar dungeon" at his home, it has been claimed.

Christian Brueckner allegedly told a friend he was planning a secret underground lair.

Details emerged investigators discovered a cellar at an allotment linked to Brueckner this week.

Officers carrying out a massive digging operation were said to be focusing on the makeshift basement at the site where Brueckner lived after returning to Germany from Portugal in 2007.

The convicted paedophile, 43, is alleged to have claimed he wanted to soundproof and insulate the hidden domain

The revelations came as masses of soil and rubble were removed from the scene to be forensically analysed in laboratories. It is thought heavy equipment was used to smash up and remove the foundations of the cellar as police dug a 10ft hole at the plot of land, located near the village of Ahlam, five miles from Hanover.

cellar

On Tuesday neighbours told how Brueckner lived there for about a year in a camper van and a wooden shed which had its own kitchen with the cellar built underneath.

One neighbour told how the suspect arrived in the early summer of 2007 and rented

the plot for a few months.

He claimed Brueckner wanted to insulate the small shack which stood on a concrete base in the garden with a small cellar underneath.

He allegedly told the neighbour he wanted to fit it with polystyrene boards he had hoarded. Another neighbour, school bus driver Jurgen Kavadka, said: "In the end the authorities kicked him off and tore down the hut but the foundations and cellar were still there. The whole thing is gruesome.

"The owner of the allotment let him stay

there after meeting him at a festival in Hanover and finding out he was homeless."

'living off the grid'

A former friend of Brueckner, known only as Bjorn, said the suspect had told him he planned to convert the basement of his home in a "garden colony" into a "cellar dungeon".

Brueckner is currently in prison in Germany and has convictions for sex and drugs offences. Wolfgang Kossack, who had a plot in the area, said: "He told me that he was living off the grid, that he had not registered with the authorities. No one knew he was there.

"At the time there was a building on the garden. It had a cellar and underneath there would be foundations."

Madeleine aged three when she disappeared on a family holiday in Praia da Luz, Portugal, in May 2007.

Τt is believed Madeleine's parents Kate and Gerry are being kept updated with developments.

Brueckner's lawyer, Fulscher, Friedrich reporters that "denies his client involvement" any Madeleine's in disappearance.

France, Germany and Belgium have all witnessed a spike in cases, which could spark further lockdowns, while Italy and Greece have also seen infections rise.

Abta, the UK travel trade association for tour operators and travel agents, said the industry was left in the dark as to the policy criteria.

It said: "Protecting public health is rightly a priority... but no specific information has been shared by the Government as to the precise criteria or infection rates being used to determine policy positions, making it impossible for travel businesses to make more effective decisions."

'support measures'

Adam Marshall, director general of the British Chambers of Commerce, said: "Abrupt changes to quarantine measures will be yet another hammer blow for the fragile travel and tourism industries, both here in the UK and overseas.

"Support measures should be extended to help firms and their employees.

"Businesses will be asking why Spain was on the safe list on Friday, only to be taken off it on Saturday. Changes to quarantine rules must be communicated clearly by Government with as much notice as possible."

Budget airline Jet2 this week cancelled all holidays and flights to mainland Spain until August 17, while Tui, Britain's biggest tour operator, suspended all holidays up to and including August 9. Paul Charles, founder of

travel PR consultancy firm PC Agency said: "People are cancelling not just Spain but other short-haul bookings. We've heard of lots of cancellations for holidays to France, Italy and Greece." But Hays Travel, Britain's largest independent travel agent, said travellers who had booked through them had asked to go somewhere else, or travel on another date. Uncertainty insurance and whether holidaymakers would be entitled to full refunds if they decided not to fly - has also added to confusion.

'public health first'

The chaotic overseas situation has been a boost to British holidays with 14 million planning to take staycations before September.

The Foreign and Commonwealth Office (FCO) is advising against non-essential travel to mainland Spain including the Balearic and Canary Islands.

Around 600,000 Britons were believed to be in the country when the rule change was imposed at midnight on Saturday.

One of them was Transport Secretary Grant Shapps, who is cutting short his family holiday to Spain after arriving there on Saturday.

He was expected to return to the UK but will self-isolate for 14 days and work from home.

The quarantine changes have also scuppered the travel plans of fellow Cabinet minister Michael

Gove, who was due to visit Ibiza. He said: "It's an inconvenience for me but it's nothing compared to the importance of putting public health first."

Exile royal couple, 40% say in shock poll result

FOUR in 10 people surveyed believe Harry and Meghan should be exiled permanently from the Royal Family, a poll has revealed.

A survey of 2,000 UK adults, by OnePoll, found more than half – 57 per cent – think that a controversial new biography of the couple Finding Freedom, which claims to reveal deep rifts between senior royals and Harry and Meghan, as well as the couple's public airing of private family matters has been "inappropriate".

Two-thirds (67 cent) said they had been saddened to watch Harry and Meghan's relationship with the Royal Family, particularly the Queen, deteriorate in such a public fashion. As a result, 40 per cent who expressed an opinion believe the LAbased couple "have made their bed" and should be booted out of The Firm for good. The popularity of the royals has already taken

a beating in light of the scandal involving Prince Andrew's relationship with convicted sex abuser Jeffrey Epstein, only to be compounded by Harry and Meghan's decision to leave their royal roles. More than half – 54 per cent – say their opinion of the royals had suffered since the allegations about the Duke of York became public. Almost a third – 30 per cent –

admitted their opinion on the wider Royal Family had fallen since the "Megxit" fallout.

Finding Freedom has been providing headlines in UK newspapers in recent days after being serialised in the Times and the Sunday Times.

According to the book, one of the main drivers behind the couple's decision was the way they felt Meghan was

treated by members of the royal family. One of the authors has said the fact Meghan is a mixed-race American was "going to ruffle some feathers" within Buckingham Palace.

One senior royal is said to have referred to Meghan as "Harry's showgirl", while another allegedly said: "She comes with a lot of baggage."

Fans bowled over by return of cricket

CRICKET welcomed spectators back to watch live action for the first time this season on Sunday.

Up to 1,000 lucky ticket holders were at The Oval in south London, watching hosts Surrey play Middlesex in a friendly match.

The event was the first in a series of Government pilots and was being hailed as a significant step towards



When not listening to Queen music, 26-year-old Lucy, who was born in New York but brought up in London, is preparing for her next projects. "I'm not someone who gets involved in baking banana bread," she laughs. She is currently researching the life of Marianne Faithfull for the upcoming biopic Faithfull in which will play the iconic 60's singer.

"I'm a big believer in trusting your gut instinct above all else and it's definitely something that I apply to my day to day life and when I'm trying to discern the next project or trying to decide what the next step should be. Gut instinct has always been the answer. I think you can never really go wrong if you're being led by your passion and instinct."

She added: "And I had a good gut instinct about Rami."

Lucy, who began her acting career when she was 12 years old as the young Beatrix Potter in 2006's Miss Potter has been deeply involved in researching the turbulent life of Marianne Faithfull.

"It's definitely been an education," she says. "I think I was very much


She had arranged to





"I want to perform at the level I'm performing at now forever, but there is a point when physicality

"The Covid lockdown, while it was a negative in many, many ways, it gave me a lot of life and energy to focus on some other things and that bit of time off was really a bit of breathing space," said Hamilton.

"It has given me a renewed bit of energy to perhaps go longer.

"Also, we are in period of time when there is not another driver from my background coming at the moment and I am conscious of that.

"I want to earn my position and I still feel like every year I come back it's not a given just because I have world championships under my belt.

"You have to earn the right to be here in terms

of how you perform. My goal is to continue to deliver for as long as I can, so I see myself going for at least another three years.'

Hamilton and his Mercedes team-mate Valtteri Bottas head into this weekend's British Grand Prix as strong favourites after winning all three races between them so far.

Hamilton, who leads the championship by five points, has won two of the races and Bottas one and the Briton is determined to add to his record tally of British GP wins.

Mercedes have dominated the start of the season, with a car that has appeared out of reach of any other, and it is expected to be stronger than ever around the fast sweeps of Silverstone, a track that should emphasise its many strengths.

But Hamilton played down the prospect of Mercedes winning every race this season.

"Our goal is always to win every race, that's what we set out to do every year," he said. "But you are constantly faced with challengers. Red Bull get stronger and stronger though the season. Ferrari have some big improvements to make on the car."

However, Arsenal's finances are severely stretched already as they face a fourth season out of the Champions League with a huge wage bill - and the cost of the pandemic has hit the club hard.

Arteta will have to sell before he can buy this summer. The club already have Mesut Ozil on £350,000 a week and he does not want to leave, while they also want to strengthen in other areas, which gives them little scope for huge new contracts.

They are hopeful of re-signing Dani Ceballos to another one-year loan deal, while selling Matteo Guendouzi may help raise cash to strengthen in midfield, and they also want another centre-half. The Europa League could be worth £30m as well as providing the prestige of European football.

The value of the competition is often underestimated but it provides much-needed extra cash.

However, Arsenal also are aware of Aubameyang's age and they have to get the deal right. That presents an intriguing scenario for the player's future because there would be very few clubs who could actually afford him - even if he only has one year left on his deal.

Toon fans 'heartbroken' as takeover collapses

Newcastle United fans say they are "confused" "hearbroken" following the collapse of the Saudi Arabian-backed takeover.

A consortium, led by the country's Public Investment Fund (PIF), agreed a £300m deal to buy the club from Mike Ashley in April but has now pulled out.

Greg Tomlinson, from the Newcastle United Supporters' Trust, said "answers are needed the from Premier League".

supporter Fellow Michelle George

said: "It's left fans devastated."

The deal was delayed after being scrutinised the Premier under League's owners' and directors' test.

And the consortium, which also included PCP Capital Partners and the Reuben Brothers, has pulled out because it is understood the PIF ran out of patience.

Magpies supporter George added: "As fans, we are heartbroken. It sounds dramatic but we have suffered for 13 years under Ashley through a lack of interest and investment in the

club.

"So the fact it played out how it did and for the length of time it did and then for the news to break, and we still don't have the full picture."

Legal documents were handed over to the Premier League 16 weeks ago, but the bid has been dogged by claims regarding Saudi Arabia's human rights record and its handling of TV piracy.

The delay to the process came because the Premier League lawyers struggled to establish precise links between the consortium and the Saudi government.

Crown Prince Mohammed Salman is also the PIF's chairman.

Despite the ownership complications, a survey of Newcastle United Supporters' Trust members found that 97% of them were in favour of the takeover, with many wanting rid of Ashley.

"Everyone was excited about the bid and potential investment in the city, so it represents a missed opportunity for Newcastle and the north-east as a region," added Tomlinson.
