Fury over 'ageist' over-50s virus plan

■ Anger at No 10's 'nuclear option' to stop second wave

PEOPLE aged 50 and over reacted furiously this week to Government plans to lock down most of the age group.

Under the drastic policy – Boris Johnson's "nuclear deterrent" against the rise in Covid-19 – up to 25 million Britons could be forced to stay in.

and Campaigners individuals branded it ageist and abhorrent. director UK Age Caroline Abrahams said: "It would be much better to assess risk on an individual basis... that's the best way of avoiding draconian measures, including this one, which feels unacceptably ageist.

"The thought that ministers have even considered an agerelated approach is bound to fuel alarm and distress among many older people.

"Age is important when it comes to the risk but other factors count too, including gender, race, having other health conditions and being overweight.

"So an age-based

policy would be a very blunt instrument."

Dennis Reed, of over-60s group Silver Voices, accused the Government of mixed messages.

Reports that ministers are looking at locking down over-50s came on the same weekend shielding was officially "paused" for the most vulnerable people in the country.

Dennis said: "On Saturday they stopped shielding support for 2.2 million people.

"To now suggest they're going to expand shielding seems completely contradictory.

"The messaging has been so confusing that most over-50s have been setting their own regimes.

Most are being very

"The advice we are giving is not to be seduced into going to a pub or restaurant unless you feel safe."

David Sinclair, director of the International Longevity Centre said: "Locking down individuals aged over 50 would be catastrophic for the UK economy and for our communities.

"People aged over 50 spend 54p of every £1 on the high street and beyond. They also contribute £175billionworth of care to society.

Quite simply, our economy and society is reliant on them."

Members of the public took to social media to voice their anger.

Teacher Jo Perry tweeted: "So I'm classed as elderly now am I? I've worked through lockdown, back in the classroom in a "bubble" of 15, caring for the elderly parents-in- law and my 14 year old. But okay, if you insist.

"Can I have my pension from 60 then please? No? Thought not"

Mum-of-three Helen



Brenton wrote: "If over 50s are now classed as 'elderly', then why are we expected to work into our late 60s?" A Twitter user called Sandra said: "I & my over50 friends haven't been going to raves or demonstrations, to the beach for the day, queuing outside Primark or crowding into pubs. Over-50s lockdown is abhorrent."

But older people's champion Dame Esther Rantzen said: "I don't want any young and fit people to have their freedom curtailed for my sake.

"If it would help me, aged 80, to continue to shield then that's fine."

The furore erupted as Government statistics showed eight more people had died from coronavirus on Saturday, bringing the total to 46,201.

There had been 755 new infections recorded. The number of coronavirus infections hit an average of 4,200 per day from July 20 to 26. That had nearly doubled on the rate the previous week.

Government officials drew up the over-50s plan last week after Boris Johnson, who is 56, ordered them to come up with ideas to prevent a national lockdown.

Friday On announced he was his lifting pausing of restrictions but compared the prospect of a full lockdown to a "nuclear deterrent" that should be used only as a last resort. Behind the scenes, aides say he is demanding "nuclear weapons" to combat Covid-19.

Britain leading in race for coronavirus vaccine

■ Human trials set to begin September 3rd

BRITAIN spearheading the global effort to find a Covid-19 vaccine in the race to find safe and effective immunisation by the end of the year.

The Government could have access to 250 million of approved vaccines which would be offered firstly to groups such as frontline health workers.

The UK has agreed for the supply of up to 60 million doses of a

vaccine being developed by GlaxoSmithKline and French pharmaceutical company Sanofi.

Human clinical studies of the vaccine are scheduled to begin in September followed by a phase 3 study - the final before licensing - in December.

But the Government has stressed the importance of investing in a broad range of vaccines to improve the chances of a successful

A deal in principle has been agreed for 60 million doses of a vaccine made in Livingston, West Lothian, by Valneva of France – with an option of 40 million more if it is proven to be safe, effective and suitable.

The UK has also secured 30 million doses the experimental vaccine from US drug maker Pfizer and German biotech company BioNTech.

And it has been agreed

that AstraZeneca would produce 100 million doses of its vaccine being developed in partnership with the Jenner Institute at Oxford University.

Last month, director Professor Adrian Hill described the first human results as a "major breakthrough".

That Oxford Covid-19

vaccine could be ready by December if enough people are recruited about 50,000 - for trials by the beginning of September.

SAS squad 'assassinated' Afghan suspects, court documents claim

AN SAS unit allegedly carried out night missions to execute Afghanistan according civilians, disclosed to documents.

The shocking classified papers claim UK special "assassinated" unarmed Taliban suspects in Helmand province in

The documents were released as part of a High Court legal case following a BBC Panorama investigation into claims SAS deliberately targeted men of fighting

The secret files were

previously withheld by the Government, it was said, causing a judge to demand an explanation from Defence Secretary Ben Wallace.

The SAS emails reveal huge concerns over the killings of more than 33 Afghan people in 11 different night raids on homes by the same unit, it was claimed.

An alleged quadruple killing by UK troops said to have taken place on February 16, 2011, is at the centre of the row.

It is claimed an SAS team hunting a Taliban fighter called Saddam, suspected

planting bombs, raided his family home.

Family members including his 19-year-old brother Saifullah Ghareb Yar stepped out into the night with their hands up, it was said.

It is claimed Saifullah heard gunfire and later found his father, Haji Abdul Kaliq, 55, two brothers, Saddam, 23, and Atullah, 25, and a cousin shot dead.

There is also concern that of the alleged 33 deaths, 10 were near-identical in their circumstances.

Saifullah, now in his 20s, has been granted a judicial

review into the deaths of four members of his family.

The allegation about the four civilian killings was passed on to the special investigation branch of the Royal Military Police.

They felt the claims were sufficiently serious to launch an investigation in March 2014.

The Ministry of Defence said the new claims were in fact from old evidence already viewed investigators.

A spokesman said: "This isnotnewevidence, and this historical case has already independently been investigated by the Royal Military Police.

"It has also been subject to four reviews conducted by an independent review team."

Virgin Atlantic files for bankruptcy

VIRGIN Atlantic this week filed for bankruptcy as it attempts to secure a £1.2billion rescue plan announced last month.

The Virgin Group airline filed for Chapter 15 bankruptcy protection in a New York court, just hours after the company told a London court it would fold if a rescue deal is not reached next month.

This comes just months after sister airline Virgin Australia filed voluntary administration

Sir Richard Branson's airline, which flies longhaul international routes, suspended passenger flights in April because the coronavirus pandemic. It resumed them in July, despite little

demand for international travel.

In court filings, Virgin Atlantic's lawyers said: "The ongoing Covid-19 pandemic has had an adverse impact on not only [Virgin Atlantic], but the aviation industry as a whole, occasioning the near shutdown of the global passenger aviation

Expat spared death penalty after killing brutal husband

■ 'I thought we'd grow old together' says wife jailed in Malaysia

spared execution after killing her husband cried as she told a Malaysian court: "I thought we'd grow old together".

Samantha Jones, 54, said she had feared for her life when the knife plunged into her husband of 17 years during a scuffle.

On Tuesday sobbed with relief as she pleaded guilty to

the culpable homicide of Iohn

Jones, 63, after a murder charge was dropped.

Her victim, grandfather-of-five, died from a single wound to his chest, which pierced his liver.

The former firefighter Worcestershire had been stabbed after returning drunk on the paradise island of Langkawi in 2018.

He had pulled out the

knife and lay dying while his wife tried to stop the bleeding, the court was told. It took 45 minutes for the ambulance to arrive, the defence said, by which time he was already dead.

Scared

The court heard how Mr Jones, who had two children from a previous marriage, had emotionally and physically abused his



The court heard Samantha Jones had endured years of abuse from her husband John

wife for years. The insurance clerk from Somerset said she had reported him to the police in the UK.

The judge told her she was fortunate as he jailed her for three-andhalf years and fined her £1,800.

With time served she could be free by March, after avoiding the mandatory death sentence for murder. She would then be deported to the UK.

Samantha – who spent days in hospital because of a chest infection from her severe asthma wore a face mask as she was escorted into the High Court in Kedah. She broke down when shown pictures of the post mortem and the knife which caused a 6in wound to her husband's liver.

The court heard that

on October 18 John had returned to their villa at 2am after drinking all

Śamantha was in bed when he attacked her, causing her to fall off the bed. He then kicked her in the back and stomach several times.

Her lawyer Sangeet Kaur Deo said: "He grabbed her and dragged her to the living room where he continued attacking her. She went to run out of the house to get help from a neighbour.

"In the kitchen the knife was on the counter, she grabbed it to defend herself and threaten him."

But the court heard a scuffle followed and "the next thing she knew" he had been stabbed.

Samantha said: "I was scared and he was so angry. I tried to stop him,

I did not know it would happen like this."

She told how they had been having marriage problems and had been getting counselling. But Samantha added: "I believed he was actually getting better. We were happy. I thought we would grow old together.

"He used to say I was one half of him and he was the other half of me. I really miss him dearly."

John met Samantha at a fire service bash and left his childhood sweetheart and children

The pair wed in 2001 before moving to Malaysia in 2005. But she suffered a broken jaw and injuries from his drunken rages.

Samantha claimed during one incident he was sober when he randomly punched her in the face.

Tributes flow for John Hume

ULSTER peace broker John Hume has died aged 83, after a long battle with dementia.

Former prime minister Tony Blair and ex-US President Bill Clinton led the tributes to the political fixer who won the Nobel peace prize for helping to reconcile Northern Ireland's divisions.

Hume, who founded and led the Social Democratic and Labour Party for 22 years, eased the path towards the Good Friday agreement.

'Visionary'

He was widely praised for pulling off risky negotiations with Gerry Adams, the controversial Sinn Fein figure suspected of IRA links.

Mr Blair, prime minister when the Good Friday Agreement was signed in 1998, hailed Mr Hume's "epic" contribution. He added: "John Hume was a political titan; a visionary who refused to believe the future had to be the same as the past.

"His contribution to peace in Northern Ireland was epic and he will rightly be remembered for it."

Clinton paid tribute in a joint statement with wife Hillary, saying: "Hillary and I are deeply saddened by the passing of our friend John Hume, who fought his long war for peace in Northern Ireland.

"His chosen weapon: an unshakeable commitment to nonviolence. persistence, kindness and love. With his enduring sense of honour he kept marching on against all odds towards a brighter future for all the children of Northern Ireland"

Hume was born to a Catholic family in Derry, scene of some of the Troubles' worst conflicts. Arlene Foster, First Minister of Northern Ireland, underlined the impact he had on both nationalists and unionists.

She said: "John was a giant figure in Irish nationalism but also in the wider life of Northern Ireland.

Let's face it, 2020 has not been the year we all expected it to be.

COVID-19 The pandemic has changed the way we live our lives, from wearing masks in public, to how we shop for groceries, we are no doubt living in a new normal that may be around for some time. I am a huge proponent of following CDC guidelines to control the spread of the virus and out of respect for those who've been affected greatly by it, including front line workers tirelessly fighting the good fight. So for me social distancing is a must, and that means most forms of nightly entertainment, including bars, dine-in restaurants, and movie theaters are a no go. BUT there has been one light at the end of the tunnel for this moviegoer in particular - the resurgence of the drive-in movie theater.

My earliest memories of seeing movies, and the very catalyst that ignited my love of them, was going to the Sunrise Drive-In Theater in the early 80's on Long Island with my family, to see classic films like E.T., Superman, Ghostbusters, Star Wars, and the original Twilight Zone The Movie.

The whole experience was exhilarating! Being outside under the stars, with popcorn and candy mom packed for us beforehand (the concession stand being way too expensive), the windows down, a warm summer breeze blowing, while the soundtrack of the movies boomed and echoed around us from numerous car windows! Nothing could compare!

Sadly, by the late 2000s, 90 percent of them had closed, especially on the east coast, where rising property taxes and inclement weather

that kept them closed half the year made it a dwindling investment. But my particular drivein experience influenced my love for film so much, that I moved from the east coast to Southern California to pursue a career as an actor. I had read about a few drive-in theaters still in operation and had to go. What better than to be at a drive-in in the heart of it all! However, after a few visits, I noticed their upkeep was not on point, and most people weren't rushing to them. Especially when you could see new movies at top-of-the-line theaters like the Cinerama Dome or classic films at outdoor summer screening series like Cinespia at the Hollywood Forever Cemetery.

Then came pandemic, and going to the movies came to a screeching halt. Summer blockbusters were pushed, premieres postponed, all summer outdoor screenings cancelled indefinitely. because they all meant large, packed crowds that would be a recipe for disaster. One of the main reasons we go to the movies is for a little escapism, which was needed more than ever, and now that wasn't even an option.

Until something wonderful began to happen. These once defunct drive-ins, that

inconsistently showed movies, suddenly started to fully reopen all around SoCal. Almost every week this summer I have seen a movie at the drive-in. Some new releases, some classics. It's a great way to reconnect with friends and feel like you're doing something together! My favorite SoCal drivein is Mission Tiki, but there are great perks to all! Most theaters have websites where you can check out what's playing weekly, schedules change each Thursday and they show movies every night, usually themed double features, and sometimes 4-6 different movies a night. Beyond Fest has been hosting a

killer lineup of classic and cult films at the Mission Tiki and it has been a highlight of my Summer movie season! They announce double features on Thursdays, separate from the Mission Tiki schedule (you can sign up via Beyond Fest's social media) and sell out within an hour.

This experience makes me feel just like I'm transported back to those warm summer evenings at the Sunrise drive-in with my family, falling in love with movies all over

Fiona Shaw: Killing Eve star muses on work, growing up and finding love later in life

For nearly 40 years Killing Eve actress Fiona Shaw travelled the world, appearing on stage, on TV and in movies, never thinking about settling down or getting married.

Then, while appearing in her onewoman show on stage in New York she read a book which led her to love, marriage and a totally different life.

In an interview via video from her home in Islington, north London, 61-year-old Shaw, who plays the steely MI6 agent Carolyn Martens in Killing Eve, talks for the first time in detail about finding love with the person who became her wife.

The book was Wave economist Sonali Deraniyagala who suffered unimaginable tragedy of losing her husband, parents and two sons in the 2004 Boxing Day tsunami.

'weary'

The Sri Lankan doctor herself was found seminaked and unconscious in a lagoon, clinging to a tree. In Wave she wrote about her struggle to come to terms with what had happened and her years of depression during which she contemplated suicide and abused alcohol and drugs.

Shaw read the book while appearing on Broadway in Testament of Mary and was so moved by it she asked to meet the author.

They were introduced by a mutual friend, they hit it off immediately and were married two

months before Shaw's 60th birthday.

"When I met Sonali my name was up in lights on Broadway which is the pinnacle of what actors want, but I was so weary of the entire thing," she recalls. "I was tired in my bones and I didn't want to say that to anyone. So maybe these calming things come at the right moment."

Now, she says, "Why didn't I get married before? Sonali brings everything to my life... fun, laughter, food-- she's a brilliant chef---companionship, steadiness. And she's not at all interested in my filming life so we don't talk about it at all. Instead we talk about life and family, so it means my identity has become my domestic identify, not my identity as a public person, which I'm so pleased about.

"I'm married to a very unusual person but maybe it took a very unusual person to marry me."

Her marriage, she says, has helped her understand the value of things.

'more grown-up'

"I don't think I could have married in my 20s or 30s because I don't think I was that kind of person," she mused. "It's just that I think I made a decision when I was about 26 to give myself entirely to the whims of work and travel and tearing around the world.

what "T think marriage has done has made me not want to travel at the rate I was travelling.

"A lot of actors live

like students or children and for a long time I had a small flat in Primrose Hill and I used to live abroad a lot. But in the last five years I live in a proper house and I feel much more grown up," she laughs.

The Irish-born actress, who previously had a relationship with the actress Saffron Burrows, trained at RADA in London and made her stage debut in Love's Labour's Lost in 1983. She has alternated between stage, television and films, in the U.K., Ireland and America.

Her films roles include My Left Foot, Mountains on the Moon, Three Men and a Little Lady, London Kills, The Avengers, Jane Eyre and Aunt Petunia in the Harry Potter films. She appeared in the U.S. television series True Blood and won a BAFTA award for her role as Carolyn in Killing Eve.

"You know, I keep saying to people that I've waited all my life to play someone like Carolyn because normally I'd be offered to play the vicar's wife or a schoolteacher or a doctor but the thing about Carolyn is that she's mysterious and her mystery is that she knows a lot more than anybody else but she's also a human being and in this season it's her humanness that is being challenged an it's much more emotional," says.

"She's such a successful person but you chip away at the surface and you challenge the essence of her. And I like her very much."

Hamilton wins British GP yet again

LEWIS HAMILTON somehow survived a puncture on his final lap of the British Grand Prix to complete the most remarkable win of his record-breaking career on Sunday.

The world champion crossed the line on three wheels to clinch his seventh victory in his home grand prix.

"I have definitely never experienced anything like that on the last lap," said Hamilton. "My heart nearly stopped. The tyre deflated and it was a heart-in-the-mouth feeling. The tyre was falling off the rim and I was just trying to keep the speed up. Oh my God... I was just praying to get it round.

"Somehow I managed it, but the last two corners were difficult. The fight for survival instinct came out. I just managed to keep it together."

Hamilton took the chequered flag 5.8 seconds ahead of Red Bull driver Max Verstappen.

Hamilton's Mercedes team-mate Valtteri Bottas was also scuppered by a puncture on lap 50 of the 52 and finished out of the points.

That means Hamilton, aiming for a recordequalling seventh world drivers' title, is already 30 points clear in the championship after just four races of a shortened season. And while this Silverstone race will be remembered for the last-gasp tyre drama, Hamilton admitted he would prefer a tougher challenge on the circuit.

Sitting alongside Verstappen and Ferrari's third-placed Charles Leclerc, Hamilton said: "I'm a racer at heart.

That's what excites me. "This is not the Championship fight that I would have hoped for."

We can win titles together, says Arteta

Mikel Arteta thinks winning the FA Cup could be just the start for Arsenal after describing it as one of the greatest moments of his career.

The Gunners beat Chelsea 2-1 in Saturday's Heads Up FA Cup final at an empty Wembley thanks to two goals from captain Pierre-Emerick Aubameyang.

Arteta won the trophy twice with Arsenal as a player, is in his first managerial role.

"I think it's even better winning this than as a player," he told BBC 5 Live.

"It's such a special day. Hopefully we made a lot of people happy. The players worked extremely hard. Thank you to all our staff and the people upstairs who made the decision to give me this incredible opportunity to manage a club that I have in my heart."

"I am really proud of what we have achieved because I know the difficulties and everything we have been through," said Arteta.

"For me personally, it has been so tough over the past six months with a lot of things that have happened in our lives but I had just one mission when I came here and that was to make the players and staff believe we could do it

"We had to change that energy and that mentality and just by seeing them in the dressing room all together, and the way they enjoy their profession and their time together, it makes me more proud and as a consequence of that after we can achieve things and win titles together."

Arteta, who replaced Unai Emery in December, is the first person to both captain and manage Arsenal to victory in an FA Cup final.
